Exactly solvable models through the generalized empty intervalmethod: multi-species and more-than-two-site interactions

#### A bstract

Multi-species reaction-di usion systems, with more-than-two-site interaction on a one-dimensional lattice are considered. Necessary and sufcient constraints on the interaction rates are obtained, that guarantee the closedness of the time evolution equation for E  $_{\rm n}^{\rm a}$  (t)'s, the expectation value of the product of certain linear combination of the number operators on n consecutive sites at time t.

### 1 Introduction

The study of the reaction-di usion systems, has been an attractive area. A reaction-di usion system consists of a collection of particles (of one or several species) moving and interacting with each other with species probabilities (or rates in the case of continuous time variable). In the so called exclusion processes, any site of the lattice the particles move on, is either vacant or occupied by one particle. The aim of studying such systems, is of course to calculate the time evolution of such systems. But to not the complete time evolution of a reaction-di usion system, is generally a very dicult (if not impossible) task.

Reaction-di usion systems have been studied using various methods: analytical techniques, approximation methods, and simulation. The success of the approximation methods, may be dierent in dierent dimensions, as for example the mean eld techniques, working good for high dimensions, generally do not give correct results for low dimensional systems. A large fraction of analytical studies, belong to low-dimensional (specially one-dimensional) systems, as solving low-dimensional systems should in principle be easier [141].

Various classes of reaction-di usion systems are called exactly-solvable, in di erent senses. In [15{17], integrability m eans that the N -particle conditional probabilities' S-m atrix is factorized into a product of 2-particle S-m atrices. This is related to the fact that for systems solvable in this sense, there are a large number of conserved quantities. In [18{27], solvability means closedness of the evolution equation of the empty intervals (or their generalization).

The empty intervalm ethod (E M) has been used to analyze the one dimensional dynamics of diusion-limited coalescence [18{21]. Using this method, the probability that n consecutive sites are empty has been calculated. For the cases of nite reaction-rates, some approximate solutions have been obtained. E M has been also generalized to study the kinetics of the q-state one-dimensional Potts model in the zero-temperature limit [22].

In [23], all the one dimensional reaction-di usion models with nearest neighbor interactions which can be exactly solved by E  $\mathbb M$  have been studied. E  $\mathbb M$  has also been used to study a model with next nearest neighbor interaction [24]. In [25], exactly solvable models through the empty-interval method, for more-than-two-site interactions were studied. There, conditions were obtained which are suicent for a one-species system to be solvable through the E  $\mathbb M$ . In [26], the conventional E  $\mathbb M$  has been extended to a more generalized form. Using this extended version, a model has been studied, which can not be solved by conventional E  $\mathbb M$ .

In a recent article [27], we considered nearest-neighborm ulti-species models on a one-dimensional lattice. we obtained necessary and su cient conditions on the reaction rates, so that the time evolution equation for  $E_{k,n}^a$  (t) is closed. Here  $E_{k,n}^a$  (t) is the expectation of the product of a special linear combination of the number operators (corresponding to dierent species) at n consecutive sites beginning from the k-th site. All single-species left-right symmetric reaction-diausion systems solvable through the generalized empty-interval method (GEIM), were classified. In this article, the method introduced in [27]

is generalized to more than two-site interactions.

In section 2, multi-species systems with three-site interactions are investigated, which are solvable through the GEIM . Conditions necessary and succient for closedness of the evolution equation of  $E_{k,n}^{\,a}$  (t) are obtained, and the evolution equation is explicitly given.

In section 3, the more general case of multi-species systems with k-site interactions, solvable through the GEIM, is investigated. Again, conditions necessary and su cient for closedness of the evolution equation of E  $^{a}_{k,n}$  (t) as well as the evolution equation itself, are obtained.

Finally, in section 4, as an example a speciem odel with a three-site interaction is introduced and exactly solved.

#### 2 Three-site interactions

Consider a periodic lattice with L+1 sites. Each site is either empty, or occupied with a particle of one of possible species. Denote by N  $_{\rm i}$ , the number operator of the particles of type—at the site i. = p+1 is regarded as a vacancy. N  $_{\rm i}$  is equal to one, if the site i is occupied by a particle of type—. O there ise, N  $_{\rm i}$  is zero. We also have a constraint

where s is a covector the components of which (s 's) are all equal to one. The constraint (1), simply says that every site, either is occupied by a particle of one type, or is empty. A representation for these observables is

where N is a diagonal (p+1) (p+1) matrix the only nonzero element of which is the 'th diagonal element, and the operators 1 in the above expression are also (p+1) (p+1) matrices. It is seen that the constraint (1) can be written as

where N is a vector the components of which are N 's. The state of the system is characterized by a vector

where V is a (p+1)-dim ensional vector space. All the elements of the vector P are nonnegative, and

Here S is the tensor-product of L + 1 covectors s.

As the number operators N  $_{\rm i}$  are zero or one (and hence idem potent), the most general observable of such a system is the product of som e of these number operators, or a sum of such term s.

The evolution of the state of the system is given by

where the Hamiltonian His stochastic, by which it is meant that its non-diagonal elements are nonnegative and

The interaction is a next-nearest-neighbor interaction:

(It has been assumed that the sites of the system are identical, that is, the system is translation—invariant. O therwise H in the right-hand side of (9) would depend on i.) The three-site Hamiltonian H is stochastic, that is, its non-diagonal elements are nonnegative, and the sum of the elements of each of its columns vanishes:

Now consider a certain class of observables, namely

where a is a speci c (p+1)-dimensional covector, and N  $_i$  is a vector the components of which are the operators N  $_i$ . We want to indicriteria for H , so that the evolutions of the expectations of  $E^a_{k,n}$  's are closed, that is, the time-derivative of their expectation is expressible in terms of the expectations of  $E^a_{k,n}$  's them selves. Denoting the expectations of these observables by  $E^a_{k,n}$ ,

For 1 < n < L, we have

In the right-hand side of the last equality, the rst two and the last two terms are contributions of the interactions at the boundaries of the block, while the sum mation term is the contribution of the sites in the bulk.

D em anding that the bulk term s in (13) be expressible in term s of the expectations of  $E^a_{k,n}$  's them selves, one arrives at the following condition for the bulk term s.

where the multipliers in the right-hand sides of (17) and (18) are constants. A rranging all these together, the evolution equation for E  $_{k,n}^a$ , for 1 < n < L, becomes

In general, even if the initial conditions are not translationally invariant, one can solve the above equation. However, assuming that the initial conditions are translationally invariant, simplies the calculations. Assuming that the initial conditions are translationally invariant, as the dynamics is also translationally invariant,  $E_{k:n}^{a}$  is independent of k, and so one arrives at

#### 3 k-site interactions

Now, let's go further and consider the more general case of k-site interactions. The problem of single-species k-site interactions solvable in the framework of empty intervalmethod was addressed in [25]. In that article necessary conditions for a system to be solvable through the EM was obtained. Here we obtain the necessary and su cient conditions for a system to be solvable through the GEM. To x notation, let's introduce

First consider the bulk terms in the time derivative of  $E_n^a$ 's. Demanding that the bulk terms can be expressed in terms of the expectations of  $E_n^a$ 's, one arrives at the following condition for the bulk terms.

Equations (33) to (36) can be solved to obtain a certain set of correlation functions (E  $_n^a{}^{\prime}s)$  .

# 4 A three-site model with annihilation, as an example

Here, a model with three-site interactions is considered. Each site may be occupied or be a vacancy. A particle at each site may be annihilated, and the annihilation rate depends on its neighboring sites. The interactions are

(A and; denote an occupied site and an empty site, respectively.) Choosing  $a=(1\ 0)$ , it is seen that this model full list he conditions needed for solvability. This means that the evolution equations for  $E_n$ 's with  $E_n=hN_1$  \_\_nNare closed. Using the method introduced in previous sections, one can obtain  $E_n$ 's. The evolution equation for  $E_n$ 's are

where  $_{k}$ 's are arbitrary constants to be determined from the initial conditions.  $E_{1}$  is also easily determined from the second equation of (40).
