No-soliton (soliton phase transition in a trapped one-dimensional Bose gas

Following the experimental observation of bright matter-wave solitons [L.K haykovich et al., Science 296, 1290 (2002); K.E. Strecker et al., Nature (London) 417, 150 (2002)], we develop a semi-phenomenological theory for soliton them odynamics and not the condensation temperature. Under a modiled them odynamic limit, the condensate occupation at the critical temperature undergoes a sudden jump to a nonzero value, indicating a discontinuous phase transition. Treating the condensation as a dilusion over a barrier shows that the condensation time is exponentially long as one approaches the thermodynamic limit, and the longest near the critical temperature.

Quantum-degenerate atom ic gases are attracting attention as versatile physics laboratories with unprecedented level of experimental control [1]. Nonlinear science in particular should bene to from the study of dark [2] and bright [3, 4] matter-wave solitons [5] recently observed in one-dimensional (1D) Bose gases, whose mean-eld dynamics is described by the 1D nonlinear Schrodinger equation. Much recent theoretical work on 1D matter-wave bright solitons is dedicated to explaining their formation, observed number, and dynamics [6] and to proposing new ways of generating them [7]. We shall consider instead the thermodynamics of this system, rarely of central importance in other nonlinear media.

M icroscopically, a bright soliton is a many-body welllocalized bound state of an attractive gas. While at zero tem perature this state contains all the atom s, at su ciently high temperature it should disappear. We describe the 1D harm onically trapped gas using a model with exactly solvable therm odynamics and show that, in a modied thermodynamic limit, the change in the bound-state population happens through a discontinuous phase transition. Our main computational result is the critical tem perature, with accompanying phase diagram . Finally, we turn to metastability issues and consider condensate form ation (and evaporation, above the critical tem perature) as a di usion over a potential barrier. We not that the transition time increases roughly exponentially with a parameter characterizing the proxim ity to the therm odynam ic lim it, the duration peaking near the critical tem perature.

G round state. The H am iltonian for a 1D system of N attractive —interacting bosons in a harm onic trap is

We assume the 1D coupling constant to be negative, $g_{1D} < 0$; its relation to the 1D scattering length a_{1D} is $g_{1D} = 2^{-2} = (m \ a_{1D})$. In the actual waveguide or cigar trap experiments the value of a_{1D} is governed by the 3D scattering length a and size of the ground transverse state $a_? = \frac{1}{2^{\sim} = m \ !_?}$, namely $a_{1D} = (a_?^2 = 2a)$ [Legardon Canada Caracha IIII]. In the absence of the trapping potential the exact ground state of the Hamiltonian (1) assumes a known Bijl-Jastrow form [9, 10, 11] $(z_1; :::; z_N) =$ $_{1}$ $_{i < j}$ $_{N}$ e $^{jz_{j}}$ $^{z_{1}j=a_{1D}}$; where A is the normalization constant. Ground state energy is then E $_0^{\rm exact}\,(\!N\,)$ = $\frac{1}{24}$ m $g_{1D}^2 = ^2$ N (N 2 1): The center of mass of a system in this state is delocalized, although the relative motion of particles is tightly bound. If we now add a weak harm onic con nem ent $U_{\text{trap}}(z) = m!_z^2 z^2 = 2$; (where the chemical potential of the free space soliton $m (qN)^2 = 2$ ~!z), the one-body density distribution becomes localized around the origin. In the limit of large N , m ean-eld theory predicts a one-body density distribution of the form $(z) = _0 = \cosh^2(z=')$; where $_0$ = (2') 1 is the peak density and '= 2^2 =m gN is the density pro le width [10, 11].

M odel H am iltonian. We analyze the therm odynam ics of our system using the following H am iltonian:

1D harm onic oscillator, and $!_{z}$ is the frequency characterizing the longitudinal connement. The Fock vacuum for the bosonic annihilation and creation operators \hat{a}_{s} and \hat{a}_{s}^{v} ; where $[\hat{a}_{s};\hat{a}_{s}^{v}]=_{s;s^{0}};$ is the harm onic oscillator ground state. Note that the ground state of the Hamiltonian P corresponds to all N particles being in the soliton, so that the rst excited state is N 1 particles in the soliton, 1 particle in the lowest harm onic oscillator state s=0: The energy spectrum thus has a gap, about equal to the chemical potential of the free space soliton, as can also be conmed by Bogoliubov analysis [10].


By far the most \phenomenological" assumption we made is the conjecture that even at nite temperatures the condensate is not fragmented, but only depleted. This conjecture is con med in ab initio calculations for m esoscopic (N 40) numbers of atom s in a 1D box [2]. Next comes the assumption that the solitonic condensate is not deformed by the external harmonic con nem ent, leading to the requirem ent[17] $\sim !_z$ 0 = 0 = 0 = 0m $(gN_0)^2 = \sim^2$: We further neglect interactions both between the noncondensed particles and between noncondensed particles and the soliton. The form er can be justied for the case of well-delocalized noncondensed cloud. To justify the latter notice that under the above requirem ent of no deform ation by the external con nem ent, the size of the soliton 'becomes, much less than the size of the trap ground state $a_z = 2 \sim m !_z$. One can show that strong but well-localized perturbation cannot a ect the overall density of states. The assumption can also be justi ed via a Bogoliubov-like analysis of the problem [11, 12]. Finally, in our Hamiltonian we neglect the center-of-m ass motion of the soliton as it can be shown to be fully decoupled from the rest of the system.

Finite size therm odynam ics. Therm odynam ics of our system is determined by the canonical partition function




FIG. 1: Solitonic condensate fraction vs. tem perature for N = 1050 7 Li atom s of a scattering length $a_{3D}=-1.46$ nm , con ned in a cigar-shape trap with frequencies ! $_{?}=2\,$ 300 Hz and ! $_{z}=2\,$ 3 Hz. This set of parameters corresponds to = 56 \sim ! $_{?}$, " = 1:77 $\,$ 10 4 , and = 0:186. (a) Finite theory; (b) thermodynamic limit, "! 0, with the value of the energy scale $\,$ and rescaled total number of particles kept constant. The critical temperature k_{B} T $_{c}=1:65$ \sim ! $_{?}$ corresponds to $_{c}=:0293$.

is the canonical partition function for N 0 non-interacting bosons in a 1D harm onic trap [13]. In Fig. 1 (a) we show the m ean soliton occupation and its standard deviation due to therm odynam ic uctuations as a function of temperature for a typical experimental setup. In this calculation we have replaced the sum over N $_0$ by an integral and used a large temperature ($k_{\rm B}\,T$ \sim ! $_z$) approximation for the partition function of noncondensed particles,

Scaling. The following scaling has proven useful for analyzing therm odynam ical properties of our system. Let us introduce a dimensionless parameter " $(m g_{1D}^2) = (\sim^3 !_z)$, a dimensionless rescaled temperature

kg T=; and a dimensionless rescaled number of particles "N, where (A! $_{\rm z}^2$)= (m $_{\rm n}^2$). We also introduce rescaled numbers of condensed ($_{\rm 0}$) and noncondensed ($_{\rm 0}$) particles in an analogous way. The parameter " can be shown to be proportional to the ratio between the binding energy of a 1D dimer $_{\rm b}$ = (m $_{\rm n}^2$)=(4~2) and the trap level spacing ~! $_{\rm z}$: "= (1=4) ($_{\rm b}$ =~! $_{\rm z}$). The rescaled partition function is

Notice that the positions of the extrem a of the Landau free energy $f_{\tt "}(\ ;\ j_0)$ as a function of $_0$ does not depend on either the energy scale or the parameter ". Here we attempt to identify the rescaled number of con-




FIG. 2: Free energy as a function of the order parameter $_0$ for the set of parameters corresponding to Fig. 1.

densed particles $_0$ w ith the order param eter of a possible phase transition. The distribution of the order param eter is given by the Boltzm ann distribution of a particle w ith coordinate $_0$ moving in the potential eld $f_{\text{m}}(\ ;\ j_0)$ at a temperature . In the limit where the variation of the elective potential f_{m} becomes large as compared to the temperature, the order parameter becomes frozen at the global minimum of f_{m} . The appearance of a global minimum dierent from $_0=0$ is associated with a phase transition. Depending on whether the minimum undergoes a nite jump from zero or gradually moves away from it as a function of temperature, the phase transition is usually said to be rst or second order.

Note that the shape of the free energy $f_{\tt m}$ as a function of $_0$ is given by a universal function independent of both the energy scale and the parameter ". However, the amplitude of $f_{\tt m}$ is inversely proportional to ".

Free energy. Let us analyze the evolution of the free energy vs. $_0$ curve with changing tem perature. Figure 2 corresponds to the experimental conditions of Fig. 1. For this set of parameters we get " = 1:77 10 4 and = 0:186. For high tem peratures the only minimum of free energy is located at $_0$ = 0. At = :0300 a second minimum appears and at = $_c$ = :0293 it becomes global ($_0$ = 0:0820, N $_0$ = 462), moving then gradually toward $_0$ = as the tem perature decreases. Since the height of the free energy curve is nite, we do not expect any sharp change at = $_c$ (k_B T = 1:65 \sim !?). Nevertheless, Fig. 1(a) shows that at this tem perature the condensate occupation does begin to increase rapidly.

Therm odynam ic lim it and phase transition. We are going to identify a lim it where the above-described quasi-discontinuity in the number of condensed particles becomes a real discontinuity. Consider the following lim it:




FIG. 3: Phase diagram of the solitonic Bose condensate

Notice that in this limit the Landau free energy $f_{\text{m}}(\;;\;\;j_0)$ grows to in nity while preserving its shape along with positions of minima. A typical condensate occupation vs. temperature dependence in the thermodynam ic limit is shown in Fig. 1 (b) [18]. Figure 3 shows our system's phase diagram. It is universal, using the rescaled quantities and . Our main result is the following implicit equation for the critical temperature T_{c} :

Here w = 3 + W $_0$ 3e 3 = 2:82144::; where W $_0$ () is the principal branch of the product log (Lambert W) function [14], the inverse of x 7 xe for x > 1. Eq. (4) is valid in the currently experimentally accessible range; 1. There $_c$ satisfies = $_c \ln{(\frac{24}{(3-w)w^2} \frac{1}{c})} + O(\frac{2}{c})$: For the experiment [3], we have T $_c$ 1 K [19].

M etastability. Conclusions. We have presented an exactly solvable sem i-phenom enological theory for the therm odynam ics of harm onically trapped attractive 1D bosons. Our principal result is that this system has a discontinuous nosoliton (soliton phase transition. We computed the critical temperature and produced a phase diagram universal with respect to experimental details such as trapping frequencies, atom icm ass, and the 3D scattering length. We also described the major scaling laws governing the condensation time, showing it to be exponentially long as one approaches the thermodynamic limit. As a function of temperature, the transition time near the critical temperature is given by a peaked curve, which we determined up to a thermalization-scheme-dependent prefactor.

Experim ents thus far [3,4] m ake solitons by rst condensing repulsive atoms and then switching the sign of the coupling constant using the Feshbach resonance. This produces certain excited solitonic states that are not states of them all equilibrium. In contrast, to observe the phase transition considered in this paper one would need to produce clouds of attractive 1D atoms in states of them all equilibrium at various temperatures. While challenging, experiments like this are probably already feasible. Conceptually the simplest strategy may be to perform experiments as in [3,4], but wait long enough for the system to equilibrate before taking measurements.

An additional reservoir is required, them altransverse excitations being a good candidate. In this case the numbers of atoms involved should be understood as those in the ground transverse mode of the trap.

[19] This tem perature is in fact many times higher than the transverse con nem ent level spacing ~! $_2$ =k $_B$, making our 1D model invalid at T $_c$. In reality the experimental tem –

perature was much less than $T_{\text{\scriptsize c}}$.
