P latoon form ation in a tra c m odel with variable anticipation

A cellular autom aton m odel of tra c ow taking into account velocity anticipation is introduced. The strength of anticipation can be varied which allows to describe di erent driving schemes. We nd phase separation into a free-ow regime and a so-called v-platoon in an intermediate density regime. In a v-platoon all cars move with velocity v and have vanishing headway. The velocity v of a platoon only depends on the strength of anticipation. At high densities, a congested state characterized by the coexistence of a 0-platoon with several v-platoons is reached. The results are not only relevant for autom ated highway systems, but also help to elucidate the e ects of anticipation that play an essential role in realistic tra c m odels. From a physics point of view the m odel is interesting because it exhibits phase separation with a condensed phase in which particles m ove coherently with nite velocity coexisting with either a non-condensed (free- ow) phase or another condensed phase that is non-m oving.

I. IN TRODUCTION

In the last years, the continuous increase of trac dem and has prom pted authorities around the world to place m ore emphasis on improving the eciency and capacity on the roadway system s. Ecological considerations, space and budgetary constraints have limited solving trac congestion by upgrading and constructing new roadway system s. A dvanced technologies for vehicular trachave been developed as a mean to improve the management of existing system and thus to solve trac congestion, environmental issues and improve trac safety. However, to achieve these aims, an accurate forecast of the impact of these technologies is critical before their nal deployment.

Testing these advanced technologies on real tra c is not always feasible. In contrast, computer simulations as m eans for evaluating control and m anagement strategies in tra c systems have gained considerable importance because of the possibility of taking into account the dynam ical aspects of tra c (see for example, [1, 2, 3]) and assessing the perform ance of a given advanced technology in a short time.

Cellular Autom ata (CA) models for trac ow [4, 5] have shown the ability to capture the basic phenom ena in trac ow [6]. Cellular autom ata are dynam ic models in which space, tim e and state variables are discrete. D iscrete space consists of a regular grid of cells, each one of which can be in one of a nite number k of possible states. All cells are updated in discrete time-steps. The new state of a cell is determ ined by the actual state of the cell itself and its neighbor cells. This local interaction allow s us to capture m icro-level dynam ics and propagates them to m acro-level behavior. The discrete nature of CA m akes it possible to simulate large realistic trac networks using a m icroscopic m odel faster than real time [5, 7, 8]. Now, alm ost eleven years after the introduction of the rst CA m odels, several theoretical studies and practical applications have in proved the understanding of empirical trac phenomena (see e.g. [6, 9, 10, 11]). M oreover, CA m odels have proved to be a realistic description of vehicular trac in dense networks [7, 8].

In this paper, we propose a single-lane probabilistic model based on the rst CA model of Nagel and Schreckenberg [4] (hereafter cited as the NaSch model) to describe the e ects of several anticipation schemes in tra c ow. Anticipation in tra cm eans that drivers estimate their leader's velocities for future time-steps [12, 13, 14, 15, 16, 17, 18]. This can lead to an increase of the vehicular capacity and a decrease of the speed variance. However, incorporating di erent driving strategies requires a safety distance with respect to the preceding vehicles. For that purpose we introduce a new parameter in the deceleration process, called anticipatory driving param eter, to estim ate the velocity of the precedent vehicle. This estimation, plus the real spatial distance to the leading vehicle, determ ine a safe braking distance. By appropriately tuning this new parameter di erent tra c situations of non-autom ated, autom ated and mixed tra c can be considered. Furtherm ore, the

anticipatory driving param eter is relevant for A utom ated H ighway System s (AHS) [19, 20].

According to simulation results from our proposed model, the relations derived from the density vs. velocity and density vs. ow curves are in agreement with the fundam ental diagram s that describe these relations in real non-autom ated tra c. In addition, simulation results from ourm odel in the case of high anticipation (like autom ation) describe one of the interesting phenom ena in tra c ow, form ation of platoons. We will show that, in contrast to models without anticipation, dense platoons can be form ed where all cars move coherently with som e nite velocity v > 0. The mechanism for platoon form ation is not only of great in portance for AHS to increase highway capacity in a much saferway [21], but also helps to understand the essential role of anticipation e ects in realistic tra cm odels. By varying the anticipatory driving param eter three di erent regim es, characterized by di erent slopes of the fundam ental diagram s, can be observed. A part from a free-ow and a congested phase, an additional regime where platoons of cars moving with the same velocity $v < v_{max}$ 1 exist.

The paper is organized as follows. In Section II we dene a modi ed NaSch model to consider di erent driving strategies. In this way, we introduce a new parameter to determ ine a velocity-dependent braking distance. In Section III, we present the results of our investigations. W e show results for the fundam ental diagram and di erent values of the anticipation parameter. A comparison with those for otherm odels and real non-autom ated trafc is presented. P hase separation into a free-ow regime and so-called v-platoon is observed in a certain interm ediate density regime. For large densities, in the congested state phase separation into a dense jam (0-platoon) and v-platoons is observed. The ow structure determ ined by the existence of dense platoons with velocity v is calculated. Dependence of an optim al anticipation level on the density is found. A nalytical results are in excellent agreem ent with results from computer simulations. In the concluding Section IV we summarize our results and discuss the relevance of our results for tra cm odels and realtra c.

II. DEFINITION OF THE MODEL

In this section we introduce the proposed model. It is de ned on a one-dimensional lattice of L cells with periodic boundary conditions, which corresponds to a ring topology with the number of vehicles preserved. Each cell is either empty, or it is occupied by just one vehicle traveling with a discrete velocity v at a given instant of time. A llvehicles have a velocity that ranges from 0;:::;v_m ax. In addition, and for sim plicity, only one type of vehicles is considered. The time step (t) is taken to be one second, therefore transitions are from t! t+ 1. It can also be easily modi ed.

Let v_{i} and x_{i} denote the current velocity and position,

respectively, of the vehicle i, and v_p and x_p be the velocity and position, respectively, of the vehicle ahead (preceding vehicle) at a xed time; $d_i = x_p \quad x_i \quad 1$ denotes the distance (number of empty cells) in front of the vehicle in position x_i that sometimes is called headway.

The dynam ics of the m odelare de ned by the following set of rules, that are applied to all N vehicles on the lattice each time-step:

R 1: A coeleration

If $v_i < v_{m ax}$, the velocity of the car i is increased by one, i.e.,

with a parameter 0 1, the velocity of car i is reduced to d_i^s . [x] denotes the integer part of x, i.e. $[x + \frac{1}{2}]$ corresponds to rounding x to the next integer value.

The new velocity of the vehicle i is therefore

R 4: Vehicle m ovem ent

Each car is moving forward according to its new velocity determ ined in steps 1-3, i.e.,

Rules R1, R2 and R3 are designed to update velocity of vehicles; rule R4 updates position. A coording to this, state updating is divided into two stages, rst velocity, second position. Note that this division follows the scheme in di erential equation integration that rst updates the time derivative and then the value of the state. It is important to mention that we are changing the order of the rules in comparison with NaSch model since R2 is applied before R3.

Rule R1 indicates that all the drivers would like to reach the maximum velocity when possible. Rule R2 takes into account the di erent behavioral patterns of the individual drivers in which with no apparent reason a driver decreases its speed. These situations include, for example, cases of overreaction in braking or incidents along the highway that distract drivers, and random uctuations.

RuleR3 is the main modi cation to the original NaSch m odel [4]. In this rule the distances between the ith and (i+1)th vehicles, and their corresponding velocities are considered. K now ledge of the preceding vehicle's velocity is incorporated through the anticipatory driving param eter with range 0 1. Notice that, by only varying the parameter in the term $d_i^s = d_i + [(1$ $v_{p} + 1=2]$ di erent anticipatory driving schem es that require di erent safe braking distance with respect to the preceding vehicle can be modelled. If takes its maximum value (=1) the speed of the vehicle ahead is not considered in the deceleration process, i.e. anticipation is not considered. 0 n the contrary, when = 0 the speed of the vehicle ahead is considered without restrictions, i.e., without establishing a braking distance with respect to the precedent vehicle [20]. This last case occurs with either a very aggressive driver or when vehicles can obtain inform ation about the velocity of vehicles ahead [29] to allow sm all distances between vehicles (e.g. of the order 1 m). Interm ediate values for thus represent di erent braking spacing policies or degrees of autom ation in the vehicles or anticipatory driving schemes. Platooning schemes [21] imply values of closer to zero and dem and additional requirem ents to preserve safety, like coordinated braking [19]. Independent vehicle driving with low level of anticipation in plies values of closer to 1 in order to preserve safety levels: the larger is the larger braking distance is. Note that in order to determ ine v_n consistently for all vehicles in the case of periodic boundary conditions, rule R3 must be iterated at most (v_{max} 1) times. In real situations, the drivers alw ays estim ate the velocity of preceding vehicle and according to this and their way to drive (relaxed or aggressive behavior) they choose a safe headway distance to drive. Variation of allows also to m odel these aspects.

Thus, the proposed m odel is able to represent di erent anticipatory driving schemes, and model the minimum braking distance required with only one parameter , here referred to as anticipatory driving parameter.

W e em phasize that the CA m odel as presented here is a m inim alm odel in the sense that all four steps R 1-R 4 are necessary to reproduce the basic features of real tra c, how ever, additional rules m ay be needed to capture m ore com plex situations [13].

III. SIM ULATION RESULTS

To simulate the CA model proposed in the previous section, the typical length of a cell is around 7.5 m. It is interpreted as the length of a vehicle plus the distance between cars in a dense jam, but it can be suitably adjusted according to the problem under consideration. W ith this value of the cell size and a time-step of 1 s, v = 1 corresponds to moving from one cell to the downstream neighbor cell in one time-step, and translates to 27 km/h in real units. The maximum velocity is set to $v_{max} = 5$, equivalent to 135 km/h. The total number of cells is as-

sum ed to be $L = 10^4$, and the density is de ned as = N = L, where N is the number of cars on the highway. Initially, N vehicles are distributed random by on the lane around the loop with an initial speed taking a discrete random value between 0 and $v_{m ax}$. Since the system is closed, the density remains constant with time.

Velocities are updated according to the velocity updating rules R1 R2 R3 and then all of cars are m oved forward in step R4. Each run is simulated for T = 6Ltime-steps. In order to analyze results, the rst half of the simulation is discarded to let transients die out and the system reach its steady state. For each simulation a value for parameter is established by taking into account the desired anticipation degree and thus, controlling the safe braking distance among vehicles. In the following, the value of is the same for all vehicles (hom ogeneous drivers).

A. Comparison with real non-autom ated tra c




FIG.1: Typical form of an empirical fundam ental diagram taken from [23] (solid line) in comparison with simulations of the proposed m odel for R = 0.2 and = 0.75 (dashed line).

The fundam entaldiagram is one of the most important criteria to show that the model reproduces trac ow behavior. This diagram characterizes the dependence of the vehicles ow on density. We obtain a fundam ental diagram for the proposed model with R = 0.2 and = 0.75, see Fig. 1. This value corresponds to cautious estim ation of the preceding car's velocity.

As we can see from Fig. 1, the curve of the proposed model (dashed line) is consistent with the characteristic curve of the measured fundam ental diagram (solid line) taken from [23]. The critical density and the maximum ux of our model are $(_{c};q_{max}) = (16\%; 2417 \text{ cars/h})$, cbser to the empirical curve values of $(_{c};q_{max}) = (17\%; 2340 \text{ cars/h})$, in comparison with other existing models, see [15]. Note the quantitative agreem ent between simulated and empirical curve of the fundam ental diagram in its decreasing part.

M oreover, as we can see from Fig. 1, a decrease in the experimental curve slope is observed at (10%;1692 cars/h), corresponding to a reduced mean velocity of vehicles near the critical density. Thus, we make a smallmodi cation to the proposed model based on an idea of [24]. We modied the deceleration rule such that a vehicle can only reach them aximum velocity if its braking distance to the precedent vehicle is greater than nine cells (67.5 m, i.e., the density is lower than 0.1). The modied rule R 3 of the model is then as follows:

R 3': If $v_i = 5$ (i.e. $v_i = v_{m ax}$) and $d_i^s = 9$ cells then

In Fig.2, the results obtained from our modi ed model are shown and compared with the experimental curve

from realtra c data [23]. The curve resulting from the m odi ed m odel ts the real curve in both its increasing part and its decreasing part quite well. Thus, the results from the m odi ed m odel agree quantitatively with the experimental shape of the fundamental diagram. This is an indication that in realtra c the value of m ay depend on velocity.

In this subsection, we have shown that the given m odel can reproduce some common characteristics of the real m anual (non-autom ated) trac ow. However, with the new parameter it is possible to consider several anticipation schemes for trac ow: non-autom ated, m ixed and autom ated trac ow. This will be shown in the following for the original model (R3) de ned in Sec. II.

B. Modeling di erent anticipation schemes




FIG.3: Fundam ental diagram for di erent values of the anticipation parameter and R = 0.2.

D eterm ination of the im pact of di erent driving strategies is important in order to propose autom ated tra c alternatives. Following that proposal, we decided to investigate tra c ow behavior using our model. As mentioned above, the parameter represents the way in which di erent driving strategies adopt a braking distance with respect to the preceding vehicles. Varying the parameter , these strategies can be tuned. In Fig. 3 we show the fundam ental diagram of the proposed m odel with a xed value of R = 0.2 and di erent values of . From this diagram, the impact of the driving strategies coded in can be observed. Smaller values of imply larger ows, that is, higher levels of anticipation. Here vehicles keep a less safe braking distance, leading to an increase in the vehicular capacity. This behavior is in agreem ent with, for example, platooning strategies that exploit the know ledge of the velocity of precedent vehicles and require a sm aller distance among vehicles (near 1 m), so increasing the ow.




FIG . 4: Relationship between mean velocity and density for R = 0.2 and di erent values of % R .

It is in portant to notice that for values of from 0.13 to 0.50 a second positive slope corresponding to a mixed branch is observed in the fundam ental diagram. It is interesting that the initial positive slope, corresponding to a free-ow region where there are no slow vehicles, is similar for all values of . Here the vehicles travel at near maximum speed. For the second branch, on the other hand, the ow is increased with non-maximum velocity, indicating a mixed region due to anticipation e ects (Fig. 4). In order to analyze the role of the anticipation, we show the average velocity as function of the density for the same parameter values as in Fig. 3.

A swe can see from Fig. 4, higher levels of anticipation (sm aller values of) in ply a larger density interval for the free- ow region. For values 0.13 < 0.50, after

the free-ow region, trac ow organizes in a so-called mixed region with a lower mean velocity. In this mixed region, in addition to free owing vehicles, and vehicles moving in platoons where all cars have the same velocity and vanishing headway exist. The existence of this mixed region indicates that a suitable estimation of the velocity of precedent vehicle, coded in , allows that more cars to t on the road and the ow increases ever for values of large-density.




FIG. 5: Space-time diagram showing the time evolution of a system simulated initially with = 0.51. A fter switching to = 0.5, the behavior changes dram atically.

Fig.5 shows a space-time diagram for R = 0.2, = 0.5 that exemplies the dramatic changes in the microscopic structure when changing the value of [30]. The sim – ulation is started with = 0.51 where the jamming regions travel backwards. However, after some time we switch to = 0.5 and immediately observe a dramatic

change in the slope of the congested regions. They are now traveling forward. This behavior has been observed before in anticipatory modeling [18]. Such structured ow observed in space-time diagrams increases the highway capacity due to the space reduction among vehicles. In these simulations we have found that the branches of congested or jammed ow collapse to a single region as in the VDR model [25]. These results are analogous to those for slow-to-start models, because e ectively the out ow from a jam is reduced compared to the maximal ow.




FIG.6: Standard deviation of the speed.

On the other hand, it is also in portant to analyze the e ciency oftra c. In non-equilibrium situations, this is usually evaluated by analyzing the entropy of the system . However, for non-physical systems the analysis of the standard deviation of the main variable can give equivalent information [26]. In the context of trac ow, high standard deviation of speed means that, on average, a vehicle would experience frequent speed changes per trip through the system. In turn, the high speed variance could also increase the probability of trac accidents. Therefore, the standard deviation of speed can be seen as an indicator of the e ciency in trac ow.

In order to analyze the e ciency of tra c with different autom ation levels, we calculate the standard deviation of speed (Fig. 6). For each value of a maximum that occurs shortly after the free-ow region can be clearly seen. In the free-ow region, the speed variance is negligible since there are no slow vehicles and uctuations are extremely rare. Since the free-ow region increases decreases, it is seems reasonable to attempt trac as with the higher level of anticipation in the range of density from 0 to 0.5. This selection not only produces a state with higher ow, but also the lowest standard deviation, so the e ciency is the highest. It can be clearly seen from Fig. 6 that beyond the e cient density range, the level of anticipation coded in should be switched based on the density regime: for 2 (0:5;0:54], an e -

2 (0:54;0:63] the highest e ciency is attained with = 0.20. Sum marizing, the behavior observed in Fig. 6 indicates that the autom ation level should be determ ined depending on the density: higher densities require a low er autom ation level, that is, a safer braking distance.

Besides, we can also see from Figure 6, the standard deviation of speed resulting from assigning a random value of between 0 and 1 to each vehicle. We stress that for each car, this value of is not changed during the time evolution. Therefore, we simulate, by means of random values of , trac with non-hom ogeneous drivers: aggressive, non-aggressive and relaxed drivers. We can see from Fig. 6 the region where the standard deviation is negligible is close to that resulting from hom ogeneous drivers with = 0.2 (high-level anticipation). How ever, the variance of vehicles speeds is 60% larger than that corresponding to hom ogeneous drivers.




FIG. 7: C om parison of the fundam entaldiagram s of hom ogeneous system s with the random case.

In order to elucidate the e ects of anticipation with non-hom ogeneous drivers, the fundam ental diagram obtained for this random case is compared with that for = 0.2 in a hom ogeneous system (Fig. 7). Note that the second slope corresponding to a mixed region is missing in the inhom ogeneous system. In this case, the variance in the level of anticipation considered by the drivers produces higher uctuations of speeds, and the ow decreases rapidly. Therefore some anticipation driving schemes have a strong in pact on the e ciency of the system. All of these notings require physical explanations [27].

C. Structure of the m ixed states

The behavior in the mixed states is determined by the existence of dense platoons in which vehicles move coherently with the same velocity v. In the following these will be denoted as v-platoons. The stationary state then shows phase separation into a free-ow region and a vplatoon. This is similar to the behavior observed in models with slow-to-start rules where the system separates into free ow and a dense jam, i.e. a 0-platoon [25].




FIG.8:Velocity distributions for density = 0.4 and di erent values of .

Fig.8 shows the velocity distributions of the di erent branches. It can be clearly seen that only cars with velocity v and free owing cars (with velocity $v_{m\ ax}$ or $v_{m\ ax}$ 1 due to the random ization) exist.

Since the headway d_i of a car i inside a v-platoon is $d_i = 0$, its new velocity is determined by $v_i^0 = m$ in $(v_i; d_i^s)$ with $d_i^s = (1) \quad y + \frac{1}{2}$. For a stable v-platoon, v_i^0 must be equal to v. This gives the following stability condition:

Equation (1) can be regarded as a condition for the anticipation parameter \cdot . It implies that a v-platoon can only be stable for

However, this condition is only necessary, not su cient. The v-platoons that can be realized for a given also depend on the random ization R. E.g. for R = 0.2, platoons with v = 0;1;2;3 occur, whereas for R = 0.4platoons with v = 3 can not be observed in the innite system although they might exist in small systems. Simulations indicate that the slope of the mixed branch in the fundamental diagram has to be smaller than $(1 \quad R)(v_f \quad 1)$ where v_f is the average velocity in free ow: $v_f = v_{m ax}$ R. This will be discussed in Sec. IIIE in more detail.

A nother criterion for the stability of platoons can be derived from the condition that the in ow and out ow of the platoon have to be identical in the steady state. In the following we will derive estimates for these ows and in this way obtain the fundamental diagram in the mixed region.

The out ow from a v-platoon is determined by the average time T_w needed by the leading vehicle of the platoon to accelerate to velocity v + 1. Assuming that this car has a large headway, this time is determined by the random ization constant R through $T_w = \frac{1}{1 \ R}$. Therefore, in the free-ow region of the system, the average headway x $_f$ is given by x $_f = T_w (v_f \ v) + 1$. This consideration is very similar to the reasoning used in [25].

A ssum ing that the platoon consists of N $_{\rm v}$ and the free-ow region of N $_{\rm f}$ vehicles, we have

Here N is the total number of cars. Furtherm ore it has been assumed that the transition region between the platoon, where all cars have headway $d_i = 0$, and the freeow region, where the average headway is given by x_f , can be neglected. E liminating N_f we nd

We now can calculated the ow J = v of the corresponding phase-separated state. The average velocity v in the presence of a v-platoon is given by

A straightforward calculation using the results given above yields for the ow

These results are in excellent agreement with the results from computer simulations. Since 1 R < 1 it implies that all slopes corresponding to mixed states in the fundamental diagram are positive, except those for 0-platoons (> 0.5 see Fig. 3) which are responsible for the jammed branch with low ow and negative slope.

D . Structure of the congested states

For large densities allanticipatory curves (0.5) collapse on one congested branch where the ow decreases with increasing density. Simulations indicate that the structure of the corresponding states depends on the param eter regime. In the range (2), where a v-platoon can exist, the congested branch is characterized by the coexistence of a compact jam (0-platoon) and various vplatoons. The v-platoons are form ed when a bunch of vehicles escapes from the jam. As argued in Sec. IIIC, the rst car escapes after an average waiting time $T_w = \frac{1}{1 R}$. D ue to anticipation, with probability 1 R the second car can m ove in the same time-step, and so on. Therefore the average number of cars escaping in the same time-step is given by

These cars form a v-platoon of length lwhere the value of v depends on the parameter region as discussed above. Since the average waiting time for the escape of a car is T_w , the average distance between two v-platoons is $x_c = vT_w = \frac{v}{1.R}$.

To calculate the ow in the congested branch, we again neglect the transition regions and assume that only one jam with N₀ vehicles and n v-platoons with a totalnum - ber of N_v cars are present. Then we have N₀ + N_v = N with N_v = nl. Furtherm ore N₀ + N_v + n x_c = L where N₀ and N_v are the total lengths of the platoons and n x_c is the total space between the platoons. These relations yield

The average velocity of the vehicles in the congested branch is $v = \frac{N_v v}{N}$. Using (9), this implies for the ow

Note that this result is independent of the velocity v of the platoons! It is in excellent agreement with the sim – ulation data, justifying e.g. the assumption made about the transition regions.

E. Stability regions

For xed we now can estimate the stability region $_{1}$ $_{2}$ for the mixed states. At the lower boundary density $_{1}$ the number of cars N_v in the v-platoon vanishes. From (5) one has $_{1}$ x_f 1 = 0 which yields

The upper bound $_2$ is not determ ined by the condition $N_v = N$, i.e. all cars belong to the v-platoon. This would correspond to the density = 1. In fact, the instability of the mixed state occurs earlier. At the density

the ow (7) of the mixed branch becomes larger than that of the congested branch, see (10) and therefore (at least

for random initial conditions) the ow of the congested branch is observed. However, our simulations have given indications for hysteresis e ects and metastability in the large density regime. We will discuss these in more detail in a future publication [27]. For v = 0 the upper transition density becomes $_2 = 1$, independent of R, consistent with the observation (Fig. 3) that the mixed region for v = 0 extends up to the maxim aldensity.

Since $_2$ has to be larger than $_1$, this yields an additional condition for the stability of the branches. It is easy to check that $_1 < _2$ if

This is just the condition obtained in Sec. IIIC from computer simulations.

Sum m arizing, a m ixed region w ith v-platoons can only exist for 1=(2(v+1)) < 1=(2v) and R satisfying (13). If these conditions are fullled, v-platoons occur in the density interval $_1$ $_2$ where $_1$ and $_2$ are given by (11) and (12), respectively.

IV. SUMMARY AND CONCLUSIONS

Forecasting the impact of dierent anticipation schemes plays a essential role in real trac ow in order to propose automated trac alternatives. In this paper we have introduced and investigated a modi cation of the NaSch model to better capture reactions of the drivers intended to keep safety on the highway. As a result, an anticipation parameter 2 [0;1], that allows to determ ine a velocity-dependent safe braking distance of the precedent vehicle, is included. The addition of this parameter proves to be useful to describe dierent trafc situations of non-automated, automated, and mixed trac.

Simulation results presented here for hom ogeneous drivers, corresponding to a cautious estimation of the preceding car velocity (large), are in excellent agreement with the shape of the empirical fundamental diagram.

On the other hand, simulation results for driving schemes associated to intermediate-levels of anticipation with from 0:13 to 0:5 (hom ogeneous drivers), exhibit phase separation in a certain density regime into a free-

ow region and so-called v-platoons. In these dense platoons vehicles move with the same velocity v and have vanishing headway. The velocity v of the platoon is determ ined by the level of autom ation.

This platoon formation observed in a mixed regime plays an important role in Automated Highway Systems (AHS) to increase the vehicular capacity. Therefore, results obtained help to elucidate the e ects of anticipation coded in . The maximum ow and the density interval for free-ow regime go with the inverse of : smaller values of , (greater estimation of the precedent car velocity) imply larger ows and larger density interval for free-ow regime. This is also in accordance with, for example, the use of certain anticipation strategies to exploit the know ledge of the velocity of the precedent vehicle and so, reducing the distance among vehicles, increasing the capacity, and the density interval for free-ow regime.

M oreover, the analysis of the speed variance of individual vehicles also indicates the importance to anticipation e ects. Results indicate that level of anticipation should be determ ined based on the density. The highest-level of anticipation should be considered before the corresponding maximum density for free- ow regime is reached. A fter that maximum density, larger density requires low erlevel of anticipation. Therefore, this selection not only produces the highest ow, but also the lowest standard deviation, and so, e ciency is the highest.

The considerations in this paper show the exibility of the CA approach to more complex tra c ow problem s. A simple and natural modi cation of the nules of the NaSch model to consider di erent driving schemes allows us to describe the form ation of coherently moving platoons observed in some anticipation schemes. We think that the results presented here are relevant to establish suitable levels of safety and autom ation not only for AHS, but also in real tra c. We stress that although in this paper the model is simulated in a single-lane on a ring, it is possible to apply it to com plex highway topologies in a satisfactory way [27].

A part from its practical relevance for tra c problem s, our work also shows interesting physical aspects. The m odel suggested here exhibits various kinds of phase separation phenomena. At intermediate densities, phase separation into a condensed (v-platoon) and a noncondensed (free-ow) phase can be observed. In contrast to most other models of driven di usion, the condensed phase is moving coherently for v > 0. At high densities an even m ore surprising state is found that exhibits phase separation between di erent condensates, a non-moving one (v = 0) and several coherently moving platoons (v > 0). To our know ledge such a behavior has not been observed before. It would be interesting to study these phases in m ore detail, especially since recently som e progress in the understanding of phase separation in driven di usive models has been made [28]. W ork in this direction is currently in progress [27].
