# U ltracold atom s in optical lattices

# Abstract

Bosonic atoms trapped in an optical lattice at very low temperatures, can be modeled by the Bose-Hubbard model. In this paper, we propose a slave-boson approach for dealing with the Bose-Hubbard model, which enables us to analytically describe the physics of this model at nonzero temperatures. With our approach the phase diagram for this model at nonzero temperatures can be quantied.

#### I. INTRODUCTION

The physics of the Bose-Hubbard model was the subject of intensive study for some years after the sem inal paper by Fisher et al., which focused on the behavior of bosons in a disordered environment [1]. More recently it has been realized that the Bose-Hubbard model can also be applied to bosons trapped in so-called optical lattices [2], and mean-eld theories [3, 4, 5] and exact diagonalization [6] have been successfully applied to these systems in one, two and three dim ensional systems. The experim ents performed by Greiner et al. [7] have con m ed the theoretically predicted quantum phase transition, i.e., a phase transition induced by quantum uctuations, between a super uid and a M ott-insulating phase. A review of the work carried out in this eld has been given by Zwerger [8]. Strictly speaking the above m entioned quantum phase transition occurs only at zero temperature [9]. At nonzero tem peratures there is a classical phase transition, i.e., a phase transition induced by therm al uctuations, between a super uid phase and a normal phase and there is only a crossover between the normal phase and a Mott insulator. It is important to mention here that a M ott insulator is by de nition incompressible. In principle there exists, therefore, no M ott insulator for any nonzero temperature where we always have a nonvanishing compressibillity. Nevertheless, there is a region in the phase diagram where the compressibility is very close to zero and it is therefore justi ed to call this region for all practical purposes a M ott insulator [5]. Qualitatively this phase diagram is sketched in Fig. 1 for a xed density. This gure shows how at a su ciently small but nonzero temperature we start with a super uid for small positive on-site interaction U, we encounter a phase transition to a normal phase as the interaction strength increases, and ultimately crossover to a Mott insulator for even higher values of the interaction strength. We can also incorporate this nonzero temperature behaviour into the phase diagram in Fig. 2. This gure shows how at zero temperature we only have a super uid and a M ott insulator phase, but as the temperature is increased a nom alphase appears in between these two phases.

The aim of this paper is to extend the mean-eld approach for the Bose-Hubbard model to include nonzero temperature elects and make the qualitative phase diagrams in Figs. 1 and 2 more quantitative. To do that we make use of auxiliary particles that are known as slave bosons. The idea behind this is that if we consider a single lattice site, the occupation number on that site can be any integer. With each dierent occupation number we identify a new particle. Although this means that we introduce a lot of dierent new particles, the advantage of this procedure is that it allows us to transform the on-site repulsion into an energy contribution that is quadratic in terms of the new particles. Because we want to be able to uniquely label each dierent state of the system, the new particles cannot independently be present at each lattice site. That is why we have to introduce a constraint. Using this we derive within a functional-integral formalism and elective action for the super uid order parameter which depends on the temperature. The equivalence with previous work at zero temperature is demonstrated.

The outline of the paper is as follows. In Sec. II we introduce the slave-boson form alism and derive an elective action for the super uid order parameter. In Sec. III we present the zero and nonzero temperature mean-eld results. The remainder of the paper is devoted to the elect that the creation of quasiparticle-quasihole pairs have on the system.

#### II. SLAVE-BOSON THEORY FOR THE BOSE-HUBBARD MODEL

In this section we form alize the above introduced idea of the slave bosons. We rewrite the Bose-Hubbard model in terms of these slave bosons within a path-integral formulation and derive an elective action for the super uid order parameter, which then describes all the physics of our Bose gas in the optical lattice.

The slave-boson technique was introduced by K otliar and R uckenstein [10], who used it to deal with the fermionic H ubbard model. A functional integral approach to the problem of hard-core bosons hopping on a lattice has been previously put forward by Z iegler [11] and F resard [12]. Let us its shed some light on this slave-boson form alism. We consider a single site of our lattice. If the creation and an initiation operators for the bosons are denoted by  $\hat{a}_i^y$  and  $\hat{a}_i$  respectively, we can form the number operator  $\hat{N}_i = \hat{a}_i^y \hat{a}_i$ , which counts the number of bosons at the site i. In the slave-boson formalism, for any occupation number a pair of bosonic creation and annihilation operators is introduced that create and annihilate the state with precisely that given integer number of particles. The original occupation number states  $jn_i$  are now decomposed as  $jn_i^0; n_i^1; \ldots i$ , where  $n_i$  is the eigenvalue of the number operator  $\hat{n}_i$  ( $\hat{a}_i$ )  $\hat{a}_i$  formed by the pair of creation ( $\hat{a}_i$ ) and annihilation  $\hat{a}_i$  operators that create and annihilate bosons of type at the site i. As it stands, this decomposition is certainly not unique. For example, the original state  $\hat{j}(i)$  could be written as  $\hat{j}(i)$ ,  $\hat{j}(i)$ ,  $\hat{j}(i)$  is increases. To make sure that every occupation occurs only once we have to introduce an additional constraint, namely

for every site j. This constraint thus makes sure that there is always just one slave boson per site. Because in the positive U Bose-Hubbard model bosons on the same site repeleach other, high on-site occupation numbers are disfavored. It is therefore conceivable that a good approximation of the physics of the Bose-Hubbard model is obtained by allowing a relatively small maximum number, e.g. two or three or four, of bosons per site.

As is well known, the Ham iltonian of the Bose-Hubbard model reads,

Here hi; ji denotes the sum over nearest neighbours,  $t_{ij}$  are the hopping parameters, and is the chemical potential. Using our slave-boson operators we now rewrite Eq. (2) into the form

with the additional constraint given in Eq. (1). We see that the quartic term in the original Bose Hubbard Hamiltonian has been replaced by one that is quadratic in the slave-boson creation and annihilation operators, which is the most important motivation for the introduction of slave bosons.

Now that we have introduced the slave-boson method and derived its representation of the Bose-Hubbard model, we want to turn the Ham iltonian into an action for the imaginary time evolution. Using the standard recipe [13, 14] we not

Although we have simplied the interaction term, the hopping term has become more complicated. By performing a Hubbard-Stratonovich transformation on the above action we can, however, decouple the hopping term in a similar manner as in Ref. [4]. This introduces a eld into the action which, as we will see, may be identied with the super uid order parameter. The Hubbard-Stratonovich transformation basically consists of adding a complete square to the action, i.e., adding

Since a complete square can be added to the action without changing the physics we see that this procedure allows us to decouple the hopping term. where the matrix M (i! n) is related to the matrix M in Eq. (4) through a Fourier transform. In principle Eq. (6) is still an exact rewriting of the Bose-Hubbard model. As a rst approximation we soften the constraint by replacing the general constraint eld  $_{i}$  ( ) with a time and position independent eld . By neglecting the position dependence we enforce the constraint only on the sum of all lattice sites. Doing this we are only left with the 0:0 contribution in Eq. (6), which can then be added to the matrix M . The path-integral over the constraint eld reduces to an ordinary integral. So we have,

The crucial idea of Landau theory is that near a critical point the quantity of most interest is the order parameter. In our theory the super uideld plays the role of the order parameter. Only 0:0 can have a nonvanishing expectation value in our case and, therefore, we can write the ground-state energy as an expansion in powers of 0,0,

This means that  $a_2$  (;U; ) = 0 signals the boundary between the super uid and the insulator phases at zero tem perature and the boundary between the super uid and the normal phases at nonzero tem perature. Therefore we are going to calculate the e ective action of our theory up to second order in . The zeroth-order term in the expansion of the action in powers of the order param eter gives us the zeroth-order contribution  $_{0}$  to the therm odynam ic potential . We have,

Once we have this contribution, we automatically also nd the dispersion relations for the quasiparticles in our system as we will see shortly. For small we are allowed to expand the exponent in the integrand of the functional integral for the partition function as

Having performed the integrals over the slave-boson elds to second order, we can exponentiate the result to obtain the elective action for the order parameter

This result is one of the key results of this paper, which is correct in the limit of small k,n. If we want to make the connection with the Landau theory again, we can identify the  $a_2$  (;U; ) in Eq. (9) with G  $^1$  (0;0)= . In Sec. III we analyse this further.

## A. M ott insulator

In the M ott insulator where  $n_0$   $\dot{n}_{0;0}i\dot{f}=0$ , the therm odynam ic potential is now easily calculated by integrating out the super uid eld. In detail

At this point we perform a saddle point approximation for the constraint eld. This implies that we only take into account that value of that maximizes the canonical partition function. If we now thus minimize the free energy with respect to the chemical potential and the constraint eld, we get two equations that need to be solved. The rst is  $\theta = 0$  and reads,

In a mean-eld approximation the last term is neglected, and this equation tells us that the sum of the average slave-boson occupation numbers must be equal to one. This rejects the constraint of one slave boson per site. The second equation follows from @=@=N and gives

This equation shows how the particle density can be seen as the sum of terms n and a correction coming from the propagator of the super uid order parameter. The latter is again neglected in the mean-eld approximation.

## B. Super uid phase

In the super uid phase the order param eter j  $_{0;0}$   $\mathring{f}$  has a nonzero expectation value. We not this expectation value by calculating the minimum of the classical part of the action, i.e.,  $\sim G^{-1}(0;0)$   $\mathring{j}_{0;0}$   $\mathring{f}$  +  $a_4$   $\mathring{j}_{0;0}$   $\mathring{f}$ . In appendix A we calculate the coe cient a  $_4$  of the fourth order term  $j_{0,0}$   $\mathring{j}$ . # III. MEAN-FIELD THEORY

In this section, we apply the theory we have developed in the previous section. First, using the Landau procedure, we reproduce the mean-eld zero-tem perature phase diagram. We then study the phase diagram at nonzero temperatures. To do so we calculate the com pressibillity of our system as a function of tem perature, showing how for xed on-site repulsion U the Mott insulating region gets smaller. By also looking at the condensate density as a function of tem perature, we get a quantitative picture of what happens at xed on-site repulsion U. The nice feature is that all our expressions are analytic. Next, we consider our system at zero temperature again and we study at the mean-eld level the behaviour of the compressibility as we go from the super uid phase to the Mott insulating phase. What we indisconsistent with the general idea that the quantum phase transition between the Mott insulator and the super uid phases belongs to dierent universality classes depending on how you walk through the phase diagram (cf. Ref. [9]). We then obtain an analytic expression for the critical temperature of the super uid-normal phase transition in the approximation of three slave bosons, i.e., up to doubly-occupied sites. Numerically we extend this study to include a fourth slave boson and nd only slight changes to T<sub>c</sub>. From the propagator of the super uid eld we extract the dispersion relations of the quasiparticlequasihole pairs and their tem perature dependence.

## A. Zero-tem perature phase-diagram

From the zeros of G  $^1$  (0;0) in Eq. (18), we obtain the mean-eld phase diagram in the (;U) plane. For a M ott insulating state with integer lling factor  $^0$  we have n = ; $^0$ . When this is substituted into the equation G  $^1$  (0;0) = 0 we can not the U () curve that solves that equation and thus determ ines the size of this M ott insulating state. For given lling factor  $^0$  we also de ne U  $_{\rm C}$  as the m inimal U that solves the equation. Within the M ott insulating phase we have a zero compressibility  $^0$  en=0, where n = n(;U) is the total density as determined from the thermodynamic potential. Straightforward calculation

gives that we are in a Mott insulating phase whenever lies between and where,

Here we have introduced the dimensionless chemical potential =zt and on-site repulsion strength U U=zt. When does not lie between any and the Super uid density  $h_{0;0}i^2$  will no longer be zero and the Mott insulating phase has disappeared. We have drawn the zero temperature phase diagram in Fig. 3.0 ur slave-boson approach reproduces here the results of previous mean-eld studies [1, 3, 4]. For nonzero temperatures the equation  $G^{-1}(0;0)=0$  no longer describes a quantum phase transition between a super uid and a Mott insulator but it describes a them alphase transition between a super uid and a normal phase. We will look into this in more detail in Sec. IIIF.

# B. Com pressibillity

To see what happens to the M ott insulator as we m ove away from zero tem perature we m ust look at the compressibility as a function of tem perature. Numerically we have solved Eq. (20), which gives us the occupation numbers of the slave bosons as depicted in Fig. 4. With that we can determ ine the total density in the phase where the order parameter is zero. It is clear that within a mean—eld approximation the compressibility at zero temperature is exactly zero. In Fig. 4 we have plotted the total density as a function of temperature. As the temperature is raised we see that the compressibility, which is the slope of the curve, becomes nonzero. This shows that there is no longer a M ott insulator present. We also see that even though the slope is no longer zero it is very small indeed for low enough temperatures. We determ ine the crossover line by requiring that  $(T)=k_BT$  is of order one, where (T) is defined as the difference of the quasiparticle and quasihole dispersions at k=0.

## C. Super uid density

In a mean-eld approximation the super uid density is extracted from the action by nding the  $^{\dagger}_{0;0}$  if that minimizes the fourth-order action in Eq. (22),

whenever is not between and  $^{\circ}$ , and zero otherwise. We have plotted this expectation value in Fig. 5 for  $^{\circ}$  = 1. In this gure we see how the super uid density grows as a function of moving away from the Mott insulator phase. Our expansion of the Landau free energy is only valid around the edge of the Mott lobes and therefore breaks down when we go too far away from the Mott insulator. This can be seen in the gure as the decrease of the super uid density when approaches 0 and/or U. It can also be seen from the propagator of the super uid eld, which has poles when = U. For U not too far away from the insulating phase the gure quantitatively agrees with the ones calculated by other authors [4].

## D. Bogoliubov dispersion relation

We now demonstrate that the dispersion  $\sim !_k$  is linear in k in the super uid phase and that the spectrum is gapless. In the super uid phase we can expand around the expectation value  $n_0 = \sim G^{-1}(0;0)=2a_4$  of the order param eter. Up to quadratic-order this gives,

## E. Near the edges of the Mott lobe

If we substitute the vacuum expectation value of the order parameter back into our elective action, we see that the zeroth-order contribution to the therm odynamic potential in the super uid phase in mean-eld approximation is given by,

From this the particle density can be obtained by making use of the therm odynam ic identity N=0=0. We can calculate this at T=0 and take the limit! to show that the derivative of the density with respect to , i.e, 0=0 shows a kink for all  $0 \in 0$ . This means that only if we walk through the tip of the M ott lobes there is not a kink in the compressibility. In fact it's not hard to see why this is true. At zero temperature the roots of 0=00;0 are by denition 0=00. This means that we can write 0=01 (0;0) = 0=01 (0;0). The proportionality constant can be shown to be equal to 0=01 (0;0). This then shows that the therm odynam ic potential is,

Remembering that the density is the derivative of the thermodynamic potential we see that the second derivative of the thermodynamic potential with respect to can show a nonzero value upon approaching the Mott lobe. Since in the Mott isolator the density is constant and equal to we have shown the existence of a kink in the slope of the density for all paths not going through the tip of the Mott lobe. This causes the dierence in the universality class of the quantum phase transition.

# F. The super uid-norm alphase transition

In this subsection, we show that it is possible to obtain an analytical expression for the critical tem perature  $T_c$  of the transition between super uid and normal phases as a function of U, for values of U below the critical U of the zero-tem perature super uid. Mott insulator transition. The analytical result is obtained if we include occupations up to two per site, i.e., three slave bosons or occupation numbers  $n^0; n^1; n^2$ . A long similar lines  $T_c$  can be found numerically if more slave bosons are included. We have carried out this procedure for the case of adding a fourth boson (triple occupancy) and not only modest quantitative changes.

If we restrict the system to occupancies 0, 1 and 2, and x the total density  $n = N = N_s$  at 1, the occupation numbers  $n^0$ ;  $n^1$  and  $n^2$  should obey the following relations if we neglect uctuation corrections (cf. Eq. (20)):

The n are furtherm ore given by Eq. (16), enabling us to elim in ate and express  $n^0$  and  $n^2$  in terms of  $n^1$ . We obtain

The constraints in Eqs. (32) and (33) im mediately lead to  $n^0 = n^2$ , so that, according to Eqs. (34) and (35), we must have = U=2. We notice that at this level of approximation, we obtain a slight discrepancy with the result from Sec. IIIA that at zero temperature the critical value of U of the super uid-M ott insulator transition, which is the limiting U for the super uid-normal transition that is addressed here, is according to Eq. (25) with  $^0=1$  determined by = (U 1)=2 [15].

As argued above the criticality condition for the super uid-normal transition is obtained by putting  $G^{-1}(0;0) = 0$ . Restricting the sum in the right-hand side of Eq. (18) to = 0 and = 1, we obtain [16]

Since the relation between  $\,$  and U is xed by Eqs. (32) and (33), and  $n^0$  and  $n^2$  can be expressed in  $n^1$  as  $n^0=n^2=(1-n^1)=2$ , the criticality condition Eq. (36) results in a remarkably simple relation between  $n^1$  and U at  $T_c$ , namely  $n^1=(U+3)=9$ . Using this in Eq. (34) leads to the following analytic formula for  $T_c$   $T_c=zt$  for the super uid-normal transition:

It is straightforward to generalize this procedure to arbitrary integer density  ${}^0$  while allowing occupation numbers n  ${}^{^0}$ ; n  ${}^{^0}$ ; n  ${}^{^0}$ +1 only. The result is




FIG.1: Qualitative phase diagram for a xed and integer lling fraction in terms of the temperature T and the dimensionless coupling constant U=zt, with super uid (SF), normal and M ottinsulating phases (M I). Only at T=0 a true M ottinsulator exists.

The critical temperature  $T_c$  for integer—lling factor n  $N=N_s=1$ , i.e., Eq. (37), is plotted in Fig. 6. The overall qualitative behavior is as one would expect (cf. Fig. 1). A few ner details appear to be less satisfactory. For instance,  $T_c$  vanishes for U=6, whereas we would expect this to coincide with the mean—eld result for  $U_c$  for the super uid-M ott insulator transition for the rst M ott lobe, i.e.,  $U_c=5.83$  obtained from Eq. (25) with  $^0=1$ . We note that the discrepancy is not large and is even smaller for the higher M ott lobes. Indeed U ( $T_c!=0$ ) = 2(2  $^0+1$ ) versus  $U_c=(2 ^0+1)+\frac{1}{2}$  (2  $^0+1$ ). A nother feature is the maximum in the  $T_c$ (U) curve (cf. Fig. 1 and [3]). B oth featuresm entioned are caused by the fact that the two conditions Eqs. (32) and (33) are strictly enforced, whereas they become less appropriate for small U. The exact solution [17] for four slave bosons on a four site lattice for small U shows that a better result may be obtained if a fourth boson occupation number  $n^3$  is included in our approach. The set of equations to be solved then becomes, again for n=1,

Again  $n^0$ ;  $n^2$ , and  $n^3$  can easily be expressed in terms of  $n^1$ , but no exact solution appears to be possible in this case. However, we have managed to not solutions numerically. The results for  $T_c$  are depicted in Fig. 6 and show fairly little quantitative change compared to the analytical result Eq. (37). In particular,  $T_c$  still vanishes for U=6, and the maximum is still there, although shifted to a lower U=1:8 compared to U=2:15 for Eq. (37). It is satisfactory to not that for the higher values of U,  $n^1$  starts to increase rapidly towards 1, signalling the approach of the Mott-insulator phase, whereas  $n^3$  is almost negligible (< 1%) already for U=3, supporting a description in terms of 3 slave bosons only [18].

## G. Quasiparticle-quasihole dispersion relations

At zero tem perature and for a given integer lling factor  $^{0}$ , we have in a mean-eld approximation that n = ;  $_{0}$  and we retrieve the previously found result for the quasiparticle-quasihole dispersions [4]. In this case the real solutions of  $_{0}$ ! follow from a quadratic equation G  $_{0}$ 1 (k;! $_{0}$ ) = 0. At nonzero tem perature the occupation numbers in general are all nonzero and there will be more than just two solutions for  $_{0}$ !. In the set of solutions there are still two solutions that correspond to the original single quasiparticle and quasihole dispersions.

The physical interpretation of the other solutions is that they correspond to the excitation of a higher number of quasiparticles and quasiholes. In Fig. 7. we show the three low lying excitation energies for k=0 at a temperature of zt=10. To obtain an analytic expression for the single quasiparticle-quasihole dispersion we only take into account the two terms in the sum in Eq.(18) which have numerators  $n^{-1}$   $n^{-1}$  and  $n^{-1}$   $n^{-1}$ . In Fig. 8 we have plotted these dispersions at k=0 as a function of U. Comparison with Fig. 7 shows that Eq. (43) gives an appropriate description of the single quasiparticle-quasihole dispersions. As can be seen from Fig. 8 the tip of the lobe moves to smaller U as a function of increasing temperature. This can be understood because that point now describes the super uid-normal phase transition (cf. Figs. 1, 6). In Fig. 9 we show how the super uid-normal boundary in the U plane evolves for nonzero temperatures. If we dene the gap as the difference between the two solutions at k=0, we not that the gap grows bigger as the temperature increases. As we have seen in Sec. IIIB it is incorrect, however, to conclude from this that the region of the Mott insulating phase in the -U phase diagram grows as temperature increases. As mentioned previously, strictly speaking there is no Mott insulator away from zero temperature and at nonzero temperatures there is only a crossover between a phase which has a very small compressibility and the normal phase.

# IV. FLUCTUATIONS

In this section we make a rst step towards the study of uctuation e ects and derive an identity between the atom ic G reen's function and the super uid G reen's function in Eq. (18). This we then use to calculate the atom ic particle density. In appendix B we show that the easiest way to calculate the density is by making use of currents that couple to the atom ic elds. We start with the action of the Bose-Hubbard model

Note that  $Z_k$  is always positive and in the lim it where U! 1 we have that  $Z_k$ !  $(1+\ ^0)$ . The quasiparticle dispersion  $_k^{qp}$  is always greater than or equal to zero and  $_k^{qh}$  is always smaller than or equal to zero. Because of this only the quasiholes give a contribution to the total density at zero temperature. The density can be calculated from ,

If we expand the square-root denom inator of Z for small k we see that it behaves as 1=k, therefore in two and three dimensions we expect the integration over k to converge. In Fig. 10 we have plotted the density for  $^0=1$  as given by the equation above. We see that the density quickly converges to one, but near the tip of the M ott lobe in all dimensions it deviates signicantly from one. This result is somewhat unexpected and may be due to the break-down of the gaussian approximation near the quantum phase transition. A more detailed study of the uctuations is beyond the scope of the present paper and is therefore left to future work.

#### V. CONCLUSIONS

In sum m ary, we have applied the slave-boson formalism to the Bose-Hubbard model, which enabled us to analytically describe the physics of this model at nonzero temperatures. We have reproduced the known zero-temperature results and we have computed the critical temperature for the super uid-normal phase transition. The crossover from a Mott insulator to a normal phase has also been quantified. We have shown how them all uctuations introduce additional dispersion modes associated with paired quasiparticles quasiholes propagating through the system. We have also considered density uctuations induced by the creation of quasiparticle-quasihole pairs. These uctuations do not average out to zero in the gaussian approximation.

Note that in the zero-tem perature limit for the rst Mott lobe, when the slave-boson occupation numbers are proportional to a Kronecker delta, this result coincides exactly with the one previously derived in standard perturbation theory (cf. Ref. [4]).

### APPENDIX B:DENSITY CALCULATIONS




FIG. 2: Qualitative phase diagram in terms of the chemical potential =zt and the dimensionless coupling constant U=zt. For nonzero temperatures a normal phase appears.







FIG. 3: Phase diagram of the Bose-Hubbard Ham iltonian as obtained from the mean-eld zero-tem perature lim it in the slave-boson form alism. It shows the super uid (SF) phase and the Mott insulator regions with dierent integer lling factors here denoted by  $^{0}$ . The vertical axis shows the dimensionless chemical potential = =zt and the horizontal axis shows the dimensionless interaction strength U = U=zt.




FIG. 5: Super uid density j  $_{0,0}$   $\mathring{f}$  as a function of for various temperatures and for U=zt=10. The super uid density as well as the region of super uid phase dim in ish as a function of increasing temperature. The vanishing of j  $_{0,0}$   $\mathring{f}$  at =0 and =10 is an artefact of our approximation (see text).




FIG. 6: Critical temperature  $T_c$  of the super uid-normal phase transition as a function of the interaction strength U=zt. The solid line is an analytic expression obtained in the approximation where we only take into account three slave bosons. The plusses correspond to a numerical solution for the case of four slave bosons.




FIG. 7: The dispersion relations for k=0 in the case where we take into account higher lling factors at nonzero temperature. On the vertical axis is (~!~+~)=zt and on the horizontal axis is U. Here we have taken into account all the terms with = 0;1;2 at a temperature of zt = 10.




FIG. 8: D ispersion relations  $\sim$ ! + as a function of U = zt for z = 0 for zero and nonzero tem peratures. The inner lobe corresponds to zero tem perature. The outer lobe corresponds to a tem perature of zt = 3. Here we have only taken into account the rst three terms in the right-hand side of Eq. (18), i.e., in the sum we only include the terms with = 0 and = 1.




FIG. 9: The -U phase diagram for zero and nonzero temperatures. The inner lobe corresponds to the zero-temperature case. The outer lobe corresponds to a temperature of zt = 2




FIG. 10: Total density n as a function of interaction strength U=zt for the  $\;$  rst M ott lobe in two and three dimensions when including uctuations. The density approaches a  $\;$  nite value dierent from one, when approaching  $U_{\text{c}}.$
