The paraconductivity, originating from critical superconducting order-parameter uctuations in the vicinity of the critical temperature in a layered superconductor is calculated in the frame of the self-consistent Hartree approximation, for an arbitrarily strong electric eld and zero magnetic eld. The paraconductivity diverges less steep towards the critical temperature in the Hartree approximation than in the Gaussian one and it shows a distinctly enhanced variation with the electric eld. Our results indicate that high electric elds can be electively used to suppress orderparameter uctuations in high-temperature superconductors.

I. IN TRODUCTION

Due to their high critical tem perature, sm all coherence length, and quasi-two-dim ensional nature, the hightem perature superconductors (HTSC) show a much more pronounced and therefore experim entally accessible effect of therm odynamic uctuations in the critical region of the norm al-superconducting transition. In general, an enhancem ent of the conductivity, denoted paraconductivity, is observed in HTSC above T_c due to the presence of superconducting uctuations. Outside the critical region, in the absence of the magnetic eld and for small electric elds, the paraconductivity can be explained in terms of the Aslam azov-Larkin¹ theory of noninteracting, Gaussian uctuations. The initial expressions for the paraconductivity have been extended for twodimensional layered superconductors, a situation very much resembling the crystal structure in the cuprates, by Law rence and D on iach.² H ow ever, it was shown that the uctuation conductivity may be calculated in the linearresponse approximation only for su ciently weak elds, when they do not perturb the uctuation spectrum. Reasonably high values of the electric eld E can accelerate the uctuating paired carriers to the depairing current, and thus, suppress the lifetime of the uctuations, leading to deviation from 0 hm 's law . In connection with the low-tem perature superconductors, the nonlinearity has been studied theoretically for the isotropic case^{4,5} and also proven experimentally on thin alum inum $\,$ lm s. 6 The issue of the non-ohm ic uctuation conductivity for a clean layered superconductor in an arbitrary electric eld has been addressed by Varlam ov and Reggiani,⁷ starting from a microscopic approach of Gor'kov⁸ for dirty isotropic superconductors. Essentially the same dependence on tem perature and electric eld has been recently 9 derived, together with generalizations for the case of arbitrary dimension, based on the analytical derivation of the velocity distribution resulting from the Boltzmann equation for the uctuating Cooper pairs.

The above-mentioned theories do not consider the interactions between uctuations, so that uctuations can be described by the Gaussian approximation. Thus, the quartic term in the Ginzburg-Landau free energy is neglected. This approximation is known to hold for tem perature values not too close to the mean-eld transi-

tion tem perature, but it breaks down in the critical region, since the nonlinear character of the TDGL equation cannot be neglected for high densities of uctuation C ooper pairs. Several works 10,11,12,13,14,15,16,17,18 have included the interaction between superconducting uctuations in the critical transition region within different theoretical approaches. The simplest and most used one is the Hartree approximation which treats selfconsistently the quartic term in the Ginzburg-Landau free-energy expansion. In this way expressions for the specic heat have been derived for $bu \mathbb{k}^{10}$ and layered¹¹ superconductors under magnetic eld, based on the functional integral approach. In the frame of the timedependent G inzburg-Landau (TDGL) theory, U llah and Dorsey¹³ computed the Nemste ect, the therm opower, the longitudinal and the Hall conductivity in the linearresponse approximation for a layered superconductor in a magnetic eld. Using the same relaxational dynam ics of the TDGL approach, Dorsey¹⁴ provided expressions for the uctuation conductivity in both ohm ic and non-ohm ic regime, for isotropic superconductors of arbitrary dimensionality and in the absence of a magnetic eld. More recently¹⁸ the e ects of critical superconducting uctuations on the scaling of the linear ac conductivity, (!), of a bulk superconductor slightly above T_c in zero applied magnetic eld have been investigated based on the dynam ic renorm alization-group method applied to the relaxational TDGL model of superconductivity, verifying explicitly the scaling hypothesis (!;) proposed originally by Fisher, Fisher, and Huse.¹² The essential features of the scaling and renormalization-group method has been also reviewed recently by Larkin and Varlam ov.¹⁹ A more sophisticated approach based on renorm alization procedure and diagram m atic techniques has been developed for treating the non-Gaussian superconducting uctuations by Ikeda, 0 hm i and T suneto, 15 and applied to the longitudinal conductivity, the magnetization¹⁶ and the Hall conductivity¹⁷ in the linear-response approxim ation, for a layered superconductor under magnetic eld.

In this paper we shall address the problem of the nonohm ic behavior of the non-G aussian uctuation conductivity for a layered superconductor, a topic that, to our present know ledge, has not yet been treated in the literature. W hile the non-linear conductivity under arbitrarily strong electric eld was derived for a layered system 7,9 for Gaussian, noninteracting uctuations, the e ect of the critical, strongly interacting uctuation on the ohm ic and non-ohm ic conductivity was investigated¹⁴ only for isotropic system s of arbitrary dim ensionality, but not for the layered Law rence-Doniach model. The latter, however, would be required for comparison to experimental data on, e.g., $YBa_2Cu_3O_{6+x}$. The paper is organized as follows. In Section II the TDGL equations are deduced for a layered superconducting system, with the explicit consideration of an arbitrarily strong electric eld, oriented parallel to the layers. The uctuation interaction term is also included in this model, within the self-consistent Hartree approximation. Section III presents the resulting equation solutions, obtained with the aid of the G reen function technique (detailed in the Appendix). By considering in detail the necessary correction through the UV cut-o procedure, expressions for the uctuation conductivity and the self-consistent equation for the renorm alized reduced tem perature param eter are provided. Further, Section IV treats the lim it cases of the linear response approximation, the no-cut-o limit, and also the isotropic 2D and 3D cases, recovering thus results of previous theories. In Section V the application of the model is illustrated by comparing the paraconductivity obtained in the present theory with that in the Gaussian uctuation approximation for various applied electric elds. A comparison between the uctuation suppression e ects of the electric and m agnetic elds is also illustrated. Finally, in Section VI, we summarize the main conclusions emerging from our analysis.

II. TDGL EQUATION FOR ARBITRARY ELECTRIC FIELD

For our purpose, we shall adopt the TDGL fram ework, and treat the quartic term in the free-energy expansion within the sim ple self-consistent H artree approximation. The starting point will be the Law rence-D oniach expression of the G inzburg-Landau (GL) free energy for a system of superconducting planes separated by a distance s, with a Josephson coupling between the planes, in the absence of m agnetic eld,

where m and m_c are elective Cooper pair masses in the ab-plane and along the c-axis, respectively. The GL potential $a = a_0$ " is parameterized by $a_0 = -2^2 = 2m_0^2$ and " = ln (T=T₀) (T T₀)=T₀, with T₀ being the mean-eld transition temperature and ₀ the in-plane GL-coherence length, extrapolated at T = 0. The critical dynamics of the complex superconducting order param – eter _n in the n-th plane will be described by the gaugeinvariant relaxational time-dependent G inzburg-Landau equation

where the pair electric charge is $e_0 = 2e$, and the order parameter relaxation rate $_0$, given by 20,21,22

is related to the life-time of metastable Cooper pairs9,19 (BCS) $\sim = 16k_B$ (T T₀) through the relation $_0^1 =$ 2a (BCS). As it can be noticed, we de ne the relaxation rate 0^1 as depending on the actual temperature T, while in many other works,^{3,19,23} it is de ned as a function of the mean-eld critical tem perature, T_0 . Of course the di erence is negligible near the transition point, but one must recall that in the derivation of the GL equations from the BCS theory, 21,24,25 the tem perature is usually approxim ated with the critical one, while the reduced tem perature $\ln (T = T_0)$ is approxim ated with T_0) = T_0 . The same happens while the TDGL equation is obtained for tem peratures near T_0 , as for instance in Refs. 23 and 26. In som em ore recent derivations of the TDGL,^{22,27} how ever, the original appearance of these param eters is preserved, so that the order param eter relaxation rate is written as depending on the actual tem perature. In this mathematically som ewhat stricter sense, one could therefore write the life-time of the metastable Cooperpairs as $^{(BCS)} = \sim = 16k_B T \ln (T=T_0)$.

The Langevin forces $_n$ (x;t) introduced in Eq. (2) in order to model the therm odynam ical uctuations must satisfy the uctuation-dissipation theorem, and ensure that the system relaxes to the proper equilibrium distribution. This requirement is fulled if the Langevin forces $_n$ (x;t) are correlated by the G aussian white-noise law

where $(x \ x^0)$ is the 2-dimensional delta-function concerning the in-plane coordinates. Since we are interested in nding the conductivity for an arbitrary electric eld, we cannot use the linear-response approximation, so we have to explicitly include the electric eld in the model. In order to compute the in-plane uctuation conductivity, we shall assume the eld E along the x-axis (where x and y are the in-plane coordinates), generated by the scalar potential ' = E x. In the chosen gauge, the current density operator along the x direction in the n-th plane will be given by

We have introduced the anisotropy parameter = _{0c}= ₀ = $m = m_c$, with 0_c the out-of-plane GLcoherence length extrapolated at T = 0. The term g (k;t) in Eq. (10) is the Fourier transform according to the rules (9) of the noise function $_{n}$ (x;t). One can directly verify that the follow ing correlation function holds:

Equation (10) may be solved using the G reen function method, as done also by Tucker and Halperin,²⁹ and Dorsey¹⁴ in order to solve the relaxational TDGL equation with a Langevin noise for isotropic superconductors. Our derivation di ers how ever by the fact that it is applied for a layered superconductor, and also through the di erently chosen potential gauge. W e denote thus with R_q (k;t;k_x^0;t^0) the G reen function for the Eq. (10), which satis es

As already mentioned, the quartic term in the therm odynam ical potential will be treated in the Hartree approximation, in the same sense as applied also in previous works, 13,20,28 namely by preplacing the cubic term $bj_n j_n$ in Eq. (7) with $bj_n j_n$. In this way, the non-linearity is decoupled, resulting in a linear problem with a_{R} modied (renormalized) GL potential e = $a+b j_n j^2$, which implies a renormalized reduced tem perature

where we have taken into account the expression (11) for the Fourier transform ed noise correlation function, and also replaced the notation a_1 with its value (13).

Before proceeding further and solve the integrals over momentum variables in Eqs. (17) and (18), we must recall the inherent ultraviolet (UV) divergence of the G inzburg-Landau theory, which is not valid on length scales less than the zero-temperature coherence length $_0$. The short wavelength uctuations break down the \slow variation condition" for the superconducting order parameter, a central hypothesis of the GL approach.³⁰ This di culty can be solved by applying an UV cut-o to the uctuation spectrum, a procedure introduced from the beginning in the GL theory.³¹

III. SOLUTIONSW ITH CONSIDERATION OF THE UV CUT-OFF

The classical 4,28,32 procedure is to suppress the short wavelength uctuating modes through the momentum cut-o condition

where the dimensionless cut-o factor c is close to unity. A lso a total energy cut-o was suggested,^{33,34,35} which eliminates the most energetic uctuations and not only those with short wavelengths,

Heuristically, the adequacy of the total-energy cut-o can be justiled on the grounds of the Gaussian GL approach by taking into account that the probability of each uctuating mode is controlled by its total energy $\sim^2 k^2 = 2m + a_0$ ", and not only by its momentum 9,19 Very recently³⁶ it was suggested that the physical meaning of the \total energy" cut-o follows from the uncertainty principle, which impose a lim it to the con nement of the superconducting wave function. It must be how ever mentioned that in the critical uctuation region, the two cut-o prescriptions almost coincide quantitatively, due to the low reduced-tem perature value " with respect to the factor c.

For sim plicity, in the following we shall apply the cuto procedure in its classical form (19) on the k-plane momentum integrals in Eqs. (17) and (18). If necessary, one can get easily also the result that would correspond to the \total energy" cut-o (20), by simply replacing $c! c \in A$ lihough for the Law rence-D oniach model, the z-axis momentum q also contributes to the uctuation mode energy with the term $\sim^2 2 = m s^2$ (1 cosqs), the inclusion of a momentum cut-o in this direction is not necessary, since the z-axis spectrum is already modulated through = s q = s. One can thus perform the integral over q-m omentum in Eqs. (17) and (18) and get

has been computed by taking into account the expression of the quartic term coe cient 30 b = ${}_{0}$ ${}^{2}e_{0}^{2} {}^{2}=2m^{2}$, with being the G inzburg-Landau parameter = ${}_{0}={}_{0}$.

The above Eq. (24) for the paraconductivity, together with the self-consistent Eq. (29), both valid for an arbitrary strong electric eld and with the explicit inclusion of the UV cut-o , are the main results of this paper. A short comment would be useful regarding the application of the cut-o procedure to the k-integrals in Eqs. (27) and (22). It could seem more appealing to apply the cut-o on the translated wave-vector magnitude, such as $k_v^2 + [k_x + (e_0 E = 2\sim)]^2 < c_0^2$, as it was approximately done, although in a dierent gauge, by Kajimura and Mikoshiba,³⁸ while studying the paraconductivity in arbitrary electric eld in the two-dimensional case. This would certainly simplify the calculations and consequently the factors that depend on the cut-o param eter c, but would not really correspond to the actual meaning of the UV cut-o , which is to assure the slow variation condition for the order parameter by elim inating the rapidly oscillating m odes in the Fourier expansion (9). It can be seen for instance that when the dummy variable grows towards 1, the component k_x would have to approach 1 in order to preserve the cut-o condition in the translated form. It can be moreover veried that the \translated" cut-o would not give the correct result in the E = 0 lim it, namely the third term in the Eq. (31) below would be m issing.

IV. LIM IT CASES

A. Linear response lim it

It is worth comparing to previous results what become Eqs. (24) and (29) in the zero-eld lim it, E = 0. Taking into account that $I_0(0) = 1$ and $I_2(0) = 0$, and using the integral form for the modil ed Bessel function I_0 (ru=2),

which is the Law rence-D oniach² form ula for the uctuation conductivity of a layered superconductor, with the inclusion of the UV cut-o. A form ally identical expression was also inferred by C arballeira et al.,³⁵ for G aussian uctuations (i.e. with e = "), in order to t the HTSC paraconductivity in the high reduced-tem perature region.

The integral in Eq. (29) can also be easily performed in the lim it E = 0, and it yields the relation

that m atches the formula found by M ishonov and Penev,²⁸ with the only di erence that in Ref. 28 the temperature T is approximated with T₀ in the logarithm prefactor. It can be easily veried that Eq. (32) is also coincident with the analogous equation found previously by U llah and D orsey¹³ (UD) for the renorm alized reduced temperature $\xi_{\rm H}$, if one considers the zero m agnetic eld limit in the UD formula. In this limit, the sum over Landau levels transform s, with the aid of Euler-M acLaurin sum m ation formula, to the integral from Eq. (32), if one takes also into account that the cut-o used by UD corresponds with c = 2.

W e have thus shown that from our Eqs. (24) and (29) one can infer in the lim it E ! 0 the already known results for conductivity and renorm alized reduced tem perature in the ohm ic approximation.

B. No-cut-o limit

The cut-o procedure is crucial for calculating the averaged uctuating C ooper pairs density, since Eq. (18) yields a divergent -integral when one performs the k-m om entum integrals on the entire k-plane.

The result (24) for the paraconductivity remains however nite even if one removes the cut-o (i.e. for c! 1), although it will give then a larger paraconductivity than in the cut-o case, especially for higher reduced temperatures (" 0:1). Turning back to Eq. (17) with the cut-o removed, one is allowed to translate the integral variable k_x so that $k_x + (e_0 E = 2^{-}) ! k_x$, and after performing the Poisson k-integrals, one obtains eventually for the uctuation in-plane conductivity in the presence of an arbitrary electric eld E, without considering the UV cut-o, the simpler relation

The expression (33) is not new. In its form, it is essentially similar to the ones found by Varlam ov and Reggiani⁷ and M ishonov et al.⁹ for the case of G aussian uctuations, if one neglects the di erence which consists in the presence of the renorm alized parameter E in Eq. (33) instead of the reduced temperature $\texttt{"} = \ln(\texttt{T}=\texttt{T}_0)$. It must be stated how ever that Ref. 7, based on a microscopical approach,⁸ de pes an out-of-plane coherence length larger by a factor $\frac{1}{2}$ than the commonly used

one. Nevertheless, its result corresponds to our Eq. (33) when expressed through Eqs. (26) in the microscopical parameters v_F and J (the latter is denoted in Ref. 7 by w). M ishonov et al.9 signalize di erences in one of their interm ediary results with respect to Refs. 8 and 7, but they nd the sam e dependence of the non-ohm ic conductivity on the reduced tem perature " and the electric eld E, by solving the Boltzm ann equation for the velocity distribution of the uctuating Cooper pairs. Their formula di ers mathematically from Eq. (33) only by the presence of two extra-factors before the integral, nam ely the ratio between a-and b-coherence lengths (since R ef. 9 takes into account also a general in-plane anisotropy), and the ratio $T = T_0$, which in fact com es arti cially only if one writes the relaxation rate $_0$ with T_0 instead of T (see the com m ent after Eq. 3).

C. Isotropic lim it

Results analogous to Eqs. (24) and (29) for the isotropic two dimensional (2D) case can be easily derived by simply taking the limit $_{0c} = 0$ (or r! 0) and identifying the interlayer distance s with the lm thickness d. W e will have thus

Equations (34) and (35) di er from the analogous results of R ef. 38, because there only an approxim ate form of the cut-o procedure was applied, as we have already m entioned at the end of Section III.

If one neglects the cut-o (c $!\,$ 1), Eq. (35) becomes divergent, while Eq. (34) takes the already know $n^{5,9,14}$ form

A form ally identical expression to Eq. (37) is also to be found in Ref. 35 for Gaussian uctuations (i.e. with e = "), while Eq. (38) is implicitly contained in the results of Ref. 28.

Results for the isotropic three-dimensional (3D) case cannot be obtained by just imposing the 3D condition s ! 0 (or r ! 1) to Eqs. (24) and (29), because these equations were calculated by assuming that a cuto in the z direction is not necessary for layered superconductors. However, in the 3D case, a cuto for the k_z -m omentum is as necessary as for the k_x and k_y components. The calculations can be performed according to the same scheme as for the layered case, and the results are presented here for completeness:

Equation (42) matches thus formally the expression found 35 for Gaussian uctuations ($\mathbf{E} = \mathbf{"}$).

V. RESULTS OF THE MODEL

The renorm alization procedure required for our present results consists thus in using the reduced temperature parameter \mathbf{e} , renorm alized by solving Eq. (29), in the conductivity expression (24). This procedure causes the critical temperature to shift towards lower temperatures. In analogy with the Gaussian uctuation case, we shall adopt as de nition for the critical temperature $T_c(\mathbf{E})$ the vanishing of the reduced temperature, $\mathbf{e} = 0$. Thus, in the absence of the electric eld we can use Eq. (32) taken at $T = T_c(0)$ and $\mathbf{e} = 0$, so that one gets

In practice, one knows the actual critical temperature $T_c(0) = T_{c0}$ measured at very low electrical eld, so that Eq. (44) allows to estimate the bare mean-eld characteristic temperature T_0 . Then, having the parameter T_0 ,

one can use Eqs. (29) for any temperature T and eld E in order to nd the actual renorm alized e(T;E), and further the conductivity (T;E).

In order to illustrate the main features of the H artree approximation for the critical uctuation model, we shall take as example a common material, like the optimally doped Y Ba₂Cu₃O_{6+x}. Typical values for the characteristic parameters are then: s = 1.17 nm for the interlayer distance, $_0 = 1.2$ nm and $_{0c} = 0.14$ nm for the zero-temperature in-plane and, respectively, out-ofplane coherence lengths, = 70 for the Ginzburg-Landau parameter and T_{c0} = 92 K for the critical temperature under (42) ery small electric eld. We also choose for convenience a linear temperature extrapolation for the norm al state resistivity which vanishes at T = 0, and has a typical 5 value N = 84 cm at T = 200 K.




FIG. 1: Resistivity in the Gaussian theory (dotted curves) and in the Hartree approximation for the interacting uctuations (solid curves), for di erent values of the applied electric eld. The following parameters were used: interlayer distance s = 1:17 nm; zero-tem perature in-plane and out-ofplane coherence lengths, $_0 = 1.2$ nm and $_{0c} = 0.14$ nm, respectively; Ginzburg-Landau parameter = 70; zero-eld critical tem - perature $T_{c0} = 92$ K. The UV cut-o parameter c = 1 was used. The arrow indicates the increasing electric eld direction. The inset illustrates the critical tem perature shift introduced by the Hartree model if the mean-eld transition tem perature T_0 were kept identical with the one in the Gaussian approach $T_0^{(G)}$.

In Figure 1 the results of the Hartree approximation for the critical uctuations are compared to the ones obdata from the Gaussian uctuation theory. The zeroeld critical temperature T_{c0} in the Hartree model was considered identical to the mean-eld critical temperature $T_0^{(G)}$ in the Gaussian approximation, in order to have the zero-eld transition at the same temperature in both theories. This identication causes the mean-eld transition temperature T_0 in the Hartree model to shift upwards with respect to T_{c0} . For our chosen parameters this shift was found to be

while taking a cut-o parameter c = 1. The di erence between the two temperatures depends on choice of the cut-o parameter, namely it increases with the c value, and becomes divergent for no cut-o ($T_0=T_{c0}$! 1 for c ! 1). It can be noticed in Figure 1 that the curves obtained in the Hartree approximation are less steep than those in the G aussian one, and show a signi cantly broadened transition region in the presence of strong applied electric elds. In addition, we nd that the paraconductivity in the renormalized model is more sensitive to the electric eld, showing a more pronounced suppression of the uctuations at high elds in the lower part of the transition. However, above the zero- eld transition temperature, the paraconductivity in the Hartree model is always higher than the one in the G aussian ap-

proximation, due essentially to the critical temperature rede nition from T_0 to $T_{\rm c0}$. If one preserved instead the same mean-eld transition temperature $T_0=T_0^{\rm (G)}$ as in the G aussian approximation, one could then visualize the critical temperature shift introduced by the Hartree approach, as shown in the inset of Fig. 1. Equation (44) would give then $T_{\rm c0}=86.894\,\rm K$, and the paraconductivity would be always lower than the one in the G aussian approximation.

For illustration, we also give in F igure 2 a com parison between the results of our model, applicable for layered superconductors in arbitrary electric elds in the absence of magnetic eld, and the ones of the com plementary model of U llah and D orsey,¹³ which treats in the same H artree approximation the case of an arbitrary magnetic eld in the linear response (zero electric eld) limit. A s one can easily notice, the same well known \fan shape" transition broadening, encountered when a magnetic eld is applied, can be also predicted for the presence of a su ciently strong electric eld. W e argue thus that high electric elds can be used to suppress order parameter uctuations in HTSC as e ectively as a magnetic eld.

This comparison between the uctuation suppression e ects of the electric and magnetic eld could give also a rough estimation on how broad the validity dom ain of our model could be. It is known for instance that the renormalized uctuation model¹⁵ for layered superconductors




FIG. 2: C om parison between the transition broadening effect of the electric (solid lines) and magnetic (dotted lines) eld, respectively, according to the renormalized Hartree approximation. The same parameters as in Fig. 1 were used. The magnetic eld e ect was calculated in the linear response (zero electric eld) limit, according to the UD model.¹³ The UV cut-o parameter c = 1 in our model corresponds with limiting the sum on the Landau levels at the index 1=2h in the UD model ($h = 2 \quad {}_0^2 B = \ _0$ being the reduced magnetic eld . The arrow indicates the increasing electric and magnetic eld direction.

can successfully t the resistivity curves of YBCO and BSCCO single crystals in magnetic elds up to about 10 T, in a tem perature range that covers approxim ately the two superior thirds of the transition region. This extends from a few K in lower elds, up to more than 10 K in higher elds, measured down from the resistivity onset point in zero eld.¹⁵ The low est third of the transition, where, experim entally, the resistivity slope becom es steeper, is instead a ected by ux pinning e ects and does not t into the GL theory. We can therefore assum e, based on the sim ilarities illustrated in Fig. 2, that also in high electric elds, the renorm alized uctuation model based on the TDGL approach may have its validity in a tem perature range at least as broad as in the case when a magnetic eld is applied. Since under high electric elds (and consequently, high current densities), the pinning of the self-eld ux lines is overcom e by the high Lorentz force, we can expect that the validity of the presented model might extend for even lower tem peratures.

In a few previous papers,^{39,40} the non-ohmic uctuation conductivity in high electric elds was reported to be experimentally proven, by confronting the measured paraconductivity to the scaling laws predicted by Gaussian uctuation models.^{4,7} However, the broadening of the temperature dependence of the resistive transition with respect to the increasing electric eld, and the breaking of the mean-eld (Gaussian) theory in the immediate vicinity of T_c , signalized by Ref. 39, indicate that a renormalized (non-Gaussian) uctuation model, as the one presented in this paper, might be more appropriate. From the experimental view point, applying electric elds of a few hundreds V/cm on cuprates may how ever be not an easy task, since the dissipated power density would attain levels of the order of GW cm 3 . On the one hand, high electric elds are necessary in order to put into evidence the non-ohm ic uctuation conductivity, while, on the other hand, they produce high dissipation and can increase the sam ple tem perature at values where the nonlinearity is no longer discemable. In this connection, using short current pulses at high current densities (a few MA cm 2), seem s to be a better alternative to the dc and ac m easurem ents.

VI. CONCLUSIONS

In sum m ary, we have treated in this paper the critical uctuation conductivity for a layered superconductor in zero m agnetic eld, in the fram e of the self-consistent H artree approximation, for an arbitrary electric eld m agnitude. The m ain results of our work are the form ulae (24) for the uctuation conductivity, and (29) for the renormalized reduced-temperature parameter. In both equations the UV cut-o of the G inzburg-Landau m odel was explicitly considered. In the linear-response limit (E ! 0), the corresponding expressions Eqs. (31) and (32) reduce to the previous results of existing theories. Q ualitatively, the temperature characteristics at di erent electrical elds in the H artree approximation turn out to be less steep than those in the G aussian one, they show a 10

m ore pronounced suppression of the uctuations at high elds in the lower part of the transition, and a higher paraconductivity above the zero- eld transition tem perature than the G aussian uctuation model. All these features are quantitatively important for commonly used HTSC, so that experimental investigations could be able to discern easily between the applicability of this model in competition with the G aussian uctuation approximation.
