Nature of the Fulde-Ferrell-Larkin-Ovchinnikov phases at low temperature in 2 dimensions

We investigate, mostly analytically, the nature of the Fulde-Ferrell-Larkin-O vchinnikov superuid phases for an isotropic two-dimensional superconductor, which is relevant for the experimental observation of these phases. We show that there is, in the low temperature range, a cascade of transitions toward order parameters with ever increasing complexity.

The transition to Fulde-Ferrel-Larkin-Ovchinnikov (FFLO) super uid phases [1,2] has given rise to much work, but a full theoretical understanding of these inhomogeneous phases has not yet been reached. This is of high practical in portance since experim ent relies heavily on theory when it needs to test if these phases have actually been observed. Indeed beside their basic theoretical interest which, in addition to superconductivity and its coexistence with magnetism [3], ranges from ultracold gases [4] to quark m atter as it m ight occur in the core of neutron stars [5,6], FFLO phases are also of very high applied interest, because they correspond to the superconducting phases which should appear in superconductors with very high critical elds in the vicinity of the transition to the normal state. A main strategy to observe these transitions in superconductors is to get rid of the orbital currents, responsible for the standard disappearance of the superconducting phase at low critical elds, and reach the regime of Pauli param agnetic limitation. This can be done in clean quasitwo-dimensional systems such as organic com poundsm ade of widely separated conducting planes, or in high T_c compounds. In these cases hopping between planes is very strongly inhibited. So when a strong magnetic eld is applied parallel to the planes, the resulting orbital currents perpendicular to the planes are very weak and there is basically no orbital pair breaking e ect which leaves open the possibility of transitions to FFLO phases at much higher elds. Nevertheless the sm all interplane coupling is necessary to suppress phase uctuations and produce phase which can be properly described by a mean eld theory. Indeed observations of this transition have been claim ed quite recently in such organic com pounds as -(BEDT-TTF)₂Cu(NCS)₂ [7,8] or $-(BETS-TTF)_2GaC_4$ or FeC 4 [9,10].

A ctually when the eld is not exactly parallel to the planes there are sm allorbital currents and associated vortices appear. The physics of the evolution from this vortex state to the pure FFLO phase is quite remarkable, both in the linear [11{13,3] and in the non linear regime [14] since it involves a series of vortex states phases corresponding to Landau levels with increasing quantum num – ber. C om pared to this com plex structure the limiting 2D FFLO phase sounds simple. Indeed the FFLO transition in 2D systems is believed to be second order and in particular Burkhardt and Rainer [15] have studied in details the transition to a planar phase, where the order param eter (r) is a simple cos(qr) at the transition. This phase has been found by Larkin and Ovchinnikov [2] to be the best one in 3D at T = 0 for a second order phase transition. And in 3D it is also found to be the preferred one in the vicinity of the tricritical point and below [16{18], although in this case the transition turns out to be rst order (except at very low tem perature). However it is not clear that this simple order parameter is always the best one since, as rst explored by Larkin and Ovchinnikov, it is in competition with any superposition of plane waves, provided that their wavevectors have all the same modulus.

In this paper we explore the low temperature range in 2D for the pure FFLO phase transition in the sim ple isotropic case and show that surprisingly there is a cascade of the second order transitions tow ard order param eters with ever increasing complexity. In principle there is an in nite number of phases. Therefore the pure FFLO phase display a structure just as rich as the vortex phases that we mentionned above, and the interplay between both promises to be of exceptional interest. A rst step in this direction has been made recently by Shimahara [19] who, instead of simple cosine, found a transition toward a superposition of up to six plane waves when looking for more complex 'cristalline' structures. We nd agreem ent with his results. How ever we will see that cristallinity does not give the proper understanding of these phases. Instead we show that, when the tem perature is low ered tow and T = 0, the cascade of transitions tow ard order param eters with an ever increasing num ber of plane waves is due to the singular nature of the T = 0 $\lim it$, which is already appearent in the T = 0 wavevector dependence of the second order term in the free energy expansion in powers of the order parameter.

O ur study follows the general fram ework set up by Larkin and O vchinnikov [2] and used by Shim ahara [19] in the 2D case. The free energy di erence s n between the superconducting and the norm al state is ex-

with respect to q, where we have introduced the dim ensionless wavevector $q = qv_F = 2$ and $!_n$!n i with $!_n = T(2n + 1)$ being the M atsubara frequency. This can be rew ritten as an integral over real frequency. At T = 0 one nds explicitly I(q; ;T) = Reln(1 + D)1 d) $\ln 2$, which is minimum for q = 1, in agreement with Shimahara [20] and Burkhardt and Rainer [15]. We note that the location q = 1 of the minimum is a singular point for I since $I = \ln (q=2)$ for q > 1, so I is continuous while its derivative is discontinuous for q = 1. For T \neq 0 but low enough tem perature, the condition giving the minimum can be expanded in powers of $t^{1=2}$ where t = T = is a reduced tem perature. We have found that expanding q = 1 up to t d gives a result in excellent agreem ent with a straight num erical evaluation fort < 0:1. Here (and sim ilarly below) we do not give the somewhat lengthy full expression [21], but we om it the last two terms and display only the lowest order correction which is:

The second order term in xes only the modulus, given by Eq.(2), of the N wavevectors entering the plane wave expansion of the order parameter. This leaves open all the various possible order parameters arising from any combinations of these plane waves. The selected state will correspond to the low est fourth order term, which is given [2] in general by:

where q_i,q_j is the angle between q_i and q_j . Just as for the second order term J() and J() can be expressed [21] as frequency integrals, expanded at low temperature t 1 and evaluated for the optim al value of q (given by Eq.(2) to leading order). As for the optim al q we have carried this expansion up to second order in $t^{1=2}$. If we restrict ourselves to leading order as in Eq.(2) we nd for example for J():

where we have set $^2 = (1 \cos(=2))=t$. The result up to second order in $t^{1=2}$ is not much more complicated. A sim ilar result [21] is found for J().




FIG.1. J() for values 0:01 and 0:05 of the reduced tem – perature t = T = (q) = t = q (with essentially q 1 in all this range). The lines are calculated using our low temperature expansion for J(), while the points correspond to the direct num erical sum m ation over M atsubara frequencies. The dashed line in the insert (which displays the same results with di erent scale) is the asymptotic behaviour for J() in the T ! 0 lim it Eq.(5).

P lots of J () for various low tem peratures can be seen in Fig. 1, either obtained from these low tem perature expressions or from exact calculations of J () obtained by direct num erical sum m ation over M atsubara frequencies after analytical angular averaging. We see that, at this level of accuracy, both agree rem arkably wellup to rather high tem peratures which shows that our low tem perature expansion is quite under control. Now Fig.1 shows that J () has at low T a quite rem arkably structured behaviour which can be easily understood from som e lim – iting cases. First let us take the lim it T ! 0 at xed . This im plies 2 ! 1, the rst term in Eq.(4) goes to zero and the easy integration leads to:

On the other hand if at xed T we take the lim it ! 0, we have 2! 0. The lim iting behaviour of the integral is =(2) 1=2, the dom inant divergent contributions from the two terms in Eq.(4) cancel out giving:

which goes naturally to in nity for T ! 0. From these two limiting situations we can understand that, for most of the range; J() is negative as it can be seen from Eq.(5) and it goes to large negative values when gets very small. On the other hand for = 0 or very small J() is positive and very large, as results from Eq.(6) (surprisingly J() starts rst to increase strongly before going down to very negative values).

We have made the same kind of treatment [21] for J(). The lim it T ! 0 with xed leads to ${}^{2}J() =$ =4 sin while in the limit ! 0 at xed T we nd $^{2}J^{()} =$ 1=4. These two cases make reasonable that J() is always negative, as we nd. However, just as for J(), one nds also a singular behaviour at small $= (8t)^{1=2}$ 1 and ${}^{2}J$ () diverges as . W hile for =4, it goes to the nite value 1=4 for = 0.N ever- 1 is weaker than the the less the divergent behaviour in one in 2 found for J () and sim ilarly J (0) j) (0) jat

low T. So J() will play the dom inant role and at st we om it $J^{()}$ () from our considerations. Let us now consider which is the most favorable order param eter. W e will always nd that the fourth order term is positive, so we have to make it as small as possible in order to m in in ize the free energy. We note st that there is unevitably a strongly positive contribution, proportional to J(0), com ing from the N term $sq_i = q_i$ in the rst sum of Eq.(3). However their unfavorable e ect is relatively reduced when N increases since there are N 2 term s in this sum . Since we clearly have to avoid other positive contributions of this kind, we want to forbid the angle dom ain 0 < < 0 where we can take 0 as giving $J(_{0}) = 0$, which is very close to the (strongly negative) minimum of J() as it can be seen on Fig. 1. So the angle between any two di erent wavectors q_i and q_j should be at least 0.0 n the other hand it is of interest to have angles close to 0 since they give strongly negative contributions to . Since it is better to have the number of wavevectorsN as large as possible, we come from symmetry reasons to the conclusion that we have to choose the wavevectors qi angularly equally spaced with the angle between two nearest wavevectors as close as possible to $_0$. Now $_0$! 0 when T! 0. Therefore we have indeed a cascade of transitions corresponding to order param eters with an ever increasing number N of wavevectors when T ! 0. This singular behaviour is clearly linked to the fact that it is not possible, in particular for J (), to perform an expansion in the lim it T ! 0, i.e. this lim it is singular.

M ore precisely it is quite a di cult problem to handle this minimization from scratch, and for example to prove that the minimum is not obtained for a com pletely disordered situations. However symmetry makes such a result quite unlikely. On the other hand if we take for granted that the wavevectors are equally spaced angularly it is easy to prove that the weight j q_i j are all equal, because this problem can be mapped on a tight binding H am iltonian on a ring. Conversely if we assume that all these weights are equal the problem is equivalent to nd the equilibrium position of atoms on a ring with repulsive short range interaction and attractive long range interaction. We expect the equilibrium to be a crystalline structure corresponding in our case to equally spaced wavevectors.




FIG.2. G_2^{-1} as a function of tem perature for various plane waves number N (for clarity only solutions up to N = 14 are presented). The arrows give the values of the successive transitions. In the upper panel the dashed lines are the exact M atsubara sum m ations. The full lines in the upper panel, as well as all the lines in the lower panel, are from the low tem perature expansion for J () and \mathcal{J} (). In the insert the full dots are the exact tem perature locations of the transitions together with the corresponding values of N (the empty dots just give N 2). The full line gives the low tem perature evaluation of these transitions from the solution of a sim ple transcendental equation, and the alm ost undistinguishable dashed line comes from the explicit rst iteration solution of this equation.

In the low temperature limit (t 1), we can easily be more quantitative and write simple analytical answers for our problem. Indeed the result is dominated by the small

behaviour of J (). In this range ${\rm Eq.}(4)$ becomes:

where X = x (1=4) ln (=2t) with x = 2 =16t. The second term is the asymptotic form Eq.(5). The zero of J () we are looking for is found for large X and satis es e^x = (k= 2)x¹⁼⁴ with k = (2 3 =t²)¹⁼⁴, which is easily solved iteratively for large k. The leading order x = ln (k= 2) gives ${}_{0}$ = (8tln)(3 =2)¹⁼²=t))¹⁼². The rst order iteration is x = ln (k= 2) + 1=4 ln (ln (k= 2). Then the optimum value of N is given by the integer value of 2 = 0, which conversely xes the temperature at which the system switches from N 2 to N wavevectors. In the insert of Fig.3, one sees that the rst iteration gives results alm ost undistinguishable from the exact solution of the above transcendental equation for x.

Exact results can be obtained by handling num erically the various steps. The m inim ization of the free energy with respect to j $_q$ j gives =N $_0 = \frac{2}{2}$ (q; ;T)=G $_2$ (N) with:

where we have om itted the J terms for simplicity. One sees in Fig. 3 the results (including the J terms) for G_2^{-1} (N), i.e. essentially the free energy, for various values of N . The stable state has the highest G_2^{-1} (N). The cascade of phase transitions is clearly seen in the low erpanel, corresponding to the lower tem perature range. The arrows show the successive transition temperatures. The results from straight num erical M atsubara sum m ation can not be distinguished from those obtained from our low T analytical expression for J() and J(), except for the higher tem perature, as seen in the upper panel. The critical tem peratures for switching from N 2 to N are shown as dots in the insert of Fig. 3. It can be seen that our above asymptotic calculation for these tem peratures, shown as full curves, are actually quite good.

At low tem perature we can make an asymptotic calculation of G_2 (N). As seen on Fig. 1 J () switches rapidly above $_0$ to its large angle asymptotic behaviour. Moreover at low T the number of plane waves N is large and in Eq.(8) the sum is dominated by the small angles terms, which leads [21] to:

This expression corresponds in Fig. 3 to the rising part, on the low temperature side, of ${\rm G_2}^1$ (N). On the other hand the downtum is due to contributions from the positive part of J () which can not be evaluated so easily.

W hen we substitute in Eq.(9) the value N = 2 = 0 for the optimum plane wave number we have:

Since $8t = \frac{2}{0}$ $1 = \ln (1 = t)$ from our above evaluation, we nd that G_2 (N) is always be positive in the low temperature range, which means that the transition stays always second order. W hen we take into account the contribution of the J terms in Eq. 3 that we had om itted so far, one gets an additional In N contribution in Eq.(9), which arises only when N is even because for equally spaced wavevectors, the J term s contribute only in this case since they require opposite wavevectors. This contribution is just enough to system atically tilt the balance in favor of even N . In this respect the phase N = 3 found by Shim ahara [19] appears as an exception. O therw ise our cascade of phase transitions contains only order param eters with an even number of plane waves, and the order parameter is just a real sum of cosines, with still a degeneracy due to the freedom of choosing the phases in these cosines.

We note that, although the transitions between the various FFLO phases and the norm al phase are second order, we expect the transitions between di erent FFLO phases in the super uid dom ain to be rst order since one can not go continuously from a given order param – eter to the next one. Finally we have seen that these successive transitions are directly due to the singularity which occurs in 2 D at T = 0. This singularity itself arises because the two Ferm icircles corresponding to opposite spins come just in contact when one applies the shift corresponding to the wavevector q of the FFLO phase. Therefore this singularity is a general feature of 2D physics and we expect it to give rise to sim ilar consequences in m ore realistic and m ore com plex m odels describing actual physical system s.
