W inding angle distribution for planar random walk, polymer ring entangled with an obstacle, and all that: Spitzer-Edwards-Prager-Frisch model revisited

U sing a general G reen function form ulation, we re-derive, both, (i) Spitzer and his followers results for the winding angle distribution of the planar B row nian motion, and (ii) E dwards-P rager-Frisch results on the statistical mechanics of a ring polymer entangled with a straight bar. In the statistical mechanics part, we consider both cases of quenched and annealed topology. A mong new results, we compute exactly the (expectation value of) the surface area of the locus of points such that each of them has linking number n with a given closed random walk trajectory (= ring polymer). We also consider the generalizations of the problem for the nite diameter (disc-like) obstacle and winding within a cavity.

I. IN TRODUCTION

In 1958, Spitzer [1] established the following result. Consider the two-dimensional random walk starting at a point other than 0, and let (t) be the total continuous angle wound by the walker around 0 up to time t (see g-ure 1 a). The Spitzer law says that the quantity (t) = lnt at large enough t is Lorenz (or Cauchy) distributed:

W ith a rem arkable delay of about 25 years, a large group of followers studied this law in depth [2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13]. The central nding of these studies attributes the divergent m om ents of the Spitzer distribution (1), e.g. h²i, to the small scale properties of the regular random walk trajectories. Simply speaking, innitely large winding is accumulated while the trajectory is wandering in nitely close to the obstacle 0. A coordingly, this pathology of divergent m om ents is rem oved by incorporating any kind of \granularity," or short length scale cut-o, in the model. Such modi cation of the model can be achieved in quite a few ways. One way is to consider the random walk on the lattice instead of the continuous space [9]; another way is to look at the winding around a nite obstacle, say, a disc of som e radius b [2, 4, 5]; one more possibility is to exam ine a broken line of straight segments of nite length beach instead of standard W iener-m easured random walk; yet anotherway is to consider a worm -like sm ooth curve with an e ective segment b (that is, the curve which adopts smoothly curved shapes r(s) with the weight proportional to exp (b=2) r²ds, where s is the arc length). In all of these cases, winding is characterized by the nonpathological distribution

A similar distribution is also characteristic for the winding of the self-avoiding walk [3, 6, 7]; self-avoidance, in this case, is just another way to suppress in nite winding at in nitely small length scale. M athematically, it turns out that the winding angle distribution is in fact an example of a broad class of limiting laws for the twodimensional random walk [4, 8].

M any studies of winding angle distribution [2, 3, 5, 6, 7, 10, 12, 13] claim that entanglem ent of long polym er lam ents is (one of) their motivation (s). Indeed, the relation to polymer physics does exist. It was found in 1967, alm ost a decade after Spitzer [1], by Edwards [14] and, independently, by Prager and Frisch [15] (see also an in uential review [16]). These authors came up with the model of a polymer chain wound around a straight bar and topologically entangled with this bar. G iven the analogy of a polymer chain conformation with the random walk trajectory, the Edwards-Prager-Frisch model is essentially the same as that exam ined by Spitzer [1]. Neither of the works [14, 15, 16] makes a reference to [1]. Most likely, mathematical work [1] was not known to physicists at the time, but even apart from that, authors of the works [14, 15, 16] did not exam ine winding angle distribution for the random walk with open ends, their goalwas obviously to com pute quantities sim ilar to those of physical interest for real polymers. Unfortunately, no explicit formula was obtained in the works [14, 15, 16] comparable in simplicity to Eq. (1).

To our suprise, we found that this fairly old area lacks both unity and clarity. The studies of winding angle distribution [2, 3, 4, 5, 6, 7, 8, 9, 10] contain no hint on the lessons of this exactly solvable model to polym erphysics. D rossel and K ardar [11] as well as Sam okhin [12, 13] brought the subject to a new level of com plexity, they exam ined winding angle distribution for the random walks in a disordered medium. D rossel and K ardar [11] also provided sim ple derivation of the results (1,2) and applied it to many physical situations involving directed polymers, but all that yields little insight into the topological properties of ring polymers. And we are unaware of any followers of [14, 15, 16] who took advantage of the more recent m athem atical achievements [2, 4, 5, 6, 8, 9, 10]. M eanwhile, an exactly solvable model in general is useful if only it yields some insight(s). Upon a closer look and re-exam ination of the literature, we found that the model of winding can be made to meet this criteria, but it has not been done yet. Our plan in this paper is to reconsider the problem from a single common view point, including both winding angle distribution and som emore physical aspects.

O ur additionalm otivation arises from the fact that the study of topological constraints in polymers in the years and decades after the works [14, 15, 16] had been dom inated by the phenom enological approaches based on the reptation theory [17, 18]. At the same time, a break-through in microscopic understanding of this subject has not been achieved, and, therefore, the need for exactly solvable models remains high. Moreover, apart from networks, there is now another large \consumer" forpolymer topology, this is DNA physics. The DNA double helix is frequently found in a closed loop form, it forms knots of various kinds [19, 20], and there are special enzymes spending energy to simplify the entanglements [21].

One of the key aspects of polym er topology is that there are two types of questions one can ask, corresponding to annealed and quenched topological disorder, respectively [22]. The beauty of the winding model, which so far seem s to remain underappreciated, is that it allow s both types of questions:

The typical annealed topology question is that about ring closure experiment and knot probabilities [25, 26, 27, 28, 29]: having a linear polymer with \sticky" ends, what is the probability to obtain a certain type of a knot upon rst meeting of the two ends [19, 20]? A similar question for the winding model is this: what is the probability that a random walk on the plane links number n (or winding angle 2 n) with an obstacle?

The typical quenched topology question is about, e.g., the size or other properties of a polymer having a given xed topology (e.g., knot type) [23, 24]; this is necessary, e.g., to understand the di usion of knotted DNA in solution or in a gel. A s im ilar question for the winding model is this: given a polymer with xed linking number n, what is the (root-mean-squared) average distance of an arbitrary point on the trajectory from 0 ?

To conclude the introduction, we should also mention that the shortcom ings of the Edwards-Prager-Frisch model are well understood [31]. Basically, this model assumes that entanglements algebraically commute with each other, while the real physical situation is non-Abelian.

This paper is organized as follows. In section III, we discuss the G reen function formulation of the problem and derive basic equations for all models - winding




FIG.1: Schem atic representation of the model. (a) R andom walk winding around an obstacle O. This obstacle m ight be just a point, or it might be a disc of a nite radius b. (b) C losed polymerwinding around an obstacle. M athem atically, this is similar to (a), except both ends are kept together. (c) Similar to (a), except the trajectory cannot leave a \cavity" of some radius B.

around the point, around the disc, or inside the cavity. In section IV, we show how to re-derive and generalize the results (1) and (2). In section V, we consider the closed loop polymer, which is the random walk with connected ends. In section VI, we make a few nalcomments.

O urw ork is heavy on calculations, even though som e of the less in portant ones are relegated into Appendices. As readers, we don't like such heavy papers. This is why we start from section Π which provides an overview of m a jor steps and the results for those readers not interested in details.

II. BIRD'S EYE VIEW OF THE RESULTS:FOR THE LAZY READER W HO DOES NOT WANT TO DW ELL ON THE CALCULATIONS

If you, our reader, do not want to follow our calculations, this section o ers a tour of the results for you.

To begin with, section III contains no results: it describes the standard di usion equation and bilinear expansion of its G reen function over the appropriate set of B essel functions. Here, for a \tourist," all that is necessary to know is the notation $a^2=4$ adopted for the di usion coe cient, which means that the root-mean-square distance traveled by a walker during the time t is equal to a t.

Form ula (14) in section IV A is our rst small result, it is a very mild generalization of the Spitzer form ula (1) which takes explicit account of the distances r and r^0 of a polymer (or random walk trajectory) ends from the origin (or obstacle) O. Form ula (14) gives the probability distribution of winding angle for the random walk of length t with r and r^0 xed. Like the Spitzer law, it has diverging m om ents, such as h²i.

The very cum bersom e form ula (23) gives a similar result for the winding around a disc of a nite radius b. It generalizes form ula (2) by keeping explicit track of positions r and r⁰ of both ends. Just like (2), it decays exponentially and yields nite values for all moments, e.g., h²i. One utility of this result is the analysis of cross-over between winding around a point with in nite h²i and winding around a disc with nite h²i. As we show in Section IV C, when the disc size b goes to zero, there opens a wide range of tim est (see Eq. (26)) where the probability behaves as $1=^2$ up to about ln (a=b), and only at larger exponential decay takes over; therefore, when we say that h²i diverges, this really m eans h²i (ln (a=b)² at sm allb.

In Section V we go closer to the polym er view on the subject. For this, we consider that the two ends of the random walk are glued together, so that $r = r^0$ and = 2 n, where (positive or negative) integer n is the linking number, the number of turns the polym er ring m akes around the obstacle. Figure 2 depicts the statistical weight of the polym er conform ations with the linking number n as a function of r^2 =t. Q ualitatively, this exhibits a behavior sim ilar to that of the knotting probability as a function of chain length, because all cases with n \neq 0 (sim ilar to non-trivial knots) reach m axim al weight at some interm ediate values of r and/or t.

Sections V B and V C present our most original and most interesting ndings. In particular, we consider the following question. Given the closed random walk trajectory of the length t, we consider $_n$ - the locus of points around which the trajectory makes exactly n turns. Then, what is the area of $_n$? We denote by $_n$ (t) the average (over the random walk trajectories) of this area, then form ula (44) provides the exact answer to this question. The essence is that $_n$ (t) decreases very slow ly with n, only as $1=n^2$. O f course, ideologically this is similar to the slow decay of the Spitzer distribution (1). Another look at the same result is to think about a virial coe cient of a polymer ring with a long straight bar. Their interaction is topological in nature [25], and the virial coe cient can be understood as the surface excluded for a polymer ring by the presence of the obstacle if the ring is not entangled with the obstacle. This virial coe cient is the sum of all $_n$ (t) with $n \in 0$, and it is exactly equal to $ta^2=12$.

Note that the form erview of $_n$ (t) corresponds to the question about annealed topological disorder, as it relates $_{n}$ (t) to the probability of getting the topological state n. By contrast, the latter view on the same quantities n (t) corresponds abser to the idea of quenched topological disorder, as it re ects on the physical property of the polymer with given n. Another such physical quantity is the distance between the obstacle and an arbitrary point on the polymer. The exact expression for the rootmean-square of such distance is given by formula (48). The interesting aspect of this result is that this distance remains of the order of a t and only quite modestly depends on n, changing from approxim ately 0:496a twhen $n = 1 \text{ to } 0.408a^{1} \text{ twhen } n ! 1 \text{ . The fact that this dis$ tance decreases with growing \topological com plexity" n is not surprising, but the fact that it changes only slightly is interesting. One could have thought that the polymer would consist of n roughly sim ilar loops, leading to the typical size of a t=n. Our result, therefore, suggests that even at very large n there remains one big loop, with the length of order t, while all other loops are tight and sm all. This is rem in iscent of knot tightening recently discussed by K ardar and his co-workers [35].

In section V D, we make a brief com m ent on the elastic forces developing in the polymer ring either pushed too close to the obstacle or pulled too far away from it.

Finally, in the section V E we consider polymer ring entangled with a nite size obstacle, and show that in this case the distribution over the linking number n decays exponentially at largen, and the characteristic n is about ln (ta²=b²).

III. GREEN FUNCTION FORMULATION

A. Point-like obstacle

Consider a Gaussian polymer in 2D or, equivalently, a random walk in 2D. Suppose rst that the obstacle is point-like, positioned at 0, the coordinate center. The statistics of trajectories is fully described by the Green function, G $\begin{array}{c} x^0 & x \\ 0 & t \end{array}$, which is the partition function (or statistical weight) of the chain having the monom er 0 at x^0 and monom er t at x. The Green function satis es the di usion equation

where the notations are standard: is the Laplace operator acting on r, a is the monom er size, t is polymer length (\time"). The notation $a^2=4$ adopted here for the di usion coe cient, which is in fact a $^2=2d$, d being space dimension, is convenient because root-mean-squared end-to-end distance of the trajectory with no obstacles equals exactly a^{-1} . The G reen function can be written in terms of the bi-linear expansion over the corresponding eigenfunctions. Because our goal is to address the obstacle at 0, we choose eigenfunctions with cylindrical symmetry. The ones with no singularity at 0 read J (r)e[{], where J (x) is Bessel function of the rst kind, r and are polar coordinates corresponding to r, and 2 is the corresponding eigenvalue. A ccordingly, we write

It is worth noting explicitly that only positive > 0contribute to this expansion, because J (x) with negative index is singular at small x.

In most cases in mathematical physics, the angular dependence is 2 -periodic, meaning that and 2 n labelone and the same place on the plane. This is not the case for the problem at hand. Indeed, $G_t(r;0jr^0;)$ is the statistical weight of trajectories (polymer conformations) that start at a point som e distance r away from the origin 0 and arrive after $\pm m e^{-1}$ tat another point som e^{-1} from 0, where it is assumed that by the time t the trajectory has accumulated winding angle around 0. A coordingly, for instance, = 0 m eans no turns around 0, while 2 means one turn counterclockwise, = 2 is one tum clockwise, etc. In other words, we should treat our plane as a Riem ann surface, in which case and 2 n correspond to di erent layers.

M ost immediately, this means that not only integer, but all positive values of must be included in the bilinear expansion (4).

It turns out that integration over can be explicitly perform ed; the derivation of the relevant so-called W eber integral [32] is provided in the Appendix A. The result reads:

where I (x) is the modi ed Bessel function.

It is instructive to re-write the latter form ula by introducing R - the distance between r and r^0 : R = r r^0 , or $R^2 = r^2 + r^{0^2}$ $2rr^0 \cos$. We can write

The rst factor in the Eq. (6) (in square brackets) is simply the G reen function of an unrestricted polymer, or unrestricted random walk; in other words, it is the statistical weight of all conform ations going from r to r^0 . Therefore, W measures the fraction of trajectories with winding angle on the way.

Equations (5-7) were derived by Edwards [14].

B. Finite size obstacle

Consider now an obstacle having the shape of a disc with some nite radius b. Since the trajectory cannot make in nitely many turns around such obstacle, we expect that the probability distribution for the number of turns should be completely di erent for this case as com pared to the point-like obstacle.

We use the same method as before. Eq. (3) still applies, but as regards bi-liner expansion, Eq. (4), we have now dimension end of the end of the end of the satisfy the boundary condition of being equal to zero at r = b. This boundary condition removes all trajectonies which cross the boundary, or, in other words, which enter the r < b region. The eigenfunctions, corresponding to the eigenvalue ², can be written in the form Z (r; b)e^t, where (see Appendix B)

Here Y (x) is Bessel function of the second kind (another frequently used notation for Y (x) is N (x); we adopt here the notation used in M athem atica [33]). A few notes about functions Z are provided in the Appendix B, including the proof that the square root in the denom inator m akes them correctly norm alized. U sing Z, we write the G reen function as a bi-linear expansion, like Eq. (4):

Unfortunately, no known analog exists of the W eber integral for the Z -functions, and so, unlike the b = 0 case above, we were unable to nd any way to simplify this by perform ing either of the two integrations.

A ddressing the same problem of winding around the disk, Rudnick and Hu [5] have already found the expression for the Green function. Formula (9) looks surprisingly di erent from the known result [5]. In the Appendix C we show explicitly that these two results are equivalent.

C. W inding inside the cavity

Yet another interesting model is shown in Fig. 1(c). It is a random walk or linear polymer con ned in a re-

stricted volume, say, inside the disc of some radius B. Then, absorbing boundary conditions should be in posed on this boundary. A ssum ing for sim plicity that the obstacle is located in the center of the connement disc, we obtain that Eq. (4) holds, except integration over at every must be replaced by the sum over the discrete spectrum of $_n$ () such that J ($_n$ ()B) = 0. A susually, as t ! 1 we can resort to the ground state dom inance principle, which means we can truncate the sum mation to one leading term :

A. W inding around a point (b = 0)

The authors of the works [1, 2, 4, 5, 6, 7, 8, 9, 10], exam ined the problem of winding angle distribution in the following formulation. Suppose the walker starts some distance r from the origin, and suppose we are interested in the winding angle distribution irrespective of r^0 , the distance from the origin to the trajectory end. Form ally, such probability distribution is obtained via suitable integration of the G reen function over r^0 :

In the Appendix D , we show how to use the W eber integral to follow this path.

Unfortunately, in some other cases considered below, such as winding around a non-zero size disc (b \in 0), we don't have the advantage of the W eber integral sim pli – cation from Eq. (4) to Eq. (5), which makes the explicit integration of the G reen function over r^0 di cult. Besides, for polym er applications it is natural to keep track of the end position as long as possible. This is why it is useful to see how we can re-derive the Spitzer law (1) directly from Eq. (4), not resorting to Eq. (5). This is what we shall do now.

W e note that integration over in Eq. (4) is e ectively truncated at 2 4=ta². W hen t is large enough, this leads to both r and r⁰ being sm all. Then the Bessel function can be replaced by the rst term of its expansion, J () ' $\frac{1}{(1+)}$ 2. A fler that, the integration over is easily perform ed, yielding

This result is similar, but not identical to the Spitzer form ula (1). The di erence is in the de nition of the scaling variable x: form ula (14), unlike (1), keeps track of the coordinates r and r^0 of the trajectory ends. As we have already mentioned, this will be useful for polymer applications. Note, however, that we cannot integrate over r^0 as in Eq. (11), because form ula (14) was derived under the assumption that r^0 is not too large.

How then can we recover the Spitzer law (1) from Eq. (14)? W hat we should do is to note that one trajectory end is xed at the distance independent of t_{p} while the other is free, meaning that r a and r⁰ a t. Then, we have for the scaling quantity x in formula (14) x = ln ta²=rr⁰ / 2 = lnt, which is indeed exactly the same as in Eq (1).

O ther interesting extrem es are as follow s:

If r a and r at, then the \width" of the distribution gets very small. This is the closest approximation G aussian model can provide for the idea that fully stretched polymer does not have any freedom to wind around the obstacle. O f course, a G aussian polymer cannot be fully stretched, this is why, say, h² i, remains divergent even when the \width" goes to zero.

A similar situation is realized when $r^{0}r^{2}a^{-}t$: winding is suppressed when the obstacle is rem oved to the periphery of the coil. Note that Eq. (14) should not be used at largerr, when r is not sm all and the Bessel function cannot be expanded.

If both r a and 0 r a, then the result is only di erent from Eq. (1) by a factor of 2 in the de – nition of x; in this case, $x = = \ln t$. That means, xing both ends and not allowing them to wander freely reduces the \width" by half.

B. W inding around a disc (b > 0)

For winding around a disc of nite radius b, we can use the same method. W hen t is large enough, integration over in Eq. (9) is dominated by small . A coordingly, we can resort to the small expansion of Z (r; b) (see Eq. (B19) and the discussion in the Appendix B):

plus som e logarithm ic corrections. In A we accumulated all the uninteresting constant prefactors, which do not depend on r, r, r^0 , and b.

Now, considering this integral over , we have to justify all the assumptions and approximations which we made on the way. First and foremost, the assumption that is small is justified by the rapid convergence of the integral (20). Indeed, at large all three sinh's can be replaced by positive exponentials, leaving us with exp $\ln \frac{ta^2}{b^2} - \ln \frac{r}{b} - \ln \frac{r^0}{b}$. Since $rr^0 - ta^2$, the latter two logarithms in the round brackets should be

neglected. That means, the convergence of the integral (20) is controlled by the sinh in the denom inator, which e ectively truncates integration at smaller than $1=\ln ta^2=b^2$. This is very good news. First of all, since $1=\ln ta^2=b^2$ 1, this justi es the small simpli cation performed in formula (19). Second of all, this also justi es the use of the lower line in the expression (18) for the saddle point. Third, since only small contribute, the validity condition for the expansion of Bessel functions in the rst step of Eq. (15), which generally reads (r)² 1+ , can be simplied to r² a²t (and similarly ro² a²t).

Thus, all approximations leading to the expression (20) are self-consistent. The only task left is to evaluate the integral (20). This task gets easier if we use the notations

where we have re-introduced the norm alization factor, such that ${}^{K+1}_{1}$ W ()dx = 1. This integral can be reduced to the in nite sum of residues corresponding to the poles along the in aginary axes on the com plex -plane. In turn, the resulting sum (which is the com bination of several geom etric series) is easy for M athem atica [33], but can be also com puted by hand. One way or the other, here is the result:

The result (23) is unfortunately quite cumbersome, although it is symmetric and in some ways quite nice. Its beauty is revealed by consideration of various limits. As we learned in the case of point-like obstacle, the most interesting limit is when chain end is free, meaning that r^0 a t. Then, provided only that ta^2 b² - which is necessary, as the walker must have traveled much farther than the obstacle size b, we get 0'. In this case, we get

where in the latter transform ation we also noted that as the trajectory starting point is xed, r is independent of t, or ! 0 at large t. Thus, we recover form ula (2). Im portantly, the de nition of scaling variable x (21) becomes identical to that in (2), again under the same condition ta² b².

As in the case of point-like obstacle, other interesting extrem es are as follow s:

Both r $a \pm and r^0$ $a \pm c$. In fact, this case is on the border of applicability of our approximations, but qualitatively the result holds. Indeed, W () becomes very narrow, and approaches (x). This means, no turns are possible around the obstacle which is away from the random walk trajectory.

Another case, and also a border case in terms of applicability of our approximations, is r at or r^0 at, implying an exponentially improbable straight trajectory. The distribution is again sharply localized at small x.

Both r and rare independent of t, m eaning that both ' 0 and $^{\circ}$ ' 0. This case is safely within the lim its of applicability. Then,

As in the b = 0 case, this distribution, as one can easily check, is exactly two times more narrow than that of (2). In this case, unlike b = 0, this statement can be form alized by boking at the second moment of the distributions (2) and (25), which (in terms of x) turns out equal 1=3 and 2=3, respectively.

C. b! 0 lim it: applicability conditions of the Spitzer form ula

A coording to the Eqs. (1) and (2), winding angle distribution has nite variance at $b \in 0$ and diverging in nite

variance at b = 0. These equations leave it unclear what happens when the obstacle gets smaller and smaller, or when b decreases and approaches 0. It is instructive and interesting to use form ula (23) to see what really happens when b! 0.

The important part of our analysis here is to realize that so far we have been using several di erently de ned scaling variables x: see Eqs. (1), (2), (14), (21). So far, it was (hopefully) clear from the context in every place which x we have in m ind. Now, when we exam ine the b ! 0 lim it, we shall face several of these di erent x simultaneously, so we must be certain as to which x is which. For the rest of this section, we adopt the notation in which each x is labeled with the num ber of the de ning equation: x_1, x_{14}, x_{21} (note, that x_2 is exactly the sam e as $x_1: x_1 = x_2$). In particular, x in formula (23) is, of course, x_{21} .

Speaking of di erent de nitions of x, we should realize that so far we have been presenting probability distributions W () normalized with respect to integration over the corresponding x. For our purposes now, it is more convenient to use the normalization condition with respect to angle : $_{1}^{1}$ W () d = 1. For the form ula (23), this means the factor 2= ln(ta²=b²) should be incorporated; we do not re-write the form ula for brevity.

The main reason why the di erence between various x was unimportant so far is that at t ! 1 all de nitions converge to the same: x_{14} ! x_{21} ! $x_1 = 2 = \ln t$. However, when b ! 0, there appears a very broad intermediate range of timest such that although ta² b² (the trajectory is long enough to wind around the obstacle), but tb² a²:

Incorporating, as explained above, the factor $2\frac{1}{R_1} \ln (ta^2=b^2)$ ' 1= ln (a=b) to establish the normalization $\frac{1}{1} W$ ()d = 1, we nally get

For the two latter steps, we have plugged in the explicit expressions for , 0 (28), and x_{21} (27), and then neglected the 0 $\ln{(r^0=r)}$ terms (which we have underbraced in the interm ediate form ula). The result is exactly the same as form ula (14) (except it is norm alized with respect to integration over).

From our analysis, we can now understand the crossover between Eqs. (2) and (1). Speci cally, the Spitzer form ula (1) and its generalization (14) apply as long as two conditions are met: t $a^2=b^2$ and $\ln(a=b)$. At longer times and/or larger angles, the exponential tail of the distribution takes over. For instance, when we say the h^2i diverges for winding around a very sm all obstacle, this really means h^2i (ln (a=b))².

D. W inding inside a cavity

We start from Eq. (10). It is not di cult to realize that (the smallest zero of J ()) increases with . Therefore, when t gets large, the integration over is dominated by small , as in all previous cases. At small , is a smooth non-singular function, we can linearize it: $_{0} + _{0}^{0}$. Num erically, $_{0}$ 2:405 and $_{0}^{0}$ 1:543. To the same approximation, J (r=B) ' J₀($_{0}$ r=B). Therefore, evaluation of the integral in Eq. (10) becomes trivial, and the result reads

The decoupling of the ends r and r⁰ in form ula (31) is not surprising, this is the property of random walk locked in a restricted volume, and it is due to the fact that correlations are broken every time that the trajectory is re ected from the cavity border. As regards probability distribution of winding angle, it is once again the C auchy distribution, how ever, the scaling variable involves = t instead of = lnt for the random walk in an unrestricted space. This is also because correlations are broken every time that the trajectory hits the border. O ne can say that pieces of random walk with length about $(B = a)^2$ act independently of each other.

This gives rise to the following simple scaling argument providing an insight into the result (31). The winding angle distribution for every \blob" of the length (B =a)² is given by the Spitzer form ula (1), with the replacement t! (B =a)². Now, we have t= (B =a)² of such blobs. Since blobs are independent, the probability distribution of the sum of all winding angles of all blobs is given as a convolution. In other words, Fourier transform of the Spitzer distribution for one blob, which is e $j j \ln (B =a)^2$, must be taken to the power t= (B =a)². Apart from logarithm ic corrections, this returns the result (31).

Thus, the reason why h^2 i diverges for the polymer inside the cavity is because every blob can make many turns around the point-like obstacle on a small scale, before ever hitting the border of the cavity.

V. RING POLYMER: EDWARDS-PRAGER-FRISCH MODEL

We now want to make one step closer to the attempt of gaining insight into the properties of closed ring polymers. One way in this direction would be to say that a ring polymer is the random walk trajectory whose end points happen to coincide, namely $r = r^0$ and = 2 n, where integern (positive, negative, or zero) is the linking number (number of turns). Our results (14,23,25,32) are suitable for this, and we shall do it. It turns out also useful, how ever, to derive some additional results independently. In particular, some of the results below are exact (not asymptotically exact, but just exact).

A. Point-like obstacle: a ring with one monomer anchored

Thus, we return to Eqs. (6,7), and use them this time to write down the statistical weight of the ring polymer conformations with linking number n and with one monomer xed at the distance r from O:

In this formula, G_n (r;t) is the statistical weight of the ring with n turns, while the prefactor $1 = a^2 t$ is the statistical weight of a ring with no topological constraints [41]. Therefore, W_n () is the probability that polymerring xed at one point r makes n turns around the obstacle. In the Appendix E we check explicitly that W_n satis es the normalization condition as a probability.

Similarly to what we did before, we can address the case ta^2 r^2 , or 1. In this case, we truncate the small expansion of I () ' (=2) = (1 +), replace (1 +) ' 1 (com pare Eq. (D 1)), and then obtain

O f course, this is nothing else but the \discrete" version of the Spitzer distribution. However, merely taking = 2 n in Eq. (14) is not enough, as the normalization factor in (14) corresponds to $\begin{bmatrix} R_{+1} \\ R_{+1} \end{bmatrix} W$ () d = 1, while in Eq. (34) it corresponds to $\begin{bmatrix} P_{+1} \\ R_{-1} \end{bmatrix} W_n$ () = 1.

For a polymer, it makes perfect sense to exam ine also the opposite extrem e, 1. The corresponding asymptotics are easy to derive from the somewhat simplied expression for W $_{\rm n}$ ().

W e can a ord further simpli cation of the expression Eq. (34) for W $_{\rm n}$ () resorting to the following integral representation of the modil ed B essel function [34]:




FIG. 2: W $_{\rm n}$ () is the probability to form a link of order n with the point-like obstacle provided that one of the chain points is xed at the distance r away from the obstacle, where = $2r^2 = a^2t$, t being the chain length. The plots present the result of numerical integration based on formula (36). The plot of W $_0$ () is presented in the main gure. W $_{\rm n}$ () with n > 0 would not be seen well in this scale. For both W $_1$ () and W $_2$ (), we show the inset, each presenting the vicinity of them axim um; the corresponding places on them ain gure are shown by tiny dark rectangles. How ever sm allm ay seem every particularW $_{\rm n}$ (), it should be born in m ind that together they sum up to 1 W $_0$ ().

Equations (36,37) are convenient enough to address the 1 extrem e. Indeed, when is large, the integral converges at sm all u, which allows us to neglect u everywhere except in the exponential factor, where we can also truncate the $\cosh u' 1 + u^2 = 2$. This yields:

Thus, comparing (34) and (38) allW $_{\rm n}$ () start at 0 at = 0 and grow very rapidly at small . At n = 0,W_0() keeps increasing monotonically with , and W_0() approaches the saturation level of 1, while all W $_{\rm n}$ () with n \notin 0 decrease and rapidly die away at large . Obviously, each of them goes through a maximum. It is not dicult to establish that the maximum of W $_{\rm n}$ () corresponds to $1 = \cosh\left(\frac{1}{4n^2} - 1\right)$ which at large n corresponds to

 $e^{2 n}$. This is consistent with the fact that small asymptotics Eq. (34) is valid at $e^{2 n}$.

Eq. (36) allow s also straightforw and num erical integration which results in the plots shown in the Fig. 2.

B. Ring polym er entangled with a point

For the ring polym er, it is not very natural to consider one monom er being xed at r; all monom ers of a ring are equivalent. A coordingly, it is natural to de ne the quantity

W hat is n (t)? This quantity has the units of surface area and can be interpreted in the following way. Suppose a ring polymer moves freely on the plane within some large area A (much larger than the polymer size, so the polymer is not restricted in terms of its conformation). Consider one particular conformation of our polymer and then choose a random point 0 within A. Then $_{n}=A$ is the probability that polymerm akes an n-fold link around 0. We expect physically that $_0$ should be large, almost as large as A. This is also seen directly from the Eq. (37): when integrated over the whole area A, the st term (unity) yields just A. This is because when 0 is outside the coil, there may not be any topological links. If and only if the random point 0 is located within the polym er coil can there be any topological link. Therefore, ⁰ should be less than A by a quantity of the order of the coilgy ration radius squared, which is of the order ta^2 . On the other hand, $n \in 0$ should be them selves of order ta^2 , or even sm aller.

A nother way of understanding of $_n$ (t) is this. Consider one particular conformation of a ring and consider the set of points $_n$ such that the polymer makes linking with n turns around every point of $_n$. Then, $_n$ (t) is the surface area, or the measure, associated with the set $_n$.

Trying to compute $_n$ (t), we can resort to either of the expressions (34) or (36). Let us rst explore the rst possibility:

Here, we face a di culty, because the integral

diverges at large . W hat is the physical meaning of this? O focurse, this is because $_0$ (t) is close to A, or, in other words, it is divergent unless we take into account overall volum e restriction. We conclude, therefore, that the integral (41) diverges for a good reason: this is because unlinked polymer is free to move away from the obstacle, making $_0$ as large as (alm ost) A.

This hints on the way to circum vent the problem . Let us assume that the polymer is attached to the point 0 by a very weak spring. Since such polymer does not move away even when there are no topological links, we expect that even $_0$ should remain nite, independent of A. Indeed, instead of (41) we have now

That result exactly can be also obtained plugging Eq. (36) into the Eq. (39), although, som ew hat surprisingly, calculations are more involved along this route.

W e would like to rem ind to our reader once again, that $_{n}$ (t)=A is the probability to have linking number n for the polym er of the length t. As the probability distribution, $_{n}$ has the peculiarity that all itsm om ents obviously diverge, even just the average linking number is in nite. It is not di cult to trace this back to the fact that innitely exible polymer, as represented by the B rownian random walk trajectory, can make in nitely m any turns around a point-like obstacle. W e shall address this further later.

It is worth emphasizing that the results (44,45) are exact, their validity does not require even that t is large - they are exact at any t.

C. How far is the ring from the point-like obstacle?

O nem ore interesting quantity to look at is hr^2 i: the mean squared distance of one particular point on the ring to the obstacle, O. To determ ine the probability distribution for r, we note that _n (t) plays the role of a partition function. The probability density for r reads

The result is interesting. Surprisingly, it goes to a nite constant proportional to the unperturbed coil size ta^2 in the lim it of very strong linking, n ! 1. This should be understood by noting that even very large number of turns will be produced by a short piece of a trajectory, leaving a long part, of the order t, unentangled, with the size of order a^2t .

This is rem iniscent of the recent ndings by K ardar and his co-workers [35] in which they claim that in m any cases realknots in three dimensional polymeric loops are entropically dominated by conformations with the knot tightened in a short piece of polymer, and with the rest of the polymer uctuating freely with no knots.

D. Force

W hen winding model was rst introduced in the polym erphysics [14, 15, 16], it was done mostly in connection with problem s related to the nubber elasticity. A coordingly, elastic force, or force-extension curve, was the prim ary subject of interest. In case of DNA, such a curve can be also measured using som e sort of a single molecule technique [36]. A lthough both in rubbers and in DNAs real forces have both entropic and enthalpic contributions, in the winding model the force has purely entropic nature and, therefore, it is proportional to $k_B T$ in standard notations, where k_B is Boltzm ann constant and T is absolute temperature. In our notations, the force f_n which should be applied to the polymer to keep one of its links a certain distance r from the obstacle 0 at the xed topological invariant n is given by

We have not found any simple closed expression for the force, in this sense we make really no progress on this point compared to the papers [14, 15, 16]. Nevertheless, qualitatively, one glance at the Figure 2 is su cient to realize that the force f_0 of an unentangled ring is always positive. This is obviously because this ring is topologically repelling the obstacle. On the other hand, when $n \in 0$, the force is positive, corresponds to repulsion, only when r (or) is sm allenough. At largerr (or), the force

ips sign and becomes negative, which obviously corresponds to the elastic stress caused in the polymer ring by an attempt to pull it away from the obstacle with which the ring is entangled.

E. Ring polymer entangled with a nite size disc

For the obstacle of nite radius b, we were unable to obtain exact answers sim ilar to Eqs. (44) or (48). All we can do for this case is to resort to the asymptotic calculations. One of the advantages of the nite size obstacle m odel is that it allows to exam ine both asymptotics, we call them loose entanglem ent and tight entanglem ent, respectively. The form er regim e is realized when the size of the obstacle b is smaller than typical polymer coil dim ension at¹⁼², and, m oreover, when m inim al length necessary to make n turns, 2 bn, is still sm all com pared to $at^{1=2}$: nb $at^{1=2}$. In this case, calculations are similar to those of Section IV B. In the opposite extrem e, when nb at¹⁼², polymer has to be signi cantly stretched out to make all n turns. This corresponds to the far tail of winding angle distribution, which is usually not exam ined and which we did not consider in Section IV B.

1. Loose entanglem ent

A llwe can do for this case is to resort to the asymptotic calculations similar to those of Section IV B. In fact, the calculations are almost identical, and at the end they return essentially the result (25), with the only di erence in the normalization factor. Speci cally, the probability to have linking number n is proportional to

Similarly, although we cannot nd the exact expression for the value of $_{n}$ (t), but the estimate reads $_{n}$ (t) $b^{2} + r^{2}W_{n} r_{a}^{p} r_{\overline{t}}$.

Thus, quantities such as W_n and _n(t) decay exponentially at very large n, and the characteristic n where exponential decay starts is about ln $(ta^2=b^2)$. This latter quantity estimates also the characteristic linking num – <u>ber in</u> another sense, de ned as the root mean squared,

 $^{-1}$ hn²i. This is an interesting and som ewhat unexpected result. Indeed, one could have naively expected that the characteristic value of n should be proportional to ta²=b². Indeed, we expect that one turn around the obstacle should be similar to walking a distance about 2 b b, which requires a time $b=a^2$, in plying the num ber of turns to be about t= . Instead, we are getting something like $\ln (t=)$. This happens because a large portion of the chain length deviates much further away from the obstacle than b, and it makes turns around a much larger circum ference. This once again suggests that knot tightening [35] occurs even in this case of a disc-like obstacle with excluded volum e.

Similar to our discussion in section IV C, we can understand what happens when b ! 0. In this case, there appears a wide interval of polymer chain lengths $b^2=a^2$ t $a^2=b^2$ in which, say, n (t) decays only as $1=n^2$ in the wide interval of n, up to a large value of n of about ln (a=b).

2. Tight entanglem ent

The tight entanglem ent regim e is realized when n^2b^2 ta². In this case, polym er barely has enough length to make n turns around the obstacle. O byiously, the dom – inant polym er conformations are those tightly wound around the obstacle. This regim e is sim ilar to ray optics [38]. Indeed, if one searches for the solution of di usion equation (3) in the form $G = \exp[s(r;t)]$ and assumes that s is (in a proper sense) a slow ly changing function, then the so-called eikonal equation for s results:

Here, # and $\#^0$ are determined by the conditions $\cos \# = b=r$ and $\cos \#^0 = b=r^0$. Both these conditions and the solution itself are quite easy to establish based on the geometry presented in the gure 3. It is also easy to check by direct di erentiation that form ulas (53,54) present an exact solution of the eikonal equation (52).

F. Ring polymer inside a cavity

O ur discussion in the previous section is additionally illum inated by the problem of a ring polym er entangled with an obstacle while con ned in a cavity of the radius B. In this case, the result (32) directly applies, apart from the replacement ! 2 n, and the proper norm alization factor. We see that in this case the characteristic




FIG.3: Tight entanglement, or "ray optics" limit. In this gure, for the ease of drawing, we assume that the polymer makes just a little more than one turn around the obstacle, while its ends are xed at the given points. Distance to one end r and the corresponding angle # are shown in the gure; similar distance r^0 and angle $\#^0$ are not shown to simplify the gure.

value of n is proportional to $ta^2=B^2$. This number can be understood by saying that polymer is conned to a tube of the width D = B and length L = nB, where the typical n must be determined such that connement entropy is similarly contributed by chain squeezing across the tube and stretching along the tube (compare similar arguments in [39]). The connement entropy is well known [40], it is proportional to $ta^2=D^2 + L^2=ta^2$, where the two terms correspond to the two factors just mentioned - chain squeezing across the tube and stretching along the tube, respectively. Equating the two terms, we arrive at n $ta^2=B^2$, as expected.

VI. CONCLUDING REMARKS

We have focused on a special application, a toy Edwards-Prager-Frischmodel [14,15], and its generalization. It can be viewed as a model of an unsymmetrical in nite catenane. This catenane is formed from a random walk oft steps and \entwined" with in nite, rigid, closed structure composed of two straight legs, which are separated at least by a distance larger than ta, meeting at in nity. As such it allows one to extrapolate a limiting probability of catenation by a closed random walk, which is consistent with earlier estimates.

This model is widely recognized as the simplest playground for \statistical mechanics with topological constraints" [14]. Unfortunately, no simple notable result had previously come out of this model studies - except the very fact that it is \exactly solvable." We were lucky to nd a couple of such simple results. First, boking at the entanglement as an element of \annealed" disorder, we found that the area associated with all points around which closed random walk makes exactly n turns is equal to hR² i=4 n², where hR² i is the mean-square end-to-end distance of the linear walk of the same length. Second, boking at the entanglement as an element of \quenched" disorder, we found that the mean-squared distance between an obstacle an an arbitrary monom er of an n times entangled ring is equal to $(1=6)hR^2i 1 + 3=2 n^2$. Both results are exact. We have also found that the entanglem ent of a very long polym er is very uneven, in the sense that it tends to segregate into one very long loop, alm ost as long as the entire polym er, and a num ber of m uch shorter loops.

The generalization of E dw ards-P rager-Frisch m odel, in which an obstacle is not a point, but a disc of nite radius b, as far as we could tell, does not allow for an exact solution in any useful closed form. However, we were able to show that for annealed loop the m ean-squared linking num berturns out to be nite, of order $\ln^2 i$ ln (a=b). As b increases, the entanglem ent becomes increasingly tight, resulting in all loops being of comparable length.

O ur deliberations clearly re ect three aspects: The rst is the fruitful nature of Spitzer's [1] original insight for both further theory and its applications. The second is the value of self-consistent approximations in the eld when direct exact calculations are precluded by mathematical di culty. And, last but not least, the third is the usefulness of complete analysis of those simplied models which do allow for mathematically exact solutions.




FIG.4: Integration contours on the complex p-plane. Explanations are in the text.
