Sensitivity to initial conditions in self-organized critical system s

W e discuss sensitivity to initial conditions in a model for avalanches in granular media displaying selforganized criticality. We show that damage, due to a small perturbation in initial conditions, does not spread. The damage persists in a statistically time-invariant and scale-free form. We argue that the origin of this behavior is the Abelian nature of the model, which generalizes our results to all models with Abelian properties, including the BTW model and the Manna model. An ensemble average of the damage leads to seem ingly time dependent damage spreading. Scaling arguments show that this numerical result is due to the time lag before avalanches reach the initial perturbation.

There is evidence that the dynamics of a pile of rice m ay display self-organized criticality (SOC) [1]. In careful experiments where elongated rice grains were slow ly dropped between two glass plates, Frette et al. found scale-free behavior in a rice pile [2]. In a slow ly driven pile, the angle of repose evolves to a stationary state and the behavior of the system is dominated by a scale-free avalanche size density and punctuated equilibrium. This punctuation causes SOC systems to be highly non-linear, a single grain added at one end can result in an avalanche propagating through the entire system. However, SOC m odels typically have stick-slip dynamics β] and it has yet to be established whether they allow the non-linearity to m anifest itself in the form of sensitivity to initial conditions, as it does in chaotic system s.

We have studied damage spreading in a simple onedimensional granular model known as the 0 slomodel, which exhibits SOC [4]. It describes a number of slow ly driven granular systems and belongs to the same universality class as a model for interface depinning in a random medium and the Burridge-K nopo train model for earthquakes [5, 6, 7]. The 0 slomodel has largely resisted e orts for an analytic solution, the few exceptions have been the exact enumeration of the number of recurrent con gurations [8], the mapping of the model to the quenched E dwards-W ilkinson equation in the continuous lim it [5, 9], and the transition matrix results [10] and operator algebra recently developed for the 0 slomodel [11]. In this letter, we add to its analytical description by illustrating its A belian properties [12].

We nd that dam age due to a small perturbation does not spread in the 0 sb m odel as the dam age is unable to evolve. It is possible to represent the perturbation in terms of commutative operators which leads to a statistically tim e-invariant and scale-free dam age. This phenom enon is in contrast to what is seen in chaotic and

equilibrium systems. We also address the results obtained by a previous study on an ensemble average of the dam age, which seem s to contradict our ndings [13]. In fact, we show that these results are consistent with ours and that the observed behavior m ay be derived using sim ple scaling arguments.

The model: The O slo model is de ned on a one dim ensional discrete lattice with L sites at positions x =1;2;:::L, see Fig. 1. On the left, the boundary is a vertical wall, and on the right, the boundary is open. The height of grains at site x and time t is denoted h (x;t), the site has a critical slope, $z_c(x)$, which takes the values 1 or 2 with equal probability. At each time step a single grain is added to the site at x = 1. If the local slope at any site, x, exceeds its critical slope, $z(x;t) > z_c(x)$, an avalanche is initiated. The site will relax and a grain will topple from site x to site x + 1, i.e. h(x;t) ! h(x;t)1 and h(x + 1;t) ! h(x + 1;t) + 1. Each time a site relaxes its critical slope is redeterm ined, chosen random ly from the values 1 or 2. This toppling may cause sites x 1 to exceed their critical slopes, in which case these sites relax in turn. The avalanche will continue until the system reaches a stable con guration, when z(x;t)z(x) for allx.

consider a system which has been evolved to the critical state and make an exact copy at some time, t_0 . We de ne h°(x;t) and h°(x;t) as the heights of the original and copy, respectively, and $z_c^{c}(x)$ and $z_c^{c}(x)$ as the critical slopes of the original and copy, such that

We then perturb the copy by adding a single grain to a site, i, such that $h^{\circ}(i;t_0) = h^{\circ}(i;t_0) + 1$, see Fig. 1(b). This extra grain is not allowed to topple until it is toppled upon by an avalanche from above. The two systems are then evolved using exactly the same exequence of random thresholds $fz_c(x)g$ for corresponding sites in the original and copy. This ensures that the dam age observed is purely due to the extra grain in the copy. Further justi-

cation for this is to consider the m apping of the m odel to interface depinning as it is clear that the m edium the interface m oves through does not change as a result of the perturbation.

W e m easure the dam age, de ned as

Figure 2 is a plot of dam age versus time for a typical simulation. There appears to be no sense of temporal evolution in the data, the dam age is continually uctuating between high and low values, often returning to H = 1 where the original and copy only di er by a single grain. The triangles in Fig. 2 indicate which of these H = 1 con gurations are repaired con gurations where the extra grain in the copy is at the site which was originally perturbed and corresponding sites in the original and copy have relaxed exactly the sam e number of times. In repaired con gurations, the di erence between the two systems is exactly equivalent to the initial perturbation at t_0 . The occurrence of a repaired con guration corresponds to Yesetting the clock', meaning that the dam age This behavior emerges because the 0 slo model has an Abelian nature, where the commutative operation is adding one unit of slope to a site and allowing the system to relax. If we add one unit of slope at site x and then at site y, it is equivalent to adding at site y and then x. The Abelian nature is alluded to by the fact that these simulations require a careful record of the sequences of random critical slopes. In this way the sequences of critical slopes are no longer random noise, but an intrinsic property of the system where the values, although generated random ly, are treated as given a priori. Note that the model is not Abelian in the strict sense of an Abelian group as there is no inverse operation.

We introduce the notation C (t) to represent the stable conguration of a system at time t. The relevant operators are the perturbation operator P_i , which simply adds one unit of slope to site i and $\hat{P_i}$, which adds one unit of slope to site i and allows the system to relax if necessary. Thus, $\hat{P_i}$ represents a mapping within the conguration space of C (t). The evolution of C (t) can be expressed by an evolution operator \hat{T} $\hat{P_1}$, that is

$$C (t + 1) = \hat{T}C (t)$$

The operators $\hat{P_i}$ and \hat{T} obey the commutation relation

$$\hat{\mathbf{P}}_{i}\hat{\mathbf{T}}\mathbf{C} (t) = \hat{\mathbf{T}}\hat{\mathbf{P}}_{i}\mathbf{C} (t); \qquad (4)$$

which we prove elsewhere [14]. Hence, adding slope to a system and then evolving it leads to the same con guration as evolving it and then adding slope, as we may always move the $\hat{P_i}$ operator on the right hand side of Eq. (4) to the left of the \hat{T} operator.

If we begin with a system at a point C (0) in con guration space, then the repeated operation of \hat{T} de nes the chain of con gurations which C (t) will pass through during its evolution. Consider a succession of points C (t), which is related to C (t) by the relation C (0) $\hat{P_iC}$ (0). The points C (t) and C (t) will be connected through the operator $\hat{P_i}$ at every step of the evolution of the two systems, i.e. C (t) $\hat{P_iC}$ (t), for all t.

The perturbation we studied in the simulations was the addition of a single grain and not slope. Adding a single grain to site i will change the slopes such that $z^{c}(i;t_{0}) = z^{o}(i;t_{0}) + 1$ and $z^{c}(i \quad 1;t_{0}) = z^{o}(i \quad 1;t_{0}) \quad 1$. To analyze this situation, we start with a master system C^{m} (0) and derive from this two other system s C^{o} (0) and C^{c} (0) through the relations

$$C^{\circ}(0) = P_{i1}C^{m}(0)$$

 $C^{\circ}(0) = P_{i}C^{m}(0)$: (5)

It is straightforward to verify that the con gurations $C^{\circ}(0)$ and $C^{\circ}(0)$ di er by one grain at site i, thus reproducing the original and perturbed system s of our sin ulations with the perturbative grain placed at site i, see

Fig. 3. Each of these points start a chain of stable congurations, linked by the operator \hat{T} . A fiter an avalanche has reached site i, each con guration in the master chain links to those belonging to the original and copy by the operators $\hat{P_{i}}_{1}$ and $\hat{P_{i}}$, respectively, due to Eq. (4). Note that the operator $\hat{P_{i}}$ does not have a unique inverse so there is no direct path between the original and copy.

The important result from this is that dam age cannot spread. Spreading im plies that the sm allam ount of dam age at t_0 leads to a little m ore dam age at $t_0 + 1$, and so on until the dam age saturates the system, which is the case for a chaotic system. The Abelian nature means that the value of the dam age at any time is independent of when the perturbation took place. Hence, spreading is not possible. However, the dam age does not rem ain constant or decay, as in an equilibrium system, because the dam age is exactly that due to the avalanches which would be caused by adding slope to di erent sites in the master system at that time. This leads to a dam age size density that is related to the avalanche size density, as easily recognized by considering the special case of perturbing site i = 1. As the avalanche size density is scale free, we nd that the dam age size density is scale free also. In an in nite system the dam age may become arbitrarily large, yet it will frequently return to an H = 1 con guration! In other words such a system may be considered as lying on the edge of chaos [15, 16].

The dam age in a single pair of system s is statistically time invariant, yet a previous study has found that the ensem ble averaged data is not [13]. The ensem ble average of dam age over N runs, gives the average dam age as a function of time

$$hH i(t;L) = \frac{1}{N} \sum_{j=1}^{N'} H_{j}(t;L;i_{j}); \quad (6)$$

where H_j(t;L;i_j) is the dam age from a single run and the variable i_j is the site of perturbation for the jth run. In Ref. [13] it was found that for $i_j = L=2.8j$

$$hHi(t;L) = t^{z} G \frac{t}{L} ; \qquad (7)$$

where z and are exponents to be determ ined and G (x) is constant for x 1 and proportional to x^{z} for x 1. The apparent time dependence arises from the fact that the perturbed site is not allowed to relax until it is relaxed upon from above. This forces all the system s into a repaired con guration at the start of the simulation and the average dam age increases over time as more system s have avalanches which reach the perturbed site.

In the case where the perturbative grain was placed on a random site for each system in the ensemble, scaling arguments may be used to derive the temporal evolution of hH i(t;L). The derived equation agrees well with the simulation data. First, we calculate how long avalanches take to reach the perturbed site, which we denote as site i. The linear avalanche size, l, is known to be related to the avalanche size, s, by s / 1^{P} , where D is the avalanche fractal dimension, D 2:25 §]. A ssum ing s = 1^{P} , the probability P₁(l;L)dl of having an avalanche with linear length in the range l ! l+ dl, obeys P₁(l;L) dl = P_s(s;L) ds, where P_s(s;L)ds is the probability of having an avalanche of size s in the range s ! s+ ds, given by the scaling ansatz

$$P_{s}(s;L) ds = s G_{s} \frac{s}{L^{D}} ds;$$

where $G_s(x)$ is constant for x = 1 and decays rapidly for x = 1, and is the avalanche exponent, 1.555]. We nd

$$P_{1}(l;L) dl = l^{D} G_{1} \frac{l}{L} dl; \qquad (9)$$

where $G_1(x)$ is constant for x 1 and decays rapidly for x ! 1. Note that we have used the scaling relation = 2 1=D which is derived from the fact that hsi = L [9].

T his result allow sus to calculate the probability of having an avalanche of linear size larger than some distance X, which we denote (X).

$$(X) = \sum_{X}^{Z_{1}} P_{1}(l;L) dl / X^{1 D} :$$

Hence, we may expect to have an avalanche of size 1> X within the timescale

$$t = \frac{1}{(X)} = X^{D-1} = X ;$$
 (11)

where we have used the scaling relation = D = 1, relating the roughness exponent to the fractal dimension D [5]. We use Eq. (11) to obtain an ansatz for hX i(t;L), the average linear distance reached by the avalanches in a time t,

$$hX i(t;L) = t^{\perp}g \frac{t}{t_{L}} ; \qquad (12)$$

where t_L is the time scale after which the avalanches can be expected to have spanned the entire system and g(x)is constant for x 1 and proportional to x $\frac{1}{2}$ for x 1 which ensures that hX i(t;L) L for all t. By inserting X = L into Eq. (11) we see that t_L / L , which leads to hX i(1;L) = L as expected.

The average dam age as a function of time and system size, hH i(t;L), may therefore be expressed as

$$\begin{aligned} \text{hH} i(\textbf{t}; \textbf{L}) &= \textbf{L} \ \textbf{F}_{\text{H} \, \text{\&} \, 1} \, (\textbf{t}; \textbf{L}) + 1 \quad \textbf{F}_{\text{H} \, \text{\&} \, 1} \, (\textbf{t}; \textbf{L}) \\ &\qquad \textbf{L} \ \textbf{F}_{\text{H} \, \text{\&} \, 1} \, (\textbf{t}; \textbf{L}) \quad \text{for } \textbf{L} \quad 1; \end{aligned} \tag{13}$$

where $F_{H \ e \ 1}$ (t;L) is the fraction of system s in an H $\ e \ 1$ dam aged con guration at time t,L is the mean amount of dam age of a system in the dam aged con guration and the last approximation is true for large L. If the positions of the perturbed sites are distributed uniform ly among the system s in the ensemble, we expect

$$hHi(t;L) = L \frac{hXi(t;L)}{L} = t G \frac{t}{L} ; \qquad (14)$$

where $G(x) = x^{-1} g(x)$ and we have taken $t_0 = 0$. Scaling arguments, taking care to use the scaling relation = 2 2=D for a bulk driven system 17, yields = 1. This is consistent with our measurement of 1 and so, putting = 5=4 and = 1 into Eq. (14), we have

A data collapse of the data using these values is show n in Fig. 4. It is in good agreement with Eq. (15), thus supporting our explanation for the appearance of a time dependence in hH i(t;L). However, this is only a crude calculation as there are many e ects we have ignored. For instance, we have only calculated the average time for avalanches to reach the perturbed site. There is actually a distribution of times and this will contribute to the time dependence of hH i(t;L). In conclusion, we have analyzed dam age spreading in the O slom odel, showing that dam age is unable to evolve in a perturbed system . The dam age is statistically time invariant and scale free and thus allows for arbitrarily large values in in nite systems. This phenom enon is due to the Abelian property of the 0 slo m odel, and this generalizes our result to all otherm odels with Abelian properties, including the BTW model [1], the M anna m odel [18] and the m odel for interface depinning in a random medium 5, 9]. Thus, many of the classic models of SOC may be considered as lying on the edge of chaos [15, 16]. Finally, we have shown how sim ulations may in fact lead to a time dependent ensemble averaged dam age and have calculated this for the case of random placem ent of the perturbative grain.
