# Collision D rag E ect on Two-Fluid Hydrodynam ics of Super uid <sup>3</sup>H e in A erogel

## Abstract

Sound propagation in super uid <sup>3</sup>H e in aerogel is studied on the basis of a two- uid m odeltaking into account the e ect by the drag force due to collisions between <sup>3</sup>H e-quasiparticles and aerogel m olecules. The drag force plays a role of frictional force between the aerogel and the norm aluid component. In local equilibrium, they move together in accordance with M cK enna et al.'s m odel. The deviation from the local equilibrium leads to the damping of sound. W e give explicit expressions for the attenuation of longitudinal sounds in this system. W e also discuss the sound propagation in a super uid <sup>3</sup>H e-aerogel system embedded in a narrow pore. It is shown that the forth sound propagates in such a system because of the clamping of the norm al uid by the aerogel.

### I. IN TRODUCTION

It is well known that there exists a variety of sound modes in liquid <sup>3</sup>He. In the norm al phase, in addition to the usual hydrodynam ic sound mode (the rst sound), the so-called zero sound propagates as a well-de ned sound mode in the collisionless regime at low tem – peratures. In the super uid phase, other two kinds of sound, the second and forth sound, can propagate which rejects the presence of the normal and the super uid component of liquid. The second sound is the out-of-phase oscillation of the two uids. The forth sound is the oscillation of only the super uid component when the normal uid is clamped owing to its viscosity in a narrow channel.

Recently, there has been increasing interest in the sounds in liquid <sup>3</sup>H e con ned in highly porous aerogel.[1, 2, 3, 4, 5, 6, 7, 8, 9, 10] The aerogel consists of a random structure of silica strands of approximately 3 nm in diameter. The <sup>3</sup>He-aerogel system has been regarded as a model system for studying the impurity scattering e ects on the Fermi liquid which undergoes a transition to an unconventional Cooper pairing state. Nom ura et al.[1] and Gervais et al.[2] have observed that the longitudinal sound attenuation in norm al liquid <sup>3</sup>H e in aerogel does not show the characteristic tem perature dependence of the Ferm i liquid, ie., the rst-to-zero sound transition. In addition, the norm alphase attenuation is of the same order of magnitude as the pure  ${}^{3}$ He case in spite of the presence of random scatterers. They also found the absence of the attenuation peak due to the order param eter collective excitation in the super uid phase of <sup>3</sup>He in aerogel. To study the attenuation theoretically, the hom ogeneous scattering model[11] can be a good starting point, because the sound wavelength (20 m) is much longer than the inter-strands spacing (30 nm), [1, 2] so that the detailed structure of aerogel is expected not to play a signi cant role. The hom ogeneous scattering model, however, predicts a signi cantly large attenuation [5, 6] (which is two order of m agnitude larger than the observed value) though it can reproduce the qualitative tem perature dependence.

To resolve the discrepancy between the theory and the experiment, Ichikawa et al.[6] have studied the e ect of simultaneous aerogelm otion caused by collisions with  ${}^{3}\text{H}$  e-quasiparticles. Such a collision drag e ect reduces drastically the longitudinal sound attenuation and the experimental results can be reproduced by the collision drag model.[6, 8] This model has recently been applied to the transverse sound in the  ${}^{3}\text{H}$  e-aerogel system .[7] It was shown that

the collision drag e ect m odi es strongly the nature of the transverse sound propagation; for example, the transverse sound in the hydrodynam ic regime, which is an overdam ped m ode in pure  ${}^{3}\text{H}e$ , can propagate over a long distance.

In this paper, we discuss the collision drag e ect in super uid <sup>3</sup>He-aerogel system. M cK enna et al. $\beta$ ] have already proposed a theory of the sound in super uid-aerogel system. They modi ed a set of two- uid hydrodynam ic equations to take into account the interlock-ing motion of the norm al component and the aerogel. This theory was used by G olov et al.[4] to extract the super uid density  $_{\rm s}$  in the <sup>3</sup>He-aerogel system from the sound velocity measurem ents.

In deriving the modi ed two-uid hydrodynam ic equations, M cK enna et al. $\beta$ ] assumed the norm all uid to be completely locked to the aerogelm atrix, i.e., the system is assumed to be in local equilibrium. The resulting equations can determ ine only the sound velocity and cannot give any information about the attenuation. In this paper, we discuss the longitudinal sound attenuation in super uid <sup>3</sup>H e in aerogel when the system deviates slightly from local equilibrium. In addition to the bulk <sup>3</sup>H e-aerogel system, we shall consider a restricted geometry such that the aerogel is built in a pore formed by sintered silver powders, as used in the fourth sound experiment[9].

# II. MODIFICATION OF TWO-FLUID HYDRODYNAM IC EQUATIONS

Now we consider the drag force exerted on aerogel molecules. The drag force can be defined as the net momentum transfer per unit time from super uid <sup>3</sup>He to the aerogel during in purity scattering processes. Thus the drag force can be determined from the collision integral in the quasiparticle transport equation.[6, 7, 8] In the normal state, the drag force density F is given by  $F = \frac{1}{t_r} (1 + F_1^s = 3)$  (v g), where  $t_r$  is the transport relaxation time for the in purity scattering, the mass density of liquid <sup>3</sup>He,  $F_1^s$  the Landau parameter and v and v<sub>a</sub> the local velocities of the liquid and the aerogel, respectively. Since F is proportional to the relative velocity v  $v_a$ , it can be also interpreted as friction between the liquid and the aerogel. In the super uid phase, the motion of the super uid component is expected to uncouple with the aerogel. It is, therefore, plausible to generalize

the norm al-state result of F into

where  $_{n}$  is the norm al-uid density,  $v_{n}$  is the norm al-uid velocity and  $_{f}$  denotes a relaxation time characterizing the frictional eet between the norm all uid and the aerogel. The relaxation time  $_{f}$  is expected to be of the same order as the impurity scattering time  $_{i}$ . In fact in the norm alphase it is given by  $_{tr}=(1 + F_{1}^{s}=3)$ . In super uid phase, involved m icroscopic calculations are necessary to obtain an explicit expression for  $_{f}$ . We shall, therefore, treat  $_{f}$  as a phenom enological parameter in this paper.

We can now obtain two-uid hydrodynamic equations taking into account the collision drage ect. In the set of the conventional two-uid equations, the momentum conservation law is modied because of the momentum loss due to the drag force, while the equation of motion of the super uid velocity  $v_s$  remains unchanged. The two-uid equations for longitudinal sound are thus given by

where = n + s,  $J = nv_n + sv_s$ , is the viscosity and P, S and T are pressure, entropy and temperature, respectively. The above equations are dimensioned to the the drag force F and the viscosity are included. The form er enables us to study the case when  $v_n \in v_a$ . The latter is necessary to reproduce the norm al-state dispersion relation derived previously.[6, 8] The two-uid equations must be supplemented by the equations of motion of aerogel:

where  $_{a}$  is the aerogel m ass density and the restoring force due to the elasticity of the aerogel is denoted as  $r P_{a}$ . The pressure  $P_{a}$  is related to the longitudinal sound velocity

## III. SOUND DISPERSION RELATION

From the above set of equations, we can derive the dispersion relation of the longitudinal sound in super uid <sup>3</sup>H e-aerogel system. To do that, we shall assume, as usual, that all the non-equilibrium quantities have the space and time dependence of exp (iq r i!t). Then, using eq. (1) and the equations of motion of aerogel, we obtain the following relation between  $v_n$  and  $v_a$ :

where  $!_q = C_{al}q$  is the frequency of skeleton aerogel sound. It follows that the local equilibrium ( $v_n = v_a$ ) is achieved by taking the limit  $!_f ! 0$ . Combining eq. (9) with our two-uid equations, we not that the dispersion relation can be written as

In eq. (10),  $C_1$ ,  $C_2$  and  $C_4 = [(_{s}=)C_1^2 + (_{n}=)C_2^2]^{1=2}$  are the rst, second and fourth sound velocities as de ned in the conventional manner. It is easy to show that eq. (10) is reduced to the previous result [6, 8] in the normal state. Moreover, eq. (10) with = 0 and in the lim it !  $_{f}$  ! 0 coincides, as expected, with the dispersion relation of M cK enna et al.[3]

Equation (12) determ ines the velocities of two sound modes (fast and slow modes) in local equilibrium . $\beta$ , 4] The two sound modes in the <sup>3</sup>H e-aerogel system have been observed by G olov et al.[4] A coording to this experiment, the velocities of the fast and slow modes, C<sub>f</sub> and C<sub>s</sub>, satisfy the conditions such that C<sub>f</sub><sup>2</sup> C<sub>2</sub><sup>2</sup>, C<sub>f</sub><sup>2</sup> C<sub>al</sub><sup>2</sup> and C<sub>1</sub><sup>2</sup> C<sub>s</sub><sup>2</sup> C<sub>2</sub><sup>2</sup>. Taking

into these conditions, we nd from eq. (12) that  $C_{f}$  and  $C_{s}$  are approximately given by

When  $_{\rm f}$  and  $_{\rm f}$  are nite, the complex velocities z's have corrections which give the attenuation = Im q of the two hydrodynam ic sound modes. U sing eq. (10) and keeping only the leading order correction terms, we obtain the attenuations of the fast and slow modes,  $_{\rm f}$  and  $_{\rm s}$ , as

The expressions for the attenuations include term s / and / f, rejecting the viscous elect and the frictional elect, respectively. The information on the phenom enological parameters and f can thus be obtained from attenuation measurements. We shall show in the next section that a more useful and direct information on the frictional relaxation time f can be provided by the forth sound attenuation measurement.

## IV. FOURTH SOUND IN NARROW PORE

Now we discuss the sound propagation in a super und  ${}^{3}\text{H}e$ -aerogel system built in a narrow pore. Such a system has recently been prepared by K otera et al.[9] using sintered silver powders of 70 m in diameter to study the fourth sound propagation in aerogel. The sintered silver powders provide pores with the average diameter of L 10 m.

In such a system, the sintered silver will play a role to clamp the aerogel strand ends. The longitudinal wave of the aerogel along the pore channel is, therefore, accompanied by a transverse standing wave so that the xed end boundary condition should be satis ed. It follows that the eigenfrequency  $!_q$  of the aerogel is replaced by

where  $C_{at}$  is the transverse sound velocity of aerogel. The second term gives an energy gap due to the standing wave motion. Using  $C_{at} = 178.5$  m/s for 91 % porous aerogel[10], the

gap at q = 0 is estimated to be 56 M H z for L = 10 m. We see that a condition  $!_q^2$   $!^2$  is fully satis ed in low-frequency acoustic experiments in which the frequencies are typically about 10 kH z or less.

This observation shows that the aerogelm otion in the pore is hardly excited by the low frequency sounds. In the lim it  $!^2 = !_q^2 ! 0$ , the aerogel cannot move and then the dispersion relation (10) takes the form

The fourth sound can propagate in the lim it  $f_{\rm f}$  0 because the norm all uid is clamped by the \hard" aerogel. The attenuation  $f_4$  of the fourth sound is obtained from eq. (18). The result is given, up to leading order in  $f_4$ , by

Note that eq. (19) does not involve the viscosity because its contribution to  $_4$  occurs only in higher order terms in the !  $_f$  expansion. The attenuation of the fourth sound in the <sup>3</sup>H e-aerogel system is thus dom inated by the frictional relaxation time  $_f$ . Using eq. (19), the parameter  $_f$  can be determined from simultaneous measurements of C<sub>4</sub> and  $_4$ .

The reason why the frictional e ect dom inates the fourth sound damping is the following. In the pore channel with the aerogel, the normal ow no longer obeys the Hagen-Poiseuille law but is governed by the D rude law .[14] In the presence of aerogel, the viscous penetration depth for !  $_{\rm f}$  1 is given by [14]

and the viscosity in the super uid phase is

where  $v_F$  is an appropriate average of the quasi-particle group velocity. At low tem peratures, the viscous relaxation time is also limited by the impurity scattering time i f. In fact, in case of the sound experiment by Nomura et al.[1] (98% aerogel, 16 bar) one can see that i happens at 10 m K.W e nd therefore that the viscous penetration depth in the presence of the aerogel is given by

and is as sm all as the mean free path.

#### V. CONCLUDING REMARKS

We have discussed hydrodynamic sound propagation in super und  ${}^{3}\text{H}$  e-aerogel system. In a bulk system, the aerogel oscillates together with the norm alliquid by the collision drag e ect. As a result, two kinds of sound (the fast mode and the slow mode) [3] can propagate as was observed by G olov et al.[4]. The deviation in the local velocity between the norm all component and the aerogel leads to the damping of the sounds. We have given explicit expressions for the sound absorption. On the contrary in a narrow pore, the aerogel cannot m ove because the aerogel is clamped by the pore surface. In that case, the fourth sound can propagate along the pore channel. It is to be emphasized that the inter-locking between the norm all component and the aerogel occurs not by the viscous e ect as so far considered but by the collision drag e ect. In other words, the norm all component is in the D rude regim e.[14]

The modi ed two-uid theory presented in this paper is still a phenom enological theory and includes many unknown parameters. In addition to the super uid mass density, microscopic information on the relaxation times in dirty super uid <sup>3</sup>He is necessary for more detailed comparison with experiments. This problem and also the justi cation of our two-uid model shall be discussed elsewhere.
