Therm odynam ic and Transport M easurem ents on Superconducting N a_x C oO $_2$ yH $_2$ O Single C rystals P repared by E lectrochem ical D e-intercalation

Superconducting single crystal samples of N $_{\rm Ax}$ C oO $_{\rm 2}$ yHO have been produced using an electrochem ical technique which dispenses with the usual brom ine chemical de-intercalation step and perm its much more precise control of the N a content. A firer careful hydration, nearly single-phase crystals have been obtained in which over 90% of the sample's volume corresponds to the superconducting N $_{\rm 30.3}$ C oO $_{\rm 2}$ 1:3HO structure. Susceptibility and special cheat measurements conamn that bulk superconductivity has been achieved. The extracted normal state density of states indicates Fermi-liquid behavior with strong mass enhancement and a modest Wilson ratio. Measurements of H $_{\rm C2}$ for H k c and H k ab reveal signicant anisotropy. The estimated value of H $_{\rm C2}$ for H k c yields a coherence length of 100 A, consistent with an extremely narrow bandwidth.

Sodium cobalt oxide, Na_xCoO_2 (x 0.65 to 0.75),has received considerable attention due to its unusual therm al electric properties.[1] Recent studies have revealed anomalous non-Fermi liquid behavior in transport properties which point to the importance of strong correlations.[2, 3] The cobalt ions form a hexagonal layered structure and the form ally 1 x fraction is in the low spin (S = $\frac{1}{2}$) Co⁴⁺ state, while the x fraction is in the $S = 0 \, \text{Co}^{3+}$ state. Interest in this material escalated with the discovery of superconductivity by Takada et al.[4] in NaxCoO2 yHO when the sodium concentration is reduced to about 0.3 and water is intercalated between the layers. The ability to control the sodium content is an exciting development because, in principle, the limit of x = 0 corresponds to a M ott insulator on a triangular lattice with $S = \frac{1}{2}$. Then the hydrated compound can be viewed as electron doping of a M ott insulator with a doping concentration x 03. As such, it is the second known example of superconductivity arising from doping a Mott insulator after the high Tc cuprates. The $S = \frac{1}{2}$ antiferrom agnet on a triangular lattice was in fact the starting point of Anderson's resonating valence bond (RVB) idea, [5] and the new superconductor has been intempreted in this light.[6, 7, 8]

Until recently, the bulk properties of superconducting N $a_{0.3}$ C oO $_2$ 13HO has been studied mostly using powder samples.[9, 10, 11, 12, 13] Single crystal measurements [13] are much less plentiful, though such measurements are extremely important in order to understand this anisotropic layered compound. In this paper we report a new electrochemical method to extract Na from Na_xCoO₂. This is an alternative to the chemical deintercalation of Na using Br ions introduced by Takada et al.[4]Our electrochemicalmethod permits precise control of the Na content and avoids the environmental hazards associated with the use of high molar concentrations of Br. In addition, we have succeeded in growing

large single crystals of N a_x C oO $_2$ by the oating zone (FZ) m ethod. By applying the electrochem ical procedure to the FZ crystals, we have obtained superconducting single crystal sam ples with which we have carried out a variety of physical property m easurem ents.

The initial Na_{0:75}CoO₂ polycrystalline material was prepared using Na₂CO₃ and Co₃O₄ with Na to Co ratio at 0.75 to 1. The thoroughly m ixed and ground powder was calcined at 750C for 12 hours and then reacted at 850C for 24 hours with frequent grindings in between. Na loss was minimized with a fast-heating method.[14] A stoichiom etric $Na_{0.75}CoO_2$ feed rod was melted and re-crystallized with an optical oating-zone furnace (4-Xe lam p design, CSI Japan) under oxygen atm osphere. Although Navapor loss was observed from the white deposit on the walls of the quartz sample chamber, this loss was minimized by choosing a fast pulling rate. A stable molten zone can be maintained with various pulling rates from 1.5 to 10 mm/hr. Electron probe microscopy analysis (EPMA) indicates the FZ crystal has Na content between 0.71 and 0.74 for a crystal pulled with 2 mm/hr rate. We have grown large single crystals of Na_{0:75}C oO 2 (5mm diameter 8 cm long) successfully with this FZ method. Powder neutron di raction con ms that the Na level of the FZ crystal is essentially identical to that in the feed rod.[15]

A three-electrode electrochem ical cellwas set up using the N a_x C oO $_2$ sample as a working electrode, platinum foil as a counter electrode, A g/A gC l as a reference electrode (E $_0$ = +0.222 V vs. the standard hydrogen electrode), and 1M N aO H as an electrolyte. The proposed half reaction at the anodically polarized N a_x C oO $_2$ electrode responsible for N a extraction is

where the generated NaOH becomes dissolved in the electrolyte. Because Na $_{\rm x}$ CoO $_{\rm 2}$ is metallic, the work-




FIG. 1: The quasi-open circuit potential (OCP) as a function of time during charging of the EC cell. The arrows indicate regions of special stability and are labelled with possible Na concentrations associated with these regions.

ing electrode can be prepared directly using a compressed powder or a single crystal sample. Hydrated $Na_{0.3}CoO_2$ yHO can be prepared by having the sam ple anodically polarized with a constant voltage (0.6{1.2 V) until the decaying anodic current reaches a constant value. A Itematively, a constant current (of 0.1 (10 m A) can be used to achieve the same charge level by waiting until the nal open circuit potential reaches V vs. Ag/AgCl. Samples obtained directly from the cell are typically in a mixture of the partially hydrated [9] (c' 13:8 A) and fully hydrated (c' 19:7 A) structures and show only trace amounts of superconductivity. Fully hydrated superconducting crystals can be achieved by sealing the sample in a water vapor saturated container at room temperature. We not that the rate of hydration depends on grain size and several months are required to fully hydrate mm-sized single crystals. The sodium content in each sample was checked by electron probe m icroanalysis. A fter electrochem ical treatment, our asprepared oating-zone single crystals with x = 0.75 typically break apart into smaller crystals (5 5 2 mm) with x' 0:28 0:32.

The quasi-open circuit potential (OCP) was measured as a function of time during a repeated sequence of having a current density of 0.01 A/g turned on (for 100 seconds) and o (for 100 seconds). Here, the quasi OCP is the potential recorded during the time the current is o .W e can interpret the OCP m easured in this manner as the chem ical potential of the surface layer of the sam ple. In Fig. 1 we plot the quasi-0 CP vs. time where the charging current density is 0.01 A/g. The time axis is therefore proportional to the total charge supplied to the sample surface. A plateau in the OCP corresponds to two-phase coexistence. We can identify three prominent plateaus in Fig. 1. The last plateau at 0.48 volts indicates a saturation of the Na concentration, at least on the surfaces of the grains of the crystal. A ssum ing that this saturation level corresponds to $Na_{1=3}$ and knowing




FIG.2: Them agnetic susceptibility m easured using a SQ U ID m agnetom eter with an applied eld of 1 Tesla with H kab and H kc. Inset: The AC susceptibilities (in-phase $^{\circ}$ and out-of-phase $^{\circ}$) at low temperatures.

that the starting m aterial is N $a_{0:75}$, we have drawn arrows in Fig. 1 to indicate the expected N a content with the assumption that the N a extraction is proportional to the charging. The close m atch of these arrows with the plateaus suggests that stable intermediate phases exist for N $a_{2=3}$ and N $a_{1=2}$. We speculate that the special fractions of x ' $\frac{1}{3}$; $\frac{1}{2}$; and $\frac{2}{3}$ m ay be indicative of at least partial N a ordering relative to the hexagonal C o structure. The role of N a ordering on the physics of these materials is an important subject for future studies.

Magnetic susceptibility, speci cheat and resistivity have been measured on our superconducting single crystal samples. As shown in Fig. 2, the susceptibility shows a large anisotropy, similar to that reported for Na_{0:68}CoO₂.[2] However, the Curie-Weiss susceptibility that is so prominent there is now absent. The small cusp at 42 K is likely due to a Co₃O₄ impurity phase, which is known to have an antiferrom agnetic transition in the 33 to 46 K range.[16] By comparing the size the magnetization cusp with that for bulk Co3O4, we estimate that the Co₃O₄ impurity fraction of our sample is small, at the 1% level. However, we cannot detect the existence of Co₃O₄ within our x-ray di raction sensitivity. A part from this anomaly and the low temperature Curie tail (which arises from only 0.5% of the Comoments), the susceptibility is nearly temperature independent. Note the large magnitude and strong anisotropy. For comparison, the magnitude is about 5 times that of lanthanum strontium cuprate (La2 x Srx CuO4) and 30 times that of a sim ple m etal like Na. The anisotropy is probably due to a combination of anisotropy in the g factor and the van V leck term. AC susceptibility measurements were taken in a eld of 3 Gauss/100 Hz as shown in the inset of Fig. 2. The diam agnetic signal is indicative of a superconducting phase with an onset temperature of about 42 K, and the screening fraction is estimated to be about 120% (without geometric correction).




FIG. 3: The speci c heat measured on a single crystal plotted as c_p =T versus T in various applied magnetic elds. In the top panel of the inset, we plot c_p =T versus T² showing the suppression of the superconducting anomaly for H kc and H kab. In the bottom panel of the inset, we plot c_p =T for elds of 10 T and 14 T (a nuclear Schottky contribution has been subtracted).

The speci cheat of an array of co-aligned single crys-

tals (combined mass of 4.7 mg) was measured using a Physical Property Measurement System (Quantum Design) in applied magnetic elds ranging from 0 T to 14 T and temperatures ranging from 0.37 K to 10 K as shown in Fig. 3. The sample had been hydrated for three months after electrochemical de-intercalation, and x-ray direction indicates that 94% of the sample consists of the fully hydrated superconducting structure. In zero eld, a pronounced peak is observed at 4.2 K, indicating

eld, a pronounced peak is observed at 42 K, indicating the transition to bulk superconductivity. A second broad peak exists at lower tem perature around 1.5 K. In a eld of 1 T, the superconducting anomaly at 42 K is strongly suppressed; in contrast, the peak at 1.5 K is slightly enhanced. This suggests that the peak around 1.5 K is not related to a second superconducting phase with a lower $T_{\rm c}$. Such a peak may be compatible with a model of weakly interacting localized Common ents, analogous to the elects seen in impurity-doped semiconductors.[7] In

elds larger than $5\,\mathrm{T}$, both peaks disappear and are replaced by a broad enhancem ent of C=T over a wide range of tem peratures. With increasing eld, the enhancem ent of C=T shifts to higher tem peratures.

In the inset of Fig. 3, the top panel com pares the suppression of the superconducting anomaly for H k c and H k ab. In order to achieve a comparable suppression, an in-plane eld with magnitude 5 times that of the the out-of-plane eld is required. This re ects the anisotropy of H c2 in the di erent eld orientations and is consistent with our resistivity measurements of H $_{\rm c2}$ (discussed below). We note that $C=T_c$ in zero- eld for our single crystal sam ple is comparable to that reported by other groups in powder samples.[11, 12] The data plotted in the main part of Fig. 3 exhibit an upturn at the lowest m easured temperatures which increases with increasing eld. This is most likely due to a Schottky contribution from the nuclear spins. The bottom panel of the inset shows C=T data at high-elds in which a nuclear Schottky contribution (6.7 10 6 B 2=T 2) has been subtracted. These data demonstrate that in elds greater than 10 T superconductivity is completely suppressed. Hence, 10 T m ay be taken as an upper lim it for H c2 with H k ab.

On dierent single crystal sample which had a smaller hydrated phase fraction, we had observed an anomaly in the specic heat at T=6~K. This feature is also noticeable in the powder data of Jin et al.,[13]. We found that this anomaly was insensitive to magnetic elds as large as 14~T. The origin of this anomaly is not clear, and it may be related to another order parameter in the vicinity of the superconducting phase on the phase diagram.

From our speci c heat data, we extract a nom al state value of 16.6 m J/K 2 Co-m ole. This corresponds to a free electron density of states (DOS) including both spins of 7.09 states/eV . At rst sight, this seem s to compare well with the LDA band structure result[18] of 4.4 states/eV . However, this apparent agreement is misleading because the LDA band consists of 3 overlapping $\rm t_{2g}$

bands whereas the true quasiparticle is expected to form a single band out of the A $_{1q}$ orbital (sym m etric com bination oft2g), splito from the rest by correlation. A better way is to extract a bandwidth which we estimate to be 1.4 eV. Even though the LDA calculation was done for x = 0.5 and without hydration, the bandwidth should be insensitive to these di erences. On the other hand, we can t the observed DOS to that of the free electron tight binding band on a triangular lattice with hopping m atrix element t_{eff} . W ith t_{eff} < 0 and x = 0:35, the tight binding DOS for both spins is $0.16=\frac{1}{1}$ eff j.[7] The m easured DOS then implies that t_{eff} j 23 m eV, or a full bandwidth of 9 teff j 02 eV, which is a factor of 7 sm aller than the LDA bandwith. We therefore conclude that there is a mass enhancement of 7 compared with band theory.

By assuming g = 2, we nd that the measured $_{\rm c}$ of 3.5 $_{\rm c}$ 10 $^{\rm 4}$ cm $^{\rm 3}/{\rm C}$ o-m ole corresponds to a free electron DOS of 10.86 states/eV . This gives a W ilson ratio 4 $^{\rm 2}{\rm k}^2{=}3\left({\rm g}_{\rm B}\right)^2$ = of 1.53. In case a signi cant portion of comes from the van V leck term , the W ilson ratio will be even smaller. The combination of susceptibility and speci c heat measurements indicate that N a_{0.3}CoO_2 yH2O may be viewed as a Ferm i liquid with strong mass enhancement due to correlations. The occurrence of superconductivity in such a narrow band mate




FIG . 4: Resistivity in the abplane and along the caxis. Low temperature results for $_{\rm c}$ are shown in an expanded scale in the inset.

 $\mbox{{\sc rial}}$ suggests an electronic rather than phononic $\mbox{{\sc m}}$ echanism .

Four term inal resistivity measurements on a single crystal are shown in Fig. 4. The zero resistance state is achieved in $_{
m c}$ and $_{
m ab}$ at low temperatures below T_c ' 42 K (the inset shows an expanded view of $_c$ (T) near the transition). The large room -to low-tem perature resistance ratio (40) indicates that the sample is a good m etal with large anisotropy between c and ab (growing to 104 at low temperatures). The conductance per square at low T of each layer is 50 (e²=h), indicative of a long m ean free path. The current and voltage leads were attached with silver paste which was allowed to dry in atm osphere for 12 hours. Even though partial dehydration m ay have occurred during this process, it appears that superconductivity in the single crystal sample, with its smaller surface-to-volume ratio, is more robust than in the powder samples where superconductivity is found to degrade in a matter of minutes.[9] The large peak below 52 K reported by Jin et al.[13] is absent.




FIG. 5: (a) The in-plane resistance curves R $_{\rm ab}$ (H) m easured for tem peratures ranging from 2.0 K to 4.2 K .Field orientations with H $\,$ k c and H $\,$ k ab (inset) are m easured. (b) H $_{\rm c2}$ vs T for both $\,$ eld orientations.

In order to m ake an estim ate of H $_{\rm c2}$, we have m easured the in-plane resistance Rab versus Hat various temperatures as shown in Fig. 5 (a). There are two regim es (at low elds and high elds) where the resistance is roughly proportional to H . W e de ne H_{c2} as the eld at the crossing point of the extrapolation of these regim es. In Fig. 5 (b), we plot H c2 vs. T for both eld orientations. There is about a factor of 5 di erence in the slopes near Tc, consistent with the heat capacity data. The value of H c2 for H k ab is consistent with the Pauli param agnetic lim it for pair breaking. From the H c2 vs. T curve for H k c, we determ ine a coherence length of 100A. This relatively short coherence length is surprising for a superconductor w ith such a low T_c , but is entirely consistent w ith the narrow bandwidth. Assuming a parabolic band, the BCS formula for $_{\circ}$ can be expressed in term softhe DOS ($_{\rm F}$) in the following way: $_{\circ}=\frac{v_{\rm F}}{\circ}=\frac{\frac{\cdot \ 3k_{\rm F}\ a^2}{2\ ^2\ (_{\rm F}\)}$ ing $(_F) = 7.09 \text{ eV}^{-1}$ extracted from speci c heat and assum ing 2 $_{\circ}$ = 3:52 kT $_{c}$, we obtain $_{\circ}$ 27a

in reasonable agreem ent with the measured value.

In conclusion, by combining a novel electrochem ical method and oating-zone crystal growth we have succeeded in producing high quality single crystals of the hydrated N a_x C oO $_2$ yH2O system which show bulk superconductivity. Our measurements indicate that the low temperature properties are consistent with those of a Ferm i liquid with strong mass enhancement. The availability of high quality single crystals opens the door to many microscopic probes (such as x-ray and neutron scattering studies) which should help achieve an understanding of this strongly correlated material.
