# N anoscience with Attosecond Laser Pulses

#### A bstract

In this paper the interaction of attosecond laser pulses with m atter is investigated. The scattering and potentialm otion of heat carriers as well as the external force are considered. D epending on the ratio of the scatterings and potentialm otion the heat transport is described by the therm all forced K lein-G ordon or therm alm odd ed telegraph equation. For therm all eisenberg type relation V h ( is the relaxation time e and V is the potential) the heat transport is described by the therm al distortion less dam ped wave equation. In this paper K lein-G ordon, m odd ed telegraph<sup>1</sup> equation and wave equation are solved.

We propose the name H eaviside equation instead of the telegraph equation for the hyperbolic partial equation (therm alwave equation with both rst and second derivative).

#### 1 Introduction

W ith attosecond lasers (1 as = 10<sup>18</sup> s) physicist and engineers are now close to controlling the motion of electrons on a timescale that is substantially shorter than the oscillation period of visible light. It is also possible with attosecond laser pulse to rip an electron wave-packet from the core of an atom and set it free with similar temporal precision.

Since we know that there is an absolute velocity, velocity of light it is su cient to de ne the smallest time interval (e.g. 1 as) and the unit of length is a derivative quantity  $(3 \quad 10^{10} \text{ m} = 0.3 \text{ nm} = \text{Bohr radius})$ .

A fter the standards of time and space are de ned the laws of classical physics relating such parameters as distance, time, velocity, temperature are assumed to be independent of accuracy with which these parameters can be measured. It should be noted that this assumption does not enter explicitly into the formulation of the classical physics. This means that together with the assumption of the existence of the objective reality independent of any measurements (in classical physics) it was tacitly assumed that there is a possibility of unlimited increase of measurements accuracy. Bearing in mind the atom icity of time i.e. considering the smallest time period, P lanck time the above statement is obviously not true. With attosecond laser pulses we are at the limit of laser time resolution.

W ith attosecond laser pulses we enter new N ano W orld where size become comparable to atom ic dimension, where transport phenomena follows di erent laws than in macro world. This means the end of rst step miniaturization (from 10<sup>3</sup> m to 10<sup>6</sup> m) and the beginning new one (from 10<sup>6</sup> to 10<sup>9</sup>). N ano W orld is a quantum world with all predicable and nonpredicable (yet) features.

In this paper we develop and solve the quantum relativistic heat transport equation for N ano W orld transport phenom ena when external forces exist. This is the generalization of the results of paper [1] in which quantum relativistic hyperbolic equation was proposed and solved.

# 2 Relativistic hyperbolic heat transport equation

In paper [1] relativistic hyperbolic transport equation (RHT) was form ulated:

In equation (1) v is the velocity of heat waves, m<sub>0</sub> is the mass of heat carrier and { the Lorentz factor =  $(1 \quad \frac{v^2}{c^2})^{1=2}$ . As was shown in paper [1] the heat energy (heaton temperature) T<sub>h</sub> can be de ned as follow s:

Considering that v, them alwave velocity equals [1]

where is the coupling constant for the interactions which generate the therm alwave (= 1=137 and = 0.15 for electrom agnetic and strong force respectively) heaton temperature equals

From form ula (4) one concludes that heaton tem perature is the linear function of the m ass m<sub>0</sub> of the heat carrier. It is quite interesting to observe that the proportionality of  $T_h$  and heat carrier m ass m<sub>0</sub> was the st time observed in ultrahigh energy heavy ion reactions measured at CERN [2]. In paper [2] it was shown that temperature of pions, kaons and protons produced in Pb+Pb, S+S reactions are proportional to the mass of particles. Recently at Rutherford Appleton Laboratory (RAL) the VULCAN laser was used to produce the elementary particles: electrons and pions [3].

In the present paper the forced relativistic heat transport equation will be studied and solved. In paper [4] the dam ped therm alwave equation was developed:

The relativistic generalization of equation (5) is quite obvious:

It is worthwhile to note that in order to obtain nonrelativistic equation we put = 1.

If the nucleus contains Z protons than we have for electron tem perature in atom

Equation (7) also tell us the magnitude of the tem perature of the ionization of the atom :

The motion of electron in the atom is equivalent to the ow of an electric current in a loop of wire. W ith attosecond laser pulses we will be able to in uence the current in the atom ic w ire". This opens quite new perspective for the N ano W orld technology or nanotechnology. The new equation (6) is the natural candidate for the master equation which can be used in nanotechnology.

W hen external force is present F(x;t) the forced dam ped heat transport is obtained instead of equation (6) (in one dimensional case):

The hyperbolic relativistic quantum heat transport equation (RQHT), formula (8), describes the forced motion of heat carriers which undergo the scatterings  $\left(\frac{m_0}{h},\frac{QT}{Qt}\right)$  term ) and are in uenced by potential  $\left(\frac{2V\,m_0}{h^2}T\right)$  term ).

The solution of equation can be written as

where  $= h = (m v^2)$  is the relaxation time. A fler substituting formula (9) to the equation (8) we obtain new equation

W hen q > 0 equation (12) is the forced K lein-G ordon (K-G) equation. The solution of the forced K lein-G ordon equation for the initial conditions:

W hen q < 0 equation (12) is the forced m odi ed H eaviside (telegraph) equation with the solution: [4]

W hen q = 0 equation (12) is the forced therm all equation [4].

On the other hand one can say that equation (16) is the distortionless hyperbolic equation. The condition q = 0 can be rewrite as:

The equation (17) is the analogous to the H eisenberg uncertainty relations. Considering formula (2) equation (17) can be written as:

One can say that the distortionless waves can be generated only if  $T_{\rm h}$  > V. For  $T_{\rm h}$  < V, i.e. when the \Heisenberg rule" is broken, the shape of the therm alwaves is changed.

W e consider the initial and boundary value problem for the inhom ogenous therm alwave equation in sem i-in nite interval [4]: that is

where a 0; b 0; a + b > 0 (with a and b both equal to constants) and F; f; g and B are given functions. The solution of equation (19) is of the form [4]:

In the special case where f = g = F = 0 we obtain the following solution of the initial and boundary value problem (19, 20):

It can be concluded that the boundary condition (20) gives rise to a wave of the form K (t  $\frac{x}{v}$ ) that travels to the right with speed v. For this reason the foregoing problem is often referred to as a signaling problem for the therm al waves.

### 3 Looking into N ano W orld

W ith attosecond laser pulses we expect to be able to track the motion of an electron within a fem tosecond. We could also follow the relaxation of the remaining bound electrons to their new equilibrium states. Once we can generate attosecond pulses with much higher energies we will be able to use them as both pumps and probes in pump-probe spectroscopy on the atom ic level.

Up to now the pump-probe m ethod allows the investigation of the heat transport on the bulk scale. The experiments triggered by Brorson paper [6] disclosed the nite velocity of the heat transport i.e. the hyperbolicity of heat transport equation.

A coordingly with attosecond pump-probe method we will be able the study of heat transport in the N ano W orld. A swas shown in [1] one can de ne

the electron tem perature (heaton tem perature) in ground state hydrogen like atom :

# 4 Conclusion

In this paper dam ped forced therm alwave equation was proposed and solved. For C auchy boundary initial condition the solution of the equation was presented. It was shown that the new equation, depending on the relation between scattering and potential motion, is of the form of the forced therm al K kin-G ordon equation or the forced modi ed H eaviside (telegraph) equation. For the therm al H eisenberg type relation V h=8 the new equation is the distortion less forced wave equation. In the context of the forced wave equation the signaling solution was obtained.
