Therm odynam ic properties of a classical d-dim ensional spin-S H eisenberg ferrom agnet with long-range interactions via the spectral density m ethod

#### A bstract

The therm odynam ic properties of a classical d-dimensional spin-S Heisenberg ferrom agnet, with long-range interactions decaying as  $r^p$  and in the presence of an external magnetic eld, is investigated by means of the spectral density method in the fram ework of classical statistical mechanics. We not that long-range order exists at nite temperature for d with <math>d = 2 and for p > d with d > 2, consistently with known theorem s. Besides, the related critical temperature is determined and a study of the critical properties is performed.

#### 1 Introduction

The quantum two-time G reen function technique has provided a very powerful tool in condensed matter physics for exploring the equilibrium and transport properties of a wide variety of many-body system s.W ithin this fram ework, the equation of motion method (EMM) and the spectral density method (SDM) allow to obtain reliable approximations to treat typically unperturbative problem s [1,2,3]. The pioneering introduction of the two-time G reen functions and the EMM in classical statistical mechanics by Bogoliubov and Sadovnikov [4], has opened the concrete possibility to describe classical and quantum systems on the same footing. Nextly, a classical version of the SDM (CSDM) has been also formulated in extensive [5,6,7] and nonextensive [8] classical statistical m echanics and applied to classical magnetic chains [5,6,7,8]. The last method, which seems to present many advantages with respect to the most conventional EMM [3,5,6,7,8], o ers a robust instrument for systematic and well tested approximations [3] to explore the macroscopic properties of classical m any-body system s as well. Unfortunately, both the mentioned methods have not received the due consideration in the classical context and further developm ents and applications are desiderable. A long this direction, in this paper we apply the CSDM to investigate the therm odynam ic properties of a highly nontriviald-dim ensional classical spin-S Heisenberg ferrom agnet with long-range interactions decaying as r p (p > d) with the distance r between spins in the presence of an external magnetic eld. The choice of this model, besides its intrinsic theoretical interest, is motivated also by its relevance in the description ofm any materials [9,10,11] of experimental and technological importance and, in particular, in the understanding of the critical behavior of magnetic systems

when long-range exchange interactions are believed to play an important role. In general, realistic m icroscopic magnetic models with long-range interactions are discult to be studied in a reliable way. Since the exact solution for the spin-1=2 quantum Heisenberg chain with an inverse-square exchange (p = 2) and without an external eld was found independently by Haldane [12] and Shastry [13], only a limited lot of information has been acquired about the low-tem perature properties, the existence of long-range order (LRO) and the related critical behavior for discrete values of the decaying exponent p and the dimensionality d.

Recently, the critical properties at nite temperature of d-dimensional quantum Heisenberg models, with interactions of the type here considered (here often named "long-range spin models") have been studied using microscopic techniques [14,15,16,17] and M onte Carlo simulations [18]. A sum mary of the known features sounds as follows. The one- and two-dimensional long-range quantum spin-1=2 Heisenberg ferrom agnets in absence of an external magnetic eld were investigated by Nakano and Takahashi using the so called modi ed spin-wave theory [14] and the Schwinger-boson mean-eld approximation [15]. Further inform ation were derived for the d-dimensional case by means of the EMM for the two-time G reen functions using the Tyablikov decoupling procedure [16]. M onte Carlo simulations for the two-dimensional quantum spin-1=2 Heisenberg model have been also performed for 2 < p 6 [18]. This scenario, has been recently enriched by an extension [17] of the Merm in-Wagner theorem [19] for the existence of ferrom agnetic (FM) LRO at nite tem perature in quantum Heisenberg and XY models in d (= 1;2) dimensions with r p-and oscillatory-interactions.

C lassical long-range spin-s H eisenberg FM m odels have attracted great atten-

tion, too. It has been proved that LRO exist in d (= 1;2) dimension when d < p < 2d [20,21] and is destroyed at all nite temperatures for p [22,23,24]. Sim ilar results were obtained for the spherical model [25] and the present scenario of the critical properties is largely based on renormalization group calculations for the classical n-vectorm odel [26,27]. Classical long-range antiferrom agnetic (AFM) models have been studied less extensively. The available rigorous results [20,21,22] suggest orientational disorder at all nite tem peratures when p 2d, but no theorem exists entailing existence or absence of LRO for d < p < 2d. M onte Carlo simulations have been also perform ed for both d = 1; 2 dim ensional classical FM (for p = 2d [28]) and AFM (for p = 3=2 and p = 3 with d = 1 and d = 2 respectively [29]) Heisenberg long-range models. The results con m that FM -LRO survives at nite tem perature provided d and allow to conjecture that no AFM -LROexists at all nite temperatures for p > d. Spin-wave studies [29] agree with last conjecture but no de nitive statem ent can be drawn at the present stage. In a quite recent work [30] the therm odynam ics and the critical properties of the classical long-range spin-S Heisenberg FM chain in the presence of an external eld have been system atically studied using the CSDM to lowest order of approximation. The results are in good agreement with previous available analytical and num erical investigations. As mentioned before, here we use the sam e m ethod to explore a d-dim ensional H eisenberg FM m odel. As we shall see, a rich phase diagram appears where all the above mentioned scenario is reproduced and extended.

The paper is organized as follows. In Sec. 2 we introduce the model and the moment equations (ME's) for the spectral density (SD) to lowest order of approximation. The main low-temperature properties are studied in Sec. 3

and the existence of LRO in dierent regions of the (d p)-plane is also shown in a transparent way. Sec. 4 is devoted to the critical properties and the low-tem perature param agnetic susceptibility of the model. Finally, in Sec. 5, some concluding remarks are drawn.

### 2 The model and the moment equations for the spectral density

A classical d-dimensional spin-S Heisenberg ferrom agnet with long-range interactions is described by the Hamiltonian:

Here, N is the number of sites of the hypercubic lattice with unitary spacing,  $fS_{i}; i=1; ...; N \text{ g are the classical spins, h is the external magnetic eld and the spin-spin interaction, in view of the thermodynamic limit as N ! 1, is assumed to be <math>J_{ij}=J=r_{ij}^p$ , where  $r_{ij}$   $j_{ij}$   $r_{ij}$  and J>0 measures the strength of the coupling. The extreme case p! 1 corresponds to the standard nearest-neighbor interaction while the mean eld approximation is obtained when p=0 (replacing J by J=N). For this type of interaction, the thermodynamical limit N! 1 is well defined only for p>d, while for p>d the ground state of the system has an infinite energy per particle as N! 1 and the conventional statistical mechanics cannot be directly applied.

The classical spins m odel (1) can be appropriately described by the set of 2N canonical variables  $'_j; S_j^z$  where  $'_j$  is the angle between the projection of the spin vector  $S_j$  in the (x y)-plane and the x axis. For practical calculations we not convenient to introduce the new variables  $S_j = S_j^x$  is  $S_j^y$ , so that

involving the Fourier components of the spins and the exchange interaction de ned by:

where k denotes a wave vector in the d-dimensional Fourier space. The sum in Eq. (2) is restricted to the rst Brillouen zone (1BZ) of the lattice. The Poisson brackets for the spin Fourier components relevant for us, are:

In the context of the CSDM [5,6,7,8,30], all the therm odynam ical properties of the model can be derived using the SD de ned by:

where the classical dynam ical variables depend on time through the conjugate canonical coordinates  $'_j$  (t);  $S_j^z$  (t); j=1;:::N . Here A (t) =  $e^{iL\cdot t}A$  (0), L = ifH;:::g is the Liouville operator and h:::i denotes a canonical ensemble average. A coording to the spirit of the CSDM, we try to determ ine it to the lowest order in the form [7,30]:

where the unknown parameters  $_{k}$  and  $!_{k}$  are to be calculated solving the

To close this system, we should express all the unknown quantities in terms of the SD. One can show [7,30] that the transverse correlation function  $hS_k^+S_k^-i$ , appearing on the right{hand side of Eq. (8), can be exactly expressed in terms of the SD by the relation:

On the contrary, the longitudinal correlation function  ${}^D_{k} {}^E_{k} {}^C_{k}$  cannot be exactly related to the spectral density  ${}_k$  (!). So, to close the system of ME's (7), (8) we should solve anotherm on ent problem by introducing a new SD. The simplest way to avoid this diculty is to resort to the decoupling  ${}^D_{k} {}^E_{k} {}^C_{k} {}^$ 

of the  $_k$  (!). This is not a simple problem for a classical spin system, also when S = 1=2 (for which the exact relation  $S_j^z = 1=2$   $S_j^t S_j$  exists in the quantum counterpart). However, as shown in Refs. [7,30] within the spirit of the SDM, one can use the expression:

W ith the above ingredients, Eqs. (7)-(8) become a closed system to be solved self-consistently. By introducing conveniently the dimensionless variables = m = S,  $\overline{T} = T = JS^2$ ,  $\overline{h} = h = JS$  and  $\overline{T}_k = !_k = JS$ , the ME's reduce to:

In the therm odynam ic lim it N ! 1 one must replace the sum  $^P_k$  (:::)=N by an integral  $^R_{1BZ}$  (:::)  $d^dk = (2)^d$  in the d-dim ensional k-space and hence Eqs.(13)

The solution of the problem is complicated and one must consider asymptotic regim es for obtaining explicit results or use num erical calculations. M oreover, we can note that these equations have physical meaning only if  $\epsilon$  0 [30]. Hence, they cannot describe the critical behavior of the system or a param agnetic phase in zero external eld. As we will see, in Sec. 3 this problem can be simply overcome with an appropriate modi cation of Eq. (18).

### Low {tem perature properties

We rst exam ine analytically the low  $\{\text{tem perature solution of Eqs. (16)-(18)}.$ The expressions of  $\$  and  $\$ T<sub>k</sub> to the  $\$ rst order in the reduced temperature  $\overline{\mathrm{T}}$  , which allow us to capture some relevant aspects of the low-tem perature physics of the model (1), are given by:

At rst, we assum ehche 6 0 so that no convergency problem for the above integrals in the k-space occurs. To calculate analytically these integrals, one needs an explicit expression of the function  $^{(p)}(k)$  which, unfortunately, cannot be obtained in terms of elementary functions in the whole 1B Z, for arbitrary values of the parameter p > d. Nevertheless, for su ciently small values of the external magnetic eld, the dominant contribution to the integrals in Eqs. (19) and (20) arises from the low wave-vector excitations as close to the critical temperature (see Sec. 4). The explicit expressions of the coe cients  $A_d$ ,  $B_d$  and  $C_d$ , which depend in a cum bersom e way on the dimensionality d, the exponent p and a wave-vector cut-o related to the geometrical de nition of  $1B\ Z$ , are inessential at this stage and will be omitted. However, for case d=2, they will be explicitly given in Sec. 4 where a comparison with some analytical and Monte Carlo predictions is performed.

Taking into account Eq. (23), the integral  $I_d^{(p)}$  (h) can be explicitely estimated and we have the following low-temperature representation for the reduced

m agnetization

where  ${}_2F_1$  (a;b;c;z) is the hypergeom etric function,  $K_d=2^{1-d-d-2}=(d-2)$  and (z) is the gam m a function. An analogous calculation of  $I_d^{(p)}$  ( $\overline{h}$ ;k) in the expression (19) for  $\overline{T}_k$  is rather complicated. However, an explicit estimate of  $\overline{T}_k$  based on the expansions (23) is irrelevant for next developments. The low-temperature susceptibility—can be now easily obtained from Eq. (24) by derivation with respect to the reduced magnetic—eld  $\overline{h}$ . For the reduced susceptibility—= =  $\overline{t}$  we have:

The above low-T expressions have a physical meaning for  $\overline{T}$  and  $\overline{h}$  in the near saturation regime ( '1) and also for  $\overline{h}$ ! 0 when long {range order occurs. As mentioned before, the integrals in Eqs. (19) and (20), and hence the functions in Eqs. (24)-(25), could diverge in the limit  $\overline{h}$ ! 0 for particular values of the exponent and the dimensionality dof the lattice. When this is not the case, from Eq. (20) a spontaneous magnetization at a nite temperature should arise signaling the occurrence of LRO. Of course, the low-k behaviors (23) determine the constraints for convergency of the integrals involved in the low-

T expressions when  $\overline{h}$ ! 0. It is easy to see that, in the  $\lim_{\longrightarrow} \overline{h}$ ! 0, the integral (21) converges only for d with <math>d = 2 and for p > d with d > 2. Then, for these values of p and d, a spontaneous m agnetization  $m_0$  (T) = 0 (T) S exists and hence LRO occurs at m all but nite temperature, with the result:

where  $I_d^{(p)}(0)$  is a nite quantity whose estimate can be immediately obtained from Eq. (24). On the contrary, for 2d with d < 2, the integral (21) diverges as  $\overline{h}$ ! O and no nite solution for exists at  $\overline{I}$  6 O. This means that, for these values of and d, no LRO occurs at nite temperature. The global situation is schematically shown in Fig. 1. Here we also distinguished the domains where, as we will show in the next Sec. 4, the system exhibits a critical behavior like for a Heisenberg model with a nearest-neighbor exchange coupling (short-range interaction (SRI) regime) and the long-range nature of interactions (LRI) becomes excitive.

In conclusion, our explicit low-tem perature results suggest that a transition to a FM phase at nite tem perature occurs in the domains of the (p d)-plane where LRO exists. In the remaining domains a dierent scenario takes place with absence of a phase transition. These predictions are quite consistent with the recent extension [17] of the known Merm in-Wagner theorem [19] to quantum spin models with LRI's of the type here considered. Other thermodynamic properties can be also obtained within the framework of CSDM when the solutions of the ME's are known. Indeed, for our spin model, one can easily show that the internal energy u and free energy fiper spin are given

by [30]:

Here,  $H_I$  is the interaction part of the spin Ham iltonian,  $f_0$  is the free energy per spin for a magnetic model without interactions and hisi  $J_0$  denotes a canonical average as a function of the interaction strength  $J^0$ . As we see, within our approximations all the quantities in Eqs. (27) and (28) can be expressed in terms of the transverse SD  $J_0$  (!) and hence all the relevant thermodynamic quantities of our classical spin model can be evaluated. In particular, for the reduced internal energy  $\overline{u} = u = JS^2$  we have:

# 4 Near zero-magnetization regimes

As we mentioned before, the decoupling  ${}^{D}S_{k}^{z}S_{k}^{z}$   ${}^{E}N_{k}^{z}i$   $S_{k}^{z}$  is suitable for regin es with nonzero magnetization (60). Hence, the basic equations used in the previous section do not allow us to explore near-zero magnetization domains in the phase diagram as the critical region. To overcome this disculty, one is forced to and a more appropriate decoupling procedure for the longitudinal correlation function which allows us to obtain self-consistent ME's appropriate for describing regines when 100 and preserves also the simplicity of the one 100-function ansatz for the transverse SD 100

As we see, with Eq. (32) only the SD  $_k$  (!) is involved and, inserting in the ME (8), one nds for the reduced dispersion relation  $^{-1}_k$  the same formal expression (16) but with R (k) replaced by:

Notice that, the e ect of the decoupling (32) corresponds essentially to achieve in Eq. (18) the transform ation 1=(N) $^P_{k^0}$  (:::) ! (=N) $^P_{k^0}$  (:::) [7,30,31]. Now, the new ME's can be properly used for an estimate of the main critical

properties of our classical spin model when it exhibits LRO and of the low temperature paramagnetic susceptibility in the remaining domains of the (pd)-plane when no LRO exists.

# 4.1 Critical tem perature and critical behavior

The reduced critical temperature  $\overline{T}_c$  (with  $T_c = JS^2\overline{T}_c$ ) can be determined by imposing the condition  $(\overline{T}_c) = 0$  and hence by solving the self(consistent equation:

For an explicit estimate of  $\overline{T}_c$ , one can again calculate the integrals in Eqs. (34)-(37) assuming for <sup>(p)</sup> (k) the dominant contribution as k! 0 and solving our self-consistent equations by iteration. To rst level of iteration we nd




Fig. 1. Domains of the (p d)-plane when a ferrom agnetic long-range-order (LRO) exists and is absent (NO LRO). The dashed line p=d+2 separates the domains where long-range interaction (LRI)- and short-range interaction (SRI)-regimes occur. The dashed region (p < d) corresponds to a nonextensive therm odynamics.

Thus, a critical temperature exists when  $I_d^{(p)}(0)$  is nite and hence in the domains of the (p d)-plane where LRO takes place (see Fig. 1), as expected. Of course the estimate for the critical temperature can be systematically improved by calculating the integral  $I_d^{(1)}(0)$  using next k-powers in the expansions (23).

Here we consider explicitly the two-dimensional case for 2 also for a comparison with recent analytical and M onte Carlo results. In this case, the coe cients in the expansions (23) are given by [16]:




Fig. 2. The estim ated critical temperature  $T_c=J$  as a function of the decaying exponent p for a two-dimensional spin-1=2 Heisenberg ferrom agnet. The full line ( $T_c$  CSDM) represents the estimate here obtained. The dashed ( $T_c$  GF) and ( $T_c$  SW) lines refer to G reen function (GF) method [16] and modified spin-wave (SW) theory [14] results. The dots depict the quantum Monte Carlo ( $T_c$  QMC) predictions [18].

The critical tem perature as a function of p (2 ) for <math>d = 2 and S = 1=2 is plotted in Fig. 2 and compared with the corresponding results recently obtained for the quantum Heisenberg model by Nakano and Takahashi, using a modiled spin-wave (SW) theory [14] and the two-time Green function EMM within the Tyablikov decoupling [16], and by Vassiliev et al. with a Monte Carlo simulation [18]. Our result appears to be consistent with the ones obtained for the quantum counterpart in view of the known feature that a quantum spin model can be reasonably approximated by a classical one only

in the large-S lim it [32].

From Eqs. (34) { (37) it is easy to obtain also the behavior of  $\overline{(T)}$  as  $T \,! \, T_c^+$ . W ith m = S and T =  $JS^2\overline{T}$ , we get (for all values of p and d in the domains where a phase transition is allowed):

Finally, we calculate the critical exponent—for the speci—cheat in the domains of p and d where the transition to a FM—phase occurs. One can easily check that the critical exponents , , , and calculated above satisfy the well known scaling laws = (1), +2+=2 and +(1+)=2 for all values of p and d which allow a transition to the FM phase. Besides, they coincide with those obtained by Nakano and Takahashi [16] for the quantum counterpart, consistently with the universality hypothesis [32].

# 4.2 Low (tem perature param agnetic susceptibility for p 2d and d 2

The previous behaviors generalize those obtained in Ref. [30] for d=1. It is worth noting that for case p=2d one and a pure exponential divergence as T! 0 as for one-dimensional model [30]. This result, although consistent with that one obtained within the modilled spin-wave theory [14] and the EMM for the two-time G reen functions [16] for the quantum counterpart, does not reduce, for d=1, to the expression derived by Haldane [12] which contains

a factor proportional to  $\overline{T}^{1=2}$ . So, one must expect a d-dependent power law factor in  $\overline{T}$  in Eq. (60), which corrects the pure low-tem perature exponential divergence. The simple lowest-order approximation in the CSDM, here used, is not able to capture this important physical aspect. However, within the spirit of the SDM [3], one can hope to improve systematically this result working to higher order approximations.

## 5 Concluding remarks

In this work we have applied the SDM, within the fram ework of the classical statistical mechanics (CSDM), to study the therm odynam ic properties of a classical d-dimensional Heisenberg FM model with LRI's decaying as  $r^p$  (p>d) in the presence of an external magnetic eld. To lowest order in the CSDM, the most relevant magnetic quantities have been obtained analytically in the low-temperature regime under near saturation conditions as a functions of d and p. The FM LRO at nite temperature has been shown to occurs in a wide region of the (p d)-plane (see Fig. 1) where a transition to a FM phase takes place decreasing the temperature.

The therm odynam ic regim es with near zero and zero magnetization have been explored on the basis of a proper modication in the ME's of the transverse SD. So we have estimated the critical temperature and the main critical properties of the model, beyond the mean eld approximation, in the domains of the (p d)-plane where a FM ordered phase is expected. The critical exponents, here determined as a function of p and d, coincide with those ones for the corresponding quantum model. This constitutes a microscopic check of the irrelevance of quantum uctuations, consistent with the universality hypothesis

in the theory of critical phenomena. In contrast, as expected, our calculations show that the nonuniversal parameters, such as the critical temperature, depends on the classical or quantum nature of the model under study, especially for small values of the spin S as explicitly shown by a comparison of our critical temperature estimates with analytical studies and M onte C arlo simulations previously achieved for the quantum counterpart. Finally, we have determined the low-temperature behavior of the paramagnetic susceptibility for p 2d with d < 2 when no LRO occurs.

The rich scenario here obtained in a uni ed and consistent way for a non-trivial spin model, shows clearly the potentiality and the exctiveness of the SDM also in treating classicalm any-body systems. It is indeed relevant feature that, already to the lowest-order approximation, the CSDM is able to capture the essential physics of the model, consistent with Monte Carlo simulations [18,28,29] and exact results [20,21,22,23,24], and to obtain results beyond the Tyablikov-like approximation for arbitrary values of dimensionality dand the decaying exponent p > d. Besides, it overs the possibility to achieve system – atically higher-order approximations with the aim to improve the results here obtained and to study also the damping of the oscillations on the same footing [6].

In conclusion, due to the great experience acquired in the quantum many-body theory, we believe that the CSDM [5,6,7,8,30] and the formalism of the two-time G reen functions in classical statistical mechanics [4] constitute a promising tool to explore equilibrium and transport properties of a wide variety classical many-body (not only magnetic) systems. Further developments and applications along this directions are desiderable.
