Strong electron-Boson coupling e ect in the infrared spectra of T l_2 B a_2 C aC u_2 O $_{8+}$

We report on a study of the in-plane in frared response of a T \lg B a_2 C aC u_2 O $_{8+}$ $\,$ lm with $T_c=108$ K. The $\,$ ngerprint evidence for a strong electron-B oson coupling has been observed. The raw rejectance below $\,$ T $_c$ exhibits a knee structure at around 650 cm $^{-1}$ and the ratio of the rejectances below and above T $_c$ displays a pronounced minimum at around 1000 cm $^{-1}$. In particular, the features appear at higher energy scale than other bilayer cuprates with T $_c$ around 90-95 K. The gap amplitude and the Boson mode energy were extracted from the analysis of the bosonic spectral function. In comparison with several other optimally doped high-T c cuprates, we indicate the gap size scales with T $_c$, but Boson mode energy has a tendency to decrease.

Superconductivity requires the electrons being glued together in pairs. In conventional superconductors the pairing is due to the coupling between electrons and phonons. A lthough the Boson responsible for mediating the pairing or the "glue" in high tem perature superconducting cuprates (HTSC) remains elusive, evidence for strong electron-Boson coupling e ects began to accum ulate in various charge spectroscopies. In particular, m any of them are suggestive of a magnetic mode to glue the charge carriers together. For example, the photoem ission line shape near (,0) in many of the HTSC in the superconducting state is characterized by a sharp peak, followed at higher energy by a dip and broad hum p.1 As one moves towards the zone diagonal, a kink in the dispersion develops.^{2,3} The kink appears at the same energy scale as the dip. 2 These anomalies were widely believed to result from the interaction of electrons with a collective mode which appears below Tc. The inferred m ode energy and its tem perature dependence agree well with the magnetic resonance observed at (;) by neutron scattering.4,5,6 The coupling of the electrons with m agnetic mode has also been indicated in the tunneling spectra of B i_2 Sr₂C aC u₂O ₈₊ (B i_2 212), where a sharp dip was observed at a voltage beyond the gap edge 2.

Study of electron-phonon coupling e ects in infrared spectra of conventional superconductors began in early 1970's. Progresses have been made in recent years. Marsiglio et al. showed that the electron-phonon spectral function $^2{\rm F}$ () is closely related to the optical scattering rate

is very close to 2F () in the phonon region with

additional wiggles beyond the phonon cuto . However, no correlation between the structure in W (!) and phonon density of states has been established for high-T_c cuprates. Instead, signature of the spin resonance mode in neutron experiment is also indicated in the inplane infrared spectrum. Carbotte et al. analyzed optical conductivity (!) in magnetically mediated d-wave superconductors and argued that W (!) of equ.(2) still gives a good approximation to the charge-spin spectral density and that the spin resonance feature should show up in W (!) as a result of coupling of the electrons to this magnetic mode. In particular, the peak in W (!) below T_c is correlated to + , where is the energy of the spin resonance mode. 11 In another theoretical study of optical conductivity in superconductors with quasiparticles strongly coupled to their own collective spin modes, Abanov et al. 2 em phasized that a deep m in im um locating at 2 + s in W (!) is more relevant to superconductivity. They also identi ed two weaker high frequency singularities at 4 and 2 + 2 . More recently, Shulga¹³ pointed out that the minimum in the ratio of the raw re ectance $R_s(!)=R_n(!)$ is the key evidence for the Boson-mediated superconductivity. He showed that the minimum locates at frequency of 2 + , where the scattering rate displays a peak. Obviously, identifying these features in the infrared spectra represents the ngenerate evidence for the electron-Boson coupling in high-T_c cuprates.

In this paper, we report on a study of the in-plane infrared response of a T $1_2 \, \mathrm{Ba_2C} \, \mathrm{aC} \, \mathrm{u_2O} \, \mathrm{g_{+}}$ (T 12212) Im with $\mathrm{T_c} = 108 \, \mathrm{K}$. The above mentioned features in reectance spectra are clearly observed, providing unambiguous evidence for the strong electron-Boson coupling e ect in this bilayer cuprate with higher $\mathrm{T_c}$. In particular, the features appear at higher energy scale than other bilayer cuprates with T $_{\rm C}$ around 90-95 K . We compared the results on T 12212 with other high-T $_{\rm C}$ cuprates, and suggest that a magnetic resonance mode exists in this bilayer material.




FIG. 1: The X-ray di raction pattern for a T 12212 $\,$ lm . A 11 the sharp peaks can be assigned to the (001) peaks of T 12212 except those of LaA 10 $_3$ substrate.

Epitaxial Tl₂Ba₂CaCu₂O₈₊ lms were grown on LaA 103 substrates by dc magnetron sputtering and a post-annealing process. X-ray di raction m easurem ents con m that the lms were strongly textured with the c-axis parallel to the c-axis of the substrate, as shown in Fig. 1. Details of the lm growth were described elsewhere. 14 Optimally doped Ims with thickness of 4000 A were used for optical re ectance measurements. The re ectance m easurem ents from 50 to 25000 cm 1 for E k ab-plane were carried out on a Bruker 66v/S spectrom eter with the samples mounted on optically black cones in a cold-nger ow cryostatusing an in situ overcoating technique. 15 The optical conductivity spectra were derived from the K ram ers-K ronig transform ation.




FIG. 2: The resistivity vs. tem perature curve for the $\,$ lm with zero resistivity at 108 K $\,$




FIG. 3: ab-plane optical data from 50 to 2000 cm $^{\rm 1}$ of the optim ally doped T1-2212 w ith T $_{\rm c}=108$ K . (a) the tem perature-dependent re ectance and (b) the tem perature-dependent $_{\rm 1}$ (!). Inset: the far-infrared re ectance of the substrate LaA D $_{\rm 3}$ at room tem perature.

Figure 2 shows the temperature dependent resistivity of the T 12212 lm. The zero-resistance temperature T_{c0} is 108 K, which is much higher than other optimally doped bilayer cuprates with T co 90-95 K. The raw re ectances R (!) from 50 to 2000 cm ¹ and the calculated optical conductivities 1 (!) at di erent tem peratures are displayed in Fig. 3(a) and 3(b), respectively. It should be pointed out that the thickness of 4000 A of our Ims appears su cient to avoid signals from the substrate. For this purpose, we show, in the inset of Fig. 3 (b), the far-infrared re ectance spectrum measured on LaA 10 3 substrate at room temperature. The spectrum is dom inated by phonon peaks. However, no clear features at the energies corresponding to the phonon peaks could be detected in R (!) of the T 12212 lm.

In the normal state, the re ectance spectra show roughly linear frequency dependence. With decreasing temperature, the low-! R (!) increases, being consistent with the metallic behavior of the sample. At 10 K in the superconducting state, R (!) shows a knee structure at around 650 cm $^{-1}$. Above this frequency, the rectance drops fast and becomes lower than the normal-state values at around 1000 cm $^{-1}$. R (!) recovers the linear-frequency dependence at higher frequencies. Similar but weak behaviors were seen at 95 K, which is close to $T_{\rm c}$. The change of the R (!) in the superconducting state with respect to the normal state could be seen




FIG. 4: (a) The re ectance ratio below and above T $_{\text{C}}$ as a function of frequency. (b) The frequency-dependent scattering rate 1/ (!) spectra at 10 K and 120 K.

m ore clearly from the plot of the ratio of the re ectance below T c over that above T c. Fig. 4 (a) shows the ratio of R $_{10K}$ (!)/R $_{120K}$ (!) as a function of frequency. It becomes evident that a maximum at around 650 cm 1 and a minimum at around 1000 cm 1 exist in the plot. The scattering rate 1/ (!) spectra at 10 K and 120 K, extracted from equ. (1) with the use of plasm a frequency of 1.6 $^{10^3}$ cm 1 determined by summarizing the optical conductivity up to 1 eV, are displayed in Fig. 4 (b). We can see that, at frequencies corresponding to the maximum and minimum in the R $_{10K}$ (!)/R $_{120K}$ (!) plot, the 1/ (!) at 10 K exhibits a rapid rise and a peak or a substantial overshoot of the normal state result, respectively.

Obviously, the features caused by strong electron-Boson coupling as discussed by Shulga¹³ were observed in infrared spectra of the optimally doped $T \lg B a_2 C a C u_2 O_{8+}$ with $T_{c0} = 108$ K. The present work is very suggestive that a simple deviation or suppression from the linear-frequency dependence in 1/ (!), i.e. the so-called "pseudogap" feature in ab-plane optical response, may not be a direct indication for the Boson mode being coupled to the electronic spectra. The dip in the re ectance ratio $R_s = R_n$ or the "overshoot" in 1/ (!) is more essential. We note that the overshoot feature was observed previously on optimally doped YBa $_2$ Cu $_3$ O $_7$ (YBCO) by Basov et al. 16 and $H gB a_2 C a_2 C u_3 O_{8+}$ (H g1223) by M cG uire et al.¹⁷. The features in Bi2212 are weak, but a recent study by Tu et al. 18 made it clear that those features exist. However, the "overshoot" behavior is absent in $La_{2 \times Sr_{x}}CuO_{4+}$ (LSCO), although the suppression of low -! scattering rate is still observed. 19

A nother rem arkable observation here is that the "overshoot" feature in 1/ (!) appears at higher energy than the corresponding features in YBCO and Bi2212, which are in the range of about 800 – 900 cm $^{\rm 1}$. $^{\rm 16,18}$ W e note that the feature in Hg1223 with T $_{\rm c}{\rm = 130}$ K locates at even higher frequency beyond 1100 cm $^{\rm 1}$. $^{\rm 17}$ Therefore, there is a tendency that the energy of the feature scales with the superconducting transition temperature.

There are two di erent opinions about the origins of the Bosons seen in charge spectroscopies. One is phonon origin³ and the other the magnetic mode origin. We found that the phonon scenario is inconsistent with the present experiment, for the feature is seen only in the superconducting state, whereas phonons exist also in the




FIG. 5: (a) The experim ental data of != (!) at 10 K together with a 20-term polynom ial t. (b) The bosonic spectral function W (!) vs. frequency derived from the polynom ial t curve.

norm al state. Recent study on the oxygen isotope effect in the ab-plane optical properties of YBCO also ruled out the phonons as the main player. 20 By contrast, T 12212 shares the same coupling behavior as the YBCO and Bi2212, where suggestions for the magnetic origin were proposed from the inversion of the ab-plane optical conductivity. 10,18,21 Note that, neutron experiments revealed a main di erence for the resonances in optimally doped YBCO and Bi2212: the resonance peak in the later material exhibits a considerable broadening in both energy and wave vector, which was interpreted to be caused by the intrinsic inhomogeneities in Bi2212.22 Therefore, We can ascribe the weak "dip" or "overshoot" features in Bi2212 to the broadening of the resonance peak. The absence of those features in LSCO m ight be related to the absence of the magnetic resonance. Since the "overshoot" feature in T 12212 is prominent, like the case in YBCO, we suggest that a sharp magnetic resonance mode exists in this material.

The above discussion on the dip or "overshoot" behavior appears at frequency of 2 + , which contains the superconducing gap and a Boson mode. It would be much desired to separate the two dierent energy scales. This might be achieved from the analysis of the bosonic spectral function W (!) de ned in equ.(2). Since W (!) is obtained by taking the second derivative of the function != (!), a smoothing of the experimental data is required. Tuetal. suggested an unambiguous method to extract W (!) by thing the experimental measured quantity!= (!) with high-order polynomial. This method has been used in present analysis. In Fig. 5 (a), the != (!) at 10 K is shown together with a 20-term polynomial t. The resulting spectral function W (!) vs. fre-




FIG. 6: Plots of , and the energy of overshoot (2 +) versus T $_{\rm C}$ for several optim ally doped cuprates. The data for B i2212 18 and YBCO 10 are from inversion of optical spectra. The values for B i2201 and B i2223 are from photoem ission study (peak position gap). 23 H g1223 data is from 17 . The value for T l2201 is from neutron experim ent. 24 The straight lines are for eye guidance. We start to put straight lines for (2 +) and , the third one for is then extracted.

quency is displayed in Fig.5 (b). We can see a large maximum at about 650 cm 1 , a deep negative minimum at 1000 cm 1 , and a weak maximum at around 1300 cm 1 . A coording to C arbotte et al., 10 the large maximum corresponds to + . In terms of A banov et al. 12, the other two features correspond to 2 + and 2 + 2, respectively. We nd obviously that the extracted gap is larger than the values for Bi2212 (35 meV) and YBCO (28 meV), but the Boson mode energy is sm aller than the corresponding values of 43 m eV for B i2212 and 41 m eV for YBCO. 10,18 Since the Tc of T12212 is very close to that of Bi2223, it would be interesting to compare the result with Bi2223. The gap amplitudes for n=1,2,3 compounds in Bi-based family have been studied in photoem ission experim ents by Feng et al. 23 They found that the leading-edge-midpoint (peak position) gap values are 10 (21), 24 (40), 30 (45) meV for n=1, 2, 3 systems, respectively. It is seen that the gap values for Bi2212 and T 12212 extracted from in-plane optical data are more closer (but a bit sm aller) to their peak position gap values for n= 2 and 3 systems. In Fig.6, we plot , the energy of "overshoot" (2 +) versus T $_{\rm c}$ for several optim ally doped cuprates where those data are available. We not that the gap increases with T_c , but the Boson m ode energy has the tendency to decrease with $T_{\rm c}$. In the gure, the data of YBCO appear to deviate substantially from the scaling behavior. The reason is not clear.

O ne possibility is that the existence of the Cu-O chains, which also become superconducting below T $_{\rm c}$, helps to enhance T $_{\rm c}$, even though its gap value is smaller than B i2212 and T l2201.

Earlier studies have established that the $T_{\rm c}$ in optimally doped cuprates is proportional to the condensed carrier density $n_{\rm s}$. The present study shows that $T_{\rm c}$ is also correlated with the energy scale of the superconducting gap . Within current understanding, both the $n_{\rm s}$ and are important quantities characterizing superconducting state. rejects the pairing strength, while $n_{\rm s}$ is an indication of the phase stiness of the pairing 23,25 To achieve maximum $T_{\rm c}$, both the superconducting gap and the condensate should be maximized.

Finally, we brie y comment on the two sizeable features at 600 cm ¹ and 230 cm ¹, which are present in all m easured tem peratures. Since the frequencies are away from the phonon modes of the substrate, 26 they are not likely to come from the substrate due to the possible leakage of the lm in the long wave length region. The highfrequency mode was seen in other high-Tc cuprates, e.g. $Bi2212^{18}$ and $YBCO^{16,20}$, and was assigned to the transverse optic phonon (Cu-O stretching mode). The 230 cm ¹ m ode was also reported in earlier re ectance study on YBCO, where it was suggested to be of electronic origin for the spectral weight of the mode was found to be an order of magnitude larger than what is expected for a phonon. 27. Com paring the present data with those studies, we found that the high-frequency mode appears as an antiresonance rather than a peak in the conductivity spectra, and the strength of the 230 cm 1 m ode is not weakened very much at high temperature, which is in contrast to the reported behavior in YBCO. Further studies are required to illustrate the di erence.

In sum mary, we have presented a set of high-quality inplane optical data for T l_2 B a_2 C aC u_2 O $_{8+}$ (T l2212) with $T_{\rm c}$ = 108 K . The $\,$ ngerprint evidence for strong electron–B oson coupling e ect has been observed in re ectance spectra for this bilayer cuprate with higher T $_{\rm c}$. In particular, the energy scale of the feature appears at higher energy than other bilayer cuprates with T $_{\rm c}$ around 90–95 K . The gap amplitude and the B oson mode energy were extracted from the analysis of the bosonic spectral function. It is found that the gap size scales with T $_{\rm c}$ for dierent cuprates. We discussed the origin of the B oson and compared the results on T l2212 with other high-T $_{\rm c}$ cuprates.
