Num erical Renormalization Group for Bosonic Systems and Application to the Subohmic Spin-Boson Model

We describe the generalization of Wilson's Numerical Renormalization Group method to quantum impurity models with a bosonic bath, providing a general non-perturbative approach to bosonic impurity models which can access exponentially smallenergies and temperatures. As an application, we consider the spin-boson model, describing a two-level system coupled to a bosonic bath with power-law spectral density, J(!) / ! $^{\rm s}$. We not clear evidence for a line of continuous quantum phase transitions for subohmic bath exponents 0 < s < 1; the line term inates in the well-known K osterlitz-Thouless transition at s = 1. Contact is made with results from perturbative renormalization group, and various other applications are outlined.

The Numerical Renormalization Group method (NRG) developed by Wilson [1] is a powerful tool for the investigation of the Kondo model and its generalizations [1, 2, 3, 4]. In these models, a (possibly complex) impurity, such as a localized spin, couples to a fermionic bath. In the case of a spin- $\frac{1}{2}$ impurity coupled antiferrom agnetically to a metallic bath, the impurity spin is screened below a characteristic scale $T_{\rm K}$, the Kondo temperature [3]. The strength of the NRG lies in its nonperturbative nature and the ability to resolve arbitrarily small energies [1]. A variety of thermodynamic and dynamic quantities can be calculated for a large number of impurity models in the whole parameter space [4, 5].

There is, however, a very important class of models for which the NRG method has not yet been developed: models with a coupling of the impurity to a bosonic bath [6]. The intensively studied spin-boson model [7, 8] belongs to this class; its Hamiltonian is given by

$$i(a_i + a_i^y) : (1)$$

Here the Pauli-matrices $_{\rm j}$ describe a spin, i.e., a generic two-level system, which is linearly coupled to a bath of harm onic oscillators, with creation (annihilation) operators $a_{\rm i}^{\rm y}$ ($a_{\rm i}$). The bare tunneling amplitude between the two spin states j"i and j#i is given by , and is an additional bias. The ! $_{\rm i}$ are the oscillator frequencies and $_{\rm i}$ the coupling strengths between the oscillators and the local spin. The coupling between spin and bosonic bath is completely speci ed by the bath spectral function

Of particular interest are power-law spectra

$$J(!) = 2 !_{c}^{1 s} !_{s}^{s}; 0 < ! < !_{c}; s > 1 (3)$$

where the dimensionless parameter characterizes the dissipation strength, and $!_c$ is a cuto energy. The value s=1 corresponds to the case of ohm ic dissipation.

The spin-boson model is a generic model describing quantum dissipation; it has been discussed in the context of a great variety of physical problems [7, 8] ranging from the e ect of friction on the electron transfer in biom olecules [9] to the description of the quantum entanglement between a qubit and its environment [10, 11, 12].

Considering the wealth of applications, the question arises whether W ilson's NRG method can be exploited for this class ofm odels; and it is the purpose of this paper to show that this is indeed the case. What we have in mind here is the direct mapping of models like (1) to a sem i-in nite chain form typical for the NRG [1]. As described below, bosonic operators constitute the sites of the chain, and the Ham iltonian is solved by iterative numerical diagonalization [13]. This approach is dierent from previous NRG calculations in Refs. 10, 14, where the mapping of the spin-boson model (1) to the anisotropic ferm ionic Kondo model was employed { such a mapping is restricted to the ohm ic case J(!)?

Bosonic NRG. Let us now describe the generalization of the NRG method to a bosonic bath with a continuous spectrum. The strategy is similar to the one used for the Kondo or single-impurity Anderson model [1, 2]. There are, however, important dierences which we outline here; a more detailed discussion will appear elsewhere. Here we present explicit equations for the spin-boson model (1); the generalization to other impurity models or multiple bosonic baths is straightforward.

W e start from the following form of the model (1):

$$H = H_{loc} + d^{"}g(")a_{"}^{y}a_{"} + \frac{z}{2} d^{"}h(")(a_{"} + a_{"}^{y})$$

with H $_{\rm loc}$ = $_{\rm x}$ =2 + $_{\rm z}$ =2. In this model, g(") characterizes the dispersion of a bosonic bath in a one-dimensional representation, with upper cuto 1 for ". The coupling between the spin and the bosonic bath is given by h ("). These two energy-dependent functions are

related to the spectral function J (!) via

$$\frac{1}{2} J(x) = \frac{d''(x)}{dx} h^2 [''(x)] \quad (x \ 2 \ [0;!_c]) ; \tag{5}$$

where "(x) is the inverse function of g(x), g["(x)] = x. As discussed in Ref. 15 for the Anderson model, Eq. (5) does not uniquely determine g(x) and h(x), and a special choice for h(x) is used to simplify the calculations.

The NRG procedure starts by dividing the energy interval [0;1] into intervals [$^{(n+1)}$; n] (n = 0;1;2;:::). An orthonorm alset of functions $_{np}$ (") / $e^{i!_{\,n}p}$ " is introduced for each interval so that the operators a_n can be represented in this basis. Choosing h (") as constant in each interval [15] and dropping the (p \in 0)—com ponents as in [1, 2], the H am iltonian of the spin-boson m odel then takes the following form:

$$H = H_{loc} + \prod_{n = 0}^{x^{l}} a_{n} + \frac{z^{l}}{2^{l}} \prod_{n = 0}^{x^{l}} a_{n} + a_{n}^{y};$$

The transform ation to a sem i-in nite chain form yields

with $_0={}^R$ dx J(x). The spin now couples to the rst site of the bosonic chain only, and the remaining part of the chain is characterized by on-site energies $_n$ and hopping parameters t_n . The parameters $_0$, $_n$ and t_n can be calculated numerically from a given spectral function J(!) [15]. Note that here the spectrum is restricted to positive frequencies; this results in hopping matrix elements falling o as t_n / n (which allows to work with

= 2 keeping a relatively small number of states), in contrast to the ferm ionic case where the discretization is performed for both negative and positive energies, in this case t_n / $^{n=2}$. The on-site energies also fall o as $_n$ / n so that a xed but s-dependent ratio $t_n = _n$ emerges for large n, where s is the bath exponent in (3).

The Ham iltonian (7) is solved by iterative numerical diagonalization [1, 2]. At each step, one bosonic site of the chain is added. The in nite bosonic Hilbert space has to be cut o, by restricting the basis of each new bosonic site to a nite number of states N $_{\rm b}$. A fter diagonalizing the enhanced cluster, the N $_{\rm s}$ lowest lying many-particle states are kept, and the procedure is repeated [16]. The calculation of static and dynamic observables can be done in analogy to the fermionic NRG . In general, and as known from the fermionic case, the accuracy of the cuto procedure has to be tested for each application, and we will show results below .




FIG. 1: a) Phase diagram for the transition between delocalized (< $_{\rm C}$) and localized phases (> $_{\rm C}$) of the spin-boson model (1) for bias = 0 and various values of , deduced from the NRG ow . b) -dependence of the critical coupling $_{\rm C}$ for various values of the bath exponent s. The dashed lines are guides to the eye, the solid lines are ts to Eq. (10) using the < 10 7 points only. For s close to 1 the asym ptotic regim e is only reached for very small . NRG parameters here and in Figs. 3{5 are = 2, N $_{\rm B}$ = 8, and N $_{\rm S}$ = 100.

Application to the spin-boson model. To investigate the feasibility of the bosonic NRG, we perform ed extensive calculations for the spin-boson model with bath exponents 0 < s 1, bias = 0, and $\frac{1}{c} = 1$. In the ohm ic case s = 1, it is known that a Kosterlitz-Thouless quantum transition separates a localized phase at $\frac{1}{c}$ from a delocalized phase at $\frac{1}{c}$ [7, 8]. In the localized regime, the tunnel splitting between the two levels renormalizes to zero, whereas it is nite in the delocalized phase. For

The subohm ic case [11,17] is less clear. For =! $_{\rm C}$! 0 the system is localized for any non-zero coupling, however, the behavior at nite was not discussed in Refs. 7, 8. For large a delocalized phase was argued to exist [17, 18], and Ref. 17 proposed a rst-order transition scenario. In the following, we shall resolve this issue and show that a continuous transition with associated critical behavior occurs for all 0 < s < 1.

N otably, the spin-boson model can be mapped onto a one-dimensional Ising model with long-range couplings falling o as r $^{\rm s}$; the localized phase of the spin-boson model then corresponds to the ordered phase of the Ising magnet [7]. As shown by Dyson [19], this Ising model features a transition for 0 < s 1, but the results for s < 1 have not been system atically carried over to the spin-boson model so far.

Our NRG calculations provide clear evidence for a phase transition in the spin-boson model for all 0 < s 1, which is continuous for 0 < s < 1 and of K osterlitz—Thouless type for s = 1. The numerical results are summarized in Fig. 1a, which shows the phase boundaries determined from the NRG ow for xed NRG parameters = 2, N $_{\rm b}$ = 8, and N $_{\rm s}$ = 100 [16]. (No transition occurs for s > 1: the system is always delocalized.) As




FIG. 2: dependence of the critical coupling $_{\rm C}$ at s = 0.9, = 10 $^{\rm 3}$, for various NRG parameters N $_{\rm S}$ and N $_{\rm b}$ [16]. The dashed line is a linear t to the N $_{\rm S}$ = 120, N $_{\rm b}$ = 8 data in the range 2 3.

displayed in Fig. 1b, the critical coupling $_{\rm c}$ closely follows a power law as function of the bare tunnel splitting, $_{\rm c}$ / $^{\rm x}$ for small , with an s-dependent exponent x. Our data are consistent with x = 1 s, see below.

In the ohm ic case, s = 1, the critical c approaches a nite value as ! 0. For the quoted NRG param eters we nd c 1:18, being slightly larger than the established value $_{C}$ (s = 1; ! 0) = 1. This deviation is solely due to the NRG discretization; calculations with di erent show that in the $\lim it$! 1 we recover c = 1. The general behavior is illustrated in Fig. 2, which shows c for xed and s = 0:9. Keeping xed, we observe a rapid convergence of c with increasing N b and N s. As expected from the iterative diagonalization scheme, the values of N $_{\rm b}$ and N $_{\rm s}$ necessary for convergence increase [16]. The converged data for $_{c}$ () with decreasing show a linear dependence in the range 1:8 < < 3, with a deviation of about 15% at = 2 from the extrapolated! 1 value. The same holds for the ohm ic case (data not shown) and the extrapolation results in $_{c}$ (s = 1; = 10 4 ; ! 1) = 0.99 0.02; our data are consistent with the RG result $_{c} = 1 + 0 (=!_{c})$ [7].




FIG.3: SampleNRG ow diagram s for the subohm ic (upper panel, s=0.6) and the ohm ic case (lower panel, s=1), close to the phase transition (except for the lower right panel).

The NRG ow of the many-particle levels of the Ham iltonian, displayed in Fig. 3, can be used to analyze the low-tem perature behavior. For all values of 0 < s < 1, we can identify two stable xed points, corresponding to the localized and delocalized phases of the in purity spin, and a third NRG xed point, which is infrared unstable and corresponds to a critical xed point. In contrast, for s=1 we nd (in addition to the delocalized xed point) a line of xed points for c, and no critical xed point, as expected for a K osterlitz-T houless transition.




FIG. 4: Crossover scale T in the vicinity of the phase transition for < $_{\rm c}$, de ned here through the rst excited NRG level $^{\rm n}$ E $_{\rm n1}$ (T)= 03. a) Subohm ic case s = 0.8, with power law ts. b) 0 hm ic case s = 1, with exponential ts.

The energy scale T , describing the crossover from the critical to a stable $\,$ xed point, is shown in Fig. 4. For 0 < s < 1, T $\,$ is found to vary in a power-law fashion with the distance from criticality, T $\,$ / j $\,$ $_{\rm c}$ j $^{\rm z}$, where we have introduced the correlation length and dynamical exponents $\,$ and z { note that 1=(z) is nothing but the scaling dimension of the leading relevant operator at the critical $\,$ xed point. Fig. 4a nicely shows that $\,$ z




FIG. 5: a) NRG results for the critical exponent z, characterizing the vanishing of the crossover energy T near the critical point, as function of the bath exponent \underline{s} . Inset: data near s=1 together with the function $1=\frac{1}{2}(1-\underline{s})+0.5$, Eq. (9). b) Spin autocorrelation function C (!) for s=0.6, $=10^{-2}$, and =0.19. $_{C}$ close to the transition.

In Fig. 5a we show the s-dependence of the exponent z. We nd a divergence for both s! 0 and s! 1, consistent with a K osterlitz-T houless transition at s=1, and the system being always localized at s=0. The s! 1 divergence is in good agreement with the perturbative result (9), see below.

The NRG algorithm can be used to compute a variety of static and dynam ic observables. As an example, we show C (!), being the Fourier transform of the symmetrized autocorrelation function C (t) = $\frac{1}{2} h[\ _{\rm Z}$ (t); $_{\rm Z}$], in Fig. 5b for s = 0.6 and parameters in the delocalized phase close to the transition. We observe a crossover from C (!) / !s at small frequencies, characteristic of the delocalized phase [17, 20], to a quantum critical behavior with a power-law divergence at higher frequencies { this gives rise to a characteristic peak at ! T.

Comparison to perturbative results. The partition function of the spin-boson model can be approximately represented as that of a one-dimensional Ising model with couplings falling of as r $^{\rm s}$ 1; in this picture, defects in the Ising system correspond to spin ips of the original spin along the imaginary time axis. A RG analysis of this Ising model has been performed by Kosterlitz [21]. Carrying over these results to the spin-boson model, we arrive at the RG equations (see also Ref. 11):

$$() = (^2 + s 1);$$

 $() = (1);$ (8)

valid for small , where = =! $_{\rm C}$ is the dimensionless tunneling strength. The RG ow is sketched in Fig. 1 of Ref. 21. For s = 1, these equations are equivalent to the ones known from the anisotropic K ondo model, and describe a K osterlitz-T houless transition, with a xed line = 0, 1. For s < 1 there is an unstable xed point at = 1, 2 = 1 s; clearly it is perturbatively accessible for small values of (1 s) only. The critical xed point is characterized by

$$z = 1 = \frac{p}{2(1 - s) + 0}$$
 (9)

For small , , Eq. (8) yields for the phase boundary

$$_{\rm C}$$
 / $^{\rm 1 \, s}$ for ! $_{\rm C}$ (10)

valid for all 0 < s < 1. The results (9) and (10) are in good agreem ent with our num erical data in Figs. 5a and 1b, respectively.

Conclusions. We have presented a generalization of W ilson's NRG to quantum impurity problems with bosonic baths. Applying this novel technique to the subohm ic spin-boson model, we have found a line of continuous boundary quantum phase transitions for all 0 < s < 1, with exponents varying as function of s. This

line term inates in a K osterlitz-T houless transition point at s=1. Near s=1, our num erical results are in agreement with perturbative calculations. The existence of a transition for s<1 in plies that weakly damped coherent dynamics is possible for qubits coupled to a subohmic bath, provided that the initial splitting is large.

In close analogy to the ferm ionic NRG, ourm ethod can be easily applied to the calculation of dynam ical quantities. Furtherm ore, generalizations to impurities with multiple bosonic baths or both ferm ionic and bosonic baths are possible. This will allow the study of large classes of impurity models, e.g., so-called Bose-Kondo and Bose-Ferm i-Kondo models.
