# Bosonizing one-dimensional cold atom ic gases

We present results for the long-distance asymptotics of correlation functions of mesoscopic onedimensional systems with periodic and open (D inichlet) boundary conditions, as well as at nite temperature in the thermodynamic limit. The results are obtained using Haklane's harmonicuid approach (also known as \bosonization"), and are valid for both bosons and fermions, in weakly and strongly interacting regimes. The harmonic- uid approach and the method to compute the correlation functions using conform al transformations are explained in great detail. As an application relevant to one-dimensional system sofcold atom ic gases, we consider them odelofbosons interacting with a zero-range potential. The Luttinger-liquid parameters are obtained from the exact solution by solving the Bethe-ansatz equations in nite-size systems. The range of applicability of the approach is discussed, and the prefactor of the one-body density matrix of bosons is xed by nding an appropriate parametrization of the weak-coupling result. The form ula thus obtained is shown to be accurate, when compared with recent di usion M onte C arbo calculations, within less than 10%. The experimental implications of these results for B ragg scattering experiments at low and high m omenta are also discussed.

### I. IN TRODUCTION

A num ber of recent experiments [1, 2, 3, 4, 5] have demonstrated the possibility of conning atoms to one dimension. This possibility has produced an outburst of theoretical activity over the last years [6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 24] in the eld of cold atoms. One important focus of these studies has been on the correlation properties of these new one-dimensional systems, with the goal of providing means to characterize them experimentally.

A lthough one-dimensional models have been the favorite toy of mathematical physicists during the last century, they only became experimentally relevant in the late 1960's and 1970's in connection with a number of solid-state materials exhibiting very anisotropic magnetic and electronic properties. Later, in the 1980's and 1990's, advances in chemical synthesis and nanotechnology made it possible to manufacture materials and devices where electrons are mainly connect to move along one or a few conduction channels. The latest experimental developments in the eld of cold atoms, however, have several distinct features. First of all, the constituent particles are not electrons

but bosonic atom s (although in the fiture ferm ionic atom s can also becom e available). Second, the \fundam ental" interaction is no longer of C oulom bic type but a short range potential. Furtherm ore, in the case of dilute atom ic vapors con ned in magnetic and/or optical traps, the degree of controllability over parameters such density and interaction strength seems unprecedented. This allows, in principle, to exhaustively explore phase diagram s, or to cleanly realize quantum -phase transitions, which so far are considered as theorists' extrem e idealizations of \dirty" solid-state phenom ena.

The only a priori limitation o ered by the atom ic system s, at least from the point of view of a condensed matter theorist, seems to be their mesoscopic, rather than macroscopic, size. However, numerical calculations over the past decades (e.g. [34, 40]) have taught us that many of the behaviors predicted for the therm odynamic limit, already manifest them selves at the mesoscopic scale, even when the system under study consists of just a few tens of particles. Furtherm ore, the study of mesoscopic system s is also a brach of modern condensed-matter physics as phenomena taking place at the mesoscopic scale have an undeniable interest. Thus the main of motivation of this paper is to present a set of tools that can be used to analyze the properties of these mesoscopic one-dimensional (1D) systems. O urmain theoretical tool in this analysis is the harm onic-uid approach, which is nothing but the relevant quantum hydrodynamics for 1D systems.

The harm onic- uid approach has a long history [26, 27, 28, 29], which in some respects culm inated with the work of H akane [30, 31]. He realized that m any one-dimensional models exhibiting gapless excitations with a linear spectrum can be described within the same framework. This framework de ned a universality class of system s that H akane term ed \Luttinger liquids". The name stems from an analogy with higher dimensional ferm ionic system s, where the equivalent role is played by the (universality class of) Ferm i liquids. In the context of one-dimensional Ferm i system s this approach has a second, more frequently used, name: \bosonization". This refers to the fact that the method shows how to describe the low-energy degrees of freedom of the ferm ions in terms of a bosonic eld which obeys a relativistic wave equation. However, di erently from the Ferm i liquids, the class of Luttinger liquids also includes one-dimensional interacting boson system s. A swe shall discuss below, this has to do with absence of a well-de ned

concept of statistics in 1D. As a consequence, boson system s can display ferm ion-like properties and vice-versa. One well-known example in the eld of cold atom s is the behavior of the Tonks gas, where the bosons interact so strongly that they e ectively behave as free ferm ions.

B esides blurring the line that separates bosons from ferm ions, con nem ent to one-dimension has another peculiarity that is worth discussing. Being all transverse degrees of freedom frozen, uctuations can only propagate longitudinally. This im plies that their e ect is enorm ously enhanced. As a consequence, no long-range order that breaks a continuous symmetry can exist in the therm odynam ic limit, even at zero tem perature.

The harm onic-uid approach has several advantages over other approaches that are commonly employed to study the low-tem perature behavior of 1D systems. First of all, it is not a mean eld theory, and therefore does not break any symmetry. Furthermore, it can treat bosons and fermions on equal footing, their dierence being manifested by the di erent structure of the correlation functions that describe them. It can also deal with strongly and weakly interacting system s at the sam e tim e since the low -energy physics param etrized by three phenom enobgical param eters (the particle density and two sti nesses). These parameters are related to measurable properties of the system, which makes the approach conceptually simple. Nonetheless, one has to be aware of its limitations, which essentially are related to its \e ective eld-theory" character. Therefore, the description is a low -energy one, it com es with a built-in cut-o, and it is unable to describe the high-energy structure or any model-specic (i.e. non-universal) features. In som e situations, when the interactions are strong, relating som e of the phenom enological param eters to m icroscopic ones can be di cult. But in m any such cases one can rely on an exact (i.e. Bethe-ansatz) solution to extract them. This will be illustrated here for the case of bosons interacting via a zero-range potential [32, 33]. We will thus be able to show that many of the results obtained in the weakly interacting limit from the Bogoliubov-Popov [47, 48] approach and its m odi cations [8, 20] can be recovered and understood within the harm onic-uid approach. We shall also present result for the correlation functions of a num ber of \toy m odels" of 1D m esoscopic system s, such like a ring (i.e. a sm all system with periodic boundary conditions) and a box (a system with open boundary conditions). Besides being analytically tractable, these models are important when comparing with numerical simulations using Monte C arb m ethods [11, 12, 21], where periodic boundary conditions are used, or the density-m atrix renorm alization-group (DM RG) [34, 35], for which open boundary conditions are best suited. Furtherm ore, in recent times, traps other than harm onic have become available [4, 36], which also makes relevant the study of these geometries.

There already exist some studies of the correlation functions in nite-size systems in the literature, but they have mostly focused on ferm ionic or spin correlations [37, 38, 39, 40]. The present approach allows to obtain the correlation functions for both bosons and ferm ions at the same time, and autom atically includes all higher-harm onics, which have been om itted in previous treatments. Besides presenting in full detail the generalization of the harm onic-uid approach to the box case, in this paper we also address how to x the prefactor of the one-body density matrix for bosons interacting with a zero-range potential (henceforth referred to as \delta-interacting bosons"). We not that, when properly parametrized, the result obtained by Popov in the weakly interacting limit. This is demonstrated by comparing with exact results [42] and recent di usion M onte C arb data [21].

The organization of this paper is as follows: In the following section, we shall review the harm onic-uid approach following Ref. 30. In this section we also present its generalization to open boundary conditions. In Sect. III, results for di erent correlation functions in the box and the ring, as well as nite-tem perature expressions in the therm odynam ic limit, are presented. We consider both bosons and spinless (i.e. spin-polarized) ferm ions. Sect. IV specializes the discussion to a system of delta-interacting bosons. This model is relevant for bosonic atom s conned to a one-dimensional channel. We show how the parameters needed for the low-energy description can be extracted from the exact (Bethe-ansatz) solution, and discuss how to x the prefactor of the one-body density matrix. Some experimental consequences of the correlation functions obtained within the harm onic- uid approach are presented in this section. In particular, the line-shape of the momentum distribution at nite tem perature is analyzed as the parameters of the system are varied. In Sect. V, we discuss the asymptotic structure of the wave-function of a bosonic Luttinger liquid, and obtain an expression for a system with open boundary conditions Finally, the appendices contain a proof of a commutation relation used in the main text, an alternative \derivation" of the low -energy H am iltonian using the path integral form alism, as well as a detailed description of how to compute correlation functions using conform all eld theory methods. Some of the results of this work have been brie y reported in Ref. 17.

# II. THE HARMONIC-FLUID APPROACH

In this section we are going to review the harm onic-uid approach in operator language, following the original work of Haldane [30]. Some of the results of this section can be also obtained using a coherent-state path integral form ulation (see Appendix B).

#### A. Haldane's construction

The discussion in this subsection will be independent of boundary conditions, but we shall assume the system to have a nite size L. For the most part, the notation is similar to that of Haldane in Ref. 30. However, we deviate from it in a num ber of places, som etim es to agree with m ore recent conventions. We shall work in second quantization m ost of the time. This means that a system of bosons is described using eld operators which obey  $[(x); y(x^0)] = (x x^0)$ , and commute otherwise; (x) = y(x) (x) is the density operator. The mean ground state density, 0, is xed either by the chem ical potential, , such that  $_0 = _0$  () (grand canonical ensemble), or by the total particle number in the ground state, N<sub>0</sub>, such that  $_0 = N_0 = L$  (canonical ensemble). Note that the discussion that follows applies to uniform system s, the necessary m odi cations needed to dealwith a non-uniform (but slowly varying) ground state density are discussed in Sect. IIE .

As pointed out in the introduction, the e ect of long wave-length them al and quantum uctuations is enhanced by reduced dimensionality. In order to derive a low-temperature description, we need to identify a set of variables that describe the low-energy uctuations of the system . For a bosonic system these variables are the density and the phase. At low tem peratures, density and phase uctuations are locally small in the sense to be de ned below. To give a proper de nition of these variables, we need to introduce the phase-density representation of the bosonic eld operator:

Consistently with the bosonic commutation relations (x); y(x) = (x + x), phase and density operators obey


A convenient way of describing the long wave-length density and phase uctuations is to split  $(x) = \langle x \rangle + \langle x \rangle$ and  $(x) = \langle x \rangle + \langle x \rangle$ , where the  $\langle x \rangle$  and  $\langle x \rangle$  refer to the slow " parts (i.e. coarse-grained over distances  $\binom{1}{2}$  of the operators, whereas  $\binom{1}{2}$  (x) and  $\binom{1}{2}$  (x) refer to the \fast" or short-wave length parts (see Appendix B for a more carefulde nition). In the following we focus on the slow parts, and below, when there is not risk of confusion, we will denote as (x) the slow part of the phase operator (i.e. < (x)). Furtherm ore, since the density uctuates at low temperatures about the ground state value, 0, it is convenient to introduce the operator (x), de ned by (x) = (x) + (x).

We shall rst consider the phase uctuations. In Appendix A we show that the slow parts (x) and (x) are canonically conjugated elds, i.e.

It is worth pointing out that this commutation relation holds, for the slow parts of the density and phase, in arbitrary dimensions. However, since in 1D uctuations are constrained to propagate on a line, this causes the aforem entioned enhancem ent of their e ect. This makes it im possible, in the therm odynam ic lim it, to de ne of an order param eter. Thus we expect that  $he^{i}$  (x) i = 0 in 1D, in contrast with the situation for d > 1, where this operator can acquire a non-zero expectation value (i.e. there can be o -diagonal long-range order). Indeed, in one dimension  $h^{1}(x)i = 0$ also in nite-size systems (see appendices C and D).

We next consider long wave-length uctuations of the density, which have been parametrized as  $_0 + (x)$ . (x) describes boally small uctuations of wave-length  $1^{1}$ . However, this does not su ce to describe all possible low-energy density uctuations. It is thus necessary to distinguish between \low-energy" and long \wave-length";



There can be low-energy density uctuations with wave-length  $_0^{-1}$  or shorter. To see this in a non-trivial case, it su ces to consider the case of the inpenetrable-boson (Tonks) gas. It is known [33, 49] that the excitations of such a system are those of a free ferm igas of the same density. In a Ferm igas the momentum of the fastest particle (the Ferm im om entum) is related to the density by the form ula  $p_F = _0$ . There are two Ferm ipoints (see Fig. 1), corresponding to  $p = _{\rm P}$ . The low-energy and long wave-length density uctuations of this system are the small momentum particle-hole excitations around each one of the Ferm ipoints. However, a ferm ion can also be excited with very low energy from one Ferm ipoint to the other, thus producing a density uctuation that oscillates as  $\cos 2p_F x = \cos 2_{-0}x$ . The long wave-length density uctuations described by (x) lead to small changes in the local Ferm imomentum :  $p_F (x) = p_F + (x)$ . This a ects shorter wave-length density uctuations, which now oscillate as  $\cos 2^{-x} dx^0 p_F (x^0) = \cos 2$  (x), where we have introduced the auxiliary eld (x), related to (x) by means of the follow ing expression [28, 30]:

Note that the integral on the left hand-side of (4) from x = 0 to x = L must be equal to total particle number operator N, namely




FIG.2: Typical con guration of (x). Its value changes by every time x surpasses the location of a particle. Note that (x) is a slow ly varying eld.

This is an important topological property of (x). It tells us that on a global scale the changes in (x) are related to changes in the total particle number. Hence, the congurations of (x) can be regarded as functions that increase monotonically from x = 0 to x = L (see Fig. 2). Thus it is tempting to associate the location of particles with the points where (x) equals an integer multiple of . Physically this amounts to trading discrete particles by solitons or kinks in (x) (see Fig. 2). The construction of a low-energy projection of the full density operator, (x), which re ects the discrete nature of the particles and therefore can describe the shorter wave-length low-energy uctuations follows from this idea [30]. First one sets:

which in the particle-soliton sense is equivalent to the rst quantized form of the density operator,  $(x) = \begin{bmatrix} x & y \\ i=1 \end{bmatrix}$  (x = y) provided that  $x_i$  is interpreted as the position operator of the particle-soliton and one uses  $[f(x)] = (x = y) = jf^0(x_0)j$ , where  $f(x_0) = 0$ . The previous expression can be rew ritten in a more useful way with the help of Poisson's sum mation form ula:

which yields:

This is the sought representation of the density operator. The m = 0 term is precisely  $_0 + (x)$ , and describes the long wave-length uctuations (i.e. those with momenta  $j_{nj} = 0$ ), the m = 1 terms describe uctuations with  $q = 2_0$ , while m = -2 those with  $q = 4_0$ , etc. (see Fig. 5).

We next take up the construction of the boson eld operator y(x) in term s of (x) and (x). A coording to Eq. (1), this requires noting a representation for the square root of the density operator, Eq.(6). At this point it is useful to recall Ferm i's trick:  $[()^2 = A (), where the constant A depends on the particular way the D irac delta function is de ned. Extracting the square root yields <math>() = A^{1=2} ()$ . Thus, using Poisson's form ula (7) and multiplying by  $e^{i(x)}$  from the right, one arrives at [30]:

The symbol means that the eld operator is given by the expression on the right up to a prefactor. This prefactor is not determined independently of the way we choose to exclude the high-energy uctuations (i.e. the fast modes) from the low-temperature description. This is usually done using a cut-o in real or momentum space, and di erent cut-o schemes lead to di erent prefactors.




FIG.3: E ect on the string operator  $e^{i (x)}$  of the creation of a particle at two di erent points  $x_1$  (a) and  $x_2$  (b). When a particle is created (or rem oved) at  $x_1$ , the string operator at  $x_2 < x_1$  is not a ected (a). However, when the particle is created (or rem oved) at  $x_2$  the value of the string at  $x_1$  picks up an extra factor of 1. Since the operators  $\frac{y}{F}(x)$  contain only odd powers of  $e^{i (x)}$ , they are sensitive to these changes, which in plies that they anti-commute.

The construction of a ferm ionic (i.e. anti-commuting) eld operator is also possible. One only needs to realize that, since (x) jumps by every time a particle is surpassed (Fig. 3), the string operator  $e^{i(x)}$  alternates between +1 and 1 (see Fig. 3). This implies that

anti-com mutes at di erent positions. To see this, consider the product  $\frac{y}{F}(x_2) \frac{y}{F}(x_1)$  assuming that  $x_1 > x_2$ , for instance. On the other hand, if we instead consider  $\frac{y}{F}(x_1) \frac{y}{F}(x_2)$  ( $x_1 > x_2$ ), the operator  $\frac{y}{F}(x_2)$  acts inst, thus creating at  $x_2 < x_1$ . Therefore, the string  $e^{i(x_1)}$  of the second is deperator picks up an extra minus sign (see Fig. 3, case (b)) relative to the case where a particle is created at  $x_1$  inst. Thus the operator defined and by (10) anti-commutes at different locations, and therefore describes fermions instead of bosons. The

same conclusion can be reached for a product of two annihilation (or one creation and one annihilation) operators at di erent points [72].




FIG. 4: W hen two particles are exchanged in one-dimension to test their statistics, they cannot avoid collision. Thus the statistical phase and the scattering phase shift cannot be separated.

The explicit construction of the low energy representations of commuting (i.e. bosonic) and anti-commuting (i.e. ferm ionic) elds show show this approach treats bosons and ferm ions on equal footing. On physical grounds, the fact that in 1D transforming bosons into ferm ions is possible is not a surprise. The reason [30] is that when one tries to exchange two interacting particles (or elementary excitations) in 1D they must necessarily collide, and therefore the statistical phase cannot be separated from the phase shift associated with the collision (see Fig. 4).

# B. Low -energy e ective H am iltonian and m om entum operators

So far we have considered the kinematics of the low energy description of a 1D quantum uid. In other words, we have introduced the variables that describe low temperature states of the system and found their relationship to density and eld operators. The next step is to consider the dynamics, that is, the H am iltonian. The starting point for our considerations is the follow ing H am iltonian for bosons interacting via a general two-body potential, v(x) [73]:

Before proceeding any further, a num ber of comments are in order: The above H am iltonian is assumed to describe the situation where all particles lie in the lowest level of a transverse conning potential. This happens when the chemical potential, , is smaller than the transverse connement energy, h!<sub>2</sub>. Regarding the longitudinal connement, we will assume in the following that it is either absent (case of periodic boundary conditions) or that it can be approximated by two in nite barriers placed at x = 0 and x = L (case of open boundary conditions). The elect of a smooth potential in the longitudinal direction will be discussed in Sect. IIE. By restricting ourselves to the lowest transverse level, we assume the system to be electively one-dimensional. If  $u_0^2$  (y;z) denotes the lowest transverse orbital, the three dimensional boson eld operator can be written as  $\frac{y}{3d}(r) = \frac{y}{3}(x)u_0^2$  (y;z) +  $\frac{y}{2}(r)$ , where  $\frac{y}{2}(r)$  describes bosons in the higher energy transverse levels. At low temperatures (i.e.  $T < \frac{1}{2}(r)$ , only virtual transitions to higher transverse levels are permitted, which lead to a renorm alization of the interaction potential v(x) (see e.g. Ref. 6)

To obtain the low -energy e ective H am illonian we use the operator identities derived in the previous section keeping only the leading terms, which are quadratic in the gradients of the slow ly varying elds (x) and (x) (alternatively, one can linearize the equations of motion for the density and the phase-gradient in terms of the gradients and ). The result can be generally written as

The history of this H am iltonian goes back to the pioneering work of T om onaga [26] on one-dimensional electron gases. He wrote it in a very dierent way, but as we shall see in the following sections, both form s are essentially equivalent

and describe the same collection of harm onic oscillators, whose quanta, the \phonons" correspond to low-energy density and phase uctuations. The rst application to a bosonic system was done by E fetov and Larkin [28], who considered a system of tightly bound electron pairs (the \BEC" limit of a 1D superconductor) and wrote  $H_e$  in a form sim ilar to Eq. (12). The form used here is due to Haklane [30, 31] who, building upon and extending the work of Tom onaga [26], Lieb and M attis [27], Luther [29], E fetov and Larkin [28],... introduced the concept of (Tom onaga-) Luttinger liquid as a universality class of 1D system s with gapless, linearly-dispersing, excitations.

For an interaction whose range R  $_0^{-1}$ , one should replace the second term in H  $_{\rm e}$  by

However, provided that the Fourier transform of the interaction potential  $v(q) = \frac{R_L}{0} dx e^{-iqx} v(x)$  is not singular as q! 0, Eq.(12) willhold at su ciently low energies, and below we shall assume that this is indeed the case (a notable exception is the C oulomb interaction). The term proportional to  $(\theta_x = 0)^2$  in Eq. (12) thus corresponds to the interaction energy of the long wave-length density uctuations. The density sti ness  $v_N$  has dimensions of velocity. In the following subsection, it is shown that it is inversely proportional to the super uid fraction. Therefore, both parameters must be regarded as phenom enological. They can be extracted from an exact solution of the microscopic m odel (when available), from numerical calculations or, ultimately, from experimental data, which still allows one to correlate the results from di erent experiments.

For many models on the continuum (i.e. those which do not require a lattice to be de ned) the term proportional to  $(\theta_x)^2$  in Eq. (12) follows from the kinetic energy operator after using Eq. (9), i.e.

Hence  $v_J = h_0 = m_F$ , where  $v_F$ , is the Fermi velocity of a gas of free spinless fermions of density  $_0$ . As we show in the following subsection, this relationship between  $v_J$  and  $v_F$  is ensured by G alilean invariance, and will not hold if this symmetry is broken. This is generally the case of lattice models, such like a 1D system of bosons hopping in a su ciently deep optical lattice

A nother interesting operator is the total m om entum, which can also be expressed in terms of (x) and (x). The derivation is similar to that of the H am iltonian, starting from the second quantized form,

we keep the leading terms in the gradients of (x) and (x), and obtain

W e close this subsection with a remark about notation. It is custom any in the literature on bosonization to work with the eld

A swe shall see shortly,  $v_s$  is the phase velocity of the low energy excitations (sound waves). However, the dimensionless parameter K is related to the strength of quantum uctuations (see Appendix B).

#### C. Particles in a ring: periodic boundary conditions.

Our rst task in this subsection will be to nd appropriate mode expansions for the elds (x) and (x), such that the Ham iltonian, Eq. (12), is diagonalized. Before doing it, we need to nd out how to implement the boundary

conditions in terms of these elds. Therefore, consider a system obeying periodic boundary conditions. As commonly introduced in the literature, this seems a mere mathematical convenience that simplifies the calculations before taking the therm odynamic limit. However, now adays there exist experimental realizations of these BC's. In the case of cold atoms one can think of a quantum degenerate atom ic gas in a tight toroidal trap [36]. Thus, if the boson eld obeys y(x + L) = -y(x), then equations (5) and (8,9) in ply that:

where N is the particle-num ber operator, and J is an operator whose eigenvalues are even integers so that  $(1)^{J} = +1$ . These are very important topological properties of the phase and density elds. In particular, they imply that the system has states that can be labeled by the eigenvalues of J and N. We show below that N and J are conserved quantities (i.e. they commute with H<sub>e</sub>) and can be used to label topologically excited states of the system. In the case of N this is not surprising because the m icroscopic H am iltonian, Eq. (11), conserves the total particle num ber. How ever, we will see that J is associated with the possibility of quantized persistent currents.

W e next write down the mode expansions for (x) and (x), which obey (19) and (20), as well as the commutation relation:

It now becomes clear that this H am iltonian describes collective phonon-like excitations (sometimes called Tomonaga bosons [26]), which disperse linearly in the long wave-length limit gip! 0. This result is perhaps not striking if one deals with bosons because it is already obtained from Bogoliubov's theory (although in 1D this theory is inconsistent in several respects, which can be cured only in the weakly interacting limit [8, 20, 47]). How ever, for interacting fermions it has striking consequences, because it means the absence of individual (i.e. particle-like) excitations in the low-energy spectrum, and the break-down of Fermi-liquid theory in 1D.

The expansions (22) and (23) diagonalize the momentum operator as well:




FIG. 5: Typical low-energy excitation spectrum of a Luttinger liquid with periodic boundary conditions. The shaded area corresponds to the continuum of multi-particle-hole excitations. The Hamiltonian  $H_e$ , Eq. (28) describes the excitation spectrum for q  $J_0$ , with J = 0; 2; 4;:::. Near q 0 the excitations are linearly dispersing phonons: ! (q) ' hyjgj (i.e. superpositions of particle-hole excitations about the same Ferm ipoint, see Fig. 1). For q  $J_0$ , where J = 2; 4;:::, the excitations involve the creation of J current quanta in the ring. For instance, J = 2 correspond to the low-energy transitions between Ferm ipoints shown in Fig. 2 (dashed arrow). For delta-interacting bosons, this picture holds in all regimes, and for the particle-hole spectrum agrees with the spectrum obtained from Bethe ansatz in Ref. [51].

From the previous expression for the Ham iltonian the (inverse) adiabatic compressibility at zero tem perature can be obtained:

Thus we see that the system responds to the twist in the BC's by drifting as whole with constant velocity  $v_{sf} = (hPi_{60} hPi_{0}) = (MN_0) = h = ML$ . For charged particles the phase twist can be thought as the result of a magnetic ux that threads the ring [57].

We next specialize to G alilean invariant system s. As we have already anticipated in the previous section, for these system s  $v_J = v_F = h_0 = M$ , and therefore s = 0. To prove this identity we perform a G alilean boost where the particle m om enta are shifted:  $p_i ! p_i^0 = p_i + hQ$ . The H am iltonian and m om entum operators transform as:

(29), we see that, to leading other, Q = J=L. Hence,  $E_0^0 = E_0 + (h)^2 = 0$ ,  $J^2 = (2L)$ . However, from Eq. (28), the energy of the boosted state is  $E_0^0 = E_0 + h v_J J^2 = (2L)$ . From these last two expressions it follows that  $v_J = v_F$ .

The previous analysis also allows to understand why no term involving the product  $\ell_x$  (x) $\ell_x$  (x) appears in the low energy H am iltonian, Eq. (12). The reason is that this product is the momentum density (cf. Eq. (16)). Therefore, the presence of such a term in the H am iltonian would indicate that we have not chosen the reference fram e where the system is at rest. Thus one can get rid of it by a suitable G alilean transform ation (cf. Eq. (38)).

We end this subsection with a discussion of the selection rules for the eigenvalues of J and N. For bosons with PBC's we have found the following selection rule:  $(1)^{J} = +1$ , i.e. J has eigenvalues that are even integers. How ever, obtaining the selection rule for fermions becomes somewhat messy using the above methods. To derive the selection rules for both bosons and fermions we recall here a construction due to M ironov and Zabrodin [56]. The construction works directly with the many-particle wave function and therefore does not rely on the previous form alism. Consider a rigid translation of the system by a distance a, i.e.

If we choose the wave function to be an eigenstate of  $\hat{P}$  with P = h JN =L, we arrive at the selection rule:

for ferm ions. In the therm odynam ic lim it these selection rules are not very in portant because one can e ectively treat N and J as having continuous eigenvalues. Furtherm ore, the terms in the H am iltonian (28) proportional to  $(N N_0)^2$  and  $J^2$  are of order L<sup>1</sup> and disappear as L! 1. However, for the mesoscopic system swhich concern us here, the selection rules can be important in certain situations where one needs to keep track of nite-size e ects and the discreteness of particles.

#### D. Particles in a box: open (D irichlet) boundary conditions.

We now turn our attention to system s with open (D irichlet) boundary conditions (OBC's). In cold atom system s these conditions have been already experimentally realized (in an approximate way) [4] using a microchip trap where the potential was shaped to a square-well with very high barriers, which can be approximated by perfectly recting walls. Less restrictively, one can assume that there are two points, x = 0 and x = L, where current density vanishes, and this corresponds to the equilibrium state in the experiment of Ref. 3, where <sup>4</sup>He was conned in a long nanopore. To implement the latter BC's, we rst note that, from the continuity equation,

This is achieved by the further requirement that  $_B \in 0$ ; ; 2 ;::: In other words, (x = 0) must be pinned at real num ber that is not a multiple of . To understand this, we need to go back to Eq. (6),

(21), must be fulled for  $0 < x; x^0 < L$ . Thus we arrive at the following expressions (remember in what follows that <sub>B</sub> is just a real number, not an operator):

This is because in a box, as opposed to a ring, there cannot be persistent currents, and therefore J is not a good quantum number.

The above mode expansions diagonalize the Ham iltonian and render it as follows:

The sound waves in a system with OBC's are standing waves and therefore do not carry momentum. Consistently, the momentum operator vanishes, i.e. P = 0 [74].

### E. E ect of a slow ly varying con ning potential

In most of current experimental setups cold atom s are conned in harmonic traps. In this section we are going to discuss how the harmonic-uid approach must be modiled when a smooth potential is applied in the longitudinal direction. We shall distinguish two situations. In the rst we consider that the external potential is weak and show that much of what has been said above applies with small modi cations. However, the harmonic potential does not belong to this class. In other words, it is not weak, but this does not mean that the harmonic-uid approach cannot be adapted to this case. However, calculations are no longer analytically feasible (except in certain limits). Some results for harmonically trapped gases of bosons [14] and fermions [15] are already available in the literature, but since in general no explicit expressions for the correlation functions are available it is hard to extract much qualitative inform ation from these results. In the Tonks limit, one can rely on the fermion-boson corresondence established by

G irardeau [49], which also allows to make a beautiful connection with the theory of random matrices in the gaussian unitary ensemble (GUE). This connection makes it possible to obtain the density probe [41], the form of the Friedel oscillations [50] as well as asymptotic forms for the one-body density matrix [43]. It is also worth mentioning that for ferm ionic systems one can use constructive bosonization [31], and some analytical results can be thus obtained [22]. How ever, the problem with this approach is that the interactions between cold ferm ions do not have a simple form in the harm onic-oscillator basis. Therefore, it becomes hard to assess the elect of the dilement matrix elements on the low energy physics.

Introducing an external potential amounts to adding to the Ham iltonian in Eq. (11) the following term

In order to render the H am iltonian to its form in the absence of  $u_{ext}$  it is convenient to shift

The above treatment is essentially correct provided that the external potential represents weak perturbation, which has been quantied by requiring that  $j_{lext}(x)j$ , for 0 < x < L, and that the external potential is a slow ly varying function. In terms of its Fourier its transform the latter means that  $u_{ext}(q) = 0$  for  $j_{2}j^{>}$  a  $^{1} =$ hy. W hereas the last condition does certainly hold for a shallow harm onic trapping potential, its e ect cannot be considered weak, especially near the ends of the atom ic cloud where typically  $u_{ext}(x)$ . Therefore, away from the center of the trap

this potential cannot be treated within linear response theory and the above results do not apply. However, one can always redo the harmonic-uid approach by considering uctuations around a smooth density prole  $_0(x)$ , which can be obtained, e.g. from the equation of state in the local-density approximation (LDA) [10]. Thus, it is not hard to see that the elective Ham iltonian becomes:

The equation of state = () is obtained from the Bethe-ansatz solution [32, 33]. Thus, diagonalization of (59) can only be accomplished numerically in the general case, and will not be pursued here.

### III. CORRELATION FUNCTIONS

# A. Periodic Boundary Conditions (PBC's)

We begin by considering the static correlation functions at T = 0 (see Sect. IIIC for results at nite tem perature) for particles in a ring, i.e. periodic boundary conditions. The tim e-dependent correlation functions can be also




FIG. 6: O scillating part (i.e. m = 1 term in (61)) of the density correlation function as a function of distance, x (normalized to the system's size), for several values of K (the di erent curves are shifted for clarity). As K decreases the system becomes more \density sti ", which means that density correlations between distant points are enhanced. However, for large K density correlations decay very rapidly with distance. This strong suppression of density uctuations is characteristic of Bose-E instein condensates in higher dimensions. The dashed line represents the power-law behavior expected for the envelope in the therm odynam ic lim it L  $\frac{1}{2}$ 

obtained, but will not be discussed in this paper (except for the dynam ic density response function, which is discussed in Sect.IV C). Here we only notice that it su ces to perform a careful analytical continuation to realtime ! it in the expressions given in appendices C and D. T im e-dependent correlations can be important for future experiments such like the two-photon R am an out-coupling experiment recently proposed by Luxat and G rin [18].

W hen computing correlation functions within the harmonic-uid approach, two strategies are possible. One can directly work with the mode expansions given in sections IIC and IID using the properties of the exponentials of linear combinations of the b(q) and b<sup>y</sup>(q) operators. Another possibility is to use the more sophisticated techniques of Conform al Field Theory (CFT). The latter is our choice here and it is explained in the appendices C and D. Therefore, the reader unfamiliar with these methods should consult the appendices for full details. In this subsection we present the results for the correlation functions for both ferm ions and bosons in a ring.

Let us rst consider the density correlation function, which does not depend on statistics. We rst notice that the structure of the density operator, Eq. (8), in plies that the density correlation function is a series of harm onics of the Ferm im on entum  $p_F = __0$ . The origin of this has been already discussed in Sect. IIA. In our calculations, we have kept only the leading (i.e. the slowest decaying) term of each harm onic. Thus,

This result is valid in the scaling limit, i.e. for jxj a, where a is the short-distance cut-o introduced in previous sections. The vertex operators  $A_{m,m}(x; \cdot)$  are dened in Appendix C. The coe cients  $a_m$  are non-universal, in other words, they depend on the microscopic details of the model and in general cannot be xed by the harm onic-uid approach. The function d(xj) = L jsin(x=L) = is called cord function: it measures the length of a cord between two points separated by an arc x in a ring of circum ference L.




FIG. 7: Phase correlations in a ring as a function of distance, x (norm alized to the system 's size), for several values of the dimensionless parameter K. Note that as K decreases the system becomes less \phase sti ", i.e. phase correlations decay faster. For large values of K phase correlations decay very slow ly, leading to a larger degree of phase coherence between distant points. The dashed lines correspond to the power-law behavior occurring in the therm odynamic limit L ! + 1. The nal upturn of the curves is due to the periodicity of the correlation functions in a ring.

W e next take up the boson and ferm ion one-particle density m atrices. Upon using Eqs. (9) and (10), we obtain:

A lso in these expressions the dimensionless coe cients  $b_m$  and  $f_m$  are non-universal. The results of Ref. 30 are recovered in the therm odynam ic lim it L ! +1, which e ectively amounts to perform ing the replacement  $d(x_jL)$  !  $j_xj$  in the above expressions [63]. In the Tonks lim it K = 1 and the leading term of (62) agrees with the exact asymptotic results obtained in Refs. 42, 43:

In Fig. 6 we have plotted the m = 1 term of h (x) (0) i to illustrate how the density correlations are enhanced as K is decreased. Thus for K = 1 (free ferm ions or the Tonks lim it of delta-interacting bosons) the distant points are more correlated in density than for large K (very attractive ferm ions or bosons with weakly repulsive interactions). This means that the oscillatory term s become more important as K decreases, whereas for large K they can be safely neglected, as it is done in the Bogoliubov approximation. On the other hand, as shown in Fig. 7, distant points become e less phase correlated for small K as the result of density and phase being conjugated elds. The system is then said to be less \phase sti ". However, for larger K phase correlations are enhanced, and only in this sense one can speak of \Bose-E instein condensate" even though, strictly speaking, there is not such a thing as a condensate (i.e. long range-order) in one dimension (for instance he<sup>i</sup> (x)</sup>  $i_{pbc} = 0$ ). At most, all that exists in the therm odynam ic lim it is an algebraic decay of phase correlations, which is often called quasi long-range order (Q LRO).

# B. Open Boundary Conditions (OBC's)

In this subsection we consider the ground state correlations for particles in a box. The expressions for the correlation functions in this case are somewhat more complicated than for periodic boundary conditions. The reason is that in a box translational invariance is bot and two-point correlation functions depend on both arguments separately and not only on their dimense. Furthermore, the ground state expectation value of some operators becomes non-trivial, that is, there are non-trivial one-point correlation functions. This is the case of the density operator (see below). However, the operator  $e^{i (x)}$  continues to have zero-expectation value, implying the absence of any continuous symmetry-breaking even though the system is nite and bounded.

We rst compute the ground state expectation value of the density:

where the coe cients  $c_m$  and m are model dependent [62]. The above expression is valid in the scaling limit, which for the above expression means that minfx; L xg a, i.e. su ciently far from the boundaries. It is noticeable that h (x)i exhibits Friedel oscillations, independently of the statistics of the constituent particles. This is not surprising in view of the many common features exhibited by interacting bosons and fermions in one-dimension, and whose origin was already discussed in Sect. II. In the therm odynamic limit, the replacement d(2x  $\frac{1}{2}$ L) !  $\frac{1}{2}xj$  shows that the di erent oscillating terms in the expression for h (x)i decay from the boundary as power laws with increasingly large exponents: m<sup>2</sup>K for m = 1;2;::: indicating that only the leading two terms are important. Next we consider the more complicated two-point correlation functions. We begin with the density-density correlation function,

U sing the results of Appendix D one can also obtain the one-particle density matrices of bosons and ferm ions. The corresponding expressions read:




FIG.8: Phase correlations for a system of bosons in a box. In the left plot,  $x^0$  has been xed to the center of the box, while phase correlations are sample as x is shifted towards the right end. In the right plot,  $x^0$  is close to the left end and as x increases we move towards the right end. As remarked in the case of a ring, the system becomes less phase sti as K is decreased. This means that in this case the boundary conditions have a large e ect on the phase correlations in the Tonks limit (K = 1) than in the weakly interacting limit (K = 1).

The coe cients a  $m_{m} m_{0}$ ;  $b_{m,m^{0}}$  and  $c_{m,m^{0}}$  are model-dependent complex numbers. In contrast with the case of periodic boundary conditions, where these prefactors can shown to be real, this cannot be established in the present case [70]. The above expressions are accurate in the scaling limit, which for two-point correlation functions means that  $j_{K} \propto^{0} j_{J}$  a as well as minfx;  $x^{0}$ ; L = x;  $L = x^{0} g_{J}$  a. It is also worth mentioning that the bulk behavior is recovered for  $j_{K} \propto^{0} j_{J}$  minfx;  $x^{0}$ ; L = x;  $L = x^{0} g_{J}$  a. In this limit, the less oscillating term s are those with  $m = m^{0}$ , which exhibit, in the therm odynamic limit, the same a algebraic decay as the correlations for the ring geometry. It is also worth pointing out that in the Tonks limit (i.e., for K = 1), the leading term of Eq. (67) agrees with the asymptotic result obtained in Ref. 43,

where  $b_{00}^{\text{Tonks}} = 2 \, {}^{1=3}^{\text{P}} - e^{A} \, {}^{6}$  / 0.5214 (A / 1.2824271 is G laisher's constant). Note that this is the same prefactor as the one found for PBC's, which is not suprising given that both correlation functions have the same bulk lim it.

It is interesting to point out that for particles in a box there are two types of exponents that characterize the decay of correlation functions. Consider for instance the density correlation function, Eq. (66). Its bulk behavior (i.e. near the center of the box) is governed by the exponent  $2m^2K$  for a harm onic that oscillates as  $e^{2m} e^{(x-x^0)}$ . How ever, the asymptotic behavior when one of the coordinates is taken near the boundary is governed by a di erent exponent. Thus if we set  $x^0$  $x^{0}$ , a term that oscillates as e <sup>2 im</sup> ox in the correlation function falls o with the a and x exponent equal to m<sup>2</sup>K, i.e. the same exponent that we have already encountered for the Friedel oscillations of the density. For the boson density m atrix the corresponding exponents are  $m^{2}K + 3=4K$  whereas for the ferm ions they are  $(m + 1=2)^2 K + 3=4K$ . It is important to stress that the presence of the boundary breaks the (Lorentz) invariance of H<sub>e</sub> making space and time directions non-equivalent. To see this, consider a dynamic correlation function such like the G reen's function h y(x;t) (x 0;0)i, for bosons, or h  $\frac{y}{r}(x;t)$  (x 0;0)i, for ferm ions (t > 0). Using the expressions of Appendix D, and perform ing the analytical continuation ! it after setting  $x = x^0$  a, one obtains that the leading term decays as t $^{1=K}$  for t  $a=v_s$  (for both bosons and ferm ions). This in contrast with the behavior of the sam e functions in the bulk, where space and tim e are equivalent (i.e. Lorentz invariance is restored) and one expects a behavior like t  $^{1=2K}$  for bosons and t  $^{(1=K+K)=2}$  for ferm ions. [75]

To illustrate both nite-size and con nem ent e ects we show in Fig. 8 the behavior of leading term in Eq. (67), which corresponds to the phase uctuations he  $i^{(x)}e^{i^{(0)}}i_{obc}$  (i.e.  $m = m^0 = 0$ ). A sm entioned above, the correlation function is now a function of x and  $x^0$  separately. Thus, in Fig. 8 we have considered two situations. In the plot on the left, we take  $x^0$  to be the center of the box. Thus it can be seen that the power-law (bulk) behavior is a good approximation for x around L=2, whereas the phase correlations deviate from it as x approaches the right end of the box (i.e. for x  $x^{0} > 0.3L$ ). These deviations become more in portant as K is decreased and the system approaches the Tonks limit (K = 1). This is because, as remarked in the previous subsection, the system becomes less phase sti as K decreases. Thus, for smaller K the boundary conditions have a larger e ect in decreasing the phase correlations near the ends of the box. However, for larger K the system exhibits a larger phase sti ness, and phase correlations decay very slow ly, even near the boundaries. Furtherm ore, the deviations from the power-law behavior are smaller. However, these deviations become much larger with distance if now  $x^0 = 0.1L$ , i.e. when  $x^0$  is xed near the left end of the box. Then, the bulk power-law is no longer a good approximation and we can observe deviations from it for a decade: from  $x x^0$ 0:1L to x 🎗 L. The reasons for this deviations is that initially the correlations decay according to the bulk power-law, but they rapidly cross-over to a decay governed by the exponent 3=4K (recall that  $m = m^{0} = 0$ ). Near the right boundary, the correlation function must vanish. This is because the pinning of the density eld (x) at x = L makes uctuate the phase at that point wildly.

# C. Correlations at nite tem perature

As described in Appendix C the same methods that have allowed us to obtain the correlation functions of a nite ring at zero temperature also allow to obtain expressions for the correlation functions of an in nite system at nite temperature (see below).

At nite temperature one nds (see Appendix C) that correlations decay exponentially with distance (as opposed to the algebraic decay found at T = 0 for L ! + 1). Therefore, in the expressions below, we shall keep only the leading term s, which e ectively means that we cut-o the series of harm onics at m = 0 (for the boson density matrix, and at jn j = 1 for the density correlation function and the ferm ion density matrix. Thus the following expressions are obtained:

the dimensionless coe cients A; B, and C are model dependent. In Sect. IV B we shall discuss how to x the prefactor for the bosonic density matrix, Eq. (71).

From the previous expressions one can see that the behavior of the correlations \crosses over" from algebraic decay for a  $j_x j^< L_T$  to exponential exp [ $j_x j = l_e(T)$ ] for  $j_x j$   $L_c(T)$ . The characteristic decay length  $L_c(T)$  depends on the correlation function. Thus, for the non-oscillating part of h (x) (0) $\frac{1}{2}$ ,  $L_c(T)$   $L_T$ . However, for the oscillating part  $L_c(T)$  L (T) =  $hv_s = KT = hv_N = T$ . For the phase correlations, however, the characteristic distance is of the order of L (T) =  $hv_s = T = hv_J = T = h^2_0 = MT$ , the latter expression being valid only in system s with G alilean invariance. O ne can use the previous expressions also in nite-size system s provided the tem perature is high enough. The value of T for which these characteristic lengths become of the order of the system size, L, give us a rough estimate of the tem perature scale below which nite-size and con nem ent e ects are in portant. Since, in general,  $L_T \in L \in L$ , this tem perature scale depends on the correlation function. Thus, for the phase correlations, L (T) L for T  $hv_J = L = h^2_0 = ML$ , the latter expression applying to system s with G alilean invariance. However, for the density correlations,  $L_T = L$  or L (T) L, whichever gives the highest value of T. Hence, T = m axfhv\_s = L; hv\_s = K Lg.

# IV. DELTA-INTERACTING BOSONSASA LUTTINGER LIQUID

# A. Extracting the Luttinger liquid parameters from the Bethe-ansatz solution

In what follows, we shall illustrate many of the concepts introduced above by considering a model of bosons interacting with a zero-range potential [32, 33]. This is relevant to cold atom is vapors, where atom s mainly interact through the s-wave scattering channel, and their interaction is parametrized by the s-wave scattering length,  $a_s$ . O Ishanii [6] has shown that the interaction between atom s con ned in 1D wave guide with transverse harmonic con nem ent is well described by a zero-range interaction potential v(x  $x^0$ ) = g (x  $\hat{x}$ ), where

where  $a_s$  is the three-dimensional scattering length, C = 1.4603 :::; and  $\frac{P}{P} = \frac{P}{h=M!_{?}}$  is the transverse oscillator length. There is a single dimensionless parameter,  $= M g = h^2_{0}$ , which characterizes the dimensionless parameter  $_{0}$   $\dot{a}_{1D}$   $\dot{j}$  which is related to by  $= 2 = _{0} \dot{a}_{1D}$   $\dot{j}$ . The model thus defined is exactly solvable. Its solution for periodic boundary conditions was found by Lieb and Liniger B2, 33], whereas the case with open boundary conditions was solved by G audin [52]. Lieb and Liniger were also able to compute the ground state energy perparticle as well as the chemical potential and the sound velocity by numerically solving a set of integral equations. One can thus obtain the phase and density stimess,  $v_J$  and  $v_N$ , by writing integral equations which allow one to obtain these parameters. These equations were written down by Haldane [53]. However, we shall not follow this path here but instead, we shall adopt a dimensions were approach [55, 56]. We first numerically not the solution of the Bethe-ansatz equations [32, 54],




FIG.9: Density and phase sti ness as a function of  $= M g = h^2_0$ . The dots are the result of the numerical calculation of  $v_J$  from the Bethe-ansatz equations. The dashed line corresponds to the Bogoliubov result for  $v_N$ , Eq. (76). The dotted-dashed line is the large- asymptotic result, Eq. (77).

When deriving these equations we have assumed that the boundary conditions are not periodic but twisted as in (32), where is the twist in the phase. In the ground state the set of integers  $fI_{ig_{i=1},...,N_{0}} =$ f (N<sub>0</sub> 1)=2; (N<sub>0</sub> 3)=2;:::; (N<sub>0</sub> 3)=2; (N<sub>0</sub> 1)=2g [32, 54]. The ground state energy for N<sub>0</sub> particles and a phase twist can be computed from the solution to the above equations,

and using Eq. (31) and (37)  $v_N$  and  $v_J$  can be num erically computed [76]. The results of these calculations are shown in gures 9 and 10. Fig. 9 shows the behavior of the phase  $(v_J)$  and density sti ness  $(v_N)$  as a function of the dimensionless parameter = M g=h<sup>2</sup><sub>0</sub>. We have num erically obtained  $v_J$  to show explicitly that, because of the G alilean invariance of the model,  $v_J = v_F$ .

As already pointed out by Lieb and Liniger [32, 33], the Bogoliubov approximation for the ground state energy yields a very accurate expression of the sound velocity for < 10. Hence,




FIG. 10: Luttinger-liquid parameters vs. =  $M g = h^2_0$ . The dashed lines are the small approximations obtained from B ogoliubov theory whereas the dotted-dashed lines correspond to the asymptotic expressions for large .

In Fig. 10 we have plotted the parameters  $v_{\rm s}$  and K as function of  $% 100\,\rm km$  . They also show good agreement with the asymptotic results at small ,

From Fig.10 one can see that as varies from zero to in nity, K varies from in nity to 1. Thus, K = 1 corresponds to the Tonks lim it, which is also the value of K for non-interacting ferm ions. Finally, in table I we provide a \translation table" between K and for the values of K used in plots of this article.

#### B. Remarks on cut-o s and prefactors

One of the disadvantages of the harmonic-uid approach is that it cannot provide explicit expressions for the prefactors of the correlation functions. As obtained within this approach, they are cut-o dependent quantities and their values depend on the particular regularization scheme used in the calculation This is a signature of non-universality, i.e. the prefactors depend on the microscopic details of the model. Thus, they must be xed by other means, either by comparing with numerical results or by adopting a physically sensible regularization scheme (this is possible in certain models) and using rather sophisticated form -factor methods (see e.g. [58] and references therein). Sometimes expressions for the prefactors can be obtained in certain limits by working directly with the microscopic

m odel. This is the case for the Tonks lim it of delta-interacting bosons [42, 59] or for a num ber of lattice m odels, such like the quantum -Ising m odel and or the XY m odel [60, 61].




FIG.11: Large momentum cut-o vs. At large  $q_{\pm}! = 0$  and  $q_{\pm} = 0$ , whereas for small  $q_{\pm} = \frac{1}{2} = \frac{1}{2} = \frac{1}{2}$ , whereas for small  $q_{\pm}$  is the inverse healing length.

Before jumping into the discussion of the prefactors for the model of delta-interacting bosons, let us pause for a moment to consider a question that will be relevant for the xing of the prefactors, namely the dependence of the wave-number cut-or  $q_c = -hv_s$  on . As mentioned in previous sections, for delta-interacting bosons the different regimes are characterized by a single dimensionless parameter,  $= M g = h^2_{0}$ , where g is the strength of the interaction. For weakly interacting bosons (i.e.  $! 0) q_{\cdot} ! = 1 = 2 = 0$ , where  $h = h^2 M$  is the healing length. On the other hand, for strongly interacting bosons (! + 1),  $q_{\cdot} ! = 0 = 2$ . The full dependence can be obtained from the numerical solution of the Bethe-ansatz equations (74). The result for  $q_c$  has been plotted in Fig. 11.

As we have mentioned at the beginning of this section, within the harm onic-uid approach the prefactors depend of the cut-o,  $a < q_1^1$  (see Appendix C). In the weakly interacting regime, Popov [20, 48] was able to obtain the prefactor of the one-body density matrix. In our notation, his result reads:




FIG. 12: M om entum distribution at nite tem perature for the Tonks gas (K = 1). The inset shows that the asymptotic behavior is not as  $p^2$ , as expected for a lorentzian but rather as  $p^{1-2K}$   $r^1 = p^{-1-2}$ .

In view of this result, one may be very tempted to use this expression for any value of K relevant to this model (i.e. 1 K < +1). The result, when compared with the di usion M onte C arb data reported in Ref. 21 and exact results [42, 43, 59], is very surprising (see Table II). It is found that Eq. (84) is accurate within less than 10% over the whole range of K values, becoming essentially exact for K 1, as expected. This fact is quite remarkable taking into account that from K 10 to K = 1 the prefactor changes by a alm ost a factor of two.

# ${\tt C}$ . ${\tt T}$ ips to com pare with the experim ents in cold gases

In the previous sections we have equipped ourselves with the tools to characterize the behavior of one-dimensional cold-atom systems. In this characterization the Luttinger-liquid parameters  $v_s$  and K play an prominent role. The latter is especially in portant because it enters the exponents of the correlation functions, and governs their algebraic decay at zero temperature. Furtherm ore, the value of K also tells us to which kind of instabilities the system can become unstable when perturbed. A well-known example [16, 30] is the quantum phase transition to a M ott-insulator in the presence of a commensurate periodic potential, which takes place (strictly speaking at T = 0 and L ! 1) for arbitrarily weak potentials at K < 2. At nite temperature, the behavior of the system is characterized by the correlation lengths  $L_T$ , L (T) and L (T), which are combinations of the parameters  $v_s$ ; K and the temperature, T. A s we are interested in the bulk properties of 1D system s, we shall focus in this section on the implications of the correlation functions previously derived for the experimental observations.




FIG.13: M om entum distribution at nite tem perature for a system with K = 2. The inset shows that the asymptotic behavior is not as  $p^{2}$ , but rather as  $p^{1-2K}$   $1 = p^{3-4}$ .

We begin our discussion by considering the nite temperature momentum distribution. This quantity can be accessed by performing Bragg scattering measurements at large momentum transfer [18, 67, 68]. At temperatures  $T = h^2_{0} = M L$ , one can safely neglect nite-size and boundary elects. In this temperature range the elects of the inhom ogeneity in harm onically trapped system s can be treated using the local density approximation as described in Refs. 67, 68. For a uniform system, the momentum distribution is de ned as the Fourier transform of  $g_1(x;T)$ , i.e.

In Figs. 12, 13, and 14 we compare both form s, Eq.(86) and (88); n (p;T)=n (0;T) and  $n^{0}$  (p;T)= $n^{0}$ (0;T) are plotted against pL (T). Our calculations assume the scaling limit, which in these plots means that  $pj^{<}$  q. For pj q., O Ishanii and D un ko have shown [19] that n (p;T) p<sup>4</sup>. From gures 12, 13, and 14 one can draw the conclusion that the brentzian is a good approximation for large K, i.e. for weakly interacting bosons. The width of the brentzian




FIG.14: M om entum distribution at nite tem perature for a system with K = 4. The inset shows that the asymptotic behavior is not as  $p^{2}$ , but rather as  $p^{1-2K}$   $1 = p^{7-8}$ .

is proportional to L (T) /  $_0$ =T, which thus provides a measure of this ratio. However, in the Tonks lim it the momentum distribution at T > T boks more like a stretched brentzian. The reason is that, in the large momentum lim it, n (p;T) as given by Eq. (87), behaves as a power-law: p  $^{(1 \ 1=2K)}$  p  $^{1=2}$ , for K = 1. Experimentally, extracting the Luttinger-liquid parameter from n (p;T) may be hard because the true n (p;T) may not display this algebraic behavior in a su ciently wide range of p (set aside the com plications that averaging g<sub>1</sub> using the local density approximation may introduce). However, there may be some chance to observe the more qualitative behavior shown by these plots: as the system 's parameters are tuned (e.g. by using a Feshbach or the con nem ent-induced resonance [6]) tow ards the Tonks lim it, the momentum distribution should become more \stretched" and less Lorentzian-like.

A more quantitative estimate of the Luttinger-liquid parameters near the center of the trap can be obtained from the dynamic density response function,

Since  $v_J = v_s K$ , the weight becomes K q=2. Thus by measuring the dispersion ! (q) one can obtain  $v_s$ , whereas from the weight of Im (q; !), K can be measured. Inhomogeneity e ects can be treated also in this case within the local density approximation, as discussed in Ref. 44. In this respect, we notice that Im (q; !) has the same structure as the result from Bogoliubov approximation in d > 1. The only difference is that it holds, as well as the expression for n (p; T) derived above, for all values of the interaction parameter , and not only in the weakly interacting lim it.

# V. JASTROW -BIJL WAVE FUNCTIONS AND LUTTINGER LIQUIDS

In Sect. II it has been shown that the low-energy spectrum of a Luttinger liquid is completely exhausted by phonons with linear dispersion. This phonons are nothing but collective oscillations of the density and the phase. In view of this fact, one may wonder what kind of correlations are built into the ground state wave function by these collective excitations. The question has been considered in di erent contexts by several authors [45, 46]. Here we restrict ourselves to the case of particles in a box (OBC's). Taking inspiration from the work of R eatto and C hester [46] we write the ground state wave function for N<sub>0</sub> bosons in a box as follows:

that is, all the N<sub>0</sub> lie in the lowest-energy orbital sin (x=L). As for  $_{c}(x_{1};:::;x_{N_{0}})$  we will obtain an asymptotic expression valid for  $jx_{1}$   $x_{j}j$  a, for  $i; j = 1;:::;N_{0}$ . In this lim it the correlations between particles are dominated by the zero-point motion of the collective excitations.

In order to obtain the asymptotic behavior of  $_{c}$ , we consider the ground-state wave function of the low-energy H am iltonian (in this section  $\hat{A}$  denotes the operator of the corresponding classical variable A),

Notice that K  $(x;x^0)$  depends on the short-distance cut-o a and therefore, it cannot correctly describe short-distance correlations where x  $x^0$ . The second expression above is thus only asymptotically correct.

A swe discussed in Sect. II, the con gurations of (x) describe long wave-length density uctuations, i.e. the \slow" part of the density. Thus, we are quite tem pted to make the replacement (x) ! (x) =  $P_{\substack{N_0 \\ i=1}}^{N_0} (x_i x_j)$ . How ever, in doing this we must be careful enough to remove the terms that involve the function K (x;x<sup>0</sup>) evaluated at x = x<sup>0</sup> since K (x;x<sup>0</sup>) cannot describe short-distance correlations (In R ef. [17] we failed to notice this, and as a result the wave function obtained there is not completely correct. See below for the correct expression). If we do so, the following function is obtained in term s of particle coordinates:

There are several reasons to believe that the wave function (106) is, at least asymptotically, correct. First, in the non-interacting limit K ! +1 (i.e. ! 0 for delta-interacting bosons), c ! 1, and one recovers the independent-particle ground state  $_0 = ~_0$ . On the other hand, in the Tonks limit K = 1,  $_0$  is the exact ground state of a system of hard-core bosons in a box [43]. Furtherm ore, if one repeats the above calculation for bosons in a ring, the result is the well-know Jastrow -B ijl function:

There is also a good chance that the latter wave function m ay be asymptotically correct for other m odels of interacting bosons in a harm onic trap.

# VI. CONCLUSIONS

In this paper we have addressed the properties of one-dimensional system s of cold atom s using the harm onic-uid approach (also know as \bosonization"). Besides reviewing the method in pedagogical detail, we have argued that it allows to treat boson and ferm ion systems both in strongly and weakly interacting limits. We have also shown how concepts and results obtained using the Bogoliubov-Popov approach [47, 48] and its modi cations [8, 20] can be naturally recovered using bosonization, which in our opinion is much simpler conceptually. When combined with the conform al eld theory m ethods explained in the appendices, it becom es a very pow erful tool to obtain the functional form s of the correlation functions for various geom etries (ring, box with Dirichlet BC's), and also nite-tem perature correlations. The method has some limitations, however, as it cannot provide explicit expressions for the prefactors of the correlation functions, which turn out to be model-dependent. Moreover, for strongly interacting systems it becomes dicult, without further input, to relate the phenomenological parameters v  $_{\rm J}$  and  $v_{\rm N}$  to the microscopic param eters of the model at hand. Nevertheless, for a relevant model of bosonic cold atoms, we have shown that one can successfully extract those parameters from the exact (Bethe-ansatz) solution. Furtherm ore, the prefactor of the one-body density matrix could be pxed with less than 10% error by expressing a result obtained in the weakly interacting limit [48] in terms of K =  $v_J = v_N$ . These results should allow for a quantitative comparison with the experiment. In this respect, we have discussed how to extract the Luttinger-liquid parameters K and  $v_s = \sqrt[r]{v_N v_L}$ (i.e. the sound velocity) from Bragg-scattering measurements of the density response function and nite-tem perature m om entum distribution. For the latter quantity, we have argued that, as a system is tuned into the Tonks regime, the nite-T momentum distribution should become more stretched, as compared to the lorentzian form exhibited by n (p;T) in the weakly interacting limit. Looking forward to experiments where these predictions can be tested, we hope that the present work will foster the use of the harm on ic- uid approach in the study of 1D cold-atom system s.

This is just a dimension of the duality of the elds (x) and (x), which provide two complementary descriptions of the low energy physics. # APPENDIX B:PATH INTEGRAL FORMULATION

O ur goal in this appendix is to present a som ewhat di erent, but at the sam e tim e com plan entary derivation of som e aspects of the harm onic- uid approach. To this purpose, we will am ploy the path integral form alism. We also com pute the low tem perature lim it of the partition function to show that the spectrum described by this form ulation has the sam e structure and degeneracies as the one obtained from the Ham iltonian given in Eq. (28) of Sect. IIC.

### APPENDIX C:FINITE SIZE/TEMPERATURE CORRELATION FUNCTIONS

In this appendix we shall compute two important correlations functions, from which any two-point correlation function can be derived. Before we do it we will introduce a lot of new technology. These methods are related to a sym metry of the phonon model de ned by  $H_e$  known as conformal invariance, which has deep consequences. This is a too vast subject to be covered here, and we refer the interested reader to the literature [58, 70, 71]. However, in the discussion below we shall try to be as self-contained as possible. The introduction of this technology will be lengthy at the beginning, but it really makes life much easier when complicated correlation functions with di erent boundary conditions need to be computed. This means that part of the results of this appendix will be also used in the following one. Here we begin by considering a system with periodic boundary conditions. Thus the rule to compute the expectation value of an arbitrary number of vertex operators is to rst separate the zero modes from  $_{\rm L}$  and  $_{\rm L}^{\rm y}$ . Next, commute all the terms involving  $_{\rm L}^{\rm y}$  and  $_{0\rm L}$  to the left of the terms involving  $_{\rm L}$  and N  $_{\rm L}$ . Every time one does so with a pair of operators i and j, one gets factor exp  $\begin{bmatrix} i & j & h & (z_i & z_j) \end{bmatrix} = (z_i & z_j)^{i \cdot j}$ . The nal expression is thus rendered into normal order, that is, it has all the operators  $_{\rm L}$ ; N  $_{\rm L}$  to the right of  $_{\rm L}^{\rm y}$ ;  $_{0\rm L}$ . The expectation value of the normal ordered product equals unity provided the neutrality condition is obeyed (and the ground state is not degenerate).

Therefore, the expectation value of fully norm alordered products of vertex operators no longer equals unity. Instead, for a two-point correlation function one is left with the factor

In both cases the phases are of 0 (1=L) and sim ply disappear as L ! +1 . However, in nite systems they must be taken into account if detailed comparison with, e.g. num erics, is being sought. In what follows, how ever, we shall assume that hJi = 0 and N\_0 is a positive integer (odd in the case of fermions). . ... . . . . .

We next turn to the computation of the second correlation function mentioned above, namely  $h_x^0$  (x<sup>0</sup>; <sup>0</sup>) $i_{pbc}$ . Finally, we shall describe how to obtain correlation functions at nite temperature in an in nite system. In terms of the complex variables  $w = v_s + ix$  and  $w = v_s + ix$ , this means that  $(w + L_T; w + L_T) = (w; w)$ , where  $L_T = hv_s = hv_s = T$  is the thermal length. If we compare this with the requirement of PBC's: (w + iL; w - iL) = (w +

Furtherm ore, the presence of boundaries makes in possible the existence of persistent currents, and thus only N can appear in the mode expansions. Therefore, only one chiral eld operator can be constructed out of  $_0$ ; N and b(q) and b<sup>y</sup>(q). Such a eld, how ever, must be de ned for L < x L, such that q is quantized as 2 m =2L = m =L, as required by OBC's. We chose the interval 0 < x L to correspond to the actual system, and below we shall assume that x > 0 always. As in the previous Appendix, we can write:

In the presence of a boundary, which breaks Lorentz invariance, one has to introduce an additional scaling dimension, term ed boundary dimension:  $d_B = 1=2K$  for both bosons and ferm ions (i.e. half the exponent of  $t^{1-K}$ , the asymptotic behavior near the boundary). Thus, for a two-point correlation function of the same operator, if one of the arguments lies at the boundary, the spatial decay of the correlation function is given by the exponents  $d + d_B = m^2 K + 3=4K$  for bosons and  $d + d_B = (m + 1=2)^2 K + 3=4K$  for ferm ions.
