## Fluctuation and localization of acoustic waves in bubbly water

## Abstract

Here the uctuation properties of acoustic localization in bubbly water is explored. We show that the strong localization can occur in such a system for a certain frequency range and su cient

lling fractions of air-bubbles. Two uctuating quantities are considered, that is, the uctuation of transm ission and the uctuation of the phase of acoustic wave elds. W hen localization occurs, these uctuations tend to vanish, a feature able to uniquely identify the phenom enon of wave localization.

Am ong m any unsolved problems in condensed m atter physics[1], the phenom enon of Anderson localization is perhaps m ost intriguing. The concept of localization was nst proposed about 50 years ago for possible disorder-induced m etal-insulator transition [2]. That is, the electronic m obility in a conducting solid could completely come to a halt when the solid is implanted with a su cient amount of random ness or impurities, in the absence of the electron-electron interaction. As a result, the electrons tend to stay around the initial site of release, i. e. localized, and the envelop of their wave functions decays exponentially from this site [3]. The physical mechanism behind is suggested to be the multiple scattering of electronic waves by the disorders.

Ever since the inception of this concept, considerable e orts have been devoted to observing localization or phenom ena possibly related to localization, as reviewed in, for instance, Ref. [3, 4, 5]. By analogy with electronic waves, the concept of localization has also been extended to classical systems ranging from acoustic and electrom agnetic waves to seism ological waves in random ly scattering media, yielding a vast body of literature (R effer to the reviews and textbooks R efs. [6, 7, 8, 9]). In spite of these e orts, the phenom enon of localization has remained as a conceptual conjecture rather than a reality that has been observed conclusively.

The di culty in observing electronic localization may be obvious. In actual measurements, the Coulomb interaction between electrons is hard to be excluded. W ith this in mind, it has been suggested that localization might be easier to observe for classical waves as wave-wave interactions are often negligible in these systems. However, classical wave localization may yet su er from e ects of absorption, leading to uncertainties in data interpretation. Indeed, up to date, a de nite experimental evidence of localization is still lacking. Signi cant debates on reported experimental results remain [10, 11, 12]. How to unambiguously isolate localization e ects from other e ects therefore stays on the task list of top priority, and poses an compelling issue to our concern.

In this Letter, we wish to continue previous e orts in exploring acoustic localization in water having m any air- led bubbles, i.e. bubbly water [13, 14]. We attempt to identify some unique features associated with localization. In particular, we will study the behavior of the phase of the acoustic wave elds in bubbly water. The uctuation of the phase and the acoustic transmission will be studied. The method is based upon the standard multiple scattering theory which has been detailed in [15].

Consider the acoustic emission from a bubble cloud in water. For simplicity, the shape of the cloud is taken as spherical. Such a model eliminates irrelevant edge e ects, and is useful to separate phenomena pertinent to discussion. Total N bubbles of the same radius a are random ly distributed within the cloud. The volum e fraction, the space occupied by bubbles per unit volume, is taken as ; thus the numerical density of bubbles is  $n = 3 = (4 a^3)$ , and the radius of the bubble cloud is  $R = (N = )^{1=3}a$ . A monochromatic acoustic source is located at the center of the cloud. The wave transmitted from the source propagates through the bubble layer, where multiple scattering incurs, and then it reaches a receiver located at som e distance from the cloud. The multiple scattering in the bubbly layer is described by a set of self-consistent equations. The energy transmission and the acoustic wave eld can be solved numerically in a rigorous fashion [13, 15].

Denoting the total acoustic wave at a spatial point as p(r), which includes the contributions from the wave directed from the source  $(p_0)$  and the scattered waves from all bubbles. To eliminate the unnecessary geometrical spreading factor, we normalize the wave eld as  $T = p=p_0$ ; therefore T is dimensionless. The total transmission is de ned as  $I = JT^2$ . The average is hIi and its coherent portion  $I_c = hJT jI^2$ ; here h i denotes the ensemble average over the random conguration of bubble clouds.

For the acoustic wave eld, we write p = pjexp(i) with  $i = {p - 1}$  here; the modulus pj represents the strength, whereas i the phase of the secondary source. We assign a two dimensional unit vector  $u_i$ , hereafter term ed phase vector, to each phase i, and these vectors are represented on a phase diagram parallel to the x y plane. That is, the starting point of each phase vector is positioned at the center of individual scatterers with an angle with respect to the positive x-axis equal to the phase,  $u_i = \cos_i x + \sin_i y$ . Letting the phase of the initiative emitting source be zero, i.e. the phase vector of the source is position of the phases of the bubbles and the spatial distribution of the acoustic wave modulus.

A general aspect of localization is as follows. The acoustic energy ow is conventionally J Re[p<sup>?</sup> (ir)p]: Taking the eld as jpj<sup>i</sup>, the current becomes jp<sup>2</sup>r. Therefore when is constant while jpj€ 0, the ow stops and energy will be localized or stored in space. This general picture is absent from previous considerations.

A set of num erical experim ents has been carried out. In the simulation, we param eterize

the relevant physical quantities as follows. The frequency is scaled by the radius of bubbles, i.e. ka. In this way, it turns out that all the simulation is dimensionless when no absorption is included [13]. The uctuation of the phase of the acoustic eld at the bubble sites is de ned as  ${}^2 = \frac{1}{N} {}^P {}_{i} {}_{i}$




FIG.1: Transm issions as a function of ka.

First we identify the regin as of localization. Following [13], we plot the averaged transmissions (hIi and  $I_c$ ) versus frequency kain Fig. 1. Here N = 800 and totally 100 averages haven used. The receiver is located at the distance 2R from the source. It is clearly suggested in the gure that there is a region in which the transmission is virtually forbidden. This ranges from about ka = 0:014 to 0.060. And form ost frequencies, the coherent transmission is the major portion in the transmission.




FIG.2: Left column: The phase diagram for the two dimensional phase vectors dened in the text for an arbitrary random distribution of bubbles. Right column: The acoustic energy distribution or transmission, averaged for all directions, as a function of distance away from the source; the distance is scaled by the sample size R. The three frequencies are selected from within and outside of the localization regime, referring to Fig.1.

To exam ine the uctuation behavior of the phase and the transmission and for the convenience of the reader, in Fig. 2, we purposely repeat the earlier e ort[14] to plot the phase diagrams of the phase vectors (left column) and the averaged wave transmission as a function of distance from the source (right column). Here it is clearly shown that the exponential decay of the transmission, i.e. the phenom enon of localization, is indeed associated with an in-phase coherence or brdering' among the phase vectors, i.e. nearly all the phase vectors point to the same direction, in the complete agreement with the general prescription of localization stated above.




FIG.3: Fluctuation of the phase as a function of ka for two sizes of bubble clouds. In both cases, the volume fraction is kept at 0.001.

In actual experiments such as acoustic scintillation in turbulent media, it is the variability of signal that is often easier to analysis. As such, we wish to investigate the uctuation behavior of wave transmission. In Fig. 3, we plot the uctuation of the phase of the acoustic wave elds at the bubble sites in term sofper scatterer. Two sizes of bubble clouds are taken, corresponding to N = 800 and 1600 respectively. Here we see that within the localization range, the uctuation tends to zero and is insensitive to the sam ple size. At around the localization transition edges, signic cant peaks in the uctuation appear. The peak position at the low frequency end does not depend on the sam ple size whereas at the high frequency side, the peak position m oves as the sam ple size increases. These results in ply that there are perhaps two types of transition m echanism s at the low and high frequency edges respectively.

In the present model we may also be able to include dissipation e ects either manually or through calculation of therm all exchange and viscosity e ects [15]. It can be shown that

the dissipation will not be able to give rise to the picture depicted by Fig. 3. Therefore these uctuation behaviors may help in discerning localization. We also note here that we have carried out two types of averaging. One has been de ned above. The second is to look at the phase uctuation of the wave eld at a xed spatial point, likely being the case in experiments, we found that the two approaches nearly produce the same results.




FIG.4: The uctuation of transmission as a function of ka.

The corresponding uctuation of wave transm ission per scatterer  $\hat{I}=N$  and the relative uctuation  $\hat{I}=hIi^2$  are plotted against frequency in Fig. 4. Again two sample sizes are considered. Fig. 4 (a) shows that the uctuation per scatterer behaves similarly as the phase uctuation, thereby providing a further check point in discerning localization e ects. However, the relative uctuation in Fig. 4 (b) behaves rather di erently. There is no signi cant reduction within the localization regime, compared to the outside. Except near the transition edges, the magnitude of the relative uctuation is nearly the same for all frequencies within or outside the localization range and for di erent sam ple sizes, a result in contrast to the discussion for one dimensional system s [16]. We note that at the zero frequency limit, all the uctuation approaches zero. This is because at this limit, the scattering e ect is nearly zero, and therefore the bubbles give no e ects.

In short, some uctuation behaviors in acoustic localization in bubbly water have been studied. The results suggest that proper analysis of these behaviors may help discern the phenomenon of localization in a unique manner.
