M agnetic structure of C eR hIn $_5$ as a function of pressure and tem perature

W e report m agnetic neutron-di raction and electrical resistivity studies on single crystals of the heavy-ferm ion antiferrom agnet C eR hIn₅ at pressures up to 2.3 G Pa. These experiments show that the staggered m on ent of C e and the incom m ensurate m agnetic structure change weakly with applied pressure up to 1.63 G Pa, where resistivity, speci c heat and NQR m easurements con rm the presence of bulk superconductivity. This work places new constraints on an interpretation of the relationship between antiferrom agnetism and unconventional superconductivity in C eR hIn₅.

I. IN TRODUCTION

Heavy ferm ion (HF) materials provide an excellent opportunity to investigate the interaction between magnetism and unconventional superconductivity (SC). In most HF compounds the magnetic interactions are govemed by the hybridization of the f electrons and the conduction electrons. This leads to competition between the tendency to order magnetically, favored by the RKKY (Ruderm an-Kittel-Kasuya-Yosida) indirect exchange interaction, and the tendency to have a spinsinglet ground state m ediated by the K ondo interaction. In these systems, there is increasing experimental and theoretical evidence that antiferrom agnetic (AFM) spin uctuations m ediate C ooper pairing and that an isotropic appears in the vicinity of a quantum -critical SC point^{1,2,3,4,5,6}. Several fam ilies of HF compounds are known where SC does coexist with weak magnetic order (eg,UPt3, URu2S这, UN这A员⁷). Howevermost of Cebased heavy ferm ion superconductors (HFS) ($CeIn_3^{8,9}$, $CeCu_2Ge_2^{10,11}$, $CePd_2Si_2^{12,13}$, $CeRh_2Si_2^{14}$) display an AFM ground state at am bient pressure and superconduct when external pressure is applied and T $_{\rm N}\,$ is driven to 0 K .

A new family of Ce-based compounds: CeM In₅ (M = Co,Ir,Rh) with Sommerfeld coe cients () of 1000, 750 and 380 m J m ol ¹ K ² respectively, has recently been added to the list of HFS^{15,16,17,18,19,20}. The most notable properties in this series include: am bient-pressure m agnetic order (T_N = 3.8 K) and pressure-induced SC (T_C = 2.1 K at P = 1.63 G Pa) in CeRhIn5¹⁵, unconventional am bient-pressure SC in both CeIrIn5 (T_C = 0.4 K)¹⁷ and CeCoIn5 (T_C = 2.3 K)¹⁷ and coexistence of SC and AFM in solid solutions of CeRh_{1 x} A_xIn₅ (A = Ir,Co)^{21,22}. The H oC oG a₅-type crystal structure is com m on to these com pounds (a= b' 4.66 A and c' 7.51 A)²³ and consists of alternating layers of CeIn₃ and M In₂ stacked sequentially along the [001] direction.

Here we focus on CeRhIn₅ which orders at ambi-

ent pressure in an incommensurate AFM helical structure²⁴ with a wave vector $q_m = (0.5, 0.5, 0.297)^{25}$. For P 1.5 GPa, the AFM ground state is suppressed and bulk SC is observed below $T_c = 2.2 \text{ K}^{15,20}$. ¹¹⁵In-NQR studies on CeRhIn5 initially reported a decrease with applied pressure of the internal magnetic eld (H int) at the In (1) site (located in the $CeIn_3$ layer) and the authors attributed this decrease either to a reduction of the ordered moment of Ce or its rotation from the a-b plane with pressure^{26,27}. Recent NQR studies found that AFM coexists hom ogeneously with SC at a microscopic level in CeRhIn₅ and estimate that if the ordered moment is reduced with pressure, its value at 1.75 GPa, where AFM coexists with bulk SC, is at most 5 % of its am bient pressure value²⁸. On the other hand, speci c heat m easurem ents on $CeRhIn_5$ show that the entropy below T_N decreases by about 20 % as pressure is raised from 0.3 to 1.32 GPa²⁰ which appears to be inconsistent with the reduction of the ordered m om ent suggested by NQR results. Neutron di raction studies are required for an unambiguous determination of the pressure evolution of the ordered m om ent and m agnetic structure.

An initial neutron di raction study under hydrostatic pressure (P < 0.4 GPa) on C eR hIn₅²⁹ revealed no changes in the staggered m om ent nor T $_{\rm N}\,$ within the error bars of the experiment and reported a slight reduction in the incom m ensurate wave num ber. Consistent with this rst study, m ore recent neutron di raction m easurem ents nd essentially no change in the magnetic structure at low pressures³⁰. However, around 1 GPa, Majum dar et al. reported a marked change in the wave vector from (0.5,0.5,0.298) to (0.5,0.5,0.396) and a 20% reduction of the magnetic moment. They also reported no evidence for AFM order above 1.3 GPa which contrasts with resistivity, specic heat and NQR observations^{15,20,26,27,28,31} and tentatively ascribe the change in the magnetic structure to a change in the electronic structure under pressure. However, de Haas-van Alphen results show that the topology of the Ferm i surface does not change at

pressures below 2.0 G P a^{32} and that there is a steep increase in the cyclotron m ass only above 1.6 G P a when SC develops. A dditional X-ray di raction studies con m that the C eRhIn₅ crystal structure, except for a small decrease in the cell volum e, remains unchanged for pressures up to 2.0 G P a^{33} . In this work, we have extended the pressure range over which electrical resistivity and neutron di raction m easurements have been performed on C eRhIn₅ in order to investigate the e ect of pressure on the superconducting and m agnetic transition temperatures and the evolution of the m agnetic structure as it approaches and exceeds the critical pressure where the two phases m eet.

II. EXPERIMENTAL DETAILS

Single crystals of C eR hIn₅ were grown using the In ux technique^{34,35}. Four-probe AC resistivity measurements, with the current owing in the tetragonal basal plane, were made on bar-shaped single crystals. A clamp-type cell generated hydrostatic pressures to 2.3 GPa for resistivity measurements using silicon oil as the pressure medium.

Neutron di raction experiments were carried out at the C 5 and N 5 spectrom eters at the NRU reactor, C halk River Laboratories (CRL) as well as at the 6T2 lifting detector di ractom eter at Laboratoire Leon Brillouin, Saclay (LLB). A clamp-type Cu-Be cell³⁶ was used in experiments performed at CRL with Fluorinert-75 as the pressure medium to generate up to 1.8 GPa. Barshaped single crystals (1.3 1.3 10 mm) were used to reduce neutron absorption by In and Rh nuclei at CRL. The longest dimension of the crystals was along the (110) crystallographic axis. The scattering plane was de ned to be the (hhl). In this set-up, the applied pressure was determ ined, within 0.1 GPa, by m easuring the lattice param eters of a graphite crystal placed behind the sam ple inside the cell at low tem perature. Neutron beam swith incident energy of $E_i = 35 \text{ meV}$ were produced from a Ge(113) or Be(002) m onochrom ator. Pyrolytic graphite (PG) Iters with approximate thickness of 10 cm were placed in the scattered beam to reduce higher order reections and occasionally a pyrolytic graphite analyzer was used to improve the signal to noise ratio.

At LLB, a gasketed sapphire anvil cell was used with a mixture of methanol and ethanol as the pressure transmitting medium for experiments at 0.63 and 1.1 GPa. Samples, with dimensions 1.3 1.3 0.2 mm, were aligned with the [001] crystallographic direction (shorted dimension) vertical. A thin layer of ruby powder was placed on the inner surface of the anvil in order to measure the applied pressure at room tem perature using the standard ruby uorescence technique. This was perform ed before and after therm al cycling to ensure that pressure was constant throughout the experim ent. This technique allows determining the pressure at low temperatures within 0.15 GPa. Neutron beam s of $E_i =$




FIG.1: a) Tem perature-pressure phase diagram for C eR hIn₅ determ ined by (T) m easurements. Open squares correspond to the N eel tem perature and solid circles to the tem perature at which the resistivity drops to zero. The lines are guides to the eye. b) P ressure evolution of the antiferrom agnetic helical structure characterized by the propagation vector $q_m = (0.5, 0.5,)$. c) P ressure evolution of the estimated C e staggered m om ent at T = 1.85 K of C eR hIn₅. Filled circles correspond to m easurements performed at CRL. Iled squares correspond to m easurements performed at LLB Saclay and em pty squares correspond to data reported by Bao et al.^{25,29}

14.81 m eV, were produced using a PG (002) m onochrom ator. In both laboratories a top bading He- ow cryostat was used to cooldown the pressure cell and sam ple. Results reported below were obtained on several di erent single crystals, in di erent pressure environm ents and at two neutron sources. The consistency of these results substantiate conclusions drawn from them.

III. RESULTS AND DISCUSSION

W e m easured electrical resistivity () on C eR hIn₅ single crystal at di erent applied pressures and tem peratures from 300 mK to room tem perature. This crystal has a resistivity ratio (295 K)/ (1.5 K)= 280 that is about two times higher than that in a crystal studied by H egger et al.¹⁵. The pressure-tem perature (P-T) phase diagram constructed from these (T) m easurements is shown in Fig.1a. Our new results show that the m agnetic




FIG. 2: Elastic q scans though selected nuclear B ragg peaks at T = 1.8 K and P = 1.15 GPa.




FIG. 3: Elastic q scans around some of the magnetic peaks at T = 1.8 K and P = 1.15 GPa.

to non-magnetic transition is smooth and reveals the existence of a large pressure region of coexisting long-range magnetic order and SC (0.9 GPa P 1.75 GPa). There is a slight increase of T $_{\rm N}$ with pressure up to about 0.8 G P a and for pressures above this value T $_{\rm N}\,$ decreases and a SC ground state develops. This phase diagram is fully consistent with that determined by speci c heat²⁰ and $NQR^{26,27,28}$ and departs from initially reported results¹⁵.

To determ ine the pressure evolution of the magnetic structure of CeRhIn5 and particularly the incommensurability parameter () of the magnetic structure ($q_n =$ (0.5, 0.5,)) special attention has been paid to the precise alignment of the single crystal since depends critically on it. For this reason, system atic checks have been perform ed during the measurem ents using f1,1,2g, f0,0,3g and f2,2,0g nuclear B ragg re ections. Fig 2 shows typicalq-scans around a series of f1,1,2g re ections at 1.85 K and 1.15 GPa which attest to the quality of the crystal alignment. When changing pressure, the cell and sam ple were warm ed to room tem perature before the next




FIG.4: Selected elastic q scans at T = 1.8 K and P = 1.8 GPa not showing any evidence of magnetic scattering.

pressure was applied. At each pressure, q-scans and rocking curves were m easured at m agnetic and nuclear peaks. Severalm agnetic re ections, including Friedelpairs, were m easured to determ ine more accurately. A set of representative m agnetic B ragg peaks are shown in Fig.3 for P = 1.15 GPa and T = 1.85 K. The absence of other com m ensurate re ections, like (0.5,0.5,0.5), was also system atically veried. From data such as shown in Fig.3, we obtain the pressure dependence of plotted in Fig.1b. Our results show that there is no substantial change in the magnetic wave vector (0.5, 0.5,) within the accuracy of these m easurem ent up to pressures of 1.63 G Pa. This is qualitatively di erent from the result reported by Majum dar et al.³⁰. At 1.8 GPa, we do not detect any evidence for magnetic scattering for temperatures greater than 1.85 K as shown in Fig.4. We speculate that the lack of magnetic long range order at this pressure can be due to the existence of a marginally higher pressure than 1.8 GPa which would drive T $_{\rm N}$ close to our lowest m easuring tem perature in which case the magnetic scattering would be not observable above background scattering from the Be-Cu pressure cell. The possibility that a dram atic change m ay occur in the m agnetic structure between 1.63 GPa and 1.8 GPa giving no magnetic scattering along (0.5, 0.5, ') for the 'interval reported seems very unlikely but cannot be de nitely ruled out.




FIG. 5: Temperature dependence of the (0.5,0.5,) Bragg peak intensity at P=0.6 GPa and 1.1 GPa (vertical o set added) and T $_{\rm N}$ (0.6 GPa) T $_{\rm N}$ (1.1GPa). The solid lines are ts to (1-T/T $_{\rm N}$)² with = 0.25.

The tem perature dependence of the (0.5, 0.5,) B ragg peak intensity which corresponds to the magnetic order parameter squared is shown in Fig.5 for P = 0.6 GPa and 1.1 GPa. It reveals that there is not a signi cant change in the developm ent of the magnetic order at pressures above and below the pressure where SC starts developing. A tentative t to $(1-T/T_N)^2$ showed better agreement when = 0.25 which is consistent with the results reported at am bient pressure³⁷.

To determ ine the magnetic moment at each pressure, m agnetic B ragg peaks were measured at 1.8 K with rocking scans at LLB-Saclay and with scans such as those in Fig.3 at CRL. Magnetic cross-sections are derived from integrated intensities with appropiate correction for

resolution³⁸. They are norm alized to nuclear B ragg peaks to yield values in absolute unit. The theoretical crosssection for the AFM spiralm odel is^{25,39}:

$$(q) = \left(\frac{r_0}{2}\right)^2 (M_{Q})^2 \frac{1}{4} \text{ if } (q) \text{ if } (1 + (\mathbf{q} \ \mathbf{b})^2) \qquad (1)$$

where f(q) is the Ce^{+3} magnetic form factor⁴⁰, $\left(\frac{0}{2}\right)^2 = 0.07265$ barns/_B and M₀ is the staggered moment of Ce ion. Fig.1c shows the staggered moment of Ce as a function of applied pressure. The staggered m agnetic m om ent of C e at am bient pressure, 0.1) $_{\rm B}$ /Ce, which is consistent with the $M_{0} = (0.8)$ previously reported value of $M_Q = (0.75)$ 0.02) _B/Ce and is found to be about 20% sm aller than the full m om ent obtained from crystal eld calculations, which estim ate M $_{Q}$ = 0.92 $_{B}$ /C e⁴¹. W e attribute the sm aller m easured value of M $_{\rm O}$ to partial K ondo com pensation of the m om ent, an e ect neglected in crystal eld calculations. Fig.1c also shows that there appears to be a slight tendency for M $_{\odot}$ to decrease with pressure (less than 15% decrease at 1.63 GPa com pared to am bient pressure).




FIG. 6: q-scans around (0.5,0.5,1-) m agnetic relection at 1.63 GPa for dilerent temperatures above and below T $_{\rm N}$ ' 2.85 K using a pyrolytic graphite analyzer to improve the signal to background ratio.

An anomaly at $T_2=2.8$ K was found for 1.3 < P < 2.0 GPa in earlier resistivity measurements on CeRhIn5¹⁵. This resistivity anomaly is not detected in the higher quality crystals used to construct the phase diagram in Fig.1. We have measured q-scans around (0.5,0.5,) at P= 1.63 GPa for di erent temperatures (Fig.6) and our results con rm that magnetic long range AFM helical order disappears between 2.25 and 2.75 K which is very close to values of T_N obtained from resistivity measurements (T_N (1.6 GPa)= 2.8 K).

For the incommensurate magnetic structure of CeRhIn₅, the internal magnetic eld sensed by ¹¹⁵In-NQR is given by H_{int} / $A_{ab}M_Q$ fsin(q₀z),cos(q₀z),0g, where A_{ab} is the hyper ne coupling between the in-plane In nucleus and each of its four Ce nearest neighbors, M_Q

is the ordered m om ent and $q_0 = 2 = c^{42}$. Our neutron di raction experiments show that $and M_0$ change by at m ost 10% and 15% respectively, as pressure is raised from atm ospheric to 1.63 GPa (Fig.1 (b) and Fig.1 (c)). These relatively sm all changes in M_0 are unable by them selves to account for the 80% reduction of H $_{\rm int}$ deduced by NQR measurements. If the Ce moments acquire a component out of the ab plane as a function of pressure an apparent decrease of H_{int} would be also observed²⁷. In such a scenario, additionalm agnetic di raction peaks corresponding to a propagation vector di erent from (0.5, 0.5,) would appear and a subsequent reduction of the in-plane component would be observed. We did not observe a large reduction of the in-plane component nor any evidence of magnetic di raction at (05,05,05) due to an AFM out of the a-b plane component but we cannot discardrule out magnetic intensity appearing at (0.5,0.5,0). Taken together, our results would seem to rule out the canting scenario. An alternative, and more plausible, interpretation of the reduction of H_{int} is that hyper ne coupling decreases with pressure²⁹. Irrespective of the m agnitude of H int, NQR m easurem ents28 establish beyond reasonable doubt the coexistence of AFM and bulk SC in CeRhIn₅ at 1.75 GPa. Our di raction results indicate that M_Q (0.67 0.04) $_B$ /Ceat 1.6 GPa and 1.85 K . These results indicate that bulk SC coexists with relatively large-momentAFM order in CeRhIn₅ under pressure.

 $Unlike UPd_2Al_2^2$ where the coexistence of AFM and unconventional SC has been ascribed to the partition of the three U 5f electrons into dual roles, magnetic and SC, CeRhIn₅ has only a single 4f electron that participates in creating both states. This situation in ${\rm C\,eR\,h\,In_5}$ is also distinctly di erent from other pressure-induced HFS based on Ce. CeIn₃, on which CeRhIn₅ is based is an example. In $CeIn_3$ the ordered moment⁹ and specic heat anomaly at T_N decrease monotonically towards zero as the critical pressure is approached where SC appears⁴³. We do not understand presently how such a large-m om ent AFM can coexist with unconventional SC in CeRhIn₅. It is as if the 4f m om ents, in som e way, also assum ed dual character, perhaps purely in a dynam ically as suggested by recent NMR studies⁴² or spatially segregating into AFM and SC domains. Such segregation, however, also could be dynam ic since there is no evidence for additional NQR frequencies^{26,27,28}.

In sum m ary, we have determ ined a P-T phase diagram from high quality $C \approx h \ln_5$ single crystals which shows a broad range of pressures where AFM and SC coexist. In addition, our single crystalm agnetic neutron di raction studies on $C \approx h \ln_5$ nd only sm all changes in the incommensurate magnetic structure and ordered moment as pressure is increased up to 1.63 G Pa. These results are consistent with speci c heat measurements but inconsistent with estimates of H_{int} determined by NQR, which we attribute tentatively to a pressure-induced change in the hyper ne coupling. We have not reproduced the observation of a signi cant change in and the absence of

AFM at 1.3 GPa reported earlier³⁰. M ost in portantly, we have found that compared to other heavy ferm ions, the relationship between AFM and unconventional SC is qualitatively di erent in CeRhIn₅ and will require the development of a new interpretative fram ework in which

the 4f electron produces both long-range AFM order and heavy-quasiparticles that pair to form an unconventional SC state.
