Single Stranded DNA Translocation Through A Nanopore: A Master Equation Approach

W e study voltage driven translocation of a single stranded (ss) DNA through a mem brane channel. O urm odel, based on a master equation (ME) approach, investigates the probability density function (pdf) of the translocation times, and shows that it can be either double or mono-peaked, depending on the system parameters. We show that the most probable translocation time is proportional to the polymer length, and inversely proportional to the rst or second power of the voltage, depending on the initial conditions. The model recovers experimental observations on hetro-polymers when using their properties inside the pore, such as sti ness and polymer-pore interaction. PACS number: 87.14 Gg, 87.15 Aa, 87.15 He

1. IN TRODUCTION

Translocation of biopolymers through a pore embedded in a membrane is a fundamental step in a variety of biological processes. Among the examples are the translocation of som e species of m-RNA through the nucleus m em brane which is the rst stage of gene expression in eucaryotic cells [1], and the attack of cells by viruses that occurs by injecting the genetic information through a hole in the cell mem brane [2]. The translocation importance in bio-systems, and the possibility for developing fast sequencing m ethods, have been the m otivation for recent experiments, in which a voltage-driven ssDNA is translocated through -hem olysin channel of a known structure [3]. In these experiments one measures the time it takes a single ssDNA molecule to pass through a membrane channel [4-7]. Since ssDNA is negatively charged (each m onom er has an e ective charge of zq, where z (0 < z < 1) is controlled by the solution pH and strength), when applying a voltage the polymer is subject to a driving force while passing through the membrane from the negative (cis) side to the positive (trans) side. Because the presence of the ssDNA in the transmem brane pore part (TPP) blocks the cross-TPP current, one can deduce the translocation tim es pdf from the current blockade duration times [4-7]. It has been found that the shape of the translocation times pdf is controlled not only by the voltage applied to the system , the tem perature and the polym er length but also by the nature of the hom o-polym er used: poly-dA (A -adenine); poly-dC (C-cytosine); $poly-T_{nu}$ (T_{nu} -thym ine), and the sequence of hetro-polymers [4-7].

The translocation process can be roughly divided into two stages. The rst stage is the arrival of the polymer in the vicinity of the pore and the second stage is the translocation itself. Severalm odels have been suggested for describing the translocation stage. In [8] an equation for the free energy of the translocation, obtained from the partition functions of the polymer parts outside the TPP, was derived and used to calculate the mean rst passage time (MFPT). Other investigators used similar ideas with improved free energy term s by taking into consideration e ects such as the mem brane width [9–10], or assumed that only the part of the ssD NA inside the TPP a ects the dynamics of the translocation rather than the polymer parts outside the TPP [11–12].

In this work we present a new theoretical approach that allows to consider both the polymer parts outside the TPP and within the TPP.U sing the M E we are able to m ap the three dimensional translocation onto a discrete space one-dimensional process. Based on the M E we compute the pdfofthe rst passage times (FPT) of the translocation, F (t), and the M FPT, as a function of the system parameters. We relate our theoretical results to recent experimental observations and by analyzing them using our model, we come up with physical understanding of these observations.

2. THE MODEL

An n (= N + d 1)-state M E is used to describe the translocation of an N-monom er long ssDNA subject to an external voltage V, and temperature T, through a TPP of a length that corresponds to d = 12 m onom ers. A state is de ned by the number of monomers on each side of the membrane and within the TPP.A change in the state of the system (only nearest states transitions are allowed) is assumed to be controlled mainly by the behavior of the polymer within the TPP in the presence of the applied voltage. In addition, it is assumed to be in uenced by entropic and interaction factors of the polymer outside and within the TPP. Absorbing ends are used as boundary conditions, which are the natural choice for this system because the polymer can exit the TPP on both sides. The state j = n represents the arrival of the rst monomer into the TPP from the cis side, and the state j = 0 represents the departure of the far end monomer from the trans side of the TPP. Let P_{i} (t) be the pdf of state j that contains m j nucleotides occupying

the TPP according to:

and a similar set of equations for a short polymer, N d, which is obtained by exchanging N and d in Eqs.(1.1) through (1.3). The governing equations of motion are:

Equations (2) can be written in matrix representation (P = Qt = AP). The propagation matrix A, is a tridiagonal matrix that contains information about the transitions between states in term of rate constants. We assume that the rate constants can be decoupled into two term s:

The st term provides the rate to perform a step, while the second term gives the probability to jump from state j in a given direction, and obeys: $p_{j;j+1} + p_{j;j-1} = 1$. To obtain k_i, we rst consider the bulk relaxation time of a polymer [13] $_{\rm b}$ / $_{\rm b}b^2 N$, where 1 = $k_{\rm B} T$, b is a m onom er length, b is the Stokes bulk friction constant per segment, b = 6 b (where is the solvent viscosity), N is the number of monomers in the polymer and the dimensions dependant represents the e ect of the microscopic repulsion on the average polymer size. In three dimensions = 3;9=5;3=2 for rod-like, self-avoiding and Gaussian (Zimm model) chains, respectively. To compute the relaxation time inside the TPP, the con ned volume of the TPP must be taken into account. For a rod-like polym er the restricted volum e dictates a onedim ensional translocation, whereas for a exible polym er the limitations are less restricted. We implement this by taking as a measure of the polymersti ness inside the TPP that obeys: 0 1:5. The expression for the relaxation rate of state j is therefore,

From Eq.(4) it is clear that as becomes smaller the rate to preform a step becomes larger, namely k_j for a rod-like polymer increases. This feature appears, at rst sight, to be in contradiction to the relaxation time behavior of a bulk polymer, where a rod-like polymer has a larger relaxation time than that of a exible polymer. This contradiction is resolved by taking into account the di errent dimensional dem and for a rod-like polymer relative to a exible polymer sti ness inside the TPP. Because is a measure of the polymer sti ness inside the TPP, it is

controlled by the interaction between the m onom ers occupying the TPP, e.g base stacking and hydrogen bonds, and therefore is a ected by the m onom er type and the sequence of the ssDNA.

The friction constant per segment inside the TPP, p, represents the interaction between the ssDNA and the TPP. The physical picture is that during translocation there are few or now aterm olecules between the polymer and the TPP. Consequently the water molecules inside the TPP can hardly be viewed as the conventional solvent and the Stokes friction constant is replaced by p representing the ssDNA-TPP interaction.

To calculate $p_{j;j-1}$, the second term on the right hand side of Eq.(3), we assume a quasi-equilibrium process and use the detailed balance condition for the ratio of the rate constants between neighboring states: $a_{j;j-1}=a_{j-1;j}=e^{E_j}$, where $E_j = E_{j-1} = E_j$. We then use the approximation $a_{j;j-1}=a_{j-1;j} = p_{j;j-1}=(1 = p_{j;j-1})$, and deduce the jump probabilities by computing E_j . To compute E_j the contributions from three dimension sources are considered: electrostatic, E_j^p , entropic, E_j^s , and an averaged interaction energy between the sSDNA and the pore, E_j^i .

For the calculations of the electrostatic energy di erence between adjacent states, E_j^p , we assume a linear drop of the voltage along the TPP and write for m_j m onom ers occupying the TPP penetrating from the cis side of the mem brane for a length of i_j b:

The e ective charge per m onom er in the TPP is taken to be the same as of the bulk. For states that contain m onom ers at the trans side of them em brane, zqV should be added for E_j^p . This contribution represents the additional e ective charge that passed through the potential V.A coordingly, the expression for E_j^p is (see Appendix A):

Here $_{j}$ takes the values: $_{j} = f 1;0;1g$ for cases described by equations f(1:1);(1:2);(1:3)g respectively ($_{j} = 1$ and $_{j} = 1$ correspond to the entrance and exit states of the translocation, whereas $_{j} = 0$ corresponds to the interm ediate states of the translocation). For a short polymer, $_{j}$ has the same values as for a large polymer.

The contribution to E_j from E_j^s is composed of two terms. One term is the entropic cost needed to store m_j m onom ers inside the TPP, and the second term originates from the reduced number of con gurations of a G aussian polymer near an impermeable wall. Combining these terms leads to (see Appendix B):

where $j = f + g_j; g_j; 1 + g_j g$, for cases described by equations f(1:1); (1:2); (1:3)g, respectively. g_j is given in Appendix B in terms of N _{j,cis} and N _{j,trans}, which are the number of m onom ers on the cis and trans sides correspondingly. For a short polymer j behaves sim ilarly but for interm ediate states $g_j = 0$.

For computing E_j^i we focus on the average interaction between the ssDNA and pore (not only its transmem brane part). Due to the asymmetry of the pore between the cis and the tran sides of the membrane [3], the ssDNA interacts with the pore on the cis side of the membrane and within the TPP but not on the trans side of the membrane. Assuming an attractive interaction, $E_j^i = k_B T (N N_{j,trans})$ (more properly, $E_j^i = "(N N_{j,trans})$, and we set $= k_B T$ in the relevant tem perature regime) we obtain:

where j = f1;1;0g, for the cases described by equations f(1:1); (1:2); (1:3)g, respectively, and for a short polymer j = f1;0;0g.

U sing the above relations, and de ning j = j + j we obtain

For the system to be voltage driven $j E_j^p j > j m ust be fulled, which translate into the condition: V=V_c > 1, where a characteristic voltage is introduced: V_c^{-1} (1 + 1=d) zjgj. This inequality ensures that there is a bias tow ands the trans side of the m em brane. O therw ise the polymer is m ore likely to exit from the same side it entered than to transverse the m em brane. Under experim ental conditions [6] V_c = 46m V, when using z 1=2.$




FIG.1: The components of the E $_{j}$, E $_{j}^{p}$ (zjqjv = 1) and $_{j}$, are shown for N = 100.

In Figure 1 we show the di erent contributions to E_j : E_j^p (for zjqjv = 1) and j. E_j^p decreases for the entrance states of the translocation, increases at the exit states of the translocation, and is a negative constant for interm ediate states. Clearly E_j^p 0 re ects the

eld directionality. On the other hand, j opposes the translocation for the entrance and intermediate states. For the entrance states j > 0 due to both entropic terms, but approaches zero (from below) for the exit states of the translocation, due to the cancellation of E_j^i against the entropic gain of storing less monom ers within the TPP. At intermediate states j = 1, where its shape near the crossover between the di erent situations is controlled by g_j .

3. RESULTS AND DISCUSSION

3.i. The FPT pdf

In this subsection we compute the FPT pdf, F (t), and exam ine its behavior as a function of the system param – eters. F (t) is de ned by:

where the survival probability, namely, the probability to have at least one m onom er in the TPP, S (t), is the sum over all states pdf

Here \dot{U} is the sum mation row vector of n dimensions, \dot{P}_0 is the initial condition column vector, $(\dot{P}_0)_j = x_{;j}$, where x is the initial state, and the denite negative real part eigenvaluem atrix, D, is obtained through the transform ation: D = C ¹AC.




FIG.2: F (t), for several values of $V=V_{\rm C}$, with: N = 30, x = N + d=4, z 1=2, T = 2°C, $V_{\rm C}$ = 46m V, =1:14 and R = $10^6{\rm H}\,z$. The left peak represents the non-translocated events, whereas the right peak represents the translocation. Inset: F (t) as a function of N, with $V=V_{\rm C}$ = 1:5, and the other parameters as above. The non-translocation peak remains unchanged when increasing the polymer length, while the translocation peak shifts to the right with N .

Substituting Eq.(11) into Eq.(10), F (t) is obtained. Figure 2 shows the double-peaked F (t) behavior as a function of $V=V_C$ and N (inset), for starting at x = N + d=4. The left peak represents the non-translocated events. Its amplitude decreases as $V=V_C$ increases but remains unchanged (along with the position) with the increase in N, because only the 'head' of the polymer is involved in these events. As x decreases, namely when the translocation initial state shifts towards the trans side, the non-translocation peak and the translocation peak merge and for x = n=2, namely, for an initial condition for which N _{j;cis}=N _{j;trans}, F (t) has one peak (data not show n) independent of $V=V_C$.

For a convenient comparison to experimental results, we calculate and exam ine the behavior of the most probable average translocation velocity, $v = xb = t_m$, where t_m is the time that maximizes the translocation peak.




FIG.3: The velocity as a function of the polym er length, for the same parameters as in gure 2, various initial conditions (linear-log scales) and $V=V_C$ = 2.6. v(N) tends towards a length independent, but display a sharp decrease for short polym ers. Note for the step feature of v(N) when N becomes larger than the TPP length, d. Inset: v(V), for N = 30, showing linear and quadratic scaling depending on the initial condition, x.

Figure 3 shows the v(N) behavior, for $V=V_C = 2.60.v(N)$ is a monotoniaclly decreasing function of N for N d, but is independent of N for N d. This agrees with the experimental results [6]. The origin for v(N) behavior, stem s from Eqs.(1) and (4), according to which the minimal k_j is a decreasing monotonic function of N for N d, but is independent of N for N d.

The velocity, v(V), depends on x, $v(V) = v_x(V)$, and changes from a linear to quadratic function of the voltage when changing x, as shown in the inset of f igure 3, for N = 30.

Starting at x = N + 1, a linear scaling is obtained: $v_{N+1}(V) = b_1(V \quad b_2=b_1)$. The coe cient $b_2=b_1$ can be identi ed as an e ective characteristic voltage: $\int_{C}^{1} (1 + 1=d) ejgj = b_1=b_2$. From the last equality e can be extracted.

Starting at x = N = 2, i.e. when initial state is close to the exit states, a square dependence is obtained: $v_{N=2}(V) = c_1(V = c_2)^2 + c_3$, with $c_1 = o(10^{-5})$, $c_2 = 40 \text{m V}$ and $c_3 = o(10^{-2})$. These coe cients are similar to the measured values [6].

We note that both linear and square scaling behaviors have been observed experimentally [4,6]. A possible explanation for the dimensional behavior of v(V) m ight originate from dimensional behavior of v(v) interpreted as having a dimensional condition.

To get numerical values for $_{\rm p}$ and , we use the experimental data in refs. [6-7], and obtain: (C) = 1, (A) = 1:14, (T $_{nu}$) = 1:28, and $_{\rm p}$ (A) 10 4m eV s=nm 2 , $_{\rm p}$ (C) = $_{\rm p}$ (T $_{\rm nu}$) = $_{\rm p}$ (A)=3. From these values we nd the lim it in which the relaxation time of the polymer parts outside the TPP can be neglected. We estimate the maximal bulk number of monomers, N_{max} , for which the bulk relaxation time is much shorter (5%) than of the TPP relaxation time. For a poly-dA bulk Zimm chain we get N_{max} 271, by taking for the viscosity the value for water at 2°C, 1:7 10^{3} N s=m². Using this value, b can be calculated from the Stokes relation to be: $_{\rm b}$ 10 7 m eV s=nm 2 , which is three order of m agnitude smaller than p.

3.ii. The M FPT

A dditional inform ation about the translocation can be obtained by computing the MFPT, $\overline{}$. To compute an analytical expression for $\overline{}$, we consider a large polymer, N > d, and replace $p_{j;j-1}$ and k_j by state independent term s: $p_+ = [1 + e^{(-V = V_c + 1)}]^{-1}$, valid for x = N, and $k = 1 = (-pb^2d)$. This leads to $a_+ = p_+k$ and $a = (1 - p_+)k$, which de ness one dimensional state invariant random walk. The MFPT is obtained by inverting A $[14]: \overline{} = \frac{1}{0}$ tF (t)dt = U = U = 1 and k = 1 (see Appendix C):

where $(p^m) = p_+^m p^m$ and $(A^1)_{s;x}$ for s x is obtained when exchanging s with x and p_+ with p in Eq.(12). Sum m ing the x column elements of (A^1) we obtain - (see Appendix C):

which in the limit of a weak bias, $V=V_C > 1$, can be rewritten as (see Appendix C)

A lthough – and t_m are di erent characteristics of F (t) and di er signi cantly when slow translocation events dom inate, Eq.(14) captures the linear scaling with

N and 1=V. The quadratic scaling of t_m with 1=V is obtained when using Eq.(9) rather than its state invariant version, for starting at, or near, an initial state for which j=x 0.

3.iii. The sequence e ect

Under the assumptions that are presented below, we now construct $_{\rm p}$ and for every ssDNA sequence and thus exam ine the sequence e ect on $t_{\rm m}$. For a given ss-DNA sequence occupying the TPP in the j state, we write an expression for the average friction of that state, $_{\rm p;j}$, assum ing additive contributions of the monom ers inside the TPP:

Here nus stands for the nucleotide s occupying the TPP. To construct a compatible state dependent sti ness parameter, j, we rst argue that only nearest monomers can interact inside the TPP and thus contributes to the rigidity of the polymer, which in turn increases k_i. We then exam ine the chem ical structure of the nucleotides and look for 'hydrogen-like' bonds between adjacent bases. The term 'hydrogen-like' bonds is used because the actual distance between the atom s that create the interaction m ay be larger than of a typical hydrogen bond. The pairs AA and CC can interact but not the pairs $T_{n\,u}\,T_{n\,u}$ and CA. For the pair C $T_{n\,u}$ the interaction is orientation dependent; namely, for the lpairs sequence, poly-d (C T_{nu})₁, the interaction is within each of the pairs but not between the pairs. A coordingly we have: (nu nu) = (nu), $(CA) = (AC) = (T_{nu})$, $(CT_{nu}) = (C)$, $(T_{nu}C) = (T_{nu})$, which allow the




FIG.4: t_m as a function of the percentage of equally spaced monom ers substitutions C $\,!\,$ A and C $\,!\,$ $T_{n\,u}$, for N $=\,$ 60, x = N, z $\,$ 1=2, V=V_C = 1:63 and T = 292°K. The curves emphasize the e ects of the rigidity and the friction on the translocation dynamics. See text for discussion.

with ($_j)_{m_j=1} = 0$. Figure 4 shows t_m as a function of equally spaced substitutions C ! T_{nu} and C ! A. The linear scaling of t_m (C ! T_{nu}) is due to the linear scaling of $_j$ (C ! T_{nu}). The saturating behavior of t_m (C ! A) is a combination of two opposing factors: the linear scaling of $_{p;j}$ (C ! A) and the nonm onotonic behavior of $_j$ (C ! A). Our model also predicts that for su ciently large l

This feature is explained by noticing that $2t_m [(CA)_1] > t_m (C_{21}) + t_m (A_{21})$, see gure 4, which follows from the expression for $_j$, Eq.(16), and then using $2t_m (C_nA_n) = t_m (C_{21}) + t_m (A_{21})$, which follows from the linear scaling of t_m with N, for N d in addition to Eq.(15). The above notings regarding the behavior of t_m for hetro-ssDNA, the experimental results [7].

4. CONCLUSIONS

In the presented model, the translocation of ssDNA through -hem olysin channel is controlled, in addition to the voltage, by the interaction between the polymer and the pore (E_{j}^{i} and p), and between nearest monomers inside the TPP (), as well as by an entropic factors originate from polymer segments outside and within the TPP.Based on the model, we showed that F (t) can be m ono or double peaked depending on x and $V\!=\!\!V_C$. We calculated the MFPT to be: $N = (V V_C)$, for N > dand $V=V_{\rm C}$ > 1, and t_m $N = v_x (V)$ for Nd, where v_x (V) changes from a linear to a quadratic function of V with x. In addition we estimated that $_{\rm p}$ 10³ $_{\rm b}$, and by constructing p and for hetro-ssDNA explained experim ental results regarding the various behaviors of t_m for hetro-ssDNA.

An extended version of this model that describes translocation through a uctuating channel structure, can be used to describe unbiased translocation, which displays long escape times [16]. Translocation of other polymers through proteins channels can be described using the same framework by changing , $_{\rm p}$ and $E_{\rm j}$.

APPENDIX A

We wish to calculate the electrostatic energy di erence between sates, E_j^p . There are three cases during translocation, which are described by Eqs.(1.1)-(1.3). For any polym er length, Eq.(1.1) (exit states) describes a case for which N $_{j;cis}=0$ and Eq.(1.3) (entrance states) describes a case for which N $_{j;trans}=0$. For the case described by Eq.(1.2) (interm ediate states), there are m onom ers on both sides of the m em brane for a large polym er, or no m onom ers on both sides of the m em brane for a short polym er. Starting from Eq.(5) we have for the entrance states:

For the exit states E_j^p is composed of two contributions. One contribution stems from the passage of a monomer with an elective charge of zq through the potential V:

For the interm ediate states and a large polymer, we have only the contribution given by Eq.(A2) (the number of m onom ers within the TPP is constant), which can be written as:

when using $m_j = d$ which holds for the interm ediate states. For a short polymer, we have to consider only the contribution given by Eq.(5), which leads again to Eq.(A5). Eq.(6) is obtained from adding the above contributions.

APPENDIX B

For calculating E_j^s , we start by writing an expression for the entropic energy that consists of two term s:

 $E_{j,1}^{s}$ represents the entropy cost of storing m_j m onom ers within the TPP and is a linear function of m_j [10]. $E_{j,2}^{s}$ originates from the reduced number of con gurations of a Gaussian polymer near an impermeable wall, and can be approximated by [8]:
