D ynam ics of zz spin correlations in the square{lattice $spin\{\frac{1}{2} \text{ isotropic X Y m odel}\}$

U sing the Jordan (Wigner fermionization in two dimensions we obtain the zz wave vector{ and frequency{dependent structure factor for the spin{ $\frac{1}{2}$ isotropic X Y m odel on a spatially anisotropic square lattice. We use the obtained results to discuss a role of the interchain interaction for the dynam ic properties of quasi{one{dim ensional system s.

Dynamic properties of the two{dimensional quantum spin models have attracted much attention for the last years mainly due to the discovery of high (tem perature superconductivity of the layered copper oxides¹. At present, m any compounds are known to be good realizations of the square{lattice quantum spin model and the experimental investigations of their dynamic properties? require corresponding theoretical studies. In most cases the isotropic Heisenberg Hamiltonian is used to appropriately model the spin degrees of freedom. However, som e generic features of the square (lattice quantum spin systems can be illustrated within the context of the spin $\{\frac{1}{2} \text{ isotropic X Y m odel, which is far more amenable to a$

theoretical analysis. M oreover, a study of the latter m odel can be viewed as a rst step for exam ining the m ore complicated case of the square{lattice spin{ $\frac{1}{2}$ H eisenberg m odel.

The aim of this study is to exam ine the dynam ic properties of the $\text{spin}(\frac{1}{2})$ isotropic X Y model on a square lattice. M any theoretical and numerical investigations concerning the thermodynam ic properties of this model have been performed until now³. Less progress has been made in the studies of its dynam ic properties. To exam the dynam ic properties of the model we use the two{dimensional Jordan{W igner fermionization⁴ {7 (for a brief review see Ref. 8) thus extending the approach which was previously applied mainly to the study of thermodynamics (see also several recent papers⁹ on calculation of the magnetization curves of some two{dimensional spin systems). More specifically, we calculate the two{site time{dependent correlation functions of z spin components and the corresponding dynamic structure factor S_{zz} &;!) for the spin{ $\frac{1}{2}$ isotropic X Y model on a spatially anisotropic square lattice. To trace a one{dimensional to two{dimensional crossover, we compare the results obtained with the corresponding ones for the spin{ $\frac{1}{2}$ isotropic X Y chain thus demonstrating the role of the interchain interaction for the dynamic properties of quasi{one{dimensional spin{ $\frac{1}{2}$ isotropic X Y systems. The recent study of the static properties of the square{lattice spin{ $\frac{1}{2}$ isotropic X Y model¹⁰ suggests that the approach based on the two{dimensional Jordan{W igner fermionization works well as long as the interchain interaction is small and it gives qualitatively correct results for larger values of the interchain interaction.

We consider a spin model consisting of N! 1 spins $\frac{1}{2}$ on a spatially anisotropic square lattice governed by the isotropic X Y H am iltonian

Here J 0 and J_? 0 are the exchange interactions between the neighbouring sites in a row and in a column, respectively. We are interested in the two{site time{dependent spin correlation functions $hs_{n,m}^{z}$ (t) $s_{n+p,m+q}^{z}i$ (the angular brackets denote the canonical therm odynamic average with the Hamiltonian (1)) and the zz dynamic structure factor

To calculate these quantities we use the two (dim ensional Jordan (Wigner transform ation) reform ulating

the problem in ferm ionic language. First we introduce the annihilation and creation operators of (spinless) ferm ion $d_{i;j} = e^{-\frac{i}{2}} d_{i;j} d_{i;j}$

Here $_k=\frac{q}{J^2\sin^2k_x+J_2^2\cos^2k_y}$ 0 is the ferm ion energy, $\cos\frac{k}{2}=\frac{q}{\frac{1}{2}+\frac{J_2\cos k_y}{2k}}$, $\sin\frac{k}{2}=\sin(J\sin k_x)$ of $\frac{1}{2}=\frac{J_2\cos k_y}{2k}$, and $\frac{k}{2}=\frac{1}{2k+1}$ is the Ferm i factor. It is useful to start the analysis of dynam ic properties by rem inding what is long known for the one { dimensional case. From the exact calculation for spin { $\frac{1}{2}$ isotropic X Y chain 11 we know that S_{zz} (k;!) at zero temperature = 1 is governed by a two { ferm ion excitation continuum with lower and upper boundaries J jsin k j and 2J jsin $\frac{k}{2}$ j respectively. The spectral weight is nite at the lower boundary. The lower boundary touches the line! = 0 at k = 0; 2 and k = (gapless modes). The spectral weight increases towards the upper boundary where S_{zz} (k;!) diverges. With the increasing temperature, the

lower boundary gets sm eared out and nally disappears, whereas the upper boundary remains unchanged. The described picture agrees with what we see from the greyscale plots of S_{zz} (k_x ;0;!) for $\frac{J_2}{J} = 0$:1 (Figs. 1a and 2a), i.e., for a system of almost noninteracting chains for momentum transfer along the chain direction. (The gap seen in Fig. 2a arises due to a nite interchain interaction: as J_2 ! 0 it shrinks and disappears.) For momentum transfer perpendicularly to the chain direction, the dynamic structure factor for a system of almost noninteracting chains disappears (Figs. 1b and 2b).

Let us pass to the two{dimensional case (the rest of the plots in Figs. 1, 2). Similar to the one{ dimensional case S_{zz} (k;!) within the framework of our approach is conditioned by two{fermion excitations and hence it exhibits nonzero values only within the restricted region having a sharp high{frequency cuto (evidently, S_{zz} (k;!) (3) equals to zero if the frequency! exceeds $2^p \sqrt{\frac{1}{J^2 + J_2^2}}$). Contrary to the one{ dimensional case, for which S_{zz} (k;!) is almost structureless within the excitation continuum (apart from the upper boundary singularities), S_{zz} (k;!) exhibits several washed{out excitation branches (modes). Consider at rst zero temperature. As it follows from Eq. (3), the {function (! $k_1 = k_2 + k_3 + k_4 + k_4 + k_5 + k_4 + k_5 + k$

This excitation is known as the spin wave³. Note, that since the derivative of the argument of {function with respect to k_{1x} tends to zero (except for $k_x = 0$; 2 if $k_y = 0$; 2 and vise versa) the peaks of $S_{zz}(k;!)$ along the line! $\binom{1}{k}$ (4) are expected. They are nicely visible in Figs. 1, 2.

It is easy to note that the branch which alm ost everywhere in the regions $(k_x; 0; !)$ and $(0; k_y; !)$ form s the upper boundary (see Figs. 1, 2) is given by

 S_{zz} (k;!) arises along the lines ! $_{k_x;0}^{(2)}$ and ! $_{0;k_y}^{(2)}$ (5) when it is conditioned by the two ferm ions with $\frac{k_x}{2}$;0, $\frac{k_x}{2}$;0 and $\frac{k_y}{2}$; $\frac{k_y}{2}$, $\frac{k_y}{2}$, respectively. There are other high { frequency excitations in Figs. 1, 2, conditioned by two ferm ions with k_1 = (0;0) and k_1 + k (k_y = 0) or with k_1 = $\frac{1}{2}$; $\frac{1}{2}$ and k_1 + k (k_x = 0), i.e.,

It is interesting to note, that the derivative of the argument of (! $k_1 = k_1 + k$) with respect to k_{1x} tends to zero at $k_x = \frac{3}{2}$; $\frac{3}{2}$ ($k_y = 0$) or at $k_y = \frac{3}{2}$; $\frac{3}{2}$ ($k_x = 0$) that manifests itself as the increase of spectral weight in these regions clearly seen in some plots in Figs. 1, 2.

In the low (tem perature lim it, because of the Ferm i factors, the (functions $(! k_1 + k_{1+k})$) and $(! + k_1 + k_{1+k})$ in Eq. (3) may contribute only if the energy of one of the two ferm ions equals to zero, i.e., if either $k_1 = 0$ or $k_{1+k} = 0$. As a result, we easily derive the lower boundary for the region of nonzero values of S_{zz} (k;!)

At high tem peratures, the Ferm i factors do not impose the mentioned restriction. Putting $k_{1x}=k_x$, $k_{1y}=\frac{1}{2}$ k_x for $k_y=0$ and $k_{1x}=k_y$, $k_{1y}=\frac{1}{2}$ k_y for $k_x=0$ we get

The excitation branch $\binom{5}{k}$ (8) contains most of the spectral weight at high temperatures (see Fig. 2).

Obviously in our analysis of S_{zz} (k;!) we focus mainly on the consequences presumed by the {functions involved in (3) om itting the precise examination of a role of the rest of the factors (e.g., of the Ferm i factors which controls a redistribution of the spectral weight as temperature increases). On the other hand, the results presented in Figs. 1, 2 (and Fig. 3) reject all those underlying features of Eq. (3).

In Fig. 3, we show the constant wave vector scans of zz dynam ic structure factor, i.e., the frequency dependence of S_{zz} (k;!) for certain wave vectors (the corresponding sections in Figs. 1, 2 can be easily located). All the discussed properties of S_{zz} (k;!) clearly manifest them selves in the depicted frequency proles which may be almost symmetric or asymmetric, resemble {peaks, result from two coalesced peaks or exhibit tails which gradually disappear or are abruptly cut o . We indicate by numbers j some well-pronounced peaks and cusps corresponding to the modes! $\binom{(j)}{k}$ (4) { (8).

To sum marize, we have presented the rst results for zz dynam ic structure factor of the spin $\{\frac{1}{2} \text{ isotropic}\}$ isotropic X Y model on a spatially anisotropic square lattice derived on the basis of the two $\{\text{dim ensional Jordan}\}$ Wigner ferm ionization. Our study has indicated excitations which govern the zz dynam ic structure factor.

The established modes may manifest them selves as peaks or cusps in frequency proles of S_{zz} (k;!) and may be used for determining the Hamiltonian parameters. (For example, the gap seen in Fig. 2a and Fig. 3e is controlled by $!_{k_x;0}^{(3)}$, $!_{k_x;0}^{(4)}$, and $!_{k_x;0}^{(5)}$, and, in particular, $!_{\frac{1}{2};0}^{(3)} = p \sqrt{J^2 + J_2^2} + J_2$, $!_{\frac{1}{2};0}^{(4)} = J$, and $!_{\frac{1}{2};0}^{(5)} = p \sqrt{J^2 + J_2^2}$ J_2 .) Thus, the theoretical result observed in our work should prove valuable in understanding the experimentally observable dynamic properties of two (dimensional spin ($\frac{1}{2}$ isotropic X Y materials. However, there are, to our knowledge, no experimental results yet available (therefore, no compound special caparameters were considered above) that enable a direct comparison between theory and experiment to be made.

It should be stressed that our results for the considered two (dim ensional spin model contains the exact ones in the one{dim ensional \lim it (after putting $J_? = 0$ or J = 0). On the other hand, our approach is approximate because of the mean { eld description of the phase factors which arise after ferm ionization. Such a treatm ent neglects the complicated interaction between ferm ions. It would be desirable to estimate the e ects of this simpli cation going beyond the mean (eld scheme for the phase factors. A possible test of the results for spin correlation functions is a comparison with the corresponding data of exact diagonalization and other num erical approaches. (Note, however, that the results reported in Refs. 3,10 refer to the in {plane spin correlation functions but not to the zz spin correlation functions which are di erent for the isotropic X Y model in contrast to the case of the isotropic Heisenberg model.) In the case of the isotropic Heisenberg model the interaction between ferm ions is present even within the adopted approximate procedure due to the (Ising) interaction of z spin components. The quartic terms in the ferm ion H am iltonian are treated after m aking further approximation⁵. One of the ways to proceed (the uniform ux solution) yields the same results for both the XY and Heisenberg models and from such a view point our results for the dynam ic properties may refer to the square { lattice spin $\{\frac{1}{2}\}$ isotropic Heisenberg model as well. However, as one can conclude from the studies reported in Refs. 5,6, a more sophisticated treatment of the ferm ion interaction inherent in the latter spin model (the in{phase ux solution, the Neel ux solution, the in{phase Neel ux solution} would be more appropriate. It seems obvious to extend the present investigation to the study of the square { lattice spin $\{rac{1}{2}\}$ isotropic H eisenberg m odel which is used for interpreting the data for corresponding compounds². It is interesting to note

that the recent neutron scattering studies on $C s_2 C u C l_4$ (the minimal model of this two{dimensional compound is the spin{ $\frac{1}{2}$ antiferrom agnetic Heisenberg model on a triangular lattice)¹² de nitely show a highly dispersive continuum of excited states. The conventional spin{wave theory clearly fails to account for the observed line shapes which do not show single particle poles but rather extended continua. We can also see some similarities at a qualitative level of the frequency properties of the present paper and in Fig. 3 of Ref. 12. However, we should bear in mind that $C s_2 C u C l_4$ is a triangular but not a square{lattice two{dimensional system and that the minimal Hamiltonian determining the magnetic order is the isotropic Heisenberg model but not the isotropic X Y model. New theoretical work is needed to elaborate the two{dimensional Jordan{Wigner fermionization results for this compound. A nother possible application refers to dynamics of spin{ $\frac{1}{2}$ ladders. Recently if the dynamic properties of the two{ leg spin{ $\frac{1}{2}$ ladder have been examined using the one{dimensional Jordan{Wigner fermionization. It seems interesting to compare these results with the corresponding ones which arise within the two{dimensional Jordan{Wigner fermionization approach.}
