# Soliton generation of tw o-com ponent Bose E instein condensates in optical lattices

#### Abstract

Coupled nonlinear Schrodinger equations (CNLS) with an extemal elliptic function potential m odel a quasi one\{dim ensional interacting two-com ponent Bose E instein condensate trapped in a standing light wave. N ew fam ilies of stationary solutions of the CN LS w ith a periodic potential are presented and their stability studied by direct num erical sim ulations. Som e of these solutions allow reduction to $M$ anakov system. From a physical point of view these solutions can be interpreted as exact $B$ loch states at the edge of the $B$ rillouin zone. Som e of them are stable while others are found to be unstable against $m$ odulations of long wavelength. The solutions which are $m$ odulationally unstable are show $n$ to lead to the form ation of localized ground states of the coupled BEC system .

## I. INTRODUCTION

Recent experim ents on dihute-gas Bose E instein condensates ( BEC 's) have generated great interest both from theoretical and experim ental points of view [1] [1]. At ultra-low tem peratures the $m$ ean- eld description for the $m$ acroscopic BEC wave-fiunction is constructed using $H$ artree Fock approxim ation and results in the $G$ rossP 计aevskii (GP) equation [III]. The latter one reduces to the one-dim ensional (1D) nonlinear Schrodinger ( $\mathbb{N} L S$ ) equation w ith an extemal potential, in particular, when the transverse dim ensions of the condensate are on the order of its healing length and its longitudinal dim ension is much longer than its transverse ones (see e.g. $\overline{[2}, \bar{\prime}, \overline{2}]$ ). This is term ed the quasi-one dim ensional (quasi1D) regim e of the GP equation. In this regim e BECs rem ain phase\{coherent, and the goveming equations are one-dim ensional.

Several fam ilies of stationary solutions for the cubic NLS w th an elliptic function potentialhavebeen recently
 ined using analytic and num ericalm ethods In the quasi-1D regim $e$, the GP equations for two interacting BEC's reduce to coupled nonlinear Schrodinger
 also Sec. 2 below). W hen the scattering lengths of the two com ponents, which characterize inter-particle interactions are close to each other, the CNLS equations reduce to the $M$ anakov system $w$ ith an extemalpotential.

[^0]In the present paper we study the stationary twocom ponent solutions of the CNLS with an extemal potential. Several cases of explicit solutions in term $s$ of elliptic functions are analyzed and their stability properties are studied num erically. In particular, w e derive a set ofstationary solutionsw ith trivialand non trivialphases. W e rem ark that som e of the solutions presented in this paper were also analyzed independently in Ref . [12]. In this w ork, how ever, allcom ponents of the CN LS were assum ed to be proportional to the sam e elliptic function. W e extend their results in the sense that we derive solutions of CNLS whose com ponents are expressed through di erent elliptic functions. W e also investigate the role played by these solutions as possible initial states from which localized $m$ atter $w$ aves (solitons) can be generated.

The paper is organized as follows. In section II we show how to derive one dim ensional equations for coupled BEC starting from the original three dim ensional problem using a multiple scale expansion in the sm all am plitude lim it. In section III we present exact solution of the CNLS system w ith non trivialphases, while in section IV we analyze their lim its (trigonom etric and hyperbolic). In Section V we derive stationary solutions with trivialphases forboth proportionaland non-proportional com ponents. In Section V I we discuss the physicalproperties of the trivial phase solutions and show, by $m$ eans of direct num erical sim ulations, how these solutions $m$ ay lead to the form ation of localized $m$ atter $w$ aves through the $m$ echanism of $m$ odulational instability. In section V II wew illdiscuss the present results in com parison w ith previous w ork and in Section V III the conclusions of the paper are brie y sum $m$ arized.

## II. BASIC EQUATIONS

At very low tem peratures, when the $m$ ean eld approxim ation is applicable, the evolution of tw o interacting BEC s can be described by tw o coupled G P equations ( $j=1 ; 2$ ) (see e.g. $[10,1,1])$

$w$ here atom ic $m$ asses of the both com ponents are assum ed to be equal, $\mathrm{V}_{j}(\mathrm{r})$ is an extemal trap potential, and $\mathrm{a}_{\mathrm{ij}}$ are the scattering lengths of the respective atom ic interactions (other notations are standard). In the case $w$ hen it consists of superposition of a $m$ agnetic trap providing cigar shape of the condensate (elongated, say, along the x -axis) and an optical trap inducing a lattioe potential (which is assum ed to be periodic along the x axes) one has ( $j=1 ; 2$ )

A though in the last expression w e have im posed equality of the optical potential for the both com ponents, in a general case one has to distinguish the linear oscillator frequencies, $!_{1}$ and $!_{2}$, when considering the tw o com ponents corresponding to the di erent $m$ agnetic $m$ om ents. For exam ple, in the experim ental settings of [13] w ith ${ }^{87} \mathrm{Rb}$ atom $\mathrm{s}=\frac{!_{2}}{!_{1}}=\overline{2}$. This fact has natural im plication on the resulting form of the e ective system of coupled 1D NLS equations. Indeed, di erent oscillator frequencies $m$ eans that tw o com ponents are located in two di erent parabolic potentials, and thus their e ective densities are di erent when the num ber of atom $s$ is equal. A s a consequence, even at approxim ately equals$w$ ave scattering lengths, and thus for $a_{11} a_{22}$, the two com ponents w ill experience di erent nonlinearities (the latter being proportional to the atom ic densities).

A nother im portant issue to be $m$ entioned here is that a cigar-shaped BEC can be viewed as a waveguide for m atter w aves. A s such it is characterized by its m ode structure. A s it is well known (c.f. w ith the nonlinear optical waveguides [14] $\underline{1}_{1}^{\prime}$ ) the intrinsic nonlinearity of a BEC results in the mode interaction (and thus energy distribution am ong $m$ odes). If how ever the nonlinearity is weak enough, the $m$ ain state of the condensate can be considered as a weakly m odulated ground state of the underline linear system. As it is clear that for a twocom ponent BEC the respective sm allparam eter is the ratio betw een the density eneqgy of tw o-body interactions, $\frac{4 h^{2} N_{j} a_{j j}}{m a_{j}^{3}}$ (hereafter $a_{j}=\frac{h}{m!_{j}}$ is the linear oscillator length and $N_{j}={ }^{R}{ }_{j}{ }_{j} f d r$ is the num ber of atom sof the jth com ponent) to the density of the recoilenergy $\frac{h^{2}}{2 m a_{j}^{2}}$. In other words the sm all param eter of the problem can
be identi ed as $=\frac{4 \mathrm{~N} a_{11}}{\mathrm{a}_{1}} \quad 1$ (where $\mathrm{N}=\mathrm{N}_{1}+\mathrm{N}_{2}$ is the total num ber of atom $s$ ). In this situation a selfconsistent reduction of the original 3D system [2, 2 the e ective 1D system of the coupled equations can be provided by $m$ eans of the $m$ ultiple-scale technique. Since the details of such a reduction have already published elsew here $\left[\begin{array}{c}3 \\ \hline 10\end{array}, 1\right]$ [15] for a single com ponent BEC , here we only outline the $m$ ain steps.

(i) 1. Then, the periodicity m odi es the spectrum of the underline system introducing the e ective group velocity dispersion. Resulting equations are just CNLS equations w thout periodic potential. This is the case sim ilar to one considered in [[] $[$ dr for the case of a singlecom ponent BEC.
(ii) (say ${ }^{2}$ ). In this case the periodic potentialcan be considered as sm oothly varying, and som ehow can be view ed as a lim it of the case considered below.
(iii) ${ }^{0}=$ where 1 . This is the case when the potential periodicity is of the order of the e ective length of the nonlinearity. Below we concentrate on this last case.

Follow ing [1] $\left.{ }^{1} 1\right]$ we refer to solutions in the cases $C_{j}=0$ and $C_{j} \in 0$ as to trivial and nontrivial phase solutions, respectively. W e notioe that nontrivial phase solutions im ply nonzero current of the $m$ atter \{ it is proportional to $\left.\dot{\mu}_{j}(x)\right\} \quad j x=C_{j}$, for each of the com ponents $\{$ along $x-$ axis, and hence seem to have no direct relation to present experim ental setting for BECs (rem em ber that the condensate is con ned to a parabolic trap). M eantime a system of coupled N LS equations appears to be a general m odel, having, for exam ple, applications in nonlinear optics (see e.g. [14]). Bearing this in $m$ ind we consider both types of solutions.

VI. M ODULATIONALINSTABILITYOF THE TRIVIALPHASESOLUTIONSAND LOCALIZED MATTER WAVESGENERATION

To discuss the stability of the above solutions we shall adopt a physical point. To this end we rem ark that all the trivial phase solutions, are periodic functions of period $t w$ ice the period of the lattice (recall that the period a ofpotentialin Eq ( 3 3, the com plete elliptic integral of the rst kind). T he corresponding wave-num ber of these solutions is $K=a$ which is just the boundary of the B rillouin zone of the uncoupled periodic linear system. M oreover, one can easily check that each com ponent $q_{i}(x), i=1 ; 2$; satisfy the Bloch condition

i.e. the trivial phase solutions are exact nonlinear B loch states (note that also in the nonlinear case the concept of a B loch state is well de ned by Eq. (6. $\overline{6} \cdot \overline{11)}$. A though nonlinearity does not com prom ise Bloch property (this being a direct consequence of the translation invariance

of the lattice), it can drastically in uence the stability of the states trough a m odulational instability $m$ echanism .

The possibility that localized states of soliton type can be generated from m odulational instability of B loch states at the edge of the $B$ rillouin zone, was analytically and num erically proved for a single com ponent BEC in
optical lattice, in the cases of one $\left[\begin{array}{ll}{[3} \\ ]\end{array}\right]$, tw o and three spatial dim ensions [15]. In order to explore the sam e possibility to occur also in the present periodic twocom ponents system we recourse to num erical sim ulations. To this regard we have used an operator splitting $m$ ethod using fast Fourier transform to integrate Eqs. (3.11), (32.2) $w$ ith initial condition taken as one of the exact solutions derived above $m$ odulated by a long wavelength $L$ ( $2=\mathrm{k} \quad=\mathrm{L}$ ) and m all am plitude sinusolidal pro le.

In $F$ ig. 1 we depict the initialpro les of the tw o com ponents $\mathrm{cn}-\mathrm{cn}$ solution plotted against the potentialpro le, while in Fig 2 we show the tim eevolution of the rst com ponent of this solution in presence of a sm allm odulation of the type :001 cos(:01x).

W e see that the pro le rem ains stable for long time (the sam e is true also for the other com ponent) indicating that the cn-cn solution is stable against sm allm odulations. W e nd that, except forthis, all the other solutions display m odulational instabilities out of which localized states em erge. T his is clearly seen in Fig. 3 where the tim e evolution of the unstable sn-sn solution is reported. N otice that in contrast with Fig 2 instability develops very quickly (already at time $t=10$ ), out of which two com ponents bright soliton states em erge, as clearly seen at tim et $=20$ (notice that the bright soliton consists of tw o coupled solitons (one for each com ponent) one bigger than the other.

In Fig. 4 and $F$ ig. 5 we show the tim e evolution of unstable sn-cn solutions $w$ th di erent am plitude ratio of

the sn and cn com ponents. In Fig. 4 the stable cn com ponent is larger than the unstable sn one, while in Fig. 5 we have the opposite. W e see that, although in both cases we have instability, the case w ith larger stable com ponent is obviously m uch m ore stable and lesse ective in creating localized states than the other. A lso notioe from

Fig. 4 that a sm all am plitude localized state is form ed from the sn com ponent at tim e $t=100$ in the $m$ iddle of the line which seem $s$ to have a character opposite to the one of the other com ponent. W e see indeed that when $m$ atter density is higher in one com ponent it is lower in the other, this suggesting a sort ofbright-dark coupling.

A better characterization of all possible states arising from the $m$ ixing of stable and unstable com ponents requires a $m$ ore accurate analysis. It is interesting to investigate also solutions involving dn com ponents since these, in contrast with sn and cn com ponents, have non zero spatial average, i.e. they are periodic waves on top of a constant background.

In Fig. 6 we depict the tim e evolution of a dn-dn solution from which we see that it ism odulationally unstable, leading to the form ation of brigth solitons of the sam e type observed for the sn-sn case. In $F$ igs. $7-8$ we depict sim ilar evolutions for the cases $\mathrm{dn}-\mathrm{sn}$ and $\mathrm{dn}-\mathrm{cn}$. A lso in this case we observe that the $m$ ixing $w$ ith the unstable sn com ponent is $m$ ore e ective than the one $w$ th the stable cn com ponent in creating localized excitations of soliton type (the three brigth solitons form ed in Fig. 7 at tim e t 10 rem ain equally spaced and well localized also on longertim es). By increasing the cn com ponent of the dncn solution of Fig.8, we also nd that the tim e evolution becom es $m$ ore stable, as discussed for the $s n$-cn case.

This analysis shows that the exact trivial phase solutions of the previous section are very usefil to create localized excitations of tw o com ponents BEC in optical lattice. The fact that these solutions are Bloch states at the edge of the B rillouin also suggests a way to create them in a real experim ent. O ne could indeed start from a uniform density distribution of the $m$ atter in the
potential wells, and accelerate the lattice until the state reaches the edge of the $B$ rillouin zone where the $m$ odulational instability take place.

V II. D ISC U SSIO N S

In this section we brie $y$ discuss the above results in com parison with those of Ref [12 $\left.{ }^{2}\right]$ in which an $n$ -
com ponent N LS-type equation with extemal potential, whose strength can be di erent for each com ponent, was also considered. Changing som ew hat notations to avoid confusion w ith ours we write it down in the form :

In Ref. $\overline{[1} \overline{2} \overline{1}]$ three types of trivial phase solutions are analyzed in $m$ ore details for a rather special ansatz for $j ;$ in fact it is required there that all $j$ up to a standard phase factor are proportional to the sam e function $(\mathrm{x} ; \mathrm{k})$. This $m$ eans that the system s of n equations w ill reduce to just one equation for ( $\mathrm{x} ; \mathrm{k}$ ); the rem aining n 1 equationsmust follow as a consequence of the rst one and a set of constraints on the coe cients a ${ }_{j 1}, \mathrm{~N}_{j}$, ${ }_{j},!j$ in the notations of $[121]$. The sam e argum ent holds true also for three of our solutions, cases 6, 7 and 8 which we added just for the sake of com pleteness.

which describes the dynam ics of the e ective eld ( $x ; t$ ). $T$ he result for the trivialphase solution case leads to $H$ red
w ith $\mathrm{M}_{1}=0$. That is why we believe that the m ulticom ponent e ects should be analyzed by using ansatz $m$ ore general than (7, 7 ).

At the same tim e an im portant result of [12] is the detailed, both analytical and num erical, analysis of type B solutions to (7.1) though again using (7.4).

In the present paper we considered intrinsic twocom ponent solutions i.e. solutions $w$ th di erent am plitudes. These solutions seem $s$ to have stability property which are not trivial consequence of the theorem s proved in [12'1] and deserve additional studies. B esides en larging the set of solutions, we have also shown the role played by these solutions as initial states from which localized $m$ atter waves (solitons) can be generated through the m odulational instability m echanism .

## V III. C O N C LU S IO N S

In conclusion, we have considered the two-com ponent CNLS w th an elliptic potential as a m odel for trapped, quasi-one-dim ensional tw o-com ponent BEC s. C lasses of elliptic, solitary w ave and trigonom etric solutions have been presented.

From a physical point of view the solutions discussed in this paper are exact nonlinear B loch states w th w ave num ber at the edges of the $B$ rillouin zone. These solutions, exœept for the cn cn one, are unstable under sm all am plitude and large w avelength m odulations. Two com -
ponent $m$ atter solitons arise from these unstable solution via a m odulationalinstabilitym echanism which resem ble the one described in Refs. $\left[\frac{3}{3}, 1,11_{1}^{\prime}\right]$ for single com ponent BEC in optical lattices.

Further perspectives of nding stable periodic solutions to the 2 -com ponent problem could be linked to investigations of nite-gap solutions of $M$ anakov system given in term sofm ulti-dim ensional -functions [1] ] and [1] ${ }^{\prime}$ ] and to reduction of nite-gap solutions to elliptic functions [1d]. Interesting classes of periodic solutions can be also obtained as the result ofreduction of the $M$ anakov system to com pletely integrable tw o-particle system
