# A sym m etric Lineshape due to Inhom ogeneous B roadening of the C rystal-Field Transitions in M n<sub>12</sub>ac Single C rystals

The lineshape of crystal-eld transitions in single crystals of M  $n_{12}$  ac molecular magnets is determ ined by the magnetic history. The absorption lines are symmetric and G aussian for the nonmagnetized state obtained by zero-eld cooling (zfc). In the magnetized state which is reached when the sample is cooled in a magnetic eld (fc), however, they are asymmetric even in the absence of an external magnetic eld. These observations are quantitatively explained by inhom ogeneous symmetrical (G aussian) broadening of the crystal-eld transitions combined with a contribution of o -diagonal components of the magnetic susceptibility to the elective magnetic permeability.

#### I. IN TRODUCTION

The high-spin magnetic cluster of M  $n_{12}ac$  (which stands for M  $n_{12}O_{12}$  (CH  $_3COO)_{16}$  (H  $_2O)_4$ ] 2CH  $_3COOH$  4H  $_2O$ ) is the prime example of single-molecule based m agnets which reveals number of interesting phenom ena like m esoscopic quantum tunneling of the magnetization and quantum phase interference  $^{1,2,3,4,5,6}$ . Over a wide range the properties of M  $n_{12}ac$  are determined by the splitting of the crystal eld (CF) of the S = 10 ground multiplet described by the spin H am iltonian  $^{7,8,9,10}$

where the st three terms represent the crystal eld and the last one the Zeem an energy in a magnetic eld H. The large single-ion anisotropy with an energy barrier of

65 K is produced mainly by the axial term  $D S_z^2$  with D < 0. The magnetization M of the cluster is stabilized along the fourth order  $C_4$  symmetry axis. At low tem – peratures resonant tunneling through the energy barrier is possible if the energy levels on both sides coincide<sup>3,4,5</sup>.

In the last years the structure of the energy levels of the ground state multiplet of M n<sub>12</sub>ac and the parameters of the e ective spin Ham iltonian (1) were studied by EPR measurements<sup>7,8</sup>, inelastic neutron scattering<sup>9</sup> and quasioptical magnetic spectroscopy<sup>10,11,12</sup>. Currently much attention is devoted to the shape and width of the absorption lines (CF transitions) which may provide a deeper understanding of the mechanism s of quantum tunneling in real crystals of molecular magnets. The Gaussian lineshape found at zero eld<sup>1,12</sup> directly indicates an inhomogeneous character of the line broadening due to a distribution of intra-crystalline interactions, in particular, magneto-dipolar and crystal elds. Detailed EPR investigations<sup>13,14,15,16</sup> of various contributions to the line broadening (distribution of the crystal elds, g-factors, dipolar elds) revealed an important role of the CF distribution coming from local strains (D-strain). In addition, the asymmetry of the EPR lines was attributed<sup>17</sup> to the distribution of the easy-axis

orientation. In particular, dislocations in real crystals were suggested to cause a distribution of crystal edds which strongly in uences the mechanism of quantum tunneling<sup>18</sup>. We have applied a novel type of magnetic spectroscopy to study the in uence of the inhom ogeneous broadening on the lineshape of magneto-dipolar transitions in M  $n_{12}$  ac which allowed us to reveal new features and to advance an alternative explanation.

#### II. EXPERIMENTAL RESULTS

A few dozen of M n<sub>12</sub>ac single crystals of typically 1 to 2 mm in size were aligned to a mosaic of about 0.5 mm thickness and 7  $7 \text{ mm}^2$  area such that the C<sub>4</sub> axes of the crystals lay in the plane of the plate and were parallel to each other (to an accuracy better than 3). U sing a frequency-dom ain magnetic spectroscopy<sup>19</sup>, we studied the magnetic absorption by measuring the optical transmission coe cient in the frequency range from 8 to 18 cm<sup>-1</sup>. The experiments were performed at tem – peratures T = 2.33 K in a magnetic eld H up to 7 Tesla which was oriented perpendicular to the magnetic eld vector h of the radiation propagating with the wavevector q along the y-direction (Voigt geom etry: h k x, q k y, H k z k C<sub>4</sub>).




FIG.1: Magnetic absorption due to the j 10i ! j 9i crystal-eld transition of M  $n_{12}$  ac single crystals as observed in the transmission spectra at T = 2.33 K without external magnetic eld. In one case (zfc) the sample is cooled down without applied magnetic eld, in the other case (fc) it is cooled in a magnetic eld of 1 T which was subsequently switched o. The solids lines represent the calculations using a single Gaussian line and an elective susceptibility as described in the text.




FIG.2: Absorption of the j 10i! j 9i crystal- eld transition in M  $n_{12}$  ac single crystals at T = 2:33 K measured by transmission at di erent magnetic elds. The lines represent the calculations using a single G aussian term and an elective susceptibility.

The two transm ission spectra plotted in Fig.1 show the j 10i! j 9i transition measured at T = 2.33 K with no external eld present: H = 0; note that this corresponds to a real zero- eld EPR experiment. In one case (non-magnetized, zfc state) the sample is cooled down without applied magnetic eld, in the second case (magnetized, fc state) the crystals are cooled from 40 K in a eld of 1 T (parallel to  $C_4$ ) which was subsequently switched o . In fc crystals the resonance frequency is shifted up by 0.1 cm<sup>-1</sup> and the lineshape is signi cantly asymmetric, with the slope sm oother on the left (low-frequency) side. Applying a magnetic eld parallel to the  $C_4$  axis of the fc crystals increases the transition frequency as displayed in Fig. 2; the lineshape remains asymmetric similar to the H = 0 case.

## III. ANALYSIS

For a quantitative description of the spectra we have to consider the radiation propagating along z axis through a transversely m agnetized medium (hkx; eky), whose optical response is determined by an elective magnetic perm eability<sup>20</sup>

and thus depends on both diagonaland o -diagonalcom - ponents of the magnetic permeability  $_{ij}()$  or susceptibility  $_{ik}()(_{ik}() = 1+4 _{ik}())$ , where the latter are sensitive to the magnetic state of the sample (fc or zfc). For low temperatures only transitions from the ground state to the rst excited state j 10i! j 9i contribute to the susceptibility

where  $h_{10} = E_9$   $E_{10} = h_{10}^0$   $g_B H_z$  are the transition frequencies between the corresponding states on one (+) or another (-) side of an an isotropy barrier. Here  $h_{10}^{0} = 19 \left[ D + D_4 \left( 10^2 + 9^2 \right) \right]$  is the zero-eld frequency and  $_{10} = 2N (g_B h 10 f_x p i)^2 (_{10}$  $_{9}$ )=h  $_{10}$  are the contributions to the magnetic susceptibility due to the corresponding transitions, N is the particle density, and m is the population of the energy levels  $E_m$  which are given by the Boltzmann factor  $_m$  = expf  $E_m = k_B T g = expf E_n = k_B T g$  in an equilibrium state. The lineshape functions R  $_{\rm 10}$  ( ) R<sub>m</sub> ( ) m ay be either Lorentzian  $R_{\,m}$  ( ) =  ${2 \atop m}/$  (  ${2 \atop m}$ <sup>2</sup> + i m), or Gaussian<sup>11</sup> with the imaginary part

In a nonm agnetized state, when the population is the same on both sides of the barrier,  $_{+10}$   $_{10}$ , and the o -diagonal components of the susceptibility vanish  $_{\rm xy,yx}$  () = 0, the elective permeability is given by

where the diagonal susceptibility component  $_{2}$  () is determined by Eq. (3) for  $_{+10} = _{10}$   $_{10}=2$  and  $R_{+10} = R_{10}$ . In a magnetized state ( $_{+10}$  1,  $_{10}$  0)

where  $_{?}() = _{+10}R_{+10}()$ . For H = 0 the functions  $_{?}()$  in the Eqs. (6) and (7) coincide and the di erence between zfc and fc perm eability is mainly determ ined by the denom inator  $1 + 4 _{?}()$  in Eq. (7).

As shown in Fig. 1 by the solid lines, we can nicely tour experimental results for both the fc and zfc states

by using the expressions for the transmission coe cient of a plane-parallel layer<sup>21</sup> and a Gaussian lineshape entering for R ( ) in  $_{?}$  ( ). The main parameters, the CF resonance frequency  ${}^0_{10} = 10.002$  cm  ${}^1$ , the Gaussian linewidth 10 = 0.095 cm<sup>-1</sup> (corresponding full width at the half of maximum  $_{10} = 2^{1} 2 \ln 2_{10}$ 0.224 cm  $^{1}$  ), and the contribution to the permeability  $_{10} = 4$   $_{10} = 0.076$ , were found by thing only the zfc data<sup>22</sup>. The calculated spectra reproduce both, the upward shift of the resonance frequency and the asymmetry of the lineshape in the fc state. The increase of the resonant frequency from the value 10 in  $e_{10}$  (1 +  $_{10}$ ) in the fc state is mainly zfc state to due to the change of the e ective permeability since the o -diagonal term of the susceptibility becomes signi cant. A slight renorm alization of the resonance frequency  $he_{10} = h_{10} + g_{B_k} M_0$  in the fc state is caused by the weak internal dipolar magnetic eld; from our twe obtain <sub>k</sub>M <sub>0</sub> 265 Oe (i.e. g  $_{\rm B}$   $_{\rm k}$ M  $_{\rm 0}$  $0:024 \text{ cm}^{-1}$ ), where M  $_0$  is the magnetization<sup>23</sup>. The above statement concerning the shift of the resonance frequency in the fc state is true both for Lorentzian and G aussian lineshape. For the change of the shape, how ever, it is essential that the lines are inhom ogeneous broadened and have to be described by Gaussian lines.




FIG.3: M agnetic absorption spectra  $^{00}$  at zero m agnetic eld (H = 0) for the eld-cooled (fc) state of M n<sub>12</sub>ac. The calculation compare G aussian with Lorentzian lineshapes of the j 10i! j 9i crystal eld transition.

In Fig. 3 the imaginary part of the permeability spectrum  $_{0}^{00}$  () (which describes the magnetic absorption) in the fc state is calculated assuming a Gaussian and a Lorentzian lineshape  $R_m$  (). It is clearly seen that the line becomes asymmetric only in the case of the Gaussian lineshape while for the Lorentzian case it remains symmetric. This important result is connected to the fact that for a Lorentzian lineshape  $R_m$  () in the Eq. (7) only the resonant frequency and the contribution ("strength") are renormalized, while the overall frequency dependence of  $_{e}$  () remains unchanged, i.e. Lorentzian<sup>24</sup>. In the

case of inhom ogeneousely broadened (G aussian) lines, their shape is disturbed<sup>25</sup>. Our approach also explains the asymmetric lineshape for nite magnetic elds, as demonstrated in Fig. 2 where the solid lines correspond to calculations using g = 1.93 and the aforem entioned parameters.

## IV. D ISC U SS IO N

An asymmetricalEPR lineshape of Mn<sub>12</sub>acmagnetodipolar transitions was reported in<sup>16</sup> and was explained subsequently<sup>17</sup> by random distributions not only of the D parameter of the crystal eld but also of the easyaxis orientation. In this case, however, the asymmetry should vanish in zero magnetic eld which is in contradiction to our present observations. Hence, the asymmetry of the lineshape can in principle not be connected with the distribution of the easy axis but rather is determ ined by a distribution of the zero-eld resonance frequencies. It should be noted that the experimental measurement geometry (Voigt con guration) is of crucial importance<sup>25</sup>. Since regular EPR experiments are performed at xed frequencies as a function of applied magnetic eld { in contrast to our experiments which are conducted at xed ( nite or zero) magnetic eld as a function of frequency { the smaller slope is found on the right (high-eld) side relative to the resonance eld as reported by H illet al.<sup>16</sup>. A ssum ing that the m ain contribution to the observed linew idth is given by the dispersion of the crystal eld D and taking into account that  $_{10} = _{10} = D = (D + 181D_4)$ D=D, we obtain 0:01D which is half the value estimated  $in^{16}$ . D

Recently it was shown<sup>26</sup> that a disorder of the acetic acids of crystallization induces di erent CF distortions at the M n<sup>3+</sup> ions positions; as a result six di erent isomers can be found. The estimated CF parameters D (n) for the most populated isomers are -0.769 K, -0.778 K and -0.788 K for n = 1;2;3, respectively<sup>26</sup>. The relative di erences  $\frac{1}{D}$  (2) D (1)  $\frac{1}{D}$  (2) = 0.0115 and  $\mathcal{D}$  (3) D (2)  $\neq$  D (2) = 0.0128 agree very well with the CF distribution obtained from the linew idth. A simulation of the observed fc and zfc spectra by three narrower G aussians lines, corresponding to the three isom ers with the given concentrations, provides an excellent description of the whole lineshape (not shown). A coording to Comia et  $al^{26}$  the CF distortions in the M  $n_{12}ac$  isom ers are accom panied by an appearance of a second-order transverse CF term E  $(S_x^2 - S_v^2)$  which is responsible for the tunnel splitting and increase of the relaxation rate. The correlation between D and E term s opens a possibility to observe an inhom ogeneous relaxation of the spectra inside the line in a long-living non-equilibrium state created by magnetic eld inversion<sup>7</sup>.

In summary, using high-frequency magnetic spectroscopy we discovered a dependence of the frequency and lineshape of the magneto-dipolar transitions in  $M n_{12}ac$  on the magnetic history of the sample. Zero-eld

cooled samples show a symmetrical Gaussian lineshape of the S = 10 ground multiplet transition j 10i! j 9i. If the sample was previously cooled in magnetic eld, the line becomes asymmetric and shifts up in frequency by about 0.1 cm<sup>-1</sup> even for H = 0. These observations are explained by an inhom ogeneous (Gaussian) distribution of the resonant frequencies taking into account the e ective susceptibility of the transversely magnetized medium which includes o -diagonal components and the internal magnetic eld. We quantitatively describe the absorption seen in the transmission spectra for both H = 0 and H  $\leq$  0 and determined the main characteristics of
