Continuous M easurem ent of A tom -N um ber M om ents of a Bose-E instein C ondensate by Photodetection

W e propose a measurem ent scheme that allows determ ination of even-moments of a Bose-E instein condensate (BEC) atom number, in a ring cavity, by continuous photodetection of an o -resonant quantized optical eld. A fast cavity photocounting process limits the heating of atom ic samples with a relatively small number of atoms, being convenient for BECs on a microchip scale applications. The measurement back-action introduces a counting-conditioned phase damping, suppressing the condensate typical collapse and revival dynam ics.

The recent achievem ent of Bose-E instein Condensates (BECs) trapped near the surface of magnetic microchip traps [1] has led to a new prom ising system for the developm ent of em erging technologies based on BECs, such as trapped-atom interferom etry [2] or atom -based quantum inform ation processing $(Q \cup \mathbb{P}) \mid \beta$, due the high degree of controlachieved over the atom ic sam ple. A fundam ental issue for in plem enting those technologies on a chip scale though is the achievem ent of a non-destructive m easurement of the BEC properties. Particularly, QUIP calls for high precision non-destructive detection of the BEC atom number [3], which has proven to be a hard task, attracting considerable attention [4[6].

Since the very early experiments with diluted trapped neutral atoms [7], the BEC dynamics monitoring has been achieved either by absorption or dispersive in aging [8]. Absorption in aging has the counter-e ect of heating up the condensate, precluding it for latter usage (destructive regime). On the other hand in dispersive imaging the small phase-shift su ered by the far-detuned probe light is compensated by a high intensity. Residual incoherent R ay leigh scattering heats up the atom ic sam ple through spontaneous em ission atom ic recoil, preventing a non-destructive regime as well [8] for the reduced number of atom s in m icrochip BECs (10⁴) [1]. Thus, it is certainly worthwhile to propose alternative schemes of atom detection that besides being non-destructive to som e extent, could also be useful for feedback and control of the condensate – a valuable resource for $Q \cup \mathbb{P}$.

In this Rapid Communication we investigate the inform ation extracted about a BEC atom number through probe-eld continuous photodetection. Previous treatments on BEC continuous measurements have been described in Refs. [9{12], di ering considerably from our approach and goals. We consider a BEC trapped inside a ring-cavity fed by two resonant (orthogonaly polarized) propagating elds - an undepleted probe and a weak quantum probe eld (Fig.1). The presence of the undepleted pumpel eld allows that the moments of the detected probe eld photon num ber give direct inform ation about even-m om ents of the BEC atom num ber. M oreover, since the condensate atom number inform ation is carried by the probe eld photocounting statistics, there is no need for a strong probe eld, avoiding thus heating during the m easurem ent process. F inally, we discuss how the detection back-action induces phase uncertainty to the condensate state, suppressing its original collapse and revival dynam ics.

The system, depicted in Fig.1, consists of a Schrodinger eld of bosonic two-level atom swith transition frequency o interacting via electric-dipole with the two singlem ode orthogonally polarized ring-cavity probe and pum p elds of frequencies 1 and 2, respectively, both being far-o resonant from any electronic transition (Calculation details given in [13]). The eigenstates for the atom s are denoted by $\frac{1}{1}$ is $\frac{1}{1}$ whose values are dependent on the trapping conditions. For an atom ic cbud well localized both longitudinally and transversally relative to the cavity round-trip (L) and to the cavity eld beam waist (S), respectively, the eld can be assum ed uniform in its vicinity, such that the coupling between atom s and pump and probe elds is approxim ately constant. In the far-o resonance regime the k-excited state population is negligible, and the collision between

excited atom s, and between the excited and the ground state atom s can be neglected. In a rotating referential with the frequency $_2$ the H am iltonian writes

where $k = l_k + and = 2$ 1, being = 0 2 is the detuning between pump and atom . q_k and a_k are the annihilation operators for atom swith k in the ground and excited state, respectively, and is the collision strength between ground state atom s. The third term in the RHS of Eq. (1) is the interaction between the atom s and the probe (b_1) and pump (b_2) elds (with coupling constants g_1 and g_2 , respectively), whose wave vectors $k_{1(2)}$ must satisfy $k_{1(2)} j= 2$ n=L, with n integer. The in-cavity probe eld is related to the input eld (b_1^{in}) by $b_1 = T_0 b_1^{in}$ (neglecting uctuations), where T_0 is the mirror 0 transmission index. The eld b_2 external pumping is given by the last term of (1), where F j is the external resonant driving eld strength. If the pum p beam cavity-loss is considerably higher than the coupling constants the pum p average photon num ber can be kept constant (undepleted), due to the pum p-loss com petition. This assumption allows the pumpeld to be treated as a c-num ber, and also avoids the atom ic sample heating through residual incoherent Rayleigh scattering by setting a low steady pump intensity. Since we also require that the probe eld loss rate is smaller than the photocounting rate, the pump is set to a k-polarization (to the table top) while the probe is set to a ? -polarization. The cavity mirror 1 thus must have distinct re ection R_1^k . A sum ing the bad-cavity limit for ion $(\frac{k}{inc} = \frac{jg_1\hat{f}}{k}; \frac{jg_2\hat{f}}{inc})$, with $\frac{k}{inc}$ / indexes R 1 the k-polarization ($_{inc}^{k}$ $T_1^k = 1$ R_1^k and the atom ic spontaneous emission rate, the pum p eld can be adiabatically elim inated such that b_2 can be replaced by $iF = \frac{k}{inc}$. Remark that the probability of atom ic spontaneous em ission (Pe) is also reduced inside resonators [4,14] with high nesse F, since the per photon probability of spontaneous em ission goes with ${\rm P}_{\rm e}$ / ${\rm F}$, and the required num ber of the probe beam photons for reliable detection is N / F 2 , thus the total num ber of spontaneous scattering events is N P $_{\rm e}$ / F $^{-1}$ [4].

In the lim it of large detuning $jg_i = j$ 1; i = 1;2 and $!_k = 1$, $_k$ [15]. Thus atom ic spontaneous em ission can be neglected and the excited states operators a_k are elim inated adiabatically resulting in the follow ing effective ham iltonian

 $igF = {k \atop inc}$ is the elective coupling, and we where q_{e} have de ned b₁ b. H am iltonian (2) is the prototype for atom -optic param etric am pli cation [16], where atom s in the ground state are transferred to side m odes states. However, we are interested in the situation where no optical inter-m ode excitation occurs. In the ring-cavity arrangement $k_{1(2)}$ (with $j_{k_{1}(2)}j = 2$ n=L) are both colinear to the longitudinal dimension of the condensate ${\rm L}_{\,\rm c}$, which is taken to be very small compared to the cavity round-trip length L. Thus hk je^{i(k1 k2) r}jli k;l whenever 2 nL_c=L ! 0, and no inter-m ode excitation occurs. This embodies the specic case of k₁ k₂ (and thus = 0), which we consider hereafter. To simplify we further assume a pure condensate with all atoms in the com ode, the ham iltonian nally reduces to

In (3) we identify two regimes in the interplay between the pump and probe elds strength: (i) W henever $j_{2}=g_1 j$ 1 the strongest contribution is from the quantum probe eld, including the situation without the classical pump-eld; (ii) otherwise the classical pump eld has an important contribution to the elective ham iltonian. Remark from (3) that the condensate atom number $n_0 = c_0^y c_0$ is a non-dem olition variable. By varying $\mathbf{F} = k \mathbf{j}$ and thus j_{2} jdistinct regimes of quantum nondem olition couplings [17{19}] are attained. For $j_{2}=g_1 \mathbf{j}$ 1 the nondem olition regime corresponds to that considered in Refs. [10,11] for BECs atom number nondem olition measurement, while for $j_{2}=g_1 \mathbf{j}^{>}$ 1 features sim ilar to the photon number nondem olition measurements discussed in Ref. [20] are added.

Now we turn to the photodetection process. To simplify the photocounting modelling [21] we rstly assume that no other incoherent process, such as ?-polarized photon losses, considerably a ects the the probe eld dynamics over the counting time interval. That means to assume $\stackrel{?}{_{\rm inc}}$, where is the eld vective cavity photodetection rate given by T_2^2 , where T_2^2 is the mirror 2 transmission coelected as the eld of the section of the section

eld photodetection rate, neglecting output eld uctuations [13,22]. The counting of k photons from the probe eld in a time interval t can be characterized by the linear operation $N_t(k)$ [21], acting on the state of the system as ^(k) (t) = $N_t(k)$ (0)=Tr $N_t(k)$ (0)] where (0) is the joint state of the condensate and the probe eld prior turning on the counting process, with probability P (k;t) = Tr $N_t(k)$ (0)]. The operation $N_t(k)$ is written as

where $S_t = e^{Y t} e^{Y^y t}$, with $Y = \frac{i}{h}H$ R=2. H is the system Ham iltonian, and R = $b^y b$ is the counting rate operator. As such J b b stands for the change of the probe eld due to the loss of one counted photon, while S_t is responsible for the state evolution between counts.

From Eq. (3) Y becomes

h i and $_{\rm m}$! $_0 + \frac{jg_2 f}{f} + (m 1)$ m is a phase introduced by the atom ic collision process and the classical pump. The last two terms of $_{\rm m}$ (t), Eq. (8), besides a direct collision process also include the terms $jG_{\rm m} f$ and $G_{\rm m} = m^{\rm t} 1$, which are originated by the pumpeld, inducing a collision-like behavior, with di usion of the condensate state phase.

The probability to count k photons during the time intervalt is given by

In regime (i), $\mathfrak{g}_2=\mathfrak{g}_1$ 1, the counting probability (9) reduces to the Poisson distribution

independently of the condensate state and the atom eld coupling as well. The r-m om ents of P (k;t) for this regime are $k^r = j f(1 e^t)^r$, and simply relate to the probe am plitude. However in regime (ii), Eq. (9) m ust be fully considered, and the condensate state is relevant for the photocounting probability distribution. Thus inference about the condensate atom num ber m om ents can be given by the photocounting distribution. The r-m om ents of (9) are

and the even-m om ents of the condensate atom -num ber are directly given by the m om ents of the num ber of photocounts. Particularly, for a BEC in a Fock state \overline{k} gives a null-uncertainty measure of the condensate hn_0i .

In the opposite lim it, $\frac{1}{2}$ $j^{g_1} j^2$, the photocounting moments give

and thus the elds strength ratio is dynam ically probed in situ, while the condensate is inside the cavity, by the determ ination of the average number of counted photons at the slow rate $\frac{1}{2}$ $\int_{-}^{g_1} f$.

The important time scale parameter for determination of the condensate atom number even-moments by photocounting is the e ective photocounting rate . Since the undepleted classical pump eld approximation is valid only in the k-polarization bad-cavity lim it ($_{inc}^{k}$ $\frac{jg_1 \hat{f}}{k}; \frac{jg_2 \hat{f}}{k}$) we must also have \lim_{inc} . The ability to build-up a ring cavity with high nesse at the microchip surface could represent a restriction, but recent e orts have been made in the study of properties of ultra cold atom ic sam ples inside a ring cavity, which could attain nesses as high as 170000 [14]. In fact, a high nesse cavity is necessary only when the small phase shift has to be compensated by a large intensity eld, such as in dispersive imaging, since information about the BEC is carried by the probe eld phase. However, in our proposal the pump and probe intra-cavity elds can be both set at low intensity, which limits the effects of incoherent Rayleigh scattering through spontaneous em ission during the photocounting period. If every atom ic spontaneous em ission heats the condensate in about an atom ic recoil energy E_R , we can estimate the total heating due the fraction $N_e = P_e hn_0 i$ of atom s su ering spontaneous em ission, where $P_e / = 2$ is the per photon spontaneous em ission probability in the faro resonance regime with the intra-cavity spontaneous emission rate . The BEC heating due the interaction with the probe light with $I = hb^{y}bi$ photons amounts to T / 2E _R Ihn₀i = $3k_B$ ². For the regime of $\frac{1}{2}$ of optim al detection of the atom number moments we can set a limiting such that the heating is negligible, <u>ġıŤ,ġzŤ</u> _{inc}. Since i. e, by considering in c in c $= T_2^2$, the above lim it can be conveniently reached with a high ? -transm ission coe cient m irror and a reasonably fast photodetector.

D espite the heating process being negligible there will always be a back-action on the condensate state due the continuous measurement process. Only if the condensate is initially in a Fock state, an eigenstate of the nondem olition variable, is that the condensate will evolve freely independently of the counting probability. The same is valid for the diagonal elements of the unconditioned state,

since hm j_c(t) in $i = jC_m \hat{f}$. The o -diagonal elements of Eq. (15) are evidences of back-action over the condensate state phase. O byiously this im plies that a conden-

sate in a completely mixed state will not suler the backaction elects. Any other condensate state will be a lected by the collision-like terms $jG_m \ f$ and $G_m \ m$ e $m^t \ 1$ from Eq. (8). The counting process induces an irreversible phase-damping, inhibiting the well known coherent collapse and revival dynamics of the condensate state [23]. Interestingly though, the k-counts conditioned phase damping does not appear when no photons are detected, k = 0, and the BEC state evolves with its typical collapse and revival dynamics.

In conclusion, we have investigated the measurem ent over the BEC inside a ring cavity that can be achieved through continuous photodetection of a quantum probe eld. Even-moments of the condensate atom number can be inferred by the probe eld photodetection probability distribution whenever the photodetector counting rate follows $\frac{1}{2}$ $j^{g_1} f$. A loo if those rates are higher than the atom ic spontaneous em ission rate the condensate heating will be prevented. A lthough atom num ber is a QND variable, there is a back action on the condensate state due to the counting process, inducing phasedam ping over the condensate state whenever photons are counted. The strong dependence of the photocounting probability distribution with the BEC original state suggests that this measurem ent scheme can be a useful resource for feedback and control of atom ic sam ples. Further investigation on those issues form on itoring of crosscorrelation between atoms and light elds together with calculations on signal to noise ratio, as well as a measurement resource for atom based quantum information processing will be addressed elsewhere [13].

As far as we know, it is still unknown whether surface interactions reinforced by the cavity will introduce noise limiting the detection process. Besides technical problem s yet to be solved for cavity quantum electrodynam ics im plem entation on m icrochips [4], we believe that the above proposal could be im plem ented, in principle, due the rapid advance on experim ental research.




FIG.1. BEC in a ring cavity setup. The pump (F) and probe $(b_1^i n)$ input elds are k and ? -polarized, respectively. M inror 1 and 2 re ectivities are polarization selective, in order that the in-cavity pump probe is heavily dam ped at m irror 1, while the transm issivity at m irror 2 allows that BEC properties be determ ined by the probe eld photocounting at the m irror 2 output.
