Universal Thermal Radiation Drag on Neutral Objects

A bstract

We compute the force on a small neutral polarizable object moving at velocity \mathbf{v} relative to a photon gas equilibrated at a temperature \mathbf{T} We nd a drag force linear in \mathbf{v} . Its physical basis is identical to that in recent formulations of the dissipative component of the Casim ir force. We estimate the strength of this universal Casim ir drag force for dierent dielectric response functions and comment on its relevance in various contexts.

The residual drag force on an AFM tip close to, but not in direct contact with a substrate in vacuo raises an important and fundamental question on the origin of non-contact friction [1]. O ther experimental techniques also are sensitive to non-contact friction [2]. Since it became clear that the Casimir ect, being par excellence a non-contact phenomenon, can lead to a dissipative drag (see [4] and references therein), it has become a primary focus of theoretical research [3]. Such Casimir dissipative drag occurs when electromagnetic eld uctuations equilibrate in a specience frame, relative to which another system (e.g. a dielectric or a conducting body) is in uniform motion [4, 5, 6]. The dierence between the frames of reference in the dissipative Casimir ect can be due to relative motion of dierent bodies, as for two conducting plates with relative motion in the parallel direction, or for a neutral body moving relative to a conducting plate [7, 8, 9, 10, 4, 11]. In these cases the radiation equilibrates in one of the plates, and the friction depends upon the proximity of the other one.

We show here that such friction can also come about when a single body moves relative to a therm albath of the electrom agnetic eld excitations, such as those between the walls of an oven or in the cosm ic microwave background. The friction has no position

dependence, i.e. it is spatially hom ogeneous. The consequence is a universal dissipative drag acting on all matter in relative motion with respect to a thermalized photon gas. To estimate the magnitude of this universal drag we evaluate it as a function of the dominant frequency of the electromagnetic response of the body for dielectrics and conductors.

Consider the Lorentz force

on a dielectric in a eld E (r;t); B (r;t). The charge and the current densities in the dielectric are set by the polarization, P (r;t), such that (r;t) = P and P and P and P where P; P obviously obey the continuity equation P0. Assume that the response of the matter to the eld is both linear as well as spatially local. Thus we write

in M K S units, where the dielectric susceptibility $_{\rm e}$ is dimensionless. In the frequency domain $_{\rm e}$ (!) is equal to ((!) $_{\rm e}$ 1)= $_{\rm 0}$ for condensed matter. For weakly interacting molecules or atom s $_{\rm e}$ = $_{\rm N}$ $_{\rm m}$, with $_{\rm N}$ the atom ic or molecular number density of the medium and $_{\rm m}$ the polarizability of the single molecule or atom .

With the polarization proportional to the eld, the force is bilinear in the eld. This bilinearity holds for objects moving at arbitrary non-relativistic velocities relative to the frame of reference of the thermal bath. We require the thermal average of the force acting on a moving body in unbounded space—led with radiation at rest, working in the reference frame where the particle is instantaneously at rest and the photon gas moves at velocity v. The average force is obtained in terms of the thermal averages of the Fourier components of the eld correlations. In unbounded space the Fourier components of the polarization and electric—elds are

where we took note of the fact that in empty space the electrice eld has no sources. A slight generalization of the standard expression ([12] Eq. 77.12) for the thermal average of the correlator of the electrice eld vectors yields

where $k = f \ddot{k} j$ and

is the Bose occupation number for a photon distribution at temperature T, moving with velocity v, and $= (k_B T)^1$. Eq. 6 is obtained by generalizing the uctuation-dissipation theorem to a translationally invariant system, and taking a G ibbs distribution corresponding to a photon gas moving with velocity v, just as done for excitations in super uidity [13]. From Eq. 6 we end up with the following average of the Lorentz force




Figure 1: Dependence of the logarithm of the relaxation time in years on the logarithm of the primary relaxation frequency (! $_0$ in Eq. 14) for three di erent temperatures, T = 300 K, T = 1000 K, T = 3000 K (upper, middle and lower curve). The frequency of the minimum is given by \sim ! $_0$ = 5:9694 k_B T.

Substitution of (4) in (5) with $\mathbf{v} = 0$ gives an integral over \mathbf{k} that, by symmetry, is zero. To obtain a non-zero result it is convenient to rst eliminate the delta functions by integrating over! and then expanding in powers of \mathbf{v} (as done to obtain the normal uid density in the theory of super uidity). Integration over! then yields

where we have taken the dielectric to be hom ogeneous so the integral over its volume $\sin p \ln y$ gives V.

The same equation also can be obtained from energy loss considerations, following the arguments of Volokitin and Persson [10]. One starts from the dissipation rate of the energy in the rest frame of the uctuating eld,

Here we take into account that in the rest frame of the therm alized photon gas the total electric current is given via the linearized Lorentz form j! j+v. A part from the heat production $\frac{dW_0}{dt}$ in the frame of the body, Eq. 8 is reproduced im mediately.




Figure 2: Dependence of the relaxation time in years on temperature. For the dielectric response (upper curve) we plot the minimal relaxation time obtained for the relaxation frequency that is proportional to the rst M atsubara frequency. We take M to be the density of water and the dimensionless measure of atomic polarizability $_0 = (N = V)_m$ 1. Numerically this value corresponds to a single particle of molecular polarizability $_0 = 1.0 \times 10^{30}$ m and a mass equal to the proton mass 1:67 $_0 \times 10^{27}$ kg. For the metallic response (lower curve) we take the characteristic time $_0 = _0 \times 10^{18}$ s, well within the range of conductivities of simple metals.

We now write, in a standard way, $_{\rm e}(x)=_{\rm e}^{0}(x)+i_{\rm e}^{00}(x)$, noting that the real part is an even and the imaginary part is an odd function of the argument. The expression for the force can now be obtained in the following form

Placed in Eq. 8, the k-space integral over the term in 0_e (ck) is zero, by sym metry. The remaining term then yields

Perform ing the angular integral over $d^3\tilde{k}$ gives a factor of 4=3. Reverting again to ! by substituting k=!=c gives

This is the fundam ental result of our paper. It states that the EM eld uctuations exert a drag, proportional in the lowest order to the velocity, on a particle that moves with respect to the frame of reference in which the EM eld uctuations are thermalized. Setting this force to M $\mathbf{v}=$, where M is the total mass of the object and $\mathbf{l}=$ is the drag time, and using $\mathbf{m}=\mathbf{M}=\mathbf{V}$, yields the result that

Regard this fundam ental result in three different contexts: molecules, dielectric and conducting condensed matter. First assume that the dielectric response of the medium can be characterized by a single sharp absorption line at $!_0$. Because 1 is proportional to $^0_e(!)$, obviously each of the absorption lines for a molecule or a dielectric will contribute additively to the integral in Eq. 13. We set $^0_e(!) = ^0_0(!) = ^0_0(!)$, where 0_0 is a constant describing the strength of the response. This assumption gives

after introducing $x=\frac{1}{2}$ ~!0. In this form the relaxation time depends strongly on the absorption frequency !0. It has a minimum at a temperature dependent frequency (see Fig. 1) that coincides with the minimum of the function $f(x)=\frac{\sinh^2(x)}{x^6}$, at $x_m=2.98$, where $f(x_m)=0.137$. Because f(x) is the square of the function $\frac{\sinh(x)}{x^3}$, it has a broad minimum with a quartic, rather than a quadratic, dependence upon the deviation from x_m . Taking this minimum at x_m into account, the smallest possible relaxation time can thus be obtained from the above equation in the form

where ${}_0T_0^5 = \frac{3 f(x_m)}{2^6} \frac{6^5 \cdot 4}{0 k_B^5}$. At this minimum the absorption frequency $\sim !_0 = 2 x_m k_B T$ is proportional to the rst M at subara frequency. The temperature dependence of this minimal possible relaxation time is given in Fig. 2.

A di erent formula for is obtained for metals, which have constant conductivity at frequencies below the collision time of their charge-carriers. In this case $_{e}(!)$ $_{i_{0}!}$. Inserting this into Eq. 13, the inverse relaxation time for drag now takes the form

with $_0=\frac{_0}{_0}$ and $T_0^4=\frac{45c^5\sim^3}{16^2k_B^4}$. For most common metals the value of $_0$ is between 10^{19} 10^{17} s. Taking its geometrical average we obtain the temperature dependence of the relaxation time as given in Fig. 2.

The times given in the gures are relatively long, corresponding to the general weakness of the Casim ir interaction and the even lower strength of the dissipative Casim ir e ect. Two circum stances under which such long times might be observable are ovens and the cosmos.

For ovens, on trapping molecules with unusually large polarizabilities it might be possible to observe a resonance in an ion or atom trap with a quality factor Q that is determined by the dissipative Casimir interaction. Small metal particles in a high temperature oven should also be susceptible to the elects of the Casimir drag.

For the cosm os, it is believed that hydrogen atoms condensed from protons and electrons at about 3000 K, and that the coupling of radiation and matter due to C ompton scattering becomes ine ective below this condensation temperature [14]. However, as is clear from Fig. 2, it should not be discult for molecules to remain coupled to the cosmic microwave background when the temperature was between about 300 K (and perhaps a bit less) and the 3000 K condensation temperature. This coupling could have an in unence on the structure and anisotropies observed in recent experiments on the cosmic microwave background. It could also in unence the behavior of molecules formed from the residue of novas and supernovas, and then subject to drag from a still-hot cosmic microwave (i.e., electromagnetic) background.

The universal therm aldrag calculated in this contribution is yet another important facet of the Casim ir e ect, which in this context appears to play a role not only in the static interactions between dielectrically inhom ogeneous bodies but also in the dissipative dynamics of particles in hom ogeneous space.
