Quantum transport through carbon nanotubes: proxim ity induced and intrinsic superconductivity.

W e report low tem perature transport m easurem ents on suspended single walled carbon nanotubes (both individual tubes and ropes). The technique we have developed, where tubes are soldered on low resistive m etallic contacts across a slit, enables a good characterization of the sam ples by transmission electron m icroscopy. It is possible to obtain individual tubes with a room tem perature resistance smaller than 40 k , which remain m etallic down to very low tem peratures. When the contact pads are superconducting, nanotubes exhibit proximity induced superconductivity with surprisingly large values of supercurrent. We have also recently observed intrinsic superconductivity in ropes of single walled carbon nanotubes connected to norm al contacts, when the distance between the norm al electrodes is large enough, since otherw ise superconductivity is destroyed by (inverse) proximity e ect. These experiments indicate the presence of attractive interactions in carbon nanotubes which overcom e C oulom b repulsive interactions at low tem perature, and enables investigation of superconductivity in a 1D limit never explored before. I. IN TRODUCTION

The hope to use molecules as the ultim ate building blocks of electronic circuits motivates the quest to understand electronic transport in thinner and thinner wires, ideally with one or two conduction modes. However a num ber of physical phenom ena tend to drive such onedimensional (1D) metallic wires to an insulating state at low temperature. The most basic is the great sensitivity of 1D transport to disorder: a 1D wire has a localization length of the order of its elastic mean free path. It has also been shown that most molecular 1D conductors undergo a structural Peirls transition to an insulating state at low tem perature¹. Finally the repulsive Coulomb interactions between electrons, which are very weakly screened in 1D, tend to destabilize the 1D Ferm i liquid in avor of correlated states which are also insulating at low tem perature.

The purpose of this paper is to show that carbon nanotubes, because of their special band structure, escape such a fate and remain conducting over lengths greater than one micron down to very low temperature. They do not present any detectable Peirls distortion and are weakly sensitive to disorder. Moreover transport through the nanotubes is quantum coherent, as demonstrated by the existence of strong supercurrents when connected to superconducting contacts. The observation of intrinsic superconductivity in ropes containing a few tens of tubes is even more surprising and indicates the presence of attractive pairing interactions which overcom e the strong repulsive interactions.

Single walled carbon nanotubes are constituted by a single graphene plane wrapped into a cylinder. The Ferm i surface of graphene is very particular, it is reduced to six discrete points at the corners of the st B rillouin zone². As a result, depending on their diam eter and their helicity which determ ine the boundary conditions of the electronic wave functions around the tube, SW NT can be either sem iconducting or $m \text{ etallic}^3$. W hen m etallicthey have just two conducting channels, only very weakly coupled by electron-electron interactions. They are thus characterized by a low electronic density together with a high Ferm i velocity (nearly as high as in copper) and relatively large m can free paths⁴. These properties m ake them much sought-after realizations of 1D conductors, or m ore precisely of 1D ladders with very small transverse coupling^{5,6}. At 1D, electron-electron interactions lead to an exotic correlated electronic state, the Luttinger liquid (LL)⁷ where collective low energy plasm on-like excitations give rise to anom alies in the single particle density of states, and where no long range order exists at nite tem perature.

P roof of the validity of LL description with repulsive interactions in SW NT was given by the measurement of a resistance diverging as a power law with temperature down to 10 K⁸ with an exponent depending on whether contacts are taken on the end or in the bulk of the tube. From these exponents the LL parameterg measuring the strength of the interactions was deduced to be g = 0.25 0.05. This value which is much smaller than 1 corresponds to dom inant repulsive interactions. The extrapolation of this power law behavior down to very low

tem perature would indicate an insulating state. However, these m easurements were done on nanotubes connected to the m easuring leads through tunnel junctions. Because of C oulom b blockade⁹, the low tem perature and voltage transport regime could not be explored.

We have developed a technique (described in section II) in which measuring pads are connected through low resistance contact to suspended nanotubes¹⁰. It is then possible to obtain individual tubes with a resistance at room temperature (RT) no larger than 40 k , that increases only slightly at low temperatures (typically a 20% resistance increase between RT and 1 K) (section III). The resistance versus voltage (RV) curves also exhibit weak logarithm ic non-linearities at low temperature. However we nd no simple scaling law between the voltage and the temperature-dependence of the differential resistance. This suggests that several di erent physical mechanism s could contribute to the very low temperature dependence of the resistance.

In section IV we show that when the contact pads are superconducting, a supercurrent can ow through SW NTs as well as through ropes of SW NTs¹¹. These experiments indicate in principle that quantum coherent transport can take place through carbon nanotubes over m icron-long scales. However the unexpectedly high m easured values of the critical current in individual nanotubes, along with non-linearities in the IV characteristics at voltages m uch higher than the superconducting gap of the contacts raise the question of possible intrinsic superconductivity.


Finally in section V we present m easurements on long ropes of SW NTs connected to norm alcontacts which indeed show evidence of intrinsic superconductivity below 0.5 K provided that the distance between norm al electrodes is large enough. We discuss the one-dimensional character of the transition and the physical parameters which govern this transition, such as the presence of norm al reservoirs, intertube coupling and disorder.

II. SAM PLE DESCRIPTION AND PREPARATION

The SW NT are prepared by an electrical arc m ethod with a mixture of nickel and yttrium as a catalyst^{12,13}. SW NT with diam eters of the order of 1.4 nm are obtained. They are puried by the cross-ow ltration m ethod¹³. The tubes usually come assembled in ropes of a few hundred tubes in parallel, but individual tubes can also be obtained after them ical treatm ent with a surfactant¹⁴. Connection of an individual tube or rope to m easuring pads is perform ed according to the follow ing nano-soldering technique: A target covered with nanotubes is placed above a m etal-coated suspended S i₃N₄ m em brane, in which a 0.3 m by 100 m slit has been etched with a focused ion beam. As described in ref.¹⁰, we use a 10 ns-long pulse of a focused UV laser beam (power 10 kW) to detach a nanotube from the target,




FIG.1: Principle of the soldering of carbon nanotubes and schem atic cross-section of a device. Below, transm ission electronic m icrograph (TEM) of the nanotubes, suspended across a slit between 2 m etallic pads; and detailed view of the contact region showing the m etalm elted by the laser pulse.

which then falls and connects the edges of the slit below. Since the m etal electrodes on each side of the slit are locally molten, the tube gets soldered into good contacts, and is suspended (see Fig.1).

The electrodes are usually bilayers (Re/Au, Ta/Au, Ta/Sn) or trilayers (A $\lg O_3$ /Pt/Au) of non-m iscible materials (in liquid or solid phases), in which the lower layer (Re, Ta) has a high melting tem perature in order to protect the nitride membrane during the welding of the tube to the top gold layer. Gold wasmostly chosen as the solder material because it neither reacts with carbon nor oxidizes. The contact region is pictured in the transm ission electron microscope (TEM) view of Fig1. Balls of metalm olten by the laser pulse can be seen on the edges of the slit.

Because the tubes are suspended, they can be structurally and chem ically characterized in a TEM working at moderate acceleration voltages (100 kV) as shown in Fig.1. We measure the length L and diameter D of a rope and estimate the number of tubes N in the rope through N = $(D = (d + e))^2$, where d is the diameter of a single tube (d= 1.4 nm), and e is the typical distance




FIG.2: Typical electron energy loss spectrum (EELS) on a carbon nanotube rope (lower curve), compared to the EELS spectrum of an am orphous carbon membrane (upper curve). The peak at 285.5 eV of carbon is visible in both spectra. The oxygen peak (at 540 eV) is much larger in the membrane than on the tubes, and the O_2 content on the rope is estimated to be less than 15% atom ic content.

between tubes in a rope (e= 0.2 nm).

W e can also check that no m etal covers or penetrates the tubes. In addition we estimate, using electron energy loss spectroscopy (EELS), that chemical dopants such as oxygen are absent to within 2 % (see Fig. 2). The characterization procedures can of course deteriorate the sam ples, because of electron irradiation dam age¹⁵ which can cause local am orphisation and induce an increase in the tubes resistance.

The originality of our fabrication technique lies in the suspended character of the tubes, the quality of the tubeelectrode contact, and the ability to characterize the measured sample in a transmission electron microscope.

III. TRANSPORT IN THE NORMAL STATE

A. M easurem ent circuit and sam ple environm ent

The sam ples were measured in dilution refrigerators, at tem peratures ranging from 300 K to 0.015 K, through ltered lines. Good calibration of the therm om eter and therm alisation of the sam ples are only guaranteed below 1K, so that higher-tem perature data are only indicative. M agnetic elds of up to 5 T could be applied perpendicularly to the contacts and the tubes. The resistance was measured by running a sm all (0.01 nA to 10 nA, 30 Hz) a.c. current though the sam ple and measuring the corresponding a.c. voltage using lock-in detection.

The two large (roughly 10 mm^2) m etallic contacts on either side of the suspended nanotube constitute, with the ground copper plate on the other side of the silicon wafer, two capacitances of the order 3 pF which help lter-out residual high frequency radiation.

W hen the tubes were contacted to superconducting

electrodes or exhibited intrinsic superconductivity, the investigation of the norm al state was done by applying a m agnetic eld large enough to destroy the superconductivity.

B. Individual single wall nanotubes

Depending on their room tem perature resistance, we nd that SW NTs can be insulating or metallic at low tem perature. The SW NT samples with high (larger than 40 k) RT resistance become insulating, with an exponential increase of resistance, as T is decreased. This insulating behavior could be due to the atom ic structure of the tube, which would correspond to a sem iconducting band structure. It could then lead to a gap sm aller than the expected value at half lling because of possible doping due by the contacts. It could also be caused by the presence of disorder in a tube (the importance of which is discussed further along). In the following, we focus exclusively on the SW NT samples which remain m etallic down to low tem perature. They are presented in table II. Their resistance at room temperature lies between 10 k and 70 k , and increases by less than a factor 2 between 300 K and 1 K .




FIG.3: Temperature dependence of the resistance of di erent single tubes: ST1, ST2, and ST4 are mounted on Au/Ta contacts and measured in a magnetic eld of 4 T to suppress the superconductivity of the contacts. ST3 is mounted on C rIn contacts. Note the logarithm ic scales. TEM m icrograph of the corresponding sam ples. The dark spots are N i/Y catalyst particles.

The temperature dependence of the zero bias resistance of four samples is shown in Fig. 3 in a log-log plot. The increase of resistance as T is lowered can be described by a power law with a very sm all negative exponent which varies between 0.01 for the less resistive tube and 0.1 for the most resistive one. Note that because of the very small values of these exponents a logarithm ic $law R / R_0$ logT could t the data just as well. This behavior is observed down to 50 mK without any sign of saturation. This weak tem perature dependence has also recently been measured in samples where good contact to electrodes was achieved by burying the tube ends over a large distance under m etallic electrodes fabricated with electron beam lithography^{16,17}. It is on the other hand in stark contrast with the T dependence of tubes with tunnel contacts^{8,18}, which exhibit power laws with much larger exponents (of the order of 0.3) at high tem perature, and exponentially increasing resistance at lower tem perature because of Coulom b blockade. It is not surprising that in addition to the intrinsic conducting properties of tubes (interactions, band structure, disorder), the way they are contacted should determ ine the tem perature dependence of the resistance. For instance extrapolating the results obtained on Luttinger liquids between norm al reservoirs¹⁹, the resistance of a ballistic tube on perfect contacts is expected to be insensitive to interactions and to be given by $R_0 = 2 = h = 2e^2 = 6.5 k$ at all tem peratures. In contrast, a tube on tunnel contacts will turn insulating at low tem perature because of Coulom b blockade. Since our measurem ents are two wire measurements, it is dicult to determine how much of the resistance is due to the contacts, and how much is due to the tube itself. However, the existence in these

very same samples of a large proximity e ect along with a high supercurrent (see next section) suggests that the transm ission at the contacts is close to unity. We therefore attribute the excess resistance compared to the expected value $R_0 = 2$ to disorder inside the tubes.

We then can try to quantify the amount of disorder within our SW NT samples and discuss the possibility of them still being metallic. To do this, we choose to consider the nanotube as a hom ogeneous di usive conductor with M conducting channels (in a SW NT M = 2), and apply the D rude form ula which relates the conductance to the elastic mean free path le through G = M ($e^2 = h$)le=L = $2G_Q$ le=L. The values of le deduced in this way are given in Table II. We nd rather short mean free paths com pared to the length of the tubes (especially for sample ST 4), suggesting the presence of de-




FIG. 4: Bias dependence at 50 mK of the di erential resistance of individual tubes ST2 and ST3 in comparison with temperature dependence (temperature is expressed in eV units).

fects in the tubes. The m icroscopic cause of these short m ean free paths could be heptagon-pentagon pairs or defects created by electron irradiation during observations in TEM .

One of the question raised by these small values of $l_e=L$, or equivalently the small values of $G=G_{\odot}$, is why these samples do not localize. Indeed, according to the Thouless criterion²⁰, a quantum coherent conductor is expected to localize, i.e. become insulating at low tem perature, if its conductance G is sm aller than G_0 . In contrast, we observe no sign of strong localization down to very low tem perature where quantum coherence throughout the whole sample is expected to be achieved. One possible explanation could lie in the fact that the conductance of a SW NT could be sensitive to interactions even on good contacts as recently suggested²¹. These authors, extending the calculations of de Channon et al.²² on chiral Luttinger liquids to the non chiral case, predict that the two contact conductance is renorm alized by a factor which depends on the boundary conditions im posed at the contacts, that can be of the order of the LL parameter g. In their calculation, there is no nearby gate to screen the interactions, and this is indeed our experim ental con guration. These theoretical results could then explain why the high measured resistances do not lead to localization at low tem perature. However, the sam e LL theories²³ predict that for a well contacted sam ple the weak tem perature dependence G $G_0 = T^x$ should saturate at tem peratures sm aller than the energy scale $E_{c} = hv = L$ where v is the plasm on velocity $v = v_F = q$. In our tubes E_c is of the order of 30 K or m ore, and we observe no saturation. Therefore we do not think that the low temperature dependence of the resistance observed in these samples contains a clear signature of Luttinger Liquid behavior.

W e now exam ine the voltage dependence of the di erential resistance dV /dI, below 1 K , and with the contacts in the norm al state. Like the tem perature dependence of the zero-bias di erential resistance, the dV /dI has a weak power law dependence as a function of V, which can also be tted by a logarithm ic law. This behavior is at rst glance qualitatively sim ilar to what is observed in sm all m etallic bridges presenting a sm all C oulom b-type anom aly in their di erential resistance²⁴. How ever in the present case the sim ilarity between tem perature and bias voltage dependence is only qualitative as shown on F ig.4: the decrease of di erential resistance with V is slower than the corresponding tem perature dependence. In addition, the dV /dI saturates below bias values corresponding to an energy much larger than the tem perature. And in contrast to nanotubes connected with tunnel contacts⁸ or sm allm etallic constrictions 24 , it is not possible to scale the data using the reduced variable $eV = k_B T$. This absence of a voltage versus tem perature scaling suggests that the tem perature dependence of the resistance contains other contributions besides the expected increase due to electron-electron interactions (for instance weak localization contributions) and calls for further understanding.

C. Ropes of single wall carbon nanotubes




FIG. 5: Tem perature dependence of the resistance m easured on di erent ropes m ounted on various types of contacts. For all sam ples the m easurem ents were conducted in a m agnetic eld of 1 T.N ote the logarithm ic scales.




FIG. 6: Dierential resistance of four ropes in the normal state as a function of voltage bias, and as a function of tem - perature (expressed in units of voltage). The dierence between bias and tem perature dependance tends to be weaker when the resistance of the rope increases.

Ropes of SW NT contacted using the same technique cover a much wider range of resistances than individual SW NT. The resistances vary between less than 100 and 10^5 at 300 K, for ropes containing between forty and several hundred SW NT (see table). There is no clear correlation between the number of tubes in a rope (deduced from the rope diam eter) and the value of its resistance. This may indicate that in some cases only a small fraction of the tubes are connected. In contrast to individual nanotubes, the ropes seem to verify the Thouless criterion: they strongly localize when their resistance is above 10 k at room tem perature and stay quasi-m etallic otherwise. This behavior is very similar to what is observed in quasi 1D m etallic wires²⁵. The temperature dependence of the m etallic ropes (see Fig. 5) is also very weak. But for low resistance ropes (R < 10 k) it is not m onotonous, in contrast to individual tubes, and as already observed in²⁶: the resistance decreases linearly as tem perature decreases between room tem perature and 30 K indicating the freezing-out of phonon modes, and then increases as T is further decreased, as in individual tubes. In all samples a bias dependence of the differential resistance is also observed at low temperature (Fig.6). The relative amplitude of these non-linearities are much smaller than in individual SW NT. This may be related to screening of electron-electron interactions in a rope, which does not exist in a single tube. The magnitude of the resistance variation with V increases with rope resistance, and is weaker than the corresponding tem perature dependence. The absence of scaling laws

in the reduced variable $eV = k_B T$ is more striking than for individual tubes. In particular, the di erential resistance saturates below voltages much larger than tem perature.

D. Im portance of intertube coupling in ropes.

In order to determ ine whether a rope is closer to an assembly of ballistic tubes in parallel, or to a single dif-

fusive conductor, we need to evaluate the importance of intertube coupling and electron transfer between tubes within a rope. The characteristic microscopic electron hopping energy to between two carbon atoms on dierent tubes depends on their relative distance d through $t_2 / t_6 \exp(d=a)$. Here a is the spatial extension of the p_z orbital of carbon, and t_G is the hopping energy between two sheets of graphite 27 . G iven the di erences in C-C distances and orbitals, the ratio between perpendicular and parallel hopping energies in carbon nanotubes has been evaluated to be at most $t_2 = t_k$ 0:01. In an ordered rope containing identical individual tubes, authors in²⁸ have shown that this low intertube coupling can induce a band gap of about 0.1 eV, turning a rope of m etallic tubes into a sem iconductor.

On the other hand in a rope constituted of tubes with di erent helicities, in the absence of disorder within the tubes, one nds that the intertube electronic transfer, de ned as the matrix element of the transverse coupling between two tubes, integrated over spatial coordinates, is negligeable because of the longitudinal wave function m ism atch between neighboring tubes of di erent helicities. The rope can then be considered as a number of parallel independent ballistic nanotubes. The very sm all level of shot noise observed in low resistive ropes corroborate this statem ent²⁹. However, it has been show n^{27} that the presence of disorder within the tubes favors intertube scattering by relaxing the strict orthogonality between the longitudinal components of the wave functions. Using a very simple model where disorder is treated perturbatively³⁰ we nd that for weak disorder the intertube scattering time is shorter than the elastic scattering tim ewithin a single tube. In tubes longer than the elastic m ean free path, this intertube scattering can provide additional conducting paths to electrons which would otherwise be localized in isolated tubes. Consequently, disordered ropes can be considered as an isotropic di usive conductors that, in contrast to individual tubes, exhibit a localization length that can be much larger than the elastic mean free path. This is why we have tentatively determ ined for each rope an elastic m ean free path from the value of its conductance using the multichannel Landauer expression for a disordered conductor equivalent to the D rude form ula: $G = 2M (e^2 = h) = L w$ ith the num ber of channels M = $2N_t$ where N_t is the number of tubes inside the sample. Since the number of metallic tubes connected is statistically of the order or less than N $_{t}$ =3 these values of le are certainly underestimated. In addition, it may be possible that the metallic tubes in a rope are not all well connected to both electrodes. Then transport through the rope will proceed via inter tube transfer. That is why ropes with many disordered metallic tubes m ight have very high resistances.

IV. PROXIMITY INDUCED SUPERCONDUCTIVITY

A non-superconducting or norm alm etal (N) in good contact with a macroscopic superconductor (S) is in the so-called 'proximity e ect regime': superconducting correlations enter the norm alm etal over a characteristic length L_N which is the smallest of either the phase coherence length in the norm alm etal L or the therm al length L_T , (in a clean metal L_T = hv_F = $k_B T$ and in a dirty metal L_T = hD= $k_B T$ where D is the electron di usion coe cient). Both lengths, of the order of a few m, can be much longer than the superconducting coherence length = hv_F = or hD = where is the energy gap of the superconducting contacts.

If the norm alm etal's length is less than L_N and if the resistance of the NS interface is su ciently small, a gap in the density of states is induced in the norm alm etal, that is as large as the gap of the superconductor in the vicinity of the interface and decreases on a typical lengthscale of L_N . Consequently, a norm alm etal shorter than L_N between two superconducting electrodes (an SNS junction) can have a critical temperature (equal to that of the superconductor alone) and exhibits a Josephson effect, i.e. a supercurrent at zero bias. This manifestation of the proximity e ect has been extensively studied in multilayered planar SNS junctions³¹ and more recently in lithographically fabricated m icron scale m etallic w ires made of normal noble metals between two macroscopic superconducting electrodes^{32,33}. The maximum low tem perature value of the supercurrent (critical current) in such SNS junctions of norm all state resistance $R_{\,\rm N}\,$ is : E c³⁴, =eR $_{\rm N}$ in the short junction lim it L or

and $E_c = eR_N$ in the limit of long junctions L or E_c ³³. Here is a numerical factor of the order of 10, and E_c is the Thouless energy $E_c = hD = L^2$.

Probing the proximity e ect in a normal wire connected to superconducting electrodes and in particular the existence of a Josephson current constitutes a powerful tool for the investigation of phase coherent transport through this norm alwire. In the next paragraph we present experimental results on carbon nanotubes mounted on superconducting electrodes showing evidence of large supercurrents which indicate that coherent transport takes place on micron length-scales.

A. Proxim ity e ect in individual tubes

W e have observed proximity induced superconductivity in the three di erent individual SW NT ST1, ST2 and ST4 described in the previous section. These samples are mounted on Ta/Au electrodes see table I which are a bilayer (5 nm Ta, 100 nm Au) with a transition tem perature of the order of 0.4 K. This value is strongly reduced com pared to the transition tem perature of bulk tantalum (4 K) due to the large thickness of gold relative to tantalum.

1. Zero bias resistance




FIG.7: Left panel: Tem perature dependence of the resistance of 3 di erent single tubes ST1;2;4:m ounted on TaAu, for different values of the magnetic eld perpendicular to the tube axis in the plane of the contacts. (The labels on the curves correspond to the value of magnetic eld in Tesla). For some samples the resistance of the contacts exhibited several steps in tem perature, probably indicating inhom ogeneities in the thickness of the gold layer. This may explain the sm all resistance drop observed on sample ST1 around 1 K at low eld. Top right panel: eld dependence of the transition tem perature, de ned as the in ection point of R (T). Bottom right panel: M agnetoresistance of the single tubes measured at 50 m K (the magnetic eld is perpendicular to the tube axis in the plane of the contacts). This positive magnetoresistance only saturates at very high eld (2T).

For these three samples the zero bias resistance exhibits a broad transition around the superconducting transition tem perature of the contacts and becom es zero at lower tem perature except for the highest resistance sam ple ST 4 ($R_N = 70 \text{ k}$) which has a residual resistance of 800 . The transition is shifted to lower tem perature when a magnetic eld is applied in the plane of the contacts and perpendicular to the tube axis. Above 2 T the resistance is eld independent and slightly increases when the tem perature is low ered below 0:2 K as already mentioned in the previous section . The critical eld is of the order of 1 T and can be also extracted as the in ection point of the magnetoresistance depicted in Fig. 7. This value is surprisingly high since it is ten times larger than the m easured critical eld of the contact (0.1)T). This high value of critical eld could be due to local modications of the bilayer Ta /Au lm in the contact region due to the laser pulse, in particular the melted upper gold Im is probably much thinner than the original one. It is however important to note that these critical elds are of the same order of magnitude in all the sam ples m easured. As Fig. 7 shows, the transition line $T_{c}(H)$ is a linear function of led for all samples.

2. Bias dependance and critical current

The most striking signature of induced superconductivity is the existence of Josephson supercurrents through the sam $ples^{11}$. The existence of a supercurrent shows up in the voltage vs. current curves and di erential resistance, see F ig. 8. For sam $ple S T_1$, the transition between the superconducting state (zero voltage drop through the sam ple) and the dissipative (resistive) state is quite abrupt and displays hysteresis at low temperature. It

is characterized by a critical current $I_{\rm c}$ = 0:14 A near zero tem perature. Sim ilar behavior with smaller values of critical current is also observed in the other samples (see table IV). The product $R_{\rm N}~I_{\rm c}$ at T $_{\rm c}$, varies between 1.6 and 3.5 mV. If we deduce from the T $_{\rm c}$ of the superconducting contacts, we nd that $R_{\rm N}~I_{\rm c}$ ism ore than ten times larger than the maximum expected value (=e = 0.2 mV) for the short junction lim it $B_{\rm c}$ > . It is then also interesting to note that the product eR $_{\rm N}~I_{\rm c}$ is closer to the gap of pure tantalum $_{\rm Ta}$ = 0:7 meV. But it is di cult to understand why the induced gap could be the gap of pure tantalum whereas the resistance drop of the tube follows the transition of the Au/Ta bilayer.

Som ew hat unexpectedly and uncharacteristic of m etal SNS junctions, the norm all state resistance is not recovered above the critical current, but the V (I) curve shows further hysteretic jumps at higher currents.

These features also appear in the di erential resistance dV=dI (see Fig. 9). The superconducting state corresponds to the zero di erential resistance at low dc current. At the critical current the di erential resistance displays a sharp peak followed by sm aller ones at higher current. Each peak corresponds to a hysteretic feature




FIG.8: IVsV curve of the single tube ST1, from which the critical current is deduced. R ight panel, data on a wider current scale showing the existence of voltage steps for currents above I_c . The arrows indicate the current sweep direction.




FIG.9: D i erential resistance of the 3 sam ples ST1, 2 and 4 for di erent magnetic elds. R ight panels: Field and tem – perature dependence of the critical current, de ned as the current at which the rst resistance jump occurs. The critical current disappears around H $_{\rm c}$ = 1 T, which is also the value deduced from the low tem perature R (H) curves in Fig. 7.

in the dc V I curve . The peaks are linearly shifted to low er current when increasing magnetic eld and all disappear above 2T. The temperature and eld dependencies of the critical current extracted from this data are plotted in Fig. 9. The temperature dependance is very weak below 0.8 T_c and decreases rapidly above. It does not follow the behavior expected for SNS junctions (neither in the limit of short junctions nor long junctions where an exponential decay of the critical current is expected³³). The eld dependance of the critical current is precisely linear for all sam ples, with disappearance of critical current above 1 T.

It is very di cult to understand these results in the fram ework of conventional proxim ity induced superconductivity. In particular we have already mentioned that the IV curves exhibit non linearities, and signs of superconductivity at very large bias, i.e. much larger than the gap of the Ta/Au contacts (and even the gap of pure tantalum !). Such non-linearities recall manifestations of phase slips in 1D superconductors³⁷: Above I_c, sm all norm al regions of size com parable to the inelastic length L_N are nucleated around defects in the sample (phase slip centers). They have not to our know ledge been observed before in SNS junctions. These observations by

them selves suggest the possibility of intrinsic superconducting correlations in SW NT, which will be discussed further on.

It is therefore interesting to compare these results with the superconductivity of other types of metallic nanow ires. Ref.³⁹ reports superconducting nanow ires fabricated by depositing thin Im s of am orphous M oG e on suspended carbon nanotubes. D isappearance of superconductivity in the most resistive wires is attributed to the form ation of quantum phase slips at very low tem perature. The rst data obtained on these samples indicated disappearance of superconductivity for norm al state resistance larger than $h=4e^2$. In a later paper⁴⁰, the authors show that what determ ines the suppression of superconductivity is not the norm al state resistance but rather the resistance per unit length. They nd that the transition is suppressed for resistances per unit length larger than roughly 0.1 k /nm . W e have observed proxin ity induced superconductivity in SW NTs with a norm al state resistance up to 70 k , with a resistance per unit length of the order of 0.25 k /nm . Note how ever that the M oG e nanow ires contain typically 10000 channels, whereas our nanotubes only contain 2 conducting channels. This comparison tells us that proximity induced superconductivity is am azingly robust in our sam ples.

Finally signs of proxim ity induced superconductivity have also been observed by other groups, on individual SW NT³⁵ and on multiwall nanotubes³⁶, but without supercurrents. In appendix A of this paper we show our results on proxim ity-induced superconductivity in multiwall nanotubes.




FIG.10: Tem perature dependence of the resistance of ropes R l_{R eAu}, R 2_{R eAu}, R 3_{R eAu} mounted on Re/Au contacts, in zero m agnetic eld. The T_c of Au/Re is 1 K. Sam ple R 3_{R eAu} becomes superconducting below 1K, but the resistance steps above the transition indicates that the superconductivity of the contacts m ay not be hom ogeneous.




FIG.12: Left panel: Tem perature dependence of zero-bias resistance of ropes R 3_{TaSn} and R 5_{TaSn} . Right panels: differential resistance curves taken at 0.1 T, with an example of the hysteresis with current sweep direction.




FIG.11: Tem perature dependence of the critical current of rope R $3_{R \ eAu}$. Main panel: I-V curves at di erent tem peratures. Inset: Tem perature dependence of the critical current (triangles), and t to the Am begackar B arato form ula $i_{A \ B}$ (T) = $i_0 \frac{(T)}{(0)}$ tanh ((T)=2k B T) (continuous line).

B. Proxim ity induced superconductivity in ropes

W e also found proxim ity induced superconductivity in ropes of SW NT m ounted on Re/Au or Ta/Sn which characteristics are shown in table V and Fig. 10 to 13.

It is interesting to note that in contrast to what was found in SW NTs, we only observe proxim ity-induced superconductivity in ropes with a norm all state resistance less than 10 k . M ore resistive ropes, as previously mentioned, are insulating at low temperature. The data of F ig. 10 for ropes mounted on Re/Au show that although a resistance drop is observed in the vicinity of the transi-




FIG. 13: V versus I curves of ropes $R J_{TaSn}$ and $R J_{TaSn}$ in elds ranging from 0 to 1.5 T. Inset: eld dependence of the critical current deduced form these IV curves. The eld is parallele to the contacts, and perpendicular to the tubes. N ote the non m onotonous behavior.




FIG.14: M agnetoresistance of the rope R 3_{TaSn} m easured at 50 mK for the eld parallel and perpendicular to the contacts, and always perpendicular to the tube.

E ect of m agnetic eld orientation

is not always complete and is only slightly visible on the most resistive sample. This may result from the com bined e ects of the quality of the contacts and disorder in the rope for which the condition $L_N > L$ may not be ful lled in our available tem perature range. The critical current deduced at 50 mK from the I-V curves are given in table V and compared to the theoretical predictions. The rope on Re/Au contacts is in the short junction regime ($< E_{c}$) and the ropes on TaSn are in the long junction lim it. In all cases the measured supercurrents are larger than allowed by the theory of SNS junctions. It is noteworthy that the two ropes mounted on tin have similar critical currents ($I_{\rm c}$ 0:7 A) in spite of the fact that their norm al state resistances differ by more than a factor three. As for the individual tubes, jumps in the IV curves are also observed at bias larger than the gap of tin. The tem perature dependence of the critical current in R $3_{R eA u}$ (see Fig. 13) is more pronounced than for individual tubes, and can be approximately tted by an Ambegaokar-Barato law typical of tunnel junctions⁴¹. In the case of ropes m ounted on tin contacts this tem perature dependence is di cult to extract because of the rounding of the IV curves with increasing tem perature. In contrast to individual tubes, the eld dependance is not monotonous. The critical current st increases up to 0.1 T where it goes through a maximum and decreases linearly at higher eld up to 1 T. Such non-monotonous behavior has been predicted in a number of models describing non hom ogenous superconductors and could be related to interference between di erent electronic trajectories along the various tubes of the rope and the existence of negative Josephson couplings between these tubes. This recalls the nonm onotonous m agneto-resistance of am orphous superconducting wires³⁸ and in MWNT (see appendix), and may have a common origin.

For the ropes mounted on tin we investigated the magneto-transport for di erent eld orientations. W e found that with the eld parallel to the contacts (and perpendicular to the tubes) the critical elds were much larger than the critical eld of the contacts. This may be explained by a local thinning of the metallic layer contacting the tube in the contact region after soldering. Figure 14 shows the magnetoresistance for these 2 di erent eld orientations. For these sam ples the magnetoresistance was also measured between 0 and 20 T using the high eld facility in Grenoble at 1 K with the magnetic eld along the rope (see g. 15). The magnetoresistance increases linearly with eld and saturates only above 10 T. This eld is of the order of the C logston C handrasekhar⁵⁴ criterion for destruction of superconductivity by pair breaking due to spin polarization: $_0H_p = _{Sn} = _B$ 7 T, where s_n is the gap of tin. Unfortunately, the high eld experiments were not conducted in the sam e tem perature range as the low eld ones, and in the second m easurem ent (low eld), because of therm al cycling, the sam ple exhibited less proxim ity e ect. N evertheless, it seem s as though the superconductivity depends on the orientation of the magnetic eld with respect to the tube and not only on its orientation with respect to the contacts, as expected for proximity induced superconductivity.

C. D iscussion

O bærvation of a strong proxim ity e ect indicates that phase coherent transport takes place in carbon nanotubes on the micron scale. However in the case of single wall tubes the surprisingly high values of critical currents can-




FIG.15: M agnetoresistance of the rope R 3_{TaSn} m easured at 1 K with the eld along the tube in the high eld facility of G renoble. Note that the magnetoresistance increases in m agnetic eld up to H = 10 T.

not be described by the standard theory of SNS junctions. The problem of an SNS junction constituted of a Luttinger liquid between two superconducting reservoirs has been considered theoretically for weakly transm itting contacts⁴², and for perfectly transm itting contacts^{43,44}. In both lim its the authors predict that it is indeed possible to induce superconductivity by a proximity e ect. In the case of repulsive interactions and perfectly transm itting interfaces the zero tem perature value of the critical current is not changed by the interactions. M ore recently it has been shown that the presence of attractive interactions in a Luttinger liquid can result in a signi cant increase of the critical current 45,46 and unusual tem perature dependencies very sim ilar to what we observe for individual tubes. A more accurate tof the temperature dependance of the critical current in the rope including the existence of the in ection point can also be obtained using the theoretical predictions of G onzale z^{46} .

Our data could also be explained by the existence of superconducting uctuations intrinsic to SW NT.For an in nite nanotube, because of its 1D character, these uctuations are not expected to give rise to a superconducting state at nite tem perature. How ever, the superconducting state could be stabilized by the macroscopic superconductivity of the contacts. In such a situation, it is conceivable to expect the critical current to be enhanced compared to its value in a conventional SNS junction and to be given by the critical current of a superconducting 2-channelwire: $I_c = (4e^2=h) t^{47}$ determined by the value of the superconducting pairing amplitude t inside the wire and independent of the norm al state resistance of the nanotube (in the lim it where the mean free path is larger than the superconducting coherence length). The existence of superconducting uctuations intrinsic to nanotubes m ay also help to explain the positive m agneto-resistance observed in allour sam ples w here the norm al state resistance is recovered at elds much higher than the critical eld of the contacts. In the next

section we show that these hypotheses are corroborated by the observation of intrinsic superconductivity in ropes of SW NT .

V. IN TRINSIC SUPERCONDUCTIVITY IN ROPES OF SW NT ON NORMAL CONTACTS




FIG.16: Resistance as a function of temperature for the six samples described in table VI, both in zero elds and large elds.

In the following we discuss the low temperature transport (below 1K) of suspended ropes of SW NT connected to norm allectrodes. The electrodes are trilayers of sputtered A $l_2O_3=P$ t=A u of respective thickness 5, 3 and 200 nm. They do not show any sign of superconductivity down to 50 mK.




FIG.17: Resistance as a function of tem perature for samples R1;2;5_{P tAu} showing a transition. The resistance of R1 is measured in magnetic elds of $_0$ H = 0, 0.02, 0.04, 0.06, 0.08, 01, 02, 0.4, 0.6, 0.8 and 1 T from bottom to top. The resistance of R2 is taken at $_0$ H = 0, 0.05, 0.1, 02, 0.4, 0.6, 0.8, 1, 1.25, 1.5, 1.75, 2, 2.5 T from bottom to top. That of R5 at $_0$ H = 0, 0.1, 0.2, 0.3, 0.5, 1.4 T from bottom to top. Bottom right: T_c (H) for R2.

As shown in qure 16, di erent behaviors are observed for the tem perature dependence of the zero bias resistance. The resistance of some samples (R $3_{P tAu}$ and R $6_{P tAu}$) increases weakly and monotonously as T is reduced, whereas the resistance of others (R 1;2;4;5_{P tA u}) drops over a relatively broad tem perature range, starting below a tem perature T between 0.4 and 0.1 K (T $_1$ = 140 mK, $T_2 = 550 \text{ mK}$, $T_4 = 100 \text{ mK}$). The resistance of $R 1_{P tAu}$ is reduced by 30% at 70 mK and that of $R 4_{P tAu}$ by 75% at 20 mK. In both cases no in ection point in the tem perature dependence is observed. On the other hand the resistance of R $2_{P tA u}$ decreases by m ore than two orders of m agnitude, and reaches a constant value below 100 m K $R_r = 74$. This drop of resistance disappears when increasing the magnetic eld. For all the samples we can de ne a critical eld above which the norm alstate resistance is recovered. As shown on Fig. 17 this critical eld decreases linearly with tem perature, very sim ilar to what is seen in SW NT and ropes connected to superconducting contacts. W e de ne a zero tem perature critical eld H $_{\rm c}$ as the extrapolation of H $_{\rm c}$ (T) to zero tem pera-




FIG.18: Dierential resistance of R $2_{P\ tA\ u}$ and R $4_{P\ tA\ u}$, at dierent temperatures. Right panel: Temperature dependence of I_{c} , the current at which the last resistance jumps occur in the dV=dI curves.




FIG. 19: Dierential resistance as a function of current for sam ples R1;2;4;5_{P tAu} in dierent applied elds. Sam ple R1: Fields are 0, 0.02, 0.04, 0.06, 0.08, 0.1, 0.2 and 1 T. Sam ple R2: Fields are 0, 0.2, 0.4, 0.6, 0.8, 1, 1.25, 1.5, 1.75, 2, and 2.5 T. Sam ple R5: Fields are 0.02, 0.04, 0.06, 0.08 T. Sam ple R4: Fields are 0, 0.02, 0.06, 0.1, 0.15, 0.2 and 0.4 T. Bottom : Field dependence of I_c for sam ples R 2_P tAu and R 4_P tAu. N ote the linear behavior.

Above the critical eld, the resistance increases with decreasing temperature, sim ilarly to ropes 3 and 6, and becomes independent of magnetic eld. Fig. 18 and Fig. 19 show that in the temperature and eld range where the zero-bias resistance drops, the dierential resistance is strongly current-dependent, with lower resistance at low current. These data suggest that the ropes 1, 2 and 4 are superconducting. A librough the experimental curves for R $2_{\rm P}$ thue look sim ilar to those of SW NTs connected to superconducting contacts¹¹, there are major dierences.

ture (see Fig. 17).

In particular the V (I); dV=dI (I) do not show any supercurrent because of the existence of a nite residual resistance due to the contacts being norm al.

Before analyzing the data further we wish to emphasize that this is the st observation of superconductivity in wires having less than one hundred conduction channels. Earlier experim ents in nanow ires 38,40,48 dealt with at least a few thousand channels. We therefore expect a strong 1D behavior for the transition. In particular, the broadness of the resistance drop with temperature is due to large uctuations of the superconducting order param eter in reduced dim ension starting at the 3D transition temperature T . In the following we will try to explain the variety of behaviors observed taking into account several essential features: the large norm al contacts, together with the nite length of the sam ples com pared to relevant m esoscopic and superconducting scales, the num ber of tubes within a rope, the am ount of disorder and intertube coupling. We rst assume that all ropes are di usive conductors but we will see that this hypothesis is probably not valid in the more ordered ropes.

A. Norm alcontacts and residual resistance

We rst recall that the resistance of any superconducting wire measured through normal contacts (an NSN junction) cannot be zero : a metallic SW NT, with 2 conducting channels, has a contact resistance of half the resistance quantum, $R_Q = 2$ (where $R_Q = h = (2e^2) = 12.9$ k), even if it is superconducting. A rope of N m parallel metallic SW NT will have a minimum resistance of $R_Q = (2N_m)$. Therefore we use the residual resistance R_r

to deduce a lower bound for the number of metallic tubes in the rope N_m = R_Q =2R_r. From the residual resistances of 74 in sample R₂ p_{tAu}, and less than 170 in R 4_{PtAu} we deduce that there are at least 90 m etallic tubes in R 2_{PtAu} and 40 in R 4_{tAu}. In both cases that means that a large fraction of tubes participate to transport and justiles a posteriori the hypothesis that ropes are diusive conductors. In the other samples we cannot estimate the number of conducting tubes because we do not reach the regime where the resistance saturates to its lowest value.

B. Estim ate of the superconducting coherence length.

A ssum ing that the BCS relation holds we get for the superconducting gap = $1.76 \text{ k}_{\text{B}} \text{ T}$: 85 eV for R $2_{\text{P} \text{ tAu}}$. We can then deduce the superconducting coherence length along the rope in the di usive lim it :

This expression yields $_2$ 0.3 m where ψ is the longitudinal Ferm i velocity 8 10^5 m/s.(Consistent with 1D superconductivity, $_2$ is ten times larger than the diameter of the rope). We now estimate the superconducting coherence length of the other sam ples, to explain the extent or absence of observed transition. Indeed, investigation of the proximity e ect at high-transparency NS interfaces has shown that superconductivity resists the presence of normal contacts only if the length of the superconductor is much greater than 50 . This condition is nearly fulled in R $_{\rm P\ tA\ u}$ ($_2$ $L_2=3$). Using the high tem perature resistance values and assuming a gap equal to that of R $_{\rm P\ tA\ u}$ we nd $_1$ $L_1=2$, $_4$ $L_4=2$, $_3$ $_2L_3$, and $_6$ $_2L_6$. These values explain qualitatively the reduced transition tem perature of R $_{\rm P\ tA\ u}$ and R $_{\rm P\ tA\ u}$ and the absence of a transition for R $_{\rm P\ tA\ u}$ and R $_{\rm P\ tA\ u}$. M oreover we can argue that the supercon-

These values explain qual- $2L_3$, and $_6$ 3 itatively the reduced transition temperature of R $1_{P tA u}$ and R $4_{P tA u}$ and the absence of a transition for R $3_{P tA u}$ and R $6_{P tA u}$. M oreover we can argue that the superconducting transitions we see are not due to a hidden proxin ity e ect : if the $A l_2 O_3 = P t = A u$ contacts were made superconducting by the laser pulse, the shortest ropes (3 and 6) would become superconducting at tem peratures higher than the longer ones (1, 2, 4). It is how ever not possible to explain the behavior of the sample 5 with the sam e kind of argum ent, since the sam e expression yields a coherence length 5 much shorter than the length of the sample, and nonetheless no complete transition is seen. We believe that this is due to the strong disorder in this sample which is very close to the localization lim it. Fig.17 shows that the transition even disappeared after therm alcycling when an increase of room temperature resistance led to complete localization at low temperature.

C. Role of the num ber of tubes.




FIG.20: Resistance as a function oftem perature (continuous line) and m agnetic eld (scatter points) for samples R $2_{P tAu}$ and R $4_{P tAu}$. Insets: TEM m icrographs of the samples.

A nother a priori in portant param eter is the number of tubes in a rope: the less tubes in a rope, the closer the system is to the strictly 1D limit, and the weaker the transition. If we compare the two ropes in Fig. 20, it is clear that the transition both in temperature and magnetic eld is much broader in the rope R $4_{P tAu}$ with only 40 tubes than in the rope R $2_{P tAu}$ with 350 tubes. M oreover there is no in exion point in the temperature dependence of the resistance in the thinner rope, typical of a strictly 1D behavior. We also expect a stronger screening of e-e interactions in a thick rope compared to a thin one, which could also favor superconductivity as we will discuss below.

D. Role of disorder and intertube coupling

As is clear from expression (1) for the superconducting coherence length, disorder is at the origin of a reduction of the superconducting coherence length in a di usive sam ple compared to a ballistic one and can in this way also decrease the destructive in uence of the norm alcontacts. M ore subtle and speci c to the physics of ropes, we have seen that disorder also enhances the intertube coupling, so it can increase the dimensionality of the superconducting transition: weakly disordered ropes like R1 and R4 will be m ore 1D -like than the m ore disordered rope R2. Of course disorder m ust always be su ciently sm all so as not to induce localization. These considera-




FIG.21: Resistance as a function of temperature for all samples which undergo a transition, plotted in reduced units $R=R_{m\ ax}$ and T=T.

tions m ay explain the variety of behaviors observed and depicted in Fig 21.

Finally, disorder is also the essential ingredient which reveals the di erence between the norm all state and the superconducting state. In a ballistic rope we would not




FIG. 22: a Resistance of R $2_{P tAu}$ plotted on a log scale as a function of the inverse temperature at H = 0. We have subtracted the low temperature residual resistance (contact resistance). The slope yields an approximate activation energy of 0.8 K which has to be compared to the condensation energy E of Cooper pairs in a sample of length E = M n (E f)² / 1K. Note that this characteristic energy is much smaller in our samples containing only one hundred channels than in whiskers where phase slips can only be observed very close to T_c. b-V (I) and $\frac{dV}{dI}$ (I) curves showing the hysteretic behavior in V (I) at each peak in the $\frac{dV}{dI}$ (I) curve for sample R $2_{P tAu}$

expect to observe a variation of the resistance over the superconducting transition because in both cases the resistance of the rope is just the contact resistance.

To gain insight in the transport regime, we have performed shot noise measurements of the ropes $R1;3;4;6_{P tAu}$, in the normal state (higher level of 1/f noise in them ore resistive ropes $R2;5_{P tAu}$ made the analysis of shot noise in possible in those sam ples), between 1 and 15 K.W e found a surprisingly strong reduction of the shot noise, by more than a factor 100, which is still not well understood, but would indicate that all the tubes in these ropes are either completely ballistic or completely localized²⁹, in strong apparent contradiction with the observation of the superconducting transition of $R4_{P tAu}$, with a 60% resistance drop.

It would however be possible to explain a resistance decrease in ballistic ropes turning superconducting, if the number of conducting channels is larger for C ooper pairs than for individual electrons. In his recent theoretical investigation of superconductivity in ropes of SW NT, G onzalez⁵¹ has shown the existence of a nite intertube transfer for C ooper pairs, even between two tubes of different helicities which have no possibility of single electron intertube transfer. This C ooper pair delocalization could lead to the opening of new channels when a rope containing a mixture of insulating and ballistic tubes become superconducting.

E. Signatures of 1D superconductivity.

Rem in iscent of measurem ents of narrow superconducting metalwires⁴⁸, we nd jum ps in the di erential resistance as the current is increased (Fig. 22). For sample 2 the di erential resistance at low currents rem ains equal to R_r up to 50 nA, where it strongly rises but does not recover its norm al state value until 2.5 A. The jump in resistance at the rst step corresponds approxim ately to the norm all state resistance of a length $_2$ of sample 2. Each peak corresponds to a hysteretic feature in the V Ι curve (Fig. 22b). These jumps are identied as phase slips^{37,48,49}, which are the occurrence of norm al regions located around defects in the sample. Such phase slips can be therm ally activated (TAPS), leading to a roughly exponential decrease of the resistance instead of a sharp transition, in qualitative agreem ent with our experim ental observation (Fig. 22a). At su ciently low temperature, TAPS are expected to be replaced by quantum phase slips, which, when tunneling through the sample, contribute an additional resistance to the zero tem perature resistance.

A lso, in sample 2 the current at which the rst resistance jump occurs (60 nA, see Fig. 19) is close to the theoretical critical current of a di usive superconducting wire⁴⁷ with gap $_2 = 85 \text{ eV}$ ($I_c = _2=R \text{ e} 20 \text{ nA}$), whereas the current at which the last resistance jump occurs (2.4 A, see Fig. 18) is close to the theoretical critical current of a ballistic superconducting wire with the same num ber of conducting channels $I_c = _2=R_re 1 \text{ A}^{49}$.

We also expect this current $I_{\rm C}$ = $_2=R_{\rm r}e$ to be the critical current of a structure with this same wire placed between superconducting contacts with gap $_{\rm S}$ even if $_{\rm S}$ < $_2$), and can thus be much larger than the Am begaokar-Barato prediction $R_{\rm N}$ $I_{\rm C}$ $_{\rm S}=e^{41}$. Intrinsic superconductivity might thus explain the anom abusly large supercurrent measured in the experiments described in the previous section, where nanotubes are connected to superconducting contacts. It is also interesting to compare the low tem perature quadratic dependence of the critical currents which is very similar in all sam ples both on norm al and superconducting contacts.

F. E ectofmagnetic eld

It is di cult to say a priori what causes the disappearance of superconductivity in carbon nanotubes. The value of H_c (0) should be compared to the depairing eld in a conned geometry⁵³, and corresponds to a ux quantum ₀ through a length p of an individual SW NT of diameter d, $_0H_c = _0=(2^{-1}d) = 1.35$ T.But H_c (0) is also close to the eld $_0H_p = = _B = 1.43$ T at which a paramagnetic state becomes more favorable than the superconducting state^{54,55}. Note that this value is of the same order as the critical eld that was measured on SW NT connected between superconducting contacts, i.e.

much higher than the critical eld of the contacts.

The linear dependence of the critical current with m agnetic eld observed in all sam ples is very similar to the data presented in the previous section on SW NT on superconducting contacts and appears strongly related to the linear dependence in T_c (H). This linear scaling with m agnetic eld is surprising since it is not expected to take place in a 1D system and is more typical of 2D superconductivity⁵². A depairing m echanism based on spin splitting of the quasiparticle energy states could how ever provide a possible explanation. Experiments perform ed with various eld directions com pared to the tube are thus necessary for a better understanding of the in uence of magnetic eld on superconductivity in carbon nanotubes.

VI. CONCLUSION

Data depicted in the previous section show the existence of intrinsic superconductivity in ropes of carbon nanotubes which number of tubes varies between 30 and 400. The question of the existence of superconducting correlations in the limit of the individual tube cannot be answered yet. It is of course tem pting to consider the high supercurrent m easured on superconducting contacts as a strong indication that superconducting uctuations are present also in individual carbon nanotubes. However since unscreened Coulomb repulsive interactions in these samples are expected to suppress superconductivity, precise investigations of individual carbon nanotubes on norm al contacts are necessary. It is essential to conduct experiments on su ciently long samples (like the ropes presently studied) so that intrinsic superconductivity is not destroyed by the norm alcontacts. Note that recent m agnetization experim ents⁵⁶ also strongly support the existence of superconducting uctuations below 10 K in very sm all diam eter (0.4 nm) individual tubes grow n in zeolites.

W e now discuss what could be the relevant m echanism for superconductivity in carbon nanotubes. Observation of superconductivity in carbon based com pounds was reported a long time ago. First in graphite intercalated with alkali atoms (Cs,K), superconducting transitions were observed between 0.2 and 0.5 K^{57} . Much higher tem peratures were observed in alkali-doped fullerenes58 because of the coupling to higher energy phonons. In all these experiments it was essential to chemically dope the system to observe superconductivity. There is no such chem ical dopants in the ropes of carbon nanotubes studied here. As shown in previous works there is some possibility of hole doping of the tubes by the gold m etallic contacts which electronic work function is larger than in the tubes^{59,60}. However, although this doping could slightly depopulate the highest occupied energy band in a sem iconducting tube it is very unlikely that it is strong enough to depopulate other lower energy subbands for a metallic tube with a diameter in the nm range. More

interesting would be a mechanism related to the 1D electronic structure of carbon nanotubes. A purely electronic coupling mechanism has been indeed shown to induce superconducting uctuations in coupled double chain systems such as ladders⁶¹. The relevance of this mechanism has been considered also in carbon nanotubes away from half lling but the very small order of magnitude for the energy scale of these superconducting uctuations is not compatible with our ndings⁵.

Recent estimations of the electron phonon coupling coupling constants⁵¹,⁶²,⁶³ in carbon nanotubes seem to be more promising. It is shown that the breathing modes speci c to carbon nanotubes can be at the origin of a strong electron phonon coupling giving rise to attractive interactions which can possibly overcome repulsive interactions in very small diameter tubes . The possi-

ble coupling of these rather high energy modes to low energy compression modes in the nanotube have been also considered, following the W enzel Bardeen singularity scheme initially propose by Loss and M artin where low energy phonons are shown to turn repulsive interactions in a Luttinger liquid into attractive ones and drive the system towards a superconducting phase⁶⁴. The suspended character of the sam ples m ay be essential in this m echanism.

APPENDIX A: PROXIMITY INDUCED SUPERCONDUCTIVITY IN MULTIWALL CARBON NANOTUBES.




FIG.23: Top: IV curves of a multiwall nanotuber ounted on tin contacts for various values of tem perature. The characterisation by transm ission electron microscopy yields the diameters of the external and sm allest internal shell respectively equal to: 25 and 12 nm which corresponds to a multiwall nanotube of approximatively 40 shells. Bottom: Magnetoresistance measured at 60m K.

We have also investigated multiwall carbon nanotubes on tin contacts. We show in Fig. 23 the IV curves recorded at several temperatures on a multiwall carbon nanotube with a normal state resistance of 10 k . The curves do not exhibit a clear Josephson behavior like in ropes but only linearities in the IV curves. It is how ever possible to de ne a characteristic current of the order of 30 nA (i.e. very sm all compared to the values of critical currents observed in ropes). Moreover there is no sign of phase slips. The magnetoresistance is a non monotonous function of magnetic eld, this behavior has already been observed in am orphous superconducting wires.
