W e propose an inductive m ethod to m easure critical current density  $J_c$  in bulk superconductors. In this method, an acm agnetic eld is generated by a drive current  $I_0$  owing in a sm all coilm ounted just above the at surface of superconductors, and the third-harm onic voltage  $V_3$  induced in the coil is detected. W e present theoretical calculation based on the critical state m odel for the ac response of bulk superconductors, and we show that the third-harm onic voltage detected in the inductive m easurements is expressed as  $V_3 = G_3 ! I_0^2 = J_c$ , where ! = 2 is the frequency of the drive current, and  $G_3$  is a factor determined by the con guration of the coil. W e m easured the  $I_0$ - $V_3$  curves of a melt-textured Y Ba<sub>2</sub>C u<sub>3</sub>O<sub>7</sub> bulk sample, and evaluated the  $J_c$  by using the theoretical results.

Large melt-textured RE-Ba-Cu-O (where RE represents rare-earth elements) superconductors can trap strong magnetic elds, and have been developed for high-eld engineering applications.<sup>1</sup> The trapped eld is proportional to the critical current density  $J_c$ , and a nondestructive and contactless method is desirable to measure  $J_c$  distribution in large-sized superconductors.

C laassen et al<sup>2</sup> proposed a nondestructive and contactless m ethod to m easure  $J_c$  in superconducting Im s, and the scienti c basis of this inductive technique was theoretically justi ed.3,4 In that method an ac magnetic eld is generated by a sinusoidal drive current  $I_0 \cos!t$ owing in a coil close to the upper surface of a superconducting lm, and the amplitude  $V_3$  of the third-harm onic voltage  $V_3 \cos(3! t + \#_3)$  induced in the coil is simultaneously measured. For superconducting lm s of thickness  $d_f$ ,  $V_3$  is detected when  $I_0 > I_{c0}$ , where  $I_{c0} / J_c d_f$  is the threshold current at which the sheet current of the lm reaches its critical value  $J_c d_f$  and the ac magnetic eld penetrates below the  $lm \cdot {}^4$  The J<sub>c</sub> is determined from  $I_{c0}$ , and the current-voltage characteristics can be determ ined by measuring the frequency !=2 dependence of J<sub>c</sub>.<sup>5</sup>

In this letter, we theoretically calculate the ac response of bulk superconductors based on the critical state m odel,  $^{6,7}$  and derive the relationship between  $I_0$  and  $V_3$ that are measured in the inductive method. Experimental setups and measured quantities in the inductive m ethod for bulk superconductors proposed in this letter are basically the same as those in the previously developed inductive m ethod for Im s.<sup>2</sup> B ecause the thickness of bulk superconductors is much larger than that for superconducting lm s, an acm agnetic eld generated by a sm all coil placed above the bulk superconductors cannot penetrate below the lower surface of the superconductors. The harmonic voltages of bulk superconductors, however, arise from irreversible vortex m otion,<sup>7</sup> even w hen the acm agnetic eld is shielded below the lower surface of the bulk superconductor. Our theoretical calculations described in this letter show that the  $I_0-V_3$  curves for bulk superconductors signi cantly di er from those for  $\ln s_r^{2,3,4,5}$  but are similar to those for superconducting rods.7,8

First, we theoretically calculate the ac response of a

bulk superconductor of thickness d situated at d < z < 0, where the upper surface is at z = 0 and the lower surface at z = -d. A single coilm ounted just above the superconductor is used to generate an ac magnetic eld and to detect the induced voltage.<sup>2</sup> The bulk superconductor is considered to extend in nitely in the xy plane, and thus the electrom agnetic elds are not a ected by the edges of the bulk superconductor sample. The edge e ects are negligible if the distance between the sam – ple edge and the coil edge is larger than the radius of the coil.<sup>2,9</sup> W e consider a coil of circular shape that produces axially symmetric elds independent of azim uth

in cylindrical coordinates (;z) = (;;z). Current density J = J(;z;t)^, sheet current K = K(;t)^, and vector potential A = A (;z;t)^ have only azim uthal components. A lthough the magnetic eld H has both a radial component H parallel to the superconductor surface and a z component H<sub>z</sub> norm al to the surface, we assume that H plays a crucial role in determ ining the ac response of the bulk superconductors. The shielding current J<sub>s</sub> ow ing near the surface prevents penetration of m agnetic ux into the bulk superconductors, and J<sub>s</sub> m ostly cancels out H<sub>z</sub> near the surface of the bulk superconductors, H j H<sub>z</sub> jfor z 0.

A drive current  $I_0 \cos t$  owing in the coil produces an acmagnetic eld, and its radial component at z = 0is given by

The coil-factor function  $F_1\left( \right. \right)$  is determ ined by the conguration of the coil,

where N is the number of windings,  $S_c = (R_2 - R_1) (Z_2 - Z_1)$  is the cross-sectional area of the coil in the z plane at  $R_1 < - < R_2$  and  $Z_1 < z < Z_2$  where  $Z_1 > 0$ .

Responding to the acm agnetic eld H $_0$ , shielding current density  $J_s$  is induced near the surface of the bulk superconductor,  $_0 < z < 0$ , where  $_0$  is the uxpenetration depth that is smaller than the thickness d

of the bulk superconductor. The vector potential arising from J<sub>s</sub> is given by

where the integral region S<sub>sc</sub> corresponds to the surface of the bulk superconductor in the xy plane, i.e., 0 < 0 < 1and 0 < 0 < 2. The A<sub>s</sub> is expressed as the multipole expansion,  $A_s = A_{s1} + A_{s2} +$ foir jzR<sub>2</sub>, where

The K<sub>s</sub>(;t) =  $\begin{bmatrix} R_0 \\ 0 \end{bmatrix} dz J_s(z;t)$  is the sheet current, Ř<sub>0</sub> <sub>0</sub> dz (zź) and M  $_{s}$  (;t) = M  $_{s}$  (;t) ^ =  $J_s(;z;t)$  is the sheet magnetic moment.

The magnetic ux linked in the coil of N 1 wound by a thin wire is calculated as

where the rst term in the right-hand side of Eq. (6) arises from the drive current, and L<sub>c</sub> is the selfinductance of the coil. The remaining terms in Eq. (6), s1 + s2 + perconductor; s1 is due to K s and s2 is due to M s. The ratio of  $j_{s2} \neq j_{s1}$  j is on the order of  $_0 = R_2$  for  $Z_2 < R_2$ , whereas  $j_{s1}j$  is on the order of  $L_cI_0$ . Because the ratio  $_0=R_2$  is typically on the order of 0.01 or less, we can neglect  $_{s2}$  to obtain the linear response to  $I_0$ . The nonlinear response of bulk superconductors, how ever, arises from  $_{s2}$ , as we show below  $^{10}$ .

When the ac eld does not reach the lower surface of a bulk superconductor (i.e.,  $2 H_0 j < J_c d$  and  $_0 < d$ ), the sheet current is given by  $K_s = 2H_0$  (where  $\frac{1}{K_s} j < J_c d$ ), the ac magnetic eld at the surface of the superconductor (z = 0) is also given by  $2H_0$ , and the magnetic ux due to the sheet current is simply expressed as  $_{s1} = L_{ci}I_0 \cos!t$ , where  $L_{ci}$  is the mutual inductance between the coil and its in age.<sup>2</sup> The  $_{s2}$  is calculated as the line integral of Eq. (5) along the wire of the  $\infty i$ , and is given by  $_{s2}(t) = 2 _{0} _{0}^{-1} d F_{1}()M_{s}(;t)$ , where  $F_1$  () is given by Eq. (2). Induced voltage in the coil is given by V (t) =  $R_c I_0 \cos! t$  d = dt, which can be rew ritten as

where  $R_c$  is the resistance of the coil. The amplitude of the last term of the right-hand side of Eq. (7) is much smaller than the other terms, but the stand second term s do not contribute to the harm onic response.

The shielding current  $J_s = J_s$  (;t) induced by the ac m agnetic eld of Eq. (1) in the critical state m odel $^{6,7}$  is

given as follows:  $J_s(;t) = J_t$  for (;t) < z < 0,and  $J_s(;t) = J_t$  for  $_0() < z <$ (;t), where  $J_c$  is the critical current density. The signs ' ' (' ') represents \+ ' (` ') for 0 < !t < and ` ' (`+ ') for < !t < 2.<sup>11</sup> The ux-penetration depths are given by  $_{0}() = 2I_{0}F_{1}()=J_{c}$  and  $(;t) = _{0}()(1)$  $\cos ! t$  =2. Then, the sheet m agnetic m om ent M  $_{s}$  (;t) = R<sub>0</sub>  $dz(z)J_{s}(z;t)$  is calculated as

The harm onic voltages are given by  $V_n = 0$  for even n =2; 4; 6; :::<sup>11</sup> and  $V_n = 5V_3 = (n^2 \quad 4)$  for odd n = 3; 5; 7; :::.The third-harm onic voltage is

where G<sub>3</sub> is the coil factor determ ined by the con guration of the coil. The fundam ental voltage  $V_1 \cos(!t + \#_1)$ , arise from the shielding current in the suin Eq. (9) is a ected by the impedance of the coil, R  $_{\rm c}$  and ! ( $L_c$   $L_{ci}$ ). Equation (10) is similar to  $V_3$  derived by Bean<sup>7</sup> to determ ine averaged  $J_c$  over the surface of cylindrical superconductors exposed to a uniform acm agnetic eld. Note that Eq. (10) is applicable to evaluate local J<sub>c</sub> distribution at the at surface of large bulk superconductors responding to a nonuniform ac magnetic eld.

Next, we demonstrate evaluation of  $J_c$  by using the theoretical result of Eq. (10) from our experim ental data for a melt-textured YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> (YBCO) bulk superconductor sample. The YBCO sample was 12:1 12:7mm<sup>2</sup> and 0:9mm thick. The third-harm onic voltage induced by the YBCO sample was measured by using the experimental setup described in Ref. 5. Although our experim ental setup was sim ilar to that in Refs. 2 and 3, an additional cancel coil was needed to compensate for harm onic noise voltages.<sup>5</sup> The coil used to generate the acm agnetic eld and to detect the induced voltage had N = 400 turns and dim ensions of inner diam eter of  $2R_1 = 1.0 \text{ mm}$ , outer diameter of  $2R_2 = 3.5 \text{ mm}$ , and height of  $Z_2$   $Z_1 = 1.0 \text{ mm}$ . The distance between the coil and the surface of the sample was  $Z_1 = 0.25 \text{ mm}$ . A dc magnetic eld B<sub>dc</sub> was applied perpendicular to the at surface of the sample (parallel to the caxis of YBCO).




FIG. 1: Drive current  $I_0$  dependence of the square root of the third-harmonic voltage  $V_3^{1-2}$  for a melt-textured YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> sample at 77K and !=2 = 1kHz. A dcm agnetic eld B<sub>dc</sub> was applied perpendicular to the wide surface of the sample.

Figure 1 shows the square root of the measured thirdharm onic voltage  $V_3^{1=2}$  as a function of the drive current I<sub>0</sub> for the YBCO bulk superconductor sample. The tted lines for the data of  $B_{dc} = 1$  and 3T intersect the origin, and are consistent with Eq. (10). We can evaluate  $J_c$  from the slope of the lines in Fig. 1 by using Eq. (10), where the coil factor calculated by using Eqs. (2) and

(11) is  $G_3 = 735$  sec/m<sup>2</sup> for the collused in our measurements. The resulting  $J_c$  values are 1:7 10<sup>6</sup> and 1:0 10<sup>6</sup> A/m<sup>2</sup> for  $B_{dc} = 1$  and 3T, respectively.

The tted line for the data of  $B_{dc} = 0 T$  in Fig.1 does not intersect the origin, suggesting the following empirical equation for  $I_0$ - $V_3$ :

where  $J_c = 1.9 \quad 10^{\circ} \text{ A/m}^2$ . The threshold current is  $I_{c1} = 11 \text{ mA}$ , which corresponds to the acmagnetic eld  $2_0 \text{ H}_0 \text{ j}$  2mT at the surface of the bulk superconductor sample. The threshold current  $I_{c1}$  might be reected by the lower critical eld or surface barrier eld.

The importance of such barrier elds has been realized in harm onic-voltage m easurem ents.<sup>8</sup>

A rough estimate of the electric eld E  $_{\rm s}$  induced at

the surface of the bulk superconductor is given as the product of angular frequency !, ac magnetic induction  $2_0 \ddagger_0 j$  and the eld penetration depth  $_0 = 2 \ddagger_0 j = J_c$ :

Both the E<sub>s</sub> induced in the bulk superconductors and V<sub>3</sub> induced in the coil are proportional to  $!I_0^2=J_c$ , and thus, the ratio V<sub>3</sub>=E<sub>s</sub> (5 cm for the coil used in our m easurements) is governed only by the conguration of the coil. The third-ham onic voltage of V<sub>3</sub> 0.05 mV, which is the typical order of V<sub>3</sub> shown in Fig. 1, in plies that the electric eld induced at the surface of the bulk superconductor is on the order of E<sub>s</sub> 1mV/m, which is much larger than that in the magnetization measurements.<sup>12</sup> Because E<sub>s</sub> / !, we can measure J<sub>c</sub>-E<sub>s</sub> curves (i.e., current-voltage characteristics) by measuring ! dependence of J<sub>c</sub>, as demonstrated for lm s.<sup>5</sup>

In sum m ary, we theoretically and experim entally investigated the third-harm onic voltage  $V_3$  in response to an acm agnetic eld generated by a sinusoidal drive current In a small coil placed just above bulk superconductors. The theoretical third-harm onic voltage induced in the coil is given by Eq. (10). The experimental data of melt-textured YBCO bulk samples for B<sub>dc</sub> 1 Tare consistent with Eq. (10), and the  $J_c$  values can thus be evaluated from the experimental data. These results show that the distribution of J<sub>c</sub> in large-sized bulk superconductors can be determined by measuring I0-V3 curves with a scanning coil (or xed multiple coils) and using Eq.(10). We can measure  $J_{\rm c}$  only near the surface (i.e., J<sub>c</sub> for  $_0 < z < 0$ ) of bulk superconductors, whereas information on J<sub>c</sub> deep inside bulk superconductors can not be obtained by this method.

- $^{10}$  For superconducting  $\,$  lm s, nonlinear response arises from  $_{\rm s1}$  when  $I_0$  >  $\,I_{c0}$ , and thus the sm all contribution from

 $_{\rm s2}$  can be neglected to obtain the behavior of harmonic voltages for  $\,$  ln s, as done in the calculation in Ref. 4. W hen  $I_0 < I_{\rm c0}$ , on the other hand, linear response of  $_{\rm s1}$  does not a ect the harmonic voltage, and thus  $_{\rm s2}$  plays a crucial role in harmonic voltages. The contribution to harmonic voltages from  $_{\rm s2}$  / 1=J $_{\rm c}$  is, how ever, too small to detect in experiments for  $\,$  ln s, because J $_{\rm c}$  of  $\,$  ln s is typically 100 times larger than J $_{\rm c}$  of bulk materials. Therefore,  $V_3 = 0$  for  $I_0 < I_{\rm c0}$  in  $\,$  ln s.  $^{2,3,4,5}$

Such behavior of  $J_{s}$  and  $V_{n}$  is not accurate because  $J_{c}$  for  $0 < !t < \;$  is not identical to  $J_{c}$  for < !t < 2 when B  $_{dc}$   $\overleftarrow{e}$  0. This assumption of the periodicity of  $J_{s}$ , however, is a good approximation and the even harmonics are generally much sm aller than the odd harmonics.
