Fluctuation spectrum and size scaling of river ow and

level

Abstract

We describe the statistical properties of two large river systems: the Danube and the M ississippi. The properties of the two rivers are compared qualitatively to the general properties of a critical steady state system. Speci cally, we test the recent suggestion by Bramwell, Fennell, Holdsworth and Portelli Europhys. Lett. 57, 310 (2002)] that a universal probability density function (PDF) exists for the uctuations in river level, namely the Bramwell Holdsworth Pinton (BHP) PDF. The statistical properties investigated in this paper are: the PDF of the river ow and river level; moment scaling with basin area; moment to moment scaling or relative scaling; and power spectral properties of the data. We nd that the moments of the ow scale approximately with basin area and that the seasonally adjusted ow s exhibit relative moment scaling.

C om pared to the M ississippi, the D anube shows large deviations from spatial scaling and the power spectra show considerable dependence on system size. This might be due to water use and regulations as well as inhom ogeneities in the basin area. W e also nd that the PDF of level data in some, but not all, cases can be qualitatively approximated by the BHP PDF.W e discuss why this coincidence appears to be accidental.

Keywords: River systems; universal uctuations; nite size scaling; multiscaling.

1 Introduction

The spatial structure of river basins and the statistics and dynamics of the ow of rivers have been analysed by a number of authors using methods from statistical mechanics. Rinaldo found that river basins are spatial fractals [R odriguez-Turbe and R inaldo, 1997]. The ow of rivers were found to exhibit scaling [Thom as and Benson, 1970] and multiscaling [G upta and W aym ire, 1990] with basin area for basins ranging from 10 to 10³ km². Tem poral correlations, when analysed by means of the power spectrum, are also considered to be multiscaling or multifractal with respect to time [G upta and W aym ire, 1990, P andey et al., 1998, Tessier et al., 1996]. Perhaps the most remarkable link to system s in statistical mechanics is an observation by B ram well, Fennell and Portelli [B ram well et al., 2002]. They found that the probability density function (PDF) of the uctuations of river level at N agym aros, which is on the D anube, is in good agreement with a PDF found for the magnetic uctuations in the classical XY model close to criticality [B ram well et al., 2000b]. W e will refer to this PDF as the B ram well+H oldsworth-P inton (BHP) PDF. The data from the N agym aros was published in [Janosi and G allas, 1999] and the t proposed by B ram well et al., as checked visually in [B ram well et al., 2002].

The BHP PDF has been described and characterised by Bram well et. al.

[Bram well et al., 2000b]. It has also been found in one experim ental system and in computer simulations of SOC -m odels [Bram well et al., 1998, Bram well et al., 2000a],

[D ahlstedt and Jensen, 2001, P inton et al., 1999, Sinha-R ay et al., 2001]. These investigations indicated that the BHP PDF describes uctuations in m any very di erent systems. It was suggested that the BHP PDF m ight be universal and ubiquitous in nature arising in systems which lack a characteristic length scale and exhibit nite size scaling sim ilar to critical equilibrium systems.

Inspired by these observed links to statistical mechanics and scale invariance, we want to address the following questions: Do the statistics of river ow and level height typically exhibit scaling and, if so, what type of scaling? Is the observation of the BHP uctuation spectrum at N agym aros representative of uctuations of river lever in general and, if so, can the observed BHP uctuation spectrum be related to scale free aspects of the river system ? It is not clear a priori which quantity one should look for when searching for the BHP uctuation spectrum [B ram well et al., 2000b, B ram well et al., 1998, B ram well et al., 2000a, D ahlstedt and Jensen, 2001, P inton et al., 1999, Sinha-R ay et al., 2001]. W e will therefore analyse level as well as ow data.

W e approach these issues by analysing data collected from several stations, corresponding to di erent basin areas, along the rivers D anube and M ississippi, see table 1. W e also consider data from one very sm all river, the W ye at C efn B rw yn with a basin area of 10.6 km² [NW A, 2002] and one very large river, the R io N egro at M anaus with a basin area of $3 10^6$ km² [R ichey et al., 1989]. This allows us to cary out a nite size scaling analysis sim ilar to that used in statistical mechanics to study the scale free behaviour in systems with a diverging correlation length [C ardy, 1990].

It is useful to explain what we mean by nite size scaling. In equilibrium critical systems one expects that the standard deviation and the mean of the order parameter hm i scale with system size (close to criticality) such that a rescaled PDF becomes independent of system size. This is expressed by the hyperscaling relation hm i / / L and the nite size scaling (FSS) hypothesis [C ardy, 1990, A ji and G oldenfeld, 2001].

The FSS hypothesis can generally be written as

which holds if the system is in a critical state [B ram well et al., 2000b, A ji and G olden feld, 2001]. If the spatial correlation length is in nitely larger than L, i.e. $\frac{L}{2}$! 0, then we can make the approximation

The FSS hypothesis leads to a scaling of the moments which we can write as

where = . This will be referred to as simple scaling. The simple scaling of the moments can be extended to multiscaling by letting the moments of the order parameter m scale as

This extension of m on ent scaling is incompatible with the simple FSS hypothesis and with hyperscaling.

The FSS hypothesis does not hold in the following three cases: the correlation length does not diverge and corrections due to the nite length of in relation to the system size have to be accounted for; the moments are multiscaling and the hypothesis needs to be changed; more than one scaling eld exists in the system, such that

In the last case, the FSS hypothesis can hold approximately if there is one dom inant scaling eld and all the other scaling elds are irrelevant Forgacs et al., 1991].

The paper is structured in the following way. We begin by considering river ow. In Secs. 2, 3 and 4 we discuss the PDF, the scaling and multiscaling analysis and the power spectrum analysis of river ow. In Sec. 5 we present the PDF of the uctuations in the river level and Sec. 6 contains a discussion and our conclusions.

To avoid m isunderstandings we mention that we use the following notation. The river ow is denoted by q and the height of the river level by h. The seasonally adjusted ow and height (de ned in the appendix) is denoted by s_q and s_h respectively.

2 RiverFlow

In this section we present the com parison of the PDFs of seasonally adjusted ow data with varying basin area from the sites listed in table 1. The signal we consider is equal to the deviation from the average, over all years, at a speci c day, say 5th of febuary, norm alised by the standard deviation of that particular day. We defer details to the appendix. This seasonally adjusted signal has by construction a zero mean and a standard deviation equal to one. Thus no further scaling is needed in order to plot the PDF of the seasonally adjusted data in the form used previously to check for Gaussian and BHP like behaviour, see e.g. Bram well et al., 1998, Bram well et al., 2000a].

Fig. 1 shows the PDF of the seasonally adjusted ow for the river M ississippi. We plot the seasonally adjusted ow along the x-axis and the logarithm of the PDF along the y-axis. A norm all distribution will appear as a parabola in this plot. We note that the tails of the distributions vary slightly but there is an approxim ate data collapse. Hence adjusting for seasonal variation cancels the dependence on system size.

In Fig.2 we show a similar plot for the D anube. In this plot, we can see a de nite change of the PDF shape from the small basin area site, at D illingen, to the large basin area site at C eatal Izm ail. The shift in PDF is towards a G aussian and it suggests that the spatial correlation length of the system is shorter than the system size at the largest site leading to a sum of uncorrelated contributions to the ow. From the PDF analysis we expect the hyperscaling relationship and simple scaling to hold for the river M ississippi but not for the D anube. We also note that the PDF of the uctuations in the ow deviates strongly from the BHP PDF, indicated by the dashed line in both gures. As we shall see in Sec. 5, the situation is more subtle for river level data.

Let us now consider the m ean and the standard deviation of the \raw " data for which no adjustment for seasonal variation has been carried out. Fig. 3 compares the scaling of the m ean with the basin area, L, and the scaling of the standard deviation with L. The m ean and standard deviation scale approximately as hqi / $L^{1:08}$ and $_{\rm q}$ / $L^{1:05}$ for the M ississippi and for the river D anube approximately as hqi / $L^{0:87}$ and $_{\rm q}$ / $L^{0:79}$. The exponents for hqi and $_{\rm q}$ are close, i.e. the hyperscaling relationship is approximately fullled for both rivers, though with greatest accuracy for the M ississipi data.

The analysis shows that the data collapse of the M ississippi ow data is in fairly good agreement with the FSS hypothesis of equation 1 and simple scaling of the rst two moments. The D anube has a larger deviation from the hyperscaling relationship, which we also expected from the analysis of the PDFs. This deviation m ight be due to a spatial decorrelation of the process, as we mentioned earlier. There m ay be several reasons for the decorrelation, such as inhom ogeneities in the basin area and hum an regulation of the river.

3 Scaling of higher m om ents and m ultiscaling

W e now present data on the scaling of the higherm on ents of the ow for the M ississippi and the D anube. W e have shown that both rivers approximately full the hyperscaling relationship. However, both rivers show deviations from simple scaling that look like multiscaling. The scaling exponents can be expressed as a function of moment-order n. This function is shown in Fig. 4.

We have also looked at the scaling of skewness h(m hm i)³ i= ³ and kurtosis h(m hm i)⁴ i= ⁴ 3 of the data. G iven the analysis above and assuming the data is multiscaling the skewness and kurtosis should not be constants and they should scale with basin area. For both the river M ississippi and the D anube, skewness and the kurtosis as functions of basin area do not t a power-law, as shown in Fig. 5. Despite this, there is a simple power-law relationship between the skewness and kurtosis. This is given by kurt / skew^{2:75} for the M ississippi and kurt / skew^{1:78} for the D anube. Thus both rivers have system – atic corrections to simple scaling that certainly look like multiscaling but, since the higher rescaled m om ents do not scale with basin area, neither of the rivers multiscale according to the standard de nitions.

The deviations from multiscaling can also be seen in the seasonally adjusted data. The moments of the seasonally adjusted river M ississippi ow as a function of basin area do not

t a power-law as seen in Fig. 6. Even so, the higher m om ents scale as power laws of the 3^{rd} m om ent with di erent exponents. W e refer to this type of scaling as relative scaling of m om ents. The exponents are shown in Fig. 7 as functions of m om ent-order n.

W e de ne the relative scaling as

A ssum ing that the moments follow simple scaling it is easy to see that K $(n;n^0) = 0$, and if the moments are multiscaling, relative scaling should be satisfied with the exponent K $(n;n^0)$

related to (n). So for the M ississippi and the D anube we found that multiscaling is not fulled and hence the observed relative scaling must have a di erent origin.

Relative scaling is also possible if we consider a weak secondary scaling eld, such that the moments scale as

If (2) 0 and hm i = 0, then / L_1 and hm $ni = n / L_2^{n}$ (n). In this way relative scaling is possible even if hm ni = n does not scale with L_1 . For a related situation in equilibrium system s see [Forgacs et al., 1991, F isher and G elfand, 1988].

The assumption of more than one scaling eld is supported by a previous study of river basin characteristics. Regression analysis of di erent basin characteristics has shown that river ow is a ected by many other features, in in addition to basin area, such as channel slope, precipitation and others [Thom as and Benson, 1970].

4 Power Spectra of R iver F low

We now want to exam ine the signs of scale free behaviour from a tem poral point of view and study the long time correlations by means of a power spectral analysis for the rivers D anube, M ississippi, R io N egro and the W ye. G enerally the power spectra of rivers have two di erent frequency regimes of power-law-like nature [Tessier et al., 1996]. The two regimes are separated by a cross-over frequency f_c . M ost river ow data is also considered to be multiscaling/multifractal with respect to time [G upta and W aym ire, 1990, P andey et al., 1998, Tessier et al., 1996]. In these studies data from di erent sites and rivers are considered to be realisations of the the same process and the power spectra are averaged over all sites and there are generally no references to how the cross-over frequency changes with basin area. H ere we explicitly study the dependence of the power spectrum on the basin area and we nd that f_c changes with basin area for the D anube but not for the M ississippi.

The M ississippi sites all have approximately the same spectrum which consists of two power-law-like regimes separated by a cross-over frequency f_c corresponding to approximately 20-40 days. In the low frequency domain the power-law has an exponent close to 1 corresponding to logarithm ic decaying correlations in the long time limit (see e.g. [Jensen, 1998]) and for high frequencies an exponent close to 3, as can be seen in Fig. 8. This indicates that the ow of the M ississippi is determined by the intrinsic, system size independent, dynamics which produces time correlations that are longer than the longest observation time. Thus, within the basin area size range investigated here we see critical-system-like behaviour: above we found that the PDF shows data collapse and that the m om ents scale; in addition we observe that the power spectra are similar for all sites in the system and exhibit 1=f behaviour down to the lowest recorded frequencies.

For the D anube the crossover f_c shifts with basin area with frequencies corresponding to approximately $1=f_c = 60$ days for C et al Izm ail and O rsova, 20 days for N agym aros and 10 days for Ingolstadt and D illigen. In the low frequency region the spectrum does to a degree behave like 1=f, see F ig. 9. However, we suggest that the trend is that as the basin area is increased, the spectrum moves towards a Lorentzian-like form, i.e. $(1 + (f=f_c)^2)^{-1}$. This would be indicative of exponentially decaying time correlations with a characteristic decay time $t_c = 1=f_c$ and no essential time correlations beyond t_c . The behaviour described here evince that the dynam ics of the D anube is non critical and that its correlation time is determined by the considered system size, or basin area. We have also considered the ow of the R io N egro at M anaus, with a very large basin area 3 10^6 km², and the ow of the W ye at C efn B rw yn, with a very sm all basin area 10.6 km². The power spectra are shown in Fig. 10.

For the R io Negro the spectrum seems to have a smooth transition between the low and the high frequency regime. The spectrum resembles, as in the case of the D anube at large basin areas, a Lorentzian form. Clearly it is not possible to identify accurately the characteristic frequency, but a value of about $1=f_c=600$ days seems reasonable. Thus the R io Negro does not show critical power-law time correlation, though its characteristic time is very long. If we assume that long time corresponds to large spatial scales, our analysis suggests that the R io Negro is so large that its size exceeds the correlation length of the river ow. The river therefore behaves as uncorrelated at the largest spatial and temporal scales.

The dynam ics of the river W ye appears to be able to support 1=f correlations down to a characteristic frequency f_c corresponding to about 60 days. For frequencies lower than f_c the spectrum becomes white, thus the river system is so small that it cannot support correlations on time scales longer than these 60 days.

The PDFs of the ow of these two rivers are shown in Fig. 11. There is a remarkable di erence since the W ye has a nearly exponential PDF and the R io N egro has a G aussian PDF. The G aussian is consistent with our noting above that the R io N egro is so big that its dynam ics are decorrelated. The exponential tail found for the small river W ye is probably related to spatial correlations extending up to the system size. This together with the 1=f behaviour down to a certain frequency m ight re ect that the dynam ics of the river W ye is critical, but since the system is rather small, the scale free range is limited.

5 River-Level

In this section, we present the results of the analysis of river level. Fig. 12 shows four PDFs of river level. The data is from the stations C linton on the M ississippi, and D illigen, Ingolstadt and N agyram os on the D anube. The seasonally adjusted PDFs are similar at the sites of Ingolstadt, N agyram os and C linton and signi cantly dierent for the D illingen site. The data that collapses seem s to do so on or close to the BHP PDF but it is also close to a

rst order extrem e value, Fisher-Tippet-Gum bel (FTG), PDF [Gum bel, 1958]. It is di cult to determ ine visually from the histogram how good the t is.

To get a better estim ate of the t, table 5 shows the seasonally adjusted higherm om ents of the data com pared to the m om ents of the BHP and a FTG PDF [Bram well et al., 2000b]. This shows that quantitatively the t is poor.

We also investigated whether the moments of a river level full the hyperscaling relationship and scale with basin area. The relationship between the mean and the standard deviation is shown in Fig. 13. For the D anube we can make an ad hoc linear t, which does not suggest hyperscaling since the slope is negative. From a scaling analysis with basin area (not shown here) we conclude that river level is not scaling with basin area. Thus the hyperscaling and scaling is not the cause of the apparent data collapse of the data from the Ingolstadt and N agym aros sites. A lthough some of the data collapses close to the BHP, we can only conclude that river level does not in general have a single universal PDF upon rescaling. Furtherm ore, in the case where river level uctuations are reasonably well described by the BHP form, the lack of scaling prevents us from concluding that the agreem ent with the BHP PDF arises as a consequence of underlying scale free behaviour.

6 D iscussion and C onclusion

We have shown that PDFs of the uctuations of the river ow of the river M ississippi for di erent basin areas can all be approximately collapsed on to one functional form by size scaling. However, this scaling function is not of the BHP form. In addition to the data collapse we have shown that the ow follows approximately simple scaling, with deviations. In the case of the river M ississippi, the deviations resemble multiscaling though quantitative analysis reveals that the behaviour is inconsistent with multiscaling. We suggested a simple form with a weak second scaling eld, independent of basin area which m ight explain the observed relative scaling of the seasonally adjusted moments. In the case of the river D anube, the deviations from simple scaling have features in common with multiscaling. However, in this case the deviations were found to be related to spatial decorrelation between the sites along the river Consistent with the lack of size scaling collapse of the PDFs. Our conclusion is that the river M ississippi behaves like one correlated whole whereas for the D anube, correlations are destroyed as the basin area is increased.

W e sum m arise that som e degree of scale invariance can be found for rivers of interm ediate size. Hence, our analysis con rm s and extends previous observations of scaling in sm aller river system s [Thom as and Benson, 1970, G upta and W aym ire, 1990].

W e set out to determ ine whether m easurem ents of river level uctuations consistently have a universal PDF close to that of the BHP PDF. For two out of the four river sites we investigated, the average daily level PDFs approximately collapse onto one PDF. This PDF resembles to the BHP PDF but quantitatively the t is poor. The two other sites have a som ewhat dierent shape of the PDF. We also found that there is no size scaling with basin area for river level. Hence even when the BHP form is found, it cannot be related to an underlying scale free behaviour of the D anube. It would have been very interesting to be able to analyse the level data for the M ississippi. Unfortunately we could only obtain ow data for the M ississippi. Nevertheless, our analysis suggests that uctuations in river level do not in general follow the BHP functional form. The observations in [B ram well et al., 2002] appear to be accidental.

In addition to the analysis reported here we have investigated nancial data, weather data, tree ring data and other data and could not nd the BHP PDF. River level data appeared to be an exception rather than the rule. Thus, in general we are compelled to conclude that the BHP PDF is rather di cult to nd in nature.

8 Appendix

The ow of a river is generally highly dependent upon the seasons. Therefore all the data has been seasonally adjusted with the seasonal mean and seasonal standard deviation denoted hx_{i_d} and $_d$. Let x(d;y) denote the measured value of either the ow q or the level h measured at day number d in year number $y = 1; :::; N_y$. The adjusted data is de ned as

The seasonalm ean and the seasonal standard deviation are de ned as

The adjusted data have s = 1 and hsi = 0 which can easily be checked.




Figure 1: The PDF of the ow for the ve sites along the river M ississippi on a sem i-log plot. For reference, a norm alPDF (solid line), a BHP PDF (dashed line) and a power-law tail (dotted line) have been plotted.




Figure 2: The PDF of the ow for the ve sites along the D anube on a sem i-log plot. For reference, a norm al (solid line) and a BHP (dashed line) PDF have been plotted.




Figure 3: The scaling of mean and standard deviation with basin area on a log-log plot. River Mississippimean [] and []. River D anube mean [t] and [4]. The dashed line is the thqi / $L^{0.86779}$, the dashed-dotted line is the t $_{\rm q}$ / $L^{0.78994}$, the solid line is the t hqi / $L^{1.0763}$ and the dotted line is the t $_{\rm q}$ / $L^{1.0477}$. The data from the D anube has been shifted with a factor of 10 for clarity.




Figure 4: Multiscaling function n (n). The solid line is the simple scaling behaviour: the Danube [], (n) = 0.89278 0.021216n and the river M ississippi [], (n) = 1.1198 $0.046448n + 0.0026748n^2$. The error bars shown are the errors from the regression analysis.




Figure 5: Scaling of skew ness and kurtosis to basin area on a log-log plot. River M ississippi skew ness[] and kurtosis[]. River D anube skew ness[] and kurtosis[4]. The data from the D anube has been shifted with a factor of 10 for clarity.




Figure 6: Higher seasonally adjusted m om ents for the river M ississippiplotted against river basin area on a log-log plot. 3rd m om ent [] to 8th m om ent []





Figure 7: The scaling of higher seasonally adjusted moments for the river M ississippi [] and the river D anube [].




Figure 9: Power spectra for the 5 sites along the D anube, for comparison two power-laws with exponents -1 and -3 are shown The unit of frequency is inverse days.




Figure 10: Power spectra for the rivers R io Negro at M anaus and W ye at C efn B rw yn. The straight line indicates 1=f behaviour. The unit of frequency is inverse days.




Figure 11: Seasonally adjusted PDF for the rivers R io N egro at M anaus[] and W ye at C efn B rw yn [] on a sem i-log plot, com pared with an exponential and a G aussian PDF.




Figure 12: The PDF of river level for the sites Ingolstadt, D illingen, N agym aros and C linton. As reference a norm al (solid line), a BHP (dashed line) and a FTG (dotted line) PDF have been plotted.




Figure 13: The scaling of river level m ean to standard deviation for the D anube [] and M ississippi [].
