Fractional statistics in the fractional quantum H all e ect

A m icroscopic con m ation of the fractional statistics of the quasiparticles in the fractional quantum H all e ect has so far been lacking. We calculate the statistics of the composite-ferm ion quasiparticles at = 1=3 and = 2=5 by evaluating the Berry phase for a closed loop encircling another composite-ferm ion quasiparticle. A careful consideration of subtle perturbations in the trajectory due to the presence of an additional quasiparticle is crucial for obtaining the correct value of the statistics. The conditions for the applicability of the fractional statistics concept are discussed.

The fractional statistics concept of Leinaas and M yrheim [1] relies on the property that when particles with in nitely strong short range repulsion are con ned in two dimensions, paths with dierent winding numbers are topologically distinct and cannot be deformed into one another. The particles are said to have statistics

if a path independent phase 2 results when one particle goes around another in a complete loop. A half loop is equivalent to an exchange of particles, assuming translational invariance, which produces a phase factor $e^i = (1)$. Non-integral values of imply fractional statistics. There are no fundam ental particles in nature that obey fractional statistics. A ny fractional statistics objects will have to be emergent collective particles of a non-trivial condensed matter state. Furtherm ore, they will be necessarily con ned to two dimensions: in higher dimensions the notion of a particle going around another is topologically ill de ned, because any loop can be shrunk to zero without ever crossing another particle.

Even though the explanation of the fractional quantum Halle ect[2] (FQHE) and num erous other remarkable phenom ena follows from the composite ferm ion theory with no m ention of fractional statistics [3], fractional statistics is believed to be one of the consequences of incompressibility at a fractional lling [4, 5, 6], and may possibly be observable in an experiment speci cally designed for this purpose. For Laughlin's quasiholes[7] at

= 1=m, m odd, the statistics was derived explicitly by A rovas, Schrie er, and W ilczek [4] in a Berry phase calculation, but a sim ilar dem onstration of fractional statistics has been lacking at other fractions, or even for the quasiparticles at = 1=m. The need for a m icroscopic con rm ation was underscored by K j nsberg and M yrheim [8] who showed that, with Laughlin's wave function, the quasiparticles at = 1=m do not possess well-de ned statistics. The reason for the discrepancy remains unclear, but it illustrates that the fractional statistics is rather fragile and cannot be taken for granted.

The objective of this article is to revisit the issue and edwith the microscopic composite ferm ion (CF) theory of the FQHE [9]. A step in that direction has been taken by K j nsberg and Leinaas[10], whose calculation of the statistics of the \unprojected" CF quasiparticle of = 1=m, the wave function for which is di erent from

that of Laughlin's, produced a de nite value, the sign of which, how ever, was inconsistent with general considerations. We can imbelow that the statistics is robust to projection into the low est Landau level (LL), and provide a non-trivial resolution to the sign enigm a, which has its origin in very small perturbations in the trajectory due to the insertion of an additional CF quasiparticle. The calculation is extended to = 2=5 for further veri cation of the generality of the concept.

Because the CF theory provides an accurate account of the low energy physics, including incompressibility at certain fractional llings, it must also contain the physics of fractional statistics, which indeed is the case. The fractional statistics can be derived heuristically in the CF theory as follows [11]. C om posite ferm ions are bound states of electrons and an even number (2p) of vortices. W hen a composite ferm ion goes around a closed path encircling an area A, the total phase associated with this path is given by

where N_{enc} is the number of composite fermions inside the loop and $_0 = hc=e$ is called the ux quantum. The rst term on the right hand side is the usual A haronov-Bohm phase for a particle of charge e going around in a counterclockwise loop. The second term is the contribution from the vortices bound to composite fermions, indicating that each enclosed composite fermion e ectively reduces the ux by 2p ux quanta. (A note on convention: W e will take the magnetic eld in the + z direction, the electron charge to be e, and consider the counterclockwise direction for the traversal of trajectories.)

Eq. (1) sum m arizes the origin of the FQHE. The phase in Eq. (1) is interpreted as the Aharonov-Bohm phase from an elective magnetic eld: 2 B A= $_0$. Replacing N_{enc} by its expectation value N_{enc}i = A, where

is the two-dimensional density of electrons, we get

The integral quantum Halle ect[12] (IQ HE) of com posite ferm ions at CF lling = n produces the FQ HE of electrons at = n=(2pn + 1). At these special lling factors, the elective magnetic eld is B = B = (2pn + 1). The fractional statistics is also an immediate corollary of Eq. (1). Let us consider the state with CF lling n < (n+1) and denote by x = x in the positions where the composite fermions in the topmost partially

An \effective" description in terms of , which will be called CF quasiparticles (CFQP's), can in principle be obtained by integrating out $z_j = x_j$ iy_j. We can conjecture the winding properties of the CFQP's from the underlying CF theory as follows. Consider two CFQP's, su ciently far from one another that the overlap between them is negligible. A coording to Eq. (1) the phase a CFQP acquires for a closed loop depends on whether the loop encloses the other CFQP or not. When it does not, the phase is = 2 eB A=hc. The change in the phase due to the presence of the enclosed CFQP is

because a CFQP has an excess of 1 = (2pn + 1) electrons associated with it relative to the uniform state [producing a local charge of q = e = (2pn + 1)]. With = 2we get the CFQP statistics parameter

This value is consistent, mod 1, with those quoted previously [5, 6].

Our goal is to con m Eq. (4) in a microscopic calculation of the Berry phases. The statistics is given by

where is the wave function containing a single CFQP at , and ; ^{\circ} has two CFQP sat and ^{\circ}. Here we take

= Re^{i} , and C refers to the path with R xed and varying from 0 to 2 in the counterclockwise direction. For convenience, we will take $^{0} = 0$.

The calculation of requires m icroscopic wave functions which are constructed as follows. The composite ferm ion theory m aps the problem of interacting electrons at into that of weakly interacting composite ferm ions at . In order to put these composite ferm ions at , we rst construct the electronic wave function at with the electrons in the partially led level at ; these are placed in the coherent state wave packets

where $l = \frac{p}{hc=eB}$ and $l = (2pn + 1)^{1=2} lare the magnetic lengths at B and B . We then make a mapping into$

composite fermions in a manner that preserves distances (to zeroth order) by multiplying by ${}_{1}^{2p} = {}_{j< k=1}^{N} (z_{j} z_{k})^{2p} \exp [2p {}_{i} jz_{i} j^{2} = 4l_{1}^{2}]$ with $l_{1}^{2} = hc = B_{1} = hc = e_{0}$, followed by projection into the lowest LL.

To give an explicit example, consider two CFQP's at = 1=(2p+1). The electron wave function at = 1 with fully occupied low est LL and two additional electrons in the second LL at and ⁰ is

This leads to the (unnormalized) wave function for two CFQP'sat = 1=(2p + 1):

Here, P is the lowest Landau level projection operator, and we have used $1^2 + 2pl_1^2 = 1^2$ which is equivalent to Eq. (2). W ave functions for one ormany CFQP's at arbitrary lling factors can be written similarly. The lowest LL projection can be performed in either one of two ways described in the literature [13]. Our wave functions are similar to those considered in Ref. 10, but not identical.

The integrands in Eq. (5) involve 2N dimensional integrals over the CF coordinates, which we evaluate by M onte Carlo m ethod. To determ ine the O (1) di erence between two O (N) quantities on the right hand side with su cient accuracy, we use the same in portance sam pling for both the quantities on the right hand side, which reduces statistical uctuations in the di erence. The two-CFQP wave function ' is used as the weight function for both terms in Eq. (5). Approximately 4 10^8 iterations are performed for each point. For = 1=3 we have studied systems with N = 50, 100, and 200 particles, and the projected wave function is used. In this case, a study of fairly large system s is possible because no explicit evaluation of the determ inant is required at each step. For = 2=5, it is much more costly to work with the projected wave function, and we have studied only the unprojected wave function for N = 50 and 100. The calculation at = 1=3 explicitly demonstrates that




FIG.1: The statistical angle \sim for the CF quasiparticles at = 1=3 (upperpanel) and = 2=5 (low erpanel) as a function of d j ⁰j. N is the total number of composite fermions, and l is the magnetic length. (The symbol \sim is used rather than for the statistical angle to remind that the correct interpretation of the results gives = \sim .) The error bar from M onte C arlo sampling is not shown explicitly when it is smaller than the symbol size. The deviation at the largest d=l for each N is due to proximity to the edge.

is independent of whether the projected or the unprojected wave function is used, or which projection m ethod is used; we assume the same is true at = 2=5.

The statistics parameter is shown in Fig. 1 for = 1=3 and = 2=5. takes a well-de ned value for large separations. At = 1=3 it approaches the asymptotic value of = 2=3, which is consistent with that obtained in Ref. 10 without lowest LL projection. At

= 2=5 the system size is smaller and the statistical uncertainty bigger, but the asym ptotic value is clearly seen to be = 2=5. At short separations there are substantial deviations in ; it reaches the asym ptotic value only after the two CFQP's are separated by more than 10 m agnetic lengths.

The microscopic value of obtained above has the same magnitude as in Eq. (4) but the opposite sign. The sign discrepancy, if real, is profoundly disturbing because it cannot be reconciled with Eq. (1) and would cast doubt on the fundam ental interpretation of the CF physics in terms of an elective magnetic eld.

To gain insight into the issue, consider two composite ferm ions in the otherwise empty lowest LL, for which




FIG.2: Density proles for (dashed line) and ^{''} (solid line) along the x axis at = 1=3, with = 131 and ⁰ = 0. (The uniform state has density = =2.) The noise on the curves is a measure of the statistical uncertainty in the M onte C arlo simulation. The CFQP in the second level has a sm oke ring shape, with a minimum at its center. The CFQP is located at x = 131 in , but is shifted outward in ^{'0}. The inset shows the density proles for (dashed line) and ^{'0} (solid line), describing CFQP's in the lowest LL (see the text for de nition).

various quantities can be obtained analytically. When there is only one composite ferm ion at $= Re^{i}$, it is the same as an electron, with the wave function given by

Two composite fermions, one at and the other at $^{0} = 0$, are described by the wave function

Here, we expect = 2p. How ever, an explicit evaluation of the Berry phase shows, neglecting 0 (R²) term s

which gives = 2p for large R. Again, it apparently has the $\ v$ rong" sign.

A calculation of the density for ,0 shows that the actual position of the outer composite ferm ion is not R = j jbut R^0 , given by

for large R . This can also be seen in the inset of Fig. (2). The correct interpretation of Eq. (13) therefore is

which produces = 2p. The O (1) correction to the area enclosed thus makes a non-vanishing correction to the statistics. (It is noted that the CF quasiparticle at = 0 is also a little o center, and executes a tiny circular loop which provides another correction to the phase, but this contribution vanishes in the lim it of large R.)

This exercise tells us that an implicit assumption made in the earlier analysis, namely that the position of the outer CFQP labeled by remains unperturbed by the insertion of another CFQP, leads to an incorrect value for . In reality, inserting another CFQP inside the loop pushes the CFQP at very slightly outward.

To determ ine the correction at = n = (2pn + 1), we note that the mapping into composite ferm ions preserves distances to zeroth order, so Eq. (14) ought to be valid also at = n = (2pn + 1). This is consistent with the shift seen in Fig. 2 for the position of the CFQP.Our earlier result

W hen the contribution from the closed path without the other CFQP, $R^{(2)}=21^2$, is subtracted out, of Eq. (4) is obtained. The neglect of the correction in the radius of the loop introduces an error which just happens to be twice the negative of the correct answer.

The fractional statistics of the CFQP should not be confused with the ferm ionic statistics of composite ferm ions. The wave functions of composite ferm ions are single-valued and antisym metric underparticle exchange; the ferm ionic statistics of composite ferm ions has been

m ly established through a variety of facts, including the observation of the Ferm i sea of composite ferm ions, the observation of FQHE at llings that correspond to the IQHE of composite ferm ions, and also by the fact that the low energy spectra in exact calculations on – nite system shave a one-to-one correspondence with those of weakly interacting ferm ions[3]. There is no contradiction, how ever. A fler all, any fractional statistics in nature m ust arise in a theory of particles that are either ferm ions or bosons when an elective description is sought in terms of certain collective degrees of freedom. The fractional statistics appears in the CF theory when the original particles fzg are treated in an average, mean eld sense to form ulate an elective description in terms so for CFQP's at f g.

The fractional statistics is equivalent to the existence of an elective locally pure gauge vector potential, with

no magnetic eld associated with it except at the particle positions[4]. In the present case, the substantial defrom its asymptotic value at separations viation of of up to 10 m agnetic lengths indicates a core region where the induced vector potential is not pure gauge, thereby imposing a limitation on a model in which the the CFQP's are approximated by ideal, point-like particles with well-de ned fractional statistics (anyons). Such an idealization is valid only to the extent that the relevant CFQP trajectories do not involve a signi cant overlap of CFQP's. G iven that there does not exist a strong repulsion between the CFQP's { the inter-CF interaction is very weak and often attractive [14] { such trajectories are not precluded energetically, and the anyon m odel is therefore not a justi able approximation, except, possibly, for very dilute system s of CFQP's in a narrow lling factor = n=(2pn + 1). Any experimental atrange around tem pt to m easure the fractional statistics of the CFQP's must ensure that they remain su ciently far apart during the m easurem ent process.
