## Spin Fluctuations and N on Ferm i-Liquid Behavior of C eN i2G e2

Neutron scattering shows that non-Ferm i-liquid behavior of the heavy-ferm ion compound CeNi<sub>2</sub>Ge<sub>2</sub> is brought about by the development of low-energy spin uctuations with an energy scale of 0.6 m eV. They appear around the antiferrom agnetic wave vectors  $(\frac{1}{2}\frac{1}{2}0)$  and  $(00\frac{3}{4})$  at low temperatures, and coexist with high-energy spin uctuations with an energy scale of 4 m eV and a modulation vector  $(0.23; 0.23; \frac{1}{2})$ . This unusual energy dependent structure of Im (Q;E) in Q space suggests that quasiparticle bands are in portant.

Non-Ferm i-liquid (NFL) behavior has been investigated in an increasing number of d- and f-electron system s in recent years [1, 2]. In usual heavy-ferm ion systems, although strong correlation e ects of f electrons bring about a mass renormalization m = m by a factor of up to a few thousands, the system s remain in Ferm i liquid (FL) states, which are typically observed as C=T  $_0$  / T<sup>2</sup> at low temperatures. The = const and large mass enhancem ent originates from uctuations of the spin degrees of freedom of the f electrons participating in the quasiparticles. W hen spin uctuations are slowed down by certain mechanisms, the FL description breaks down, and NFL behavior appears as, for example,  $C = T / \ln (T_0 = T)$  and  $_0$  / T<sup>x</sup> with x < 2.

A mechanism of NFL behavior is critical spin uctuations near a quantum critical point (QCP), i.e., a zero-tem perature m agnetic phase transition,  $T_N$  (or  $T_C$ ) = 0 [2, 3, 4]. Observation of a QCP requires tuning of the competition between quenching of spin by the K ondo e ect and interspin coupling by R uderm an-K ittel-Kasuya-Yosida (RKKY) interactions using chem ical substitutions, static pressures, or magnetic elds [5]. Recent experim ental studies on critical behavior of C eC u<sub>5:9</sub>A u<sub>0:1</sub> [5, 6] posed an intriguing theoretical question: Is the singularity described by the standard spin- uctuation theories [3, 4] or a locally critical quantum phase transition [2, 7]? For chem ically substituted systems, disorders inevitably a ect singularities, ranging from perturbative effects to disorder-driven NFL behaviors [8]. Experiments using stoichiom etric compounds showing NFL behavior without tuning, such as C eN i2G e2 [9] and Y bR h2 Si2 [10], are thus expected to clarify the QCP or otherm echanism s ofNFL in the clean lim it.




FIG.1: A contour map of constant-E scans taken with E = 0.75 meV in the (H H L) scattering plane at T = 1.6 K. No data were taken in the hatched area, due to nonm agnetic background. Possible antiferrom agnetic spin con gurations, depicted on the left and right sides, illustrate low energy spin uctuations with wave vectors  $k_2 = (\frac{1}{2} \frac{1}{2} 0)$  (X point) and  $k_3 = (00\frac{3}{4})$ , respectively, assuming spins along the a axis. The wave vector  $k_1 = (0.23; 0.23; \frac{1}{2})$  is the position where the high-energy spin uctuation (  $_{Q}$  <sup>i</sup> 4 m eV) shows maximum intensity [18].

C eN  $i_2$ G e<sub>2</sub>, which crystallizes in a body-centered tetragonal structure (see Fig. 1), is a paramagnetic heavy-ferm ion compound with enhanced C=T ' 350 m J/K<sup>2</sup> m ol [11]. It shows K ondo behavior with a tem - perature scale of T<sub>K</sub> ' 30 K [11] and has a metamag-

netic behavior at H<sub>M</sub> ' 42 T [12]. For T < 5 K, i.e., well below  $T_K$ , CeN  $i_2Ge_2$  exhibits NFL behavior with C=T / ln (T<sub>0</sub>=T) and \_\_0 / T<sup>x</sup>, where 1 < x < 1:5 [9]. CeN  $i_2Ge_2$  also displays superconductivity near the QCP [13] which m ay be spin- uctuation m ediated [14].

The NFL behavior has been thought to be caused by the spin uctuations being slowed down by a QCP of an antiferrom agnetic phase, which would be one of those observed in Pd, Rh, or Cu substituted compounds [15, 16, 17]. How ever, previous neutron-scattering experiments [18] on single crystalline CeN  $i_2$ G  $e_2$  disagree with this simple interpretation. The dynam ical susceptibility is well described by the standard form

used in the spin- uctuation theory [3]. However, the energy scale  $_Q$  4 m eV  $k_B T_K$  shows only a weak Q dependence. This is in contradiction with the QCP scenario, in which  $_Q$  is expected to depend strongly on Q and vanish at the antiferrom agnetic wave vector  $k_1 = (0.23; 0.23; \frac{1}{2})$  at T = 0.

In this Letter, we present neutron-scattering m easurem ents that reveal a second type of spin uctuations, which are shown to be characterized by a lower-energy scale and highly relevant to the NFL behavior. The m ain part of the m easurem ents was performed on the triple-axis spectrom eter HER at JAER I, equipped with a PG (002) m onochrom ator and a horizontally focusing PG (002) analyzer. The typical energy resolution using a

nalenergy of  $E_f = 3.1 \text{ meV}$  was 0.1 meV [fullwidth at half maximum (FW HM)] at the elastic position. Com – plem entary m easurem ents at low erenergies were done on the IR IS tim e-of- ight spectrom eter at RAL, with an energy resolution of 15 eV (FW HM). Single crystals were grown by the Czochralski method using isotopic <sup>58</sup>N i, which is important to avoid the large incoherent elastic scattering of natural N i. Four crystals with a total vol-

um e of 2.2 cm  $^3$  were aligned together and mounted in He ow or dilution cryostats. All the data shown are converted to the dynam ical susceptibility and corrected for the magnetic form factor. It is scaled to absolute units by com parison with the intensity of the incoherent scattering from a vanadium sample.

A number of constant-E scans covering an irreducible Brillouin zone were performed to search for low-energy spin uctuations at T = 1:6 K.Constant-E scans at E = 0.75 meV in the (HHL) scattering plane show (see Fig. 1) that there are two peak structures around  $Q = (\frac{1}{2}\frac{1}{2}1)$  and  $(11\frac{3}{4})$ , i.e., at reduced wave vectors of  $k_2 = (\frac{1}{2}\frac{1}{2}0)$  and  $k_3 = (00\frac{3}{4})$ . The wave vector  $k_2$  is the X point in the Brillouin zone, which also corresponds to  $Q = (\frac{1}{2}\frac{1}{2}0)$  in Fig. 1, where a smaller peak is seen. We note that strong intensities were observed only around k2 and k<sub>3</sub> in the whole Brillouin zone, except for the vicinities of the point, where the high background prohibited us from measuring the magnetic scattering. Possible antiferrom agnetic spin con gurations modulated by  $k_2$  and k<sub>3</sub> are illustrated on the left and right sides of the contour m ap, respectively, assuming that the spins are parallel to the a axis.

The spin- uctuation scattering at E = 0.75 meV is peaked at the wave vectors  $k_2$  and  $k_3$ , in contrast to that. at. 4 meV, which is centered at  $k_1$  (see Fig. 1) and elongated in the [110] direction [18]. This feature cannot be accounted for by the spin- uctuation theory of Ref. [3], since the product (Q)  $_{0}$  of Eq. (1) is predicted to be Q independent. A constant (Q)  $_{\circ}$  im plies that Im  $_{\rm L}$  (Q; E) peaks at a Q vector where  $_{\rm O}$  is m in im um, which excludes the possibility to have other




FIG.2: (a) Constant-Q scans at Q =  $(\frac{1}{2}\frac{1}{2}1)$ . Solid lines are ts to the Lorentzian of Eq. (1) with  $_{Q}$  = 4 m eV with an additional Gaussian [cf. Eq. (2)] for data below 8 K. The inset shows the magnetic eld dependence of the intensity at E = 0.4 meV. (b) Constant-E scans along the line  $Q = (\frac{1}{2} \frac{1}{2} L)$ taken with E = 0.75 m eV. Solid line is a guide to the eye and dashed line is the orientation factor of an anisotropic spin uctuation in the ab plane, for data at 1.6 K .

peaks in Im L (Q; E) at di erent energies. The archetypalheavy ferm ions  $C\,e\!R\,u_2\,S\,i_2$  and  $C\,e\!C\,u_6$  , on the other hand, are in agreem ent with the Q independent product

(Q)  $_0$  [19]. The failure of the description of C eN  $\frac{1}{2}$  G e<sub>2</sub> by the spin- uctuation theory will be a clue to clarify its NFL behavior.

To investigate the energy response around  $k_2$ , we perform ed constant-Q scans at Q =  $(\frac{1}{2}\frac{1}{2}1)$  and tim e-of-ight m easurem ents with a locus approxim ately along the line  $\left(\frac{1}{2}\frac{1}{2}L\right)$  for 0.8 < L < 2.2. We note that  $k_2$  is close to the antiferrom agnetic wave vectors of  $C \in (N_{1/2} \times M_{1/2})_2 G e_2$ with M = Pd and Rh [20]. Figure 2(a) shows energy spectra in the tem perature range 0:1 < T < 20 K.Onecan see a pronounced enhancem ent of the low -energy spin

uctuations at low tem peratures where NFL behavior in bulk properties becom e evident. In order to show the relevance of these low energy spin uctuations to the NFL behavior, we measured the magnetic-eld dependence of the intensity at E = 0.4 meV. The inset of Fig. 2(a) shows a signi cant reduction in the intensity, in agree-




FIG.3: Constant-E scans along lines Q = (11L) and (00L) taken with E = 0.75 m eV at T = 1.6 and 20 K.The solid line is a guide to the eye. The inset shows a constant-Q scan at the peak position Q = (1;1;0;7) and a tto Eqs. (1) and (2).

ment with the recovery of the FL behavior with applied

eld [9]. We conclude that the observed enhancement of the low-energy spectral weight is at the origin of the NFL behavior.

The energy spectrum at T = 20 K is well described by the Lorentzian form of Eq. (1) with  $_Q = 4$  meV, as reported in Refs. [11, 18]. To t the additional peak structure below 1.5 meV at T < 8 K, we parametrize the data by adding an ad hoc G aussian

to Eq. (1). The resulting ts of Eqs. (1) and (2) give an excellent description of the data [solid lines in Fig.2(a)]. It is also possible to describe the data by two Lorentzians for E < 1.5 meV, but the long tail of the second Lorentzian disagrees with the data at higher energies. Below T < 1:6 K, the energy width [half width at half maximum (HW HM )] of the low energy G aussian (Lorentzian) term is 0.7 (0.45) m eV. We note that the necessity to include Eq. (2) expresses the failure of the spin- uctuation theory [3] in another way.

Figure 2 (b) shows that antiferrom agnetic correlations, peaked at integer values of L along Q =  $(\frac{1}{2}\frac{1}{2}L)$  at E = 0:75 m eV, develop only at low temperatures. The slow Q variation of the intensity can be described by an orientation factor  $(1 + \hat{Q}_c^2)$  [see dashed curve in Fig.2 (b)], which in plies that the spins uctuate predom inantly in the ab plane. This spin anisotropy is consistent with the antiferrom agnetic structures of the Pd-doped com pounds [20]. However it disagrees with the susceptibility m easurements [12], which indicate an Ising-like anisotropy along the caxis at T 50 K.

To characterize the spin uctuation at  $k_3$ , constant-E scans along (11L) and (00L) are shown in Fig. 3. The sim ilar intensities between the (11L) and (00L) scans in-




FIG. 4: (a) Temperature dependence of the wave-vector dependent susceptibility (Q) and uniform susceptibilities <sup>c</sup> and <sup>a</sup> (from Ref. [21]). Error bars of (Q) include only statistical errors; the system atic uncertainty in the absolute norm alization can be up to a factor of 1.5. D ashed lines are guides to the eye. (b) O bserved speci c-heat coe cient C=T (from Ref. [22]) compared with m odel calculations using the SCR spin-uctuation theory [3]. The solid and dashed lines are the SCR evaluations without and with the low-energy spin uctuations, respectively.

dicate that the spin uctuations are isotropic. The energy spectrum at the peak position Q = (1;1;0:7) (see the inset of Fig. 3) was also param etrized using Eqs. (1) and (2) assuming  $_Q = 4 \text{ m eV}$  for the Lorentzian. The energy width of the G aussian is 0.9 m eV (HW HM) at 1.6 K. This is slightly larger than that of  $k_2$ , suggesting that the spin uctuations at  $k_3$  have a sm aller in portance for the NFL behavior.

Finally, we compare the present neutron data with other measurements. The wave-vector dependent susceptibilities (Q) at Q =  $(\frac{1}{2}\frac{1}{2}1)$  (k<sub>2</sub>), (1;1;0:7) (k<sub>3</sub>), and  $(\frac{1}{2}\frac{1}{2}\frac{1}{2})$  [23] were calculated using the K ramenes-K ronig relation from Im (Q;E), and are shown in Fig. 4 (a) together with the uniform susceptibilities <sup>c</sup> and <sup>a</sup>. While the susceptibility (Q) at Q =  $(\frac{1}{2}\frac{1}{2}\frac{1}{2})$  shows a T independent FL behavior, (k<sub>2</sub>) reproduces the uptum at low temperatures of <sup>c</sup> and <sup>a</sup>.

Since spin uctuations dominate the speci c heat at low temperatures, one would like to ask to what extent the observed low-energy spin uctuations account for the NFL behavior of C=T. This can be answered sem iquantitatively by using the self-consistent renorm alization (SCR) theory of spin uctuations  $\beta$ , which were applied to several heavy fermions [24]. Since C is theoretically calculated from Im (Q;E) approximated by the Lorentzian form, a contribution from the 4 m eV spin

uctuation can be calculated using the SCR technique. Figure 4(b) shows this part of C=T, evaluated assuming a Q independent  $_Q = 4 \text{ m eV}$ , by a solid line together with the observed C=T [22]. These show reasonable agreement above T > 5 K. An estimate of C=T including the lowenergy spin uctuations was obtained by replacing the Lorentzian spectral weight with the observed data [25].

It is plotted by a dashed curve in Fig. 4(b), showing an NFL upturn below T < 5 K with almost the same m agnitude as the observed C = T. W e conclude that the NFL behaviors observed in bulk properties are crossover e ects due to the antiferrom agnetic low -energy spin uctuations. From the nondivergent behavior of  $(k_2)$  [see Fig. 4(a)] and  $1 = k_2$  [see Fig. 2(a)] in the lim it T ! 0, we also conclude that the location of C eN  $i_2$  G  $e_2$  is slightly o the QCP. This is supported by the fact that the E =T scaling is not observed in CeNi2Ge2; most easily seen from the fact that the peak position of the low -energy response is independent of T [see Fig. 2 (a)]. In agreem ent with this interpretation, the recovery of the FL behavior, ie., C=T = const has been reported [22] for some stoichiom etric samples at the lowest tem peratures T < 0.3к.

An aspect of the antiferrom agnetic low-energy spin uctuations that cannot be explained by the spinuctuation theory [3] was addressed in the itinerantlocalized duality theory [26]. The dynam ical susceptibility (Q; E) was derived in the theory as (Q; E)  $^{1}$  = <sub>0</sub>(E)<sup>1</sup> (Q;E) J(Q), where  $_0(E)$  is a local spin susceptibility and J(Q) the Fourier transform of the RKKY interactions. The function (Q; E) re ects properties of the quasiparticle bands, and is usually absorbed into J (Q) by neglecting its E dependence. The resulting  $(Q;E)^{1} = _{0}(E)^{1}$ J (Q) was used as the starting assumption in the spin- uctuation theory [3]. However, the developm ent of a particular quasiparticle band can bring about a non-negligible E dependence of (Q;E), which was discussed in Ref. [26] in connection with two kinds of spin uctuations with energy scales of 5 m eV and 0.2 m eV in the heavy-ferm ion superconductor UPt<sub>3</sub> [27]. We may speculate that the enhanced low-energy spin uctuations and the deviation from the standard spin-

uctuation description of  $C \in N \downarrow G \in_2$  can be explained in this fashion. At present, however, other theoretical scenarios will have to be pursued.

It is interesting to com pare the present results with two other compounds that are close to QCP and which have been studied in detail by single-crystal neutron scattering:  $CeCu_{6x}Au_{x}$  with  $x_{c} = 0:1$  [6] and  $Ce_{1x}La_{x}Ru_{2}Si_{2}$ with  $x_c = 0.075$  [28]. The dynamical susceptibilities of these systems can be, at least approximately, described by a single Lorentzian [cf. Eq. (1)] with  $_{\circ}$  ! 0 at the antiferrom agnetic Q, in agreement with the spinuctuation theories [3, 4]. The essential problem of QCP is to determ ine the singularity, which may be dierent from the mean-eld-type solutions of the spin-uctuation theories. For  $C \in C u_{6 x_{c}} A u_{x_{c}}$  [6], a detailed study of the divergence revealed a signi cant deviation from the single Lorentzian, which led them to propose an extended functional form with a non-standard exponent of 0:75. On the other hand, for  $Ce_{1x_{c}}La_{x_{c}}Ru_{2}Si_{2}$  [28] g stays

nite in the limit T ! 0. In this context, an exactly tuned system, e.g., CeNi<sub>2</sub> x Pd<sub>x</sub>, Ge<sub>2</sub> [16, 17] with  $x_c$  0.09, is a promising candidate for studying divergent behavior of the Gaussian term of Eq. (2).

In conclusion, we have identi ed the low-energy spin uctuations that lead to the NFL behavior in CeN  $\frac{1}{2}Ge_2$ . They are antiferrom agnetic correlations around wave vectors  $(\frac{1}{2}\frac{1}{2}0)$  and  $(00\frac{3}{4})$  with a characteristic energy scale of 0.6 m eV.
