R esonant and anti-resonant frequency dependence of the e ective param eters of m etam aterials

We present a numerical study of the electrom agnetic response of the metam aterial elements that are used to construct materials with negative refractive index. For an array of split ring resonators (SRR) we nd that the resonant behavior of the elective magnetic permeability is accompanied by an anti-resonant behavior of the elective permittivity. In addition, the imaginary parts of the elective permittivity and permeability are opposite in sign. We also observe an identical resonant versus anti-resonant frequency dependence of the elective materials parameters for a periodic array of thin metallic wires with cuts placed periodically along the length of the wire, with roles of the permittivity and permeability reversed from the SRR case. We show in a simple manner that the nite unit cell size is responsible for the anti-resonant behavior.

The recent developm ent of metam aterials with negative refractive index -or double-negative (DNG) metam aterials¹ has con med that structures can be fabricated that can be interpreted as having both a negative e ective permittivity and a negative e ective permeability simultaneously. Since the original microwave experiment of Smith et al.² various new sam ples were prepared,^{3,4} all of which have been shown to exhibit a pass band in which the permittivity and permeability are both negative. These materials have been used to demonstrate negative refraction of electrom agnetic waves,⁵ a phenom enon predicted by Veselago.⁶ Subsequent experiments⁷ have rea med the property of negative refraction, giving strong support to the interpretation that these metam aterials can be correctly described by negative permittivity and negative permeability.^{8,9}

There is also an increasing am ount of num erical work¹⁰(¹² in which the transm ission and re ection of electrom agnetic wave is calculated for a nite length of m etam aterial. For a nite slab of continuous material, the com plex transm ission and re ection coe cients are directly related to the refractive index n and in pedance z associated with the slab, which can in turn be expressed in terms of permittivity and permeability . A retrieval procedure can then be applied to nd material parameters for a nite length of m etam aterial, with the assumption that the material can be treated as continuous. A retrieval process was applied in Ref.¹³ and con med that a medium composed of split ring resonators (SRR s) and wires could indeed be characterized by elective and whose real parts were both negative over a nite frequency band, as was the real part of the refractive index n.

The retrieval process, how ever, uncovers som e unexpected e ects. For the SRR m edium, for instance, the realpart of the e ective perm ittivity ⁰ exhibits an anti-resonant frequency dependence in the same frequency region where the perm eability undergoes its resonance. This anti-resonance can be seen in the composite SRR+wire negative index medium as well. The anti-resonance in the real part of the perm ittivity is also accompanied by anti-resonant behavior in the imaginary part of the perm ittivity ⁽⁰⁾, which exhibits an absorption peak opposite in sign to that of the imaginary part of the perm eability. A ssum ing that waves have a time dependence of exp(i! t), one would expect the imaginary parts of both the permittivity and perm eability to have positive values at all frequencies, since the material is passive.^{14,15}

The aim of present paper is to show that the anti-resonant behavior of the material parameter is an intrinsic property of a metamaterial, a consequence of the nite spatial periodicity. To illustrate this point, we present the retrieved material parameters for two types of metamaterial media that have been used to form negative refractive index composites: the rst medium comprises an array of SRR s that exhibit a resonant permeability and anti-resonant permittivity. The second medium comprises an array of cut metallic wires, which exhibits resonant permittivity and anti-resonant permeability.




FIG.1. Transm ission of the EM wave through the periodic lattice of thin m etallic wires. W ires are parallel with the y axis, and the EM wave, polarized with E k y, propagates in the z direction. The system is in nite in the x and z direction, and 60 rows of wires are considered along the propagation direction. The structure is characterized by four length param eters: the wire thickness w, gap , the wire length L and the lattice period (mutual distance of wires) a. In the present simulations, the lattice constant is a = 3:66 mm, the thickness of the wire is w = 0.33 mm, the length of the wire is L = 7mm and the cut of the wire is = 0.33 mm. Data show the drop of the transmission (solid line) at frequency f_0 13:35 GHz.Dashed line is absorption.W e found that the resonant frequency fo is alm ost independent on the lattice constant a a 5 m m). However, it depends strongly on the gap (1:66 . In inset shows how the frequency f $_{\rm 0}$ depends on the ratio =L. Solid line is the tf _0 = $\frac{c_{\text{light}}}{p} \left[a_0 \ln (L=) + a_1 \right]^{1=2}$ with $a_0 = 0.48$ and $a_1 = 0.17$. Plasm a frequency f_p depends on the lattice period a. For a = 3:66 mm we found num erically f_p 24:5 G H z w hich agrees with predictions of Sarychev and Shalaev, 17 indicating that the value of the plasm a frequency is not in uenced by the wire cut.

W e used the transfer matrix method to simulate numerically the transmission of the electro magnetic waves through the metamaterials. Transmission data for an array of SRR were published elsewhere^{10,12} and will not be repeated here. To the best of our know ledge, the analysis of the array of cut wires has not been presented in the literature yet. Fig. 1 shows the frequency dependence of the transmission and absorption for an array of cut wires. As expected, the system exhibits a band gap for frequencies $f_0 < f < f_p$. Here, f_0 is the resonance frequency and f_p is the plasm a frequency. The transmission data are similar to that for an array of the SRR. However, contrary to an array of SRR, the system exhibits the resonant behavior of the ective permittivity at $f = f_0$.

From the transm ission and re ection data we calculate the e ective perm ittivity and perm eability. D etails of the m ethod were published elsewhere.¹³ The m ethod is based on the assumption that the system is hom ogeneous. Textbook form ulas for the transm ission and re ection of the slab of width d are then inverted to obtain e ective im pedance z and effective refractive index n. Perm ittivity and perm eability are obtained from relations

Typical frequency dependence of the e ective param eters of an array of SRR and array of cut wires are shown in g. 2 and 3, respectively. Both structures exhibit qualitatively the same behavior: there is a resonant frequency interval, in which one e ective param eter is negative (0 for SRR, 0 for cut wires). The resonant behavior of this param eter at the left border of the band gap is clearly visible. The frequency dependence of the second param eter is anti-resonant. Its real part decreases to zero at $f = f_{0}$ and in aginary part is negative for $f > f_{0}$. Notice the qualitative sim ilarity of both system s: data are qualitatively the same, and di er only in the exchange of and (which is equivalent to the transform ation z ! 1=z).

The anti-resonant behavior of the e ective parameter has its origin in the nite lattice period a associated with the m etam aterial structure. One manifestation of the lattice periodicity is that there is a maximal wave number, given by $k_{m ax} = =a.^{16}$ If we assume that the metamaterial can be treated as a continuous medium with an index of refraction n, then the de nition of n = $c_{light}k=!$ shows that n is necessarily bounded. The generic ! (k) dispersion diagram of a resonant periodic structure results from the coupling of a dispersionless resonance curve at the resonant frequency ! $_0 = 2$ f₀ and the light line f = $c_{light}=k$ (see R ef.² for details). The result is a lower branch that extends from zero frequency to the resonance frequency f₀, followed by a band gap that extends from f₀ to f_p, followed by an upper branch that extends upwards in the frequency from f_p.

Because the resonant frequency of a typical metam aterial element in plies a free space wavelength much longer than the unit cell size, an elective medium approach has been applied that results in a characterization of metam aterial in terms of bulk and . The square root of the product is the refractive index, which must be consistent with that determ ined from the dispersion diagram. To understand the generic properties associated with a resonant system in a periodic structure, we start by considering the dispersion characteristics of the system near the resonant frequency, where we have

where is a real number. Solving Eq. 2 for k and using $n = c_{light}k=!$, we nd an approximate expression for the refractive index:

The maximum value of the refractive index at the resonance frequency is thus

determ ined only by the resonant frequency of the element and the periodicity.

For the com posite structures analyzed in this paper, Eq. 4 gives $n_{m\ ax} = 4.24$ for an array of SRRs and $n_{m\ ax} = 3$ for the cut wires array. W hen comparing $n_{m\ ax}$ with data presented in gs. 2 and 3, we see that n^0 indeed does not exceed these lim its.

A ssume that the e ective parameter x (x represents the e ective perm ittivity for the cut wires system and the e ective perm eability for the SRR system) exhibits a resonant form corresponding to

where is a damping factor, and F is a lling factor (fraction of volume of the metallic components). At resonance, the imaginary part $x^{(0)}$ (!) becomes

 $(!_{p}^{2} = !_{0}^{2} = (1 F))$ and is greater than zero, as expected.

If we require that the index n calculated form the dispersion curves be consistent with the bulk permittivity and permeability parameters, than we must have n (!) = x (!) y (!). Near the resonance frequency this implies that the second effective parameters y (!) behaves as

C om paring the expression for y(!) with that for x(!) we see that the poles and zeros of x and y are reversed, as long as n is bounded with the form given by Eq. 4. M oreover, for sm all $n^{(0)}(!)$, we immediately see that the product of im aginary parts $x^{(0)}(!)y^{(0)}(!) < 0$ is negative. To be more speci c, with the help of Eq. 1 we obtain that




FIG.2. E ective parameters for an array of split ring resonators (solid lines: real part, dashed lines: in aginary part). The resonant behavior of the e ective permeability at frequency $f_0 = 9.66$ GHz is clearly visible. Shaded area shows the resonance frequency interval in which ⁰ is negative. Note the anti-resonant behavior of . Note also that ⁰⁰ is negative. The sharp discontinuity in ⁰⁰ is due to the extrem ely fast decrease of n⁰ to zero in the right part of the resonance interval. The size of SRR is 3 mm, the size of unit cell is L_x L_y $L_z = 3.33$ 3:66 3:66 mm. The SRR lies in the x = 0 plane, EM wave propagates along the z direction and is E k y polarized.




FIG.3. E ective parameters of the periodic lattice of cut wires. Resonant behavior of the elective permittivity as well as anti-resonant behavior of elective permittivity are clearly visible. The real part of permissibility ⁰ is zero at f₀, and the imaginary part of the permissibility ⁰ is negative for f > f₀.

O ne sees that the sign of 00 00 is fully determ ined by the rhs. of Eq. 8. We are not aware about any physical requirement which prevents the rhs. of Eq. 8 to be negative. In fact, data presented in Figs2 and 3 show clearly that

in the left part of the resonance gap, since $jz^0j < jz^{00}j$ and $jn^{00}j < jn^0j$. Thus, in agreement with Eq. 7 we conclude that the opposite sign of ⁰⁰ and ⁰⁰ is a consequence of sm all transm ission losses in the structure. The same conclusion was derived in Ref.¹² for the DNG metamaterials.

In conclusion, we presented the num erical analysis of the e ective param eters of two m etam aterials: an array of SR R and an array of thin m etallic cut wires. We show that the e ective param eters of these system s exhibit resonant and anti-resonant behavior similar to that found recently in the double negative m etam aterials. We suggest that the antiresonant behavior is caused by the requirem ent that the refractive index m ust be bounded in the structures which posses nite spatial periodicity. As the spatial periodicity is an unavoidable property of the m etam aterials, we conclude that observed seem ingly unphysical behavior of e ective m aterial param eters is an intrinsic property of com posites, which can not be avoided for instance by decreasing the size of the unit cell.

The electrom agnetic response of metamaterials is usually embodied in a description involving bulk, continuous, frequency dependent permittivity and permeability tensors. This description, however, is only approximate, as spatial dispersion is always present to some degree in metamaterials. Thus, the applicability of our retrieval procedure, which uses the form ulas for transm ission and re ection of the hom ogeneous slab, m ight not be applicable in the neighbor of the resonance frequency, where the wave length of the electrom agnetic wave inside the com posite is already com parable with the spatial period.

B esides the analysis of the e ective param eters, our results are interesting also for further development of new double negative m etam aterials, in which the lattice of cut w ires m ight nd new interesting applications.^{12,18}
