H₂ in the interstitial channels of nanotube bundles

The equation of state of H_2 adsorbed in the interstitial channels of a carbon nanotube bundle has been calculated using the di usion M onte C arbo m ethod. The possibility of a lattice dilation, induced by H_2 adsorption, has been analyzed by m odeling the cohesion energy of the bundle. The in uence of factors like the interatom ic potentials, the nanotube radius and the geom etry of the channel on the bundle swelling is system atically analyzed. The m ost critical input is proved to be the C H_2 potential. U sing the same m odel than in planar graphite, which is expected to be also accurate in nanotubes, the dilation is observed to be smaller than in previous estimations or even inexistent. H_2 is highly unidim ensional near the equilibrium density, the radial degree of freedom appearing progressively at higher densities.

I. IN TRODUCTION

Theoretical and experim ental research in carbon nanotubes (CN's) is now adays a very active eld in which new avenues are opening continuously, all related to its particular structure at the nanom eter-scale level. Besides their singular electrical and mechanical properties, CN's are able to adsorb som e atom s and m olecules o ering a real possibility for quasi-one-dim ensional environm ents. These are mainly the inner part of the nanotubes and the interstitial channels (IC 's) among them due to their natural bundle arrangem ent. W hen CN's are form ed, they appear as long capped cylinders which only can adsorb a given substance if their caps are removed by chem icalmeans. Instead, IC's are always present o ering very narrow channels, distributed according to an hexagonal lattice, and with a sizeable adsorption capability in com parison with adsorption in planar graphite. Recently, Talapatra et al.¹ studied experimentally the binding energies of X e, C H₄, and N e on close-ended nanotube bundles and concluded that none of them is adsorbed in the intersites. P robably, the size of these atom s and m olecules is too large com pared with the radius of the interchannel $(r_{IC} ' 3 A)$ to t into them . However, the situation for lighter species like $H \in \text{or } H_2$ seems dierent. There are several experiments which claim that both of them can be adsorbed in the IC's due to their sm all radius.^{2,3,4} H₂ is certainly the most interesting system since a CN bundle could be one of the best options to reach the target energy densities for a lightweight hydrogen-storage system usable for transportation.^{5,6}

In a recent theoretical work, C albiet al.⁷ have studied the adsorption of H_2 , and other m olecules and atom s, in the IC's of a CN bundle. Introducing in the form alism a possible dilation of the bundle, by m eans of a harm onic approximation, they concluded that in equilibrium the bundle can swell. The dilation is observed in all cases, with di erent intensity depending on the particular system . In the geom etry there considered, corresponding to (10,10) tubes in the standard term inology, and when the gas adsorbed is H_2 that swelling amounts approximately to 1 % . This is the result of a delicate balance between two competing e ects when the lattice is expanded: a decrease in the CN bundle cohesion energy and an increase in the H₂-nanotube binding energy. O byiously, this prediction for H₂ acquires special relevance since it would imply a signi cant increase of the CN bundle storage power. However, at present there is not any experimental con mation of this possible adsorption-induced dilation. Probably, even if such e ect is indeed present, its manifestation could be hardly observed due to the present experim ental uncertainties. Ram an spectroscopy seem s a prom ising m ethod for a better insight. In a recent w ork, this method was applied successfully by W illiam set al.3 to discrim inate the di erent adsorption sites of H₂ in CN bundles.

In the present work, we present a di usion M onte C arlo (D M C) study of H₂ adsorbed in IC's of a (10,10) CN bundle. In the past, and using the same m ethodology, we characterized the ground-state properties of ⁴H e and H₂ inside a single CN^{8,9} and of ⁴H e adsorbed in an IC.¹⁰ In this paper, our aim is to determ ine the equation of state of H₂ using m icroscopic theory, with special attention to the possibility of an adsorption-induced bundle dilation. To this end, the in uence on swelling of inputs like the nanotube radius, the m olecule-m olecule and CN-m olecule interactions, the geom etry of the intersite, and the transversal degree of freedom are thoroughly discussed. Our results agree som ehow with the ones of R ef. 7 but the m agnitude of a possible swelling is seen to be comparatively sm aller or even inexistent.

The rest of the paper is organized as follows. In Sec-

tion II, the in uence of the several parameters of the model on a possible dilation of the bundle is studied using a one-dimensional approximation. The accuracy of this model is then tested in Section III by means of a three-dimensionalDMC calculation. Finally, Section IV comprises a brief summary and the main conclusions.

II. ONE-D IM ENSIONAL APPROX IM AT ION : $\label{eq:testing_themap} \text{TEST IN G THE MODEL}$

As in Ref. 7, we study H_2 adsorbed in the IC of a (10,10) CN bundle. The bundle is disposed in such a way that, in the plane perpendicular to the CN long axis, a triangular lattice is form ed. The lattice constant, i.e., the distance between adjacent centers, is $D_0 = 17 \text{ A} \cdot D_0$ corresponds to the equilibrium position and there is an overall agreem ent on its value. Therefore, we consider it as a xed parameter in all the calculations.

Having established the value of D_{0} , the radius of a single nanotube is directly related to the C-C m in im um separation between two neighbors. In a theoretical calculation, Terso and Ruo¹¹ concluded that this distance is 3.4 A, in agreem ent with the most accepted value for the Lennard-Jones $_{C-C}$. In fact, this value coincides with the experim entally accepted distance between graphite sheets. Considering this C-C distance, the radius of a (10,10) tube is 6.8 A. It is worth mentioning that this radius is the same one obtains constructing the same nanotube by rolling up a graphitic surface with a C-C distance of 1.42 A . How ever, there is not a general agreem ent on those values. Recently, Charlier et al.¹² carried out a density functional calculation of a CN bundle and obtained an equilibrium geometry corresponding to a C-C intertube distance of 32 A. The CN radius is then 6.9 A, a value which was used in Ref. 7. At present and to our know ledge, there is not experim ental data on the C-C distance which could help to choose between different theoretical models. Therefore, we consider in the present calculation two possible CN radius, 6.8 and 6.9 Α.

The interstitial channel between three adjacent nanotubes in a (10,10) bundle can bdge a hard sphere with radius 2.9 or 3 A, corresponding to CN's with radius 6.8 and 6.9 A, respectively. Since the parameter for the C – H₂ Lennard-Jones potential is around 3 A, one can reasonably assume a one-dimensional (1D) approximation for hydrogen adsorption in IC's. In this approximation, the H₂ energy per particle (e = E = N) can be written as⁷

with the linear density of the H₂ m olecules and D the lattice parameter. In Eq. (1), $_0$ (D) is the binding energy of a single m olecule in the IC, e_{1D} () is the 1D H₂ energy per particle, h (;D) corresponds to the interaction energy with H₂ in neighboring IC 's, and the last term takes into account the cohesion energy of the bundle when it is

dilated from the equilibrium lattice distance D_0 . In the following, we analyze the several terms entering Eq. (1) to disentangle which are the relevant inputs in uencing a possible dilation of the bundle.

Both $_0$ (D) and e_{1D} () are calculated using the diusion M onte C arlo (D M C) m ethod.^{13,14} T he D M C m ethod solves in a stochastic way the N -body Schrodinger equation in imaginary time for the wave function f (R;t) = (R) (R;t),

with (R) a trial wave function introduced for in portance sampling. In Eq. (2), $D = h^2=2m$, $E_L(R) = (R)^{-1}H(R)$ is the local energy, and $F(R) = 2(R)^{-1}r(R)$ is the so-called drift force which guides the di usion movement to regions where (R) is large.

The trial wave function used in the calculation of 1D $\rm H_2$ is a Jastrow one,

with $f(r_{ij}) = \exp 0.5 (b=r_{ij})^5$ a M cM illan two-body correlation factor. The parameter b in f (r) has been determ ined by m eans of a variational M onte C arb (VM C) optimization. N ear the equilibrium density, the optim al value is b = 3:996 A and it increases gradually with the density (at = 0:358 A⁻¹, b = 4:026 A).

The trial wave function used in the calculation of $_0$ (D) includes two-body correlations with the three nanotubes surrounding the IC. They are also of M cM illan type,

 r_n being the distance of the hydrogen m olecule to the center of any of the three tubes. The param eter a, optim ized using VMC, varies from a = 22.5 A for zero dilation to a = 21.5 A for D $_{\rm D}$ = 0.2 A. On the other hand, the optim al values for the param eter a present a negligible dependence with the particular C-H $_2$ potential chosen in the calculation. The IC is so narrow that one can approximate the sum of individual CN-m olecule potentials by a new one which is only a function of the radial distance r to the center of the IC. This sim plied m odel is obtained by an azim uthal average of the three individual potentials.⁷ In this case, the trialwave function is sim pler than the previous m odel (4). We have chosen a gaussian

the parameter c varying from 7.6 A 2 to 11.5 A 2 , depending on the radius of the tube and on the dilation. The greater the radius, the sm aller the value of c.

P ara-hydrogen is spherical to a large extent. A s usual in m ost of m olecular hydrogen calculations, the interm olecular interaction is considered purely radial and described by the Silvera and G oldm an (hereafter SG) m odel.¹⁵ In addition, and to m ake com parisons with previous work (Ref. 7), we have also m ade som e calculations with the potential proposed by K ostov, C ole, Lew is, D iep, and Johnson.¹⁶ This H_2 - H_2 potential (hereafter K C LD J) incorporates, in a rather crude way, three-body corrections to the pair potential com ing from the triplets H_2 -C- H_2 .

M uch m ore critical for estim ating a possible bundle dilation is the m odel for the $CN H_2$ interaction. As in our previous work on the equation of state of H_2 adsorbed inside a nanotube,⁹ we use the $CN H_2$ potential proposed by Stan and Cole.¹⁷ This potential results from an average over all the $C H_2$ interactions between the C of an in nite CN and a single molecule located at a radial distance r. The interaction is thereby independent of z (corrugation e ects are neglected) and can be used for adsorption both inside and outside the nanotube. The resulting $CN H_2$ potential depends explicitly on the and

param eters of the Lennard-Jones potential between C and H_2 . At present, there is not an overall agreement about which are the best set of param eters (,) describing this interaction. In order to study the in uence of this choice on the calculations, two di erent sets have been studied. The rst one, used for example in Refs. 7 and 18, is derived with the Lorentz-Berthelot combining rules

Using $_{C-C} = 3.4$ A, $_{C-C} = 28$ K, $_{H_2+H_2} = 3.05$ A, and $_{H_2+H_2} = 37.0$ K the rst set is $_{C+H_2} = 32.2$ K and $_{C+H_2} = 32.3$ A (hereafter LB). The second option is to consider the optim al parameters which describes the interaction of H_2 with planar graphite. This set from W ang, Senbetu, and W oo¹⁹ is probably m ore realistic than the rst one and it has also been used in the past.^{3,9,20} The values are $_{C+H_2} = 42.8$ K and $_{C+H_2} = 2.97$ A (hereafter W SW). Notice the sizeable difference between both sets which will generate signi cant di erences in the nal results.

D ilation and compression of the lattice constant in the CN bundle have an energetic cost. Following Refs. 21 and 7, that contribution is assumed to be harmonic in the displacement around the equilibrium position D₀ (see Eq. 1). This approximation is expected to hold for small D₀ values but the uncertainty in the real value of k is rather large. From compression modes measured in graphite by Nicklow et al.²² M izel et al.²¹ estimated a value k = 1740 K A³. The constant k can also be obtained from the bulk modulus B. Considering that any deformation of the tube takes place only in a direction perpendicular to its long axis, k = 2 = 3B.¹¹ From the experimental measure of B by Tang et al.²³


(B = 41:66 GPa) one obtains k = 3015 K A 3 , a gure much larger than the one from Ref. 21. Part of the di erence can som ehow emerge from the fact that the experim ental data for B was obtained for CN 's with wider radius (7.04 A). In the results presented below, we have used k = 1740 K A 3 everywhere but the in uence on the nal results of the particular k value is analyzed in selected cases.

Finally, the term h(;D) in Eq. (1) sums the interaction energy between the H₂ molecules of a given IC and the ones of its neighboring channels. This contribution may be readily obtained assuming a mean eld approximation,

which considers the neighboring channels as uniform arrays without correlation e ects that could modify the H $_2$ kinetic energy. The calculation in Eq. (7) is extended to the nearest neighbors, the next-nearest neighbors, and then on up to the desired accuracy. Obviously, h(;D) changes when the bundle swells. In Ref. 24, we have veri ed the high accuracy of Eq. (7) by comparing its estimation with an exact DMC calculation.

The in uence of the CN radius and the $C - H_2$ potential in the equation of state of adsorbed H_2 is clearly observed in the value of 0. Table I contains results for the H₂ binding energy considering two CN radius, 6.8 and 6.9 A, the two C-H₂ potentials discussed above, LB and W SW , and two geom etries for the IC , the real one with the triangular com position of the tubes surrounding the IC (T) and the radial (R) model from an azhimutal average. The narrow ness of the IC m akes the di erences between the T and R results not to be larger than 15 % . The dom inant e ect is unquestionably the C-H $_2$ potential. The signi cant di erences between the pairs (,) for the two models generate a big discrepancy in the value of 0. The largest binding energies correspond to the most accurate W SW potential due to its larger parameter . It is also noticeable, and will be discussed below in connection with dilation, the di erent behavior of 0 with the CN radius: it strongly depends on the radius for LB whereas remains nearly unchanged for W SW .






FIG.1: Energy per hydrogen molecule for CN radius 6.9 A,T geometry, SG H_2 - H_2 potential, and LB C- H_2 potential. >From top to bottom in = 0.2 A¹: D D₀ = 0.18, 0.17, 0.16 and 0.15 A.

This last feature is a consequence of the larger value of the LB potential which e ectively reduces the space available inside the IC to accomm odate the H_2 m olecule.

In order to determ ine if a dilation of the bundle is energetically preferred, a series of calculations using Eq. (1) has been carried out. A s com m ented before, our aim is to quantitatively determ ine the in uence of the potentials, the CN radius, the elastic constant k, and the geometry m odel for the IC on a possible dilation. The direct output of Eq. (1) is the energy per particle as a function of the linear density and D. For a given dilation D D_0 0, with xed $D_0 = 17 A_r e()$ can be obtained and from it the equilibrium point $(0, e_0)$ corresponding to zero pressure. Illustrative outputs of this procedure are shown in Figs. 1 and 2. Fig. 1 contains the H_2 equation of state in the IC for values of the lattice dilation D $D_{0} =$ 0.18, 0.17, 0.16, and 0.15 A. All the curves have been calculated assuming a CN radius of 6.9 A, the SG H_2-H_2 potential, $k = 1740 \text{ K} \text{ A}^{-3}$, the LB C-H $_2$ potential, and a T channel. The lowest energy per particle at the minimum is obtained for a dilation 0.16 A, nearly coincident with the result reported in Ref. 7 (0.166 A) obtained with the H_2-H_2 KCLDJ potential and an R channel. If the $C - H_2$ potential is the W SW model, the H_2 equation of state changes dram atically and the dilation becom es much smaller. This is shown in Fig. 2 which diers from Fig. 1 in the $C - H_2$ potential, the other inputs being unchanged. The curves now correspond to dilations D D₀

= 0.06, 0.05, and 0.04 A. The minimum corresponds to a swelling of 0.05 A. The equilibrium density is $_0 = 0.232$ A ¹, slightly inferior to the one obtained with the LB potential, $_0 = 0.268$ A ¹. The magnitude of the energy per particle is very di erent in the two cases: going from LB to W SW the energy increases in a factor two. The major part of this increment comes from the di erences in the binding energies of a single molecule $_0$ (Table I).

The full set of results combining CN radius, C+H2 and H2-H2 interactions, and IC geometry is reported in Table II. 0 corresponds to the H₂ equilibrium density at the energetically preferred swelling, reported also in the Table. Due to the large uncertainty in the value of k, we only report the in uence of its change (3015 K A 3 instead of 1740 K A $^{-3}$) in the most favorable cases for the bundle swelling. Inspection of the data shows that neither the H_2 - H_2 potential nor the detailed form of the IC, R or T, are relevant in the swelling process. M aintaining xed the radius to a value 6.9 A and the LB $C-H_2$ interaction, the dilation com es out 0.16-0.17 A, in overall agreem ent with Calbiet al.⁷ How ever, if the LB interaction is substituted by the W SW one, the swelling observed is reduced by a factor of three (from 0.17 A to 0.05 A), and the equilibrium density $_0$ decreases by 15 8.

The second part of Table II contains a similar analysis for a CN radius of 6.8 A. A general trend arising from the comparison between the rst half of the Table (6.9 A) and the second one (6.8 A) is the increase of the dilation




FIG. 3: Full DMC calculation of molecular hydrogen adsorbed in the interchannels of a CN bundle. No dilation, full squares; D $D_0 = 0.05 \text{ A}$, empty squares; D $D_0 = 0.10 \text{ A}$, full circles; D $D_0 = 0.15 \text{ A}$, empty circles.

with the CN radius when the rest of the inputs are kept xed. This seems quite obvious since, with a smaller nanotube and the same CN-CN distance, the room for adsorption increases. Thus, the swelling decreases from 0.17 to 0.11 A with the LB C-H₂ interaction whereas it turns absolutely negligible in case of using the probably most accurate W SW potential. On the other hand, $_0$

is observed to system atically decrease when the radius is moved from 6.9 to 6.8 A. Finally, the in uence of the value of k appears in the Table marked with an asterisk for a particular case in which the dilation is one of the largest values. As it could be expected, $(D = D_0)$ decreases if k increases: using k = 3015 K A ³ instead of 1740 K A ³ the dilation is reduced by 30 %. Sim ilar reductions would be obtained in the other cases.

III. FULL DM C CALCULATION

In the preceding Section it has been assumed that radial and longitudinal degrees of freedom of H₂ inside IC's are not coupled. The correlations between H₂ m olecules were purely longitudinal and the interaction with the surrounding walls was solved only for the one-body problem. In this Section, we check the validity of that approxim ation by making an exact three-dimensional DMC calculation of H₂ in the IC. The CN bundle cohesion term and the mean eld contribution h(;D) are summed up to the DMC energy as in Eq. (1).

The trial wave function for importance sampling is written as

where 1D (R) and IC (R) are the same than in the 1D calculation, Eqs. (3) and (4), respectively. The optimal values for the parameters entering Eq. (8) are the same than the ones in the preceding Section. The DMC calculation has been carried out for a selected case which we consider contains the most reasonable model. The CN radius is 6.8 A and the IC is of T type. The $\rm H_2-\rm H_2$ interaction is SG and the parameter set for $\rm C-\rm H_2$ is the W SW one.

In Fig. 3, the total energy per particle of H_2 in the IC is shown as a function of f and for di erent bundle




FIG. 4: Comparison between a DMC calculation (full squares) and a 1D approximation (solid line) in a case without dilation. See comments in the text.

lattice values, D D₀ = 0, 0.05, 0.10, and 0.15 A. The m inimum of the energy is achieved with D = D₀, what in plies an absence of dilation in the bundle of nanotubes. This is in agreement with the corresponding case in Table II, marked by a dagger. In the full 3D calculation the equilibrium density is $_0 = 0.2184(12) \text{ A}^{-1}$, to be compared with 0.2194(5) A ⁻¹ from Table II. The second value is within the error bar of the rst one. The energy per hydrogen molecule at the equilibrium density is also very similar in both cases, $e_0 = 1101.43(1) \text{ K}$ and $e_0^{1D} = 1102.31(2) \text{ K}$. This clear overlap means that the 1D m odel (1) is a very good approximation to the physics of H₂ inside the interchannels of a bundle of nanotubes around the equilibrium density.

F inally, in F ig.4 the com parison between both calculations is extended to higher densities. In the energy scale, the binding energy $_0 = 1096.02$ K (Table I) is now subtracted. Equation (1) provides un upper bound to the exact result which is very close to the exact energies near $_0$. However, its quality worsens when the density increases due to the emergence of the radial degree of freedom which is frozen in the 1D m odel.

IV. SUMMARY AND CONCLUSIONS

The equation of state of H_2 adsorbed in the IC's of a CN bundle has been calculated using m icroscopic theory.

By means of the DMC method, which provides exact results for given m odel potentials, the possible dilation of the bundle induced by adsorption has been carefully analyzed. The most complete analysis has been done in the 1D model.⁷ In spite of its simplicity, this approach (1) has proven to be very accurate when com pared with a full 3D calculation, specially near the equilibrium density. P laying with the di erent alternatives for the parameters entering into the calculation the in uence of each one has been established. Sum m arizing, the results show that the critical one is the particular $C-H_2$ interaction. The deeper and probably more realistic W SW potential reduces the swelling predicted by the LB model in a signi cant way. The same can be concluded about the C-C interaction, represented here by the k param eter, but to a lesser extent. On the other hand, sizeable changes in the H_2-H_2 interaction do not modify the physics of the dilation process. Our results do not exclude com pletely the possibility of some lattice dilation but if it exists its value seems clearly smaller than the gures quoted in Ref.7.

A key point in the discussion is the issue of what $C - H_2$ potential is more realistic. To this end, one should com pare theoretical data with experimental results. However, the latter are really scarce. Recently, Vilches and collaborators 25,26 reported data on H $_2$ isotherm s on bundles of closed-capped carbon nanotubes for several tem peratures. At very low coverages, they deduced the existence of H₂ adsorption on the ridges created between two nanotubes in the outer part of the bundle and/or in the IC 's. For these sites, they estim ated a binding energy 700 K, 1.5 tim es larger than the one for m olecular hydrogen on graphite. Com parison with Table I rules out the case with R = 6.9 A and the LB potential: its $_0$ is too small. On the other hand, the value for R = 6.8A and the LB potential seems to t perfectly well the experimental result. However, there is a problem : the binding energy 700 K is supposed to be an average of the energies of hydrogen adsorbed on the ridges and in the IC's. Then, the real binding energy in IC's should be greater than the experimental nding, tting well with the results obtained with the W SW potential.
