# Therm odynam ic stability conditions for nonadditive com posable entropies

A bstract. The therm odynam ic stability conditions (TSC) of nonadditive and com posable entropies are discussed. Generally the concavity of a nonadditive entropy with respect to internal energy is not necessarily equivalent to the corresponding TSC. It is shown that both the TSC of T sallis' entropy and that of the -generalized Boltzm ann entropy are equivalent to the positivity of the standard heat capacity.

#### 1 Introduction

It is well known that the conventional therm odynam ic stability condition (ISC) [1] is the concavity of the Boltzm ann-G ibbs (BG) entropy  $S^{BG}$  with respect to internal energy U, i.e.,

$$\frac{\varrho^2 S^{BG}}{\varrho U^2} < 0; \tag{1}$$

which is also equivalent to the positivity of heat capacity C 0U=0T, since the temperature T is dened by

$$\frac{1}{T} = \frac{(0)^{B}}{(0)}; \qquad (2)$$

and

$$\frac{1}{C} = \frac{\partial T}{\partial (1=T)} \qquad \frac{\partial (1=T)}{\partial U} = T^2 \frac{\partial^2 S^{BG}}{\partial U^2} :$$

The conventional them odynam ic stability arguments are based on both the extrem um principle and additivity of the BG entropy. Now adays nonadditive entropies have been extensively considered in the literature since the generalized form alism based on T sallis' nonadditive entropy [2,3] has been successfully applied to a variety of complex system s. The T sallis entropy is a generalization of the BG entropy by one real parameter of g,

$$S_{q} = \frac{\prod_{i}^{q} p_{i}^{q} - 1}{1 - q};$$

where  $p_i$  stands for a probability of i-th state. For the sake of simplicity, we set the Boltzm ann constant to unity throughout this paper.  $S_q$  reduces to the BG entropy in the limit of q! 1.

D using the early stages of the developm ent of T sallis' therm ostatistics, R am shaw [4] pointed out that the concavity of T sallis' entropy with respect to the standard expectation energy  $U_1$  \_\_\_\_\_i p\_i E\_i

is not su cient to guarantee the therm odynam ic stability for all values of q because S  $_{q}$  is nonadditive. He derived the TSC of the nonadditive S $_{q}$  from the TSC of the additive Renyientropy [5]

$$S_{q}^{R} = \frac{\ln \left[ \frac{1}{q} p_{i}^{q} \right]}{1 q}; \qquad (5)$$

by utilizing the nonlinear functional relation between both entropies

$$S_{q}^{R} = \frac{\ln [1 + (1 - q)S_{q}]}{1 - q}$$
: (6)

The present author [6] further studied the TSC of  $S_q$  by directly utilizing the nonadditivity Eq. (9) of  $S_q$ , and shown that the resultant TSC is equivalent to the positivity of the standard heat capacity C.

In this paper we discuss the TSCs of nonadditive composable entropies, and show that the TSC of such a nonadditive entropy is not equivalent to the concevity of the entropy with respect to internal energy. In the next section, after the explanation of the concept of composability, we brie y review the standard TSC of an additive entropy. We then discuss the TSCs of two dimensions of nonadditive composable entropies. The subsection 2.1 deals with the TSC of the Tsallis q-entropy, and in the subsection 2.2 we consider the TSC of the -generalized Boltzm ann entropy. It is shown that the TSCs of the both nonadditive entropies are equivalent to the positivity of the standard heat capacity. The nal section is devoted to the conclusions.

## 2 Therm odynam ic stability conditions of com posable entropies

The concept of composability [7] is important and quite useful when we consider a therm odynamic system which consists of independent subsystem s. Suppose a total system consists of two independent subsystem s A and B. If the total entropy of any sort S (A; B) is a bivariate and symmetric function f of the subsystem entropies S (A) and S (B), i.e.,

$$S(A;B) = f(S(A);S(B)) = f(S(B);S(A));$$

we say S is composable. This means that the total entropy S (A;B) can be built of just the two macroscopic quantities, S (A) and S (B). Hence we can further discuss the therm odynam ic properties of any composable system without knowing its underlying microscopic dynam ics. For example, the zeroth law of therm odynam ics [8,9,10,11] for T sallis' entropy has been discussed by assuming the composability. It is well known that the BG entropy is composable and additive,

$$S^{BG}(A;B) = S^{BG}(A) + S^{BG}(B)$$
: (8)

I sallis' entropy is also com posable but it's nonadditive, i.e., so-called pseudo-additive [2,3]

$$S_{\alpha}(A;B) = S_{\alpha}(A) + S_{\alpha}(B) + (1 \quad q)S_{\alpha}(A)S_{\alpha}(B);$$

Let us now review the TSC of any additive entropy S (U). We denote the maximum entropy of a therm odynamic system with an internal energy U by S (U). For the sake of simplicity, the internal energy is assumed to be additive, i.e., U (A; B) = U (A) + U (B), in this paper. It is how ever worth noting that W ang [11] has discussed the zeroth and rst laws of therm odynamics by utilizing nonadditive energy expectation value within the fram ework of nonextensive statistical mechanics.

The essence of conventional them odynam ic stability [1] lies in the entropy maximum principle and additivity of S (U). It is known that the relation between the concavity of S (U) and the standard T SC is straightforward as follows. If one transfer an amount of energy U from one of two identical subsystem s to the other subsystem, the total entropy changes from its initial value of S (U;U) = 2S (U) to S (U + U;U U) = S (U + U) + S (U U). The entropy maximum principle dem and s that the resultant value of the entropy is not larger than the initial one, i.e.,

$$2S(U) S(U + U) + S(U U);$$
(10)

which is the TSC of the additive entropy S (U). In the limit of U ! 0, Eq. (10) reduces to the concavity of S (U) with respect to U,

$$\frac{(e^2 S(U))}{(e^2 U)^2} = 0:$$

Thus the TSC and the concavity of S(U) with respect to U are equivalent each other when S(U) is additive. However this is not the case for a nonadditive entropy as we will see in the subsequent subsections.

## 2.1 Tsallis' entropy

Let us now turn focus on the TSC of T sallis' entropy [6]. Taking account of the pseudo-additivity Eq. (9), the TSC of  $S_g$  can be written by

$$2S_{q}(U) + (1 \quad q) [S_{q}(U)]^{2}$$

$$S_{a}(U + U) + S_{a}(U \quad U) + (1 \quad q)S_{a}(U + U)S_{a}(U \quad U):$$

The physical meaning of this inequality is same as that of the conventional TSC Eq. (10). If we transfer a small amount of energy U from one of two identical subsystems to the other subsystem, then the total entropy changes from its initial value  $S_q(U;U)$  of the left-hand-side to the resultant value  $S_q(U + U;U = U)$  of the right-hand-side in Eq. (12). The principle of the maximum T sallis entropy dem ands that the resultant entropy should not be larger than the initial one. The rem arkable di erence between Eq. (12) and Eq. (10) is the presence of the nonlinear term proportional to 1 q, which originally arises from the pseudo-additivity of Eq. (9).

In the lim it of U ! 0, Eq. (12) reduces to the di erential form

Now we introduce the q-generalized tem perature  ${\tt T}_q$  de ned by

$$\frac{1}{T_{q}} \quad \frac{\varrho S_{q}}{\varrho U}; \tag{14}$$

and the q-generalized heat capacity  $C_q$  de ned by

$$\frac{1}{C_{q}} \quad \frac{\partial T_{q}}{\partial U} = T_{q}^{2} \frac{\partial^{2} S_{q}}{\partial U^{2}};$$
(15)

Then Eq. (13) becomes

$$\frac{L + (1 \quad q)S_q}{C_q} + (1 \quad q) \quad 0:$$

We thus see that only the positivity of  $C_q$ , or equivalently the concavity of  $S_q$  (U), is not su cient to satisfy the TSC of the nonadditive T sallis entropy. When q 1, however, the positivity of  $C_q$  guarantees to satisfy Eq. (16) since  $1 + (1 - q)S_q = \frac{1}{i}p_i^q$  is always positive.

Next we shall consider the relation between the TSC and the positivity of the standard heat capacity. By maxim izing the total T sallis entropy  $S_q(A;B) = 0$  under the constraint of the total energy conservation U(A;B) = 0, we obtain the equilibrium condition for a composite system described by T sallis' entropy,

$$T_{q}(A)f1 + (1 \quad q)S_{q}(A)g = T_{q}(B)f1 + (1 \quad q)S_{q}(B)g;$$
(17)

which should be equal to the intensive tem perature T of the total system [8], i.e.,

$$T = f1 + (1 \quad q)S_q g \quad T:$$
 (18)

$$\frac{1}{C} = \frac{1 + (1 - q)S_q}{C_q} + 1 \quad q:$$

The TSC condition of Eq. (16) is thus equivalent to the positivity of the conventional heat capacity,

#### 2.2 The -generalized Boltzmann entropy

Next we turn focus on another nonadditive composable entropy. Kaniadakis [12,13] has introduced another type of one parameter deform ations of the exponential and logarithm ic functions

$$\exp_{f_g}(x) \qquad \frac{h_p}{1 + {}^2x^2} + x ; \qquad (21)$$

$$\ln_{f_g}(\mathbf{x}) = \frac{\mathbf{x} \cdot \mathbf{x}}{2}; \qquad (22)$$

where is a real parameter with 1 < < 1. In the limit of ! 0, the  $\exp_{fg}(x)$  and  $\ln_{fg}(x)$  reduce to the standard exponential and logarithm ic functions, respectively. The -deform ed exponential and logarithm ic functions have the following properties

$$\exp_{f_q}(x) \exp_{f_q}(y) = \exp_{f_q}(x - y);$$

$$\ln_{f g}(xy) = \ln_{f g}(x) \quad \ln_{f g}(y);$$

where -sum is de ned by

x y x 
$$\frac{p}{1+2y^2}$$

Kaniadakis has de ned the -deform ed entropy as

$$\overset{K}{=} p_{i} \ln_{f g} p_{i};$$
(26)

to construct a generalized statistical mechanics in the context of special relativity [14].  $S^{K}$  reduces to the Shannon-BG entropy in the limit of ! 0. The -additivity de ned by Eq. (25) is the additivity of relativistic momenta as shown in Ref. [14].

We shall here consider the TSC of the -generalized Boltzm ann entropy de ned by

S

$$S^{B}(U) = \ln_{f_{q}} W(U);$$
 (27)

where W is the number of microcanonical con gurations of a therm odynamic system.  $S_0^B$  (U) = lnW (U) is the standard Boltzmann entropy. Note that this  $S^B$  is dimensional from the Kaniadakis – entropy  $S^K$ , which is an entropy a la G ibbs, whereas the  $S^B$  is one a la Boltzmann. The reason of using  $S^B$ , instead of  $S^K$ , is that it has the composability (the -additivity),

$$S^{B}(A;B) = S^{B}(A) \quad S^{B}(B):$$

By utilizing this composition rule we readily write down the expression of the TSC of S  $^{\rm B}$  ,

After som e algebra, in the lim it of U ! 0, Eq. (29) becomes

$$\frac{1+2\ ^{2}\ ^{2}\ ^{B}\ ^{B}\ (U\ )\ )^{2}}{1+\ ^{2}\ ^{B}\ ^{B}\ (U\ )\ )^{2}} \frac{q}{1+\ ^{2}\ ^{B}\ ^{B}\ (U\ )\ )^{2}} \left(\frac{^{2}\ ^{2}\ ^{B}\ (U\ )}{^{2}\ ^{2}\ } -\frac{^{2}\ ^{2}\ ^{B}\ (U\ )}{^{2}\ } -\frac{^{2}\ ^{2}$$

Since the term s in front of the brace is always positive, the di erential form of the TSC of S<sup>B</sup> becomes

$$\frac{\varrho^2 S^B}{\varrho U^2} = \frac{\varrho S^B}{\varrho U} \frac{^2}{1 + ^2 [S^B]^2} \qquad 0: \qquad (31)$$

Furtherm one since W (U) is much larger than unity for almost every energy U in conventional therm odynam ics situations,  $S^B$  (U) =  $\ln_{f~g} W$  (U) is positive for such an energy. Thus the concavity of  $S^B$  (U) guarantees to satisfy the TSC of Eq. (31) unlike the case of the TSC of T sallis' entropy. Interestingly the concavity  $Q^2S^B$  (U) =  $Q^2U < 0$  is the su cient, but not necessary, condition in order to satisfy the TSC of  $S^B$ . For example, it is possible to satisfy Eq. (31) even if  $S^B$  is convex (or  $C_{f~q}$  is negative). Therm odynam ic stability conditions for nonadditive composable entropies

Next we turn to the relation between the TSC and the standard heat capacity. We introduce the -generalized temperature  $T_{f~\sigma}$  de ned by

$$\frac{1}{T_{f,q}} \quad \frac{(0S^{B}(U))}{(0U)};$$

Following the similar arguments of the equilibrium condition (or therm odynamic zeroth law) for T sallis' entropy in the previous subsection, we obtain the relation between  $T_{fg}$  and the corresponding intensive tem perature  $T = T_{f0g}$  as

$$T = T_{f g} \frac{1}{1 + 2[S^{B}(U)]^{2}}$$
(33)

A lternatively we can obtain this relation from the de nition Eq. (32) of T  $_{\rm f}$   $_{\rm g}$  ,

$$\frac{1}{T_{f,q}} = \frac{\emptyset}{\emptyset U} \quad \frac{W}{2} \quad W = \frac{\emptyset \ln W}{\emptyset U} \quad \frac{W + W}{2} = \frac{1}{T_{f,0q}} \quad \frac{W}{1 + 2 \mathbb{S}^{\mathbb{B}} f^{2}} :$$

By dimensioning the both sides of Eq.(33) with respect to U, we obtain the relation between the standard heat capacity C and the -generalized heat capacity C<sub>fg</sub>  $@U=@T_{fg}$  as follows.

$$\frac{1}{C} = \frac{q}{1+2} \frac{1}{2} \left[ \frac{1}{C_{fg}} + \frac{2S^{B}}{1+2S^{B}} \right]^{2}} = T_{fg}^{2} \frac{q}{1+2S^{B}} \frac{q}{1+2S^{B}} \frac{q}{2S^{B}} \frac{q$$

where we used Eq. (32) and the relation  $1=C_{fg} = T_{fg}^2$  ( $\&S^B = @U^2$ . By comparing Eq (35) with Eq. (31), we nally nd that the TSC of  $S^B$  is also equivalent to the positivity of standard heat capacity C = 0.

### 3 Conclusions

We have discussed the therm odynam ic stability conditions (TSC) of the two nonadditive composable entropies, which are the T sallis and -generalized Boltzm ann entropies. Unlike the TSC of an additive entropy, the concavity of a nonadditive composable entropy is not necessarily equivalent to the corresponding TSC in general. It is shown that in addition to the TSC of T sallis' entropy, the TSC of the -generalized Boltzm ann entropy is also equivalent to the positivity of the standard heat capacity. It is interesting to further study whether it is common feature to composable entropy.

N onadditive entropy can provide a basic ingredient in order to describe non-separable or correlated system s whose therm odynam ic behaviors are complex and anom abus. It is worth noting that the we have derived the TSCs with resort to the composability of the nonadditive entropies. However composability of system s restricts our consideration to separable system s, which are divisible into independent subsystem s. For non-composable entropies we have not yet known the expression of the corresponding TSCs.
