## Probing Anderson localization of light via decay rate statistics

## Abstract

We have studied the distribution of resonant widths P () in one-, two- and three dimensional multiple light scattering system s. P () should follow a universal power law P ()  $^{1}$  in the localized regime as con rm ed by extensive num erical calculations. This behavior can be interpreted as an unambiguous signature of exponential Anderson localization of light in open system s.

The research on Anderson localization of light has been of great interest [1] since it was originally proposed as the optical counterpart of electronic localization [2]. Localization, as proposed by Anderson, is de ned as an inhibition of wave di usion in in nite disordered media due to interference of multiple scattered waves [3]. A much stronger de nition is that the eigenfunctions in an in nite disordered medium are characterized by an exponential decay in space, j (r) j exp (jr  $r^0 j=$ ), where is the localization length. In nite, open media, waves can \leak" through the sample boundaries. Anderson localization must thus relate to manifestations of leakage in observables quantities. For optical systems, they are typically the emerging intensity, the total transm ission or the coherent backscattering cone. The observation of an exponential scaling of transm ission [4, 5], as well as the rounding of the backscattering cone [6], may not have de nitively established localization since absorption could be responsible for these sam e e ects.

There are several criteria to determ ine the onset of the localized regine. The Io e-Regel criterion states that, in three dimensions (3D), localization occurs for k 1 (w ith k the light wavenum ber inside the medium and 'the mean free path). Another approach to de ne electrom agnetic localization is based on the variance of uctuations of transmission, even in the presence of absorption [7]. In open systems, the \eigenstates" are resonances with a nite energy width (or, equivalently, with a nite lifetime t 1=) due to leakage. The Thouless criterion establishes that localization can be set to occur when the typical time that an excitation needs to propagate through the entire system of size R,  $t_T = 1 = T$  (Heisenberg time), exceeds the maximal time scale of the system,  $t_H = 1 = E$  (Heisenberg time) [8]. Here D is the di usion constant and E the mean level spacing.

This Thouless criterion applies to the average leakage width. Hence it is reasonable to assume that the statistical properties of resonance widths are strongly a ected by localization. The aim of the present paper is to investigate how localization manifests itself in the distribution of resonance widths P () in multiple light scattering in open systems. We will show that P () exhibits the universal power law P () <sup>1</sup> in 1D, 2D and 3D optical disordered systems, thereby generalizing recent theoretical [9] and num erical [10] studies in 1D models of mesoscopic transport. We assert that the algebraic decay P () <sup>1</sup> represents a universal property of Anderson localization of light.

A lthough the statistical properties of resonance widths in open systems have been extensively studied over the last years, in particular for chaotic/ballistic systems [11, 12, 13], their

behavior for system s exhibiting localization has received considerably less attention. As arqued by Casatiet al., P() should follow a power law P() <sup>1</sup> in localized, classically chaotic system s [14]. P () was analytically obtained for 1D disordered system s, showing a slightly di erent power law P ()  $^{1.25}$  [9]. This prediction was corroborated later by num erical calculations in 1D and quasi-1D tight binding models [10]. The P () <sup>1</sup> behavior was also reported in 1D and 3D strongly driven atom ic Rydberg states in the context of dynam ical localization [15]. Exactly at the Anderson transition [16] and in the di usive regime [17], P () was shown to follow a power law with a power di erent from 1. Concerning the study of P () for optical systems, the only work on the subject is, to the best of our know ledge, due to Patra [18], who mainly focused on the small regime and its application to random lasers. For small, it is known that P () is dierent from a power law, for both the di usive [12, 18] and the localized regimes [13, 18]. It should be emphasized that the power law decay of P () is expected to occur only for interm ediate values of , i.e., for not too large , where the resonances are strongly coupled to the continuum and where P () decays faster than algebraically [9, 10], and for > h i.

We will present a simple physical argument, inspired by Refs. [9, 10, 14], to explain the universal P()<sup>1</sup> behavior for the localized regime, i.e., independent on the dimensionality of the system. Due to the opening of the system, exponentially localized eigenstates of the corresponding closed system (linear size R) acquire a nite frequency width <sup>0</sup>, <sup>0</sup> e<sup>r<sup>0</sup></sup>, with r<sup>0</sup> the distance to the boundaries. Near the system edges, the leakage is strong and the resonances are large compared to T. On the other hand, far from the boundaries the leakage is small and the typical in this region is much smaller than T. A ssum ing that the resonances are uniform ly distributed in space, it follows that the (integrated) probability of noting a resonance width smaller than <sup>0</sup>, P<sub>int</sub> ( < <sup>0</sup>), is equal to the probability of noting a resonance situated at a distance r from the boundaries larger than r<sup>0</sup>, P (r > r<sup>0</sup>), i.e., P<sub>int</sub> ( < <sup>0</sup>) = P (r > r<sup>0</sup>). Since P (r > r<sup>0</sup>) / <sub>D</sub> (R r<sup>0</sup>) = <sub>D</sub> (R) with <sub>D</sub> the D-dimensional volume, we conclude that the probability density is

The purely geom etrical factor  $d=dr^0 [_D (R r^0) = _D (R)]$  depends on the dimensionality of the system but does not a ect the exponent in .

To test the validity of (1) in the context of Anderson localization of light, we will consider scalar wave propagation in disordered media using the method introduced by Rusek and O rlowski [19, 20]. This approach is based on the analysis of the G reen matrices spectra, which describe light scattering from random ly distributed pointlike dipoles (i.e., particles much smaller than the wavelength of light). For an incident plane wave  $_0$  (r) in a system of N identical dipoles with scattering matrix t, the eld acting in the dipole at  $r_i$  is given by [19, 20]:

The complex-valued N N matrix G ( $r_{ij}$ ) describes light propagation of the wave scattered by the dipole at  $r_i$  to the dipole at  $r_j$ . Since the eigenvalues M of M I tG and G of G are related by M = 1 t G, and t depends on frequency ! via the scattering phase shift (!) [21], an eigenvalue G with Re G = 1 will perm it an appropriate choice for (!) in order to obtain an eigenvalue M = 0, which would correspond to a genuinely localized state som ewhere inside the random medium [19]. A ssum ing a Breit-W igner model for the scatterers, (with one resonance of width 0 at the position !0) and for which (!) has a simple form, it is possible to obtain, in a good approximation, the resonance widths via G, = 0' 1+ Re G [20]. In the following, we will numerically diagonalize G in 1D, 2D and 3D and calculate the distribution of resonance widths P () using the above approximation.


FIG.1: The norm alized distribution of resonance widths P () calculated for 1000 di erent congurations of 100 point scatterers random ly distributed in a 1D segment with two di erent values of the uniform optical density , = 1 (full squares) and = 10 (open circles) scatterers per wavelength. The dashed line corresponds to the prediction P () <sup>1</sup> for the localized regime and the solid ones are just to guide the eyes. The values of are norm alized by the resonance width of a single dipole  $_0$ .

In Fig. (1), P () is calculated for 1D systems composed of 100 random ly distributed scatterers in a linear segment for two dierent values of the uniform optical density : = 1 and = 10 scatterers per wavelength. In 1D, all eigenstates are known to be exponentially be localized even for weak disorder and is of the order of the mean free path `.P () exhibits a power law with an exponent very close to 1, in good agreement with (1). In addition, the exponent does not change by increasing , i.e., by decreasing . This demonstrates that the algebraic decay P () <sup>1</sup> in the localized regime is valid not only for 1D m odels of m ecoscopic transport [9, 10], but also for our model of wave propagation in disordered m edia. At large , P () decays faster than algebraically. This can be explained by the fact that this region is dominated by short living resonances, typically close to the boundaries, for which the prediction (1) breaks down.

Fig. (2) shows P () for 2D systems of 2500 scatterers random ly distributed in a square for = 1 and = 10 scatterers per wavelength squared. A coording to the scaling theory of

bcalization, all eigenstates in 2D closed systems should be localized, but scales exponentially with '[22]. The <sup>1</sup> decay of P () in Fig. (2) is clearly visible for both values of used, with an exponent very close to 1, in excellent agreement with (1). Remark however that the range of the power law is broader when is higher. Increasing means decreasing 'and, consequently, decreasing . The range of the algebraic decay P () <sup>1</sup> is expected to be broader as more and more states become localized. Such a behavior was also reported in numerical calculations within the Anderson model [10]. For large , P () decays again faster than algebraically as in the 1D case.

In Fig. (3) the 3D case is considered, where P () is calculated for system s composed by 1000 point scatterers random ly distributed in a sphere (radius R) for = 1, = 10, = 30and = 60 scatterers per wavelength cubed. In 3D, the system is expected to undergo, upon varying the degree of disorder, a transition from extended states to localized states. It is therefore interesting to investigate if and how this transition manifests itself in P (). As in the 2D case, we notice that, as increases, the range of the algebraic decay P () increases. We also remark that, as increases, the associated exponents tend more and more to the value 1. The exponents, obtained by a linear t in the range where the power law 0.76 for = 1, 0.83 for = 10, 0.95 for = 30 andis present, are 1:1 for = 60. This suggests, according to (1), the onset of the localized regime for higher . In fact, the Io e-Regel criterion for localization (k < 1) is estimated to be satis ed for > 2<sup>2</sup> 20 for scatterers at resonance. This condition is fullled for = 30 and = 60, for which is very close to 1, showing that the system with these densities are indeed in the localized regime and con m ing that the power law P ()  $^{1}$  can be considered a genuine signature of Anderson localization of light. The fact that the exponents for = 30and = 60 are not exactly equal to 1 can probably be attributed to nite-size e ects. Once again, note that P () decays faster than a power law for large .

Let us now compare the mean width of the distribution to the inverse Thouless time  $_{T} = 1 = t_{T} = 6D_{B} = R^{2}$ , where  $D_{B}$  is the Boltzm ann di usion constant. To estim ate  $_{T}$  one should recall that in 3D,  $D_{B} = v_{E}$  '=3, where ' is the transport mean free path (which is, for point scatterers, equal to ') and  $v_{E}$  the energy transport velocity,  $v_{E} = c_{0} = [1 + d_{w} = m_{f}]$  [23], with  $d_{w} = 1 = 0$  the dwell time in a single scattering and  $m_{f} = = c_{0}$  the mean free time. Applying these considerations,  $_{T}$  can be written as  $_{T} = 0$  =  $2 (=R)^{2}$ . Fig. (4) exhibits P () for the same optical densities of Fig. (3) but now with normalized to  $_{T}$ . For low

( = 1 and = 10), P () is peaked near  $_{\rm T}$ , showing that the system is in the di usive regime. Notice that there is a non-vanishing probability to nd modes that live much longer than  $t_{\rm T}$  even in the di usive regime, the so-called \prelocalized" modes [24]. As increases, we observe that P () is no longer centered at  $_{\rm T}$  and that the probability to nd a mode with resonance width smaller than  $_{\rm T}$  also increases. This means that, on average, the modes live longer than  $t_{\rm T}$ . At the same time, Fig. (3) shows that localization manifests itself in P () not only via the broadening of the power law range but also via the fact that the associated exponents approach to 1. We conclude again that the P () <sup>1</sup> behavior is an unambiguous signature of Anderson localization of light in open media. It must be mentioned that the present 3D study may be relevant for recent multiple light scattering experiments in atom ic media [25], for which modeling the scatterers by pointlike dipoles constitutes an excellent approximation.

In sum m ary, we have studied the distribution of resonance widths P () in 1D, 2D and 3D multiple light scattering systems composed of random ly distributed pointlike scalar dipoles. We have developed a simple physical argument, based on the exponential decay of localized eigenfunctions, to show that P () should follow an universal power law P () <sup>1</sup> decay in the localized regime. This prediction was con med by extensive numerical calculations and demonstrates that the P () <sup>1</sup> behavior can be interpreted as an unambiguous signature of Anderson localization of light in open media.


