Speci c heat and m agnetization study on single crystals of a frustrated, quasi one-dim ensional oxide: C a₃C o₂O ₆

Speci c heat and m agnetization m easurem ents have been carried out under a range of m agnetic elds on single crystals of $Ca_3Co_2O_6$. This compound is composed of Ising m agnetic chains that are arranged on a triangular lattice. The intrachain and interchain couplings are ferrom agnetic and antiferrom agnetic, respectively. This situation gives rise to geom etrical frustration, that bears som e sim ilarity to the classical problem of a two-dimensional Ising triangular antiferrom agnet. This paper reports on the ordering process at low -T and the possibility of one-dimensional features at high-T.

IN T R O D U C T IO N

Ca₃Co₂O₆ belongs to a large fam ily of com pounds of general form ula A'₃ABO₆, with Ca, SrorBa on the A' site, while the A and B sites can be occupied by a great variety of cations including many transition m etal elements.[1] The rhom bohedral structure of these com pounds consists of [ABO₆], in nite chains running along the c-axis of the corresponding hexagonal cell, with the A' cations located in between them (see Fig. 1). These chains are made of alternating, face-sharing AO₆ trigonal prisms and BO₆ octahedra. Each chain is surrounded by six equally spaced chains form ing a triangular lattice in the ab plane. The intrachain A-B separation is quite small, whereas the interchain distance is approximately twice that distance (for example about 2.6 and 5.2 A, respectively, in the case of $Ca_3Co_2O_6$).[2] Reinforcing this geom etrical anisotropy, the oxygen atom s along the chains can e ciently mediate the intrachain coupling, whereas the A' cations play no role in the interchain coupling. Therefore, these compounds are expected to display pronounced one-dimensional (1D) magnetic character.

Am ongst this fam ily, $Ca_3Co_2O_6$ has attracted special interest in recent years due to its very peculiar magnetic properties.[3, 4, 5, 6] A coording to the most recent studies, [5, 6] both the cobalt ions in this com – pound are trivalent, but as they are subject to di erent crystalline-electric- elds (CEF), the Co ions are in different spin states. As pointed out by A asland et al.,[3] the CEF-induced splitting of the 3d orbitals produces a gap between a lower triplet and an upper doublet that is larger in an octahedral environm ent than in a prism atic one. As a consequence, the 3d⁶ con guration of C σ^{3+} can produce a high-spin state (S = 2) on the prism atic site and a low-spin state (S = 0) on the octahedral site. A lthough indisputable evidence is still absent, this scenario is the m ost consistent with the neutron di raction data and the magnetic measurements that are available at the present tim e.[3, 4, 5, 6] At high temperatures, it must be borne in m ind that the situation may be com plicated by a progressive transition from the low-spin state to the intermediate-spin state (S = 1) and/or the high-spin state.[6]

The previous studies on $Ca_3Co_2O_6$ have established several basic features about the Co-Co interactions in this compound: (i) a strong Ising-character, [7] with the spins oriented along the chain axis; (ii) a ferrom agnetic intrachain coupling; (iii) an antiferrom agnetic (nearestneighbor) interchain coupling. Such features, combined with the triangular arrangement of the chains on the ab plane, give rise to a prototypical situation of geom etrical frustration. $Ca_3Co_2O_6$ is also reported to exhibit peculiar magnetic behaviour, especially in M (H) curves.[3, 4, 5, 6] For instance, a sequence of irreversible m etam agnetic transitions take place at very low T (< 5 K), in the so-called Frozen Spin state, while there is a sharp ferrin agnetic-to-ferrom agnetic transition at interm ediate tem peratures around 10 K. Com plex phase diagram s have been proposed.[4, 6] Som e features of these phase diagram s are still the subject of controversy. One of the most debated issues deals with the ordering process under zero or low eld. K ageyam a et al. [4] have proposed a scenario sim ilar to the one developed by M ekata et al. [8, 9] for C sC oC b (antiferrom agnetic Ising chains, antiferrom agnetically coupled on a triangular lattice).[10] Upon cooling, this model predicts an initial transition to a Partially D isordered Antiferrom agnetic (PDA) state, in which two thirds of the chains are antiferrom agnetically coupled while the last third remains incoherent,[11] followed by a second transition to a ferrim agnetic state at lower T. W hether this scenario is applicable to the case of $Ca_3Co_2O_6$ has recently been questioned.[6, 12] To date no speci c heat m easurem ents have been performed on this compound, although such therm al data would be valuable in understanding the physics of this m aterial.

In this paper, we report on speci c heat measurements under an applied magnetic eld, carried out on $Ca_3Co_2O_6$ single crystals. The magnetic eld has allow ed us to investigate the ordering process in the various m agnetic states adopted by this m aterial: disordered antiferrom agnetic, ferrim agnetic and ferrom agnetic. Such a study had to be carried out on single crystals due to the highly anisotropic properties of this com pound. [5, 6] This paper is organized as follows. Section II is devoted to experim ental details, and in particular details of the single-crystal alignm ent procedure and the subtraction of the lattice contribution to the speci c heat. Section III reports the speci c heat data under zero eld and large m agnetic elds, along with the corresponding m agnetization m easurem ents. The results are discussed in Section IV and our conclusions are presented in Section V.

EXPERIM ENTAL DETAILS

Single crystals were grown using a ux method described previously. [6] This method yielded needle-like crystals - sim ilar to those used for magnetic measurements in Ref. 6 -along with other specimens that have an aspect ratio that is more suitable for speci c heat measurements. These latter crystals have the shape of short hexagonal rods term inating in three diamondlike faces at each end. Their small size (0:7 0:7 1 mm³) makes it di cult to get reliable speci c heat data on only one crystal. We have used a set of four crystals with a totalm ass of 10.64 mg. Magnetic measurements carried out on each crystal veri ed the good hom ogeneity of this assembly.

A llm agnetic and speci c heat m easurements reported in this paper were recorded with the magnetic eld along the c axis of the crystals. The crystals were aligned using the following procedure: (i) at 300 K, the four crystals were put into a small amount of Apiezon N grease (contained in a gelatine capsule, or on the measuring platform, for magnetization or speci c heat, respectively); (ii) a magnetic eld of 5 T is then applied. Owing to the substantial magnetic anisotropy persisting up to room temperature in this compound, the sam ples experience a torque which tends to align their c-axis along the direction of the applied eld. We checked that 5 T is large enough to rotate our crystals in Apiezon N at 300 K, a temperature at which this grease has a low viscosity; (iii) the sam ples are then slow ly cooled under 5 T down to 150 K. This ensures the eld alignment is maintained through the glass transition of Apiezon N grease that occurs around 230 K;[13] (iv) at 150 K, the grease is solid enough to hold the sam ples in position without a magnetic eld, while the temperature is still above the magnetic transitions of the compound. The eld is reduced to zero, and the cooling is resumed to prepare the sam ples in a Zero Field Cooled (ZFC) state. The quality of the alignment obtained by this method was demonstrated by the sharpness of the ferrim agnetic-to-ferrom agnetic transition and the magnetization values at the associated plateaus.

The speci c heat m easurements were carried out by a two-tau relaxation m ethod (PPM S, Q uantum D esign) with m agnetic elds up to 5 T and temperatures down to 2 K. A background signal (platform and grease) was recorded versus temperature under each eld investigated. M agnetization m easurements were carried out on the same set of crystals, by m eans of a Superconducting Q uantum Interference D evice m agnetom eter (M PM S, Q uantum D esign), with m agnetic elds up to 5 T and temperatures down to 2 K.

In order to subtract the lattice contribution to heat capacity, a non-m agnetic isostructural com pound was synthesized. A ceram ic sample of Ca_4PtO_6 was prepared from a stoichiom etric mixture of CaO and PtO₂. These starting materials were pelleterized in the form of bars and heated in a evacuated silica ampoule at 800 C for 12 h. X-ray di raction veri ed the single phase of the Ca_4PtO_6 compound, and con med that this material has the same rhom bohedral structure as $Ca_3Co_2O_6$. In Ca_4PtO_6 , the Ca^{2+} cations occupy the trigonal prisms, while the Pt^{4+} (3d⁶) on the octahedral sites are supposed to be in a low-spin state (S = 0) due to a large CEFinduced gap. To check this point, magnetic measurements were performed between 2 and 300 K, leading to a susceptibility of the form = 0 + C = T, with $C = 0.00151 \text{ em u K m ol}^1$. This Curie constant is about 0.05% of the value expected for high-spin Pt^{4+} (S = 2), and 0.15% of the value expected for interm ediate-spin Pt^{4+} (S = 1). This result ensures that the speci cheat data of Ca_4PtO_6 (up to 300 K) does not contain a signi cant magnetic contribution from the electronic spins. Furthermore, the data down to 2 K for both compounds reveals no contribution from a Schottky term related to nuclear level splitting. Finally, one can also safely discard the presence of a signi cant electronic term in these compounds owing to their poor electrical conductivity.[6, 14] One can thus consider that the speci cheat of C a_3 C o_2 O $_6$, in the range 2-300 K, is made up of two term s: C (T) = C $_{\rm L}$ (T) + C $_{\rm M}\,$ (T), where C $_{\rm L}\,$ is the lattice contribution related to phonon excitations, while C_M is the magnetic term that we are interested in.

The contribution C_{L} (T) of $C_{a_3}C_{o_2}O_{6}$ can be derived from the total speci c heat $C^0(T)$ of $C_{a_4}PtO_{6}$, but the di erence in molecular weight between the two compounds must be taken into account. There is no generally accepted method to do this, and some approximations have to be made. Within the framework of the Debye approach, the lattice contribution is determined only by the ratio =T, where is the Debye temperature, which depends on the structure and the mass of the constituent atom s.[15] A coordingly, the correction of mass amounts to the determination of the ratio $r = = {}^{0}$, where and 0 are the Debye temperatures of Ca₃Co₂O₆ and Ca₄PtO₆, respectively. Since

in the basic monoatom ic model is inversely proportional to the square root of the mass, one can get a rst estim ate by using the molecular weights, leading to r′ M $(Ca_4PtO_6) = M (Ca_3Co_2O_6) = 1:16$. A more sophisticated method based on the principle of corresponding states has been developed by Stout and Catalano. [16] This technique is based on the comparison of the speci c heat data at high tem peratures for the m agnetic and the reference com pounds. It has the great advantage of accounting for a tem perature dependence in the parameter r, but, on the other hand, it requires an extrapolation of r in the low T range (below about 190 K in our case) which introduces a signi cant uncertainty. Following the extrapolations proposed in Ref. 16, we found r 1:15 at low T. In the present study, we also have the opportunity to derive an experimental estim ate of r by analysing the low-tem perature dependence of the speci c heat data. Indeed, the lattice contribution is reduced to a term ${}_{3}T^{3}$ at low temperature, with $_3$ / (1=)³. In a C = T - vs-T² plot, both the curves of Ca₃Co₂O₆ and Ca₄PtO₆ exhibit a linear regime at low T from which one can extract 3 values leading to $r' [_{3}(Ca_{4}PtO_{6}) = _{3}(Ca_{3}Co_{2}O_{6})]^{1=3} = 1:13.$

In the analysis presented hereafter, we chose to retain this latter value, which appeared to us as the best comprom ise between simplicity and reliability. However, we will take the uncertainty on the r value into account when discussing the comparison of C_M (T) with theoretical predictions (Sec. IV-B). Since one can write C_L (T) = $C^0(T = r)$ within the fram ework of the D ebye model, the lattice contribution of $Ca_3Co_2O_6$ has been derived by multiplying the temperature values of the total speci c heat data $C^0(T)$ of Ca_4PtO_6 by r = 1.13.

RESULTS

Figure 2 shows the total speci c heat versus tem perature for C a_3 C o_2 O $_6$ m easured under zero-eld, along with the estimated lattice contribution obtained by using the procedure described above. The main feature is a prominent peak in the raw data around 25 K, indicative of a long-range ordering (LRO). It can also be observed that the total speci c heat C (T) tends to merge with the lattice contribution C_L (T) at high T. The inset displays an

enlargem ent of the low T portion of the data as a C=T-vs-T² plot. Three separate runs are shown together, which illustrate the good reproducibility of the C (T) data. This plot also shows that the lattice term has a simple cubic tem perature dependence ($C_L = _3T^3$), as expected for such contributions. We found $_3$ ' 310^4 JK 4 m ol¹, leading to a D ebye tem perature ' 415 K. Beside this lattice term, the speci c heat of Ca₂Co₂O₆ exhibits a linear contribution T (' 10 m JK² m ol¹), and one can see the development of magnetic excitations above 7 K.

Figure 3 shows the magnetic part of the speci c heat, C_M (T) = C (T) C_L (T), under zero-eld. Beyond the sharp peak around 25 K, [17] there is a broad bum p at higher tem peratures. Because of increased scatter in the data at high T, which is further enhanced by the subtraction procedure, the curve has been cut above 200 K. The inset shows the tem perature dependence of the magnetic entropy S_M (T) = $\binom{R_T}{0}$ (C_M = T) dT. The peak in C_M (T) at 25 K yields a signi cant change in the rate of entropy variation around this tem perature. It should be noted that the entropy at the LRO transition, S_M (25 K) is equal to 18 % of the total magnetic entropy. This sm all value is consistent with the expected behaviour in a 1D system .[18] One can also note that S_M at high T tends to saturate just below the expected value for one cobalt of spin 2 per form ula unit (R ln 5).

Before showing the speci cheat results under magnetic eld, let us consider the corresponding magnetization data. Figure 4 shows an enlargement of dc-susceptibility curves for an applied eld of 0.1 T, 2 T and 5 T, and focusses on the region around the transition at 25 K . In both 2 T and 5 T, one observes a small di erence between the Zero Field Cooled (ZFC) and Field Cooling (FC) curves at very low T (T < 5 K), a behaviour which is consistent with the large hysteresis displayed by the M (H) curves in the same temperature range.[4, 5, 6] Above this irreversible regime, the low T plateaus of the curves under 2 T and 5 T correspond to m agnetizations equal to M $_{\rm S}$ = 3 and M $_{\rm S}$, respectively, where M $_{\rm S}$ is the full spin polarization.[19] This is consistent with the ferrim agnetic and ferrom agnetic natures of the low T states in 2 T and 5 T, respectively, that have been reported previously. [3, 4, 5, 6] Let us now turn to the corresponding speci c heat data recorded in 0 T, 2 T and 5 T after ZFC. Even below 5 K, no signi cant hysteresis could be detected between the ZFC and the FC curves in the C (I) data. Furtherm ore, we checked that there is no di erence between the C (T) curves recorded under 0 T or 0.1 T . Figure 5 shows the C_M (T) curves under eld which were derived by subtracting $C_{\rm L}$ (T) from the raw data.

The 2 T data exhibit a very large, lambda-like peak at 25 K. It must be emphasized that the height of this peak is much larger than that found under 0 T. In 5 T, there is only a smooth bump around 25 K. This is

consistent with the expected behaviour for a long-range ferrom agnetic transition in a large eld. In the low T regime, one observes that the 2 T curve lies well below the data collected with no eld applied. One can get a better insight into this low T range by considering the temperature dependence of the magnetic entropy as displayed in Fig. 6(a). The curves for 0 and 2 T are close to each other below about 7 K and above $T_{\rm N}$. In the intermediate range, the entropy in 0 T is much larger than in 2 T.

Figure 6 (b) shows the ZFC susceptibility curves in the same tem perature range, that were recorded under 0.1 T with a waiting time t_W after each tem perature stabilization equal to either 5 seconds or 600 seconds. A Libough

(T) starts increasing abruptly at $T_{\rm N}~$ (see also Fig. 4), the maximum slope in the ZFC curves is actually found at $18~{\rm K}$. In between $18~{\rm K}$ and $8~{\rm K}$, the ZFC curve exhibits a pronounced relaxation e ect. Below $8~{\rm K}$, (T) becomes time-independent and is roughly constant down to $2~{\rm K}$.

D ISC U SSIO N

The ordering process under low eld

In the literature on $Ca_3Co_2O_6$, the existence of two critical tem peratures at $T_{C_{\rm 1}}$ (' 25 K) and $T_{C_{\rm 2}}$ (' 10 K) has often been invoked: the rst has been associated with a ferrom agnetic intrachain transition, while the second is identi ed with an antiferrom agnetic transition between the ferrom agnetic chains. One of the main pieces of inform ation provided directly by our speci c heat investigations is the sharp peak observed at 25 K in the C (T) data under zero- eld. This feature clearly dem onstrates the occurrence of a collective magnetic transition. Since it is wellknown that such long-range ordering (LRO) cannot take place in one dimension, this feature cannot be ascribed to a ferrom agnetic transition along the chains. The scenario described above is thus inconsistent with the speci c heat data. W e propose that there is a collective transition at T_N ' 25 K corresponding to an antiferrom agnetic coupling between the chains. Note this is consistent with the emergence of antiferrom agnetic Bragg peaks around 25 K in neutron di raction data.[3] However, the entropy jump associated with this transition shows that the antiferrom agnetic ordering is far from being complete. At the same time, the development of a long-range interchain ordering, even if it is partial, can reduce the magnetic uctuations along the chains. This could explain why the antiferrom agnetic ordering at T_N is accompanied by a sudden increase of the susceptibility.

The existence of a LRO transition at a rather high tem perature in $Ca_3Co_2O_6$ emphasizes a clear departure from the pure Ising triangular antiferrom agnet which has a totally frustrated ground state. [20, 21, 22] One of the most likely origins for such a lifting of degeneracy is the in uence of next-nearest interchain interactions.[23] Som e studies of Ca₃Co₂O₆ proposed a scenario involving a PDA (Partially Disordered Antiferrom agnetic) state, [4, 5] which im plies AF nearest-neighbor coupling and F next-nearest { neighbours coupling. In this m odel, the decrease of tem perature rst induces a transition at $T_{\rm N\ 1}$ to a PDA state, followed at $T_{\rm N\ 2}$ by a transition to a ferrim agnetic state.[8, 9] This process is supposed to give rise to a smooth peak in speci c heat at T_{N-1} and a large one at $T_{N 2}$. This is in contrast with our experimental results in $Ca_3Co_2O_6$, since we observed a sharp peak at the st transition, while no additional peak exists at lower tem peratures. It should be noted, how ever, that even in the ABX₃ compounds (A = C s, Rb, and B = C o) for which this model was developed, the speci c heat data do not show clear support for the theoretical expectations. [24, 25, 26] It was argued that the transition to ferrin agnetism might be prevented by the establishm ent of a glassy phase at low tem peratures.[27] In $Ca_3Co_2O_6$, this latter phase could be the Frozen Spin state which was found in magnetization studies. [4, 5, 6]Our speci c heat measurements show that the transition to the Frozen Spin state (T $_{\rm F\,S}$ ' 7 K) is associated with a noticeable change of regime in a $C = T - vs - T^2$ plot (see inset of Fig. 2). In the low T regime, the speci c heat exhibits a linear term with ' 10 m J K 2 m ol 1 . Such a feature is usually found in spin glasses [28] and in other disordered m agnetic system s such as m ixed-valent m anganites.[29, 30] W e can thus speculate that this linear contribution re ects the disorder that remains in the chain system of $Ca_3Co_2O_6$ at low T.

As for the shape of the peak at $T_{\rm N\ 1}$, it was found that it could vary considerably with the level of frustration.[27] Depending on the signs and respective values of the rst, second and third neighbor interactions in a 2D Ising triangular antiferrom agnet, M onte C arlo simulations showed that a large variety of C (T) curves can be expected, including a single large peak at $T_{\rm N\ 1}:$ O ur observations are thus consistent with such a generalized PDA scenario, while they seem to rule out the standard picture proposed earlier.[4, 5]

The speci c heat m easurem ents provide us with inform ation about the entropy variation in between $T_{\rm F\,S}$ and $T_{\rm N}$. In an applied eld of 2 T, Ca_{\rm S}Co_{\rm 2}O_{\rm 6} undergoes a transition from a disordered state (system of uncoupled chains) to a ferrim agnetic state. The speci c heat data exhibit a very large, sharp peak at $T_{\rm N}$, which is much m ore pronounced than under zero- eld. The magnetic entropies calculated at $T_{\rm N}$, how ever, are found to be the sam e under both elds. Therefore, the magnetic eld only a ects the way the entropy evolves below $T_{\rm N}$. In an applied eld of 2 T, the magnetic state), so there is a sudden large release of entropy just around $T_{\rm N}$. In contrast, the transition under zero- eld is more progres-

sive. A lthough there is a noticeable change of entropy at $T_{\rm N}$, it is much smaller than under 2 T, and the entropy is progressively reduced as the tem perature is decreased further. The di erence between the S (T) curves under 0 T and 2 T can give direct insight into the large m agnetic disorder that persists far below $T_{\rm N}$ under zero eld. U pon cooling below $T_{\rm N}$, the slow decrease of entropy in zero- eld is interrupted by the spin freezing at $T_{\rm FS}$ '7 K . This is also the tem perature at which the S (T) curves at 0 T and 2 T are found to merge onto each other.

A nother aspect of this ordering process is revealed by m agnetization data at low eld, which showed that a pronounced relaxation e ect takes place below T_N . This e ect starts above T_{FS} , which is consistent with the fact that one cannot expect signi cante ects over short time scales (i.e. 600 seconds) in a frozen spin state. This large relaxation e ect [Fig. 6(b)] indicates that the magnetic disorder revealed by the speci cheat m easurements [Fig. 6(a)] evolves with time. This behaviour is probably related to the frustration and the slow dynam ics associated with spin reversals in ferrom agnetic chains.[5, 6]

The broad maxim um at high tem perature

A nother striking feature of the magnetic contribution to the speci c heat is the existence of a broad m axim um at high tem peratures, well above $\ensuremath{T_{N}}$. Actually, such a result is theoretically expected in a 1D m agnetic com pound, owing to the developm ent of short-range ordering along the chains. [18] From an experimental point of view however, there are not so m any reports on such features, in particular for Ising system s. To our know ledge, the only clear report of such a broad maximum with Ising ferrom agnetic chains dealt with CoC 1/2 2N C5H 5.[31] The tem perature of the maximum (T_{max}) in C_M (T) as well as its height (C_{max}) are predicted to increase with the spin value.[18] This could explain why this broad maximum is so visible in our case while it is generally hidden by the LRO transition in Ising system swith smaller spin values. A coording to theoretical predictions for a Ising system with S = 2, one should expect T_{max} ' 3:72 J and C_{max} ' 1:4 R; where J and R are the intrachain coupling and the gas constant, respectively.[18, 32] In our case, $C_{\,m\,\,ax}\,$ is found to be close to 8 rather than 1:4 R 12 J K 1 m ol 1 , but it should be noted that C_{max} is quite sensitive to the value of the r parameter used in the subtraction of the lattice contribution (e.g. one $nds C_{max}$ 11 JK ¹ mol¹ forr 1:16). In contrast, $T_{m ax}$ is found to be essentially independent of the r value in the range 1:13 1:16. This characteristic tem perature leads to J 22 K, while K ageyam a et al. reported 15 K from an analysis of the susceptibility at high J T.[5] Taking into account that this latter analysis may also contain som e uncertainties, one can consider that there is a reasonable overall agreem ent between the experimental C_M (T) data and the theoretical expectations for short-range excitations in an S = 2 Ising chain.

It must be emphasized that a totally di erent phenom enon m ay contribute to the existence of a broad peak in C_M (I). The cobalt ions in the octahedral sites that are in low-spin (LS) state at low T could change their spin state to high or interm ediate spin states (HS or IS) as T is increased. Such a phenom enon is currently the source of intensive debate [33, 34, 35, 36] in the case of LaC oO $_{3}$, which also contains LS C o³⁺ on octahedral sites at low T. Rather than a true spin state transition, an increase in temperature can induce a progressive therm al population of the IS and/or HS levels. Such a process will have a pronounced signature in $C_{\,M}\,$ (T), in the form of a Schottky anom aly.[15] Therefore, a spin-state crossover, if it occurs, could contribute to the bum p seen in speci c heat at high T .[37] A coordingly, it is worth noting that the existence of such an additional phenom enon could affect to some extent the analysis of the bump in C_M (T) in terms of pure short-range spin ordering. The interplay between the short-range spin ordering and a possible spin-state crossoverm ust be very com plex, and at the present time, it seems di cult to separate the two e ects simply on the basis of speci cheat and/orm agnetization data. It is clear that m ore direct investigations of the C o spin states in $Ca_3Co_2O_6$ are required to proceed further with this analysis.

CONCLUSION

Our speci cheat investigations in Ca₂Co₂O₆ have revealed several features that complement the previous magnetization studies. We have shown that there is a peak at T_N ' 25 K in C_M (T) under an applied eld of 0 T and 2 T. This feature clearly demonstrates the occurrence of a long-range ordering associated with the antiferrom agnetic interchain coupling. In 5 T, there is no longer a peak in the data, as expected for a ferrom agnetic transition in a large magnetic eld. In an applied eld of 2 T, the ordered state is ferrin agnetic and the peak at T_N is found to be very pronounced. Under zero eld, the peak at T_N is signi cantly reduced; the magnetic entropy displays a smooth, continuous evolution versus tem perature below ${\rm T}_{\rm N}$, that is interrupted when entering the Frozen Spin state around T_{FS} ' 7 K.One observes a pronounced crossover in the tem perature dependence of C_M (T) around T_{FS} . Below T_{FS} , the speci c heat has a linear term (T) that can be associated with frozen m agnetic disorder. It must be emphasized that no additional peak was detected in C_M (T) below T_N , which appears to rule out a ferrin agnetic transition as proposed by som e PDA scenarios.[8,9]

M agnetization m easurements revealed a noticeable time dependence in the intermediate temperature range between $T_{\rm F\,S}$ and $T_{\rm N}$. The combination of our speci c

heat and magnetization results demonstrates that the magnetic state below $T_{\rm N}\,$ under zero $\,$ eld is still highly disordered and evolves continuously with both temperature and time. This feature probably derives from a combination of geometric frustration and the slow spin dynamics of ferrom agnetic chains.

The magnetic heat capacity exhibits a broad maximum at high T which can be related to one-dimensional short-range ordering along the ferrom agnetic chains. The fact that only a small fraction (' 0.18) of the total magnetic entropy \mathbb{R} ln (2S + 1)] is released up to T_N is consistent with the expectations for a 1D system. It is worth em – phasizing that Ca₃Co₂O₆ and a few other compounds of the same fam ily [38] seem to be the only model system s for the case of Ising ferrom agnetic chains, antiferrom agnetically coupled on a triangular lattice.
