# E lectrom agnetic response of layered superconductors with broken lattice inversion sym m etry

W e investigate the m acroscopic e ects of charge density waves (CDW) and superconductivity in layered superconducting system s with broken lattice inversion symmetry (allowing for piezoelectricity) such as two dimensional (2D) transition metal dichalcogenides (TMD). We work with the low temperature time dependent G inzburg-Landau theory and study the coupling of lattice distortions and low energy CDW collective modes to the superconducting order parameter in the presence of electrom agnetic elds. We show that superconductivity and piezoelectricity can coexist in these singular metals. Furtherm ore, our study indicates the nature of the quantum phase transition between a commensurate CDW phase and the stripe phase that has been observed as a function of applied pressure.

#### I. IN TRODUCTION

The quasi-two-dimensional (2D) transition metal dichalcogenides (TMD)<sup>1</sup> 2H-NbS<sub>2</sub>, 2H-NbSe<sub>2</sub>, 2H-TaS<sub>2</sub> and 2H-TaSe, are layered compounds where superconductivity coexists with a charge density wave (CDW) state<sup>2</sup>. It has been documented experimentally that these materials present anom alous properties such as a decrease of the resistivity and decoupling between planar and c-axis transport in the CDW phase<sup>3</sup>, anom alous in purity e ects on the superconductivity and non-linear Hall  $e ect^4$ , stripe phases<sup>5</sup>, and more recently angle resolved photoem ission experiments (ARPES) have shown a quasi-particle lifetim e diverging linearly with the energy close to the Ferm i surface<sup>6</sup> in contrast to ordinary Ferm i liquids where the lifetim e diverges quadratically with energy. Some of these properties are similar to the ones observed in high tem perature superconductors  $(HTC)^7$ . Contrary to HTC, however, TMD are extremely clean systems and therefore the anom alous behavior is undoubtedly intrinsic and sample independent. Therefore the understanding of the anom alous m etallic behavior in these 2D m aterials m ay provide clues for the understanding of the anom alous physics that occurs in a broad class of 2D system swhere superconductivity occurs.

One of us (AHCN), has proposed recently an unied picture of the CDW and superconducting transitions that can explain some of the anomalies observed experimentally<sup>8</sup>. The theory proposes that the mechanism of superconductivity is related to the pairing of the CDW elementary excitations mediated by acoustic phonons via a piezoelectric coupling. These excitations are D irac electrons situated in the nodes of a CDW gap, resembling the Ferm i surface zone of graphite. In TMD, unlike the case of graphite, the lattice inversion sym metry is broken in the CDW phase. The breaking of the inversion symmetry in TMD, as documented in neutron scattering experiments<sup>9</sup>, allows for a piezoelectric coupling between charge carriers and phonons<sup>10</sup>. Since CDW formation is usually related to nested Ferm i surfaces in 1D systems, weak 2D nesting combined with strong variations in the electron phonon coupling due to the tight-binding nature of the electronic orbitals, can be responsible for the origin of the nodal CDW order param – eter. This model is able to correctly explain some of the anom alous properties of TMD such as the energy dependence of the quasi-particle lifetime (given by the im aginary part of the D irac ferm ion self-energy), the critical dependence of the superconducting transition with the lattice param eters, the reduction of the resistivity, and the m etallic behavior in the CDW phase.

However, a criticism has been raised to this theory based on the fact that piezoelectricity normally occurs in insulating systems since metals can screen the internalelectric elds<sup>11</sup>. However, Dirac ferm ions in 2D have a vanishing density of states at the Ferm i energy and therefore do not screen electric elds<sup>12</sup> allowing for the existence of a m etallic state (that is, a state with gapless ferm ionic excitations) and piezoelectricity. Nevertheless, the possibility of coexistence of piezoelectricity and superconductivity is indeed surprising. In such a system it would be possible to generate super-currents by simply squeezing the sample. In this work we show that there is no contradiction between the existence of piezoelectricity and superconductivity in materials where the low-lying excitations are D irac ferm ions. W e investigate the current and charge uctuations that would arise in these system s under the view point of the collective m odes.

U sing path integrals we derive a sem i-classical action that describes the coupling between plasmons (responsible for screening) and acoustic phonons to the superconducting order parameter via the piezoelectric coupling. Various well-known regimes are described by this action: (1) in the case of normal electrons without superconductivity we recover the well-known results for collective m odes and screening in 2D and  $3D^{13}$ ; (2) in the case of D irac ferm ions without superconductivity we re-obtain the results for collective m odes and screening in sem im etals like graphite<sup>14</sup>; (3) in the absence of piezoelectric coupling, we recover the behavior of an ordinary type II superconductor<sup>15</sup>. However, when we allow the piezoelectric coupling with D irac ferm ions and superconductivity, new e ects appear in the electrom agnetic response. M oreover, our results shed light on the origin of the quantum phase transition between the commensurate CDW phase and the stripe phase in TMD.W e also investigate the collective m odes that appear when combined with low lying energy bulk plasm ons.

The article is organized in the following manner: in section II we discuss the plasm ons in layered nodal liquids and speci cally in TMD; in section III we develop the sem i-classical calculation in general grounds and apply it to layered com pounds like TMD in section IV.W e have added an appendix where the details of the calculation are presented.

## II. NODAL LIQUID PLASMONS

The eld theory of nodal liquids<sup>16</sup> is built under the basic idea that the nodes of a CDW order parameter lead to two distinct subsystems which correspond to the two components of the D irac ferm ion spinor  $y = \begin{pmatrix} y \\ + \end{pmatrix}$ ; y), with +, indexing respectively the ferm ionic particles and anti-particles (holes). The non-interacting low energy H am iltonian that describes the elementary excitations inside the D irac cone is:

where k is the momentum,  $_{\rm x,y}$  are Paulim atrices that act in the particle-anti-particle subspace,  $v_{\rm F}$  and v are the anisotropic velocities perpendicular and parallel respectively to the Ferm i surface, and B Z is the rst Brillouin zone of size 2 =d along the  $k_z$  axis (d the inter-plane distance). When the chemical potential, , intercepts the D irac point, the Ham iltonian (1) leads to the zero order polarization function^{17} at T = 0, whose com plex conjugate is given by:

where ! is the frequency,  $q = q_x + (v = v_F)q_y$  the anisotropic in-plane m on entum. In the absence of hopping between the planes or interactions with the lattice, the collective excitations of the D irac ferm ions are due to the 3D C oulom b interaction,  $V_0$ , between carriers in di erent planes:  $V_0(q;k_z) = 2 de^2 = (_0q)S(q;k_z)$ , with a structure factor  $S(q;k_z) = \sinh(qd) = \cosh(qd) \cos(k_zd)$  identical to the layered electron gas (LEG) case<sup>18</sup> (e is the electron charge, and  $_0$  the dielectric constant). In the random phase approximation (RPA) the electric susceptibility is given by: (!;q;k\_z) = 1 V\_0(q;k\_z)  $^0$ (!;q). At the points where the susceptibility vanishes, that is, (!\_p(q;k\_z);q;k\_z) = 0, one obtains the plasm on dispersion, !\_p(q;k\_z). From (2), we notice that no plasm on m odes are allowed for D irac ferm ions.

The displacement of the chemical potential from the D irac point generates a pocket around the nodes which drastically changes this picture. The density of states becomes nite at the Ferm isurface with Ferm im om entum  $k_{_{\rm F}}$  , and Fermi energy E  $_{_{\rm F}}$  =  $\,\sim k_{_{\rm F}}\,v_{_{\rm F}}$  , giving rise to intra-band excitations in the cone. In this case we recover the optic plasm on  $!_p(q) = \frac{1}{2} (q=q)^2 + (v_0q)^2$  for the  $k_z = 0$  bulk mode, where  $v_0 = \frac{1}{2} \frac{1}{2}$ and the 2D accoustic mode  $!_p$  (q) / q<sup>2</sup>=q for the rest of =d. The intra-band conthe plasm on band  $0 < k_z$ tribution is satisfactorily understood in the context of doped graphite<sup>14</sup> where for  $v_F q \leq v_F (2k_F)$ q) there is gap in the particle-hole continuum of the inter-band excitations (see g.1) de ned by the imaginary part of (2). The optical plasm on is free of Landau dam ping in the long wavelength lim it and its energy is of the order of E  $_{\rm F}$  . Notice that in the anisotropic case (v  $_{\rm F}$  6 v ) the gap in the plasm on spectrum depends on the direction around the pocket Ferm i surface.




FIG.1: Schem atic drawing of the  $k_z$  = 0 bulk plasm on in an isotropic pocket with Ferm i momentum  $k_F$ . =  $!=\!v_F$  and q is the in-plane transfer momentum. The shaded areas correspond to the particle-hole continuum due to intra-band and inter-band excitations.

If we also add the piezoelectric electron-phonon coupling<sup>8</sup>

due to acoustic phonons (with phonon eld (x)) with energy ~!<sub>q</sub> into the pocket excitations, the RPA electric susceptibility acquires a correction:  $(!;q;k_z) =$

is the phonon propagator that a ects very little the optical bulk plasm on in the  $q! 0 \lim it$ .

Besides doping, coherent inter-layer hopping is known to drive a dimensional crossover in direction to a 3D system, leading as well to a pocket formation in a nodal liquid<sup>19</sup>. The energy of the pocket is of the sam e order of the inter-layer hopping energy, which in TMD NbSe<sub>2</sub> and  $NbS_2$  (we will drop the 2H pre x from now on) were calculated in  $0.1 \text{ eV}^{20}$ . We notice that inter-layer interactions were not taken into account into those band calculations and that this energy could be considerably smaller. More experimental studies are required to investigate the nature of the low energy collective modes in these materials. However, we can consider the plasm on m odes in realm aterials to have a nite energy, like in ordinary m etals. N evertheless, the plasm on frequency will be smaller than in ordinary metals because of the low density of states in the system .

## III. SEM I-CLASSICAL DYNAM ICS

W e consider the problem of D irac ferm ions described by (1) coupled to lattice vibrations described by the H am iltonian

where n labels the lattice site  $R_n^i$ ,  $P_n^i$  is the lattice momentum operator with  $i = x_i y_i z$  (these operators are canonically conjugated, namely,  $[P_n^i; R_m^j] = i \sim_{ij nm}$ ), K<sub>nm</sub> is the coupling matrix. In what follows we will also consider the coupling of the D irac ferm ions and lattice degrees of freedom to a classical electrom agnetic eld described by a vector potential eld, A (r), and electrom agnetic eld tensor, F = @ A @ A (@ = @=@x with ; = 0;i) with electrom agnetic energy density:

where  $F_{0j} = E_j$  is the electric eld strength (we use the metric g; = (1; 1; 1; 1; 1)). In a piezoelectric the electric eld couples to the lattice distortion, X  $_n^i = R_n^i - R_{n+1}^i$ , via the piezoelectric tensor,  $_j^i$ , by:

where repeated indices are to be sum m ed. The coupling between D irac ferm ions and lattice vibrations is given by (3). The full problem can be written in path integral form for the generating functional of the problem :

where L is the Lagrangian (realtime) of the problem (, are G rassm ann variables).

Let us consider ist the case of the normal (nonsuperconducting) state. We are only interested in the long wavelength physics of the electronic problem which, as argued in the previous section, is described by the plasmon mode. The plasmon mode can be separated from the particle-hole continuum using the formalism developed by Bohm and Pines<sup>22</sup> and the Lagrangian of the problem reduces to:

where  $4 = k_c^2$ , with  $k_c$  the 3D electron screening wave vector (for an isotropicm etal  $k_c = \frac{1}{3} \frac{1}{ne^2 = (2E_F)}$  where n is the 3D electron density and  $E_F$  the Ferm ienergy<sup>22</sup>),

is the lattice m ass density,  $v_{\rm ph}$  is the sound velocity,  $j_N^{\,0}=c=_N$  is the density of norm all electrons and  $j_N^{\,i}$  is the norm all 0 hm ic current density (in our notation,  $\varrho^0=c^{-1}\varrho_t$  is the time derivative norm alized by the speed of light c).

The collective properties of the electrons in the norm alphase are the sam e of the electrons in the superconducting phase, since the opening of the superconducting gap does not a ect the real part of the electronic polarization function, (q), in the long wavelength  $\lim it^{23}$ . In fact, within RPA one can easily show in the context of BCS theory that Re (q) remains essentially unchanged until the superconducting gap is of the order of the Ferm i energy, when the BCS pairing approximation becom es invalid<sup>24</sup>. In other words, for small q the plasm on is not sensitive to the superconductor phase transition. Thus, norm aland superconducting electrons screen electric elds exactly in the same way and therefore enter at equal footing in the Lagrangian. Thus, irrespective of the phase, normalor superconducting,  $_{\rm N}$  in (8) can be replaced by the total electron density =  $_{N}$  +  $_{s}$ , where  $_{\rm s}$  is the density of superconducting electrons (  $_{\rm s}$  = 0 in the norm al state). Norm alcurrents, how ever, are due to the quasi-particle excitations while the supercurrents,  $j_s$  , are due to the ground state of the condensate<sup>25</sup>. Thus, in the superconducting state the vector potential only couples to the norm alcurrents. At nite tem perature, T, the num ber of norm aland superconducting electrons is not conserved. For sim plicity, we have chosen to work at T = 0, where all the electrons are in the condensate and the total current is  $j = j_s$ .

In the superconducting phase we can introduce the superconducting order parameter, , via a standard H ubbard-Stratanovich transform ation and trace over the electrons<sup>26</sup>. The generating functional reads:

where  $L_{GL}$  is the G inzburg-Landau Lagrangian. In order to describe the macroscopic current-charge uctuations we must also include a time dependence in the superconductor order param eter. This is not an obvious task but it can be done in two special lim its: close to T = 0, and near the critical temperature $^{27}$ . In the later, the validity of the tim e-dependent G orkov equations expansion in the gap, s, require frequencies higher than the binding energy of the Cooper pairs, ~! s. In this lim it the uctuations have enough energy to break the Cooper pairs and convert them into single particle excitations, leading to a di usive regime. As we mentioned above, we will work in the opposite  $\lim it T = 0$  where the hydrodynam ic description at  $\sim ! < s$  is rigorously valid. W e introduce the low -tem perature tim e-dependent G inzburg-Landau Lagrangian<sup>27,28</sup>,

which is specially suitable for type II superconductors, where the penetration length is much larger than the coherence length (in (10) is the electrostatic potential and all the other symbols are standard<sup>15</sup>). In the clean lim it,  $v_{\rm s}$  is typically of the order of the Ferm i velocity  $v_{\rm F}$ . Under the assumption that the elds vary much slower than the coherence length, we assume that the magnitude of the superconductor order parameter is constant and therefore all the uctuations come from the superconducting phase, ' (t;x). Thus, the order parameter is written as:

D espite the gauge invariance of (10), we conveniently assume the transverse gauge, r A = 0, in what follows. Notice, however, that  $L_N + L_{GL}$  is not complete because the elds and the supercurrents remain decoupled. This problem is solved by assuming the validity of the nonhom ogeneous M axwell equations. The Poisson equation is clearly a constraint between the density of superconducting electrons and the electrostatic potential,

For simplicity we will assume that  $i_j = i_j$  is a diagonal and isotropic tensor. The minimization with respect to the other elds completes the set of equations:

and therefore, in the absence of external currents is either a function of space or of time, but not of both. If

depends on time, then is a stationary time dependent hom ogeneous (or non-periodic) distribution because of (16), what obviously violates the charge conservation. Therefore, we conclude that  $Q_0 = 0$ .

The Lagrange multiplier denest two distinct classes of solutions for the charge density: (i) screening-like when  $(x) \in 0$ , and (ii) plasmon-like when 0. In the rst case, (!;k) / f(k) (!), where f(k) depends on the boundary conditions, has no dynam ics and describes the physical response to a boundary perturbation such as a static squeeze of the crystal or the introduction of a charge probe. In case (ii), the electrons can oscillate freely with the plasm on frequency, allow ing the existence of norm alm odes.

## IV. COLLECTIVE MODES

We consider the problem of a layered solid (such as the TMD) made by an in nite number of weakly interacting planes. In the continuum limit this problem becomes an elective 3D model with spatial anisotropy in the direction perpendicular to the planes, say the z axis. It is convenient to dene the diagonal anisotropy tensor  $i_j = (1;1;)$ , where is the anisotropy parameter, (we introduce the notation  $\mathfrak{E}^i = i_j \mathfrak{E}^j$  and  $A^{\star i} = i_j \mathfrak{A}^j$ ) and rew rite the G inzburg-Landau Lagrangian as a time-dependent Law rence-D on iach model<sup>15</sup>:

The model leads to the anisotropic version of equation (17),

From now on, we use an overhead symbol to represent the in-plane vectors  $\mathbf{x}$ ,  $\mathbf{q}$ ,  $\mathbf{X}$ ,  $\mathbf{\hat{r}}$  and etc. In our notation, we de ne  $\mathbf{q}$  as the in-plane component of the momentum k, such that  $\mathbf{k} = (\mathbf{q}; \mathbf{k}_z)$  and  $\mathbf{\tilde{k}} = (\mathbf{q}; \mathbf{k}_z)$ .

In highly anisotropic layered compounds the absence of piezoelectricity along the z axis is justiled by the weak distortions of the ions in this direction. The z-component of the sound velocity is also very small due to the weak elastic coupling between planes. In the  $v_{ph \ z} = v_{ph}$  ! 0 limit, the phonon dispersion is  $!_{ph} = v_{ph}q$  and the inplane phonon equation (18) has a cylindrical symmetry

The  $k_0^2 > 0$  case leads to exponentially decaying solutions that describe the screening induced by proper boundary conditions like the squeeze or shear of the crystal. If the piezoelectric coupling is larger than a critical value  $(k_0^2 < 0)$ , the screening is suppressed and a quasi-static charge modulation should be observed, in such way to m inim ize the elastic energy. This analysis is con med by introducing an external charge probe Q at the origin: we re-obtain the well known Thom as Ferm i result<sup>13</sup>,

which gives a screened potential for  $k_0^2 > 0$  and recovers the metallic case when the cut-o of the in-plane band dispersion s (of the order of inverse of the in-plane lattice spacing) is taken to in nity.

For a nite cut-o s we have various cases. W hen  $k_0 > s$ , the screening is limited to the direction perpendicular to the planes. W hen  $k_0^2 < 0$  and  $k_0 j < s$ , the system does not show any screening since the potential decays like  $\cos(jk_0 jr)=r$  for large r. The last possible case,  $k_0^2 < 0$  and  $jk_0 j > s$  is not physical in this theory and gives a purely in aginary response. We verify that the phase of the superconducting order parameter is free of uctuations and satis es the zero- eld vortex equation ( $\mathbf{\hat{r}}$ )<sup>2</sup> = 0 in the whole  $\frac{6}{2}$  0 class.

The collective modes follow from a slightly dierent calculation. We start from the plasm on solution of (23),

Equation (28) represents the bulk plasm on mode  $k_z = 0$ , which prevails over the rest of the plasm on band. This is in agreement with a general result valid for a stack

of layers coupled by C oulom b interactions and by coherent hopping terms between adjacent planes. The presence of inter-layer charge transfer induces a dimensional crossover to a 3D system, which dom inates the long wavelength spectrum. Noting that  $v_{\rm s}>v_{\rm ph}$ , because the ions arem uch slower than the electrons, we identify two distinct cases, (1)  $v_0>v_{\rm s}$  and (2)  $v_0< v_{\rm s}$ . The norm alm odes are clearly absent in the regime (1) for any value of g. On the other hand, these m odes are possible in the regime (2) for non zero g. Naturally, they would not be physical for g<  $(v_{\rm ph}^2=v_{\rm s}^2)!_0^2$ , where the interactions are screened.

The clean limit of the superconductor gives exactly  $v_s = v_F = 3$ . In the particular case of an isotropic nodal liquid with a small pocket, the intra-band bulk plasm on disperses with  $v_0 = (3=2)v_F^{-14}$  and therefore it corresponds to the regime (1) mentioned above. This is also the case of the metal ( $v_0 = \frac{1}{3=5}v_F$ ), and of doped graphite ( $v_0 = (3=2)v_F$ ). Therefore, in the particular case of TM D, we should not observe any essential di erences in the plasm on modes in comparison to the LEG (where g = 0) because of the piezoelectricity.

#### A. Experim ental results

There is a large am ount of experim ental literature dealing with the observation of commensurate (CDW) or incommensurate charge order in TMD. Neutron and x-ray diraction measurements in TaSe<sub>2</sub> and NbSe<sub>2</sub> reveal the existence of Bragg peaks at incommensurate wave vectors  $Q_i = (1 \ _i)b_i=3$ , where  $b_i \ (b_ij=4 \ =(\overline{3}a))$  are the three reciprocal vectors with hexagonal symmetry, a is the lattice spacing and  $i \ .0.02$  is the incommensurability<sup>5,9</sup>. This state is called a triple CDW phase.

In TaSe, the phase diagram temperature vs. pressure, P, is very rich<sup>29</sup> with three dierent phases: (1)a high tem perature hexagonal incom m ensurate CDW phase (HCDW) where the three ordering vectors have  $i \in 0$  (i = 1;2;3); (2) an incom m ensurate stripe phase where one ordering vector is incom m ensurate, say  $1 \notin 0$ , but the other two are commensurate, 2:3 = 0; (3) a commensurate CDW phase (CCDW) where i = 0 (i = 1;2;3). The transition from the undistorted phase (norm al) to HCDW occurs at a pressure independent tem per-120K, up to pressures of 4:5 GPa; the ature, T<sub>N H</sub> transition between HCDW to stripe phase  $T_{H}$  s 110K is also roughly pressure independent; the transition between stripe phase and CCDW,  $T_{S-C}$  (P), is highly pressure dependent and vanishes at  $P = P_c$  1:8 G Pa. Thus, there is a quantum phase transition (T = 0), as a function of pressure at  $P = P_c$ . By further application of pressure there is a reentrant CCDW phase that has not been fully studied and will be not discussed here. W e will concentrate on the nature of the quantum critical point (QCP) at  $P = P_c$ .

The nature of the stripe phase has been discussed by M dM illan<sup>30</sup> and others<sup>31</sup> from the phenomenological point of view as a result of the formation of topological defects of the complex CDW order parameter. This stripe phase can be easily observed with electron microscopy<sup>32</sup>. The microscopic nature of this phase is still unknown but our results here suggest that it may have its origins on the piezoelectric coupling in the solid. Indeed, we have found that there is a charge modulation in these materials when  $k_0^2 < 0$  (see eq.(26)). This modulation can be thought as an incommensuration  $_i = 3$   $k_0^2 = p_i$  j. Equivalently, using de nition (35) there is a critical coupling constant  $g_c$  so that an extra charge m odulation appears ( $_{i} > 0$ ) when  $k_0^2 < 0$  or

Recall that  $TaSe_2$  ( $T_c$ 0:1K) and NbSe ( $T_c$ 8:3K) are both superconductors 1 whose  $\mathrm{T}_{\mathrm{c}}$  increase under application of pressure<sup>33</sup> and therefore  $_0 \in 0$  at T = 0. Notice that both the piezoelectric coupling, , as well as the sound velocity,  $v_{ph}$  , are also m onotonically increasing functions of pressure. If we assume that in  $TaSe_2$  we have  $g < g_c$  at T = 0 and am bient pressure, then the quantum phase transition can occur as a function of pressure as long as  $g=v_{ph}^2$  is an increasing function of pressure. In NbSe2, however, the system is always incommensurate indicating that  $g > g_c$  even at am bient pressure. Since the T = 0 phases seem to be directly connected with the stripe phases that are observed at nite tem perature we can immediately conclude that the existence of these stripe phases have to do with the piezoelectric coupling in these materials. Besides, recent experiments report a signi cant electrostatic modulation of T<sub>c</sub> in epitaxial bilayers composed by a HT<sub>c</sub> cuprate and a polarized insulator deposited on it <sup>34</sup>. The connections between TMD and HT<sub>c</sub> are rem arkable and we believe that this experim ental result could be num erically calculated by relaxing the rigidity in the amplitude  $_0$  of the superconductor order parameter. In addition, we suggest that similar electrostatic devices combined with neutron scattering could test experim entally the role of the piezoelectricity in TMD stripe phases.

N eutron scattering m easurem ents have shown the softening of the phonon optical mode  $_1$  in NbSe<sub>2</sub> and TaSe<sub>2</sub> at the  $Q_i$  position for a wide range of temperatures". This behavior was interpreted as a coupling of the opticalphonons with the charge order. Constant-Q scans at Q i have shown that the phonon energy gap in both cases is of the order of 10 m eV<sup>9</sup>. The coupling of the plasm ons with the lattice vibrations in the present theory drives the long wavelength phonons to lock their frequency with the frequency of the  $k_z = 0$  bulk plasm on. In comparison to the metallic case where the plasm on modes are rigid (in the sense that their wavelength has exactly the size of the system), we have found that the increase of the elastic energy due to the piezoelectric coupling may give rise to elastic plasm ons which oscillate in resonance with the optical phonon mode. Despite not observable in TMD, we believe that this e ect would be the macroscopic manifestation of the plasm on-phonon resonance observed experim entally in these materials.

## V. CONCLUSIONS

We have investigated the collective excitations of the electrons in a layered superconductor by a sem i-classical calculation in the continuum lim it of a highly anisotropic material. This procedure is analogous to the Law rence-Doniach e ective model for an in nite stack of layers. D espite the evident interest in TMD, the calculation is su ciently general and be could be applied to any superconducting layered compound at zero temperature with broken lattice inversion symmetry.

W e have dem onstrated from the electrodynam ic point of view that superconductivity and piezoelectricity can coexist. M etallic screening is observed when the e ective piezoelectric coupling g is smaller than a critical value gc, with the Thomas-Fermi m om entum reduced by the increase of g. Above the critical coupling, the system is not screened and a long-range charge modulation is expected to appear as the response to a local quasi-static charge unbalance, which can be created by squeezing the crystal. We have shown that piezoelectricity is possibly related to the mechanism behind the stripe form ation in TMD.Besides, we have investigated the existence of zero tem perature norm alm odes arising in the presence of low energy bulk plasmons, which dom inate the spectrum of collective excitations. We have also conjectured that the  $k_z = 0$  plasm on mode behind these excitations comes from the contribution of the intra-band excitations of a pocket opened around the nodes of TMD by low energy coherent hopping term s between adjacent planes. These pockets could be also generated by doping TMD with intercalating m aterials.
