Di usion Limited Aggregation with Power-Law Pinning

U sing stochastic conform alm apping techniques we study the patterns emerging from Laplacian grow th with a power-law decaying threshold for grow th R_N (where R_N is the radius of the N particle cluster). For > 1 the grow th pattern is in the same universality class as di usion limited aggregation (D LA) grow th, while for < 1 the resulting patterns have a lower fractal dimension D () than a D LA cluster due to the enhancement of grow th at the hot tips of the developing pattern. Our results indicate that a pinning transition occurs at = 1=2, signi cantly sm aller than m ight be expected from the lower bound $_{m in}$ ' 0:67 of multifractal spectrum of D LA. This limiting case shows that the most singular tips in the pruned cluster now correspond to those expected for a purely one-dimensional line. U sing multifractal analysis, analytic expressions are established for D () both close to the breakdown of D LA universality class, i.e., 1, and close to the pinning transition, i.e., & 1=2.

I. IN TRODUCTION

Nonequilibrium growth models leading naturally to self-organized fractal structures, such as di usion limited aggregation (DLA) [1], are of continuing interest due to their relevance form any important physical processes including dielectric breakdown [2], electrochem ical deposition [3, 4], and Laplacian ow [5].

A pow erfulm ethod, nam ely iterated stochastic conform alm apping [6, 7], has been already successfully applied to generate and analyze DLA [8, 9] and Laplacian [10] grow th patterns in two dim ensions. This has provided an alternative way to address m any of the important open questions related to pattern form ation in DLA in two dim ensions, one of these being the existence of m inim al

elds for grow that the boundary of the grow ing cluster. In previous work [11] we studied the properties induced by a xed, material dependent critical eld E_c for grow th, and showed that in the presence of such a threshold all clusters ultimately become printed and, in addition, this sim ple constraint has remarkable consequences for the resulting patterns { the rich, branched structure of DLA is replaced by a much lower dimensional shape consisting of a few surviving branches.

In this paper we address a similar, but signi cantly more important question because of its relationship to the multifractal spectrum of DLA, that of what happens when there exists a critical eld for grow th on the boundary of the cluster, eld decaying like R_N as the cluster increases in size. We shall call this model the \backslash -m odel".

As we will show below, as decreases from > 1 toward a critical value = 1=2 (which corresponds to the most singular possible behavior for the Laplacian eld, that occuring at the tip of a line), there is a continuous transition from DLA toward lowerdim ensional shapes for which the multifractal spectrum is necessarily di erent from that of DLA. We study this transition in terms of the fractal dimension D () of the emerging patterns, and we derive analytic expressions for the behavior of D () in the range . 1 where the DLA universality class breaks down and & 1=2 close to the pinning transition.

II. M ODEL AND THEORETICAL BACKGROUND

W itten and Sander [1] have shown that the growth probability at any points on the boundary of a DLA cluster of length L is given by the harmonic measure $P(s) = j(r V)(s) \neq \begin{bmatrix} R_L \\ 0 \end{bmatrix} ds^0 j(r V)(s^0) j$ where V (r) obeys Laplace's equation $r^2 V = 0$ subject to the boundary conditions V = 0 on the (evolving) boundary of the cluster and V ln r as r! 1 (corresponding to a uniform ux of particles far away from the cluster).

Them odelwe study is a variant of the two-dimensional DLA growth model described above in which growth is disallowed at points on the cluster boundary where the probability for growth is smaller than a critical value $R_{\rm N}$, where $R_{\rm N}$ (the exact meaning will be dened later) is the radius of the N particle cluster, i.e.,

where (s^0) is the multifractal exponent at point s^0 on the cluster boundary, L is the length of the boundary, and the step function $((s^0))$ ensures that only those regions of the cluster boundary obeying $jr V(s^0) j > R_N$ contribute to the normalization integral. Estimates of this integral will be very in portant in our analysis of the fractal dimension of the growing $\$ -cluster". Since we need to calculate the harm onic measure on a freely evolving interface, this is handled by using conform all mapping techniques [6, 8]. The method was presented in great detail in Refs. [6, 8], and thus here we will just brie y review the main results.

The basic idea is to follow the evolution of the conform alm apping $z = {}^{(n)}$ (!) of the exterior of the unit circle in a mathematical! {plane onto the complement of the cluster of n particles in the physical z {plane rather than directly the evolution of the cluster's boundary. The initial condition is chosen to be ${}^{(0)}$ (!) = !. The process of adding a new \particle" of constant shape and linear scale ${}^{-0}$ to the cluster of (n 1) \particles" at a position s which is chosen random ly according to the harm onic measure is described via a function ; (!), where

which conform ally maps the unit circle to the unit circle with a bump of linear size bocalized at the angular position [6]. The shape of the bump depends on the parameter a. Following the analysis in [8], we have used a = 0.66 througout this paper, as we believe the large scale asymptotic properties will not be a ected by the microscopic shape of the added bump.

The conform alm ap for an n-particle cluster $^{(n)}(!)$ can be built by adding one \particle" to an $(n \ 1)$ -particle cluster $^{(n \ 1)}(!)$, resulting in the recursive dynam ics

which can be solved in terms of iterations of the elementary bum $p m a p_{n;n}$ (!),

In Eqs.3 and 4 the angle $_n$ 2 (0;2] at step n is random ly chosen since the harmonic measure on the real cluster translates to a uniform measure on the unit circle in the mathematical plane,

is chosen in order to ensure that the size of the bump in the physical z plane is 0. Since 0 is a natural length scale in the problem, in can be scaled out by measuring all the lengths in terms of it. We re-emphasize here that although the composition Eq.4 appears at rst sight to be a standard iteration of stochastic maps, this is not so because the order of iterations is inverted { the last point of the trajectory is the inner argument in this iteration. As a result the transition from $\binom{n \ 1}{(!)}$ to $\binom{(n)}{(!)}$ is achieved by composing the n form erm aps Eq.4 starting from a di erent seed. Finally, identifying [8] the radius R_n of the growing pattern with the coe cient $F_1^{(m)} = \frac{n}{(m)} (1 + \frac{1}{(m)})^n$ in the Laurent expansion of $\binom{(n)}{(m)}$,

the constraint to grow only at values of which obey Eq.1 translates into

This constraint is in plemented as follows. At step n, $_n$ is choosen from a uniform distribution in (0;2], independent of previous history. If it obeys the constraint given by Eq.8 accept this value of $_n$, otherwise repeat until the constraint is obeyed.

III. RESULTS AND DISCUSSION

For the model de ned in Sec. II one would expect the resultant patterns to have fractal shapes which depend on , and in order to characterize these shapes we will focus on the scaling behavior of the rst Laurent coe cient $F_1^{(n)}$. Following the arguments in Ref. [8], for a given value one expects a scaling law of the form

where D () is the e ective fractal dimension of the resulting cluster.

We have simulated the model de ned in Sec. II for a number of values in the range 1=2 1.2 and we have calculated $F_1^{(n)}$ as an average over 100 clusters (for > 0.65), and, respectively, over 20 clusters (for




FIG.1: Typical clusters (size N = 40000) grown with (a) = 1.20, (b) = 0.75, and (c) = 0.55, respectively.

0:65) of size N = 40000. In Fig. 1 we show typical clusters of size N = 40000 for = 1.20, 0:75 and 0.55, respectively. It can be easily seen that the rich, branched structure of the cluster at = 1.20 changes, as decreases toward = 0:55, into a much lower-dimensional shape with only a few branches surviving. This can be intuitively understood by considering the e ect the pinning probability R_n has on the multifractal spectrum of the cluster. From multifractal scaling [12, 13, 14] we know that the interface of a fully developed D LA cluster consists of sets of N_{D LA} () R_n^{f_D LA} () sites with grow-ing probabilities jr V j R_n, and we will assume that

such a structure is also valid for the clusters grown with pinning probability R_n . As grow th proceeds, the lowest probability sites (large), norm ally deep in the fjords, will be pinned rst, with the hot tips surviving longest, leading to \pruning" of the branches where the tips have a singularity > .




FIG.2: (a) $F_1^{(n)}$ as a function of n for clusters grown with = 1.20;0:75;0:65; and 0:55, respectively (log-log plot). A lso shown (dashed lines) are the limit cases of a DLA cluster, $F_1^{(n)} = n^{1=D_{\rm DLA}}$, where $D_{\rm DLA} = 1:71$, and of a line cluster, $F_1^{(n)} = n$, respectively. (b) The elective fractal dimension D () obtained from $F_1^{(n)} = n^{1=D_{\rm C}(1)}$ as a function of (circles). The dotted line is just a guide to the eye. The solid line is the theoretical prediction (Eq.12) with f () = $f_{\rm DLA}$ () from Ref. [15].

A santicipated, for all the values 0.5 1.2 that we have tested the coe cient $F_1^{(n)}$ has a clear power-law dependence on the size n, as shown in Fig.2 (a). A ssum ing the exponent 1=D () to be related to a fractal dim ension as given by Eq.9, the dependency D () (shown in Fig.2 (b)) is obtained from a power-law to the data. It

can be seen that at values of & 1 the behavior is close to that of a DLA cluster, i.e., D (> 1) ! D_{DLA} ' 1:71, while for 1=2 the behavior of the radius $F_1^{(n)}$ tends to n, i.e., D (! 1=2) ! 1, thus the behavior of a growing line.

In order to understand these results theoretically let us begin with a very simple argument based on the assum ption that the clusters have a multifractal spectrum in the sense described above, in that the interface consists of sets of N () R_n^f⁽⁾ sites with growth probabilities jr V j R_n. Since the constraint will cut-o grow that regions in the cluster with exponents in the range > of the multifractal spectrum, we can write down the following equation for the rate of growth of the cluster in the presence of the barrier in terms of the rate of grow th of a DLA (no barrier for growth) cluster

where f ($_{m \text{ in}}$) = 0. The enhancem ent of grow th com es from Eq.1 together with the estimate

Now, we know that the harm onic measure is concentrated at = 1, and thus for > 1 the integral is dom inated by the value of the integrand at = 1, while for .1 it is dom inated by the value at , and thus

where K () is some constant independent of N . Eq.11 therefore im plies

For the case where .1, i.e., close to the breakdown in the DLA universality class, we may assume that the multifractal spectrum of the cluster is only weakly perturbed from its value in DLA and therefore f () f_{DLA} (), or

This prediction m ay be tested using the recently com – puted $f_{D LA}$ () spectrum [15]. The results are shown in Fig. 2(b) (solid line), and it can be seen that for '1 the theoretical predictions are indeed close to the m easured values D (). The discrepancies at sm aller values of can be attributed to the fact that the multifiactal spectrum of the cluster is not exactly the one of DLA, and when ! 1=2, as we will now discuss, it actually m ay be expected to deviate signi cantly from that of a DLA.




FIG.3: (a) A verage number of attempts for growing clusters of sizes N = 20000 (dashed line) and N = 40000 (solid line), scaled by the actual size of the cluster, respectively, as function of (b) The multifractal spectrum f() from Eq.15 (symbols) in comparison with the multifractal spectrum of DLA (solid line) from Ref. [15].

For & 1=2, the change in the multifiactal spectrum from that forD LA is signi cant. For example, it is known [15,16] that for the D LA spectrum $_{\rm m \ in}$ ' 0:67, while we see that grow th continues signi cantly below this value, with $_{\rm m \ in}$ = 1=2 being the asymptotic lim it. Our simulations show strong evidence for this lim it, as can be seen in Fig. 3(a): the average number of attempts for growing clusters of sizes N = 20000 and N = 40000 (scaled by the actual size of the cluster) exibits a steep increase as ! 0:5.

We shall assume that for these highly pruned \setminus clusters" there is a well de ned limiting form for the multifractal spectrum, f (), de ned for 1=2 < <and obeying f (1=2) = 0, which is a monotonically increasing function of . De ningf() = f (), we can use a reasoning similar to that used by Turkevich and Sher [16] in their estimate of the fractal dimension of

DLA to estimate f(). The idea is that for ~&~1=2 only the \hottest" tips contribute to grow th, and thus one can write

where the last relation follows from the fact that the integral is dom inated by the value of the integrand at $\,$. Thus, we obtain

Since from simulations we know the values D (), Eq.15 (which is valid for & 0.5) allows the calculation of the upper multifractal exponent f(). As shown in Fig. 3(b), the pinning threshold R leads to a shifting of the multifractal spectrum for < to the left, i.e., f () > $f_{D LA}$ () (m ore hot tips, and larger elds at those hot tips, due to pruning).

These results can be intuitively understood as a ow of singularities away from (which acts as an unstable xed

point of the dynam ics). For any particular value __0 < , what happens while the cluster evolves is that screening is reduced compared to DLA and therefore there is a ow of singularities __0 ! __1 with __1 < __0. In addition, new singularities with < $\frac{(D \ LA)}{m \ in}$, can be created. Thus, we would expect that the number of singularities N (__1) N_D \ LA} (_0) or

On the other hand for $_0$ > the singularity ow $_0$! $_1$ can only act toward an increase $_1$ $_0$ since such points can never grow and thus can only either keep their original singularity or get a higher value of during grow th.

IV. CONCLUSIONS

U sing the stochastic conform al mapping techniques we have studied the patterns emerging from Laplacian grow th with a power-law decaying threshold for grow th $R_{\rm N}$, $1{=}2.\,W$ e have shown that due to the enhancement of grow th at the hot tips as decreases the grow th evolves from patterns in the DLA universality class for

> 1 to clusters with a lower fractaldim ension D () for
 < 1 due to the enhancem ent of grow th at the hot tips.
 W e have presented evidence that = 1=2, corresponding to the singularities at the tip of a purely one-dim ensional

(line) grow th pattern, is the lower lim it for grow th, with all clusters becoming ultimately pinned for < 1=2. By using multifractal analysis, we have proposed analytic expressions for D () for both . 1 near the breakdown of the DLA universality class and near the pinning transition & 1=2. Finally, we have shown that in the small

range the multificatal spectrum of the resulting cluster is signic cantly changed from that of a DLA. We have suggested that this change may be due to a ow of singularities with acting as an unstable xed point of the dynamics, but further work will be necessary to fully elucidate this point.
