D ispersion of M agnetic Excitations in Superconducting Optim ally D oped $Y B a_2 C u_3 O_{6:95}$

Detailed neutron scattering measurements of YB a₂C u₃O $_{6:95}$ found that the resonance peak and incommensurate magnetic scattering induced by superconductivity represent the same physical phenomenon: two dispersive branches that converge near 41 meV and the in-plane wave-vector $q_{af} = ($ /a, /a) to form the resonance peak. One branch has a circular symmetry around q_{af} and quadratic downward dispersion from 41 meV to the spin gap of 33 lmeV. The other, of lower intensity, disperses from 41 meV to at least 55 meV. Our results exclude a quartet of vertical incommensurate rods in q-! space expected from spin waves produced by dynamical charge stripes as an origin of the observed incommensurate scattering in optimally-doped YBCO.

The magnetic resonance peak observed by inelastic neutron scattering (INS) is one of the most striking features of high-T_c superconductors [1-7]. It corresponds to an unusual enhancement of spin uctuations in the SC state at the planar antiferrom agnetic (AF) wave vector $q_{af} = (/a, /a)$ at an energy E_r , which is found experimentally to scale with T_c as a function of hole doping. First discovered in optimally doped YBa₂Cu₃O_{6+x} [1], its observation has then been extended to other systems such as T½Ba₂CuO_{6+x} [5] and B½Sr₂CaCu₂O_{8+x} [6]. The role of the magnetic resonance in measured changes of the ferm ionic properties of cuprates below T_c is hotly debated [8, 9, 10].

In underdoped YBa₂Cu₃O_{6+x} (x=0.6 [11], x=0.7 [12, 13], x=0.85 [14]), INS measurements revealed additional incommensurate (IC) spin uctuations at energies below E_r at low temperature. They may appear as reminiscent [11] of a quartet of peaks at planar wave vectors $q_{ab}=(/a(1),/a)$ and (/a,/a(1)) observed in both the SC and normal state of $La_2 \times Sr_xCuO_4$ [15]. These are sometimes interpreted as spin waves originating from stripe uctuations (uctuating hole poor AF domains in anti-phase separated by uctuating lines of holes running along a* or b* [16]). However in weakly underdoped YBa₂Cu₃O_{6.85} [14], both energy and temperature

dependencies of the incommensurability indicate that IC uctuations and the magnetic resonance peak are part of a downward dispersing magnetic collective mode that exists in the SC state only. Presently, the origin of the IC magnetic uctuations, their interplay with the magnetic resonance peak and their evolution with hole doping are still controversial issues.

The current study of YB a_2 C u_3 O $_{6:95}$ focuses on the search for magnetic signatures of dynamical stripes and on the dispersion of the magnetic excitations at optimum doping. Throughout this article the wavevector Q (H,K,L) is indexed in reciprocal lattice units (2 = a_1 2 = b_1 2 = c).

All INS experiments were performed on the 1T double focusing triple-axis spectrometer at the ORPHEE reactor. The 1.5 cm 3 sample with mosaic spread of 2.2 was made up of 3 coaligned high quality twinned single crystals of YBa2Cu3O $_{6+\, \times}$ (T $_{c}=93$ K). Lattice constants precisely measured by high resolution neutron diraction were: a= 3.816 A, b= 3.886 A, c= 11.682 A. By comparison with Ref. [17], the unit cell volume as well as the a-b anisotropy indicate x= 1, the c-axis lattice constant gives x= 0.92, while the T $_{c}$ is consistent with x= 0.95. A dierent very precise study of oxygen content vs. lattice parameters in single crystals produced higher oxygen contents for the same c-axis lattice parameters [18], so we




FIG. 1: a) 10K intensity m inus 100K intensity at 35 meV (same data as in gure 2c) b) Model calculations (represented in gure 2c by blue lines) The apparent lack of symmetry around $q_{\rm af}$ after convoluting with the resolution function is a focusing e ect illustrated in gure 3b, which is a clear signature of dispersion.c) Predictions of the stripe model. The small dierences in intensities of the four spots are due to the magnetic form factor. Magnetic correlation length used in the calculations was the same as in (b) and (c) (see text).

conclude that our sample had x=0.95 0.02. The c-axis was aligned close to vertical in order to access the entire B rillouin zone adjacent to Q = (3/2,1/2, 1.7). Relaxed vertical resolution in this orientation maximizes magnetic intensity, which is broad in the c-direction. The tilt of the sample changed during the scans to achieve the desired com ponent of a perpendicular to the ab-plane (qc). Iter m in im ized contam ination from higher order neutrons. PG 002 m onochrom ator and analyzer xed at the nalenergy of 14.8 meV was chosen for the study at 35m eV (Figs. 1a and 2c). For the scans between 35 and 55 m eV (Fig. 2a) we used a Cull1 m onochrom ator and PG 002 analyzer xed at 30.5 m eV.W e also found an experim ental condition that dram atically im proved spectrom eter resolution over all previous m easurem ents (energy resolution of 22 meV FW HM; the longitudinal and transverse q-resolution of 0.11 A 1 and 0.2 A 1 respectively) and allowed looking at the resonance peak in a "magnifying glass". (Fig. 2b) Here we used a Cu220 m onochrom ator and a PG 002 analyzer xed at 152 m eV. At energies far above the resonance peak only a limited part of q-space was measured because the kinematics of the neutron allow access to only a small part of the Brillouin zone. Using an unpolarized neutron beam, we relied on the standard technique of using tem perature dependence to distinguish magnetic

and nuclear scattering [3, 4].

Constant energy scans taken at E=41m eV and T=100K showed only a at background in agreement with previous results for this composition [3, 4]. However, rather strong features with q-dependence expected from magnetic scattering persisted to 100K at E=44m eV and above. Further heating to 300K did not make them disappear entirely. Therefore, their magnetic origin needs to be con med by further measurements. In the following, our analysis is based on intensity dierences between 10K and 100K, which are condently assigned to magnetic scattering.




FIG. 2: a-d) Intensity at 10K m inus intensity at 100K (data points) compared with the model illustrated in Fig. 3 convoluted with the resolution function. B lue/red lines represent the model with/without the broadening described in the text. The energy resolution was a -5m eV, b,d -22 m eV, and c -4m eV. A small linear term was subtracted from the scans in c to make the background the same on both sides. O verall amplitude diers for a, b and d, and c, but is the same for each set of calculated curves. The diagram s below a, b, and c represent the scan directions projected onto the h-k plane for the plots above. e) Scattering intensity at (Q,!)= ((1.4 0.4 1.7), 35m eV), ((1.5 0.5 1.7), 40.5m eV), and ((1.6 0.6 1.7), 47m eV) vs. tem perature. C onstant intensity was subtracted from 35 m eV and 47 m eV data to scale together the 10-100K intensities. f) H igh resolution scans at 35 m eV measured with Cull1/PG 002 monochrom ator/analyser and E f = 13.4m eV at 100K and 10K.g) Intensity at 10K minus intensity at 100K (data points) compared with the odd bilayer magnetic structure factor (blue line).

In order to search for evidence of dynamical stripes in optimally-doped YBCO we mapped in Q -space the scattering intensity at 35 m eV, which is just above the measured spin gap of 33 0.5m eV (data not shown in gures) and well below Er (41m eV). High resolution scans at 10K and 100K shown in gure 2f clearly show the extra IC magnetic scattering appearing at 10K on top of a broad feature originating from phonons. The contour plot of the intensity di erence between 10K and 100K at 35 meV (Fig. 1a) measured with lower resolution also clearly shows IC magnetic signal. However, the data show strong asymmetry around q_{af}, a high sym m etry point of the nearly tetragonalYBCO reciprocallattice. This apparent anomaly can be easily explained by the tilt of the resolution ellipsoid in q-! space that breaks the symmetry in the experiment and results in wellunderstood focusing/defocusing e ects. In fact a spectral function S(q,!) that is dispersive and circularly symmetric around qaf results in an intensity distribution that closely matches the data (Figs. 1b, 2c). On the other hand, the spin wave model for the stripe picture that gives a good description of the magnetic response of stripes in the nickelates [20] should produce a quartet of peaks as calculated in [19]. After convolution with the calculated spectrom eter resolution the model prediction di ers from the data far beyond the experim ental uncertainty even if a nite correlation length of the stripes is assumed (Fig. 1c). So we can rule out the "spin waves due to stripes" model, though the excitation spectrum of the stripe phase of La_{1:875}Ba_{0:125}CuO₄ [19] is not consistent with such a modeleither.

Further m easurem ents (Fig. 2a) revealed that the magnetic signal at 35 m eV arises from a branch

that disperses to lower energies from $E_{\rm r}$ and cuts o at the spin gap. We also found another branch that disperses upward above $E_{\rm r}$ persisting above 55 meV. This upper branch has not been previously observed because its peak intensity at energies where it is well separated from the lower branch is much smaller than at $E_{\rm r}$. The raw data at 47m eV and 10K (not shown in gures) were consistent with circular symmetry and not

with four IC peaks, though they do not rule out a more complex q-space lineshape. Figure 2e shows temperature dependence at three energies with q xed at the maximum of the intensity change between 10K and 100K at each energy. The intensities at 40.5 and 47 meV increase and then saturate with decreasing temperature below T_c. At 35meV the intensity peaks at 70K as observed in YBa₂Cu₃O_{6:85} [14] hinting at a nontrivial temper-




FIG. 3: A model for S(q,!) in good agreement with most of the data (Fig. 2): a) q-integrated density of states derived from the model. b) Schematic of resolution e ects in the a-b plane. The oval represents the a-b plane projection of the resolution ellipsoid, and the circles represent cuts of S(q,!) at ! = 40.5 and 35 meV. The entire S(q,!) ts into the resolution ellipsoid near 41 m eV, which results in enhanced scattering intensity at the resonance peak energy. c) Solid lines represent the q-! dispersion relation. The color plot represents this model convoluted with experimental resolution. Red lines show the resolution ellipsoid. Its tilt is responsible for better peak de nition on the left/right side for the upper/lower branch respectively. The dashed line corresponds to a di erent dispersion relation that also ts the data.

ature dependence, which needs to be investigated further. A long L the upper branch has a broad maximum at L=1.7, thus it is odd in the bilayer as is the resonance peak (Fig. 2g).

We then utilized the high resolution condition to focus on the dispersion of the two branches where they converge to 41 meV and $q_{\rm af}$. The constant q scan through $q_{\rm af}$ (Fig. 2d) shows the well-known resonance peak at 41meV, but the scattering has considerable broadening in q-space at energies away from 41meV (Fig. 2b). However the q-integrated S(q,!), S(!), is roughly the same at all energies in Fig. 2b because of the broadening of S(q,!) along both H and K.

To get a more quantitative estimate of S (!) we

m odelled the data (Fig. 2) with the following dispersions (solid lines in Fig. 3c):

For
$$33m \text{ eV} < ! < !_1: ! = -ajq q_{af} \mathring{f} + !_0;$$

For $! > !_2: ! = bjq q_{af} \mathring{f} + !_0;$

where $!_0=41\,2\text{m eV}$, $a=191\,\text{m eV}\,\text{A}^2$, $b=75\,\text{m eV}\,\text{A}^2$ (Values of b up to 100 give a good t as well). The low-energy cuto at 33m eV represents the experimentally determined spin gap. An innitely sharp (function of the above dispersions) S (q,!) gives a reasonably good agreement with the data (red lines in Fig. 2) in the lower branch, but is too narrow for the upper one. In order to better the data, isotropic Lorenzian broadening in q and ! was applied to include a nite correlation length of 55A and an energy width of $2\,2\text{m eV}$ FW HM (blue lines in Fig. 2). The ratio of the amplitudes of the upper and lower branch is found to be 0.65 to best agree with the data.

Experim ental uncertainty allows slightly dierent values of ! $_{0}$, a, and b. There also m ay be a gap of less than 1m eV between the branches or one or both branches m ay not "close" at q_{af} (dashed line in Fig. 3c).

Fitting the scattering intensity at di erent energy transfers with the same amplitude places stringent constraints on the dispersion relation exponent. Higher powers than 2 would atten the dispersion manifold near $!_0$ and strongly enhance the predicted scattering intensity there whereas powers lower than 2 would suppress it relative to the expectations of quadratic dispersion. Neither such enhancem ent or suppression is observed experimentally, which means that the quadratic terms dominate the dispersion relation. This also implies at S(!) in each branch (Fig. 3a). The im portant caveat is that the dierences between the data and the model at 51 and 55 meV hint at a more complex behavior there. Convergence of S(q,!) to q_{af} at E_r (Fig. 3b) can account for all intensity in the resonance peak (Refs. [1, 3]) as dem onstrated by the excellent agreem ent between the model and the data in gure 2d.

Som ewhat sim ilar q-! dispersions, though with a dierent temperature dependence, was reported for YBa₂Cu₃O_{6:7} [13] and more recently for the stripe phase of La_{1:875}Ba_{0:125}CuO₄ [19].

A number of theories predict or assume dispersive magnetic branches in copper oxide superconductors. A 2D metalwith strong antiferromagnetic

correlations in the d-wave SC state is characterized by dispersive magnetic collective modes [21]. The phenom enological spin-ferm ion model assum es an upward-dispersing branch sim ilar to the observed one though it does not predict the downwarddispersing one [23]. A recent calculation based on the t-t'-J m odel yielded results som ew hat sim ilar to ours [22]. An RPA calculation based on the Ferm i liquid scenario predicts an incom m ensuratecom m ensurate-incom m ensurate evolution of the m agnetic signal with energy [24, 25]. A more quantitative comparison is required to understand the relevance of these models. Most importantly, many theories have to be reevaluated in light of the nding that most spectral weight of magnetic excitations appears at energies above and below the resonance peak even at optim um doping.
