# V ibrations of free and embedded an isotropic elastic spheres: Application to low-frequency R am an scattering of silicon nanoparticles in silica

V ibrational mode frequencies and damping are calculated for an elastic sphere embedded in an in nite, hom ogeneous, isotropic elastic medium. A nisotropic elasticity of the sphere signi cantly shifts the frequencies in comparison to simplied calculations that assume isotropy. New low frequency R am an light scattering data are presented for silicon spheres grown in a SiD<sub>2</sub> glass matrix. Principal features of the R am an spectrum are not correctly described by a simple model of the nanoparticle as a free, isotropic sphere, but require both matrix e ects and the anisotropy of the silicon to be taken into account. Libration, not vibration, is the dom inant mechanism.

The classical continuum mechanical problem of the vibrational frequencies of a hom ogeneous, isotropic, free sphere was solved exactly long ago in terms of roots of spherical Bessel functions<sup>1</sup>. It nds application in seism ology<sup>2</sup>, foam spheres<sup>3</sup> and even kidney stones<sup>4</sup>. Progress has also been made on generalizations of this problem. Closed form solutions are obtainable for special cases of inhom ogeneity with certain special kinds of anisotropy<sup>5</sup>, and isotropy with radial inhom ogeneity<sup>6</sup>. Generalized anisotropy can be handled for a sphere and other shapes with a basis function expansion<sup>7</sup>.

A pplication of the Lam b solution to m etal or sem iconductor spheres a few nanom eters in size has been successful in explaining vibrational frequencies observable using low frequency R am an light scattering<sup>8</sup> and other m ethods<sup>9</sup>. These "nanoparticles" are not truly free, but are embedded inside a glass m atrix and frequently are nearly spherical. The Lam b solution is useful because of the sharp change of acoustic in pedance z = c at the nanoparticle-glass boundary as long as the nanoparticle is m uch heavier or m uch harder than the glass. The applicability of this is challenged in the case of silicon nanoparticles grown in SiO<sub>2</sub> glass, where the densities are alm ost the same and the speed of sound in silicon is only 1.5 tim es faster than in glass. A lso, silicon is far from isotropic with Zener anisotropy factor 1.6.

The nanoparticle's vibrational frequencies become complex valued due to damping of the modes as energy is mechanically radiated away from the nanoparticle into the surrounding glass matrix<sup>10</sup>. The e ect of coupling the nanoparticle to the matrix is to shift the frequencies of the modes and dampen them<sup>11</sup>. Some qualitatively new vibrational modes appear even in the limit of weak coupling<sup>12</sup>. The solution to the elastic mechanical problem of an elastically anisotropic sphere embedded in an in nite elastic continuum has not been presented before. Here we employ both a closed form solution for the case of

isotropic elasticity as well as molecular dynamics (MD) simulations for the case of a cubic crystal with elastic constants  $C_{11}$ ,  $C_{12}$  and  $C_{44}$ . The agreement of these two methods for the exactly solved free sphere case allow us to be condent in the correctness of our solution. Two di erent computer program swere written for the embedded isotropic sphere calculation. These cross checks are essential to avoid errors that have occurred elsewhere in the literature of this subject.

#### II. THEORY

The displacement eld u(x;t) of an elastic medium of density (x) is governed by Navier's equation: (1).

where  $c_{ijkl}(r)$  is the 4th rank elastic tensor eld with 21 independent components. In a hom ogeneous, isotropic medium, Eq.1 takes the form of Eq.2 where and are Lam e's constants.

To elucidate the key features and physical basis of the motion, the vibrations of the nanoparticle are calculated here using three methods: (A) analytic solution of a free isotropic sphere reprising reference<sup>1</sup>; (B) analytic solution of an isotropic sphere embedded in an in nite matrix; (C) MD computer simulation of a free sphere including anisotropy. Method (B) has previously been used only for some spheroidal modes<sup>9,13</sup> or limiting cases<sup>10</sup>. Method (C) is reported for the rst time.

The following comments apply to methods (A) and (B) which are able to exploit spherical symmetry. The time dependence of the displacement is taken as u(r;t) = $u(r)e^{i!t}$ ; where ! can be complex. The angular frequency ! (in rad/s) is related to wavenumber (in cm<sup>1</sup>) through = !=(200 c), where c is the speed of light (in m/s). In what follows, all of the results are reported in term s of R e() (energy) and Im () (dam ping).

To solve Eq.2, a scalar and a vector potential are introduced which correspond to dilatational and equivolum inalm otions respectively. Eq.2 separates into scalar and vector parts. D etailed expressions for the displacement u and the stress tensor <sup>\$</sup> can be found in<sup>14</sup>. In a previous work<sup>6</sup>, we expressed u and <sup>\$</sup> r in a more convenient basis. Next, boundary conditions corresponding to the system have to be applied and result in secular equations whose com plex valued roots gives the frequencies of the eigenmodes of vibration. W ithin the nanoparticle, the scalar and vector potentials involve the spherical Bessel function of the rst kind j<sub>1</sub>.

Form ethod (A) there is no external force on the sphere so that r=0 at every point on the surface. Form ethod (B), the continuity of u and r is in posed at the surface of the nanoparticle where it contacts the m atrix.

If the glassm atrix is a free sphere of radius  $R_{\rm m}$  concentric around the nanoparticle of radius  $R_{\rm p}$ , norm alm ode frequencies can be found<sup>6</sup>. But what happens is that every eigenfrequency vanishes as  $R_{\rm m}^{-1}$  as  $R_{\rm m}$  ! 1. In other words, for a macroscopic glass matrix there is a continuum of states but no discrete modes.

The approach of method (B) is to look for damped modes of vibration of the nanoparticle where ! is now a complex number such that Re(!) is the frequency of the vibration and Im (!) is the damping. In the glass matrix, the spherical H ankel function of the second kind,  $h_1^{(2)}$  (kr), is used because it corresponds to an outward travelling wave. The wavevector k is also complex.

E quations for the embedded sphere case ofm ethod (B) have already been written by Dubrovskiy et al.<sup>10</sup>. In order to nd the roots of the secular equation, Dubrovskiy et al. m ade approximations which depend on the relative values of the parameters in the sphere and around it. We made no approximations and found the complex roots num erically<sup>22</sup>. Frequencies and damping in<sup>13</sup> were reproduced with this method.

Method (C) is a molecular dynamics calculation $^{15}$ . W hile this approach can readily be extended to the more general case of an object of arbitrary shape with inhom ogeneous an isotropic elasticity, we choose for brevity only to present the case of a spherical object with cubic crystalline elasticity. A simple cubic a a lattice of N identical point particles of mass a<sup>3</sup> interacting through "springs" has particle positions r<sub>j</sub> integrated in time and Fourier transform ed in order to obtain m ode frequencies. Each particle has six rst neighbors and twelve second neighbors. Every pair (i; j) of rst neighbors are coupled by potential energy  $\frac{1}{2}k_{sp1} (kr_i r_j k a)^2$ , while second neighbor pairs (i; j) are coupled by  $\frac{1}{2}k_{sp2}$  (kr<sub>i</sub> r<sub>j</sub>k  $p \overline{2}a)^2$ . Cubic octets are coupled by  $(k_{8pt}=4a^2)$  (D  $6a^2)^2$ where D =  $\sum_{j=1}^{8} k \tilde{R}_{cm}$   $r_j k^2$  and  $\tilde{R}_{cm} = \frac{1}{8} \sum_{j=1}^{8} r_j$ . The bulk modulus is B =  $(C_{11} + 2C_{12})=3$ . A small isotropic dilatation = dV=V stretches all neighbor distances proportionally and leads to stored energy  $\frac{1}{2}$  V B  $^2$  ,

so that we obtain a  $(C_{11} + 2C_{12}) = k_{sp1} + 4k_{sp2} + 24k_{8pt}$ . Considering that a transverse plane wave moves along the x-axis at speed  $C_{44} =$ , we nd aC<sub>44</sub> =  $k_{sp2}$ . Finally, considering that a longitudinal plane wave moves along the x-axis at speed  $C_{11} =$ , we nd aC<sub>11</sub> =  $k_{sp1} + 2k_{sp2} + 8k_{8pt}$ . Inversion allows the three force constants to be obtained for a general cubically elastic material:  $k_{sp1} = a(C_{11} - (C_{12} + C_{44})), k_{sp2} = aC_{44}$  and  $k_{8pt} = \frac{1}{8}a(C_{12} - C_{44})$ .

The frequency dependence of a given mode is f (N). A sequence of simulations with N varying from a few hundred to 210000 is used to extrapolate f (1), which is the continuum limit. A ccurate results are obtainable with just a few thousand. A ctual nanoparticles are not continuum objects, and so the continuum limit is an idealization. Furthermore, our calculation uses the bulk elastic coe cients of silicon. Surface e ects (arguably, the entire bulk of the nanoparticle is close to its surface) and dispersion (e ects of the silicon crystal structure on phonon speed) are not taken into account in this calculation. How ever, the wavelengths of the low est modes are so large compared to interatom ic distances that dispersion will be negligible.

The correctness and degree of convergence of m ethod (C) was checked by comparing its results to those of m ethod (A) for isotropic elastic m aterials of various Poisson ratios. The results of the two m ethods agree closely.

Since the rst report of low-frequency R am an scattering from nanoparticles<sup>8</sup>, such m easurements have been made on many materials<sup>23</sup>. Results are most offen successfully explained with the free sphere model described above. However, calculated frequencies are much too high in silicon nanoparticles embedded in a silica matrix<sup>16,17</sup>. In this work, we want to see if the situation can be improved by taking into account the presence of the matrix and the elastic anisotropy of silicon.

#### III. EXPERIMENT




FIG.1: Parallel (solid line) and crossed (broken line) con guration R am an spectra of 6.8 nm diam eter silicon nanoparticles embedded in silica. A decom position is made into peaks with depolarization factor 0.75 (plus signs) and 0.33 (bullets). Laser plasm a lines are indicated by arrow s.

New experimental results using the samples studied in<sup>17</sup> have been obtained. The experimental setup is a Jobin-Yvon T 64000. Incident light com es from the 514.5 nm line of an Argon ion laser and is focused onto a 1 m<sup>2</sup> area on the sam ple. Power was kept below 1 m W to avoid sample heating. The CCD detector allows for long accumulation times; the quality of the spectra is much improved compared to previous measurements using a scanning monochrom ator coupled with a photomultiplier. Spectra obtained for the sample heat treated at 500 C are presented in Fig. 1. M easurem ents were made with the sample at room temperature. Average nanoparticle diam eterm easured by transm ission electron microscopy is 6.8 nm. The two narrow lines centered around 23 and 29 cm  $^{1}$  are plasm a lines from the laser. The parallel and crossed spectra correspond to scattered light intensity with polarization parallel (I, ) and perpendicular  $(I_2)$  to the excitation beam respectively.

The positions of the peak maxim a of these two spectra di er slightly indicating scattering by several vibrational modes, one being strongly depolarized at low frequency and another less depolarized contribution at higher frequency. From the ratio of the two spectra at 10 cm  $^{1}$ the depolarization factor of the rst mode is close to dep =  $I_2 = I_k = 0.75$ , as must be the case for a non-resonant non-totally symmetric mode. If we assume our spectra com ponents to have only two di erent depolarization factors, then the shape of the scattering with depolarization factor dierent from 0.75 is given by  $I_k$  0:75  $I_k$ . As a result, two vibrational modes are observed: the rst one with a maximum at 10 cm  $^{1}$  (determined from the crossed con quration) and the second one with a broad maximum around 20 cm<sup>-1</sup> (determined from the calculated spectra).

## IV. DISCUSSION

First, we want to see how the free sphere model (A) com pares with our experim ental results. Table I presents the calculated vibrational energies for a free isotropic sphere of diam eter 6.8 nm with the density of silicon and di erent sound speeds corresponding to im portant crystal directions in silicon. The rst and second [110] lines correspond to transverse phonons polarized along [110] and [001] respectively. Uniform ly averaging over all directions, the longitudinal and transverse speeds of sound in silicon are (9017 233) m /s and (5372 385) m /s, respectively, where one standard deviation of the variation is indicated. The average rms speed is nearly the same. For com parison, energies were also calculated using these averaged sound speeds. E lastic param eters were taken from <sup>18</sup>. As reported by Fu jiet al.<sup>16</sup>, these frequencies can't explain the low est band position. Nevertheless,

we will use these results to choose the isotropic param eters which best describe the calculated anisotropic energies. From Table I, the closest agreem ent with the exact anisotropic calculation (C) is obtained when m ethod (A) uses the averaged sound speeds.

W e applied m ethod (B), with averaged sound speeds, to silicon nanoparticles embedded in silica glass. E lastic param eters for silica were taken from <sup>12</sup> and<sup>19</sup>. Results are presented in Table II. Results using m ethod (A) (free sphere) are also shown, for which case there is no dam ping. M odes can be spheroidal (SPH) or torsional (TOR). l is the orbital quantum number and n is the index of the solution. B lank spaces in the free case indicate that there is no equivalent to the corresponding embedded m ode.

The silica matrix has three e ects: it shifts energies (Re()), it creates damping (Im ()) and it also introduces new modes. One of these new modes is (TOR, l=1, n=0). In the absence of the matrix this would correspond to rigid rotation. The matrix imposes a restoring force changing the rotation into a libration (rigid rotational oscillation). Other new modes have more complicated origins. Considering modes existing in the free case, the more their energies are shifted, the greater the damping. This is consistent with a stronger contribution of the matrix. The damping values given in Table II correspond to the Ram an hom ogeneous half width at halfmaximum. The observed Ram an linew idth should be greater mainly because of the nanoparticle size distribution inside our samples.

For comparison purposes, calculated energies and damping of vibrations of a 6.8 nm diameter spherical cavity in silica as well as around an in nitely hard, heavy sphere are presented in Table III. In particular, the lowest spheroidalmodes in Table II correspond approximately to modes around a rigid, heavy sphere.

From Table II, two modes are good candidates for the lowest Raman peak: (SPH, l=1, n=1) and (TOR, l=1, n=0). But SPH modes with odd land TOR modes with even lhave odd parity and should be Raman inactive<sup>20</sup>. The calculated damping for (TOR, l=1, n=0) is higher than the Raman peak HW HM. Moreover, size and shape distributions<sup>17</sup> and temperature broadening also increase the Raman linewidth. A possible explana-

tion is that in ourm odel, the nanoparticle-m atrix contact is perfect and therefore m ore energy is radiated into the m atrix than in our sam ple.

The second mode is in agreement with the calculated (SPH, l=2,n=0,1) modes. Follow  $ing^{21}$ , we assume the de-

polarization factor of this peak to be 1=3. Therefore, we are able to fully decompose each spectra. The decomposition for the parallel conguration is shown in Fig.1.

### V. CONCLUSION

The special dem ands of silicon nanoparticles em bedded in silica require consideration of mode broadening by the matrix, mode shifting by the matrix, new modes created by the matrix and the anisotropy of the silicon. A strong candidate as the dom inant feature of the R am an spectra is the libration mode (TOR, l=1, n=0) which would be R am an inactive without either anisotropy or nonspherical shape<sup>20</sup>.

The approach we are using can easily be extended to handle other features of realistic nanoparticles, such as non-spherical shape, surface relaxation and details of the nanoparticle-m atrix interface. The extension to inhom ogeneous onion-like particles where the parameters have radial dependence can also be m ade.

Exact incorporation of anisotropy is not di cult, but relatively accurate estim ates of frequency are possible using an isotropicm odel of the elasticity as long as direction averaged speeds of sound are used. This works best for m odes with 1 1, since they are atm ost three-fold degenerate with isotropy and are not split by cubic crystalline anisotropy.

For an isotropic m aterial, the l= 2 spheroidal and torsional m odes are 5-fold degenerate. This degeneracy is broken by the anisotropy, into what M D simulations suggest is a doublet.

O verall, this study has provided a clearer basis for interpreting Raman experiments where the acoustic impedance of the nanoparticle is close to that of the matrix. Crystal elasticity is anisotropic in any case. However, without theoretical calculations of the absolute cross sections of Raman scattering it is possible only to make tentative identication of the vibrationalm odes that appear in the low frequency Raman spectrum.
