Finite temperature e ects on the collapse of trapped Bose-Ferm im ixtures

By using the self-consistent Hartree-Fock-Bogoliubov-Popov theory, we present a detailed study of the mean-eld stability of spherically trapped Bose-Fermim intures at nite temperature. We not that, by increasing the temperature, the critical particle number of bosons (or fermions) and the critical attractive Bose-Fermi scattering length increase, leading to a signicant stabilization of the mixture.

The recent experim ental achievem ent in the trapping and cooling of degenerate Bose-Ferm im ixtures of alkalim etal atom s have introduced interesting new instances of a quantum many-body system [1, 2, 3, 4, 5]. Similar to the purely Bose gases such mixtures provide a unique opportunity of investigating fundam ental quantum phenom ena. Up to date a num ber of theoretical analyses of trapped Bose-Ferm im ixtures have been presented, addressing, for example, the static property [6], the phase diagram [7], the behavior of low-lying collective excitations [8, 9, 10, 11, 12, 13, 14], the expansion [15], as well as the relevant implications for the achievem ent of Bardeen-Cooper-Schrie er (BCS) transition to a superuid phase of the ferm ionic components [16, 17, 18]. The last point is particularly interesting and is highly favorable by tuning the Bose-Ferm i interaction by means of Feshbach resonance [19, 20], in order to induce a large e ective attraction between ferm ionic components by exchanging density uctuations of the bosonic background [16, 17, 18]. It has been suggested in Ref. [20] that the optim al conditions for boson-induced Cooper pairing are reached when the Bose-Fermim ixtures are close to a criticalpoint, beyond which the system will become unstable and collapse.

This kind of collapse is indeed observed very recently in a binary 40 K 87 Rb m ixture [21]. The observation indicates a large attractive interaction between bosonic and ferm ionic atoms, and therefore highlights the possibility of inducing a boson-mediated e ective attraction between two ferm ionic components once another hyper ne state of ferm ionic atom s is populated. On the theoretical side, the collapse or the instability of a trapped Bose-Ferm i m ixture at zero temperature has already been considered by several authors [6, 22, 23, 24, 25]. In Refs. [23, 24], the mean-eld instability of a spherically trapped Bose-Ferm im ixture is studied using a standard two-uid model for the condensate and degenerate Ferm igas. Most recently, the samemean-eldmodelhas been used in Ref. [25], in which the precise geometry of the experiment is taken into account. Its prediction has

been compared with the experimental stability diagram of 40 K 87 Rb m ixtures to give a better estimate of the s-wave Bose-Fermi scattering length [25].

In the present paper we investigate the e ects of the tem perature on the stability of a spherically trapped Bose-Ferm im ixture by only a mean-eld approach. The m otivation is twofold: At rst, in the experim ent there is a detection lim it for determ ining the tem perature. This lim it is around 0:67T_c, where T_c is the transition temperature of the Bose-Einstein condensation (BEC). Below this characteristic tem perature, though no uncondensed fraction of the BEC is practically detectable, the possible role played by the therm alcloud of bosons in the stability of the mixture should be claried. On the other hand, in the context of boson-induced BCS super uidity, the critical tem perature for the form ation of s-wave Cooper pairing increases exponentially as the mixtures move to the collapse point. The qualitative or quantitative understanding of the collapse of Bose-Ferm im ixtures at nite tem perature is therefore crucial to optim ize the experim ental conditions to achieve the BCS transition.

Our investigation is based on the simplest self(consistent mean-eld theory | the Popov version of the Hartree-Fock-Bogoliubov (HFB) theory | that has been generalized by us to the system of Bose-Fermim in ixtures in previous works [14, 26]. For a weakly interacting Bose gas, it was shown that the HFB-Popov theory gives the correct therm odynam is properties with a very good accuracy [27], though it fails to predict the correct behavior of collective excitations at high temperatures [28]. In Ref. [29], this theory has been applied to study the collapse of attractive Bose-Einstein condensates.

In the following we brie y sum marize the main points of HFB-Popov theory. The trapped binary mixture is considered as a thermodynamic equilibrium system under the grand canonical ensemble whose thermodynamic variables are N $_{\rm b}$ and N $_{\rm f}$, respectively, the total number of trapped bosonic and fermionic atoms, T, the absolute temperature, and $_{\rm b}$ and $_{\rm f}$, the chemical potentials. In the second quantization language, the density H am ilto-

nian of the m ixture reads (h = 1),

where (r) ((r)) is the Bose (Ferm i) eld operator that annihilates an atom at position r. The rst and second terms in the brackets contain the kinetic-energy operators and the external trapping potentials $V_{\rm ext}^{\,\rm b}$ (r) = $m_b!_b^2r^2=2$ and $V_{ext}^f(r) = m_f!_f^2r^2=2$ for the bosonic and the ferm ionic species with masses mb and mf, respectively. In the dilute regime, we have considered two types of contact interactions: the interactions between bosons, and the interactions between bosons and ferm ions. They are param etrized by the coupling constants $g_{bb} = 4 h^2 a_{bb} = m_b$ and $g_{bf} = 2 h^2 a_{bf} = m_r$, respectively, in terms of the s-wave scattering length abb and $a_{\rm bf}$, with m $_{\rm r}$ = m $_{\rm b}$ m $_{\rm f}$ = (m $_{\rm b}$ + m $_{\rm f}$) being the reduced m ass. W e have neglected here the ferm ion-ferm ion interactions since for spin-polarized ferm ions the s-wave contact interaction is prohibited by the Pauli principle. The next leading order, p-wave interaction is small at low energy [30] and will not be considered in the following.

We consider the many-body ground state j i of H am iltonian (1) as a direct product of a sym metric N_b-body state j_bi for the bosonic species and an antisym metric N_f-body state j_fi for the fermions. With this choice we are not considering the possible correlation eects beyond the mean-eld approximation [31]. The density H am iltonian describing the Bose-Fermi coupling can therefore be decoupled in a self-consistent mean-eld manner, namely,

As a result, the bosonic and ferm ionic atom s experience, respectively, the e ective potentials $V_{\rm eff}^{\,b}(r) = V_{\rm ext}^{\,b}(r) + g_{\rm bf}\,n_{\rm f}(r)$ and $V_{\rm eff}^{\,f}(r) = V_{\rm ext}^{\,f}(r) + g_{\rm bf}\,n_{\rm b}(r)$; with $n_{\rm b}(r)$ and $n_{\rm f}(r)$ being the bosonic and ferm ionic density distributions, respectively. It is then straightforward to apply the HFB-P opov theory for the bosonic species, following Ref. [32]. A fler invoking the Bose symmetry breaking in the equation of motion for the Bose eld operator (r), we obtain, respectively, the modiled Gross-Pitaevskii (GP) equation for the condensate wave function (r);

and the modi ed Bogoliubov-deGennes (BdG) equations for the thermal quasiparticle amplitudes $u_i(r)$, and $v_i(r)$,

where the operator

is the generalized GP Ham iltonian that includes the mean-eld contributions generated by the interaction with the thermal cloud and the ferm ionic species. Once these wave functions have been determined, the local density of the condensate and of the noncondensate, and the total bosonic density distribution can be calculated according to

w ith $= 1 = k_B T$ being the inverse tem perature. To solve the modi ed GP and BdG equations, one has to evaluate the ferm ionic density distribution $n_f(r)$. To this aim, we employ the nite-tem perature Thomas Ferm iapproximation (TFA) [30],

Specially, for the range of N $_{\rm f}$ considered here (N $_{\rm f}$ ' 10^4), it was shown that TFA is a good approximation for a mixture with repulsive Bose-Ferm i interaction at zero temperature [7]. In our case, this approximation is expected to work even better, since the quantum uctuations are suppressed by the nite temperature and the increased density due to the Bose-Ferm i attraction.

Equations (3)-(7) from a closed set of equations that we have referred to as the \HFB-Popov" equations for a dilute Bose-Ferm im ixture. The simultaneous solution of this set of equations gives the tem perature-dependent density proles of the condensate, of the noncondensate, and of the degenerate Fermigas, from which we can extract the stability conditions of the system. We have numerically solved these coupled equations by an iterative scheme, as described in Ref. [26].

W ith above tools we investigate the e ects of the temperature upon the collapse of a trapped Bose-Ferm im ixture induced by the attractive Bose-Ferm i interaction. Rather than taking the realistic experimental conditions, in this paper we present a general analysis of nite temperature e ects, and restrict ourselves to spherical symmetric systems. The reason is that for this geometry the temperature-dependent density proles of the system are easily calculated. On the contrary, for anisotropic systems, though the formalism given in the present paper is




FIG. 1: Radial density pro les of a Bose-Ferm i m ixture with N $_{\rm b}$ = N $_{\rm f}$ = 5 10^4 for di erent tem peratures and Bose-Ferm i interaction strengths. The condensate and noncondensate densities $n_{\rm c}$ (r) and $n_{\rm T}$ (r) are given, respectively, by the solid and dash-dotted lines (left scale), and the ferm ion density $n_{\rm f}$ (r) by dashed line (right scale). To visualize $n_{\rm T}$ (r) is enlarged by a factor of ten. The upper and lower rows show, respectively, exam ples with decreasing Bose-Ferm i attraction at $T=T_{\rm C}=0.005$ and 0.67, where $T_{\rm C}=0.94h!N_b^{1=3}=k_{\rm B}$ is the transition tem perature of a non-interacting Bose-E instein condensate in the therm odynam ic limit. We x the boson-boson scattering length $a_{\rm bb}=1=0.005$.

suited as well, the num erical calculation is com putationally much more involved. In particular, for the highly anisotropic traps used in the experiments at the European Laboratory for Non-linear Spectroscopy (LENS) [4, 21] it is unlikely to obtain useful information without the use of further approximation. In the following, we consider equal m asses for the two species $m = m_b = m_f$ and identical trapping frequencies $! = !_b = !_f$. The oscillator length $1 = (h=m!)^{1=2}$ and trap energy h!, respectively, serve as fundam ental length unit and energy unit. We also take the transition temperature of a non-interacting Bose gas with N $_{\rm b}$ = 5 10^4 atom s, $T_c = 0.94h! N_b^{1=3} = k_B = 34.63h! = k_B$, as a characteristic temperature. In most calculations, we have set $T = 0.67T_c$ that corresponds to a typical detection $\lim_{n \to \infty} it$ for the m easurem ent of the tem perature.

First we consider the e ects of the tem perature upon the density pro less of the mixture. The upper and lower rows in Fig. 1 show the density pro less of con gurations with $N_b = N_f = 5$ 10^4 particles for three different values of the s-wave Bose-Ferm i scattering length a_{bf} =lat two tem peratures: $T=0.005T_c$ and $T=0.67T_c$. The value of a_{bb} =l=0.005 has been xed, which corresponds to a_{bb} $100a_{B\,ohr}$ for a typical trap with l=1 m. Our results at the lower tem perature $T=0.005T_c$ are in good agreement with the ndings by Roth and coworkers [23, 24], that is, the mutual attraction between bosons and ferm ions results in an enhancement of both densities in the overlap region. In particular, as shown in Fig. (1c), both the bosonic and ferm ionic densities grow

substantially when the mixture is close to the instability point (note that at T = $0.005T_c$ the critical value of $a_{\rm bf}$ =1 is 0.0193). This enhancement, however, is much reduced at a nite temperature, whose e ect is a broadening of the density distributions of the condensate and of the Fermi gas and therefore reduces their center densities. As can be seen in Fig. (1f), at T = $0.67T_c$ both densities is decreased by a factor of 2 compared to the lower temperature case. As a consequence, the mixture in this case is expected to be much stabilized against collapse.

In a sim pli ed m odel [6], the collapse or the instability of the mixture is governed by the balance between the kinetic energy of ferm ions and the mutually attractive mean-eld generated by the Bose-Ferm i interaction (see, for example, the discussion above the Eq. (11) in Ref. [6]), If the Bose-Ferm i attraction becomes too strong, i.e., the numbers of bosons (or ferm ions) or the scattering length abf becomes too large, the attractive mean eld cannot be stabilized by the kinetic energy anym ore, so both density distributions grow inde nitely within the overlap region and collapse. A coording to the study reported in Refs. [6, 23, 24, 25], the onset of this meaneld instability is monitored by the failure of the convergence during the iterative procedure. In this manner, we can determ ine the critical s-wave Bose-Ferm i scattering length $a_{\rm bf}$ or critical particle numbers $N_{\rm b}^{\rm \, crit}$ and $N_{\rm \, f}^{\rm \, crit}$ beyond which the collapse occurs.




FIG. 2: Behavior of the critical particle number as a function of the s-wave Bose-Ferm i scattering length $a_{\rm bf}=1$ for N $_{\rm b}$ = N $_{\rm f}$ at two temperatures: T=Tc = 0:005 (solid line) and T=Tc = 0:67 (dashed line). Tc = 0:94h! N $_{\rm b}^{1=3}=k_{\rm B}$ is the ideal transition temperature evaluated at N $_{\rm b}=5$ 10^4 . The boson-boson scattering length $a_{\rm bb}=1=0:005$ is xed.

In Fig. 2, we show the critical particle number as a function of the s-wave Bose-Ferm i scattering length $a_{\rm bf}=1$ with xed $a_{\rm bb}=1=0.005$ for two tem peratures. In




FIG. 3: (a) The critical number of bosons $N_b^{\rm crit}$ as a function of the rescaled temperature $T=T_c$ with xed number of fermions $N_f=5$ 10^4 . The dashed line shows the corresponding number of condensed bosons. (b) The critical number of fermions $N_f^{\rm crit}$ as a function of the re-scaled temperature $T=T_c$ with xed number of bosons $N_b=5$ 10^4 . In both cases $T_c=0.94h!\,N_b^{1=3}=k_B$ is the ideal transition temperature for $N_b=5$ 10^4 . The other parameters are: $a_{bb}=1=0.005$ and $a_{bf}=1=0.020$.




FIG. 4: Region of stability of the Bose-Ferm i m ixture, as a function of the number of atom s, for the case of a_{bb} =1 = 0.005 and a_{bf} =1 = 0.020. Lines show the boundary between the stable (left) and collapse (right) regions, for three values of the temperature: T= T_{C} = 0.005 (solid line), T= T_{C} = 0.50 (dashed line) and T= T_{C} = 0.67 (dash-dotted line), where T_{C} = 0.94h! N $_{b}$ 1=3 =kB is the transition temperature for a non-interacting Bose gas with N $_{b}$ = 5 10^{4} .

this calculation we have kept equal numbers of bosons and ferm ions $(N_b = N_f)$. At the lower temperature $T = 0.005T_c$, we observed that even a small decrease of Bose-Ferm i attraction can reduce the critical particle num ber signi cantly, i.e., N crit changes by a factor of 2 when abf = 1 changes by 5 percent. This strong dependence of the criticality on abf = l is in accordance with the scaling law for the critical particle num ber: N crit ja_{bf} j with = 12, as discussed in Refs. [6, 22, 25]. The presence of a m oderate tem perature $T = 0.67T_c$ results in a substantial increase of the critical particle number. For example, at $a_{\rm bf}$ = 1 = 0.022, N ^{crit} grows from 1:1 10⁴ to 3:6 10⁴ with the inclusion of the temperature. Apart from this growth, the critical particle number is still strongly dependent on a_{bf}=1. However, the presence of the nite tem perature leads to a re-normalization of the scaling exponent, i.e.,

In Figs. (3a) and (3b), we study the critical particle numbers of bosons and ferm ions as a function of the tem perature. We report, respectively, the prediction on the critical particle numbers of bosons (with xed N $_{\rm f}=5~10^4$) and ferm ions (with xed N $_{\rm b}=5~10^4$). For comparison, in Fig. (3a), we also show the critical number of the condensed atoms against temperature (dashed line). As expected, the critical particle number for each species increase with increasing the temperature. The dependence is highly nonlinear. Below $0.5T_{\rm c}$, the critical particle number varies slowly with the temperature, whereas above $0.5T_{\rm c}$ it rises up steeply. In addition, the critical particle number of ferm ions grows more rapidly than that of bosons against the temperature.

Finally, we have built a region of stability of the Bose-Ferm im ixture in Fig. 4, as a function of the number of

atom s, for the cases of a_{bb} =1= 0.005 and a_{bf} =1= 0.020, for three values of the tem perature: T= T_{C} = 0.005, T= T_{C} = 0.50 and T= T_{C} = 0.67. Each of the curves marks the lim it of stability. For numbers of bosons or fermions below the stability lim it the mixture is stable, otherwise the mixture is unstable against mean-eld collapse. Figure 4 indicates that the region of the stability broadens with increasing temperature. This behavior emphasize again that the inclusion of a temperature gives rise to a signicant stabilization of the mixtures.

In conclusion, we have investigated the mean-eld stability of a spherically trapped binary Bose-Ferm im ixture at nite temperature. We solved the coupled HFB-Popov equations numerically and obtained the critical particle

num ber as a function of the tem perature and the s-wave Bose-Ferm i scattering length. We have shown that the criticalparticle number and the criticalBose-Ferm i scattering length increase with the inclusion of a moderate tem perature that corresponds to the typical experimental detection limit. This leads to a signicant stabilization of the Bose-Ferm imixtures.
