Velocity distributions in dissipative granular gases

M otivated by recent experiments reporting non-G aussian velocity distributions in driven dilute granular materials, we study by numerical simulation the properties of 2D inelastic gases. We not theoretically that the form of the observed velocity distribution is governed primarily by the coe cient of restitution and $q = N_H = N_c$, the ratio between the average number of heatings and the average number of collisions in the gas. The di erences in distributions we not between uniform and boundary heating can then be understood as di erent limits of q, for q 1 and q. 1 respectively.

G ranular m aterials consisting of m acroscopic particles orgrains can exhibit behavior rem in iscent of conventional phases of m atter. Sand, for instance, can ow like a liquid under som e conditions. D ilute granular system s, or gases, have been extensively studied both experimentally and theoretically, in large part as simple model system s exhibiting nonequilibrium and dissipative behavior. These system s are intrinsically dissipative and out of equilibrium, even though it is tempting to apply such equilibrium notions as tem perature. Since the collisions in such a gas are inelastic, a gas-like steady state is achieved only with a constant drive, or input of energy. O therwise, all motion ceases after only a nite time [1, 2]. In principle, it is possible to drive the system uniform ly throughout the container, with every particle in contact with a heat source all the time (uniform heating). This has been done in simulations [3, 4] and is assumed in analytic theories [5]. In experiments, however, one usually drives a granulargas by shaking or vibrating the walls of the container. Such boundary heating m eans that the energy is inserted in a spatially inhom ogeneous way [7, 8, 10]. As a consequence, the gas will develop a gradient in density and m ean kinetic energy [6]. Even for uniform heating, how ever, signi cant deviations from equilibrium gases, e.g., in density correlations, are observed [3].

One of the most fundamental aspects of molecular gases is the Maxwell-Boltzmann velocity distribution [11]. A very general and striking feature of driven dissipative gases, how ever, is the apparently strong deviation from this classical behavior. Such velocity distributions have been the subject of num erous recent experim ental studies [7, 8, 9, 10], and characteristic velocity distributions of the form $P(v) = C \exp[$ (v=)] have been observed, where $= hv^2 i^{\frac{1}{2}}$ is often called the granular tem perature, in analogy with equilibrium gases. Experiments of Rouver and Menon [8], in particular, have suggested that a universal exponent of = 1.5 occurs over a wide range of experim ental param eters. This observation was particularly intriguing, as Van Noije and Emst [5] predicted a high-velocity tailw ith an exponent 1.5 using kinetic theory. Here, we dem onstrate instead that a fam ily of distributions show ing apparent exponents cov-

ering a wide range of values < 2 is expected, depending on both material and experimental conditions. Furthermore, we show that the velocity distribution is governed prim arily by the relative in portance of collisions to heating, i.e., the way in which energy ows through the system of particles. Speci cally, we introduce a new param eter $q = N_H = N_C$, which measures the ratio between num bers of heating events and collisions experienced by a typical particle. These theoretical observations can explain both the observed non-Gaussian behavior, as well as the ambiguities in the experimental and theoretical literature on dissipative gases to date. W e also dem onstrate that the behavior of the velocity distributions can be captured quantitatively by a simple model that takes and g into account, with no spatial degrees of only freedom .

Even though the distribution of velocities is such a basic property of gases, results for velocity distributions in dissipative systems have remained am biguous. Both in simulation and experiment, di erent setups and driving mechanism susually give di erent behavior of the velocity distribution. For a setup where particles on a horizontal plate were driven in the vertical direction, O lafsen and Urbach [12] found a crossover from exponential to Gaussian distributions as the amplitude of the driving was increased. The result of Rouver and Menon [8] was obtained for a di erent con guration where particles were con ned between two vertical plates and driven in the vertical direction. B lair and K udrolli [10] use a di erent setup where particles move along an inclined plane. Friction with the plane during collisions reduces the effective coe cient of restitution to 0:5, in contrast = 0:93 in the setup of Rouyer and Menon. They to nd the distribution with exponent = 1.5 only in the very dilute case. O therwise, the distributions deviate strongly from both Gaussian and the distribution obtained by Rouyer and Menon. For the denser case B lair and Kudrolli nd a distribution that has one exponent

for low velocities and crosses over to another for high velocities. This crossover is also observed in simulation by M oon, et al. [4].

Thus, it remains unclear what the analogue (if any)

of the M axwell-Boltzm ann distribution is for dissipative gases, let alone what the origin of the non-G aussian behavior is. Puglisi, et al. [13] have suggested that the deviations are caused by the spatial correlations in the gas. They propose that for a region of uniform density the velocity distribution of the gas actually is G aussian, with a density dependent width. The spatial correlations cause density uctuations and they claim the non-G aussian distributions arise as an average over the velocity distributions over these regions of di erent density. Experiments [8, 12] show that this is not the case. Even within window sofuniform density the velocity distributions remain non-G aussian. O ur results below con im this.

W e study velocity distributions using an event-driven simulation of N particles of radius r moving in a twodimensional box. Particles gain energy by heating and lose energy through inelastic collisions. W hen two particles i and j collide their nal velocities depend on their initial velocities in the following way:

where is the coe cient of restitution and \hat{r}_{ij} is the unit vector connecting the centers of particles i and j.

W hen heating uniform ly, we add every time step t a random contribution to the velocity of all the particles and we use periodic boundary conditions to simulate bulk behavior. Note that this is signi cantly di erent from the spatially hom ogeneous heating used in experiments [12], as here in uniform heating the driving is uncorrelated in space and time. W hen heating through the boundary, particles are con ned in a box with radius R = 1. The particles receive a kick upon collision with the boundary. We assume that the collision between particles and the boundary is elastic and we add a random contribution to the velocity in the direction perpendicular to the boundary. For more details, we refer to [15]. We allow the system to reach steady state before taking data. For both uniform and boundary heating, data is taken periodically every t.




FIG.1: Snapshot of a clustered state state for N = 350, = 0.05 and = 0.6. Particles are indicated by circle, while the lines show the direction and magnitude of the velocity.

One of the rst striking di erences between uniform heating and boundary heating is clustering. When heating through the boundary, a stable liquid-like cluster surrounded by a hot gaseous state will form for low coe cients of restitution or high area fraction . This occurs as particles are compressed in the center of the box by particles moving in from the boundary. The increase of density leads to collapse and a stable cluster is form ed. A typical example is shown in Fig. 1. These clusters do not occur in our simulations with uniform heating. This is because particles are heated all the time, which prevents the collapse to a cluster.




FIG. 2: Velocity distributions for N = 350 and = 0.02. Shown are both results for uniform heating with = 0.8(), = 0.1() and results for boundary heating with = 0.9(}, = 0.6(0) and = 0.4(). (a) P (x = x) (b) Inf $\ln P (x = x)$ g versus $\ln (v_x = x)$. A Gaussian is shown as a solid line.

Velocity distributions obtained for uniform and boundary heating are shown in Fig. 2. When heating through the boundary, the gas develops a gradient in area fraction and granular temperature. In this case, we record the velocity distribution in a ring of radius 0.4 < r = 0.6around the center of the box, where the granular tem - perature is approximately constant. The velocity distributions in the di erent rings varies only slightly. For uniform heating, we collect data everywhere in the box.

Fig. 2 shows clear qualitative di erences between uniform and boundary heating. For uniform heating the velocity distribution is close to G aussian for a large range of . In contrast, for boundary heating the distribution is only G aussian in the nearly elastic case = 0.9. As the coe cient of restitution is low ered, a crossover develops where the exponent changes from $_1$ 2 to a low er value $_2$. The exponent $_2$ becomes smaller as dissipation is increased (for smaller or higher) and we nd any value in the range 0.7 . $_2 < 2$. As $_2$ decreases it becomes increasingly di cult to describe the high velocity tail with a single exponent $_2$. This crossover in

exponent is observed in boundary heating for all values of $% \mathcal{A}(\mathcal{A})$ and \mathcal{N} .




FIG.3: (a) Inf $\ln \mathbb{P}(y=x)$ g versus $\ln (v_x=x)$ for N = 350, = 0.05 and = 0.9 (), N = 500, = 0.05 and = 0.9 (), N = 350, = 0.25 and = 0.8 (), N = 350, = 0.25 and = 0.9 (4). The solid lines correspond to the tasm ade by Rouyer and M enon and has an exponent = 1.52. The range of the solid lines corresponds to half the range used by Rouyer and M enon in their t, but contains about 80% of their data points.

For a certain range of parameters we also nd highvelocity tails with exponent $_2 = 1.5$. For their experiments Rouver and Menon used N particles with 0:9, where 100 < N < 500 and 0:05 < < 0:25 [8]. In Fig. 3 we plotted the velocity distribution for = 0.9, = 0.05 and several values of N . We also show the t = 1.52 as made in [8]. This line clearly coinwith cides with the high-velocity tail of the velocity distribution found by the present simulation. This suggests that instead of a universal distribution with = 1:5, theym ight have observed a part of a more complex velocity distribution, with more than one apparent exponent.

The main di erence between uniform and boundary heating is that in the st case heating takes place hom ogeneously throughout the box, whereas in the latter case energy is injected inhom ogeneously at the boundaries. This is not the direct cause for the di erence in velocity distributions. W hen heating hom ogeneously, one can go from a Gaussian distribution to one with a crossover by increasing the time between heatings [15] allow ing the average num ber of heatings per unit time to become smaller than the average number of collisions. The reverse is also true. W hen heating inhom ogeneously through a boundary, one nds G aussian distributions in very dilute system s, when the particles on average collide m ore often with the boundary than with other particles. This suggests that in our system the shape of the velocity distribution is not a function of all parameters , , N and the details of the energy in jection, but only of and $q = N_H = N_C$, the ratio between the average number of heatings N $_{\rm H}\,$ and the average num ber of collisions N $_{\rm C}$.

This idea can easily be tested in boundary heating.




FIG. 4: Velocity distributions for di erent values of the heating-dissipation rate q.D istributions with the same q are show n on top of each other. (A) q = 1:3 and we show N = 100 and = 1 10^3 (), N = 200 and = 5 1^{40} (), N = 800 and = 1:25 10^{4} (}). (B) q = 0:13 and we show N = 100 and = 0:02 (}). (C) q = 0:013 and we show N = 100 and = 0:02 (}). (C) q = 0:013 and we show N = 100 and = 0:4 (), N = 200 and = 0:2 (), N = 400 and = 0:1 (}). Inset: Heating-dissipation ratio q for N = 800 (), N = 400 (), N = 200 (}) and N = 100 () for several values of . The line is a t of the form (N)¹⁻².

W hen increasing the number of particles N or the area fraction , the average number of collisions increases. One can show in a mean eld approximation that q (N)) ¹⁼². The average distance a particle travels between collisions is given by l_{coll} 1= . For a box of area A the average distance between boundaries is $A^{1=2}$ $(N =)^{1=2}$. Finally, we know given by heat loll=lheat. Our simulation obeys this approx-N_H =N_C imation very well. In Fig. 4 we show velocity distributions for = 0.8 and di erent combinations of N and . W e m easure the heating-dissipation ratio q in the sim ulation and show velocity distributions with the same q on top of each other. For q = 1:3 and q = 0:13 we nd excellent collapse for di erent N and , even when we scale the system by a factor 8. For q = 0.013, where spatial correlations becom e very strong, we still nd reasonable collapse. A swe increase qwe observe the usual pattern, where a crossover appears in a distribution that was initially close to a Gaussian.

It has been speculated that the non-G aussian distributions are caused by spatial correlations in the gas [13]. How ever, we can qualitatively reproduce the dimensions we observe in simulation with a simple model (based on Ref. [14], but including dissipation) of a twodimensional inelastic gas of N particles without spatial degrees of freedom. In this model, every time step C pairs of particles are selected at random and collide using equation 1 with a random impact parameter 2r < b < 2r, where r is the radius of the particles. At the same time H particles are selected at random to be heated by adding a




FIG.5: Inf $\ln \mathbb{P} (y=x)$ g versus $\ln (v_x=x)$. The symbols shown are velocity distributions acquired by simulation for q = 120 (), 0:08 (), 0:012 (). The lines show the velocity distributions found in the model for the same values of q (solid, dotted, dashed).

random velocity. This gives us a heating-dissipation ratio of q = H = C. In Fig. 5 we compare velocity distributions from the model and simulations for di erent values of q. We nd good qualitative agreement between simulation and model, even though it has no spatial degrees of freedom. This im plies that spatial correlations play a minor role, if any, in P (v).

D ue to the idealized nature of our system, it is not possible to do a direct com parison between our simulation and experiments. Yet, some experiments seem to show a similar behavior, accounting for the parameter q that we introduced here. In the experiments of Ref. [12] velocity distributions go from non-G aussian to G aussian when a rough plate or a layer of heavy particles is used instead of a at plate. In this case, energy is injected directly into the directions parallel to the plate, e ectively increasing the number of in-plane heatings over collisions. M ost convincing is the experiment by B lair and K udrollli [10]. Here the num ber of collisions is increased by adding m ore particles. As a result, their velocity distributions develop the same crossoverwe see both in our simulations and ${\tt m}$ odel.

W e studied behavior of the velocity distributions of $\operatorname{granu} \operatorname{lar} \operatorname{gases} \operatorname{as} \operatorname{a} \operatorname{function} \operatorname{of} \ ,$ the area fraction, and , the coe cient of restitution. Speci cally, we considered the e ect of driving the gas by heating uniform ly, as is assumed in theory and many prior simulations, and by heating through a boundary, as is done in most experiments. We nd that there exists clear qualitative di erences between the velocity distributions for uniform and boundary heating, which dem onstrates that the form of the distributions is not simply a function of material param eters (e.g.,). Furtherm ore, we show that there is no evidence for a universal velocity distribution with a constant exponent = 1:5. Instead, for boundary heating, we nd that velocity distributions cross over from one exponent to another for the high-velocity tail. For this high-velocity tail we observe a wide range of exponents and we nd = 1.5 only for specic values of and .

Instead, we dem onstrate that the distribution of velocities for dissipative gases, while not universal in form, depends only on two parameters: the coe cient of resti-(a material parameter) and $q = N_H = N_C$, the tution average ratio of heatings and collisions in the gas (a function of experim ental conditions). We nd that velocity distributions range from Gaussian for q 1, where heating dom inates dissipation, to strongly non-Gaussian for 1, where the dynam ics of the gas is dom inated by α the dissipative collisions between particles. Furtherm ore, a simple model of a driven, inelastic gas without spatial degrees of freedom reproduces the entire fam ily of velocity distributions we nd in simulation, as we vary and q. This means that the velocity distributions are non-Gaussian not because of spatial correlations. Rather, it is the cascade of energy from a few high-energy particles to the slow-moving bulk of the gas that is the key determ inant of the non-Gaussian velocity distributions.
