# Statistics of extrem al intensities for G aussian interfaces

The extrem al Fourier intensities are studied for stationary Edwards-W ilkinson-type, Gaussian, interfaces with power-law dispersion. We calculate the probability distribution of the maximal intensity and nd that, generically, it does not coincide with the distribution of the integrated power spectrum (i.e. roughness of the surface), nor does it obey any of the known extrem e statistics lim it distributions. The Fisher-Tippett-Gum bel lim it distribution is, however, recovered in three cases: (i) in the non-dispersive (white noise) lim it, (ii) for high dimensions, and (iii) when only short-wavelength modes are kept. In the last two cases the lim it distribution emerges in novel scenarios.

### I. IN TRODUCTION

Extrem e value statistics (EV S) has traditionally found applications in the analysis of environmental and engineering data, such as water level uctuations or appliance lifetim e [1]. Recently there has been a surge of activity from physicists in modeling phenomena that are governed by the extrem al values of some random variable. Exam – ples range from the low temperature state in spin glasses [2], a variety of disordered system s with traveling fronts (see [3] for a brief review), and modeling corrosive fracture [4], to depinning of surfaces [5, 6], to relaxation in granularm aterials [7].

A central notion in EVS is the existence of lim it distributions, that is, the extrem al value in a batch of a large number of independent, identically distributed (i. i. d.) random scalar variables obeys a probability density function (PDF), which is lim ited to one of three main types [1, 8, 9]. It is the tail of the PDF of the original variable, the parent PDF, that determ ines which one of these three classes the EVS will belong to. One distinguishes the Fisher-T ippett-G um bel (FTG) distribution, for a decay faster than any power law, the Fisher-T ippett-Frechet (FTF), for power tail, and W eibull, for power law at a nite edge. The lim it PDFs can even be cast into a single function with a param eter whose di erent ranges correspond to di erent traditional classes, see e.g. Ref. [1].

The appearance of EVS lim it distributions in physical systems is in itself interesting and yields a new tool for the description of those systems, see e.g. [2]. On the other hand, there are instances when the quantities in question are either dependent, di erently distributed, or, have several components and thus generically do not belong to any of the aforem entioned EVS classes, see e.g. [5, 10, 11]. Closely related to our present subject are the studies on the distribution of local [12, 13, 14] and global [15] extrem a of the height of surfaces. W hereas there is no general mathematical theory for the EVS of non-i.i.d.quantities, quite a few special cases have been claried, Refs. [1, 8] has some examples of them.

A possible connection of EVS to non-Gaussian uctuations of spatially averaged, or, global, quantities in critical (strongly correlated) systems has recently been raised [5, 16, 17, 18, 19, 20, 21] in relation to both experim ents [16, 21, 22, 23, 24, 25] and simulations [26, 27, 28] for many-body systems as well as for environmental data [29, 30]. There are two striking characteristics of this ensemble of observations. Firstly, the form of the PDF is similar for these observables [16, 26], and secondly, these functions bare a strong resemblance to the FTG distribution. There is some variation in form and there are some clear exceptions, but this approximate universality has been the subject of considerable debate in the literature.

M ore concrete connections to EVS have been found in studies of the uctuations of the roughness, or, width, of interfaces. The non-Gaussian nature of these uctuations was rst discussed in [31], and in [17, 21, 30, 32, 33, 34] fam ilies of PDFs were identied, all characterized by a single maximum, positive skewness, an exponential, or near exponential, tail for large uctuations above the mean, and even faster decay below it. In Gaussian interface models relation to the FTG distribution has been observed in several instances. Namely, the magnetization distribution of the 2d X Y m odel, in the low-tem perature phase where vortices are rare, has been related to the roughness distribution in the stationary 2d Edwards-W ilkinson interface, and strong resemblance has been found to a form algeneralization of the FTG function [26]. In another work on the 2d XY model, the FTG function was num erically observed for extrem alm ode selection [35]. A strong connection to EVS com es from an

analytic result on a 1d interface model with long-range interactions, corresponding to a G aussian noise with 1=f power spectrum, where the roughness of the interface turns out to be exactly of the FTG form [21].

Given the manifold occurrence of the FTG shape, we are led to study the relation between EVS and the roughness of Gaussian interface models. These models can be considered as generalizations of the stationary ddim ensional Edwards-Wilkinson interfaces, specied by the exponent in the power-law dispersion of Fourier modes (for = 2 the Edwards-W ilkinson case is recovered). Due to their integrability, they are ideal starting point for the study of more com plex, strongly uctuating system s. A s the m odels diagonalize into statistically independent modes, and the roughness equals the sum of the Fourier intensities, it is straightforward to address the problem of possible connection to EVS. Namely, one can pose the question that originally motivated our research: do the modes with the largest intensities dom inate the PDF of the roughness? Here we show that the answer to this question is no. In fact, this negative result, the rst main conclusion of this paper, is immediately apparent once we construct the distribution of the maximal intensity, an expression that turns out to be a generalized form of the Dedekind function. Besides being dierent from the distribution of roughness, this function generically also deviates from the FTG or any known EVS lim it distributions. The reason for the deviation from conventional EVS is that the independent modes have gapless dispersion, and are strongly non-identically distributed even for higher wavenum bers. As a result, for each realization of the interface, the largest intensity com es from one of only a few soft modes. The EVS is therefore effectively coming from a nite-size system, even in the therm odynam ic lim it.

The main body of the paper concerns the study of the maximal intensity PDF, which is found to depend on d and . W hile there are no nite criticald or c, marking thresholds to the known EVS lim it distributions, we discover three lim its where FTG statistics sets in: (i) ! 0, (ii) d ! 1, (iii) when only hard modes with wave vectors beyond a diverging radius R are kept. Common in these cases is that the therm odynam ic lim it can be taken beforehand, N ! 1, where N is the total number of modes, so one chooses the maxim al intensity out of an in nite set, in contrast to the conventional EVS procedure. The extrem al value PDF becom es degenerate in all three cases in the sense that the standard deviation shrinks to zero on the scale of the mean. This is similar to the traditional FTG scenario when such degeneracy appears for N ! 1 . Now, how ever, in each case special scaling should be applied to resolve degeneracy and reveal the FTG distribution. It is suggested that the FTG lim it in case (iii) is responsible for the num erically observed t to the FTG function in Ref. [35].

F inally, we turn to the question how the EVS changes by considering a di erent choice of expansion functions (m odes). This study further illum inates the fact that the EVS is not generically described by any of the traditional EVS limit functions. Since the dom inant contribution to the EVS comes from a few modes, the EVS will depend on the specie c expansion functions. We not analytically a diment family of extreme value PDFs for the intensities if the interface is expanded in sines and cosines, albeit the overall shape goes close to that of the PDF of the maxim al Fourier intensities.

W e section the paper as follows. In Section II we dene the Gaussian model (IIA), present the basic form ulas for EVS form axim al Fourier intensities (IIB), then in IIC evaluate the EVS for the model showing 1=f noise. General 1=f noise is considered in IID. The case of arbitrary substrate dimensionality is treated in Sec. III, with the general form ulas for the extrem aldistributions calculated in IIIA. In Sec. IIIB the EVS for the magnetization modes for the XY system in the frame of the Gaussian model is investigated. The emergence of the FTG distribution in three limiting cases is described in IV. The EVS of square amplitudes from the expansion in sines and cosines is discussed in V, Sec. VI is devoted to a comparison to the distribution of the roughness, and Sec. V II contains the concluding remarks. W e give the list of abbreviations in Appendix A, the sm all-z asym ptotes of the extrem al value PDFs are derived in Apps. B and C, and the nite-N correction to the extrem aldistribution is considered in App.D. Som e details for the calculation of the PDF in the white noise lim it is claried in App.E, and in App.F we determ ine, for > d, the initial asymptote of the PDF of the roughness for com parison.

# II. GAUSSIAN SURFACES IN ONE DIMENSION

### A. 1=f noise

The interface at position x on a one-dimensional (d = 1) substrate is characterized by the height h(x). Replacing x by time t, h(t) can be thought of as the distance from the origin of a random walker.

The roughness, or mean-square width, is given by

The Fourier decomposition of the interface gives the am - plitudes of the uctuating modes we are interested in

Here h (t) is de ned on N<sub>0</sub> equidistant points (t = k t, T = N<sub>0</sub> t) and we introduced the notation N = (N<sub>0</sub> 1)=2, with N<sub>0</sub> assumed to be odd, before nally taking the therm odynamic lim it N ! 1 . The roughness is then the integrated power spectrum

In the m odels we consider, the time signal (t) has periodic boundary condition, it exhibits 1=f power spectrum, and the m odes are independent G aussian variables. The path probability is given by

where the action S is given in term s of Fourier intensities  $\dot{p}_n \stackrel{f}{\xrightarrow{}} as$

with exponent dening the 1=f noise spectrum. The  $_0$  is a parameter setting the elective surface tension and the power of T originates from dimensional considerations [34].

The PDF of the roughness for the G aussian m odel has been extensively studied in [20, 21, 34]. For = 1 it was found analytically to coincide with the FTG function [21], one of the limit functions of EVS. N evertheless, the roughness is not a priori an extremal quantity and it remains an open question why it obeys the EVS. O ne m ay argue that the sum is dom inated by the softerm odes whose extrem alvalues possibly determ ine the cum ulative behavior [18, 35]. M otivated by this problem we study the largest contribution to the sum (4).

An alternative choice of Fourier coe cients would be the set  $(\text{Rec}_n)^2$ ;  $(\text{Im }c_n)^2$ , as studied in [35]. These are the coe cients from the expansions by sines and cosines, and while this does not seem to be a physically signi cant modi cation, the EVS for this set is, in general, quantitatively di erent from that of the intensities  $j_{cn} j^2$ . Nevertheless, the PDFs for the two sets are similar in shape and lead to the same physical conclusions, so in order to keep unity of discussion we focus on the set  $j_{cn} j^2$  along m ost of the main text, and sum marize the results on the (Rec<sub>n</sub>)<sup>2</sup>; (Im c<sub>n</sub>)<sup>2</sup> at the end.

### B. Extrem e value distributions

We calculate the probability that the maximal intensity  $j_n f_{nax}^2$  is T<sup>-1</sup>z=<sub>0</sub>, so we shall actually determ ine the scaling function of the EVS.We denote the PDF for that extrem e value by P<sup>-</sup>(z), and the cumulative, or, integrated probability distribution function (IPDF) by

Since M (z) is the probability that none of the  $jc_n js$  exceed T  $^1z=_0$ , we can express it as

where  $A_n = n = is$  the norm alization constant for the PDF of the nth m ode. A fler evaluating the integrals in (8) we nd

In fact, for = 1 the product (9) is known from the de ning form ula of D edekind's eta function, the latter also containing an extra power prefactor [36]. D espite the di erence in the prefactor, we will refer to (9) as a generalized D edekind function. D i erentiating (9) we arrive at the expression for the PDF of the maximal intensity

The IPDF and the PDF vanish for z = 0, the above form ulas (9,10) are understood for non-negative z.

Three lim its are easily understood here. Firstly, if = 0, i.e. the modes are identically distributed, we nd

where is Riemann's zeta function and Euler's constant, yields the FTG distribution in the N ! 1 limit

The constants in (12) were used to scale the FTG distribution so that the mean becomes zero and the variance one [37]. Secondly and thirdly, in both limits ! 1 and z ! 1 only the mode n = 1 matters and one nds

A lready at this point we can draw one of the main conclusions of the present paper, namely, that for general the extrem e value PDFs are none of the know n EVS lim it functions. This im mediately follows from the fact that the negative-z and large-z behavior of (9,10) is incompatible with those of the lim it functions for the statistics of maxim a [1, 8].

The breakdown of validity of the traditional EVS lim it distributions can be ascribed to the fact that, for > 0, due to the n dispersion, the distributions of the individual modes are su ciently di erent. Here \su ciently" needs to be emphasized, because one can conceive sets of di erent parent PDFs for the modes [38] that lead to say the FTG function. Such is the case of a dispersion that has a gap at the origin or goes to a constant for high frequencies. Conversely, one should not be surprised by the appearance of special PDFs di erent from the known lim it distributions, because actually for any given PDF one can choose sets of di erent parent distributions yielding that PDF in EVS [8].

It is easy to convince oneself that for > 0 in form ulas (9,10) the lim it N ! 1 can be taken and the resulting distribution has nite moments. Indeed, because of dispersion the exponential PDFs of individual modes decay increasingly fast and so no singularities appear for large N. In conventional EVS, lim it distributions arise because the moments of variable z scale in singular ways in the therm odynam ic lim it, thus removing most of the details of the distribution of the original random variables. Now, how ever, there is no such singular scale and the strong dependence on the statistics of the individual modes through the parameter remains. This gives us a physical intuition about why the EVS for intensities of interfaces with dispersion is not described by any of the traditional lim it distributions.

Furtherm ore, we can also immediately assert the difference between the PDF of the roughness (4), studied in Ref. [34], and the PDF (10) of the maximal intensity component in (4). An obvious deviation is in the physical scales, namely, while the maximal intensity is always of order T<sup>1</sup>, the mean roughness is like that only for > 1, diverges logarithm ically for = 1, and stays - nite for nite sampling times t if < 1. Even when the scaling is the same, for nite > 1, the two PDF's clearly di er (the generating function of the roughness PDF is given in [34], whose Laplace transform is not Eq. (10)), and became the same only in the limit ! 1, when the n = 1 m ode dom inates. M ore detailed com parison will follow in Sec.VI.

### C. 1=f noise ( = 1)




FIG.1: D istribution functions for the = 1 case evaluated numerically according to Eq. (10) for various N s, each function scaled to unit average. The convergence is apparently fast for practical purposes.




FIG.2: The same as Fig.1 on a semilog scale so as to better display the regions where  $P_1(z)$  is small.

W hile for large z the PDF  $P_1(z)$  is pure exponential s given in (14b), for general arguments one should resort to numerical evaluation. The function (10) is shown for a sequence of N s in Figs. 1 and 2. For N 9 the curves are hard to distinguish by the naked eye, the approximation by nite N thus converges fast for practical purposes.

For small-z, the expected nonanalytic behavior can be estimated in the following way: the product in (10) can

where we have used Stirling's approximation for the factorial. While here we took the terms with n > 1=z as one, this gives us a rst hint of the expected functional form. A more precise calculation in Appendix B shows that the large-n region gives a contribution of equal order, and in the end the true asymptote di ers from (15) only in a scale factor in the exponent

A s dem onstrated in F ig.3, the above expression is correct at sm all z and provides a reasonable approximation over m ost of the ascending part of  $P_1$  (z).




FIG. 3: The PDF  $P_1(z)$  from Eq. (10) with N = 100 and its sm all-z asymptote as given by Eq. (17).

We conclude the case of the 1=f noise by noting that, the PDF for the roughness (4) scales logarithm ically in N and approaches the FTG function [21]. In contrast, as shown above, direct extrem all selection of the constituent intensities in (4) leads to a nonsingular PDF, related to the D edekind function, even in the therm odynam ic lim it. In short, we have the FTG distribution for the roughness, which is not an extrem al quantity, while the EVS is not described by the FTG function. Thus the question raised in Ref. [21], namely, what kind of extrem al value selection can possibly be responsible for the FTG distribution of the roughness, has not been answered and is left to further explorations.

#### D. General

Here we go beyond the 1=f spectrum and investigate the noise for general . The special cases = 0 and = 2 correspond to white noise and the W iener process (ordinary random walk), respectively. The PDF of the roughness for G aussian noise for periodic and  $\w$  indow " (bulk) boundary condition has been studied in [30, 34], and no other than 1 has been found for which the PDF coincided with any of the known lim it PDFs of extrem e statistics.

From the previous discussion it is clear that it is only for  $= _{c} = 0$  that EVS is given by the FTG function in nite dimensions. Concerning the small-z asymptote, the IPDF is given in Appendix B in (B14), whence differentiation yields the PDF

where c() is given in Eq. (B12). One can see that the above form becomes singular only in the ! 0 limit. While for any nite > 0 the asymptote is obviously incompatible with the FTG function (13b), surprisingly, expression (18) corresponds to the generalized FTF function for k<sup>th</sup> maximum [8] in the special case when k, the FTF power parameter , and are related through =  $2 (k \ 1) = 1 = .$  The function (18) does not equal the EVS distribution for larger z, it is not even normalized to one, so this coincidence does not contradict the claim that the extrem evalue PDFsP (z) are none of the known limit distributions of EVS. The FTF class is not expected to be of relevance here anyhow, because the parent PDFs of the constituent m odes decay exponentially.

W hen one evaluates P (z), the convergence in N is important. The N -dependence has been determ ined in App.D, whence it is apparent that convergence is fast for of unit order and larger, but slows down for sm aller .

W e give here the asym ptote in the region of slow decay, < 1,

where we kept the N index for P when only N modes were counted.




FIG. 4: Distribution functions for d = 1 and various s. We rescaled z by its mean hzi to get a variable of unit average. For = 0.1 we show the sequence of approximants with N  $= 10^5; 10^6; 10^7$ , peak moving upwards with increasing N, to demonstrate slow convergence.




FIG. 5: The PDF with the same s as in Fig. 4, but z is rescaled now by its mean hzi and standard deviation z to produce a variable of zero average and unit deviation. For

The results of the evaluation of P (z) are given in Figs. 4 and 5. If displayed on the scale when the mean is set to one, see Fig. 4, for vanishing the PDFs develop a singularity as eventually they approach the D irac delta. Slow convergence in N for small is also demonstrated, already for = 0.1 one has to go up to exceedingly large N sto get a satisfactory approximation for the PDF.W hen the PDFs are shown with variance scaled to one, as in Fig. 5, the functions remain nonsingular and tend tow ards the FTG distribution.

### III. GENERAL DIMENSION

# A. Extrem al intensities

It is easy to generalize the above calculations to surfaces h(r) de ned on a hypercubic lattice substrate of dimension d and edge length L. We retain the periodic boundary condition for substrate, so the natural expansion of h(r) involves again Fourier modes. The probability of a surface (5) is then characterized by the elective action [20, 34]

m assless model with nite-range, and for  $\Leftrightarrow$  2k with interactions decaying like a power law.

Denoting the maximal value of  ${}_0 L^d$   $j_n \hat{j}$  by z, and its IPDF by M  ${}_{d}(z)$ , each mode gives a multiplicative factor 1  $e^{j_n j z}$  resulting in

The IPDF (21) can be considered as a further generalization of D edekind's original product form ula [36]. As in one dimension, it is straightforward to show that for > 0 the above functions remain nite and involve nite mean and variance in the limit N ! 1. Thus again no singular scaling is necessary and so we do not expect that any of the known extrem e value limit PDFs emerge for general d and . How ever, again as in d = 1, for = 0 all independent m odes become e identically distributed and we recover the FTG function after proper scaling by N.

The large limit of (22), for any xed dimension d, is determined by the contribution of the modes  $j_1 j = 1$

For nite where all modes count, we have closed form s only for the asymptotes. In the large-z limit, for any > 0 and xed d, one obtains

Since here, too, only the modes  $j_1 j = 1 \text{ m}$  atter, the largez form ula is obtained from the PDF (23) for ! 1, by taking z ! 1, which explains the fact that (24) is independent of .Forz ! 0 we determ ined, in Appendix B 2 the asymptote of the logarithm of the IPDF M  $_{rd}$  (z), see Eqs. (B15, B16). One can easily convince oneself that the leading term for the logarithm of P  $_{rd}$  (z) is the sam e as for M  $_{rd}$  (z), so we have for small z

For general z we have to evaluate expression (22) num erically. This poses no di culties unless 0.

# B. The 2d Edwards-W ilkinson model ( = 2)

O ne of the physically m ost relevant cases is d = 2 and = 2, the Edwards-W ilkinson surface as originally dened. Since it is a massless Gaussian system, it also corresponds to the XY model in that part of the low

Here the rescaled wave vector  $n = (n_1; n_2; :::; n_d)$  has integer components  $n_i$  such that  $j_n; j \in \mathbb{N}$ , furtherm ore, the mark  $^0$  im plies that if an n is counted then n is not, and the zero vector is excluded. (The halving of the B rillouin zone is the consequence of the relation  $c_n = c_n$ .) The above action for = 2 corresponds to the stationary state of the original E dwards W ilkinson m odel, while for




FIG. 6: D istribution function for the maximum Fourier intensity statistics for d = 2 and the FTG function scaled to unit mean and the same variance.

= 4 it gives the curvature-driven M ullins-H erring interface. For a general = 2k, k integer, it is a G aussian tem perature phase where the e ect of vortices is negligible [18]. There the magnetization distribution is proportional, with a change of sign, to the roughness of the Edwards-W ilkinson surface. Accordingly, the distribution of the maximum amplitude of the magnetization uctuations, after proper scaling, should be given by the PDF (22) for d = 2. Fig. 6 shows the  $P_{2,2}(z)$ , together with the FTG function normalized to the same mean and variance. W hile the fact that the two functions are di erent is obvious, here we dem onstrate that the functions deviate signi cantly and in no range could they be mistaken for each other. The large di erence here is of in portance, because the PDF P2:2 (z) characterizes also the XY model, so this is an example when the FTG statistics is far from an EVS in a criticalm any-body system .

### IV. FTG LIM IT ING CASES

# A. Case (i): W hite noise lim it ! 0

A swe have seen, for = 0 the modes become identically distributed in Eq. (21), thus, because of the exponential decay of the parent PDF for large z, one recovers the FTG function by proper scaling in N. One may, therefore, expect that when N = 1 is set rst, the extrem e value distribution converges to FTG for ! 0, if proper scaling in is applied. Such a convergence is not part of the standard theory of the FTG limit [1,8], so we show here how it comes about. A num erical dem onstration in d = 1 was given before on Fig.5, now we derive it analytically for any d, and determ ine the natural scaling of the variable z by .

Let us start out from the IPDF given by (21). Exponentiating the product into a sum, we realize that in

the interesting region of z, where  $\ln M$  (z) is not too large, z must be large, thus we can linearize the logarithm s. Then we notice that for small the term s in the sum change slow ly with jn j therefore we assume that the sum can be replaced by an integral. So we get

where hzi is the mean and z the standard deviation of z up to term s vanishing for ! 0. It thus follows that the scaled maximal intensities z have an average diverging proportionally to  $^{1}$ , and they scatter in an 0 (1) region about the average.

# B. Case (ii): H igh dim ensions

We immediately recognize the FTG limit when d! 1 in the formula (23) of the PDF for large ,  $P_{1;d}(z)$ . Indeed, the PDF for the variable y = (z log d)=a

then goes over to the FTG limit function (13b). Below we study the d! 1 limit for any xed positive and conclude that again FTG arises. This is far from obvious a priori, because while in large dimensions there are many modes in each shell of constant jn j so they have the same, exponential, parent distribution and, if we had only them, they would give rise to FTG, but on dierent shells the intensities are non-i.i.d. variables.

A gain we exponentiate the product (21) into a sum, and notice that if d is large, the entropic weight quickly increases with jn j. Thus the dom inant contribution comes from large jn js, so we replace the sum by an integral and again get form ula (26), which should be taken now for any xed > 0 but in the limit d ! 1. Its asymptotic analysis is similar to that described for ! 0 in Appendix E, and gives

We can thus conclude that in high dimensions the extrem al intensities belong to the FTG class. Furtherm ore, by comparing Eq. (32) with (35) we can determ ine the average and standard deviation of the scaled maximal intensity z, namely, hzi / d<sup>1</sup> =<sup>2</sup> and z / d =<sup>2</sup>. Interestingly, hzi diverges only for < 2, while it shrinks to zero when > 2, so the latter case is an example of a nonconventional FTG limit, when the maximal intensities are small although the intensities them selves are not bounded from above. While it is plausible that strong enough dispersion can have the e ect of an upper cuto on the amplitude, the novelty here is the sharp transition at = 2, the only value when the characteristic maximal intensities remain nite and positive. For all

> 0, however, the scale of the standard deviation becom es much sm aller than that of the average, a feature of the conventionalFTG scenario [1, 8].

# C. Case (iii): Hard modes

We study the situation when the maximal amplitude is selected only from among those with jnj R 1, that is, the very hard modes. We consider arbitrary but xed and d. For we take the thermodynamic limit N ! 1, we are left with a single divergent parameter R. W hereas all hard mode intensities are quite small, they are of di erent scales and so are essentially noni.i.d. variables. Thus special considerations are necessary to determ ine their EVS.

The PDF for the maxim alhard mode amplitude is

O by iously R = 1 gives the form enly studied IPDF (21) in the therm odynam ic lim it. The interesting region in z is where M (z) changes fast. At this stage we assume that in that region R z is large, but we should check the result for consistency in the end. We can make from (38) a sum in the exponent, and since large jn js are involved, we rewrite the sum into an integral. In leading order we obtain

where the linear transformation (41) is understood. C om paring (41) with (32) we nd that the mean hzi has the leading singularity R  $\ln R$ , so in the relevant region of z the R z indeed diverges, as assumed in the above derivation.

### D. Scales of singularity

Sum m arizing the aforem entioned lim its, we found that FTG emerges (i) as ! 0, (ii) for d ! 1, and (iii) when only hard modes R jn j with R ! 1 are considered. W hile for = 0 the intensities become i.i.

d. and so FTG should be expected, they are a priori non-i.i.d. in the cases (ii,iii). Nevertheless, for d! 1 we found that a shell of practically i. i. d. modes in the Brillouin zone becom es dom inant, so this essentially explains why one of the known EVS lim it distributions em erged. On the other hand, in the case of hard modes we do not see i. i. d. intensities grouping, thus presently we lack an intuitive explanation for FTG. Remarkably, how ever, a comm on feature of all the above cases is that the distribution narrows down to a scale smaller than that of the average, a phenom enon also present in the traditional FTG scenario. In Table I we sum marize the scales of the mean and standard deviation of the maxin alam plitude, and compare them to the scales in the conventional lim it when FTG em erges. In the latter case we consider batches of i. i. d. variables, whose parent  $\mathbb{P}DF$  approaches 1 like exp (  $a z^{t}$ ) for large z. The divergent parameter is then the number N of variables in a batch. Then the statistics of the maxim al values within the batches becomes of FTG type [8], and straightforward calculation yields the scales given in the last row of the table.

#### V. SINE AND COSINE EXPANSION

B ased on physical intuition one may suspect that, in the absence of the traditional EVS lim it for i. i. d. variables, the extrem al am plitude PDFs will depend on the choice of expansion functions. G iven the periodic boundary conditions for the surface, another natural choice of expansion functions are the sines and cosines, whose coe cients squared are  $(\text{Rec}_n)^2$ ;  $(\text{Im} c_n)^2$ . Below we show that indeed a new fam ily of PDFs arise for the maximal square am plitude in this case, thus further illustrating deviation from the know n EVS lim it functions. M orem otivation to look at these coe cients com es from the fact that the rst EVS study in this area was done with such an expansion in Ref. [35]. There, the FTG distribution was found num erically when soft m odes were discarded.

W hen the sine and cosine modes are considered separately, we obtain the  $\mathbb{P}DF$  of z L d = 0 being the max-



For the sake of dem onstration we consider = d = 1, and denote the corresponding PDF by  $P_1$ . For sm all z, Eq. (C3) of Appendix C with = 1 gives the asymptote

Note that the deviation of the small-z asymptote from the exact PDF never exceeds 0.25 even for larger zs. W e also displayed the PDF of extrem al intensity  $P_1(z)$  from Fig. 1, which is given by a dimensity form ula and has a dimension of the second provide the point of the second provides the point of the point of the provides the point of the point of

Interestingly, in the three lim its yielding the FTG distribution for the intensities  $j_{c_1}j^2$  in Sec. IV, the FTG function is found also for  $(\text{Rec}_n)^2$ ;  $(\text{Im c}_n)^2$ , following derivations sim ilar to the ones in Sec. IV C. So the FTG lim its seem to be robust with respect to the choice of expansion functions. The FTG function found for the case of hard modes (the equivalent of the result in Sec.

albeit the proportionality constants in the two asymptotes are di erent. W hat is more, in 1d both PDFs become the FTG function in the limit  $!_{c}$ . Note how – ever, that the two kinds of PDFs have di erent asymptotes for larger arguments, when  $>_{c}$ .

We can put the threshold behavior in a short form . Firstly, for both kinds of distributions there is a (lower) critical value (d= )  $\dot{c}$  where, for increasing d= , on the scale of the mean the distributions become the Dirac delta, and this threshold is 1 for the roughness and 1 for the EVS. Then there is an upper critical value (d=  $)_{c}^{u}$ , that is the threshold for the respective classical lim it distribution, Gaussian for the roughness and FTG for the maximal intensity. For the roughness we have seen [34] that  $(d=)_{c}^{u} = 2$  and for the maximal intensity it is again  $(d=)_{c}^{u} = 1$ . So there is a region, 2 d= 1, where the roughness is G aussian, but the EVS is still not given by any of the known lim it distributions of EVS, rather by the generalized D edekind function.

There is a signi cant di erence also in the nite-size correction to the PDF. The PDF for the extrem alam plitude converges essentially exponentially fast (see App.D for the 1d correction form ula), while the correction to the roughness PDF can be shown to be algebraic in N.

In sum, there is a strong qualitative resem blance between the shape of the roughness PDF for > d and the EVS, furtherm one, their initial asymptotes have similar functional forms, they are, however, distinctly dierent functions. It remains to be claried whether the similarity has some deeper reason, or it is simply a mathematical coincidence.

#### VII. CONCLUSION

The results presented above bring us to a very de nite conclusion concerning the relation between interface uctuations and extrem al statistics: the roughness PDF is not given by the largest mode in the Gaussian interface model. This is true, even in the case = d = 1, where the roughness PDF is the FTG distribution [21], one of the known lim it functions of extrem e statistics. W e showed, further, that the PDF was none of the known EVS lim it. distributions and depended on the statistics for the individual elements of the model. In addition, one expects the boundary conditions to in uence the shape of the PDFs. It should be added that, to the extent that the Gaussian model is a universal family of massless models from the view point of critical phenom ena, the generalized Dedekind PDFs are equally universal, depending on the dimensionality d and the dispersion parameter .

It is worth pointing out that there is an analogy between the Gaussian distribution arising from the central




FIG.7: The extrem e value PDF  $P_1(z)$ , computed from (45) with = d = 1 (full line), the asymptotes for small z from (47) (dashed), and for large z (48) (short dashed). For com – parison the maximal intensity PDF  $P_1(z)$  from Fig.1 is also shown (dotted); the two PDFs are very close, but distinct, as can be observed also near the maximum (see inset).

IV C) explains the nding of [35], where extrem alsquarecoe cient statistics was studied num erically for the XY m odel, and the FTG function (13b) proved to be a good t when soft m odes were discarded from the batches of intensities before the selection of the m axim alones.

# VI. COMPARISON W ITH THE DISTRIBUTION OF THE ROUGHNESS

Interestingly, there is a resemblance between the scaling function of the extrem e value PDFs for > 0 and those for the roughness [34] for > d. Namely, both types of PDFs have a single maximum, positive skew – ness, a nonanalytic initial asymptote, and a dom inantly exponential decay (the leading term in the logarithm of the PDF is linear for large z). However similar they are qualitatively, the functions are di erent.

A straightforward way to make the comparison quantitative is to calculate the asymptotes of the PDFs. For small x the roughness PDF behaves as given by (F16) of Appendix F, and the EVS PDF goes like (25). It is interesting to note that for the roughness the critical  $_c = d$ , where the variance shrinks to zero on the scale of the mean, while for the EVS the same type of criticality is observed for  $_c = 0$ . Then both asymptotes can be cast in the common form

where for the roughness and for EVS one should understand y as z and x, respectively.

Furtherm ore, in 1d one can calculate the power prefactor in front of the nonanalytic exponential, c. f. (18)

lim it theorem, which applies for sum s of random variables with nite moments, and the extreme value lim it distributions such as FTG, which is about the maximal of those variables. Both lim it distributions are related to a large ensemble of independent, identically distributed objects. The appearance of a non-Gaussian PDF for the integrated power spectrum (i.e. roughness), in Gaussian system s [16, 17, 21, 23, 26, 31, 32, 34, 35], is a consequence of strong dispersion, whence follows the strongly non-identical distribution of the modes. W hat we have illustrated in this paper is that it is this same dispersion that generically excludes the known lim it distributions of extrem e statistics. To re ne the picture, we found that if G aussian central lim it statistics is excluded for the integrated variable because of dispersion, FTG extrem al statistics is also explicitly excluded, but the reverse is not necessarily true: there is the region of nite d= 2, where the integrated power is Gaussian but the maximalFourier intensity does not follow FTG. However, we found three border cases where, by singular scaling, the FTG distribution arises. In the limit ! 0 the am plitudes obviously become identically distributed. For the other cases, that is, in the  $\lim it d! 1$  and when a large num ber of m odes are om itted near the center of the Brillouin zone, the num ber of contributing modes diverge but the dispersion across the zone remains. This result appears to broaden the scope of validity of the FTG distribution in EVS to non-i. i. d. variables. Furtherm ore, the special scalings that led to the emergence of FTG in the border cases dem onstrate new ways of extracting the known lim it distribution even in the absence of the conventionalFTG scenario.

In sum mary, the extrem e value PDF for Gaussian interface models are, for xed choice of variables, a twoparameter family of functions with a nonanalytic part for small values, a single maximum, and an essentially exponential tail. The functions look qualitatively sim ilar, but vary quantitatively over the range of param eters d and studied. This fam ily of curves is di erent from that found for the roughness distribution for the same param eters ;d [34]. W e conclude that it is not possible to make a direct link between non-Gaussian roughness uctuations and extrem e values in these models. G iven the multitude of recent observations of non-Gaussian uctuations in experim ental and in model strongly correlated system s, as well as in the use of interface models as phenom enological tools in describing such uctuations, this seem s like an important result. How ever, the relevance of extrem e values in more com plex, non-Gaussian system s remains an open question and it would be interesting to follow up this work with studies in this direction.

T his is the sought after asymptote for small z in the sense that its relative error vanishes for  $z \neq 0$ .

R em arkably, when we neglect the large n contribution, we nd the correct  $1=z^{1=}$  dependence in the argument of the exponential in M (z). However, the coe cient c() is only found by keeping term s with large n. Note, furtherm ore, that the inequality (B 6) needs > 0. Thus we should not be surprised that the asymptote for ! 0 does not relate to the tail of the FTG function (13b) for large negative argument.

In sum m ary, the leading term of  $\ln M$  (z) was produced by exponentiating the product and rew riting the sum as an integral. We shall follow this recipe below for general dimensions.

### 2. A rbitrary dim ension

We consider here the asymptotes of the PDF (21). The leading term of the logarithm of the PDF M  $_{\rm rd}$  (z), in the small-z limit, can be determined by transforming the sum over the modes of the Brillouin zone into an integral, because for z ! 0 the terms in the sum change slow ly. Thus we obtain, to leading order in z

This correction diverges algebraically for d > 1, giving rise to a further exponential singularity in the IPDF. The asymptote of M is therefore not as simple as in the 1d case (B14).

In this Appendix we just sum marize the results for the PDF of the maximal square-coe cient for the sine and cosine expansion functions. The leading term for the logarithm of the PDF (44) comes from our making the sum an integral

The last form ula, an upper bound for the asymptote, is just the rst term in the sum I. The sum has positive terms, whence it follows that the rst term is at the same time the asymptote of I for > 1. Finally, in the case < 1 we can rewrite the sum for I into an integral, because if in Eq. (B8) we substitute e<sup>n z</sup> for f (n) and N + 1 forn , the correction to the integral is negligible for > 1 in the large N limit. The integral is approximately N<sup>1</sup> e<sup>N</sup> = z, this is then the sought asymptote for I. In conclusion,

We can summarize the above results for various s such that if the summand in I decays slow ly, one can replace the sum by an integral, and if it decays fast then the sum asymptotically equals its rst term.

### APPENDIX E:ON THE FTG LIM ITS

Below we derive Eq. (28) from (26). We shall replace the lower lim it of integration 1 by  $n_0$  to show irrelevance of the precise setting of the lower lim it. Denoting the integralin (26) by I and changing the integration variable to  $v = n \ z \ we \ get$

W hen z d=e, the argument of the erfc becomes a large negative number, where the erfc is approximately 2. Thus, including the prefactor before I in (26), we recover (28).

We have here an opportunity to test whether the sum in (26) was justly rewritten into an integral. We do not have rigorous results, but we know that the integralm ust not be smaller than a single sum m and term, if it is, the integral representation cannot be accepted. A characteristic sum m and term now is  $e^{n z} e^{v}$ , where  $v = (d \quad 1)=$  is the saddle point in E1), so the summ and term is small. Since we consider zs for which the full integral for  $\ln M$  is of O(1), the integral is indeed m uch larger then a single characteristic summ and term  $e^{v}$ . This is a generic test that the integral representation of a sum should pass, and we perform ed it in all pertinent cases in the paper.

# APPENDIX F:SMALL-ZASYMPTOTE OF THE ROUGHNESS DISTRIBUTION

# 1. One dim ension, > 1

W e derive here the sm all-x asym ptote of the PDF of the roughness for the G aussian model of 1=f noise with periodic boundary condition. We consider the case > 1, when all cum ulants of the roughness are of the sam e order. In the case of the W iener process, = 2, the PDF has a nonanalytic asym ptote, which has been calculated in Ref. [31]. Here we nd that nonanalyticity prevails for all > 1. We begin with the sim plest form, free of norm alizing constants, of the generating function [34]


