One and Two-Electron Spectral Function Expressions in the Vicinity of the Upper-Hubbard Bands Lower Limit

A bstract. In this paper we derive general expressions for few-electron spectral functions of the one-dimensional Hubbard model for values of the excitation energy in the vicinity of the Mth upper-Hubbard band lower limit. Here M = 1;2;::: is the rotated-electron double occupation, which vanishes for the ground state and is a good quantum number for all values of the on-site C oulom b repulsion U. Our studies rely on a combination of symmetries of the model with a recent nite-energy holon and spinon description of the quantum problem. We apply our general scheme to the one-electron addition spectral function, dynam ical structure factor, and spin singlet C ooper pair addition spectral function. Our results provide physically interesting inform ation about the nite-energy spectral properties of the many-electron one-dimensional quantum liquid.

1. IN TRODUCTION

Recent experimental studies of quasi-one-dimensional (1D) materials observed unusual nite-energy/frequency spectral properties, which are far from being well understood [1, 2, 3, 4, 5]. Several of these experimental studies reveal the occurrence of charge-spin separation in terms of independent holon and spinon excitation modes [2, 4, 5, 6, 7, 8, 9, 10]. For values of the excitation energy larger than the transfer integrals associated with electron hopping between the chains, the 1D Hubbard model [11] is expected to provide a good description of the physics of these materials [4, 5]. Unfortunately, an accurate determination of the spectral properties for nite values of the excitation energy and of the C oulomb repulsion is until now still lacking. M ost accurate results correspond to the limit of in nite on-site C oulomb repulsion [12] where the B ethe-ansatz [11] wave function is easier to handle, yet the solution of the problem remains complex in this limit.

In this paper we combine the holon, spinon, and pseudoparticle accurate description recently introduced and studied in Refs. [6, 7] and the pseudoferm ion representation very recently introduced in Ref. [8] with symmetries of the 1D Hubbard model to derive general expressions for few -electron spectral functions in the vicinity of the lower lim it of the upper Hubbard bands. For nite values of the excitation energy and on-site repulsion U there are not m any previous studies of few electron spectral function w eight distributions. The interesting studies of the one-electron spectral functions presented in Ref. [12] refer to the limit of in nite U. There are num erical studies of these functions 4t [13]. Moreover, the weight distribution of the real part of the frequency for U dependent optical conductivity in the vicinity of the optical pseudogap was previously studied in Refs. [14, 15]. The very recent results presented in Ref. [10] refer to the oneelectron spectral-function weight-distribution in the vicinity of singular branch lines. Some of these lines cross the upper-Hubbard band lower-lim it points considered in this paper. However, our results are complementary of those presented in Ref. [10], which were obtained by use of the method of Ref. [16]. Indeed, our weight-distribution expressions are valid when one approaches these points along all nite weight directions except those corresponding to the above-mention singular branch lines. The values of the critical exponents which control the weight distribution are di erent for these lines and for all the remaining directions of the (k; !)-plane considered here.

We evaluate expressions for the critical exponents that control the weight distribution of few-electron spectral functions for excitation energies corresponding to the vicinity of the Mth upper Hubbard band lower-limit points. (The method used in this paper is dimension that of Ref. [16], which was used in Ref. [10] in the study of the weight distribution in the vicinity of the singular branch lines.) Our studies rely on a symmetry which is specific for the model when defined in the reduced Hilbert subspace associated with the (k; !)-plane region in the vicinity of the above lower-limit points. Few-electron spectral functions can include several upper Hubbard bands, the Mth band being spanned by excited states of rotated electron double occupation M > 0.

The lower Hubbard band corresponds to the spectral-weight distribution generated by excited states of rotated-electron double occupation M = 0. For one-electron and two-electron spectral functions only the rst few upper bands have a signi cant am ount of spectral weight [16]. A lthough our general expressions refer to the lower-lim it points of all upper H ubbard bands, we apply our method only to the study of weight distributions corresponding to upper bands with a signi cant am ount of spectral weight. For the one-electron addition spectral function and dynam ical structure factor (and the spin singlet C coper pair addition spectral function) only the M = 1 rst Hubbard band has (and both the M = 1 rst and M = 2 second upper Hubbard bands have) a signi cant am ount of weight.

Our motivation in studying the nite-energy one-electron spectral function is that our method provides the exponents of the singular spectral features beyond the branch lines considered in Ref. [10]. The latter lines are observed in quasi-1D materials [9, 10]. Thus, the study of other nite-energy singular spectral features is of interest for the further understanding of the unusual spectral properties observed in these materials. Both for the dynam ical structure factor and other spectral functions we do not consider the low-energy features because those can be investigated by standard two-component conform al- eld theory. Our aim in studying the Cooper-pair spectral function is to clarify whether there are singular spectral features at the upper-H ubbard bands lower lim it. Indeed, in the lim it of small on-site repulsion and for electronic densities very close to one, such singular features would appear at low energy and could lead to a superconductivity instability in a system of weakly coupled H ubbard chains, as further discussed in later sections.

The paper is organized as follows: In Sec. II we sum marize the 1D Hubbard model. In Sec. III we introduce the holon-spinon H am iltonian and study the 1D Hubbard model spectrum in the vicinity of the lower limit of the upper Hubbard bands. In Sec. IV we use the holon and spinon conservation laws and other symmetries of the model in the evaluation of general expressions for few-electron spectral functions. Moreover, we apply ourm ethod to the study of the one-electron addition spectral function, dynam ical structure factor, and singlet Cooper pair addition spectral function. Finally, Sec. V contains the concluding remarks.

2. THE 1D HUBBARD MODEL

In a chemical potential and magnetic eld H the 1D Hubbard Hamiltonian can be written as,

where $c_{j;}^{y}$ and $c_{j;}$ are the spin electron creation and annihilation operators at site j, respectively. The operator $\hat{n}_{j;} = c_{j;}^{y}$ c_j, counts the number of spin electrons at real-space lattice site $j = 1; ...; N_{a}$. The number of lattice sites N_{a} is even and large and $N_{a}=2$ is odd. We consider periodic boundary conditions. Moreover, $_{c}=2$, $_{s}=2_{0}H$, $_{0}$ is the Bohr magneton, and $\hat{S}_{z}^{c} = (1=2) N_{a} \hat{N}$ and $\hat{S}_{z}^{s} = (1=2) \hat{N}_{*} \hat{N}_{*}$ are the diagonal generators of the -spin and spin SU (2) algebras [17], respectively. The operators $\hat{N} = {}^{P} \hat{N}$ and $\hat{N} = {}^{P} \hat{n}_{j;}$ count the number of electrons and spin electrons, respectively. The H am iltonian \hat{H}_{SO} (4) de ned in Eq. (1) commutes with the six generators of the -spin and spin algebras [17]. The Bethe-ansatz solvability of the 1D Hubbard model is restricted to the H ilbert subspace spanned by the lowest-weight states (LW Ss) of the spin and spin algebras, i.e. such that $S = S_{z}$ [6] for = c and = s, respectively. Here S_{c} (and S_{s}) denotes the -spin (and spin) value. The momentum operator reads,

where the spin momentum distribution operator is given by $\hat{N}(k) = c_{k_1}^y c_{k_2}$, and the operator $c_{k_1}^y$ (and c_{k_1}) creates (and annihilates) a spin electron at momentum k. The momentum operator (2) commutes with the Hamiltonians of Eq. (1).

There are N $_{\rm H}$ spin-up electrons and N $_{\rm H}$ spin-down electrons in the chain of N $_{\rm A}$ sites, lattice constant a, and length $L = [N_a a]$ associated with the model (1). Throughout this paper we use units of Planck constant one and of lattice spacing a = 1 and denote the electronic charge by e. The Fermi momenta read $k_{\rm F}$ = n and $k_F = [k_{F'} + k_{F'}] = 2 = n = 2$, where $n = N = N_a$ and $n = N = N_a$. The electronic density can be written as $n = n_* + n_{\#}$ and the spin density is given by $m = n_* - n_{\#}$. In general we consider electronic densities n and spin densities m in the domains 0 n 1 and n, respectively. Our general correlation-function expressions are derived for the 0 m m etallic phase of electronic densities 0 < n < 1 and spin densities 0 < m < n. However, taking the limit n! 1 in some of these expressions leads to correct expressions for the n = 1 M ott-Hubbard insulator phase. Also the m = 0 spectral function expressions can in general be obtained by taking the limit m ! 0 in our general expressions. In our applications to the study of specic spectral functions we consider such m = 0expressions only.

The concept of rotated electron [6, 7, 8] is associated with a unitary transform ation introduced in Ref. [18]. For such rotated electrons, double occupation is a good quantum number for all values of the on-site C oulombian repulsion U. The electrons that occur in the 1D Hubbard model (1) are dened by $c_{j;}^{y}$, while the rotated electron operator $e_{j;}^{y}$ is given by, $e_{j;}^{y} = \hat{V}^{y}$ (U=t) $c_{j;}^{y}$, \hat{V} (U=t), where \hat{V} (U=t) is the electron – rotated-electron unitary operator dened by Eqs. (10)–(12) of Ref. [8]. As a result of the H ilbert-space electron – rotated-electron unitary rotation, all energy eigenstates of the model are described in terms of occupancy con gurations of $s_c = 1=2$ and $_c = 1=2$ holons, $s_s = 1=2$ and $_s = 1=2$ spinons, and c pseudoparticles [6]. Here we denoted the

-spin and spin projections of the quantum objects by c and s, respectively, whereas their -spin and spin values are denoted by s_c and s_s , respectively. In this paper we call the holons and spinons according to their values of $_{c}$ = 1=2 and $_{s}$ = 1=2, respectively. We denote by M ; $_{1=2}$ the number of 1=2 holons (= c) or 1=2 spinons (= s). The value of the number of rotated-electron doubly occupied and unoccupied sites (and spin-down and spin-up rotated-electron singly occupied sites) equals that of the holon numbers M $_{c: 1=2}$ and M $_{c:+1=2}$ (and spinon numbers M $_{s: 1=2}$ and $M_{s;+1=2}$), respectively. Thus, rotated-electron double occupation M is such that M = M $_{c; 1=2}$. Moreover, M = M $_{;+1=2}$ + M $_{; 1=2}$ and N $_{c}$ = M $_{s}$, where N $_{c}$ is the number of c pseudoparticles. The 1=2 holons and c pseudoparticles carry charge 2e and e, respectively, whereas the spinons have no charge degrees of freedom. The c pseudoparticles (and s pseudoparticles) associated with Takahasi's charge (and spin) ideal string excitations of length [11,6] are -spin singlet 2 -holon (and spin singlet 2 spinon) composite quantum objects [6, 7, 8]. The 1=2 holons (and 1=2 spinons) which are not part of such 2 -holon composite c pseudoparticles (and 2 -spinon composite s pseudoparticles) are called 1=2 Yang holons (and 1=2 HL spinons) [6]. In the designations HL spinon and Yang holon, HL stands for Heilm ann and Lieb and Yang refers to C.N.Yang, respectively, who are the authors of the papers of Ref. [17]. W e denote by N the number of composite pseudoparticles belonging to branches = c; s and = 1;2; \therefore W e call L; $_{1=2}$ the number of 1=2 Y and holons (= c) or 1=2 HL spinons (= s). Note that M ; $_{1=2} = L$; $_{1=2} + P_{1=1}^{P}$ N

Below we are mostly interested in excited states without HL spinons and s > 1. Therefore, for simplicity often we replace the pseudoparticles such that pæudoparticle branch index s1 by s. Thus, throughout this paper the notations s1 and s are equivalent. For the subspaces spanned by the ground state and excited states generated from it by a nite number of pseudoparticle and/or Y ang holon processes, the c, s, and cl pseudoparticles carry band momentum q such that jqj $q_{c}^{0} =$ jqj $q_s^0 = k_F$, and jqj $q_{c1}^0 = [2k_F]$, respectively. This refers to electronic densities 0 < n < 1 and spin density m = 0. For these densities the ground state is such that there are no 1=2 Y and holons, the cl and s preudoparticle bands are empty and lled, respectively, and the c pseudoparticles occupy 0 $q_{F_{C}}^{0} = 2k_{F}$ and thus jqj empty [6, 7]. Following the notation of Ref. [7], we call an electron leave $2k_{\rm F} < jqj$ ensem ble space a Hilbert subspace spanned by all states with xed values for the N . and N # electron num bers. Furtherm ore, we calla CPHS ensem ble space, where CPHS stands for c pseudoparticle, 1=2 holon, and 1=2 spinon, a Hilbert subspace spanned by all states with xed values for the numbers N $_{c}$, M $_{c}$; $_{1=2}$, and M $_{s}$; $_{1=2}$. A CPHS ensemble subspace is a Hilbert subspace spanned by all states with xed values for the num bers N $_{\rm c}$, L $_{\rm c; 1=2}$, and L $_{\rm s; 1=2}$ and for the sets of num bers fN $_{\rm c}$ g and fN $_{\rm s}$ g corresponding to = 1;2; ::: branches. W e note that one does not need to provide the values of $M_{c;+1=2}$ and M $_{s;+1=2}$ in order to specify a CPHS ensemble space, since these numbers are not independent [7]. Also the numbers $L_{c;+1=2}$ and $L_{s;+1=2}$ are not independent and one does not need to provide these values in order to specify a CPHS ensemble subspace.

One and Two-Electron Spectral Function Expressions...

Finally, let us introduce the useful quantum number = sgn(q)1 = 1 which refers to the number of right pseudoparticle m overs (= +1) and left pseudoparticle m overs (= 1). The numbers N_c; of c pseudoparticles and N ; of pseudoparticles of character are good quantum numbers. We thus introduce the c pseudoparticle and pseudoparticle current numbers,

The numbers N $_{\rm c};\,$ and N $\,$; can be expressed as N $_{\rm c};\,$ = N $_{\rm c}{=}2$ + $\,$ J and N $\,;\,$ = N $\,$ =2 + $\,$ J $\,.\,$

Each CPHS ensemble Hilbert subspace characterized by xed values for the sets of numbers N_c , fN g such that = c;s and = 1;2;3; ..., and fL; $_{1=2}$ g such that = c;s contains di erent subspaces with di erent values for the sets of current numbers J_c and fJ g such that = c;s and = 1;2; A coording to the notation of Ref. [8], we call these subspaces J-CPHS ensemble subspaces.

3. THE HOLON -SPINON HAM ILTONIAN AND THE UPPER HUBBARD BANDS LOW ER LIM IT SPECTRUM

The correlation function expressions are determ ined by transitions from the ground state to excited states. Let us consider that the initial ground state belongs to a canonical ensemble space associated with densities such that 0 < n < 1 and 0 < m < n. O frem we consider such ground states. In the application of our results to the evaluation of speci c spectral function expressions we are mostly interested in m = 0 initial ground states. Fortunately, we are able to derive the corresponding m = 0 expressions from the general correlation functions expressions obtained for 0 < m < n. Let us introduce the H am iltonians \hat{H}_{GL} and \hat{H}_{HS} such that,

Here \hat{H} is the 1D Hubbard model (1), \hat{H}_{HS} is the holon-spinon Ham iltonian, and in \hat{H}_{GL} the letters GL stand for gapless. Indeed, the energy spectrum of the Ham iltonian \hat{H}_{GL} of Eq. (4) is gapless. Moreover, \hat{M}_{12} is the 1=2 holon (= c) and 1=2 spinon (= s) number operator given in Eqs. (24) and (25) of Ref. [8], \hat{N}_{S} is the s pseudoparticle num ber operator, and $\frac{0}{s}$ (q) is the s pseudoparticle energy band de ned in Refs. [6, 7, 8]. Form ! 0 and > 1 this energy band is such that $\frac{0}{s}$ (q) = 0.

Since the numbers of 1=2 holons, 1=2 spinons, and s pseudoparticles are good quantum numbers, the three H am iltonians of Eq. (4) commute with each other. Thus, these H am iltonians have the same energy eigenstates, only the corresponding energy eigenvalues being in general di erent. Let us consider an energy-E eigenstate of the

1D Hubbard model. Such a state is also an energy eigenstate of the holon-spinon H am iltonian \hat{H}_{HS} whose energy eigenvalue $!_{HS}$ reads,

It is also an energy eigenstate of the H am iltonian \hat{H}_{GL} of Eq. (4) of eigenvalue $E_{GL} = [E_{HS}]$. A nalysis of the nite-size corrections of the energy $E_{GL} = [E_{GL} E_{GS}] = 0$ of all low energy states of the H am iltonian \hat{H}_{GL} reveals that the ground state of the 1D H ubbard m odel is also the state of m inim alenergy $E_{GL} = [E_{GL} E_{GS}] = 0$ for such a H am iltonian. Indeed, for all canonical ensem ble spaces the latter H am iltonian and the 1D H ubbard m odel (1) have the same ground state. The general spectrum of interest for the problem of the few-electron spectral functions of the 1D H ubbard m odel for excitation energies $! = [E_{GS}] = !_{HS} + E_{GL}$ such that $E_{GL} = [E_{GL} E_{GS}]$ is small can be written as the sum of the nite energy $!_{HS}$ plus the gapless contribution E_{GL} expressed in terms of the pseudoparticle energy bands [7, 8]. This gapless contribution is the excitation energy of the same states relative to the H am iltonian \hat{H}_{GL} of Eq. (4).

The ground-state norm al-ordered expression of an operator \hat{O} is defined as : \hat{O} : \hat{O} hGS j \hat{O} jGS i, where jGS i is the ground state. Let jext be any excited state. The corresponding deviation O is defined as O hexj \hat{O} jext hGS j \hat{O} jGS i. From now on we will deal mostly with the two H am iltonians (1) and \hat{H}_{GL} of Eq. (4) while acting in the reduced H ilbert subspaces spanned by excited states with small excitation energy E _{GL} for the H am iltonian \hat{H}_{GL} . Thus, it is useful to introduce the ground-state norm al-ordered H am iltonians : \hat{H}_{GL} : and : \hat{H} : such that,

where \hat{H} is the 1D Hubbard model (1). (Note that since the energy eigenvalue $!_{HS}$ (5) of the holon-spinon H am iltonian \hat{H}_{HS} vanishes for the ground state, its ground-state norm allordered expression is such that $:\hat{H}_{HS} := \hat{H}_{HS}$.) While the H am iltonian $:\hat{H}_{GL}$: of Eq. (6) describes the gapless part of the excitations, the holon-spinon H am iltonian $:\hat{H}_{HS}$ of Eqs. (4) and (6) controls the nite-energy physics. Creation of a 1=2 holon requires a m inim al am ount of excitation energy 2. Creation of a 1=2 spinon (except those which are part of s1 pseudoparticles) requires a m inim al am ount of excitation energy 2 $_{0}$ H. Creation of a s pseudoparticle of bare-m om entum q and belonging to a > 1 branch involves creation of a 1=2 spinons and is associated with an energy given by 2 $_{0}$ H + $_{S}^{0}$ (q). Creation of a c pseudoparticle of bare-m om entum q involves creation of 1=2 holons and requires an am ount of energy 2 $_{+}^{0}$ (q). (The pseudoparticle energy bands $_{S}^{0}$ (q) and $_{0}^{0}$ (q) are studied in Refs. [6, 7].)

A lthough our expressions refer to general values of spin density m such that 0 < m < n, in the case of applications to few electron spectral functions we are most interested in zero-m agnetization. Thus, for simplicity we consider excited states without

1=2 HL spinons and without s pseudoparticles belonging to > 1 branches. We emphasize that nite-energy states with nite occupancies for these quantum objects

play an important role only for nite values of the spin density. One arrives to the same nalm = 0 expressions from our general 0 < m < n scheme regardless we consider excited states with or without 1=2 HL spinons and s pseudoparticles belonging to > 1 branches.

For m ! 0 initial ground states only excited states with nite 1=2 holon occupancies have a gapped energy spectrum. These states have a minimal nite excitation energy given by,

Here the energy $E_u = 2$ is defined by Eq. (107) of Ref. [8]. In the limit m ! = 0and for 0 = n = 1 it is an increasing function of the on-site repulsion U such that $E_u = 4t\cos(n=2)$ for U=t ! = 0 and $E_u = U + 4t\cos(n)$ for U=t ! = 1. For any value of U=t it is a decreasing function of the electronic density n such that $E_u = U + 4tasn ! = 0$ and E_u approaches the value of the M ott-H ubbard gap E_{MH} as n ! = 1. For values of rotated-electron double occupation M such that M > 0, the energy $!_{HS} = M E_u$ of Eq. (7) is nite and corresponds to the lower limit of the M th upper H ubbard band.

Transitions from a ground state to excited states belonging to a given J-CPHS ensemble subspace can be labelled by the set of deviation numbers and deviation current numbers f N g, f J g, f N $_{c}$ g = fN $_{c}$ g, f J $_{c}$ g = fJ $_{c}$ g, and f L $_{c; 1=2}$ g = $fL_{c: 1=2}$ g where = c; s and = 1; 2; Since there are no c pseudoparticles and 1=2 Yang holons in the ground state, below we replace the deviations N $_{\rm c}$, J $_{\rm c}$, and L $_{\rm c;\ 1=2}$ by the corresponding number and current number values N $_{\rm c}$, J $_{\rm c}$, and L_{c; 1=2}, respectively. All states belonging to the sam e J-CPHS ensemble subspace have the same number of 1=2 holons and thus the same energy eigenvalue $!_{HS} = M E_{u}$ relative to the holon-spinon Ham iltonian \hat{H}_{HS} of Eq. (4). We are mostly interested in the reduced J-CPHS ensemble subspaces. Such subspaces are the part of the general J-CPHS ensemble subspaces which is spanned by states of excitation energy ! (relative to the 1D Hubbard model) such that $E_{GL} = (! M E_u)$ is small. Transitions from a ground state to these states correspond to transitions to the lower lim it of the M th upper Hubbard band. Importantly, the c pseudoparticle creation processes which generate the M_{c; 1=2} = M = 1;2; ... excited states of vanishing energy E_{GL} 0 and M > 0 excitation energy E = ! M E _u for the 1D H ubbard m odel involve c pseudoparticles $q_0^c = [$ $2k_{\rm F}$] only. In addition, these states can of bare-momentum value q involve 1=2 Yang holons creation and low-energy c and s pseudoparticle creation and/or annihilation and particle hole pseudoparticle processes in the vicinity of the corresponding c and s pseudoparticle Ferm i points. M oreover, since we are considering nal states with no 1=2 HL spinons and no s pseudoparticles belonging to > 1 branches, the number deviations and numbers N $_{\rm c}$, N $_{\rm s}$, L $_{\rm c;~1=2}$, and fN $_{\rm c}$ g where = 1;2;::: obey the sum rules (51) and (52) of Ref. [7] with $L_{s; 1=2} = 0$ and N $_{\rm s}$ = 0 for > 1 (In that reference N $_{\rm s}$ is denoted by N $_{\rm s}$; .)

W hen de ned in a reduced J-CPHS ensemble subspace, the momentum operator

The momentum values k_{M}^{1} de ned in Eq. (10) play the same role for the J-CPHS ensemble subspaces as the energies $!_{HS} = M E_{u}$ for the CPHS ensemble spaces. While the straight horizontal line (k; ! = M E_u) de nes the lower limit of the Mth upper Hubbard band, the points (k = k_{M}^{1} ; ! = M E_u) of the same line de ne the edges of the Mth upper Hubbard band, as further discussed in Sec. IV.W e call H_{red} the reduced J-CPHS ensemble subspaces spanned by states of momentum k and excitation energy ! such that (k k_{M}^{1}) and (! M E_u) are small. These subspaces are characterized both by speci c values for the set of deviation numbers and numbers f N g, fN_c g, f J g, fJ_c g, and $fL_{c; 1=2}$ g where = c; s and = 1; 2; ... and by sm all values for (k k_M^{\perp}) and (! M E_u).

It is useful for our studies to nd the speci c form of the general energy spectrum E_{GL} of the Ham iltonian : \hat{H}_{GL} : of Eq. (6) for the excited states which span a reduced subspace H_{red} . That energy spectrum can be expressed in terms of a phase-shift momentum functional associated with pseudoferm ions introduced in Ref. [8]. A coording to the results of that reference, there is a canonical transform ation that maps

pseudoparticles and c pseudoparticles onto pseudoferm ions and c pseudoferm ions, respectively. While the pseudoparticles and c pseudoparticles carry bare-momentum q, the pseudoferm ions carry momentum q = q + Q (q)=N_a and the c pseudoferm ions carry momentum $q = q + Q_c$ (q)=N_a. The functionals Q (q) and Q_c (q) are de ned in Eq. (73) of Ref. [8]. A fler some algebra one nds that for the above states E _{GL} has the following leading-order 1=N_a nite-size energy terms,

A property with a deep physical meaning is that the nite-size energy spectrum of the c pseudoparticles vanishes as the limit $q ! d_{e}^{0} = [2k_{F}]$ is approached. In that limit the c pseudoparticles become localized and non-interacting objects, as found in Ref. [7] and discussed in Appendix A. In contrast, creation of c pseudoparticles at other bare-momentum values leads to nite-size c energy corrections and to values of excitation energy ! such that $E_{GL} = (! M E_{u})$ is nite. In that case the niteenergy problem cannot be mapped onto a low-energy conform al- eld theory and our method does not apply. Behind this vanishing of the nite-size c energy spectrum there is a symmetry which in poses that the -1=2 Yang holon and c pseudoparticle

energy and momentum spectra become the same as q! [$2k_{\rm F}$] for one of the 2k_F] or + [$2k_{\rm F}$]. Creation of 1=2 Yang holons bare-momentum values [contributes to the 1D Hubbard model energy spectrum $! = !_{HS} + E_{GL}$ through the nite-energy term $!_{HS} = M E_u$ of Eq. (7) by an energy amount E_u , but does not lead to any contribution to the gapless spectrum E_{GL} (13) and thus to the value of the functional (15). Therefore, an excitation involving c and s pseudoparticle processes 1=2 Yang holons leads to an energy spectrum of the form (13), and creation of is given by (15) with J_c $P_1 = J_c$ replaced by J_c . Except whose functional 2 for this di erence, the c pseudoparticle and - 1=2 holon contributions to the energy spectrum $! = !_{HS} + E_{GL}$ and functional (15) are the same. However, the role of the c pseudoparticle current number deviation shift $P_{1}^{P_{1}} J_{c}$ is to introduce a counter term whose presence assures that two M > 0 nite-energy excited states with the same c and s pseudoparticle occupancies and either one c pseudoparticle such that = M or MYang holons, respectively, have the sam e m om entum _ and energy spectrum . The sam e holds for general M > 0 excited states such that $M = {P \choose 1} N_c + L_{c; 1=2}$. For simplicity, let us consider that M = 1. In this case the current $\int_{-1}^{P} \int_{0}^{1} reads J_{c1} = 1=2$ and zero for creation of a c1 pseudoparticle and a 1=2 Y ang holon, respectively. A coording to Eq. (12), for states with the same c and s pseudoparticle number deviations the value of the c current number deviation J c for the one-cl pseudoparticle states di ers from the corresponding number of the one- 1=2 Y and holon states by 1=2. Thus, for one of the two possible values of opposite sign of the current number $J_{cl} = 1=2$ such di erence is precisely cancelled. For that one-cl pseudoparticle state the current number J_c J_{c1} equals the current number J_c of the one- 1=2 Y and holon state.

4. SPECTRAL FUNCTION EXPRESSIONS IN THE VIC IN ITY OF THE UPPER-HUBBARD BANDS LOW ER LIM ITS

In this section we derive general nite-energy expressions for few-electron spectral functions for excitation energy and m om entum values in the vicinity of upper-H ubbard bands lower lim its. M oreover, we apply these general expressions to the study of speci c one-electron and two-electron functions.

4.1. THE GENERAL FINITE-ENERGY SPECTRAL FUNCTION EXPRESSIONS

Although for M $E_u > 0$ the energy spectrum $! = M E_u + E_{GL}$ of the the 1D Hubbard-model in the reduced subspace H_{red} refers to a nite-energy problem, the functionals 2 $_{c}$ and 2 $_{s}$ appearing in Eq. (13) equal the c and s primary-eld dimensions of a low-energy two-component conformal-eld theory [19, 20]. We note that the momentum spectrum (11) can be expressed in terms of these functionals as $P_{GL} = \frac{2}{N_a} P_{=c;s} P_{=1} [+ N_{;}^{ph}]$. Furthermore, manipulation on the integral equations that de ne the phase shifts of the 1; 0 and 0; 0 expressions given in Eq. (A 2) of Appendix B, reveals that those are entries of known matrices. The two

corresponding m atrices are the transpose of the dressed charge m atrix and the inverse of the transpose of the dressed charge m atrix, respectively, of the low-energy 1D Hubbard m odel conform al eld theory [19, 20]. This property allows the evaluation of the 1D Hubbard-m odel few-electron spectral function expressions for m om entum k and excitation energy ! such that both (k k_{M}^{1}) and (! M E_{u}) are sm all. For M $E_{u} > 0$ such a 1D Hubbard m odel nite-energy problem cannot be solved by standard low-energy conform al eld theory.

Let $\hat{f}_{\#}(x;t)$ (and $\hat{f}_{\#}^{GL}(x;t)$) represent an one-electron or two-electron physical eld and # = 1p; ; ss refer for example to one-electron, charge, and singlet superconductivity, respectively. The time evolution of $\hat{f}_{\#}(x;t)$ (and $\hat{f}_{\#}^{GL}(x;t)$) is described by the 1D Hubbard Ham iltonian : \hat{H} : (and Ham iltonian : \hat{H}_{GL} : of Eq. (6)). The space translations are described by the momentum operator : \hat{P} : of Eq. (8) (and : \hat{P}_{GL} : of Eq. (9)). The asymptotic expression for the low-energy correlation function of the physical eld $\hat{f}_{\#}^{GL}(x;t)$ can be obtained by use of conform al- eld theory. Such an expression, com bined with the relation between the three Ham iltonians of Eq. (6) and their symmetries, is used in Appendix B to show that the leading term in the asymptotic expansion of the corresponding nite-energy correlation function of the 1D Hubbard m odel is of the follow ing form,

In order to derive the expressions of the few-electron spectral functions one needs the imaginary part of the correlation functions in the k and ! plane. Let $_{\#}(k; !)$ be the Fourier transform of the function $_{\#}(x; t)$ given in Eq. (16). The $_{\#}(k; !)$ expression is controlled by the same universal exponent when one approaches the point $(k = k_{M}^{1}; ! = M E_{u})$ from all directions $(k ! k_{M}^{1}; ! ! M E_{u})$ in the nite spectralweight region corresponding to the reduced subspace H red, except for the four lines such that (! M E_u) v $(k k_{M}^{1})$. (Two lines for each = c; s pseudoparticle branch { in some cases only two of these four lines are inside the nite spectral-weight region.) These lines are associated with the slope at the point $(k = k_{M}^{1}; ! = M E_{u})$ of the general branch lines studied for few-electron spectral functions in R efs. [10, 16]. In the vicinity of these lines the ! dependence of the weight distribution is also in general of power-law type but is controlled by exponents di erent from that given below. Thus, our studies are complementary to those of Refs. [10, 16]. For simplicity, we consider that the critical point is approached through the line dened by $k = k_M^1$ and $! ! M E_u$. In this case we not the following expressions for $_{\#}(k; !)$,

and the functional 2 is given in Eq. (15). Expression (17) corresponds to the leading term of an expansion in the small energy (! $M E_u$). The exponent $_{\#}$ is a rapidly increasing function of the number of excited pseudoparticles. The non-interacting character of the 1=2 Yang holons and $q = q_c^0$ c pseudoparticles justi as that for m ! 0 the U=t and n dependence of the exponent (19) occurs through the parameter K of Ref. [22] only, as con med by the exponent expressions found below. (This is not in general true for the branch-line exponents of Refs. [10, 16], whose expressions involve the momentum -dependent phase shifts de ned in Ref. [8].) Importantly, when for one-electron (and two-electron) correlation functions the exponent $_{\#}$ tends to 1 (and 2) as U=t ! 0 or U=t ! 1, expression (17) is not valid. In this lim it the correlation-function expression is such that,

For simplicity, the general expression (17) refers to the vertical line corresponding to to $k = k_{M}^{1}$ and small values of (! M E_{u}), yet the exponent (19) controls the weight distribution for all other lines crossing the point ($k = k_{M}^{1}$; ! = M E_{u}) except for the branch lines. Thus, although in our applications to the one-electron addition spectral function, dynam ical structure factor, and singlet C cooper pair addition spectral function we use the $k = k_{M}^{1}$ expression (17), we emphasize that sim ilar expressions apply to the weight distribution associated with momentum values k and excitation energy ! such that ($k = k_{M}^{1}$) and (! M E_{u}) are small.

Except in particular lim its of parameter space, our present method does not provide the values of the constants that multiply the weight-distribution power-law expressions. This justimes the use of the proportionally symbol / in the general expression (17). Fortunately, there is a relation between the value of the critical exponents that control the weight distributions in the vicinity of the di erent upper Hubbard band lower-lim it points and the relative value of the corresponding power-law multiplicative constants. In general, the smallest is the critical exponent, the largest is the value of the corresponding multiplicative constant. Such a relation is con med by analysis of the results obtained for U=t ! 1 by the method of Ref. [12]. The nite-U=t numerical results of Ref. [13] and the smallU=t results of Ref. [15] also con m that relation. M oreover, offen the form of the weight distributions at U=t= 0 also provides an useful boundary condition. Thus, our considerations for nite values of U=t concerning the relative amount of spectral weight located in the vicinity of the di erent upper Hubbard band lower-lim it points result from comparison with the known limiting results, including those given in the above references.

For M $E_u = 0$ our correlation-function expressions reduce to the well known conform al-eld general expressions [19]. However, for M $E_u > 0$ our expressions provide new useful information about the nite-energy spectral properties of the 1D Hubbard model.

4.2. INTRODUCTION TO THE FEW ELECTRON FINITE-ENERGY PROBLEM

All our applications refer to positive excitation energy !. In this case the general correlation function $_{\#}(k; !)$ can be written in terms of a Lehmann representation as follows,

In our applications of the general spectral-function expressions we consider the following operators $\hat{O}_{\#}(k)$: The spin-up one-electron addition operator, the charge operator, and the singlet-superconductivity Cooper-pair addition operator,



We consider the case of ground states of spin density m ! 0. In this case the energy $!_{HS} = M E u$ given in Eq. (7) de nes the lower lim it of the Mth upper Hubbard band.

Often the momentum values k_{M}^{1} given in Eq. (10) and associated with the M th upper Hubbard band are such that $k_{M}^{1} = [1k_{0}]$ where k_{0} is a spectral-function dependent momentum. In our applications we consider Hubbard bands generated by dominant processes only. According to the results of Ref. [16], for the spin-up one-electron addition operator $\hat{O}_{1p}(k) = c_{k,"}^{v}$ and charge operator $\hat{O}_{1p}(k) = c_{k,"}^{v} c_{k+k^{0}}^{v}$ (and singlet-superconductivity operator $\hat{O}_{ss}(k) = \sum_{k=0}^{P} c_{k}^{y} c_{k}^{y} c_{k}^{y}$) m ore than 99% of the spectral weight corresponds to excited states such that M $_{c; 1=2} = M = 0; 1$ (and $M_{c; 1=2} = M = 0; 1; 2$). States with $M_{c; 1=2} = M > 1$ (and $M_{c; 1=2} = M > 2$) lead to nearly no spectral weight and are om itted below. For electron addition and the dynam ical structure factor we study the weight distribution for dom ains of the (k; !)plane corresponding to small values of $(k \quad k_1^1)$ and $(! \quad E_u)$ just above the lower limit. of the st upper Hubbard band. For the regions corresponding to other momentum values and small energy (! E_{u}) these spectral functions vanish because there is no spectral weight. In the case of the singlet Cooper pair spectral function we study the weight distribution both for dom ains of the (k; !)-plane corresponding to sm all values of $(k \quad k_1^1)$ and $(! \quad E_u)$ just above the lower lim it of the rst upper H ubbard band and $(k k_2^1)$ and (! $2E_u$) just above the lower lim it of the second upper Hubbard band.

>From analysis of the energy spectrum of the excited states generated by dom inant processes, one nds that the Mth Hubbard band nite-spectral-weight region of the (k; !)-plane whose lower limit is located at the line $! = M E_u$ is for all values of k separated from the next lower-limit line $! = [M + 1]E_u$ of the $[M + 1]^{h}$ Hubbard band by a region with nearly no spectral weight. The latter region of the (k; !)-plane is out of the range of the excitations generated by dom inant processes. This holds for all few-electron spectral functions and is illustrated in Fig. 1 for the speci c case of the one-electron spectral function. For on-site repulsion U = 4t, electronic density n = 1=2, and spin density m = 0 the regions of the (k; !)-plane whose spectral weight is generated by dominant processes are shown in the gure by shaded areas. The dom inant processes also include pseudoparticle particle hole processes which lead to spectral weight both inside and outside but in the close vicinity of the shaded dom ains of Fig. 1. In that gure an extended momentum scheme centered at momentum k = 0(and k = 0) is used for electron removal and the M = 0 lower Hubbard band (and M = 1 rst upper H ubbard band). The one-electron addition upper and lower H ubbard band spectral functions correspond to values of excitation energy such that $! > E_u$ and ! > 0, respectively. Note that for all values of k there is indeed a region with nearly no spectral weight located between the nite-weight regions corresponding to the M = 0and M = 1 Hubbard bands. In the gure the one-electron rem oval spectral function corresponds to ! < 0. The gure shows the locations (k = lk_F ; ! = E_u) for the four l = 1; 3 upper Hubbard band lower-limit points whose weight distribution is studied below. There are also two upper Hubbard band lower-lim it points for l = 5 which are not shown in the gure.

As in the case of the one-electron spectral weight represented in the gure, it occurs for all few-electron spectral functions that in the straight and horizontal lower lim it

upper Hubbard band lines $(k; ! = M E_u)$ of the (k; !)-plane there is nite spectral weight for a set of discrete m on entum values only, as mentioned above. These discrete m on entum values coincide with the m on enta k_M^1 given in Eq. (10). The fourm on enta $k = lk_F$ where l = 1; 3 that are shown in Fig. 1 are examples of such m on entum values. Each of these m on entum values correspond to a di erent reduced J-CPHS ensemble subspace of the CPHS ensemble space spanned by states of rotated electron double occupation M and with an occupancy of $M = M_{c; l=2}$ 1=2 holons. Our scheme e provides the weight distribution for small energies (! $M E_u$) corresponding to regions of the (k; !)-plane just above such straight and horizontal lower-lim it upper Hubbard band lines. For the straight and horizontal lines parallel to the lower-lim it lines and corresponding to values of ! such that (! $M E_u$) is small, there is nite spectral weight for small m on entum dom ains centered around the set of m on entum values $k = k_M^1$.

The correlation-function expressions obtained from standard conform al-eld theory [19,20] correspond to a speci c lim it of our scheme such that M = 0. The corresponding low-energy edges result from ground-state transitions to $M_{c_{i}}_{1=2} = M = 0$ excited states.

In gure 1 this corresponds to the nite-weight regions in the vicinity of the three points $(k = k_F; ! = 0)$, $(k = 3k_F; ! = 0)$, and $(k = 5k_F; ! = 0)$. In the following applications of our nite-energy method we do not consider weight distributions resulting from such low-energy transitions, which can be evaluated by means of two-component conform aleld theory [20]. Our studies are restricted to the weight distribution of each of the above

spectral functions in the vicinity of nite-energy points associated creation of 1=2 Y ang holons and/or c pseudoparticles of baremomentum q $d_{\rm e}^{0} = [2k_{\rm F}]$. The weight distributions resulting from creation of c pseudoparticles at other bare-momentum values appear at nite energy ! such that (!!_{H S}) is nite. These weight distributions cannot be evaluated by our method and are studied elsewhere [9, 10, 16]. Below we nd that several critical exponents which control the weight distribution in the vicinity of the rst and second upper H ubbard band low er-lim it points equal corresponding exponents that control the low -energy weight distributions studied in R ef. [20]. How ever, we note that in the qures that reference these exponents were plotted for nite values of the

m agnetic eld whereas our study refers to zero eld and m agnetization. Transitions from the ground state to excited states belonging to the sam e J-CPHS ensemble subspace are of the sam e type, whereas transitions of di erent type refer to

ensemble subspace are of the same type, whereas transitions of dierent type refer to excited states belonging to dierent J-CPHS ensemble subspaces. In some cases we extend this concept to pairs of J-CPHS ensemble subspaces with the same absolute momentum value for $k_{\rm M}^1$.

4.3. ONE-ELECTRON ADDITION UPPER-HUBBARD BAND WEIGHT DISTRIBUTION

We start by considering addition of a spin-up electron. A coording to Eq. (12) and Eqs. (51) and (52) of Ref. [7] with $L_{s; 1=2} = 0$ and $N_s = 0$ for > 1, in the case of the M $_{c; 1=2}$ = M = 1 type of transitions one has that N $_{c}$ = N $_{s}$ = 1 and $J_s = 1=2$. There are two one- 1=2 Y and holon types of transitions and six one-q = q_{c1}^0 = [$2k_F$] cl pseudoparticle types of transitions. For m ! 0 the number of momentum values $k = k_1^1$ associated with dominant processes such that $! = E_{ij}$ is in the present case six. These momentum values read lk_F where 1 = 1; 3; 5. Indeed, two one- 1=2 Y and holon type of transitions and two of the six one- $q = q_{r1}^0 = [$ $2k_{\rm F}$] c1 pseudoparticle type of transitions have the sam e momentum and energy spectrum. Thus, they contribute to the same upper Hubbard $k_{\rm F}$; ! = $E_{\rm u}$). band lower-lim it weight distribution located around the points (k = These are the two one- 1=2 Y and holon types of transitions such that $L_{c; 1=2} = 1$, $J_c = 0$, and $J_s = 1=2$ and the two one- $q = q_c^0 = [2k_F]$ cl pseudoparticle types of transitions such that $N_{c1} = 1$, $J_c = 1=2$, $J_{c1} = 1=2$, and $J_s = 1=2$. Two other upper Hubbard band lower-lim it points are $(k = 3k_{\rm F}) = E_{\rm u}$. The corresponding spectral weight is generated by types of transitions such that $N_{cl} = 1$, $J_c = 1=2$, $J_{c1} = 1=2$, and $J_s = 1=2$. Below we also study the weight distribution in the vicinity of these points. In their vicinity there is a sm aller am ount of spectral weight than in the vicinity of the above two form er points. Finally, the weight located in the vicinity of the remaining two points is even smaller. It is generated by transitions such that $N_{cl} = 1$, $J_c = 1=2$, $J_{cl} = 1=2$, and $J_s = 1=2$. These two points are located at $(k = 5k_F, ! = E_u)$. In the following we study the weight distribution around the above six upper Hubbard band lower-limit points located at $(k = 1k_F; ! = E_u)$ where l = 1; 3; 5.

Let us consider the limit m ! 0 where the spin-up and spin-down one-electron spectral functions have the same form. Use of the general expression (17) leads for excitation energy ! just above E_u and momentum values $k = lk_F$ where l = 1; 3; 5 to,

To reach this result we rst evaluated the expression for general values ofm in terms of the parameters (A 2) of Appendix A.U \approx of the limiting values for these parameters given in the same Appendix then leads to expression (25). The same procedure is followed in the calculation of the m ! 0 weight distribution of the dynamical structure factor and singlet C cooper pair spectral function given below. Note that in the present case all the transitions leading to the weight distributions (24) involve creation of both a c pseudoparticle hole and a s pseudoparticle hole. Note also that the dependence on n and U=t of the exponent (25) occurs through the parameter K only, as mentioned in the previous section. For m = 0 this is a general property of the critical exponents that control the weight distribution in the vicinity of the upper-H ubbard bands lower limit. In contrast, the expressions of the exponents that control the weight distribution in the vicinity of the momentum -dependent phase shifts de ned in Ref. [8].




Figure 2. The upper H ubbard band one-electron exponents (a) $\frac{1}{1p}$ and (b) $\frac{3}{1p}$ given in Eq. (25) as a function of the electronic density n for U = 1.5t, U = 4t, U = 10t, and U ! 1 (horizontal lines).

The exponent (25) is a function of U=t which for electronic densities n such that 0 < n < 1 changes from $\frac{jlj}{lp}!$ $(l^2 \quad 5)=4 = 1; 1; 5$ for l = 1; 3; 5, respectively, as U = t ! 0 to $\frac{j j}{j p} ! (l^2 8) = 8 = 7 = 8; 1 = 8; 17 = 8$ for l = 1; 3; 5, respectively, as U=t! 1. Note that as the critical exponent (25) approaches 1 for l=1 as U=t! 0 the spectral function behaves as given in Eq. (20). The exponents (25) are plotted in $k_{\rm F}$ and k =Figs. 2 (a) and (b) for k = $3k_{\rm F}$, respectively, as a function of the electronic density n and for di erent values of U=t. The l= 5 exponent is not plotted in the gure. This exponent is larger than two and corresponds to regions of very little spectral weight. The exponents plotted in Fig. 2 are monotonous functions of n. The exponent $\frac{1}{1p}$ is always negative and such that $1 = \frac{1}{1p}$ 7=8 and is associated with a weight-distribution singularity. It increases for increasing values of U=t. For nite values of U=t it is a function of the electronic density n with a minimum for an intermediate value of n. The exponent $\frac{3}{1p}$ is always positive and such that 1=8 3 1p 1 and is associated with a weight-distribution edge. The exponent $^{3}_{1p}$ decreases for increasing values of U=t. For nite values of U=t it is a function of the electronic density n with a maximum for an interm ediate value of n.

For all values of U=t there is more spectral weight around the lower-lim it upper Hubbard band points located at $(k = k_F; ! = E_u)$ than around the points located $3k_{\rm F}$; ! = E_u). M oreover, the amount of weight in the vicinity of the points at (k =located at (k = $3k_{\rm F}$; ! = E_u) is larger than that of the weight located in the vicinity of the points (k = $5k_{\rm F}$; ! = E_u). For U=t ! 0 the spectral weight located in the vicinity of the points (k = $3k_{\rm F}$; ! = E_u) and (k = $5k_{\rm F}$; ! = E_u) disappears. As mentioned above, the value of the critical exponent plotted in Fig. 2 (a) is 1 for U=t! 0. Thus, in this lim it the spectral function behaves as given in expression Eq. (20). In portantly, in that lim it the energy E_{u} of the upper Hubbard band lower lim it equals the non-interacting electronic spectrum at (k = 1) $k_{\rm F}$; ! = E_u). It follows that our general U=t weight distribution leads to the correct non-interacting spectrum in the U=t! 0 lim it. In this paper we study the weight distribution in the vicinity of points located in the lower limit of the Hubbard bands. The branch-line studies of Ref. [10] reveal that the low er-H ubbard band and upper-H ubbard band spectral weights become connected at k = $k_{\rm F}$ as U=t! 0. For nite values of U=t, the nite-weight regions of these two bands are separated by a region out of the range of dom inant processes. This is con med by analysis of Fig. 1.

Our above nite-energy expressions were derived for the metallic phase corresponding to electronic densities 0 < n < 1. In the limit n ! 1 and nite values of U=t expressions (25) lead to the correct n = 1 results. In that limit and form ! 0 the upper H ubbard band lower-limit points ($k = k_F; ! = E_u$) coincide with the lower-limit points ($k = 3k_F; ! = E_u$), and ($k_E = 5k_F; ! = E_u$). Thus, in this case the smallest of the three exponents (25), such that l = 1, controls the leading-order weight-distribution term (24).

In the limit n ! 1 the equality of the exponent that controls the electron rem oval lower-H ubbard band and the l = 1 nite-energy electron addition exponent (25) is required by particle-hole symmetry. Our results reveal that in the metallic phase the l = 1, l = 3, and l = 5 nite-energy exponents (25) also equal the exponents that control the weight distribution in the vicinity of the three zero-energy points located at $(k = k_F; ! = 0)$, $(k = 3k_F; ! = 0)$, and $(k = 5k_F; ! = 0)$, respectively. (The points $(k = k_F; ! = 0)$, $(k = 3k_F; ! = 0)$, and $(k = 5k_F; ! = 0)$ are shown in Fig. 1.) For l = 1 the exponent expression (25) was already found in Ref. [20]. It corresponds to the H ! 0 expressions of the one spin-up and spin-down electron exponents given in Table I of that reference, where H is the magnetic eld.

There are not m any previous results about the excitation energy and m om entum dependence of the weight distribution in the vicinity of the UHB lower-lim it points considered above. Conform al- eld theory does not apply to nite energy. The m ethod used in Ref. [12] refers to U=t ! 1 where the UHB lower lim it corresponds to $! = E_u = 1$. Thus, the UHB was not considered in the nite-energy studies of that

reference. The point $(k = k_F; ! = E_u)$ corresponds to (k = -2; (!) = 0.5)and $(k = 7 = 12 \ 0.58 ; (!) = t \ 1)$ in Figs. 3 and 4 of Ref. [13], respectively. The spectral weight of Fig. 3 is for half lling and U = t = 4. (The gure zero-energy is the middle of the M ott-H ubbard gap.) The weight of Fig. 4 is for electronic density n = 5=6and U = t = 4. These weight distributions were obtained by numerical calculations based on a combination of exact diagonalizations of nite clusters with strong-coupling perturbation theory and are consistent with our results. Unfortunately, a quantitative comparison is not possible because the method used in Ref. [13] does not provide accurate inform ation about the weight-distribution dependence on the excitation energy and momentum.

4.4. THE DYNAM ICAL STRUCTURE FACTOR UPPER-HUBBARD BAND WEIGHT DISTRIBUTION

According to Eq. (12) and Eqs. (51) and (52) of Ref. [7] with L _{s; 1=2} = 0 and N _s = 0 for > 1, for M_{c; 1=2} = M = 1 types of transitions one has in this case that N _c = 2, N _s = 1, and J _s = 0. These transitions generate spectral weight in the vicinity of two upper Hubbard band low er-lim it points. There are two one- 1=2 Y ang holon types of transitions and two one-q = q_{c1}^0 = [2k_F] cl pseudoparticle types of transitions which contribute to these weight distributions. The form er two types of transitions correspond to L_{c; 1=2} = 1 and J_c = 1=2. The latter two types correspond to N_{c1} = 1, J_c = 0, and J_{c1} = 1=2. The weight distribution in the vicinity of the two upper Hubbard band lower-lim it points located at (k = 2k_F; ! = E_u) results from transitions belonging to these two types. Use of the general expression (17) leads in the lim it m ! 0 to the follow ing expression for the dynam ical structure factor for excitation energy ! such that (! E_u) is small and momentum values k = 2k_F,

The exponent (27) is plotted in Fig. 3 as a function of the electronic density n for di erent values of U=t. This exponent is a function of U=t which for electronic densities densities n such that 0 < n < 1 and spin density m = 0 changes from ! 0 as U=t ! 0 to ! 1=2 as U=t ! 1. For the n = 1 M ott-H ubbard insulator phase the exponent reads 1=2 for all nite values of U=t. The exponent is always positive and such that 0 < 1=2 and is associated with a weight-distribution edge. It increases for increasing values of U=t. For nite values of U=t it is a function of the electronic density n with a minimum for an interm ediate value of n.

In contrast to the above one-electron problem, the spectral weight associated with the dynamical structure factor upper H ubbard band vanishes in the lim it U = t ! 1. For




Figure 3. The exponents $= \frac{1}{ss}$ (27) that control the weight distribution of the upper Hubbard band dynam ical structure factor and second upper Hubbard band singlet C coper pair spectral function, respectively, as a function of the electronic density n for U = 1:5t, U = 4t, U = 10t, and U ! 1.

the n = 1 M ott-H ubbard transition, the whole dynam ical structure factor vanishes as U=t! 1. This behavior is related to the vanishing of the kinetic energy as U=t! 1 [21]. The dynam ical structure factor upper H ubbard band exponent (27) had not been studied until now. It controls an onset of spectral weight whose ! derivative is in nite at the lower lim it of the upper H ubbard band ! = E_u and raises upwards according to the power law (26).

In general them omentum values $k = 2k_F$ are nite and thus in them etallic phase the weight distribution (26) is not related to the zero-m omentum frequency dependent optical conductivity. However, in the limit n ! 1 these momentum values vanish. Thus, for the particular case of the M ott-H ubbard insulator one can use the following relation between Im (k; !) and the regular part of the frequency dependent optical conductivity reg (!),

This expression applies to all nite values of U=t.

In contrast to the upper Hubbard band dynam ical structure factor expression (26) which refers to k = $2k_{\rm F}$ and values of ! such that (! $E_{\rm u}$) is small, the frequency dependence (29) of the k = 0 optical conductivity in the vicinity of the upper H ubbard band lower-lim it point was studied by otherm ethods [14, 15]. In reference [14] that zerom om entum conductivity edge was studied for the m etallic phase, whose critical exponent is dierent from the exponent (27). However, in the limit n ! 1 the zero-momentum density dependent exponent found in such a reference provides the correct half-lling exponent. In spite of the di erent m ethod used in the evaluation of that exponent, the half-lling expression derived in Ref. [14] coincides with that of Eq. (29). Moreover, the sam e optical conductivity edge was studied in Ref. [15] for both sm all and large values of U=t. These investigations also lead to the same critical exponent 1=2 for both these limits, in agreement with expression (29) which is valid for all nite values of U=t. As the conductivity exponent 1=2 is characteristic of a nite-energy sem iconductor edge, also the conductivity exponent 1=2 is now believed to be an universal signature of the Mott-Hubbard insulator [14, 15].

4.5. SPIN-SINGLET COOPER-PAIR FIRST AND SECOND UPPER-HUBBARD BAND WEIGHT DISTRIBUTIONS

The energy E_u becomes small for low values of U=t and electronic densities n in the vicinity of one. Thus, it is interesting to clarify whether there are singular spectral features in the Cooper-pair spectral function at the upper-Hubbard bands lower lim it. Indeed, for the above values of U=t and electronic density such singular features could lead to a superconductivity instability for a system of weakly coupled Hubbard chains. Unfortunately, the only singular feature found below is a function peak located at the point ($k = ; ! = E_u$). That isolated peak results from the -pairing mechanism [17]. As the electronic density n approaches one the weight of that peak vanishes as (1 n). W hile this spectral structure cannot lead to a superconductivity instability for the coupled-chain system, other singular features for excitation energy above the rst upper Hubbard band lower lim it could exist, as further discussed in Sec. V.

A coording to Eqs. (12) and Eqs. (51) and (52) of Ref. [7] with L $_{s; 1=2} = 0$ and N $_{s} = 0$ for > 1, in the case of the M $_{c; 1=2} = M = 1$ type of transitions there is for the spin-singlet C ooper-pair spectral function a one- 1=2 Y ang holon type of transition and three one-q = $q_{c1}^{0} = [2k_{F}]$ cl pseudoparticle types of transitions. However, we not that the one-q = $q_{c1}^{0} = [2k_{F}]$ cl pseudoparticle transition whose excitation momentum and energy is the same as the momentum and energy of the one- 1=2 Y ang holon type of transition does not contribute to the singlet C ooper pair spectral function. Thus, only the one- 1=2 Y ang holon type of transition and two

of the three one- $q = q_{c1}^0 = [2k_F] cl pseudoparticle types of transitions contribute$ to weight-distribution features. We is not that the weight-distribution feature generatedby the one- 1=2 Yang holon transition is a single peak located in the rst upperHubbard band lower limit at k = and ! = E_u. The matrix element between thecorresponding cl pseudoparticle excited state with the same momentum k = andexcitation energy ! = E_u and the ground state vanishes in this case. Therefore, thissinglet C ooper pair spectral function feature results from the one- 1=2 Yang holonexcited state only. There are also two is upper Hubbard band lower-limit points $located at (k = 4k_F; ! = E_u) which are generated by one-q = <math>q_{c1}^0 = [2k_F] cl$ pseudoparticle transitions. Below we also study the weight distribution in the vicinity of these rst Hubbard band lower-limit points.

For the one- 1=2 Y and holon transition we not that $N_c = N_s = J_c = J_s = 0$. Thus, this is an example of a transition where the quantity (19) reads $_{ss} = 2$ and is not a critical exponent. Instead, the correlation function at that point of the (k; !)-plane is of the form given in Eq. (20) for all values of U=t and reads,

The weight feature (31) can be obtained by direct evaluation of the matrix elements on the right-hand side of expression (21) for # = ss. That procedure con rm s in this particular case the validity of the results obtained by our method. Moreover, direct calculation of the matrix elements reveals that for k = the expressions (30) and (31) do not refer to values of ! such that (! E_u) is sm allonly, but to all values of excitation energy !. Direct evaluation of the matrix elements also reveals that the constant C of Eqs. (30) and (31) reads C = $[N_a = N]$ and vanishes for the Mott-Hubbard insulator.

In order to evaluate the matrix elements of expression (21) for # = ss and in the particular case of the momentum value k = , we note that the o diagonal generator \hat{S}^{c}_{+} of the -spin SU (2) algebra given in Eq. (9) of Ref. [6] can be rewritten as follows,

Use of Eq. (34) in Eq. (21) reveals that for k = the correlation function expression results from the overlap of the ground state with the excited state (33) only. Thus, for <math>k = only one matrix element between the ground state and the available excited states of momentum k = is nite. That matrix element corresponds to the state (33). It follows that for k = the singlet superconductivity correlation function and corresponding spectral function are indeed given by expressions (30) and (31) with $C = N_a$ N] for all values of !.

The one- 1=2 Yang holon state (33) is associated with the -pairing mechanism [17]. That mechanism leads in the metallic phase to the -function peak (31) in the singlet C ooper pair spectral function. Such a state possesses o -diagonal long-range order [17]. The corresponding peak is located at nite excitation energy. The peak (31) is absent in the case of the M ott-H ubbard insulator where $C = N_a N$]! 0. This vanishing is required by a half-lling selection nule, since the ground-state spin value of the M ott-H ubbard insulator reads $S_c = 0$. Note that the present transition is a mere rotation in -spin space which conserves S_c and leads to $S_c = 0$ and $S_c^2 = +1$. Thus, only for initial ground states such that $S_c = 1$ can this transition occur. This excludes both the M ott-H ubbard insulator ground state such that $S_c = 1=2$.

Next, we consider the weight distribution in the vicinity of the rst upper Hubbard band lower-lim it points generated by other M_{c; 1=2} = M = 1 types of transitions. These transitions correspond to a region of little spectral weight and are such that N_{c1} = 1, $J_c = 1=2$, $J_{c1} = 1=2$, and N_c = N_s = $J_s = 0$. Use of the general expression (17) leads in the lim it m ! 0 to the following expression for the spin singlet C ooper pair spectral function for momentum values $k = 4k_F$ and excitation energy ! such that (! E_u) is small,

This weight-distribution edge does not occur for the M ott-H ubbard insulator. From use of Eq. (19) we not the following expression for the critical exponent $_{ss}$ in the limit m ! 0,

This exponent is a function of U = t which for all electronic densities changes from $_{ss}$! 2 as U = t ! 0 to $_{ss}$! 0 as U = t ! 1. Such a dependence on U = t is continuous. (Since there is not much spectral weight in the vicinity of this edge feature, we do not plot the positive exponent (36).)

We close our study by considering the weight distribution in the vicinity of the M $_{c_{i}}$ $_{1=2}$ = M = 2 second upper H ubbard band lower-lim it points located at excitation

energy $! = 2E_u$. We note that for the M ott-H ubbard insulator there is no rst upper H ubbard band. In this case there is an energy gap which equals twice the M ott-H ubbard gap and separates the singlet C ooper pair rem oval and addition spectral functions. The latter function corresponds to the present second upper H ubbard band in the limit n ! 1.

The M_{c; 1=2} = M = 2 types of transitions are such that N_c = 2, N_s = 1, and J_s = 0. Interestingly, there are ve di erent types of transitions which contribute to the sam eweight distribution in the vicinity of two points and lead to the sam e critical exponent. These ve types of transitions are such that (a) L_{c; 1=2} = 2 and J_c = 1=2, (b) L_{c; 1=2} = 1, N_{cl} = 1, J_c = 0, J_{cl} = 1=2, (c) N_{cl} = 2, J_c = 1=2, J_{cl} = 0, (d) N_{cl} = 2, J_c = 1=2, J_{cl} = 1, and (e) N_{c;2} = 1, J_c = 0, J_{cl} = 1=2. All transitions of these types contribute to the weight distribution around the two second upper Hubbard band lower-lim it points located at (k = $2k_F$; ! = $2E_u$). In addition, there is a sixth type of transition which leads to two second upper Hubbard band lowerlim it points located at (k = $6k_F$; ! = $2E_u$). This type of transition is such that N_{cl} = 2, J_c = 1=2, and J_{cl} = 1=2. There is nearly no spectral weight in the vicinity of these two latter points.

Use of the general expression (17) leads in the limit m ! 0 to the following expression for the spin singlet C ooper pair spectral function for excitation energy ! such that (! $2E_u$) is small and momentum values $k = k_2^1 = 12k_F$ where l = 1; 3,

Note that for l = 1 this exponent equals the dynamical structure factor exponent given in Eq. (27). Thus, it changes from $\frac{1}{ss}$! 0 as U=t ! 0 to $\frac{1}{ss}$! 1=2 as U=t! 1. It is plotted in Fig. 3 as a function of the electronic density n for di erent values of U=t. On the other hand, the exponent $\frac{3}{ss}$ is much larger and changes from $\frac{3}{ss}$! 8 as U=t ! 0 to $\frac{1}{ss}$! 9=2 as U=t ! 1 . This exponent corresponds to a region of very little spectral weight. In the lim it n ! 1 the four second upper Hubbard lower-lim it points located at $(k = 2k_F; ! = 2E_u)$ and $(k = 2k_F; ! = 2E_u)$ $6k_F$; ! = $2E_u$) become the same single point. Thus, in this case the smaller exponent $\frac{1}{ss}$ corresponds to the dom inant contribution and controls the weight distribution in the vicinity of the lowerlimit point located at $(k = ; ! = 2Eu = 2E_{MH})$. For the n = 1 M ott-Hubbard insulator phase the exponent $\frac{1}{ss}$ reads 1=2 for all nite values of U=t. It equals the exponent which controls the weight distribution around the zero-energy point located at (k = i! = 0). Interestingly, comparison with the results of Ref. [20] reveals that also in the metallic phase the exponents (38) for l =1 and 1 =3 equal the corresponding exponent that control the low energy weight distribution of the singlet Cooper pair rem oval spectral function in the vicinity of the zero-energy points located

at $(k = 2k_F; ! = 0)$ and $(k = 6k_F; ! = 0)$, respectively. However, in the metallic phase there is more spectral weight in the vicinity of the latter zero-energy points than in the vicinity of the corresponding second upper Hubbard band lower-lim it points.

Finally, we note that if one extends the present study to nite-energy excited states with nite occupancies of $1=2~{\rm H\,L}$ spinons and/or s pseudoparticles belonging to

> 1 branches, sim ilar features are obtained for gapped spin excitations. For instance, in the case of the spin-down triplet superconductivity spectral function a -function peak sim ilar to (31) is obtained at $k = and ! = E_u + _0 H$. This peak is generated by a transition from the ground state to a single nite-energy excited state with one 1=2 Y ang holon and one 1=2 HL spinon.

5. CONCLUDING REMARKS

In this paper we derived general few-electron spectral function expressions for the 1D H ubbard m odel in the vicinity of the lower lim it of the upper H ubbard bands. For the one electron addition and dynam ical structure factor we studied the weight distribution in the vicinity of the lower lim it of the rst upper H ubbard band. In the case of the singlet C ooper pair spectral function we considered the same problem in the vicinity of the lower lim its of both the rst and second upper bands. The weight of these H ubbard bands is generated by dom inant holon and spinon processes which am ount to m ore than 99% of the spectral weight [16]. O ur general expressions were obtained by com bination of symmetries of the 1D H ubbard m odel, such as the holon and spinon num bers conservation laws, with the nite-energy holon and spinon description of the quantum problem recently introduced in Refs. [6, 8].

The results obtained in this paper provide physically interesting and useful inform ation about the nite-energy spectral properties of the present m any-electron 1D quantum liquid and are complementary to the branch line studies of Refs. [9, 10, 16]. In the case of the one-electron problem the combination of our results with those of Ref. [10] provides all nite-energy spectral-weight singularities. Since the singular spectral features observed in quasi-1D m etals agree quantitatively with them odel singular branch lines, our results are of interest for the further understanding of the unusual spectral properties observed in low-dimensional materials [2, 4, 5, 9, 10]. Moreover, from the

nite-energy weight-distribution found for the dynam ical structure factor, we checked that in the limit of half lling our results lead for all nite values of U=t to the expected M ott-H ubbard insulator exponent 1=2 for the onset of the nite-frequency optical conductivity absorption. Unfortunately, we found no singular features at the the upper-H ubbard bands lower limit of the spin-singlet C opper-pair spectral function other than the expected -pairing -function peak. However, it could be that there are branch lines just above such a lower limit which show singular spectral features. Since the energy width of the rst H ubbard band is sm all for low values of U=t and electronic densities n in the vicinity of one, such singular features could lead to an instability for a system of weakly coupled H ubbard chains. studied by the branch-line m ethod used in Ref. [10] for the one-electron problem .

Appendix A.THE FIN ITE-SIZE ENERGY SPECTRUM QUANTITIES

In this Appendix we show that the functional 2 has the form given in Eq. (15) and discuss issues related to the vanishing of the c nite-size energy spectrum for $q = q_{\rm c}^0 = [2k_{\rm F}]$.

By direct use of the results of R ef. [8], we nd that for the excited states that span the reduced J-CPHS ensemble subspaces H $_{red}$ the functional (14) can be written as,

In the limit m ! 0 these parameters read ${}^{0}_{c;c} = 1 = \frac{q}{2K}$, ${}^{0}_{c;s} = 0$, ${}^{0}_{s;c} = 1 = \frac{p}{2}$, ${}^{0}_{s;s} = \frac{p}{2}$, ${}^{0}_{c;c} = 0$, ${}^{0}_{s;c} = 0$, ${}^{1}_{c;c} = \frac{q}{2K}$, ${}^{1}_{c;s} = \frac{q}{K}$, ${}^{1}_{c;s} = 0$, ${}^{1}_{s;c} = 0$, ${}^{1}_{s;s} = 1 = \frac{p}{2}$, ${}^{1}_{c;c} = \frac{q}{2K}$, and ${}^{1}_{s;c} = 0$. Here K is the parameter de ned in Ref. [22] which is such that K ! 1 as U=t ! 0 and K ! 1=2 as U=t ! 1.

The creation of 1=2 Y ang holons does not lead to any contribution to the value of the functional (A.1). However, the creation of c pseudoparticles leads to contributions through the term s $P_{a1}^{P_{a1}}$, $N_c = 2$ and $P_{a1}^{P_{a1}}$, J_c of that functional. On the other hand, the symmetry discussed in the text below Eq. (15) requires that the values of the phase-shift parameters $j_{,c}$ of Eq. (A.2) are such that the functional (A.1) simplies to (15). Indeed, by manipulation of the integral equations of Ref. [8] that de ne the two-pseudoferm ion phase shifts, we nd the following relation between the parameters $j_{,c}$ and $n_{,c}$ (A.2),

M oreover, the same symmetry is behind the vanishing of the nite-size energy contributions of the $q_{\rm p}^0 = [2k_{\rm F}]c$ pseudoparticles. Indeed, by careful analysis

of the general energy spectrum E_{GL} we nd that these contributions vanish provided that the quantity,

also vanishes. Here Q_c (q) is the functional de ned by Eq. (73) of Ref. [8]. Use of the equality Q_c ($\frac{d}{d}$)=N_a = q_c^0 given in Eq. (126) of the same reference in expression (A.4) con rm s that 2 _____ vanishes for the excited states that span the reduced subspace.

These properties apply only to c pseudoparticles such that $q ! [2k_F]$. Indeed, these quantum objects become non-interacting and localized in that limit. This behavior is related to the fact the 1=2 Y ang holon is also non-interacting and invariant under the electron - rotated-electron unitary transformation [7]. However, in general a c pseudoparticle is di erent from the rotated c pseudoparticle. The only exception is precisely for bare momentum values q such that q! $q_{0}^{0} =$ Γ $2k_{\rm F}$]. The c pseudoparticles become non-interacting in that lim it only. Indeed, the energy associated with creation of a 1=2 Y and holon is given by E_{u} . A c pseudoparticle is a composite 1=2 holons and +1=2 holons. C reation of a +1=2 holon is a quantum object of process which requires no energy. The amount of energy required for creation of a c pseudoparticle is $E_u + \frac{0}{c}$ (q). Thus, the energy per 1=2 holon is $E_u + \frac{0}{c}$ (q)= $\Leftrightarrow E_u$. However, one has that ${}^0_{c}$ (q) ! 0 as q ! q^0_{c} = [$2k_{\rm F}$] and thus in this lim it the energy per 1=2 holon becomes E_u and equals that of a non-interacting 1=2 Y ang holon.

Appendix B.THE FIN ITE ENERGY CORRELATION FUNCTION

Here we show that the asymptotic expansion of the correlation function hGSj^{*}_#(x;t)^{*}_#(0;0) jGSi is of the form given in Eq. (16). The operator ${}^{GL}_{#}$ (x;t) acts and is de ned in a reduced J-CPHS ensemble subspace associated with sm all values of the excitation energy E $_{GL}$ = (! !_{HS}) and excitation momentum P $_{GL}$ = (k $k_{\rm M}^{\rm l}$). In the H eisenberg description and in that reduced H ilbert subspace the space coordinate x and timet dependent physical eld ${}^{GL}_{#}$ (x;t) can be expressed relative to its x = 0 and t = 0 expression ${}^{*}_{#}$ (0;0) as,

For the Hamiltonian : \hat{H}_{GL} : of Eq. (6) the low-energy energy spectrum (13) and momentum spectrum $P_{GL} = \frac{2}{N_a} \int_{-R_c}^{P} e_{c,s} = 1 [+ N_i^{ph}]$ are conformal invariant and correspond to a two-component conformal-eld theory associated with the c and s pseudoparticle excitation branches [19, 20]. The e ect of the c pseudoparticles is merely to shift the c pseudoparticle current number deviations J_c by $\int_{-R_c}^{P_1} J_c$. Fortunately, such an e ect does not a ect the conformal invariance of the low-energy energy spectrum and momentum spectrum. Thus, the asymptotic expression for the low-energy correlation function of the physical eld $\int_{-R_c}^{G_L} (x; t)$ is for electronic and spin densities such that 0 < n < 1 and 0 < m < n, respectively, of the following general form [19, 20],

(6) have the same energy eigenstates, there is a one-to-one correspondence between the correlation function term s (B 2) of the H am iltonian $:\hat{H}_{GL}$: and those of the 1D Hubbard model: \hat{H} :. Transitions to dierent reduced subspaces H _{red} lead to di erent correlation-function term s. M oreover, transitions to reduced subspaces with di erent values for M E $_{\rm u}$ and $k_{\rm M}^{\rm l}$ lead for the 1D H ubbard m odel to correlation-function contributions with di erent values of the excitation energy ! M E u and m om entum $k^1_{\scriptscriptstyle M}$. Thus, our rst choice is the energy value M E $_{\rm u}$ and momentum value $k^1_{\scriptscriptstyle M}$ k which our correlation-function asymptotic term refers to. If for the same values of M E $_{\rm u}$ and $k_{\rm M}^{\rm l}$ there are several reduced subspaces, we choose that associated with the leading-order asymptotic correlation-function term for the Hamiltonian : \hat{H}_{GL} : of Eq. (6). That leading-order term is of the form (B 2). Let j (j) i with j = 1;2; ... denote the excited states that span the chosen reduced H ilbert subspace H $_{\rm red}$. Based on the com mutation relations of the three norm al-ordered H am iltonians related by Eq. (6) and three norm allordered momentum operators involved in Eq. (8) we nd that,

Here the j summation refers to the above set of excited states fj (j)ig which span the suitable reduced subspace H_{red}. Finally, the combination of Eqs. (B 2) and (B 5) implies that the leading term in the asymptotic expansion of the correlation function of the 1D Hubbard model is of the form given in Eq. (16).
