Super uid toroidal currents in atom ic condensates

The dynam ics of toroidal condensates in the presence of condensate ow and dipole perturbation have been investigated. The Bogoliubov spectrum of condensate is calculated for an oblate torus using a discrete-variable representation and a spectralm ethod to high accuracy. The transition from spheroidal to toroidal geom etry of the trap displaces the energy levels into narrow bands. The low est-order acoustic modes are quantized with the dispersion relation ! jn j! with m = 0; 1; 2;:::. A condensate with toroidal current splits the jn j co-rotating and counter-rotating pair by the amount: E 2 jn j⁻² hr² i. Radial dipole excitations are the low est energy dissipation modes. For highly occupied condensates the nonlinearity creates an asymmetric m ix of dipole circulation and nonlinear shifts in the spectrum of excitations so that the center of m ass circulates around the axis of symmetry of the trap. W e outline an experimental method to study these excitations.

I. IN TRODUCTION

The elementary excitations of trapped Bose Einstein condensates have been extensively studied in recent years. These collective modes are coherent macroscopic matter waves that can be used in many applications in cold atom Physics. Since the trap geometry de nes the mode spectrum and am plitudes, recent studies have considered spheroidal condensates [1, 2] and in novel topologies such as toroidal traps [3, 4, 5]. A toroidal trap is of particular interest as it can be employed as a storage ring for coherent atom waves [6] or ultracold molecules [7] enabling investigations of persistent currents, Josephson e ects, phase uctuations and high-precision Sagnac or gravitational interferom etry. M ore adventurous possibilities for toroidal condensates include the construction of a mode-locked atom laser [8] and the creation of sonic black holes in tight ring-shaped condensates [9]. A narrow ring of condensate, e ectively reducing the dim ensionality to 1D, could be applied to dark soliton propagation [10] or low-dimensional quantum degeneracy including the Tonks gas regime [11, 12]. Toroidal traps have been around for som e time, being em ployed in early experiments with Sodium vapors [13]. In this case a bluedetuned laser was used as a measure to counteract M aprana spin ips; a loss mechanism which can be problem atic in the cooling required for condensation. In more recent experiments the toroidal topology has been used in the study of vortex nucleation and super uidity [14].

Recent theoretical work concerning toroidal condensates has concentrated on excitations in traps which have some time dependence in their topology [15] and on vortex-vortex dynam ics which have been shown to be strongly distorted by such a geom etry [16]. The stability

of multiply-quantized toroidal currents has been studied by [5, 15]. The spectrum of single-particle excitations for cigar-shaped toroidal traps with circulation has also been considered [4]. Although a wide variety of toroidal trap param eters is possible, one of the advantages of such a system, the most easily accessible experiments appear to be based on oblate shaped traps. In this paper we study results for the spectrum of collective excitations of oblate toroidal condensates within the Bogoliubov approxim ation, and explores the dynam ical stability of ring currents around the torus. The main features we note are generic to this design of trap and would apply to similar geom etries. Perturbations of super uid ring currents by an o set of the trapping potential are studied. For example, in a toroidal trap the central repulsive potential acts a pinning site for the vortex and thus the stability of the ow can be studied. The excitation spectrum, mode densities, ow rate and center-of-m ass motion for this system are obtained by employing both a time-dependent and tim e-independent m ethod [17, 18]. A sim ple, but accurate, form ula is presented for the low est angular acoustic modes of excitation, and the splitting energy of these modes when a background current is present.

II. THE MODEL

A. The weakly-interacting Bose gas

For a cold dilute weakly-interacting gas, the ground state (condensate mode) dom inates the collective dynam – ics of the system. In experimental realizations one can achieve temperatures such that T T_c (typically 0:1 to 1 K) and densities such that the gas is weakly interacting and highly dilute. Under such conditions, the condensate of N₀ 1 atoms is well described by a mean eld, or wavefunction, governed by the G ross-P itaevskii

equation, and the quasiparticle excitations are acoustic

waves within this eld. If the perturbations of the condensate are small, then it is appropriate and convenient to use the linear response approximation, which is equivalent to the B ogoliubov approximation for single-particle excitations in highly-condensed quantized B ose gases at zero tem perature.

Consider a dilute system of N₀ atom s, each of mass m_a, trapped by an external potential V_{ext} (x;t) and interacting weakly through the two-body potential V (x;x⁰). At low temperatures and densities, the atom -atom interaction can be represented perturbatively by the s-wave pseudopotential: V (x;x⁰) = (4 ~²a_s=m_a) ⁽³⁾ (x x⁰), and a_s is the s-wave scattering length. The dynam ics follow from the Hartree variational principle:

, and the chem ical potential plays the role of a Lagrange multiplier. Supposing that the tem peratures are su ciently low that the condensate can be represented by a Bogoliubov mean eld . The single-particle excitations can be described by the linear response ansatz:

where <u>represents</u> the highly-occupied condensate; that is, $ja_0 j = N = ja_j j j \in 0$. From the variation , and linear expansion in the small parameters $a_j;a_j$ taken as constant, the stationary G ross-P itaevskii equation and B ogoliubov equations follow:

T in e-reversal symmetry of equations (4,5) is rejected in the fact that every set of solutions $f!_{j};u_{j};v_{j}g$ has a corresponding set $f!_{j};v_{j};u_{j}g$ and the normalization convention is: $(u_{i};u_{j})$ $(v_{j};v_{j}) = i_{j}$.

B. Toroidal condensates

Conventional atom traps provide a con nement of the condensate in the radial and axial directions. We write this as a spheroidal potential of the type: V = $\frac{1}{2}m_a!_r^2(r^2 + {}^2z^2)$, where r is the radial coordinate, $!_r$ the radial frequency, and z the axial coordinate. Here

is the aspect ratio of the harm onic potential, so that




FIG.1: Torus potential (dashed line) and condensate density \hat{f} (full line) as a function of radius in the the plane z = 0 The radial potential corresponds to $h_0 = 50^{-1}r$, and $= 2 \frac{1}{2} \sqrt{-2m_a!r}$. The condensate circulation is = 0 and the interaction strength is C = 1000. The scaled condensate probability density $j \hat{f}$ is given in units $(-2m_a!r)^{3-2}$

> 1 attens the condensate into an oblate pancake shape. For convenience we use scaled dimensionless units for length, time and energy namely: $(\sim = 2m_a!_r)^{\frac{1}{2}};!_r^{1}$ and $\sim!_r$, respectively. Typically, $!_r$ 2 200H z, so that the natural tim escale for oscillation is of the order ofm illiseconds. If this potential is supplem ented by a repulsive core then the toroidal shape can be realized. The conventional method is to use blue-detuned laser light to create a dipole force. In the experiment of D avis et al. [13] the AC Stark shift from the green light of an argon-ion laser (= 514nm), detuned from the D-line (= 589nm) of the trapped sodium atoms created the dipole force. If the laser beam is aligned along the z-axis of the trap at the di raction lim it focus then the potential if a function of r only: U (r) = $\sim I(r) (8^{2} : I_{sat})^{1}$, where I_{sat} is the saturation intensity of the level, is the detuning and the lifetim e of the upper atom ic level [19]. A cross the focus the intensity variation is Gaussian: $I(r) = I_0 \exp((r^2 = 2))$, where the on-axis intensity is related to the power P and waist of the beam w_0 by $I_0 = 2P = w_0^2$. So the width and height of the central barrier can be controlled by the these param eters. Consider a typical case for a trap containing sodium atoms; an argon-ion laser beam of 3.5 W focused to a waist $w_0 = 30 \text{ m}$, would give a frequency shift of 7 M H z at r = 0. C om pared w ith trap frequencies of order100 400H z, this would be su cient to create a ! r=2 hole along the trap axis and form a toroidal condensate. The combination of the elds gives the external potential: $V_{\text{ext}}(\mathbf{x}; 0) = \frac{1}{2}m_{a}!_{r}^{2}(\mathbf{r}^{2} + \mathbf{z}^{2}) + h_{0}\exp(\mathbf{r}^{2} + \mathbf{z}^{2}),$ where the repulsive central barrier is de ned by height and width parameters h_0 and , respectively. The radial m in imum of the well is displaced to $r_0 =$ $\ln(4h_0 = 2)$. For convenience we use scaled dimensionless units for length, time and energy namely: $(\sim = 2m_a!_r)^{\frac{1}{2}};!_r^1$ and ~!, respectively Then it is convenient to de ne the interaction strength by the dimensionless parameter C

8 N₀a_s (~=2m_a!_r) $\frac{1}{2}$, so that as millions of atom s occupy the condensate N₀ ! 1;C ! 1, while the ideal gas corresponds to C ! 0. For the pancake geometry

1 the central barrier height h_0 controls the transition from spheroid to torus. The radius ro of the potential well m in im um provides a guide to the size of the torus. Collective excitations for a quartic toroidal potential of the form : V (r;z)_{ext} = $\frac{1}{2}$ m a ! $\frac{2}{r}$ [(r g)² + $\frac{2}{r}$ z²] were considered by Salasnich et al [4] and the variation in chem ical potential and frequency with respect to particle number was studied. The geometry chosen [4] was a prolate shape such that $= 1 = \frac{1}{8}$ in contrast to the oblate case considered here. An example of a toroidal condensate density in static equilibrium is shown in gure 1. The trap param eters are $h_0 = 50 \sim !_r$, and $= 2^{-} \sim = 2m_a !_r$ so that 4, and the interaction strength is C = 1000. For r_0 strong interaction, high C , the radius of gyration (r_K) about the symm etry axis is a better estim ate of condensate radius; where r_{K}^{2} $j j r^2 d^3 x = j j d^3 x$. For the pancake shape ($h_0 = 0$) $r_K = 32$, but as the barrier is raised to $h_0 = 10$ then there is some depletion of condensate at the center, so that it expands to $r_{K} = 3.8$. Finally for a high central barrier, $h_0 = 50$, the condensate is excluded from the trap axis and a narrow ring is form ed with $r_K = 4.6$ as shown in gure 1. Here the maximum condensate density is located close to the potential energy minimum r₀ 4 in accord with hydrostatic equilibrium [20].




FIG.2: Excitation spectrum for the axisymmetric modes of semi-toroidal condensate without circulation (= 0) as a function of interaction strength C. Trap parameters are = $\frac{1}{7}$, = 2. The symmetries of the modes are: m = 0 (), jn j= 1 (), jn j= 2 ().

C. Bogoliubov spectrum

In this paper we are primarily interested in the lowlying axisymmetric excitations arising from weak per-




FIG.3: Excitation spectrum for the axisym m etric m odes of toroidal condensate without circulation (= 0) as a function of interaction strength C.Trap parameters are = 7, = 2 and $h_0 = 50$. The mode symmetries are: m = 0 (),jn j= 1 (), jn j= 2 ()

turbation of the condensate, so that detailed results will be presented for the rst few monopole, dipole and quadrupole excitations only. For nite C, the spectrum of excitations must be determined by num erical solution of equations (3,4) and (5). Separating variables gives:

The cylindrical sym m etry of the condensate m eans that sm all am plitude excitations can be described by radial (n_r) , axial (n_z) and rotational (m) quantum numbers, each with an associated parity. Here m = n = 0; 1; 2;::: denotes angularm on entum with respect to the condensate, while n_r ; $n_z = 0$;1;2;3;:::. The quasiparticle am plitudes:

The equations are discretised on a 2D-grid using Lagrange functions [17]; the radial coordinate is de ned at M grid points $(r_1; r_2; :::; r_M)$ and the axial coordinate at N points $(z_1; z_2; :::; z_N)$. Therefore:

The functions for the r-coordinate are chosen to be generalized Laguerre polynom ials [17], scaled to encompass the entire condensate, with typically M = 50 m esh points. On the other hand, H erm ite polynom ials are used in the z-direction so that

A high degree of accuracy was found with only N = 30 points. The resultant eigenvalue problem was solved using the following approach. The condensate density was found using N ewton's method for equation (7). The decoupled linear eigenvalue problem (11,12) was solved by conversion to H essenberg Q R form followed by inverse iteration [21]. C onvergence was established by a combination of grid scaling and number of mesh points, so that at least six- gure precision was assured for all frequencies (see table I and table II).

D. Spectrum of torus excitations

The Bogoliubov mode frequencies for a toroidal condensate without circulation (= 0) are shown in gures 2 and 3 for two di erent barrier heights. The variation in frequencies as the particle number (C) increases is shown. In the absence of circulation for the low barrier $h_0 = 10$ (gure 2) the e ect of increasing the interaction strength, or equivalently increasing the number of atom s in the condensate, is to spread the spectral lines of the low -lying m odes, while the highly-excited state frequencies are relatively insensitive as C increases. In contrast, to the prolate toroid results [4] the e ect of increasing atom number, increasing C , leads to an increase in the gap between the low -frequency excitations. The three m = 0 m odes shown are, in increasing frequency, the gapless m ode ! = 0, the rst breathing m ode, and the




FIG. 4: Excitation spectrum for modes of a condensate with circulation = 1. The mode symmetries are jn j= 0();1();2(). Frequencies are plotted as a function of bargier height h_0 in a trap characterized by = 7 and = 2 ~=2m_a!_r, with interaction strength C = 1000. See also table II

rst axial dipole mode $! = \frac{p}{7}$. The lowest degenerate modes m = 1 are the fundamental radial dipoles, at higher frequency ! 2 we observe an octupole mode, and nally the xz-quadrupole at ! 2.8 is very close to the axial dipole. The increasing density of states for higher excitations is familiar from studies of spherical condensates and is reproduced here. Finally the lowest pair of m = 2 states, corresponding to quadrupole excitation in the radial coordinate are far below the next higher excitations of this symmetry.

A sthe toroidal shape ism ore sharply de ned ($h_0 = 50$) the high-frequency m odes become m ore tightly grouped (gure 2) and the gap to the low est-order excitations widens. The long-wavelength low-energy m odes are circulations around the torus, as shown in gure 3. The acoustic m odes [20] appropriate in the lim it C ! 1, are sinusoidal oscillations in density and follow the m icroscopic wave equation, in our units:

In the Thom as Ferm i limit, the condensate occupies the region where $V_{xt} > 0$. The angular waves satisfy the periodic boundary conditions (' + 2 m) = ('). Taking the volume average of equation (17) over the radial and axial density gives: $! = jn j!_s$ where

The results in gure 2 re ect the change in dispersion relation ! m^2 to ! m for the low er frequency modes as the interaction strength increases. The value of !s varies slow ly with changes in the interaction strength C, see gure 3. It is worth noting that the simple form ula (17) gives a good estimate of the frequency spectrum. For example, for C = 1000 !s 0:57 in good agreement with the results shown (gure 3) while for C = 4300 the value is !s 0:78. The relation (19) is quite general and can by applied to any toroidal geometry. For a large

radius but tightly con ned torus, so that $hr^2 i r_{K}^2$ the relation simpli es to the 1D result as expected:

where the wavenum ber is quantized according to $jn\;j=r_K$, and the speed of sound is proportional to the square root of the atom density. One m ight assume, for a given radial and axial mode, that this pattern of frequencies for the m sublevels would be repeated for the higher frequency bands. In fact this is not the case as con med in gures 2 and 3. The bands become mixed and the ! jn jrelation does not hold. A more extensive list of the frequencies including the highly excited modes is given in Table II.




FIG.5: Center-ofm ass trajectory of a toroidal condensate current = 1 displaced from the trap center. The torus has parameters = 7, = 2 $\sim = 2m_a!_r$ and $h_0 = 50 \sim !_r$ and interaction strength C = 1000. The gure shows the path traced out over a total time T = 100 in the horizontal plane by the condensate center-ofm ass following a sm all horizontal displacement of the trap axis " = 1. The combination of the x-dipole and y-dipole oscillations leading to precession of the condensate. These dipoles modes are degenerate and nearly in phase. The spectrum density of the x-dipole oscillations is shown in gure 7

E. Toroidal current ow

If the condensate itself has a current \notin 0, then the central barrier acts as a pinning site for the vortex. Furtherm one the jn jdegeneracy of the excitation m odes is rem oved. Perturbations of the external potential are of interest since it allows us to study in perfections in the toroidal trap potential, and also the dissipation of the ring current. We propose that these modes can be studied by a lateral displacement of the trap. In Figure 4 the spectrum of excitations of a singly-quantized current loop = 1 are presented. In this gure we consider the transition from a conventional pancake geometry $h_0 = 0$,




FIG. 6: Center-ofm ass trajectory of a toroidal condensate (current = 1) after radial displacement. As in gure 5 the torus has parameters = 7, = 2 $\sim 2^{-2}m_{a}!_{r}$ and $h_{0} = 50 \sim !_{r}$, how ever the atom number is much higher in this case C = 4300. The gure shows the path traced out over a time T = 100 in the horizontal plane by the condensate center-ofm ass following a sm all horizontal displacement of the trap " = 1. The center ofm ass performs a circular motion due to two e ects: the x and y dipole states are not degenerate in frequency and the am plitudes are out of phase, by roughly =2.

through a sem i-toroidal trap $h_0 = 10$, before reaching the torus shape $h_0 = 50$. The presence of the barrier creates a narrower radial well, so that the m = 0 radial excitations are pushed to higher frequencies. The axialm = 0 dipole mode ! = 2:65, is una ected of course. The splitting of the m-degeneracy is greatest for the spheroidal $h_0 = 0$ case, in particular the lowest pair of jm j= 1 m odes. The co-rotating m ode m = +1 has a positive frequency lying close to the lowest m = 2 m ode.The anom alous or counter-rotating mode m = 1 has a negative frequency, but positive norm . A nom alousm odes arise when a condensate has a stable topological excitation such as a vortex, indeed the presence of a vortex is a necessary condition for an anom alous excitation as its presence is required to satisfy conservation of energy and momentum in the system [22]. In this case the central barrier raises the anom alous mode to positive frequencies e ectively creating a stable pinning site for toroidal

ow . The stability of high circulation current in toroidal traps has been discussed in detail by Busch et al. [15]. The splitting of the jn j= 1 pair reduces as the barrier rises and the condensate becomes toroidal. The closing of the energy gap relects the fact that the barrier expels condensate density from the center so that the m = 1 cannot occupy the vortex core region and create a large energy gap. The jn j = 1 m odes will be evident when dipole excitations of the circulating ow are discussed. The m = 2 states, degenerate in gure 3, are also split by the condensate ow and in the toroidal limit, $h_0 = 50$.




FIG. 7: Spectral density of x-dipole of a condensate with circulation = 1 corresponding to gure 5: P_x (!) The torus $= {}^{P}\overline{7}, = 2 {}^{P}\overline{-2m_{a}!_{r}} \text{ and } h_{0} = 50 {}^{\circ}!_{r}.$ param eters are The condensate interaction strength is C = 1000 with trap displacem ent = 1. The gure shows the dominance of three modes, the low frequency m = 1 doublet, and an excited m = 1 mode. The center of the doublet corre-2C hr ² i sponds to the frequency $!_s =$ 0:58. In the graph the frequency peaks are shifted from the linear response results given in Table I and have a broader splitting than the Bogoliubov approximation. The x-dipole modes, shown above, have frequencies $!_x = 0.421; 0.666; 2.237; 2.441$ while the corresponding y-dipole modes have frequencies: $!_{v} = 0:449; 0:657; 2:234; 2:422.$

The energy splittings are proportional to jn jthe current m om entum. This follows from the Bogoliubov equations when the centrifugal energy terms can be considered as perturbations. First-order perturbation theory applied to equations (11) and (12) gives the energy shift:

where u_0 and v_0 are the unperturbed quasiparticle states. This gives the energy splitting $E = \sim (!_+ !)$:

The splitting decreases as C, and hence r_K increases. Referring to Table I for $h_0 = 50$, the jn j= 1 splitting is close to that given by the perturbation expression (equation 23) E 0:19. However the low est jn j= 2 m odes in Table I have a splitting (0.37) very slighty sm aller than the pertubation result 0:38.

The simplest experimental scheme to observe these modes is to displace the potential in the horizontal plane




FIG.8: Spectral density of x-dipole of condensate with circulation = 1 corresponding to gure 6: P_x (!) The torus parameters are = 7, = 2 $-2m_a!_r$ and $h_0 = 50 \cdot !_r$. The condensate interaction strength is C = 4300 with trap displacement = 1. The center of the doublet corresponds to the frequency $!_s = 2Ch^2r^2i$ 0:78 The gure shows the shifting upwards of the mode frequencies and a narrow-ing of the m = 1 doublet splitting consistent with an expanded condensate with a higher sound speed. The modes show n above have frequencies: $!_x = 0.625; 0.804; 2.095; 2.284$. The corresponding y dipole modes, not show n, have similar strengths but with frequencies $!_y = 0.657; 0.792; 2.086; 2.275$.

and follow the motion of the condensate center-of-mass. Consider a sudden adjustment of the trapping potential

The e ect on the center-ofm ass is shown in gures 5 and gure 6 in which the trajectory is traced out as time evolves. These graphs were obtained by direct solution of the time-dependent G ross-P itaevskii equation, following from taking arbitrary variation of in (1):

For very sm all perturbations the nonlinearity is sm all and the time-dependent linear response method (TDLR) is equivalent to the stationary B ogoliubov equation m ethod outlined above. This employs a direct num erical solution, in combination with spectral analysis can also be used to determ ine the frequency spectrum [17] and the strength of each frequency component, that is the population of modes and density uctuations of the collective excitations. This can be done e ciently and accurately using spectral methods. The initial state can be determined by imposing the phase according to the value of and evolving in imaginary time [17]. The calculations presented here were perform ed on a 64 64 64 grid. The scaling of grid spacing according to the degree of con nem ent ensures m axim um spatial resolution of the condensate, so that the z dimension is more tightly con ned. The time step chosen, t 0:001 $2 = \frac{1}{r}$, is dictated by the characteristic timescale of the excitations. A powerspectral-density estimate which used a Kaiser windowing

function was employed to analyse the various moments of interest in term s of its component frequencies. For exam – ple the x-dipole moment can be transformed as follows:

The spectral data obtained for a very small trap displacem ent " = 0.02 con m s the m ode frequencies from the Bogoliubov-de Gennes equation, and establishes the accuracy of the m ethod. A s show n in table I, the frequencies using this method are accurate to within a few per cent. How ever a realistic m easurem ent process based on density in aging requires a much larger amplitude motion in order to resolve the uctuations. In this case, the nonlinear e ect can be important. In our scheme, which we propose as a viable method to measure the spectrum, we consider the trap displaced by a substantial amount " = 1 in order to resolve the oscillations in the plane. W hen circulation of the toroidal current is disturbed in thism anner the e ect is to create large countercirculating currents. If these currents are in phase and of equal magnitude the condensate would execute a pedulum motion. In general the motion will be 2D if the symmetry is broken. In terms of experimental observables, the e ect appears as oscillations of the center of mass with a precessional motion. Similar precession motion for quadrupole excitation of a spheroidal vortex state has been noted [17]. The locus of the center-of-m ass in the horizontal plane from t = 0 to t = 100, is shown in

gure 5 for C = 1000 and $h_0 = 10$. Initially the condensate m oves from x = 0; y = 0 towards the equilibrium point x = 1; y = 0, however this motion is converted an irregular precessing pendulum motion. The rate of precession is proportional to the splitting of levels. How ever the center-of-m assm otion is not simple. A clearer understanding of the motion follows from a spectral analysis of the x and y dipolem om ents. In fact, the apparently irregularmotion is dominated by only a few components the low frequency dipoles. In both the case $h_0 = 10$ (gure 7) and $h_0 = 50$ (gure 8) the m = +1 mode is stronger than the m ode m =1 and this dictates a motion with positive helicity, that is the condensate precession is in the same sense as the ow. How ever the frequencies are signi cantly di erent from the linear model and the xy degeneracy is removed due to the nonlinearity of the response in the xpdirectionp In gure 7, the torus param eters are = 7, = $2^{-1} \sim = 2m_{a}!_{r}$ and $h_{0} = 50 \sim !_{r}$. The condensate interaction strength is C = 1000 withtrap displacement = 1. Comparing the x frequencies with the values of table I we note the y-dipole frequencies are very sim ilar in both cases, but the x-dipole pair splitting is increased when the trap displacem ent is this large. The motion shown in qure 5 is a superposition of a faster x dipole with a slower y dipole. The results for the higher interaction strength C = 4300 show the splitting of the $i_{j} = 1$ lines narrow ing as the size of the condensate increases. The gure shows the shifting upwards

of the m ode frequencies and a narrowing of the m = 1 doublet splitting consistent with an expanded condensate with a higher sound speed. The m odes shown have frequencies: $!_x = 0.625; 0.804; 2.095; 2.284$. The corresponding y dipole m odes have sim ilar strengths but with frequencies $!_y = 0.657; 0.792; 2.086; 2.275$. The nonlinear interactions give di erent splittings for the x and y dipoles: $!_x = 0.179$ com pared with $!_y = 0.135$ both of which are slightly sm aller than the linear perturbation theory (23) ! 0.200. The major contrast between

gures 5 and 6 is the orbiting motion observed for the higher value of C, although the frequency components shown in gures 7 and 8 are of sim ilar relative strengths, the x and y dipoles have a large phase di erence close to =2 for C = 4300 and explains the more circular character of the motion. This is slightly suprising in that the usual behavior of collective mode of oscillations is that the frequency dependence on N is relatively weak for large N. In this respect, collective excitation frequencies are usually a poor method of estimating condensate fraction compared with the hydrostatic pressure. How - ever, in this case the toroidal geometry seems to retain the quantum features of the excitations even for large particle number.

III. CONCLUSIONS

In this paper we studied the spectrum of collective excitations of oblate toroidal condensates within the Bogoliubov approximation, and explored the dynamical stabil-

ity of ring currents around the torus. The main features we noted are generic to this design of trap and would apply to similar geometries and would be exhibited in experim ents on toroidal condensates. The transition from spheroidal to toroidal geom etry of the trap displaces the energy levels into narrow bands. The low est-orderm odes are quasione-dim ensional circulations with dispersion relation ! $m !_{s} w ith m$ quantized. W hen the condensate has an toroidal current ow, the low-energy circulations are split into co-rotating and counter-rotating pairs. A simple, but accurate, form ula is presented for the lowest angular acoustic modes of excitation, and the splitting energy when a background current is present. The stability of the ow is maintained by the central barrier acting as a pinning site.

Instabilities will most readily occur by radial dipole excitations. The dipole states are nearly degenerate in the toroidallim it. Sm all condensate currents when disturbed create slow precessionalm otion through the center of the trap through mixing of the degenerate x and y dipole states. For a tightly con ned torus, these modes are well separated in energy and accessible to observation. We propose an experiment that would detect these modes. A realistic m easurem ent requires resolution of the global condensate motion. Large displacements, such as those we propose, give rise to sm all nonlinear shifts in the frequencies beyond the Bogoliubov model. We also note that the highly occupied condensate perform s a circular orbiting motion of the center-of-mass. Such features are resolvable and experim entally measurable with current technology and expertise.
