D im ensional Crossover of Localisation and Delocalisation in a Quantum Hall Bar

The 2{ to 1{dimensional crossover of the localisation length of electrons connect to a disordered quantum wire of nite width  $L_y$  is studied in a model of electrons moving in the potential of uncorrelated impurities. An analytical formula for the localisation length is derived, describing the dimensional crossover as function of width  $L_y$ , conductance g and perpendicular magnetic eld B . On the basis of these results, the scaling analysis of the quantum Halle ect in high Landau levels, and the delocalisation transition in a quantum Halle ire are reconsidered.

## I. IN TRODUCTION

The Hall conductance of a 2 dim ensional electron system in a strong magnetic eld [1] is precisely quantised due to the trapping of electrons to localized states in the bulk of the system. Thereby, a change of electron density does not result in a change of the Hall conductance [2{4]. In the tail of the Landau bands the localisation length is small, on the order of the cyclotron length  $l_{evc} = 12n + 1l_{B}$ , where the magnetic length  $l_{B}$ is de ned by  $l_{\rm R}^2$  = h=(qB). The localisation length increases towards the middle of the Landau bands, located at energies  $E_n = h!_c(n + 1=2)$ , where  $!_c = qB = m$  is the cyclotron frequency, q being the electron charge, and n = 0;1;2; .... In an in nite system the localisation length of an Eigen state with energy E is expected to diverge as Œ  $E_n$ ). The exponent is found for the lowest two Landau bands, n = 0;1 to be for spin split Landau levels, as supported by analytical [5,6], num erical [7,8] and experim ental studies [9], rem iniscent of a second order transition from an insulator to ametal. Thus, for a nite system, there should exist in the m iddle of a disorder broadened Landau {band,  $E_n$ , n being the Landau index, a band of states, which extend through the whole system of size L, with band width  $E = (L_{cvc} = L)^{1}$ , where = h 2= '!<sub>c</sub>= .

On the other hand, the localisation length in two (  $\dim$  ensinal system s with broken time reversal sym m etry is from the one parameter scaling theory expected to depend exponentially on the conductance g as  $[10\{13]]$

g is the conductance param eter per spin channel. g exhibits the Shubnikov-de-H aas oscillations as function of the magnetic eld, for  $!_{\,\rm C}>1=$  , where 1= is the elastic scattering rate. The maxima occur, when the Ferm i energy is in the middle of the Landau band. Thus, the localisation length is expected to increase strongly from the tails to the middle of the Landau bands, irrespective of the existence of the quantum critical point.

For uncorrelated impurities, within self-consistent Born approximation [14], one nds that the maxima in the longitudinal conductance are given by g(E = E\_n) =  $\frac{1}{2}(2n+1)$  =  $g_n$ . Thus, one gets localisation lengths  $_{2D}$  (E\_n) =  $l_{\rm cyc} \exp(\ ^2g_n^2)$  in the middle of higher Landau levels, n>1, which are macroscopically large [8,15]. However, when the width of the wire  $L_y$  is smaller than the length scale , the localisation is expected to become equasi{1{dimensional.}} That is, the electrons in the middle of a Landau band can diuse freely between the edges of the wire, but are localised along the wire. The quasi-1-dimensional localisation length is known to depend only linearly on the conductance, and is, in a magnetic eld, with broken time reversal symmetry, given by [16{19}]

Thus, for  $L_y$   $_{2D}$  (E  $_n$ ) there is a crossover from 2{ to 1{dim ensional localisation as the Ferm i energy is m oved from the tails into the m iddle of a Landau band. It is known from numerical [7] and analytical studies [6], that in a nite quantum Hall bar, the criticality in the m iddle of the Landau band results in a nite localisation length  $_{\rm crit}$  12Ly, exceeding the wire width Ly. Comparing this value with the quasi{1{dim ensional localisation length for uncorrelated in purities in the middle of the Landau band, obtained from Eq. (2),  $_{\rm n1D}$  =  $^2$  (2n + 1)Ly, we see that this length scale exceeds the critical localisation length  $_{\rm crit}$  in all but the lowest Landau level, n = 0.

It is the aim of this article to derive analytically the dimensional crossover of the localisation length—in a wire as function of a perpendicular magnetic—eld. This might also help to identify the irrelavent scaling parameters observed in numerical studies of the integer quantum Hall transition [7,8]. We also not that in quantum Hall bars of nite width  $L_y$ , there exists at low temperatures a new phase, when the phase coherence length  $L_r$  exceeds the quasi{1{dimensional localisation length, in the middle of the Landau band,  $L_r > 10$ . This phase may accordingly be called the mesoscopic quantum Hall phase,

exhibiting plateaus in the Hall conductance, when the bulk localisation length is smaller than the wire width, and the Hall conductance is carried by edge states, separated by regions in energy where all states are localised along the wire, and the conductance is zero. A similar result has also been noted recently in a renormalization group study of a quantum Hallbar in Ref. [6].

In the next section the crossover between 1{ dim ensional and 2 (dim ensional localisation is studied. In the third section the localisation length is derived as function of magnetic eld. In the fth section, the scaling theory of the integer quantum Halle ect is considered. It is shown that the irrelevant scaling param eter and the scaling function is in qualitative agreem ent with the one obtained from the noncritical theory. In the last section, a sum mary is given, and implications of these results for the theory of the integer quantum Halle ect are pointed out. The derivations are given in appendices A (orthogonal localisation length as function of wire width  $L_v$ ), B (unitary localisation as function of wire width  $L_v$ ), and C (orthogonal to unitary crossover of 2D localisation length). In Appendix D a generalized derivation of the eld theory including an edge state potential and the topological term in the presence of a magnetic eld is given.

# II. D IM EN SIONAL CROSSOVER OF LOCALISATION

In the follwing, we study the localisation length of electrons con ned to a disordered wire of nite width L $_y$ . O rthogonal Regim e. First, let us consider the problem without magnetic eld, B = 0, the orthogonal regim e.

An estimate of the localisation length can be obtained by performing a perturbative renormalization of the dimensionless conductance g, which appears as the coupling constant of the action in the nonperturbative theory of disordered electrons. The bare conductance g is obtained in self consistent Born approximation [14]. The vanishing of the renormalised conductance g! 0 as one increases the wavelength of renormalisation, signals the localisation, and can be used to obtain an estimate of the localisation length, as done in appendix A.

The rst order in 1=g of the perturbative renormalization corresponds to the weak localisation correction to the conductivity. Thus, one can estimate the localisation length at zero magnetic eld B = 0 as done in appendix A . There, the renormalisation is performed for arbitrary nite widths  $L_{\,\rm Y}$  of the wire. One thus gets the following equation for the localisation length ,

where  $k_0 = 2$  =1=  $k_F$  =g, and we assumed that the wire width is diusive,  $L_V > 1$ .

In the quasi-1-D lim it,  $L_y$ , we not a logarithm ic correction, to the expected quasi-1-D result, =  $gL_y$ :

In the opposite  $\lim$  it,  $L_y$ , the nonlinear equation for the localisation length  $\sin$  pli es to,




FIG. 1. The width dependence of the localisation length at xed conductance g=2 without magnetic eld, B=0, is shown as the full line. For comparison, the quasi{1{dimensional limit  $L_{\gamma}g$  is drawn as the dash{dotted line. The crossover occurs at  $=L_{yc}=\exp{(\ )}(2g=k_{_F})\exp{(\ g)}$ .

The solution of this equation can be written in closed form in terms of the Lambert {W  $\{function W_0(z)\}$ }?

where we substituted  $l=2g=k_{_{\rm F}}$ . The Lambert{W { function W  $_0$  (x) is de ned as the solution of the nonlinear equation [21]

Thus, the localisation length is found to increase linearly with the width like

when the localisation length exceeds the width  $L_y$ ,  $L_y$ . It logarithm ically deviates from this behavior when the width  $L_y$  is on the order of  $L_{yc} = \exp{(\ )} \log{(\ g)}$ . For larger widths, it slow ly saturates towards the width independent 2D {localisation length,

as seen in Fig. 1.

For intermediate widths there is a wide regim e where the localisation lengths deviate strongly from both 1{D, Eq. (9), and 2{D, Eq. (10), which would yield  $_{\rm 2D}$  (g = 2) = 2142 on the scale 1=k $_{\rm F}$ , used in Fig. 1.




FIG. 2. The localisation length (full line) in units of  $k_F^{-1}$  as function of the conductance g at xed width  $L_y=40$ , and without magnetic eld, B=0. It is plotted using Eq. (6) for  $< L_y$ , and Eq. (4) for  $> L_y$ . For comparison, we show the quasi{2{dimensional  $_{2D}=(2g=k_F)\exp(g)$  (dashed line) and the quasi{1{dimensional  $_{Ly}g$  (dash{dotted line) limiting functions.

As one xes the width  $L_y$ , and increases the dimensionless conductance g, a crossover from 2D { to 1D { localisation is observed, as shown in Fig. 2. There, Eq. (6) is plotted as function of g, for  $< L_y$ . For  $> L_y$ , the localisation length is plotted using, Eq. (4). In the interm ediate regime, the solution of the general equation Eq. (3) deviates only little from these asymptotic solutions. Note that the validity of the derivation is limited to g > 1, while the deviations from 2D localisation behavior occur for the chosen width  $L_y$  already close to g = 1. The derivation given above has been done for wires of di usive width,  $1 < L_y$ , or  $g < L_y k_F = 2$ , corresponding to g < 20 in Fig. 2.

Unitary Regime. At moderately strong magnetic eld, the time reversal symmetry is broken, and the so called unitary regime is reached, when the localisation length exceeds the magnetic diusion length [22],  $\,>\,$  L  $_B$ , (where L  $_B$  =  $l_B$ , when  $l_B$  < L  $_Y$  and L  $_B$  =  $(3)^{1-2}\,l_B^2$  =L  $_Y$ , when  $l_B$  > L  $_Y$  > 1). Then, the rst order, weak localisation correction vanishes and one needs to do the perturbative renormalisation to second order in 1=g. Thus, we have to calculate all diagrams contributing to this order, the so called Hikami boxes [12], to study the dimensional crossover in a magnetic eld. An ecient way to do this, is to start from the supersymmetric nonlinear sigma model and do an expansion around its classical point, as done in Ref. [16] for the pure orthogonal and unitary regimes in 2 dimensions.

Perform ing this renormalisation for wires of nite width  $L_y$  in the unitary regime, we obtain in appendix B, that the localisation length satis es in the unitary regime the equation,




FIG.3. The localisation length—as function of conductance g, for large enough magnetic—elds such that  $\,>\,L_{\rm B}$ , at xed width L  $_{\rm Y}$ . For comparison, the quasi(2{dimensional behavior  $_{\rm 2D}=\,2\,(g=k_{\rm F}\,)\exp\left(\,^2g^2\right)$  (dotted line) and the quasi(1{dimensional limit L  $_{\rm Y}g$  (dash{dotted line). The width L  $_{\rm Y}$  is indicated by the dashed line.

Here, the length scale 2 =  $k_{\rm 0}$  is the short distance cuto of the nonperturbative theory, being l= 2g(B = 0)= $k_{\rm F}$  at moderate magnetic elds, when !  $_{\rm C}$  < 1, and crossing over to the cyclotron length  $l_{\rm cyc}$  at strong magnetic elds when !  $_{\rm C}$  > 1.

Here, = 1, unless the spin degeneracy is broken, and the energy levels are mixed by spin ip as by scattering from magnetic impurities, then = 2. Note that the above results con m the result for the localisation length in the quasi{1{D limit [17,18],

where = 1;2 with, without time reversal symmetry. We will set = 1 in the following. We can solve Eq. (11) in two limiting cases. When  $L_{\gamma}$ , the quasi{1{ dimensional localisation length is obtained with a logarithm ic correction,

In the lim it of  $2\{\text{dim ensional localisation,} \quad L_y$ , the localisation length is found to satisfy the equation

Its solution can be written in terms of the Lambert {W  $\{$  function [21] as

Fixing the width  $L_y$  the dimensional crossover is seen in Fig. 3, where the localisation length is plotted as function of the dimensionless conductance g, using Eq. (13) for  $> L_y$ , and Eq. (15) for  $< L_y$ .

## III. THE MAGNETIC FIELD DEPENDENCE OF THE LOCALISATION LENGTH

Weak magnetic eld

In disordered quantum wires without strong spin (orbit scattering or magnetic impurities, the electron localisation length is enhanced by a weak magnetic eld. If the localisation is quasi{1{dimensional, > Ly, then the magnetic eld results in a doubling, Eq. (12), = gLy, where = 1;2, corresponding to no magnetic eld, and nite magnetic eld, respectively [17,18]. Recently, such a doubling of the localisation length was observed experimentally [23]. That doubling is governed by the magnetic di usion length  $L_{\rm B} = (D_{\rm B})^{1=2}$ , where  $_{\rm B}$  is the magnetic phase shifting time, which is a function of magnetic length  $l_{\rm B}$ , mean free path land width of the wire  $L_{\rm y}$  [22]. Thus, the localisation length crosses over to = 2gLy, when the magnetic di usion length becomes smaller than the localisation length,  $L_{\rm B}$ <

This crossover has recently been derived analytically [19,22]. The quasi{1{D localisation length, valid for >  $L_y$ , is obtained to be given by:

For a wire of di usive width W > l, one nds, X =(0)= $L_B = {}^23$   ${}^{1=2}N$   ${}^2b_r$  where N  $_V = k_F$   $L_Y = is$  the num ber of transverse channels, and b = !c = eB =m the dim ensionless magnetic eld parameter. The factor 64 was not noticed in a previous publication [22], and is a consequence of the particular properties of the autocorrelation function of spectral determ inants, and its relation to the actual localisation length which was used to derive Eqs. (16,17) [22]. When the localisation is 2{ dim ensional, the localisation length becomes exponentially enhanced. The crossover between the orthogonal, Eq. (10), and unitary, Eq. (1), localisation length is governed by the parameter  $X = -L_B$ . Extending the perturbative renormalisation, by calculating the Hikami boxes as a function of magnetic eld as outlined in appendix B (This problem, the magnetic eld induced crossover of the weak localisation corrections to the conductivity, has been considered to 2 nd order in 1=g also in Ref. [26], using the complex matrix model), one obtains the following equation for the 2D (localisation length,

Thus, when the time reversal symmetry is broken, >  $L_B$ , the localisation is given by Eq. (13) for >  $L_Y$ , and Eq. (15) for <  $L_Y$ , respectively. The elective short distance cuto of the renormalisation is a function of the magnetic eld itself. We get  $2 = k_0 = 1$  at smallmagnetic elds, b < 1, and  $2 = k_0 = l_{eyc}$  at large elds from the renormalisation of the distance roughly a model. But, we should note that an analysis of the nonlinear sigma model on ballistic scales is needed to get more reliable information on  $1=k_0$ .

Strong magnetic eld

In the following, we consider a quantum wire of disordered electrons in a strong magnetic eld, which is expected to exhibit the quantum Halle ect, when its width  $L_v$  and the mean free path 1 do exceed the cyclotron length l. We consider quantum Hall wires of di usive width, where the mean free path is smaller than the wire width,  $1 < L_v$ . In the opposite  $\lim it$ ,  $1 > L_v$ , the ballistic motion between the edges of the wire leads to anom alous magnetoresistance phenomena due to classical com m ensurability e ects of cyclotron orbits with the con nem ent potential of the wire [24,25]. This will not be pursued here, since these e ects are not related to disorder induced quantum localisation, which is the focus of this article.  $_{xx}$  (B) is the conductivity in self-consistent Born approximation. For weak magnetic eld, b < 1, it is identical to the D rude result  $xx = ne^2 = (1 + b^2)$ . W ith

the electron density  $n_e = E m = (2 h^2)$  this can be rew ritten as  $g(b) = {}_{xx} = {}_0 = g = (1 + b^2)$ , where g = E =h per spin channel. Fixing the electron density  $n_e$ , the Ferm i energy depends on magnetic eld  $E_F(B)$  for b > 1. In the following, we will x the Ferm i energy  $E_F$ , instead.

The conductivity in SCBA for b > 1, when the cyclotron length  $l_{\rm c}$  becomes smaller than the mean free path l, or  $!_{\rm c}$  > 1= , and disregarding the overlap between Landau bands, is given by

for jE  $E_n$  jk , where  $^2 = (2=)h^2!_c =$ , for  $< h!_c$ .




FIG. 4. The localisation length as function of magnetic ux through a unit cell of area  $a^2=1=k_F^2$ ,  $x=\frac{a^2}{2\ l_B^2}$ , with conductance parameter g(B = 0) = 10. For weak magnetic eld, Eq. (16) is used. For strong magnetic elds the localisation length is plotted by inserting g(B) in the 2nd order B om approximation in the formula for the quasi-1-dimensional localisation length, Eq. (2), including a summation over all Landau levels (full line). The short dashed line is obtained by using the self consistent B om approximation (SCBA) for g(B) for one Landau band, Eq. (20), and inserting it into the formula for the quasi-1-dimensional localisation length, Eq. (2). The long dashed curve denotes the corresponding result using the SCBA conductance and inserting it in the crossover formula Eq. (15). The width of the wire Ly = 40a is indicated as the horizontal dashed line.

One obtains thus the localisation length for b> 1 and  $j \Rightarrow n = 1-2 \not < 1$ , by substituting the expression for the dimensionless conductance Eq. (19), into Eq. (13) for > L\_y, and Eq. (15) for < L\_y, respectively. Thus, the localisation length is found to oscillate between maximal values in the middle of the Landau bands, and minimal values on the order of the cyclotron length  $l_{\rm cyc}$  in the tail of the Landau bands, as seen in Fig. 4.

The localisation is quasi{1{dimensional as long as  $(W) > L_y$ . We see that for n > 1 this is, for uncorrelated disorder potential, practically always the case in the middle of the Landau bands, with a logarithm ic correction as given by Eq. (10), yielding

Only in the lowest Landau band, Eq. (2) gives a value for the localisation in the middle of the Landau bands  $(2=)L_y$ , for n=0, which is smaller than the width  $\mathbf{L}_{\text{V}}\text{.}$  Thus, in the lowest Landau band the NLSM is 2-dim ensional and the topological term becomes fully e ective already for sm all w idths  $L_v$ , see Appendix D. There, the gap in the action of the nonlinear sigma model is diminished due to the presence of the topological term  $xy \in 0$ . Then, there are excitations with nonvanishing topological charge q, like Skym ions which give a phase exp (i2  $\, q_{xy}$ ) to the functional integral. For xy = (2n + 1)=2, the skyrm ions with q = 11 give the opposite sign to the functional integral, exp(i) = than con gurations without topological charge, q = 0, like vortices [27]. Thus, the presence of the topological term leads to quantum criticality, and a diverging localisation length, there. For a wire of nite width, the localisation length then saturates to its critical values which was found numerically to be c  $1.2L_v$  [7], while analytical estim ates exceed this value [6].

We note that we have assumed in the derivation of Eqs. (18,20), that the conductivity is hom ogenous. In a strong magnetic eld, the formation of edge states can result in strongly inhom ogenous and anisotropic conductivity, thereby preventing the mixing of edge states with the bulk states [28,29]. The consequences of these elects will be discussed in more detail, in the next chapter and in a forthcoming article, including a numerical analysis [20].

In a real sample there exists a slowly varying potential disorder which is known to stabilize the edge states against mixing with bulk states and back scattering [30,31]. But in the middle of the Landau bands there is always scattering from the edge states into the bulk [28], so that quasi{1{dimensionallocalisation should occur for large aspect ratios of the quantum hall bar, L  $_{\rm Y}$ .

#### IV. SCALING FUNCTION

In the above analysis of a disordered wire in a magnetic eld we disregarded the e ect of the topological term, which appears in a derivation of the nonlinear sigma

m odel [27,32,33], see Eq. (D 13). It is known that in the two-dim ensional lim it this topological term is needed in order that the eld theory becomes critical in the middle of Landau bands, and the quantum {Hall{transition from localised states in the Landau band tails to a critical state in the middle of the Landau bands can be described [27,32{36}]. Can one still learn something about the quantum Hall transition from knowing the noncritical localisation length as function of magnetic eld, (B), as derived above, as function of the wire width  ${\rm L}_{\rm V}$ ?




FIG.5. The noncritical scaling function obtained analytically (full line), Eqs. (22,23), for the Landau band, n=3, with  $g_n=7=$ . The dashed line, 1=x, is approached in the 2D limit, when the localisation length becomes equal to  $_{\rm 2D\ unit}$ .

Both in num erical calculations [7] and experiments one needs to perform a nite size scaling analysis in order to extract the critical divergence of the localisation length,

(E  $E_n$ ) , when approaching the m iddle of a Landau band,  $E_n$ . The procedure is to nd numerically the scaling function  $= = L_y = (L_y = ^{\sim}(E))$ , rescaling with the critical localisation length, which diverges according to  $^{\sim}(E)$  (E  $E_n$ ) , and does not depend on width  $L_y$ . Then, one can determ ine by optimizing the accuracy of scaling. The scaling function is not known a priori. It is clear that (x)! 1=x for x=1, since in the tails of the Landau band  $L_y$ , and becomes independent of  $L_y$ , approaching  $^{\sim}$ .

For the higher Landau bands, n>0, the single parameter scaling is not accurate, and it is important to include also irrelevant scaling parameters [37], apart from the relevant parameter,  $L_y = {^{\sim}}(E)$  [7,38]. So far the irrelevant scaling parameters have been included in the numerical scaling analysis on a phenomenological ground, without a precise knowledge of their physical origin. It has been observed, however, that the irrelevant scaling length increases by orders of magnitude in higher Landau bands, for uncorrelated disorder [7].

Therefore, it seems worthwhile to rst analyse, if the noncritical width dependence of (B), derived above, Eq. (3), can yield analytical know ledge on the scaling func-

tion (x) and moreover account for the observed irrelevant scaling parameter in higher Landau bands. Only then will we try to implement the topological term in the derivation of the scaling function at the end of this section.

A coording to Eq. (23), the ratio scales with the large length scale  $_{\rm 2D~unit}$ , which is a huge length scale in the middle of higher Landau bands, where g 1. Therefore, it is natural to expect that  $_{\rm unit}$  can be identified with the irrelevant length scale  $l_{\rm irr}$ , and to compare the scaling function, Eqs. (22,23), with the one obtained numerically, Eq. (24).




FIG.6. The irrelevant scaling function obtained analytically for the Landau band n=1, g=3= (full line) as compared with the function Eq. (24) (dashed line), for =3 and c=5, double logarithm ic scale.

In Fig. 5, we plot the scaling function, as obtained above, Eqs. (13,15), as function of  $x = L_y = _{2D \text{ unit}}$ , where  $_{2D \text{ unit}}$  is the 2D limiting value of the unitary localisation length,

This noncritical scaling function is plotted in Fig. 5, where g = 7 = has been chosen, corresponding to the unrenormalised conductance in the Landau band, n = 3. We note that the derivation is only valid for g = 1, so that we are able to compare this function only with the scaling function in higher Landau bands, where  $g_n = 1$ . It is expected that this noncritical scaling function is accurate as long as  $x = L_y = _{2D \text{ un it}} < 1$ .

C lose to the critical point,  $x = L_y = _{2D \; un \; it}$  1, the scaling function is from the numerical analysis obtained to be in the middle of the Landau band

where  $_{\rm c}$  = 1.2, and the irrelevant critical scaling exponent is numerically found to be = 38 .04, and c is a constant.

In Fig. 6, we plot  $_{c}$ , Eq. (24) using = 3 and c = 5, and compare it with as obtained from the result of the noncritical analysis, Eq. (23). Note that this function converges to zero as  $L_v$  ! 1 , corresponding to crit = 0, since it was obtained from the noncritical eld theory, disregarding the topological term. Thus, as expected, the form of the noncritical irrelevant scaling function defers from the results of the numerical analysis as seen in Fig. (6), but is in som e quantitative agrrem ent. Inspite of this, it is expected that the scaling function itself is changed by the presence of the critical point in the middle of the Landau band, and the similarity to the noncritical scaling function derived above, is only of qualitative nature. Since in higher Landau levels one is in the study of wires of nite width  $L_v$  for uncorrelated disorder always far away from the critical point, as shown above, we conclude that this noncritical scaling function is im portant in order to enable one to analyse the quantum Hall transition in higher Landau bands, n > 1. We can estimate the region of criticality by the condition that  $^{\sim}$ (E) =  $_{\rm 2D~un~it}$  > 1. Thereby we nd for the interval of criticality around En:

which yields E= = :65;:02;2: 10 <sup>5</sup>;::: for n = 0;1;2;::. Thus, we conclude that criticality can only be observed in the lowest two Landau levels. Since the width of the quantum Hall plateaus is determined by the condition (E) =  $L_y$ , there are nevertheless wide plateaus between higher Landau bands, and we conclude that criticality is not essential to observe the quantum Halle ect.

Next, let us consider the e ect of the topological term in the derivation of the scaling function. At small length scales, in high Landau bands, the dimensionless conductance  $_{\rm xx}$  is large, and the instanton approximation can be used. To this end, one nds solutions which minimize the action of the NLSM , Eq. (D 13),

D is regarding the spatial variation of the coupling functions  $_{ij}$  (x) in Eq. (26), and assuming isotropy, one founds that there are instantons with nonzero topological charge q, which are identical to the skymmions of the compact O (3) NLSM, as obtained from the compact part of the superymmetric NLSM [32,16]. Their action is given by

where  $_{xx} = _{yy}$  and  $_{xy}$  are the spatially averaged conductivities. Now, we can repeat the derivation of the scaling function, by integrating out G aussian uctuations around these instantons. It is clear, however that the contribution from instantons with  $q \in 0$  is negligible, as long as  $_{xx} > 1$ . Within the validity of the 1=g expansion one does not not a sizable in uence of the topological term on the scaling function  $= _{xy} = _{yy} = _{yy}$ 

Taking into account the spatial variation of  $_{ij}(x)$ , there are extended regions where  $_{yy}(x)$ ! 0, indicating the decoupling of the edge states from the bulk states [28]. Thus, the free energy for spatial variations of Q is reduced in these regions. Thereby, one can not instantons with nonzero topological charge q, whose spatial variations are restricted to these edge regions with vanishing real part of the free energy:  $F_{q \text{ edge}} = i2$   $_{xx}$  (edge), where  $_{xx}$  (edge) is the Hall conductance of the edge states, which is quantised to integer values. Thus, we conclude that the renormalisation and thereby the scaling function of the bulk,  $= L_{y}$ , is not in uenced noticeably by the presence of the edge states for g > 1.

C loser to the critical point, the NLSM, Eq. (26), can not be used to derive further inform ation, since that theory ows to strong coupling, q < 1. It has been established num erically that the quantum Hall criticality is not sensitive to the type of disorder. This observation found further support by the proof that the Hamiltonian of a chain of antiferrom agnetically interacting superspins can be derived both from the nonlinear sigm a model for short ranged disorder at xy = 1=2 [41], as well as from the Chalker (Coddington model [42], which is the reduced version of the quantum percolating network model of unidirectional (chiral) drifting modes along equipotential lines of a slow ly varying disorder potential [43]. It has been shown by numerical solution of a nite number of antiferrom agnetically coupled super spins that this theory is critical. So far, no analytical information has

been obtained for the critical parameters, such as the localisation exponent, and the critical value c. However, building on this model of a superspin chain, supersym m etric conformal eld theories have been suggested, which ultimately should yield the critical parameters of the qunatum Hall transition [44,45]. The critical value of the scaling function, c has been related to the free param eters of the conformal eld theory [45]. Restricting this theory to quasi-1D, by choosing a nite width  $L_{y}$ , on the order of 2D unit, which serves as the ultraviolet cuto of the conformal eld theory, one nds that the critical value of the scaling function c is inversely proportional to the gap between the lowest two eigenvalues of the Laplace-Beltram i operator of this reduced class of supersym m etric conform al eld theories. Thus, it seems that the critical value c of the scaling function at the critical point can be obtained from the dimensional crossover of the conformal eld theory. So far, however, the critical exponent of the localisation length has not been derived from the conformal eld theory, nor from the theory of superspin chains. Therefore, it is so far not possible to give an anlytical derivation of the scaling function close to criticality.

#### V. CONCLUSIONS

In disordered quantum wires the electrons are localised due to quantum interference along the wire with a localisation length which scales linearly with the wire width, as long as the electrons can diuse freely across the wire width. For wires, which would classically be good m etals, as characterised by a large dim ensionless con $ductance q = k_F 1$ 1 the 2D quantum localisation lim it is never reached, but rather a slow crossover between quasi{1{D and 2{D localisation occurs as function of the wire width. Therefore, we think that the crossover function derived here, can be relevant for the study of strong localisation in weak magnetic elds in disordered quantum wires. These have been studied mainly by means of activated transport measurements [23]. Capacitance measurements would yield the localisation length directly. Since insulators are dielectrics, with dipole moments proportional to their localisation length, the metallic divergence of the dielectrical constant is cuto , (q ! 0)  $^2$  . In general, for an insulator one obtains for T  $_{\rm c}$  = 1=  $^{\rm d}$   $_{\rm d}$ , [48]

Thus, the measurement of the dielectrical constant has been used to study the metal insulator transition [49], where the localisation length and thus the dielectrical constant is diverging [50]. For a quasi (1 dimensional wire one obtains

where is the Riemann {function [17]. Measuring the magnetocapacitance, C(B) =  $_0$ (B)S=L, where S is the cross section and L the length of the wire, one would expect an enhancement of the dielectrical constant (B) by a factor 4 as the magnetic eld is turned on. To our know ledge this positive magnetocapacitance in a wire has not yet been experimentally observed, and would be a means to study the dimensional crossover of localisation directly.

In a strong magnetic eld, the kinetic energy is quenched, resulting in enhanced localisation. While in the tails of the Landau bands the localisation length is small, on the order of the cyclotron length, it increases towards the center of the Landau bands, due to an increased classical conductance. For wires of nite width, this results in a dimensional crossover of localisation form 2 { to 1 { dimensional behavior. The noncritical crossover function derived above is relevant for localisation in higher Landau bands, where the noncritical 2D { localisation length is exponentially large, dominating its behavior since the critical point in the middle of the Landau band becomes relevant only in the 2D limit.

In the tails of the Landau bands, extended edge states exist due to the edge con nem ent potential of the wires, which can carry a quantised Hall current. W hen the dimensinal crossover of the localisation of the bulk states occurs, the edge states are expected to m ix and becom e localised along the wire. In order to study this localisation transition, the edge states have to be taken into account explicitly, by accounting for a strongly inhom genous and anisotropic conductivity. The ballsitic length scales of the edge states exceeding the elastic mean free path in the bulk, do have to be taken into account explicitly, in the derivation of the eld theory of localisation, as outlined in appendix D.A full analysis of this theory, including the edge states and the topological term, in deriving dim ensional crossover of localisation remains to be done, as well as a num erical analysis of the metalinsulator transition of the edge states in quantum Hall wires [20].

## APPENDIX B:




FIG. 7. Crossover in dimensionality as momentum of renormalisation is changed.

In a nite magnetic eld, the rst order in 1=g correction to the conductance is vanishing. An e cient way to do the perturbative renormalisation to second order in 1=g is, to start from the supersymmetric nonlinear sigmam odel and do an expansion around its classical point, as

done in Ref. [16] for the pure unitary lim it. Here we extend this derivation taking into account the nite wire width  $L_{\gamma}$ . We note that the dimensionality changes as one integrates out the Q modes from large momenta, corresponding to the smallest length scales, which is  $l_0$  in the unitary lim it, to the largest length scale, which is the localisation length , see Fig. (7).

While the disorder averaged electron wave function amplitude decays on time scales on the order of the elastic scattering time , information on quantum localisation is contained in the impurity averaged evolution of the electron density n (x;t) = < j (x;t)  $\mathring{J}$ >. Thus, nonperturbative averaging of products of retarded and advanced propagators, < G  $^{\rm R}$  (E )G  $^{\rm A}$  (E  $^{\rm O}$ ) > has to be performed to obtain information on quantum localisation.

In usefull anology to the study of spin systems, the supersym m etry m ethod contracts the information on localisation into a theory of Goldstone modes Q, arising from the global sym m etry of rotations between the retarded propagator ("spin up") and the advanced propagator ("spin down") in a representation of super elds (composed of scalar and Grassmann components). Spatial uctuations of these modes contribute to the partition function,
