On the break in the single-particle energy dispersions and the 'universal' nodal Ferm i velocity in the high-tem perature copper oxide superconductors

Recent data from angle-resolved photoem ission experiments published by Zhou et al. Nature, 423, 398 (2003)] concerning a number of hole-doped copper-oxide based high-tem perature superconductors reveal that in the nodal directions of the underlying square B rillouin zones (i.e. the directions along which the d-wave superconducting gap is vanishing) the Ferm ivelocities for some nite range of k inside the Ferm isea and away from the nodal Ferm iwave vector k_f are to within an experimental uncertainty of approximately 20% the same both in all the compounds investigated and over a wide range of doping concentrations and that, in line with earlier experimental observations, at some characteristic wave vector k_r away from k_f (kk_r = k_fk typically amounts to approximately 5% of kk_fk) the Ferm ivelocities undergo a sudden change, with this change (roughly speaking, an increase for $kk < kk_rk$) being the greatest (sm allest) in the case of underdoped (overdoped) com pounds. We dem onstrate that these observations establish four essential facts: rstly, the ground-state momentum distribution function n(k) must be discontinuous at $k = k_r$; with $v_{k_r}^c$ and $v_{k_r}^c$ denoting the measured velocities close to $k = k_r$, $kk_r k < kk_r^2 k$, and Z_{k_r} = n(k_r) = 0, we

in which v_{k_2} is the Fermi' velocity corresponding to the case in which $Z_{k_2} = 0$ (for twobody interaction potentials of shorter range than the Coulomb potential, $v_{k_{\,2}}$ v[<]_k whereby $v_{k_2^+}^{<} < v_{k_2^-}^{<} < 2v_{k_2^+}^{<}$); secondly, the single-particle spectral function A (k;") must at $k = k_2$ possess a coherent contribution corresponding to a well-de ned quasiparticle excitation at an energy of approximately 70 meV below the Fermi energy; thirdly, the amount of discontinuity $Z_{k_{e}}$ in n(k) at the nodal Ferm i points must be sm all and ideally vanishing; fourthly, the long range of the two-body Coulomb potential is of vital in portance for realization of a certain aspect of the observed behaviour in the Fermi velocities (speci cally) in the underdoped regime. The condition $Z_{ke} = 0$ conform s with the observation through an earlier angle-resolved photoem ission experiment by Valla et al. [Science, 285, 2110 (1999)], on the optimally doped compound $B_{12}Sr_2CaCu_2O_{8+}$, which shows that the imaginary part of the self-energy along the nodal directions of the Brillouin zone and in the vicinity of the nodal Ferm i points satis es the scaling behaviour characteristic of m arginal Ferm i-liquid m etallic states, for which $Z_{k_{f}}$ is indeed vanishing. W e present argum ents advocating the view point that the observed kink' in the measured energy dispersions cannot be a direct consequence of electron-phonon interaction, although a nite Z_k, may possibly arise from this interaction. In other words, even though possibly vital, the role played by phonons in bringing about the latter kink' must be indirect. Our approach further provides a consistent interpretation of the observed sudden decrease in the width of the so-called In om entum distribution curve' on kkk increasing above kk₂k.

x 1. Introduction

Angle-resolved photoem ission spectroscopy (ARPES) [1,2] provides information with regard to the singleparticle spectral function A (k;") of system s for " < , where " is the external energy parameter, the chem ical potential, k the wave vector and the spin index. The quantity measured experimentally is the photoelectron intensity I (k;") which at nite tem perature T and under som e speci ed approximations is proportional to)A (k; "), where f (") 1=1+exp $("=[k_bT])$ is the f(" Ferm i distribution function [1,2]. The experimental results obtained by Zhou et al. [3] and other workers [4[8], to be discussed in the present paper, are deduced from the so-called in om entum distribution curve' (MDC); this curve is obtained by setting out I (k;") along the desized directions in the k space for a xed value of ". A related curve, referred to as the energy distribution curve' (EDC), is obtained by plotting I (k;") for a xed k along the "axis. Am ongst others, the determ ination of the peak positions in A (k;") from the corresponding M D C does not su er from the ambiguities associated with f (").

In this paper we rst consider the relationship between the energy dispersions as measured in angle-resolved photoem ission experiments and the single-particle excitation energy dispersions as determ ined by solving the quasiparticle equation in term softhe self-energy operator; the latter accounts for the correlation in the ground states (G Ss) of the underlying system s. The form alism concerning them easured energy dispersions that follows from our purely heuristic argum ents turns out to coincide, in all details, with that developed by the present author in his recent investigations regarding the nature of the uniform m etallic G Ss of the conventional single-band H ubbard H am iltonian [9] and m ore general single-band H am iltonians [10] in which the particle-particle interaction can be of arbitrary range. The speci c aspects of the form alism developed in [9,10] that greatly suited the aim s in the aforem entioned investigations are that for the indicated G Ss it form ally yields

- (i) the exact GS total energy,
- (ii) the exact Ferm i energy,
- (iii) the exact Ferm i surface and
- (iv) the exact m om entum distribution function.

The form alism has made possible [9,10] to make exact predictions concerning the values that the GS m om entum distribution function n (k) can take fork in the close neighbourhoods of the underlying Ferm isurface Sf; . On the basis of this, it has been possible to expose [10] the signi cant in uence that the range of the two-body interaction potential can have on n (k) and consequently on the partitioning of the GS total energy into kinetic' and 'interaction' parts. This observation led us to the conclusion [10] that the experim entally-inferred excess kinetic' energy in the norm al states of the copper-oxide based high-tem perature superconductors [11,12] (for other pertinent references see [10]) may be signifying the importance of the long range of the two-body interaction potential in determ ining other distinctive aspects of the norm alm etallic states of these com pounds that m ark them as unconventionalm etals [13].

For the norm aluniform m etallic G Ss of the single-band Hubbard Ham iltonian, we have established that, so long as these are Fermi liquids, for k inside the Fermi sea and close to the Ferm i surface, a single-particle energy dispersion $"_{k:}^{<}$, which in [9,10] was attributed to some 'ctitious' particles and in this paper we reason to be the one measured through the ARPES, is up to a multiplicative k-independent constant equal to the energy dispersion "k; of the Landau quasi-particles inside the Ferm i sea (m ore precisely, the energy dispersion "k; as obtained from the quasi-particle equation in Eq. (3) below; see x 3.1); similarly for $_{k}^{*}$; (Eq. (23)) and $_{k}^{*}$; concerning k outside the Ferm i sea. For cases where the two-particle interaction potential is the long-range Coulomb potential, in [10] it was how ever show n that no such strict relationship exists between ${}^{<}_{k}$; (and sim ilarly ${}^{>}_{k}$;) and ${}^{"}_{k}$; $\binom{n}{k}$,), not even for Ferm i liquid m etallic states. In this paper we rigorously dem onstrate that in spite of these aspects, in cases where for a given $k = k_2$ the quasi-particle equation (Eq. (3) below) has solutions $"_{k_2}$; and $"^+_{k_2}$; corresponding to well-de ned Landau quasi-particles, irrespective of the nature of the two-body interaction potential $"^<_{k_2}$; identically coincides with $"_{k_2}$; (if $"^<_{k_1}$; is continuous at $k = k_2$; Eq. (27)) and $"^>_{k_2}$; with $"^+_{k_2}$; (if $"^>_{k_1}$; is continuous at $k = k_2$; Eq. (30)); we present the appropriate expressions for $"_{k_2}$; and $"^+_{k_2}$; in terms s of $"^<_{k_2}$; and $"^>_{k_2}$; respectively for cases in which either or both of $"^<_{k_1}$, and $"^>_{k_2}$; are discontinuous at $k = k_2$; according to our analysis (x 3.4), these functions cannot both be continuous at $k = k_2$.

In the light of the above-mentioned similarities between $_{k}^{\prime}$ and the possible solutions $_{k}^{\prime}$ of the quasiparticle equation associated with particle-like excitations (as opposed to collective low-lying excitations in non-Ferm i-liquid m etallic states) as well as the heuristic argum ents underlying the de nition of ${}^{"<}_{k}$ (see x 2), in this paper we assert that the ARPES data concerning the dispersion of the single-particle excitation energies are to be compared with $\mathbf{u}_{k}^{<}$. The fact that the behaviour of $\mathbf{w}_{k}^{<}$ corresponding to Ferm i-liquid metallic states of system s of ferm ions interacting through the long-range Coulom b potential in the neighbourhood of S_{f} ; dem onstrably diers from that of the asymptotic solution (see x3.1) "_k: of the quasi-particle equation in the neighbourhood of S_{f} : (see above) does not dim in ish the strength of our argum ents. In this connection we should emphasize that our assertion has bearing on the energy dispersions as m easured by m eans of the ARPES and thus does not negate the fundam ental signi cance of the possible asymptotic solutions of the quasi-particle equation, nor the essential role that these (explicitly, the asym ptotic solutions corresponding to the exact quasi-particle solutions for k 2 S_f; ; x 3.1) play in determ in ing the low tem perature therm odynam ic and transport properties of the Ferm i-liquid m etallic system s [14].

Ourpoint of departure in this paper consists of the consideration that the measured (by means of the ARPES) single-particle energy dispersions coincide with the expectation value of " with respect to the norm alized distribution of the single-particle excitations whose energies lie above E and below , that is A $(k;") = \int_{E} d" A (k;")$ (note the dependence on k of the norm alization am plitude); for system s with bounded single-particle energy spectrum (such as those described by the single-band Hubbard and the extended Hubbard Ham iltonians), E can be identied with in nity (x 2). This consideration regarding the m easured energy dispersions provides the opportunity to introduce a quantitative size for the width of the main peak in the single-particle spectral $_{k}^{\prime}$ (see Eq. (7)). A coording to this measure and under the conditions that we shall explicitly specify in the due

place, the behaviour of the width of the single-particle spectral function centred at $"_{k}^{<}$ is directly correlated with the behaviour of n (k); on transposing k through a region where n (k) undergoes a rapid decrease (increase), this behaviour is directly relected in a concom itant decrease (increase) in the latter width. This, which for m etallic states can be shown to be the characteristic aspect of the corresponding A (k;") for k approaching the underlying S_{f} , r^{1} thus turns out to be a generic property of A (k;") pertaining to system s of interacting ferm ions for k in the neighbourhoods of all points (and not solely the points of S_f;) where n (k) exhibits large local variation. According to this insight, the experimental observations in [3,5,7,8] with regard to a sharp decrease in the width of the peak in A (k;") centred at " = $\binom{4}{k}$; for $k = k_{?}$ is indicative that $k_{?}$ is a point at which the underlying GS momentum distribution functions undergo a sharp decrease, if not discontinuity. Our analysis of other aspects of the experim ental observations reported in [3[8] supports a discontinuity in the underlying n (k), with n $(k_2) > n (k_2^+)$, where kk_2 k, k is in nitesin ally sm all and k_2^+ denotes the vector nearest to the nodalFerm iwave vector k_{f} ; .

In the sections that follow, we combine our theoretical considerations with brief discussions of the pertinent experimental observations in β {8]. Our theoretical treatment in this paper is restricted to T = 0.

x 2. Preliminaries

A ssum ing that, for a given k, the experim entally determ ined A (k;") is dom inantly sharp at and symmetrical around " = "_k; (later we shall identify this energy with "_k; for reasons that will be claried), "_k; would coincide with the expectation value of " with respect to the energy distribution function h ¹A (k;"). In this connection it is important to realize that A (k;") is positive semide nite, as be ts a proper distribution function; how ever, although h ¹A (k;") is normalized to unity for " over (1;1), this is not the case for " restricted to the semi-in nite interval (1;]. Thus, under the above-mentioned conditions, for "_k; < , corresponding to bccupied' single-particle states, one should have (see Eq. (39) below)

stands for the GS m om entum distribution function pertaining to particles with spin index . The right-hand side (RHS) of Eq. (1) identically coincides with the expression for the energy dispersion ${}^{<}_{k;}$ as de ned in ² [9,10]. We note in passing that ${}^{<}_{k;} <$ for all k [9,10]. Evidently, the experimentally measured A (k;") exhibits m ore structure than a single dom inant peak, how ever so long as these additional structure correspond to highenergy processes (e.g. core-level peaks, which is not described by single-band models), for a relatively small range of k, such structure can only account for a rigid (i.e. k-independent) shift of the RHS of Eq. (1) with respect to the low-energy peak position of the experim entally determ ined A (k;").

A lthough $"_{k}^{<}$ (i.e., the RHS of Eq. (1)) is not form ally a 'quasiparticle' energy, in the sense of unconditionally being the solution of the quasiparticle equation (see later)

in which "_k is the single-particle energy dispersion describing the non-interacting system (see Eq. (36) below) and (k;") the self-energy, in [9,10] it has been rigorously shown ³ that, for k approaching the interacting Ferm i surface S_{f} , "[<]_k, approaches the exact Ferm i energy "_f; with k_{f} ; 2 S_{f} ; and ⁴ k_{f} ; (k_{f}^{+} ;) inside (outside) the Ferm i sea FS (in this paper we denote the set of k points com plan entary to FS with respect to the available wave-vector space by FS so that k_{f}^{+} ; 2 FS) and in nitesim ally close to k_{f} , we have [9,10]

The freedom in the choice of either of the two vectors k_{f} ; and k_{f}^{+} , in the above expression rejects the continuity of \mathbf{w}_{k}^{+} ; in a neighbourhood of S_{f} ; (for details see xx 3.4 and 4.2 below); our use of k_{f} ; , rather than simply k_{f} ; (the continuity of \mathbf{w}_{k}^{+} ; at $k = k_{f}$; notwithstanding), is prompted by the fact that, in cases where n (k) is discontinuous at $k = k_{f}$, the expression on the RHS of Eq. (4) is in its present form form ally ill de ned.

W e point out that for m etallic G Ss, " = " $_{\rm f}$ satis es Eq. (3); Ferm i surface S_f; is the bous of all k points for which this equation is fulled for " = " $_{\rm f}$ and m oreover " $_{\rm k}$ + h (k;" $_{\rm f}$) " $_{\rm f}$ has di erent signs for k in nitesimally transposed in opposite directions along the norm al to the constant-energy surface, i.e. S_f; , described by " $_{\rm k}$ + h (k;" $_{\rm f}$) = " $_{\rm f}$.⁵ Equation (4) presages the possibility that the RHS of Eq. (1) m ay at least be a useful m athem atical device for the purpose of estim ating the energies of the low-lying single-particle excitations in interacting m etallic system s.

As a measure both of the accuracy with which $"_{k}^{<}$ describes the location of the main peak in A (k;"), "<, and of the width of the latter peak, one can consider the variance $"_{k}^{<}$, of ". Since for the systems in which $"_{k}$ is unbounded from above, which for the uniform GSs considered in this paper is feasible only for those dened on the continuum (to be contrasted with those dened on lattice), one has A (k;") h^{2} $(k)=(2j"_{j}^{3})$ for $j"_{j}$! 1 (see Eqs. (239a) and (239b) in [19]), where

(k) stands for $a_{\rm R}$ well-de ned function, ⁶ it follows that for these systems $_{\rm E}$ d" "² A (k;") is logarithm ically divergent for E ! 1. Consequently, for systems in which "k is unbounded from above it is necessary to employ a nite energy cuto, E, in order for " $_{\rm k}^{<}$, to be a meaningful quantity. ⁷ Thus, although for the latter systems the average value of ", that is " $_{\rm k}^{<}$, is bounded for E ! 1, a consistent form alism for the determ ination of the position of the fundam ental peak and the associated width in the single-particle spectral function requires introduction of a single cut-o energy throughout. We thus de ne (see Eqs. (1) and (39))

For system s with bounded " $_{k}$, E in the above expressions can be equated with +1. For system s with unbounded " $_{k}$, it is necessary to set E equal to some nite value; how ever, none of the main results in this paper crucially depends on the precise value chosen for E so long as this value is greater than the absolute values of the energies of interest, speci cally " $_{k;}^{<}$. Consequently, in the remaining parts of this paper we have out E as the argument of the pertinent functions; for consistency with the results in [9,10] (which do not consider " $_{k;}^{<}$), at places we still write 1, rather than E, in the lower boundaries of the integrals over ".

It is interesting to note that according to the RHS gf Eq. (7) a smooth (or continuous) behaviour in $_{\rm E}$ d" "² A (k;") and "[<]_k; in the neighbourhood of a point k?, where n (k) undergoes a steep (or discontinuous) change, must be accompanied by a decrease or increase in $\binom{<}{k}$ (corresponding to a narrow ing or broadening of the peak centred around ${\sf m}^<_{k_2}$;) upon transposing k from k_2 to k_2^+ , depending on whether n (k_2) > n (k_2^+) orn $(k_2) < n (k_2^+)$ respectively. This observation is based on the non-negativity of the argument of the square root function on the RHS of Eq. (7) for all k. In fact, in x 3.7 we rigorously demonstrate that, at points where $\mathbf{u}_{k}^{<}$ is continuous (such as the points of the underlying Ferm i surface; see x 3.4) and n (k) is discontinuous, " $_{k}^{c}$, must necessarily be discontinuous. In the light of this, the sudden decrease in the width of the M DC at $k = k_{?}$ (while transposing k towards the nodal Ferm i point k_f; along the nodal direction of the rst Brillouin zone (1BZ)) in the experimental observations by Zhou et al. [3] (corresponding to the hole concentration x = 0.063) is indicative of a sharp decrease (if not discontinuity) in n (k) at $k = k_2$. The same applies for the sim ilar observations in [5,7,8].

It is important to realize that, for interacting GSs, " $_{k}^{<}$, does not vanish for any k, not even for k ! S_f; . This follows from the fact that, with the exception of " = " $_{k}^{<}$, (" " $_{k}^{<}$,)² is positive everywhere along the " axis and that A (k;") 0, 8". For non-interacting GSs, where A (k;") consists solely of a single function (see appendix A), the corresponding " $_{k}^{<}$, is naturally identically vanishing.

In order to appreciate the signi cance of $\binom{m}{k}$, it is appropriate to consider the following. Ferm i-liquid m etallic states are characterized by smooth quasiparticle energy dispersions $\binom{m}{k}$; in some neighbourhood of the underlying S_{f} ; (see x 3.1), a property that on general grounds

ventional Ferm i-liquids, Sf; constitutes the locus of the k points in the vicinity of which the underlying n (k) undergoes its strongest variation (see footnote 1). W ith these in m ind, our above-m entioned statem ent with regard to the behaviour of $"_{k}^{<}$, is seen to be in full conform ity with the fact that for the Ferm i-liquid m etallic states the width of the quasi-particle peak, centred at " = $"_{k;}$, in the corresponding A (k;") also dim inishes. It is important at this point to realize that the descend towards zero of jm [(k;")]j (which in the case of the conventional Ferm i liquids is like ("k; $({}^{r}_{f})^{2}$) for k approaching S_{f} ; does not imply the same for $\binom{<}{k}$; (which otherwise would contradict our above statem ent with regard to the strict positivity of the latter quantity in the case of interacting GSs), for $"_{k}^{<}$ takes account of A (k;") in its entirety and not solely of the coherent contribution to A (k;") (i.e. S (") in Eq. (8) below) which indeed has a vanishing width.

In the light of the above observations, we conclude that the standard variance ${}^{"}_{k}$; de ned in Eq. (7) provides a reliable representation of the width of the peak in the single-particle spectral function A (k;") centred at " = ${}^{"}_{k}$; for k close to any point (which m ay or m ay not be a point of S_f;) at which ${}^{"}_{k}$; is continuous and the underlying n (k) undergoes a sharp or discontinuous change.

x 3. Generalities

3.1. Som e rem arks on the single-particle excitation energies

For an arbitrary wave vector k the quasiparticle equation, Eq. (3), has in general no solution. ⁸ In spite of this, in cases where k is located in a small neighbourhood of a point, say k_0 , where Eq. (3) is satis ed and the self-energy is su ciently smooth with respect to k (for " = " k_0 ;) and " (for k = k_0), an energy dispersion " k_i ; is capable of being de ned through an asymptotic series in terms of the asymptotic sequence $f(k = k_0)$ ' k' = 0;1;::g, with the zeroth-order term in this series coinciding with the exact solution " k_0 ; of Eq. (3); we thus refer to " k_i ; as the asymptotic solution

Here and in the following when stating that, for an arbitrary k, in general, Eq. of Eq. (3), re ecting the fact that, for the k at issue, Eq. (3) has no true solution. By the non-analytic nature (k;") at $(k;") = (k_0;"_{k_0};)$ (see later), the aforeof mentioned series can only be of nite order, that is there exists some nite integer $'_0$ such that the coe cient of the 'th-order term in this series will be unbounded for). Ferm i-liquid m etallic states are those for which the $'_0$ corresponding to all k in the neighbourhood of the underlying Ferm i surface S_f; is strictly greater than unity [18,19,9]; the e ective m ass, or the Ferm i velocity, of the Landau 'quasi-particle' at k is related to the coe cient of the asymptotic term linear in (k k₀), with $k_0 \ 2 \ S_f$; for an isotropic m etallic G Ss the latter coe cient is in general a non-diagonal Cartesian tensor.

C oncerning the above-m entioned non-analytic nature of (k;") at $(k;") = (k_0;"_{k_0};)$, this follows from the fact that for interacting systems (speci cally those in the therm odynam ic lim it) the solutions of the quasi-particle equation are not isolated points but accum ulation points [18,19]; this aspect is directly related to the overcom – pleteness of the set of am plitudes of the single-particle excitations (the so-called Lehm ann am plitudes) in the single-particle H ilbert space of interacting H am iltonians (see [19]).

In view of the speci c applications in this paper, we mention that even for single-band models, based on a non-interacting energy dispersion (in this paper denoted by "_k), the possible solutions of Eq. (3) for a given k occur in pairs (for a more precise speci cation see footnote 9 below), of which one is associated with point k and one with point k⁺ where k and k⁺ are in nitesimally close to k (see Fig. 1). This aspect, which is universally neglected in the literature for k 2 S_f; (see how ever [18] and speci cally [9]; see also footnote 5 above), attains an extraordinary signi cance in cases where the abovementioned k is located at some nite distance from S_f; (considering for the moment metallic G Ss), and hence our explicit reference to "_k; "_k; in x 1 (see Eq. (13) below). This aspect will be fully clari ed in x 3.2 below.

3.2. Regular and singular contributions to the single-particle spectral function A (k;")

In anticipation of our follow ing discussions and in view of Eq. (4) it is instructive to introduce a decom position of A (k;") in terms of its regular ('incoherent') and singular ('coherent') parts. To this end, let k_2 denote a wave vector at which n (k) is singular (not necessarily discontinuous). For $k = k_2$, where k_2 are in nitesimally close to k_2 and whose distinction is in plicitly determ ined through Eq. As is evident, the discontinuity of n (k) at $k = k_{?}$ requires that $"_{k_{?}}$; < , for otherwise S (") would not have any impact on the behaviour of n (k), de ned according to Eq. (2). On the other hand, the discontinuity of n (k) at $k = k_{?}$ implies discontinuity of 1 n (k) at $k = k_{?}$, which, following Eq. (12), can only materialize if the condition $"_{k_{?}}$; > is satis ed [9].

Since for $k_{?}$ located at some nite (i.e. non-vanishing) distance from S_{f} ; the solutions $"_{k_{?}}$; and $"_{k_{?}^{+}}$; dier by some nite amount ¹⁰ (see xx 4.2 and 4.3 as well as

Fig. 1), it is of crucial in portance that particular attention is given to the superscripts and + in $"_{k_{\alpha}}$; which as a matter of habit one is apt to ignore. We shall elaborate on the single-particle energies " $_{\rm k}$, and the relationship between these and ${n_k}^{\flat}$ in x 3.5 where we are equipped with the details necessary for this task. Su ce it for the m om ent to m ention that the single-particle excitation energies of single-band models can be viewed as consisting of at least (see footnote 9) two branches, conveniently denoted by $"_k$, with $"_k$, < and $"_{k^+}$, > . The energy dispersions $\mathbf{w}_{k}^{>}$ dealt with in this paper are caricatures of " $_{k}$, which, how ever, when continuous at the points of discontinuity of n (k) (see x 3.4), coincide with $''_k$; (cf. Eqs. (27) and (30) below). From this perspective, it is more transparent to denote " $_{k}$; by " $_{k}$. In this paper we shall therefore alternately use the following convention:

This result is of experimental signi cance, as the possible singular contribution to A $(k_{f;}; ")$ is not capable of being resolved in real experiments. It is also of significance to our subsequent considerations as it shows that, for k su ciently close to S $_{f;}$, there is no restriction on the actual shape of the corresponding R (") in order for the expression on the RHS of Eq. (1) to am ount to a reliable description of the dispersion of the low -lying single-particle excitations in interacting system s, this in surprising contrast with the heuristic arguments in x 2 that initially motivated our introduction of the expression in Eq. (1). For illustration, assuming that n (k) is discontinuous at $k_{?} = k_{f;} 2 S_{f;}$ and denoting $Z_{k_{?}}$; by $Z_{k_{f;}}$, from Eqs. (2), (8) and (9) we obtain the following relationship: ¹¹

which is a well-known M igdal [21,22] theorem .

3.3. On ratios of discontinuous functions

A result that proves considerably useful in our considerations in this paper is based on some simple observations. Let

3.4. Possible discontinuities in $\binom{1}{k}$ and $\binom{1}{k}$

Some of the crucial results in this paper rely on the condition of continuity of $\mathbf{u}_{k_{i}}^{<}$ at such points as $k = k_{i}$ where n (k) is discontinuous. For m etallic states, where $\binom{m^{>}}{k_{?}}$, and $\binom{m^{<}}{k_{?}}$, are up to innitesimal corrections equal to $\texttt{"}_{f}$ for $\texttt{k}_{?}$ = \texttt{k}_{f} ; 2 S_f; [9,10], the LHS of Eq. (26) is vanishing for $\texttt{k}_{?}$ 2 S_f; so that, by the arguments presented in [9], Eq. (26) establishes the continuity of $\texttt{"}_{k}$; and $\texttt{"}_{k}$; at k = $\texttt{k}_{?}$ 2 S_f; (see also x 4.1).

For k_{2} at a nite distance from S_{f} , the LHS of Eq. (26) is strictly positive (see footnote 10), from which and from Eq. (26) it follows that at least one of the two functions ${}_{k}^{<}$, and ${}_{k}^{>}$, must be discontinuous at $k = k_{?}$. For $k_{\, ?}$ su ciently close to S $_{\rm f;}$, on account of the afore- S_{f} ; and on account of the fact that these functions are required to achieve the value $"_{\rm f}$ at the latter points, it is most likely that, for a possible discontinuity of $"_{k}^{<}$, at $k = k_{?}$, one has $\mathbf{m}^{<}_{k_{?}}$; $< \mathbf{m}^{<}_{k_{?}^{+}}$; and that, for a possible discontinuity of $\mathbf{m}^{>}_{k_{?}}$; at $k = k_{?}$, $\mathbf{m}^{>}_{k_{?}^{-}}$; $> \mathbf{m}^{>}_{k_{?}^{+}}$; Raising the status of these observations to facts, an inspection of the signs of the term s on both sides of Eq. (26) reveals that the possibility of a continuous ${\bf u}_k^>$, and discontinuous $\mathbf{w}_{k}^{<}$ at $k = k_{?}$ is ruled out; in contrast, a similar inspection reveals that a continuous $\mathbf{w}_{k}^{<}$, and discontinuous $\mathbf{W}_{k:}^{>}$ at $k = k_{?}$ is potentially feasible. On the same grounds, it is in principle possible that both $\binom{1}{k}$; and $\binom{1}{k}$; are discontinuous at $k = k_{?}$ although, in such an event, $_{k}^{*}$ is required to undergo a larger amount of discontinuity (as implied by Eq. It is interesting to point out that the energy dispersion as measured by Zhou et al. [3] corresponding to $(La_2 \ _x Sr_x)CuO_4$ in the extrem e underdoped lim it, where x = 0.03, appears to exhibit a nite amount of discontinuity at $k = k_2$. On identifying the measured energy dispersion with $\binom{n}{k_2}$, it is observed that it indeed satisfies the relationship $\binom{n}{k_2}$; suggested above on general grounds.

In our above considerations we have been able to deduce a number of properties associated with " = " $_{f}$ and k = k_f; 2 S_f; by speci cally relying on the property of continuity of $\mathbf{m}_{k}^{<}$, at $k = k_{f}$; 2 S_f; (see x 3.4). Here we explicitly assume ${}^{\prime\prime}_{k}$; to be continuous also at k ${\tt g}$ S_f; , speci cally at $k = k_2$ where n (k) is discontinuous; follow ing the analysis in x 3.4, $\frac{m^{>}}{k}$; m ust therefore by necessity be discontinuous at $k = k_2$. Let the latter k_2 be further located inside the Ferm i sea of the GS of the system under consideration; for the ensuing discussions it is not necessary that this GS be m etallic. The general expression for $_{k}^{\prime\prime}$ can be cast into the form $_{f} = _{g} = h(x_{0})$ (see Eq. Equation (27) is to be contrasted with the more speci c exact result in Eq. (4) above. In this connection we should point out that the validity of Eq. (4) does not depend on whether n (k) is discontinuous at $k = k_{f_{\gamma}}$ 2 S_{f_{\gamma}}. This suggests that the validity of Eq. (27) may similarly not depend on the assumed discontinuity (as opposed to the more general condition of singularity) of n (k) at the $k = k_{\gamma}$ under consideration; at the time of writing this paper, we are not in a position to make a de nite statem ent on this aspect. In this connection note that in general n (k) is singular (not necessarily discontinuous) for all k 2 S_f; [9,10].

In the light of the results in Eqs. (4) and (27), it is important to point out that, for Ferm i-liquid metallic states of the single-band Hubbard Ham iltonian (if such states at all exist), we have shown [9] that the gradient of the quasi-particle energy dispersion "k; (or the Ferm ivelocity timesh) for k inside the Ferm isea and in the close neighbourhood of S_f ; diers from $r_k {''_k}$; by a multiplicative constant, , which we have shown [9] to approach unity 13 on reducing the on-site interaction energy U. It follows that in general the validity of (27) does not extend beyond the points k where n (k) is discontinuous; in other words, in general the asymptotic series expansions of " $_{k}$; and " $_{k}$; centred around a k, say k?, at which n (k) is discontinuous (so that " = " $_{k_{2}}$; satis es Eq. (3) at $k = k_2$; see x 3.1), only agree to the leading order and deviate at higher orders in $(k = k_2)$; analogously for $"_k^+$, and $"_k^>$, in the event that $"_k^>$, is continuous at k = k? (see how ever the last but one paragraph in x 3.4). This aspect becom es clearly evident by considering the two-body interaction potential to be the long-range C oulom b potential. In this case, $r_k "_{k:}^{<}$ is logarithm ically divergent for k approaching the points of discontinuity of n (k) (see x 4; see also [10]), a property that m ay or m ay not be shared by r $_{k}$ " $_{k}$; for instance, for Ferm i-liquid metallic states, r k "k: is by de nition [18] bounded, satisfying

The fact that the two important k points that feature in the experimental observations as reported in [3{8], namely the nodal Fermi point k_{f} ; and $k_{?}$, are relatively very close to one another (typically, kk_{f} ; $k_{?}k$

am ounts to approxim ately 5% of kkf; k), im plies, follow ing Eqs. (4) and (27), that the fundam ental distinction between " $_{k}$; and " $_{k}$; must be of m inor observational consequence for k inside the interval between k_2 and k_{f} ; along the diagonal direction of the 1BZ compared with outside. In other words, in the light of Eqs. (4) and (27), it is expected that, for k inside the latter interval (between $k_{?}$ and k_{f} ;), ", and ", should to a good approxim ation coincide. In the speci c case at hand, where one of our main conclusions drawn from the experimental observations in $[3\{8\}, \text{speci cally those by Zhou et al. } [3],$ is that the underlying n (k) is continuous at the nodal points of the Ferm i surfaces of the compounds studied (see x 4.1), the above-m entioned di erences between $"_{k}$: and $\mathbf{w}_{k}^{<}$ should be minimal for k in the close neighbourhoods of the nodal Ferm ipoints.

Concerning the 'universality' in the nodal Ferm i velocities as observed by Zhou et al. $[\beta]$, since in all cases (whether di erent cuprate com pounds are concerned or a specic compound at dierent levels of hole doping) the corresponding Ferm i energies are chosen as the origin of energy, it follows that the above-mentioned universality of the nodal Ferm i velocities is indicative of the universality of the energy dierence " $_{
m f}$ "?, where ${}_{k_{2}}^{\prime\prime}$. This in turn is suggestive of the pos-"? **≔** "_{k ?}; sibility that the root cause of the discontinuity in n (k) at $k = k_2$ should be external to the electronic degrees of freedom, such as longitudinal optical phonons which have been suggested [5,8] as inducing the kink', or break', in the observed single-particle energy dispersions in the investigated cuprates. For an extensive discussion of this aspect see x 5 w here we argue that, w hereas phonons m ay be vital in bringing about the observed kinks' in the energy dispersions, they cannot be the imm ediate cause but possibly a secondary determ inant through their modi cation of the electronic states in such a way that n (k) is rendered discontinuous at $k = k_2$ inside the underlying Ferm i seas and that " $_{\rm f}$ "? is close to 50 to 70 m eV. It is important to point out that, with the exception of rigid parabolic bands, all rigid tight-binding bands give rise to relatively strong variation of the bare mass of ferm ions as a function of doping; such variation has undoubtedly consequences for the corresponding dressed m ass and thus the interacting Ferm i velocity which, in such cases as considered here, can be arti cial and undesirable. The experim ental observations by Zhou et al. [3] are thus suggestive of the possibility that rigid tightbinding bandsm ay not be appropriate (speci cally) while dealing with the cuprate compounds. The unsuitability of rigid tight-binding bands (as well as rigid on-site interaction energies) in general is the essential argum ent underlying the dynam ic Hubbard model proposed by Hirsch [24] (see also [25] and the references therein) and their shortcom ings speci cally in applications concerning the cuprate com pounds has been explicitly em phasized in [9].

The results in Eqs. (27) and (30), which cannot simultaneously hold (see x 3.4), gain special signi cance by realizing the fact that ${}^{<}_{k}$, and ${}^{>}_{k}$, correspond to a single-particle spectral function A (k;") introduced in [9,10], de ned for all k as follows

In [9,10] a num ber of salient properties of A (k;") have been explicitly demonstrated. For instance, on replacing A (k;") by A (k;") in the expression for the total energy of the GS of the interacting H am iltonian \mathbb{P} , one obtains exactly the same value, that is the exact GS total energy. Although in [9,10] A (k;") was associated with some ctitious particles, having some direct significance to the properties of the single-particle excitations in the neighbourhood of S_{f} ; , Eqs. (27) and (30) unequivocally show that A (k;") has special signi cance also for all k outside S_f; where n (k) is discontinuous (as we have indicated earlier, this signi cance may also extend to all points outside S_f; where n (k) is merely singular and not speci cally discontinuous). W ith this in m ind, Eq. (32) show sthat, at such points as $k = k_2$ where n (k) undergoes a discontinuous change, this is accompanied by an equally discontinuous redistribution of the spectral weights of the peaks in the single-particle spectral function centred at " = " $_{k}$; and " = " $_{k}^{+}$; (see Eqs. (27), (28), (30) and (31)). Concerning the general subject of the spectral weight redistribution in interacting systems as described by the Hubbard Ham iltonian, we refer the reader to [26], and for related considerations concerning specic strongly correlated systems to [27{29]. We em phasize once m ore that Eqs. (27) and (30) are local (i.e. they apply to isolated points, such as k_2 is, and not to open dom ains of the k space) so that they do not im ply equality of r_k , with r_k , at $k = k_2$.

3.6. On the num ber of solutions of the quasiparticle equation at $k = k_{f}$, corresponding to well-de ned quasiparticles

In x 3.4 we have presented details which rigorously demonstrate the continuity of $"_{k_{i}}^{<}$ for k in the neighbourhood of $S_{f_{i}}$ (see also x 4). A corollary to this result in conjunction with Eq. (19) is that, in cases where the S (") corresponding to $k_{i} = k_{f_{i}}$ is not identically vanishing, one must have

This result establishes that, for $k_{?} = k_{f;}$, Eq. (3) cannot possess more than one solution corresponding to a well-de ned quasiparticle; that is to say, in cases where n (k) is discontinuous at $k = k_{?}$ and $k_{?} 2 S_{f;}$, the expression for S (") in Eq. (9) is the most general expression. ¹⁴ The proof of this statement is as follows. We thus arrive at the general conclusion that, at points (which may or may not be points of $S_{f_{i}}$) where n (k) is discontinuous, $"_{k_{i}}^{<}$ and $"_{k_{i}}^{<}$ cannot both be continuous; at $k = k_{f_{i}}$ 2 $S_{f_{i}}$ where $"_{k_{i}}^{<}$ is continuous (see x 3.4), $"_{k_{i}}^{<}$ must be discontinuous in cases where n (k) is discontinuous.

(35), g (which has the dimension of energy) is the coupling constant of interaction, " $_{k}$ is a spin-degenerate single-particle energy dispersion (which m ay or may not be isotropic), C_{k}^{y} , and C_{k} ; are the canonical creation and annihilation operators respectively for ferm ions with spin index , gw (kqk) v (kqk) is the Fourier transform of the two-body interaction potential v ($r r^{0}$) (assumed to be isotropic), and $= L^{d}$ is the volume of the (m acroscopic) d-dimensional hypercubic box occupied by the system. The wave-vector sum s in Eqs. (36) and (37) are over a regular lattice (the underlying lattice constant being equal to 2 = L) covering in principle the entire reciprocal space. On e ecting the substitutions

(38), while maintaining the above-mentioned restrictions concerning the wave vectors, the H am iltonian in Eq. (35) coincides with an extended' Hubbard H am iltonian.

We should emphasize that, although $"_{k_1}^< < .$, nonetheless $"_{k_1}^<$ is de ned over the entire available k space; this we have m ade explicit in Eq. (39) through 8k. We note in passing that, similar to $"_{k_1}^<$ and following the same techniques as employed in [9,10,19], for systems corresponding to bounded $"_k$, one can readily express $"_{k_1}^<$ (E ! 1), as de ned in Eq. (7) above, in term s of G S correlation functions.

A long the same lines as used in [9,10] it can be shown 15 that, for the set S of K points for which $^{"<}_{K}$, coincides with "f, the function

This observation is signi cant in that it shows that, for k 2 S_f; where $\mathbf{m}_{k_{j}}^{<} = \mathbf{m}_{f}$ and n (k) is generically (but not necessarily) discontinuous, the energy dispersion $\mathbf{m}_{k_{j}}^{<}$ is continuous in the neighbourhood of S_f; (see also x 3.4). W ith reference to Eq. (19), it follows that, in cases where n (k) is discontinuous at S_f; , \mathbf{k}_{j} ; m ust undergo a discontinuity commensurate with that in n (k) at S_f; (and indeed at any set S introduced above) for which $\mathbf{m}_{k_{j}}^{<}$ attains the value \mathbf{m}_{f} (see x 3.4); in appendix A this aspect is made explicit within an approximate framework. In what follows, unless we explicitly indicate otherwise, we assume $\mathbf{m}_{k_{j}}^{<}$ to be continuous for all k.

The experimental ARPES data in β {8] indicate that the measured "_k; (i.e. "[<]_k; from our present standpoint) behave linearly as function of k k_f; for a nite range of k away from k_f; ; focusing on the data in β], this is the case for kk k_f; k varying between zero and approximately 5% of kk_f; k for k_f; a nodal Ferm i wave vector along the (0;0) (;) direction of the underlying square-shaped 1BZ.W ith "_k being linear in k k_f;

In other regions of the k space where ${n'_{k}}^{*}$; ${n'_{k}}^{*}$, a possible singular behaviour in r ${k''_{k}}^{*}$ in some neighbourhood can in principle entirely or partly be accounted for by a similar behaviour in r ${k''_{k}}$ (k). ¹⁷ The above observations will prove useful in our subsequent considerations below .

Since n $(k_{f_i}) = 0$ corresponds to the peculiar condition A (k_f.;") 0, for all "2 (1;] (see Eq. (2) above), we discard the condition in Eq. (55) for being unphysical in the present context where Eq. (43) is held as valid on account of experim ental observations. It thus follows that, for the case of C oulom b-interacting particles, $Z_{k_{fi}}$ cannot be positive, whereby Eq. (55) is rendered obsolete. A ssum ing $Z_{k_{f_{f}}}$ to be positive but relatively small, it is not inconceivable that, for k su ciently close to k_{f} ; , j_{k} ; jbehaves sim ilarly to j_{k} ; jas presented in Eq. (55) which experiments by Zhou et al. [3] may not have resolved. Consequently, at this stage the possibility of Eq. (55), and thus of $Z_{k_{f_1}} > 0$, cannot be unequivocally rejected. We point out that here we are relying on our standpoint that experim entally one m easures $_{k}^{\prime}$ rather than the 'solution' to Eq. (3). For completeness, in [10] (x 6.1.3) the consequences of j_k ; jsatisfying an asymptotic relation similar to that in Eq. (55) have been investigated in some detail. In [10] (x 6.1.3) it has been emphasized that, for ferm ions interacting through the long-range Coulomb potential, Ferm i-liquid metallic states belong to the category of states for which, as $k \mid k_{f}$; 2 S_f; , k_{f} ; satis es Eq. (55) and k_{f} ; fulls a functionally sim ilar expression.

We conclude that the assumption of the validity of Eq. (43) can be compatible with a picture of ferm ions interacting through the long-range C oulom b potential (or a potential as long ranged as this) only if $Z_{k_{f_i}} = 0$. This condition is satistic ed (not exclusively) within the fram ework where the norm alm etallic states of the copper-oxide based superconductors along the nodal directions of the 1BZ are of a marginal Ferm i-liquid type [32]. This view - point enjoys direct experimental support through the angle-resolved photoem ission experiments by Valla et al. [4] along the nodal directions of the 1BZ concerning the optim ally-doped compound Biz Sr₂C aC u₂O ₈₊.

The experimental results by Zhou et al. [3] further show that, at $k = k_2$, with $kk_2 = k_f$; k approximately 5% of kk_{f} ; k, $\mathbf{w}_{k}^{<}$, is singular, the singularity appearing to be a discontinuity in the slope of $\mathbf{w}_{k}^{<}$, in the overdoped regime and some stronger singularity in the underdoped regime. The strongest singularity that can be expected from $"_{k}$ is a discontinuity (see x 3.4), followed by (in the order of signi cance), for two-body interaction potentials as long ranged as the Coulom b potential, a logarithm ic divergence in $r_k "_{k}^{<}$ for k approaching the points of discontinuity of n (k). We believe that the observations by Zhou et al. [3] are highly supportive of the view point that, at least in the underdoped regime, the long-range of the Coulom b potential can be of considerable signi cance in determ ining the (unconventional) physical properties of these compounds. For clarity, for the hole doping fraction x = 0.03 concerning (La_{2 x}Sr_x)CuO₄ (LSCO), one observes a behaviour in the measured energy dispersion [3] which is rem in iscent of a discontinuity superim posed by a contribution whose gradient is logarithm ically divergent at $k = k_2$.

4.2. On the relationship between discontinuities in n (k) and r $_k \, {}^{w^<}_{k\, \cdot}$

Here we demonstrate that singularity (not necessarily discontinuity) of n (k) at a point is directly rejected in the behaviour of $r_k "_{k;}^{<}$ at the same point. We shall explicitly consider the case where n (k) is discontinuous in the interior of FS nS_{f;}; concerning the behaviour of $r_k "_{k;}^{<}$ for k ! $k_{f;}$ 2 S_{f;}, this is in plicit in our earlier work [9,10] which for completeness we recapitulate in the following. In this connection, note that n (k) is always singular (not necessarily discontinuous) on S_{f;} [9,10].

For k 2 $S_{f;}$, $"_{k;}^{<}$ and $"_{k;}^{>}$ attain the value "f (up to in nitesimal corrections) so that the exact inequalities $"_{k;}^{<}$ and $"_{k;}^{>}$ > [9,10] in ply that, for "k a smooth function of k in the neighbourhood of $S_{f;}$, it is required that r k k; undergo at least ¹⁸ a discontinuous change for k transposed through $S_{f;}$ from in nitesimally inside to in nitesimally outside the Ferm i sea. From Eqs. (59) and (58), one observes that on k crossing S_f; (from inside to outside the Ferm i sea), indeed the derivative of k; with respect to k in the direction norm al to S_f; undergoes a discontinuous change (this amounts to 2b + a = g > a (2 = + 1)0), from the positive value b at $k = k_{f}$ to the negative value (b + a =g) at k = k_{f}^{+} . Sim ilar behaviour is shared by the k; pertaining to system s of ferm ions interacting through two-body potentials of arbitrary range. An analogous discontinuity takes place in \hat{n} (k_f;) ₽£ "≥ on transposing k through S_f; . For Ferm i-liquid m etallic GSs of system s in which the two-body interaction potential is of shorter range than the Coulom b potential, the functions ${\tt "k}_k^{<}$ and ${\tt "k}_k^{>}$ are such that, on transposing k from inside to outside the Ferm i sea, the continuous and di erentiable extension of ${}^{">}_{k}$, coincides with ${}^{"<}_{k}$, in the close neighbourhood of S_f; (see Fig. 3 in [9]). On the basis of this fact and a number of available num erical results, in [9] we arrived at the conclusion that, in the case of the single-band Hubbard Ham iltonian described in terms of the nearest-neighbour hopping integral t and the on-site interaction energy U, the corresponding $_{k}^{<}$ and $"_{k:}^{>}$ fail to posses the latter property for U = t[>] 8 (see footnote 27 below).

It is reasonable to believe that this feature has its root in the magnitude of Z_{k_2} ; which for an increasing level of (hole) doping should be decreasing, rendering thus the in uence of the long range of the two-body Coulom b potential at $k = k_2$ less e ective. In order to maintain a non-vanishing amount of discontinuity in $v_{k:}^{<}$ at $k = k_{?}$, however, following Eq. In Fig. 3 we present results concerning $\mathbf{w}_{k}^{<}$ "k + g_k ; within an approximate framework in which k; has the functional form of the Hartree-Fock self-energy (see appendix A; Eq. (A 21)), evaluated in terms of a momentum distribution function n (k) which is continuous at the nodal Ferm ipoint k_f; and discontinuous at $k = k_2$. The results in Fig. 3 concern a planar squarelattice model (for the relevant parameters see the caption of the gure) and the two solid curves correspond to two densities of particles representing the underdoped and overdoped regions of the hole-doped cuprates. We obtain almost identical results as in Fig. 3 by employing an isotropic model de ned on the continuum and for one, two and three spatial dimensions; ²² our observations concerning d = 1 are particularly relevant in light of the fact that in the superconducting state, or in the advanced stages of the pseudogap phase, the experim ental observations along the nodal direction of the 1BZ should be in uenced by the reduced wave-vector space available to gapless excitations. Not surprisingly, our num erical calculations for d = 2 reveal that sim ilarly all qualitative aspects of the results in Fig. 3 rem ain intact by m odeling n (k) in such a way that the discontinuity in n (k) is anisotropic, taking its maximum value at $k = k_2$ along the diagonal directions of the 1BZ and dim inishing for directions away from the diagonal directions.

Considering the fact that, in real materials, charged ferm ions interact through the long-range Coulomb potential, the experimental results by Zhou et al. β , as well as those by other workers [4{8], should be viewed as consisting of a superposition of the results in F igs. 2 and 3; here we are leaving aside the possibility of a discontinuity in $\mathbf{w}_{k}^{<}$ at $k = k_{?}$ which is theoretically feasible (see x 3.4) and appears to be realized in the underdoped (La_{2 x}Sr_x)CuO₄ [3], speci cally at x = 0.03.

A n important aspect of the result in Eq. (100) is the following. In x 4.1 we have emphasized that, for metallic G Ss of ferm ions interacting through potentials which are as long ranged as the C oulom b potential, $r_k "_k$, logarithm ically diverges for k approaching any region where n (k) undergoes a discontinuous change [10]. in follow s that any logarithm ically divergent contribution that m ay be contributing to $r_k "_{k_1}^{<}$ for $k ! k_2$, which by necessity has the same sign for $k ! k_2$ and $k ! k_2^{+}$, ²⁶ cancel. Thus, even though for the above-mentioned system s $r_k "_{k_1}^{<}$ is divergent for $k ! k_2$, for these system s, following Eqs. (100) and (101), v_{k_2} ; is bounded.

Finally, we point out that Eq. (100) is not applicable to cases in which $k_2 \ 2 \ S_f$; This aspect is moted in the failure of Eq. (85) for $k_2 \ 2 \ S_f$; which, in turn originates from the fact that, on all points of S_f ; $n_{k_1}^{<}$ acquires its maximum value (namely "f) [9,10]. x 5. Summary and discussion

In this paper we have presented a set of com plem entary pieces of evidence indicating that the single-particle energy dispersions as deduced through the ARPES are in that form ally is a solution of the quasi-particle equation (Eq. (3)). We have shown that, in addition to ${}^{"<}_{k}$, coinciding with "k; on the Ferm i surface Sf; of metallic GSs, the two energy dispersions are equal at any point inside the underlying Ferm i sea FS where the GS momentum distribution function n (k) undergoes a discontinuous change and $\mathbf{m}_{k}^{<}$ is continuous; at the time of writing this paper the question remains open whether this property is retained when the last-mentioned discontinuity in n (k) is replaced by a more general kind of singularity. One of the conclusions that we draw from the analysis of the experim ental data obtained by Zhou et al. [3] as well as by other workers $[4\{8\}]$ is that (in particular), along the nodal directions of the 1BZs of the cuprate compounds investigated by the latter workers,

n (k) is discontinuous at a point k? located in the close vicinity of the nodal Ferm i point k_f; (kk_f; k_?k typically amounts to some 5% of kk_f ; k). From this and our aforem entioned nding with regard to the equality of " $_{k_{1}}$ and " $_{k_{1}}^{<}$ at k_{2} and $k_{f_{1}}$, we have concluded that in the interval along the diagonal direction of the 1BZ between k_{2} and k_{f} ; the two energy dispersions " $_{k}$; and $\mathbf{u}_{k}^{<}$ should be in general experimentally indistinguishable (see Fig. 2). For ferm ions interacting through the long-range Coulom b potential, " $_{k}$; and " $_{k}^{<}$; have distinct behaviours in the neighbourhoods of points where n (k) is discontinuous (x 4.1). Since, according to our analyses, the n (k) corresponding to system s studied by Zhou et al. [3] must be either continuous or only slightly discontinuous at $k = k_{f}$; , we have arrived at the conclusion that the in uence of the long-range of the Coulom b interaction potential should be strongest at $k = k_2$. The experimental data obtained by Zhou et al. [3] indeed show that for the underdoped sample (La_{2 x}Sr_x)CuO₄, corresponding to for instance x = 0.03, the measured energy dispersion shows behaviour in the vicinity of k_2 that markedly diers from similar energy dispersions corresponding to optim ally-doped and over-doped sam ples of (La_{2 x}Sr_x)CuO₄. This di erence can be viewed as consisting of two separate contributions, namely a nite discontinuity and a logarithm ic divergence in the slope of the energy dispersion at $k = k_2$. The form er is consistent with the exact result obtained in x 3.4 according to which $\mathbf{w}_{k}^{<}$ can undergo a discontinuous change at points inside FS where n (k) is discontinuous, and the latter is feasible only if the two-body interaction potential is as long ranged as the Coulom b potential. Our point of departure in this paper has been based on the consideration that single-particle energy dispersions as measured by the ARPES coincide with the average value of " with respect to the norm alized energy distribution function h ^{1}A (k;")=n (k); this average value we have denoted by $\mathbf{w}_{k_{i}}^{<}$. Throughout this paper we have presented a host of evidence to support this point of view. On the basis of this view point we have proposed the standard variance ${}^{\prime}_{k}$, of ${}^{\prime}$ with respect to the above-mentioned normalized energy distribution function as corresponding to the measured width of the peak in A (k;") centred at ${}^{\prime}_{k}$. [3] observed a decrease in the electron scattering rate (i.e. the width of the MDC) at the same energy as a discontinuity in the gradient of the energy dispersion is observed on transposing k from below ' to above' k2, corresponding to $kkk < kk_2k$ and $kkk > kk_2k$ respectively. This decrease in the scattering rate is in full conform ity with the sign associated with Z_{k_2} ; $= n (k_2) n (k_2^+)$ which has to be positive in order for the change in the energy dispersion as described by the expression deduced in this paper (Eqs. W e thus observe that the interpretation as put forward in the present paper of the experim ental observations in [3{8] also provides a natural explanation concerning the experim ental observations of the excess kinetic' energy in the norm al states of the doped cuprate compounds [11,12] in comparison with the kinetic' energies of the GSs of conventionalm etals; in arriving at the latter statem ent we have relied on the supposition that the gapless excitations along the nodal directions of the 1BZ (below the pertinent superconducting transition tem peratures) are akin to the gapless excitations of the norm al states of the investigated cuprate compounds. Experimental observations, at tem peratures elevated above the pertinent superconducting transition tem peratures, along various directions of the 1BZ [5] (concerning change in the spectral widths see [8]), are in conform ity with the abovementioned supposition.

A lthough the considerations in this paper provide a consistent scenario concerning the main aspects of the experimental data in [3{8], a fundamental question remains to be answered, namely whether a single-band model which, moreover, exclusively takes account of the electronic degrees of freedom (Eq. (35)), allows for a uniform metallic GS whose corresponding single-particle spectral function involves a coherent contribution below

"f characteristic of a well-de ned quasi-particle excitation at $k = k_{?}$ located inside the underlying Ferm i sea (i.e. at some nite distance from S_{f} ;). Note that, although the existence of a well-de ned quasiparticle excitation at $k = k_2$ is su cient for rendering n (k) discontinuous at $k = k_2$, this discontinuity does not necessarily in ply that the pertinent excitation energy should lie by a nite amount below the Fermi energy; conversely, in cases where the excitation energy at issue is less than the Ferm i energy by a non-vanishing am ount, it is necessary (in fact by de nition) that k_2 be located away from S_{f_2} (see paragraph following Eq. Recent M onte C arb results corresponding to projected variational wave functions [34,35] concerning the conventional single-band Hubbard Ham iltonian (involving only an on-site interaction between ferm ions of opposite spin) on a square lattice, are not supportive of the possibility of a noticeable discontinuity in n (k) in the interior of the underlying Ferm isea.²⁷ Furtherm ore, although for the hole-doping fraction x approaching zero, the discontinuity of n (k) at the nodal Ferm i point k_{f} : dim in ishes (according to the authors of [34,35], $Z_{k_{f_i}}$ scales like x for su ciently small x), for x corresponding to optimal doping (here $x_{opt} = 0.18$) it is relatively too large for the following two reasons. Firstly, since 0 n (k) 1, the larger the value of $Z_{k_{f:}}$, the sm aller is the maxim alvalue that Z_{k_2} = n (k_2), or $_2$ (see Eq. (68)), can possibly attain; following Eq. (63), a small value for the latter quantity corresponds to a small kink' in the single-particle energy dispersion ${\bf w}_{k_1}^<$ at $k = k_2$. Secondly, in principle a non-vanishing (and in practice a relatively large) $Z_{k_{f}}$ corresponding to a nodal Ferm i point at optim al doping does not conform with the experim ental observations by Valla et al. [4] according to which the self-energy in the neighbourhood of a nodal Ferm iw ave vector along a nodal direction of the 1BZ satis es the scaling behaviour characteristic of the self-energies of marginal Ferm i liquids. A ssum ing that, insofar as our present considerations are concerned, the variational results in [34,35] are su ciently accurate, we have no alternative but to pronounce the conventional Hubbard Ham iltonian (as opposed to 'extended' Hubbard Ham iltonians and as opposed to Hamiltonians, such as the Hubbard-Holstein Ham iltonian (see, e.g., [36]), in which the ferm ionic eld is coupled to an external bosonic eld) as being inade-

quate for describing the phenom ena observed in $[\beta]$ and $[4\{8\}, This conclusion contradicts the nding by Randeria et al. <math>[\beta7]$ whose analysis is based on the very sam e computational results (i.e. those reported in $[\beta4,35]$) as relied upon by us above.

Concerning the interpretation of the experim ental observation in [3{8] as presented in [37], denoting the Ferm i velocity at high binding energies by v_{f}^{high} (to be compared with what we have in this paper denoted by $v_{k_2}^{<}$;) and that at low binding energies by v_f^{low} (to be compared with $v_{k_{\rm f}^+}^<$), Randeria et al. [37] deduce that $v_{\rm f}^{\rm high}$ = $v_{\rm f}^{\rm low}$ =Z (com pare with Eq. (63) above) where Z stands for what we have in this paper denoted by ${\rm Z}_{\,k_{\,\rm f;}}$, to be strictly distinguished from Z_{k_2} ; . The expression as deduced in [37] for $v_{\rm f}^{\rm low}$ is the standard expression for the Ferm i.velocity in (isotropic) Ferm i-liquids (see Eq. (7) in [37]). Through stating that \at interm ediate to high energies, 1", where 0 is the real part of self-energy †@ ⁰=@!j as evaluated at $k = k_f$ ", Randeria et al. [37] deduced an expression for v_f^{high} which up to the num erical factor Z (by the latter statem ent this is identied with unity) coincides with that for vfow and hence the above-quoted expression relating the two velocities. It is evident that the crucial, and in our opinion manifestly unjustied, step taken by Randeria et al. [37] in deducing the expression $v_{\rm f}^{\rm h\,igh}$ = $v_{\rm f}^{\rm low}$ =Z is that of e ecting the condition $1^{0} = 0!$ j 1" in the expression concerning v_{f}^{high} , for the essential aspect of the experim ental observations being interpreted concerns a change in energy dispersions (ordiscontinuity in Ferm ivelocities) over a relatively very narrow range of energies (centred around, for instance, approximately "? = "f 70 m eV insofar as the experim ents reported in [3] are concerned) whereby an appeal to the relationship $j^0 = 0! j = 1"$ is seen to be entirely unwarranted. The only possibility that would justify an appeal to the latter relationship would be the discontinuity of $\ensuremath{^0}=\ensuremath{0}$!" at !_? = "_?=h, with ⁰ reducing to a nearly constant function 28 of ! for all ! < !_?. By the K ram ers-K ronig relation the imaginary part $^{\circ\circ}$ of the self-energy would be alm ost vanishing for all $! < !_{?}$, which is neither realistic nor enjoined by the experim ental observations under consideration. W e therefore conclude that the considerations by Randeria et al. [37] do not shed light on the observations as reported in $[3\{8]$.

It is in portant to point out that according to a widely, but not universally, held view (for a review see [33];

see also [38]), both the kink' in the single-particle energy dispersion and the decrease in the spectral width at $k = k_2$ are to be attributed to electron-phonon interaction [8,39].²⁹ Counterargum ents, disfavouring phonons and attributing the latter phenom ena to antiferrom agnetic spin uctuations have been put forw ard ³⁰ [43,44,42] (see also the discussions in [6,7] which concern experiments as well as those in [5], examining experimental observations in the light of a num ber of di erent theoretical possibilities). W e do not consider electron-phonon interaction as being the primary cause for the kink' in the experim entally measured energy dispersions. This becomes evident by linearly extrapolating the data in Fig. 1a of [3] at high binding energies (corresponding to energies between approximately 0:2 and 0:1 eV below the Ferm i energy $"_{\rm f}$) towards the nodal Ferm ipoint $k = k_{f_{i}}$. One observes that at $k = k_{f_{i}}$ the extrapolated energy dispersions corresponding to all doping concentrations (in total 10 energy dispersions corresponding to x 2 [0:03;0:3]) intersect the energy axis at the same point (this with remarkable accuracy) above the Ferm i energy, namely at approximately 0:075 eV above "f (instead of at, or nearly at, "f if electron-phonon interaction were directly at work; see later); this excess energy is almost equal to the binding energy (i.e. "f ") at which kink' in the energy dispersions has been observed. The conventional electron-phonon theory [23] (see in particular x 6.4 herein), according to which kv_{k_2} ; $k=kv_{k_2}$; k = 1 = (1 +), where is the coupling constant of the electron-phonon interaction, or the electron-phonon contribution to the mass enhancement (for a com prehensive overview see [45]), requires that the change in the energy dispersion correspond to a clockw ise winding' around "f (inside an energy window of width $h!_{ph}$ centred at "f, ³¹ where $!_{ph}$ the the characteristic

phonon frequency) of the electronic dispersion with respect to that in the absence of phonons; the kink' in the single-particle energy dispersions in system s of electrons coupled to phonons is thus seen to correspond to a sharp crossover of the phonon-dressed dispersion into that of electrons in the absence of electron-phonon interaction (from which the phonon-dressed energy dispersion becomes rapidly indistinguishable) at some short distance outside the above-mentioned energy window; linear extrapolation of electron-phonon dressed energy dispersions from outside the above-mentioned crossover region (and corresponding to $kkk < kk_2k$) must therefore at $k = k_{f}$; very nearly intersect the energy axis at "f. Experimentally, this aspect is evident from the highresolution photoem ission data concerning the (0001) surface state of beryllium (also referred to as the -surface state of Be(0001)) as presented in Fig. 3 of the work by Hengsberger et al. [47] (see also [48]). A comparison of the data in Fig. 3 of [49] with those in Fig. 4 of [48] leads one to conclude that the above-m entioned clockw ise Winding' around "f of the phonon-dressed single-particle energy dispersions with respect to their undressed counterparts is also present in the energy dispersion of the (110) surface-state of molybdenum [49]. W ith reference to our above statem ent with regard to the extrapolation of the energy dispersions in Fig. 1a of [3] corresponding to $kkk < kk_{2}k$ towards $k = k_{f}$, it is evident that the kinks' observed in the single-particle energy dispersions in the hole-doped cuprate com pounds [3{8] cannot be a direct consequence of the electron-phonon interaction.

In order to exam ine the possibility of an indirect role played by phonons in bringing about kink' in the energy dispersions as observed in $[3\{8]$, it is instructive to recall a model proposed by Frohlich [50,51] (see also xx 1.8 and 3.16 in [52]). Frohlich [50,51] showed that, for su ciently large value of coupling constant, the interaction of independent electrons with phonons gives rise to an exotic electronic GS, which Frohlich showed to be a superconducting state.³² In this state, the Ferm i sea of electrons consists of two concentric regions, separated by a narrow region of unoccupied single-particle states (see Figs. 1 and 2 in [50]); Frohlich explicitly showed that this GS, corresponding to a 'shell' distribution of electrons in the k space, is characterized by the equality of the widths of the intervening unoccupied region and the outer occupied region of the k space. For such a state, on transposing

k from the interior of the inner Ferm i sea to the exterior of the outer Ferm i sea, n (k) undergoes three discontinuities, from unity to zero, from zero to unity and again from unity to zero respectively. Each of these discontinuities would in turn give rise to discontinuities in $\mathbf{w}_{k}^{<}$ (in principle; x 3.4) and r $_{k}$ " $_{k}^{<}$, in the manner described in this paper (xx 3.4, 4.2 and 4.3), were it not for the fact that these discontinuities all correspond to single-particle excitations whose energies coincide with "f. It follows that the Frohlich state is not the appropriate state insofar as the observations in [3[8] are concerned. In spite of this, the crucial role that phonons play in bringing about the Frohlich state (at least in principle), with the aboveindicated discontinuities in the associated n (k), makes evident that phonons can in principle be vital in regard to the observations reported in $[3\{8];$ in this connection it should be noted that the binding energies " $_{\rm f}$ "? corresponding to kinks' in the measured single-particle energy dispersions of the investigated cuprate com pounds very nearly coincide with the energies of the longitudinal optic phonons in these [8] (for a detailed discussion of this subject see [33]).

W e point out that the prediction by Frohlich [50] of the above-mentioned Shell' state relies on a second-order perturbation expansion of the GS energy of the coupled electron-phonon system. Soon after its predication, this state was asserted by W entzel [54] and K ohn and Vachaspati [55] as not feasible through its interception by a structural lattice instability at an electron-phonon coupling constant sm aller than that required for the form ation of the Frohlich state; W entzel [54] conceded, however, that interaction of electrons, not taken account of in Frohlich's considerations, would render the Frohlich state feasible. How ever, according to Bardeen [56] (see the closing paragraph of section III herein), who has established a modi ed stability condition for the lattice, the Frohlich state is viable. ³³

Concerning the 'universality' (within an experim ental uncertainty of approxim ately 20%) of the Ferm i velocities at low binding energies as reported by Zhou et al. [3], following the analysis in x 3.5, this 'universality' reveals two aspects; rstly, the 'universal' energy "f ", where ${}_{k_2}^{\kappa}$, is associated with some bosonic ex-"_? ₩ k₂; citations that are external to the electronic degrees of freedom, supporting the possibility that longitudinal optical phonons, though not directly (see above), can indirectly be the sought-after bosonic excitations; secondly, a rigid, that is doping-independent, tight-binding energy dispersion "k underlying the many-body Ham iltonian in Eq. (35), is not capable of reliably describing the cuprate

³³ Anderson [57] presented the contents of the Frohlich m odel in a m odern setting, indicating the diagram m atic representations of the underlying exchange processes. Subsequently, with reference to a M igdal theorem [58], Anderson [57] stated (p. 1346): \But in fact M igdal resolved the problem even more completely by showing that is a much more sensitive function of ! than of k | i.e., it is local in space, retarded in time, thus depends on ! much more sharply so that the large correction to $(E_k)_e$ com es from 0 = 0! : ...and Z = 1 = [1](@ =@!)] is always positive: the Frohlich-Bardeen instability simply does not occur. The complete treatment shows that phonon instability and the rst singularity of Z actually occur precisely at the same coupling strength." Two comments are in order. Firstly, the electronic state on which the Migdal theorem at issue is based is that of the non-interacting free-ferm ion m odel (this is readily veried through inspecting [58] in conjunction with [50]); in other

words, it is assumed that the scale of the electronic excitation energies is determ ined by a single electronic m ass param eter. For speci cally strongly-correlated electron systems there is no a priori reason to believe that the GS of this m odel would at all be an appropriate starting point for dealing with the problem of electron-phonon interaction (this is exactly the same problem which in fact hinders a rigorous form ulation of a theory concerning the superconducting states of the cuprate com pounds whose low -lying single-particle excitations in the norm al state are not quasi-particle-like; see how ever [59]), so that the above-mentioned Frohlich-Bardeen instability cannot on its own rule out the existence of the Frohlich state. Secondly, it is generally, even though perhaps not universally, accepted that non-adiabatic processes are signi cant in the copper-oxide-based high-tem perature superconductors, leading to the Yailure' of the Migdal theorem referred to above. See [60]. For com pleteness, we have carried out calculations [61] on a uniform two-dimensional model in which the GS is the Frohlich state. From the rst-order self-energy in terms of the dynam ically screened interaction function we have deduced quasi-particle lifetim es which are generically by one order of m agnitude shorter than the lifetim es of quasi-particles in the conventional two-dim ensional model at sim ilar densities. We have further studied [61] a variety of the properties of this model in the superconducting state within the Bardeen-Cooper-Schrie er (BCS) fram ework, despite the fact that the aforem entioned short quasi-particle lifetim es underm ines the use of the BCS form alism. For instance, in the weak-coupling lim it we obtain that 2 (T = 0)= $[k_b T_c]$ is relatively close to 4 (to be compared with the conventionalBCS value of 3:52). We point out that a recent [62] non-selfconsistent rst-order calculation (in which the e ective interaction has been deduced from diusion M onte Carlo results concerning the static charge and spin structure factors and random -phase approxim ation Ansatze concerning the dynam ical density-density and spin-spin susceptibilities) concerning two-dimensional liquid ³He indicates that on increasing the aerial density of ³He atom s the e ective m ass diverges; a subsequent increase of the density suggests what Boronat et al. [62] refer to as being indicative of a transition to \anom alous occupation num bers" and to which we would refer as the Frohlich 'shell' state. Interestingly, according to Boronat et al. [62] \Both spin and density uctuations have profound e ects."

com pounds, speci cally those investigated by Zhou et al. [3]; the bare m ass corresponding to a rigid tight-binding energy dispersion is relatively strongly dependent on the level of doping (see caption of F ig. 3), and this is m ost likely inherited by the corresponding dressed m ass and consequently the interacting Ferm i velocity, thus contradicting the above-m entioned experim ental observations.

A though in this paper we have mainly focused on the ARPES data along the nodal directions of the 1BZs of the cuprate compounds as reported in $[3\{8\}, our approach is$ applicable along any direction of the 1BZ. In the light of the observations as reported in [5] (see speci cally Fig. 3 in [5]) we conclude that a discontinuity in n (k) in the interior of the Ferm i seam ay be a generic property of the norm alstates of all cuprate superconductors. W ith reference to our observation in this paper that along the nodal directions of the 1BZs of the cuprate com pounds investigated in $[3\{8]$, the quasi-particle equation must have at least (see footnote 9) two solutions " $_{k_2}$; < and ${}^{"}_{k_2}$; > corresponding to true Landau quasi-particles (in the sense of Z_{k_2} ; > 0), it is interesting to recall an earlier observation presented in [9]; here it has been rigorously shown that, within the fram ework of the conventional single-band Hubbard Ham iltonian, fork located in the pseudogap regions of the reciprocal space, the quasiparticle equation must have (at least) two solutions, one strictly below and one strictly above , and that these solutions do not correspond to quasi-particle excitations of the Landau type, but to resonances. It is of interest to investigate whether, and if so, how these two distinct energies are related to $"_{k_2}$; and $"^+_{k_2}$; which correspond to Landau quasiparticles. We should emphasize that, whereas the above-mentioned resonances correspond to wave vectors in the pseudogap regions of the underlying putative Ferm i surfaces (in [9] it has been shown that ³⁴ $S_{f}^{(0)} nS_{f}$, which may or may not be empty, constitutes the pseudogap region of the wave-vector space), the wave vector k? is located in the interior of Ferm i seas, i.e. at some nite distance from S_{f} ; .

W e close this section by reiterating that, although we have been able to provide a consistent scenario for the experim ental observations in β {8], a num berofoutstanding questions rem ain. These are

(i) whether a single-band model is capable of possessing a uniform metallic GS whose momentum distribution function is discontinuous in the interior of the underlying Ferm i sea (speci cally along the nodal directions of the 1BZ) and at the pertinent wave vector, denoted in this paper by k_2 , the single-particle spectral function involves a singular contribution at " = ", where ", lies some 50 to 70 m eV below the Fermi energy "f,

(ii) whether a uniform GS is su cient, or inhomogeneity, such as 'stripes' (whether static or dynamic) $[63\{65\}$ are essential for the single-particle spectral function A (k;") to possess the properties indicated above and

(iii) whether the above m entioned properties expected of A (k;") can arise through collective excitations internalto the electronic system (charge and spin excitations) [66] or coupling of electrons to external bosonic m odes (phonons) are essential, or a combination of both.

As for the role that phonons can play in bringing about the above-mentioned properties concerning A (k;"), we believe that the experimental data considered by us in this paper β {8] rule out a primery role; however, a secondary (even though possibly vital) role is not excluded. As an example of the interesting possibilities that can become available through the mediation of the electronphonon interaction, we have brie y discussed the Frohlich Shell' state. We have, how ever, show n that this state cannot be the appropriate state to which the experimental observations as reported in β {8] can be ascribed.

m ore closely related to the subject m atters of the present paper.

W e consider the following form for the many-body interacting H am iltonian \dot{P} :

One observes that, within the approxim ate fram ework in which n (k) 2 f0;1g, the single-particle energy dispersion in fact consists of a single branch, namely ${}^{hf}_{k}$; , and not of two identical branches. 


FIG.1. Schematic representation of the conditions under which the quasi-particle equation $"_k + h$ (k;") = " has apparently two solutions at $k = k_2$, where k_2 is located strictly inside the Ferm isea FS ; the two solutions are denoted by " $_{k_2}$; and ${\tt "}_{k_2^+\,;}$, where ${\tt "}_{k_2^-\,;}\ <\$ and ${\tt "}_{k_2^+\,;}\ >\$. The singularity of $n_{R}(k)$ at $k = k_{?}$ together with the normalization condition $h_{1}^{1} d''A$ (k;") = 1 in ply that " k_{2} ; and " k_{2}^{+} ; must be solutions of the quasi-particle equation at $k = k_2$ and $k = k_2^+$ respectively (see x 3.2). Curve (a) depicts \mathbf{w}_{k_2} + hR e[(k₂; ")], curve (b) gives hIm $[(k_2; ")]$, and curve (c) shows the function f(") = ". Although the functions are depicted schematically, care has been taken to ensure that $h \text{Im} [(k_2; ")]$ satisfy the necessary requirements Im $[(k_2; ")] = 0$ for " < 0 for " > , and Im [$(k_2;)$] = 0 Im [(k₂;")] (the stability of the GS requires the more stringent condition Im [(k;)] = 0, 8k. Since n (k) is assumed to be discontinuous at $k = k_2$, (k ? ;") is continuously di erentiable with respect to " in the neighbourhood of " = $"_{k_2}$; . Note that, since following the considerations in x 3.2 for the case dealt with here, the spectral weights Z_{k_2} ; and $Z_{k_2^+}$; corresponding to the singular contributions S (") and S⁺ (") respectively are equal (we denote the common value by ${\rm Z\,}_{k_{\,2}\,;}$), it follows that d $(k_2; ;")=d"$ at " = " k_2 ; is equal to d $(k_2^+; ")=d"$ at " = " $_{k_{2}^{+}}$; Further, since in general 0 Z $_{k_{2}}$; 1, it follows that the latter derivatives are negative or at most zero (the latter corresponding to Z_{k_2} ; = 1).




FIG .2. Schem atic representation of " $_{\rm k}$; , the asymptotic solution of the quasi-particle equation (Eq. (3)), and $\mathbf{u}_{k}^{<}$ as dened in Eq. (39), for k inside the Ferm i sea and close to the Ferm i wave vector k_{f} ; , with k_{f} ; k pointing in the direction of the outward norm alf (k_{f} ;) to the Ferm isurface S_{f} ; at $k = k_{f}$. It is assumed that n (k) is continuous at $k = k_{f}$; (ie. $Z_{k_{f_i}} = 0$) while it undergoes a nite discontinuity at $k = k_2$ (i.e. Z_{k_2} ; > 0). Following Eqs. (4) and (27), "_{k:} and $_{k}^{\prime}$ coincide at $k = k_{f}$; and $k = k_{?}$ respectively and, owing to the sm allness of $kk_2 = k_f$; $k = kk_f$; k (in practice, of the order of 5%), the possible di erence between " $_{k}$; and " $_{k}^{<}$; cannot be experimentally discernible for k in the interval between $k_{\scriptscriptstyle ?}$ and k_{f_i} . We have = tan¹ $\hat{n}(k_{f_i}) r_k "_{k_i} \dot{j}_{k=k_{f_i}}$, in which Z_{k_2} ; =n (k₂); counterclockwise is kk_f; k="_f, and the direction in which we count angles as positive. By viewing $\mathbf{I}_{k}^{<}$ as the single-particle energy dispersion as measured through ARPES and excluding the results corresponding to the underdoped cuprates, our schem atic representation (which is based on Eq. (63); see also Eqs. (74) and (75)) is in excellent qualitative agreem ent with the experim ental observations by Zhou et al. [3]. For ferm ions interacting through the Coulomb interaction potential, fi (k_f;) $r_k \frac{w_k}{k}$; acquires a logarithm ic divergence at $k = k_{?}$ (see Fig. 3). Taking this aspect into account, as well as a nite discontinuity in $\binom{1}{k}$, at $k = k_2$, which is feasible (x 3.4), the corresponding schem atic representation would similarly be in excellent (qualitative) agreem ent with the experim ental observations by Zhou et al. [3] concerning cuprates in the underdoped regime, as exemplied by $(La_2 \times Sr_x)CuO_4$ for x = 0.03.




FIG.3. The energy dispersion $\mathbf{"}_{k}^{<}$; "_k + g _k; (Eq.(39)) for $n = N = N_1$ equal to 1 (curve (a), corresponding to the extreme limit of hole underdoping) and 0:7 (curve (b), corresponding to an overdoped cuprate compound) along a diagonal direction of a square 1BZ as calculated within the fram ework in which g $_{k}$, is replaced by h hf (k) (for the details concerning this choice see the x 4.1 and appendix A; see also Fig. 2) evaluated in terms of the long-range Coulom b potential and a GS momentum distribution function n (k) of the form n $(xk_{f;}) = 1$ h₀ $(x x_0)$ Z_{k_{f;}} (x 1) where 0 and h₀ = $(1 Z_{k_{f;}})(x_z^2 1)=(x_z^2 x_0^2)$; here k_z x₀ 1 $x_z k_f$; stands for the vector from the centre of the 1BZ to the zone boundary in the direction of k_{f} ; 2 S_f; . Full account has been taken of the Um klapp of wave vectors that in the process of wave-vector integration m ove outside the 1BZ. The calculations are perform ed for $x_0 = 0.95$ and $Z_{k_{f_1}} = 0, 8k_{f_1}$, so that by norm alization $h_0 = 0.968$ for n = 1 and $h_0 = 0.976$ for n = 0.7. For the energy dispersions $"_k$ (curve (c) for n = 1 and curve (d) for n = 0.7) we have chosen the tight-binding expression $\mathbf{k}_{k} = 2t[\cos(a_{0}k_{x}) + \cos(a_{0}k_{y})]$ where k_{x} and k_{y} stand for the Cartesian coordinates of k and $a_0 = 3:895$ 10 ¹⁰ m for the lattice constant. For the Fourier transform of the Coulomb potential we have v (kqk) gw (kqk) where w (kqk) = 2 a_0 = kqk and $g = e^2 = (4_0 ra_0)$ in which e^2 stands for the square of the electron charge, $_0 = 8.854 ::: 10^{12}$ F m⁻¹ for the vacuum permittivity and r the relative dielectric constant of the background. W ith $e_0 := h^2 = (m_2 a_0^2)$, the calculations presented here correspond to $g = 3e_0$. Here m₂ denotes the e ective mass associated with " $_{\rm k}$ (to be distinguished from that associated with $\binom{m^2}{k}$) at $k = k_f$; along a diagonal direction of the 1BZ, for which we have chosen m $_{2}$ = 4m $_{e}$ (for both densities n = 1 and n = 0.7), where m_e stands for the bare electron mass (for the above values of a_0 and m_2 , $e_0 = 0.1255$ eV; the choice $q = 3e_0$ thus amounts to r = 9.814). Consequently, t = $e_0 f = \begin{bmatrix} 2 & 2 & \sin(f = \frac{1}{2}) \end{bmatrix}$, where $f = a_0 kk_f$; k. Forn = 1 we have p f = 2.221 ($f = \begin{bmatrix} 2 \\ 2 \end{bmatrix} = 0.5$) and for n = 0.7, f = 1.965 $(_{f}=[2] = 0.442)$, corresponding to $t = 0.785e_0$ for n = 1and $t = 0.706e_0$ for n = 0.7. A density-dependent t is chosen to avoid a strongly density-dependent m ?.




FIG.4. The analytic structure of the single-particle Green function 🤄 (k;z) on the physical Riem ann sheet of the com plex z plane for cases where (A) $k = k_{f_i}$, with k_{f_i} , 2 S_{f_i} and (B) k 2 FS and at a nite non-vanishing distance from $S_{\,\rm f;}$. It is assumed that in the latter case for the k at issue the quasi-particle equation $"_k + h$ (k;") = " is satis ed " k; for $(k;") = (k;"_{k})$ (see Fig. 1) in which "_k; (Eq. (13)); for m etallic states and k_{f} ; 2 S_f; , this equation is satis ed for $(k;") = (k_{f}; ;"_{f})$. The solid lines on the real axes whose end points coincide with $_{N:} = E_{N}$; $_{N,0} = E_{N-1,N}$; and $_{N}^{+}$; $= E_{N} + 1; N; 0$, $E_{N}; N; 0$, represent the branch cuts of \mathfrak{G} (k;z); here E_{M} ; N; N; N + 1, stands for the total energy of the (M + N)-particle GS of the interacting Hamiltonian \mathbb{P} (for = ", = #, and vice versa). Form etallic GSs, $_{N}$; = "f and $_{N}^{+}$; diers only in nitesimally from $_{N}$; the chemical potential satisfies $N_{\rm N}$; < < $+_{\rm N}$; In evaluating the integrals of $z^m \mathcal{C}$ (k; z), $m = \beta; 1$, over the contour C we employ the decomposition $_{C} dz = _{C nC_{s}} dz + _{C_{s}} dz$ which am ounts to the decom position, according to Eq. (8), of A (k;") into its regular and singular contributions respectively.
