Exact hydrodynam ics of a trapped dipolar Bose-Einstein condensate

We derive the exact density prole of a harmonically trapped Bose-Einstein condensate (BEC) which has dipole-dipole interactions as well as the usuals-wave contact interaction, in the Thomas-Ferm i lim it. Rem arkably, despite the non-local anisotropic nature of the dipolar interaction, the density tums out to be an inverted parabola, just as in the pure s-wave case, but with a modi ed aspect ratio. The \scaling" solution approach of Kagan, Surkov, and Shlyapnikov Phys. Rev. A 54, 1753 (1996)] and Castin and Dum Phys. Rev. Lett. 77, 5315 (1996)] for a BEC in a tim e-dependent trap can therefore be applied to a dipolar BEC, and we use it to obtain the exact m onopole and quadrupole shape oscillation frequencies.

The current revolution in the cooling of atom ic gases to ultra-cold temperatures has led to the experimental realization of a number of highly idealized and fundamental regim es in the quantum physics of many-particle sys- checkerboard phases [11], and modi ed excitation spectems [1, 2]. For example, in a Bose-Einstein condensed gas containing severalm illion atom s the zero-point kinetic energy can be negligible in comparison to the interparregime the collective dynamics of the Bose-Einstein condensate (BEC) are described by the collision less hydrodynam ic theory of Bose super uids at zero tem perature Bl. Furtherm ore, the interparticle interactions can be directly m anipulated using external electrom agnetic elds, giving a degree of freedom not normally available in the systems traditionally studied in statistical physics. The dominant interactions in these gases are usually of the van der W aals type, decaying as r 6 , short-ranged in comparison to the interatom ic separation. This perm its an e ective description of the interactions solely in terms of the s-wave scattering length, as. Within the mean-eld scheme of the Gross-Pitaevskii.equation [4] the interactions are modelled $(4 a_s h^2 = m) (r)$, by the contact pseudo-potential, q (r) where m is the atom ic mass, and g incorporates the quantum aspects of low-energy scattering. By using a magnetic eld to induce a Feshbach resonance during atom ic collisions, one can adjust the value of as between positive (repulsive) and negative (attractive) values [5].

Here we consider a harm onically trapped BEC which, as well as van der W aals interactions, also has dipole-dipole interactions. Such a system was rst considered by Yi and You [6] in the context of dipoles induced by an external electric eld and by Goral, Rzazewski, and Pfau [7] in the context of perm anent magnetic dipoles aligned by an external magnetic eld. In comparison to van der W aals interactions, dipole-dipole interactions have a much as

longer range and are anisotropic. This has been predicted to lead to BECs with unusual stability properties [8, 9], exotic ground states such as supersolid [10, 11] and tra [12, 13] even to the extent of a roton minimum [14]. D ipole-dipole interactions are also inherently controllable, either via the magnitude of the external electric eld in the ticle interaction energy. In this so-called Thom as-Ferm i case of electrically induced dipoles, or in the case of perm anent dipoles by modulating the external aligning eld in time [15], which allows control over both the magnitude and sign of the dipolar interactions.

> The long-range part of the interaction between two dipoles separated by r, and aligned by an external eld along a unit vector ê, is given by

where the coupling C_{dd} =(4) depends on the speci c realization. E lectric dipoles induced by an external static electric eld $E = E \ \hat{e}$ have $C_{dd} = E^2 = 0$ [6], where is the static polarizability. For magnetic atoms with magnetic $dipole m om ent d_m$ aligned by an external magnetic eld $B = B \, \hat{e}$, then $C_{dd} = {}_{0}d_{m}^{2}$. A measure of the strength of the dipole-dipole interaction relative to the short-range van der W aals s-wave scattering energy is given by the dim ensionless quantity

For "dd > 1 instabilities are expected [7, 15] in the lim it of negligible kinetic energy. Note that the value of g can be altered in the presence of a strong external electric eld [12]. A lkali atom s can have a magnetic dipole moment of $d_m = 1_B$ (Bohr magneton), and for 87 Rb, which has $103a_0$ (Bohr radius), one nds " $_{dd}$ 0:007. Na has

0:004, and accordingly magnetic dipolar e ects in BECs of these atoms are expected to be small, at least in a stationary condition. The e ects of the dipolar interactions can be made visible by rotating the magnetic eld in resonance with a collective excitation frequency of the system [15]. Also, using a Feshbach resonance to reduce as could substantially increase "dd [16]. However, a good candidate atom for a dipolar BEC is chromium which has $d_m = 6_B$. The s-wave scattering length of ^{52}Cr , the m ore common isotope, is $170 40 a_0$. Consequently for that isotope "dd 0:089. The less common isotope 50Cr has $a_s = 40$ 15 a_0 , and $"_{dd}$ 0:36 is much higher. A chrom ium BEC does not yet exist, but a program of experim ents is underway with that goal in mind [17]. Using a crossed optical trap, like in the recent cesium condensation experim ent [18], atom numbers in a 52CrBEC on the order of N = 10^4 m ight be within reach, and the radial and longitudinal frequencies of the cylindrically sym m etric (optical) harm onic con nem ent would be in the region of! $_x = !_y = 2 \cdot 170 \text{ s}^{-1}$ and $!_z = 2 \cdot 240 \text{ s}^{-1}$, respectively [17]. The trap anisotropy = $!_z = !_x = 1:41$ is optimal for enhancing the condensate shape deform ations [19]. For a harm onically trapped BEC with just s-wave scattering the Thom as Ferm i lim it is reached for large values of the dim ensionless param eter N $a_s=a_{ho}$ [2] where $a_{ho}=$ is the harm onic oscillator length of the trap, and N is the total number of atoms. For 52Cr one has Na_s=a_{ho} illustrating that the Thom as-Ferm i regime is an appropriate starting point for analyzing these experim ents.

The application of collisionless hydrodynam ics to an ordinary BEC is based upon the existence of a m acroscopic condensate order parameter $(r;t) = \frac{1}{n} (r;t) \exp i (r;t)$, norm alized to N , consisting of density n (r;t), and phase (r;t). The phase determines the super uid velocity via potential ow, v(r;t) = (h-m)r (r;t). The nonlinear evolution of the condensate in the Thomas-Fermi regime is then dictated by the continuity and Euler equations given by, respectively,

 $V_{\rm ext}$ is the external potential, which is provided by the harm onic trap, $V_{\rm ext}\left(r\right)=m$ (! $_{x}^{2}x^{2}$ + ! $_{y}^{2}y^{2}$ + ! $_{z}^{2}z^{2}$)=2. Eqs. (3) and (4) describe the potential ow of a uid whose pressure and density are related by the equation of state $P=(g=2)n^{2}$, and are equivalent to the time dependent G ross-P itaevskii equation [4] when the zero-point uctuation term ($h^{2}r^{2}$ \overline{n} =2m \overline{n}) is included in the brackets on the right hand side of (4) after the Bernoulli term m v^{2} =2. The equilibrium solution of (3) and (4), which has v=0, is the well-known T hom as-Ferm i inverted parabola density pro-le

and n(r) = 0 elsewhere. Thus the density prole is completely determined by the trapping potential, having the

sam e aspect ratio as the trap.

An analysis of the dynam ical ($v \in 0$) solutions of (3) and (4) has been given by Stringari [3]. However, motivated by the experimental possibility of changing the trapping frequencies in time, so that $!_j ! !_j(t)$ with $j = x_j y_j z_j$, K agan, Surkov, and Shlyapnikov [20] and C astin and D um [21] studied a special class of \scaling solution, valid for time-dependent harmonic traps, corresponding to [2]

valid where n (r;t) 0 and n(r;t) = 0 elsewhere. The central density n_0 (t) is constrained by normalization to be n_0 (t) = 15N = [8 R_x (t)R_y (t)R_z (t)]. The time-evolution of the radii R i reduces to the solution of three ordinary di erential equations, and the components of the velocity eld, j, depend on the corresponding radii as j = R-j=Rj. Although these scaling solutions represent only a limited class of the possible solutions to the hydrodynam ic equations, they model two crucial experimental situations: i) the expansion of a BEC when the trap is relaxed or turned o this is usually necessary to image the BEC which would otherwise be too small in situ (time of ight measurements then record the original momentum distribution); ii) the response of the BEC to a modulation of the trapping frequencies, which is the easiest way to generate shape oscillations of the BEC.

The existence of the class (6) of analytic scaling solutions relies upon a harm onic trap and the local character of s-wave interactions. The remainder of this paper demonstrates an analogous exact result for a dipolar BEC. This result is not obvious because of the non-local nature of dipolar interactions. Nevertheless, it turns out that the dipolar contribution to the mean-eld potential generated by a parabolic density prole is itself also parabolic so that (6) and (7) still represent a self-consistent solution to the hydrodynam ic equations of motion.

Exact static solution for a Thom as-Ferm i dipolar BEC Dipolar interactions can be included in a mean-eld treatment of the BEC via a Hartree potential

as shown by Yi and You [12] based on a calculation of the two-body T-m atrix. The hydrodynam ic equations of motion for dipolar BEC are then the same as above but with the Euler equation (4) supplemented by adding $_{\rm dd}$ (r) into the bracket on the rhs. We begin our analysis with a suggestive re-casting of the dipole-dipole term (1)

W e can then write

The problem thereby reduces to an analogy with electrostatics, and one need only calculate the 'potential' arising from the static charge distribution n(r). We are now in a position to see the basic form n(r) must take, since (r) given by (11) obeys Poisson's equation $r^2 = n(r)$. Thus, if the density is parabolic, of the form (6), then Poisson's equation is satis ed by a potential of the form = $a_0 + a_1 x^2 + a_2 y^2 + a_3 z^2 + a_4 x^2 y^2 +$ $a_5x^2z^2 + a_6y^2z^2 + a_7x^4 + a_8y^4 + a_9z^4$, and by (10) dd (r) is also parabolic. Therefore, an inverted parabola remains a self-consistent solution to the dipolar hydrodynam ic equations. The evaluation of the integral (11) is too long to be reproduced here [22], but can be achieved either by integrating over successive thin ellipsoidal shells, or in the case of cylindrical sym metry by transforming into spheroidal coordinates and using the known G reen's function for Poisson's equation in that basis.

For simplicity (though not necessity), we shall restrict attention to cylindrical sym m etry for both trap and BEC about the z axis, along which the external polarizing eld is understood to point. Thus we have $R_x = R_y$ for the BEC and $V_{ext} = (m = 2) [! \frac{2}{x} + ! \frac{2}{z} z^2]$, where $\frac{2}{x} = x^2 + 1$ y^2 , for the trap. Then, inside the condensate region, the dipolar potential (10) generated by an inverted parabola density distribution (6) of dipoles, is [22]

 $R_x=R_z$ being the condensate aspect ratio. We recover the result (9) of [15] in the particular case of a spherical dipolar condensate $(R_x = R_z)$. In order to determ ine the equilibrium values of Rx and Rz, the result (12) for dd should be substituted into the Euler equation (4) with v = 0, giving a transcendental equation for the aspect ratio [12]




Figure 1: Equilibrium aspect ratio of the BEC, as a function of the dipole-dipole to s-wave coupling ratio, "dd. Each line is for a trap of a dierent aspect ratio (= when $"_{dd} = 0$). When 0 < [] < 1 the trap [condensate] is prolate, [] > 1 the trap [condensate] is oblate. The dashed lines indicate an unstable branch. However, local density perturbations most likely render the condensate unstable whenever $"_{dd} > 1$.

where $= !_z = !_x$ is the ratio of the harm on ic trapping frequencies. Fig. 1 shows some examples of the dependence of upon "dd for oblate, spherical and prolate traps. The e ect of the dipole-dipole forces polarized along the z-axis is to make the condensate more cigar-shaped along z. For

stability to scaling perturbations and is only metastable [8, 12, 22] (only a local minimum of the energy), the global m in im um being a collapsed pencil-like prolate state. Increasing "dd yet further, the scaling solution ceases to exist entirely in the region marked as unstable in Fig. 1. However, we strongly caution the reader that any state of a dipolar BEC with "dd > 1 is probably unattainable since other classes of perturbations (that do not respect the scaling form (6)), such as local phonons, render the dipolar BEC unstable to collapse whenever $"_{dd} > 1$ [7, 15].

A moment's thought shows that the aspect ratio is independent of the species of the density prole and indeed the same transcendental Eq. (14) has been previously obtained using a Gaussian ansatz [12]. However, what is speci c to the exact solution are the absolute radii which, once (14) has been solved for , are given by

and $R_z = R_x =$. If the trap is turned o the s-wave and dipole-dipole interaction energies are converted into kinetic energy, the so-called release energy E $_{\rm rel}$, which can be directly measured in an experiment. One $nds E_{rel} =$ 15qN²[1 "ddf()]=(28 $R_x^2 R_z$).

Solving these equations under particular choices of the dependence of $!_j$ (t) upon time gives the evolution of the density and phase of the condensate when undergoing e.g. free expansion (trap switched o), or shape oscillations (time-modulation of the trap). A time-dependent dipolar coupling is also possible as explicitly indicated. As mentioned above, our results show that previous calculations based upon the Gaussian variational ansatz of the aspect ratio (t) during ballistic expansion [19], or during the parametric excitation of the quadrupole shape oscillation mode using dipolar interactions as a time-dependent coupling [15], are exact in the Thomas-Ferm i limit.

Linearizing (16{17) around the equilibrium solution (15) gives the following frequencies for small amplitude scaling oscillations




Figure 2: The monopole (dashed) and quadrupole (dashedotted) oscillation frequencies in units of the radial trapping frequency, as functions of "dd. The solid lines are for a BEC with only s-wave contact interactions, $^{\rm 0}$. The trap aspect ratio is set at =240=170. The frequencies become complex at precisely the value of "dd at which the equilibrium solution becomes unstable. However, other instabilities, due to phonons, are possible whenever "dd > 1.




Figure 3: The monopolar (dashed) and quadrupolar (solid) frequencies as fractions of their s-wave-only frequencies, 0 , of 52 Cr (11 dd = 0:089) and 50 Cr (11 dd = 0:36), plotted as functions of the trap anisotropy .

corresponds to quadrupole, and $_{+}$ to monopole (breathing) shape oscillations, respectively [12, 13], see Fig. 2. Note that the frequencies do not depend on g directly, only through $^{\rm m}_{\rm dd}$. Fig. 3 illustrates that certain trap anisotropies maxim is the e ects of the dipolar interactions upon the collective excitation frequencies.

Conclusion | Dipolar condensates promise to open a new chapter in the study of controllable super uids. At rst sight, the non-local and anisotropic form of dipolar interactions also make the elucidation of the static and excited states of a dipolar BEC non-trivial, i.e. direct numerical calculation is for instance computationally heavy in comparison to standard BEC swith contact interactions. We have shown, however, that there exist simple exact solutions which should prove useful for quantitative analysis of upcoming experiments.
