A Neutron Elastic Di use Scattering Study of PM N

We have performed elastic di use neutron scattering studies on the relaxor Pb (M q_{-3} N b_{2-3})O $_3$ (PMN). The measured intensity distribution near a (100) B ragg peak in the (hk0) scattering plane assumes the shape of a butter y with extended intensity in the (110) and (110) directions. The temperature dependence of the di use scattering shows that both the size of the polar nanoregions (PNR) and the integrated di use intensity increase with cooling even for temperatures below the Curie temperature $T_{\rm C}$ 213 K.

I. INTRODUCTION

Pb M $g_{1=3}Nb_{2=3}O_3$ (PMN) is a typical relaxor ferroelectric that has a broad and strongly frequency-dependent dielectric constant. This system has attracted much attention in the last few years, because of the discovery of an ultrahigh piezoelectric response in solid solutions with PbT iO_3 (PT) near the morphotropic phase boundary MPB. Pure PMN is considered to be a prototype relaxor, and has been studied extensively in recent years². Nevertheless, certain aspects of this system are not fully understood. Unlike one of its close analogues, Pb $(Zn_{1=3}Nb_{2=3})O_3$ (PZN), PMN remains cubic below the (eld-induced) Curie temperature T_C 213 K 3,4 , and

was believed to exhibit no macroscopic ferroelectric phase

transition in zero eld.

E orts to understand the dynam ical properties of relaxors have focused on the polar nanoregions (PNR) present in these compounds. Burns and Dacol found that on cooling such systems, PNR start to form at tem peratures a few hundred degrees above T_C . This tem perature was later called the \Bums Tem perature" 620 K for PMN. Neutron scattering measure- ${\rm m}\;{\rm ents}^{6,7}$ have demonstrated that di use scattering appears in PMN between 600 K and 650 K, consistent with previous opticalm easurem ents by Burns and Dacol. The di use intensity that develops in relaxors below T_d has been identied with the PNR. Various neutron and x-ray m easurem ents on di use scattering have been carried out in order to investigate how PNR are formed, and to determ ine average sizes and polarizations (atom ic shifts) at di erent tem perature 8,9,10,11. Phonon contributions have always been a potential source of contam ination in di use scattering measurements. In this paper, we present, and attempt to interpret, elastic di use scattering m easurem ents on pure PMN.


II. EXPERIMENT


The experim ent was carried out using the D isk Chopper Spectrom eter (DCS)¹² at the N IST Center for Neutron Research. The sample was a high quality single crys-0:1 mosaic, and a mass of 325 g, talofPMN with grown at the Sim on Fraser University in Canada. A num ber of neutron scattering studies using this crystal have already been published^{8,13,14,15}. The room temperature lattice parameter is a = 4:04 A. At each of several tem peratures, tim e-of- ight spectra were collected for each of at least 51 successive crystal orientations 0:5 apart using 325 detectors with active dimensions in and normal to the scattering plane of 31 mm and 400 mm respectively. The DCS detectors are located 4000 mm from the sample at scattering angles from 5 to 140. At an incident neutron wavelength of 5.5 A, the FW HM (full width at half maximum) of the elastic resolution function was 0.085m eV, and the time between pulses at the sample

is 9 m s, e ectively elim inating fram e overlap. D ata were collected near a (100) B ragg peak in the (hk0) scattering plane. The choice of a low Q re ection helps m inim ize phonon and multiphonon contributions.

III. RESULTS AND DISCUSSION

In Fig. 1, we show the neutron di use scattering around a (100) peak in the (hk0) plane measured at different tem peratures. Compared with similar x-ray measurements, our neutron scattering measurements have much higher energy resolution, and almost all phonon contributions can be removed by integrating the scattering over an appropriate energy range, 0.075 meV either side of the elastic peak position. In fact, the energy spectra show that there is no signicant scattering intensity outside this integral range, i.e., phonon contributions are indeed very small around the (100) Bragg peak. The remaining low energy phonon contributions included within this energy integral (phonons with energy transfer j.! j 0.075 meV) can also be estimated, because





phonon intensity increases with temperature, while the elastic di use scattering intensity decreases. Since no change in lineshape with temperature was observed, we believe that phonon contributions to the elastic di use scattering intensity are negligible.




FIG. 2: A sm oothed logarithm ic plot of the neutron elastic di use scattering intensity at $200~\mathrm{K}$.

Comparing the data sets plotted in Fig. 1, one can clearly see that di use scattering develops around the (100) peak with decreasing temperature. At the \butter y"-shaped di use scattering intensity pattem observed at low tem peratures is absent, and only a small trace of intensity transverse to the wave vector Q = (1;0;0) remains. An enlarged plot of the diffuse scattering intensity measured at 200 K is given in Fig. 2. The di use scattering intensity has a \butter y" shape and extends from the Bragg peak along (110) and (110) directions. Previous x-ray di use scattering measurements show that the polarizations of the PNR are along f111g directions in PMN, and the local sym m etry is rhom bohedral. This f111g type polarization gives the \butter y" shaped di use intensity pattern in the (hk0) plane. The present elastic di use scattering results are in good agreem ent with the x-ray results. Recent neutron di use scattering measurements in the (hhk) scattering plane by S.H.Lee et al. 17 provide additional evidence to support the f111g type polarization in PMN.

Fig. 3 shows cuts through the data along the (110) direction at three selected tem peratures. At 400 K, which is well above $T_{\rm C}$, the di use scattering intensity is already measurable. At higher tem peratures, the di use scattering intensity become se even weaker and harder to measure. We use a simple Lorentzian function to describe the spatial correlation of the atomic displacements contributing to the di use scattering:

$$I_{diff} = \frac{I_0}{(q^2 + 2)};$$

where I_0 is the integrated di use scattering intensity, =

1= is the inverse of the real space correlation length , and q is the length of the wave vector measured from the (100) B ragg position. Fig. 3 shows the results of ts to the Lorentzian, plus a G aussian that describes the central B ragg peak, and a at background. We have been able to obtain good ts using this model. The tting parameters are the integrated intensity I_0 and the half width at half maximum of the Lorentzian, the intensity and width of the central G aussian, and a at background. I_0 and I_0 are plotted in Fig.4.


In Table. I, we list the integrated di use scattering intensity I_0 , correlation length , and the intensity at a selected wave vector Q=(1.95;0.95;0) vs tem perature T. The elastic di use scattering starts to be noticeable around T 400 K, much below T_d 620 K. The \correlation length" is a direct measure of the length scale of the static PNR. A coording to our results, the PNR are small when they rst appear at high tem peratures, with average sizes around 15 A (see Fig. 4). Both the spatial correlation length of the atom ic displacements and the integrated intensity of the di use scattering increase on cooling, even at tem peratures below T_C (Fig. 4). At low tem peratures the length scale of the PNR reaches 65 A.




FIG. 5: P lot of $I_0\!=\,^3\,$ vs T . P aram eters were obtained from the $\,$ ts to the di use data.

From T = 300 K to 100 K, the volume of a single PNR (V / 3) increases by a factor of 60, yet the integrated intensity only increases by a factor of 10. W riting I_0 as the product N 3 D 2 j where N is the total number of PNR and is the average displacement of atoms within the PNR, we conclude that N D 2 jincreases on cooling from high temperatures and then drops dramatically at around T_C , remaining roughly constant below T_C . This is illustrated in Fig. 5 which shows I_0 = 3 as a function of T. A likely scenario is that on cooling below T_C , remains relatively constant whereas N decreases as the smaller PNR merge together.

P revious inelastic neutron scattering m easurem ents on PM N 14 have shown that the transverse optic (T O) m ode phonon becom e overdam ped near the zone center, start-

ing at T_d 600 K, which is roughly the temperature at which the PNR start to appear. We believe that the overdam ping of the soft TO mode phonon is directly associated with the form ation of the PNR. In other words, the PNR m ay originate from the condensation of the soft TO m ode. Reexam ining the neutron di use data on PMN by Vakhrushev et al. Hirota et al. have proposed a new interpretation of the atom ic displacem ents derived from the data. The atom ic displacem ents can be decom posed into the sum of two terms with comparable magnitudes: soft + shift. soft values satisfy the center-of-m ass condition and are consistent with the values derived from inelastic scattering intensities from the soft TO mode. The other term , $_{\mbox{\scriptsize shift}}$, shows that the PNR are shifted along their polar directions relative to the surrounding lattices. This \uniform phase shift" has established convincing connections between the di use scattering from the PNR and the condensation of soft TO mode phonons.

It is important to note that the magnitude of $_{\rm shift}$ is

com parable to $_{\rm soft}$, which can be estimated to be around 1/10 of the lattice spacing. This large phase shift creates a huge energy barrier, preventing these polar regions from merging into the surrounding lattices.

Recently, Gehring et al. have perform ed measurements that unambiguously established a true ferroelectric soft mode in PMN¹³. Further inelastic neutron scattering studies by W akim oto et al. 14 show that the soft mode extends to much lower tem peratures below T_{C} , and that the phonon energy squared $(\sim !_0)^2$, which is inversely proportional to the dielectric constant , increases linearly with decreasing temperature. These results represent a dynamical signature of a ferroelectric phase below $T_{\mathbb{C}}$. The phase below T_C is now believed to be the recently discovered phase X 19,20, which exhibits an average cubic structure. However, unlike conventional ferroelectric phase transitions, no macroscopic (rhombohedral) lattice distortion has been observed. The decoupling of the lattice distortion from the ferroelectric polarization is quite intriquing, and we believe that the interaction between the PNR and the surrounding lattices is the key in solving this puzzle.

Our current understanding of PNR in relaxor systems

can be described as follows: At the Burns temperature T_d , the soft TO phonon mode becomes overdamped near the zone center, and starts to condense into PNR. These regions form with local polarizations along f111g directions and are shifted uniform by along their individual polarization direction. The number and size of PNR in the system increases with cooling. At the phase transition $T=T_C$, a large scale overall \freezing" of the PNR occurs. Small PNR merge into larger ones and the total volume of PNR in the system keeps increasing. The related ferroelectric soft mode lifetime increases below T_C ,

and the overdam ping near the zone center disappears. A macroscopic ferroelectric polar phase without lattice distortion is then established. Below $T_{\rm C}$ the size of the PNR can grow slowly with further cooling. However, if the coupling between the PNR and the surrounding lattice is not su ciently strong, as is the case in pure PMN, then the energy barrier created by the uniform phase shift would prevent the PNR from merging further and forming macroscopic lattice distortions. The resulting phase will have a polar lattice of average cubic structure, but with embedded (rhombohedrally) polarized PNR.

In addition to neutron and x-ray di use scattering measurements, recent R am an studies 21 and specic heat measurements 22 have also provided useful information on PNR in PMN. We are planning to carry out further diffuse scattering measurements on a series of relaxor systems in the near future.

In sum m ary, we have shown high resolution neutron elastic di use scattering data from PMN in the tem perature range of 10 K to 650 K. The form ation and development of PNR at tem peratures above, around, and below $T_{\rm C}$ have been carefully studied. A merging of smaller PNR into larger ones occurs at the ferroelectric phase transition, while further growth of the PNR into macroscopic rhom bohedral domains can not be achieved below $T_{\rm C}$.
