The rôle of electronic correlations on the the phonon m odes of M nO and N iO

The possibility of magnetic-order induced phonon anisotropy in single crystals of M nO and N iO is investigated using inelastic neutron scattering. Below T_N both compounds exhibit a splitting in their transverse optical phonon spectra of approximately 10%. This behavior illustrates that, contrary to general assumption, the dynamic properties of M nO and N iO are substantially non-cubic.

The failure of ab initio approximations to correctly incorporate many-body e ects such as electron exchange and correlation is an issue at the core of contemporary solid-state research. A lthough these e ects are important in alm ost all solids, they are essential for a proper description of co-operative phenomena such as antiferrom agnetism, charge-ordering, superconductivity and colossal m agnetoresistance.

D espite the status of M nO and N iO as benchm ark m aterials for the study of correlated electron systems and frequent use in rst principles electronic structure investigations, m any aspects of the physics of the 3d transition m etalm onoxides requires better theoretical explanation. For example, the basic physical properties predicted for M nO and N iO (e.g. band-gaps, distortion angles and phonon spectra) di er radically depending upon which techniques have been em ployed [1, 2].

In a recent publication comparing di erent ab initio and m odelband-structure m odels on M nO (including bcal spin-density approximation (LSDA) and LSDA + m odel' calculations), M assidda et al. [2] suggest that although the electronic density in M nO is approximately cubic, the low ering of sym m etry associated with antiferrom agnetic ordering can induce an electronic response that is signi cantly non-cubic. This results in the dynamical properties of the system, such as transverse optical (TO) phonons, exhibiting substantial \m agneticorder induced anisotropy".

O ne of the predicted features from such calculations is that the zone center (ZC) optical phonon modes should split depending on their polarization. A higher energy occurs for a mode polarized along the [111] direction and a lower energy for degenerate modes polarized in the orthogonal ferrom agnetic plane, see Table I. Massidda et al. [2] nd that this e ect arises solely due to the magnetic ordering, and would even occur in the absence of any rhom bohedral distortion. By com paring results from four di erent approximation schemes, lower and upper bounds of 3-10% for the magnitude of the splitting are estim ated. Variations in the splitting due to the distortion are calculated to be less than 1%. A lthough sim ilar theoretical calculations have not yet been performed for N iO, the results of measurements of N iO TO phonons are predicted to be qualitatively similar to those in M nO. Indeed, it has been suggested that the splitting in N iO may be even greater in absolute magnitude than in M nO due to the larger magnetic superexchange [3].

M nO and N iO are classic exam ples of type-II antiferrom agnets possessing the cubic rock-salt structure. Below T_N, exchange-striction causes contraction of the unit cell along the [111] direction perpendicular to the ferrom agnetic planes [4, 5]. This results in a sm all deviation from the perfect cube of 0.62° for M nO and 0.1° for N iO. In M nO the magnitude and tem perature dependence of the rhom bohedral distortion has been well characterized [6]. Since the distortion is considered weak, investigations of the dynam ic properties of M nO and N iO are frequently carried out under the assumption of perfect cubic symmetry.

To exam ine the possibility of anisotropy in the opticalphonon spectra of M nO (and N iO), (and distinguish these e ects from any changes due to the sm all rhom bohedral distortion), TO phonons in single crystals of M nO and N iO were measured using inelastic neutron scattering. M nO and N iO crystals used in these experiments were grown using the oating-zone method at a rate of 10 mm/h in 1 atm of Argon. B oth crystals consisted of sm all cylindrical pillars approximately 0.5 cm in diameter and 2 cm long.

The optic phonons, m agnon m odes and sublattice m agnetization of our M nO crystal were studied using the IN 8 triple axis spectrom eter located at the high- ux reactor at the Institut Laue Langevin, (ILL), G renoble. The Cu (111) re ection was used as m onochrom ator in com bination w ith a pyrolytic graphite (PG) liter, PG (002) analyzer and Soller collimation. M easurem ents were m ade using constant-Q scans, with a xed nalenergy of $E_f = 14.69 \text{ meV}$, ($k_f = 2.66 \text{ A}$). The crystal was oriented w ith the [110] direction vertical.

O perating the spectrom eter in di raction mode, measurem ents of the tem perature evolution of the magnetic $(\frac{3}{2},\frac{3}{2},\frac{3}{2})$ re ection were obtained. The observed value of T_N = 118 K, measured during slow cooling at a rate of 1° every 3 m ins, was in excellent agreem ent with previous reports [7, 8, 9].

Compression along equivalent [111] directions in the bulk crystal creates four possible orientations of twinning, or T-dom ain', each with a distinct 3D orientation of magnetic Brillouin zone. The scattering plane of the sample is then comprised of a superposition of slices through each of the magnetic Brillouin zones [10, 11]. The T-dom ains in our M nO sample were characterized using spin wave dispersion measurements obtained at 4.3 K. Proceeding by continuity from unambiguously de-

ned reciprocal lattice positions, the full magnon dispersion curves of our multi-T -dom ain M nO crystal along the [110], [001] and [111] directions were determ ined. From these dispersion curves it was possible to deduce that the crystal was comprised of two approxim ately equally populated tw inned dom ains.

M easurements of transverse optical (TO) phonon m odes were obtained along several directions in the crystal ([001], [111] and [110]) and around various B rillouin zone (BZ) centers (Q = (004), Q = (113), Q = (222) and Q = (220)). At 4.3 K, splitting of the m odes was consistently observed in all of the m easured BZ's. R epresentative zone center scans obtained at 4.3 K and 300 K are shown in gure 1.

The energy of the 300 K ZC excitation occurs at 33.2 $\,$

0.2 meV with a full-width half-maximum of 2.87 0.5 meV. In the antiferrom agnetically ordered phase at 4.3 K two modes were consistently observed at energies of E = 33.3 0.2 meV and E = 36.4 0.3 meV. The zone center splitting at 4.3 K is approximately 3.1 meV,

which corresponds to 9.3% of the energy of the original (degenerate) m ode above T $_{\rm N}$.

The uncertainty in reduced wave vector, q, arising from the rhom bohedral distortion was estimated for the m easured Brillouin zones to range between dq= 0.02 and dq= 0.04 r.Lu. At the ZC position where the dispersion of the TO modes is virtually at the e ects of an uncertainty of this magnitude on the energy spectra would be negligible. We therefore conclude that the splitting is a reale ect which can not be attributed to the sm all static structural distortion.

The low tem perature data were tted to a pair of G aussian peaks of identical width. Peaks at each of the zone-centers possessed widths of 2.43 0.6 m eV. The ratio of the integrated intensities of the two peaks was approximately 2:1 in favor of the lower mode at each of the measured zone-centers. The total integrated intensity of the two (split) peaks and the initial single peak were approximately conserved on passing through $T_{\rm N}$. This behavior is consistent with the creation of a new higher energy mode arising from excitations polarized along the [111] direction [2]. A lihough both modes are observed at a slightly higher energy than the LSDA + model value (table 1), the observed 9% anisotropy is within the suggested bounds of 3–10% [2].

P bots of the tem perature evolution of the ZC phonon anisotropy are shown in gures 1 (inset) and 2. The splitting in the phonon spectra is clearly associated with the transition to magnetic order. A symmetry in peaks measured at 130 K and 150 K (g. 2) hints that a small amount of anisotropy may be present at tem peratures substantially above T_N , (i.e. when the unit cell is thought to be perfectly cubic [6]).

D ispersion curves obtained for TO m odes along the [100] and [111] directions in M nO at 4.3 K and 150 K are presented in gures 3 and 4 (a). A lthough the splitting extends throughout the B rillouin zone, the distortion is m ost clearly resolved at values of reduced w avevector (q) close to the zone-center, see gure 3 (a). Further from the ZC (w here the scattering is less intense and the spectrom – eter m ay be less focussed), the presence of two m odes is revealed by the deviation of the shape of the overall peak from G aussian, and its increased width in com parison to the sam e m easurem ent at 150 K, g. 3 (b). As the crystal consisted of two dom ains, intensity from di erently polarized m agnons could be seen reasonably well in all of the m easured directions.

The notion that a small splitting may be present in M nO above T_N is supported by the dispersion measured at 150 K, shown in gure 4(a). The 150 K data (open circles) was tted to a single G aussian peak but found to be slightly raised in energy in comparison to the lower energy mode (led circles), and to the room temperature data of W agner et al. [13] (square markers).

To investigate whether a similar phonon splitting could be observed in the room temperature dispersion of NiO,

a prelim inary survey was performed using the HB1 spectrom eter located at the High Flux Isotope Reactor, O ak Ridge N ational Laboratory, USA. As before, the crystal was oriented with the [110] direction vertical, and the spectrometer operated in constant-Q mode with xed - nalenergy $E_f = 14.73$ meV.

O ur N iO crystal was of less reliable quality than the M nO crystal, and spurious B ragg-B ragg-inelastic' scattering was observed. This limited our measurements to regions surrounding ZC's located at Q = (220) and Q = (222). Room temperature TO dispersion curves for the [111] and [001] directions of antiferrom agnetically ordered N iO are presented in gure 4 (b) (lled round markers). Squares represent the data of R eichardt et al. [15], also collected at room temperature.

In our N iO data two peaks were observed occurring at energies of around 45 and 50 m eV. This is in reasonable agreement with previous reports indicating a single TO excitation with an energy varying between 46 and 50 m eV [15, 16]. This ZC splitting of approximately 5 m eV is larger in absolute magnitude than observed in M nO,

(despite the smaller distortion angle), and corresponds to roughly 10% of the average energy of the two m odes.

Since both this data and data of previous researchers were collected at room temperature (where N iO is already magnetically ordered) it is necessary to ask why this e ect had not been been observed before. We suggest that the cause of the discrepancy lies in the poor energy resolution and ux of the early spectrom eters, particularly at high energy transfers. These experimental factors coupled with the expectation of a single (degenerate) phonon mode may have lead to thing of the data to a single peak.

In sum mary, we have shown that below T_N the dynamic properties of MnO and NiO are substantially noncubic. The magnitude of the zone center anisotropy observed in transverse optic modes in MnO and NiO corresponds to 9-10% of the energy of the original (degenerate) phonon. The intensities of the two optic modes in MnO and the form of the dispersion are consistent with the picture of the splitting described by recent band structure calculations where a higher energy m ode is predicted for phonons polarized along [111] [2].

In MnO, we have shown that the splitting of the phonon modes is associated with the transition to maqnetic order. A lthough exchange-striction induces a sm all rhom bohedral distortion, this static distortion in itself is too weak to explain the magnitude of the anisotropy. Furthermore, N iO possesses a signi cantly sm aller distortion angle than M nO but a larger (5 m eV) splitting. The strain associated with exchange-striction (even in the undistorted structure considered by M assidda et al. [2]) de nes a new potential well for the atom s, which may signi cantly in uence the dynam ics. However, further research will be required to investigate the mechanism underlying the splitting and determ ine how the magneticorder induced phonon an isotropy in M nO and N iO is mediated. Theoretical studies investigating the rôle of electronic correlations on the phonon modes of N iO are particularly encouraged. A lthough theorists have not provided any calculations for N iO as yet, we are con dent that our prelim inary ndings of an even larger splitting will provide a new impetus for them to do so.
