# Tunneling e ects on impurity spectral function in coupled

asym m etric quantum w ires

## Abstract

The inpurity spectral function is studied in coupled double quantum wires at nite temperatures. Simple anisotropy in the connement direction of the wires leads to nite non-diagonal elements of the impurity spectral function matrix. These non-diagonal elements are responsible for tunneling elects and result in pronounced extra peak in the impurity spectral function up to temperatures as high as 20 K. 73.50 G r, 73.21 H b

#### I. IN TRODUCTION

From a theoretical point of view, it is well known that the Coulomb interaction leads to the Luttinger liquid (LL) behavior of one-dimensional (ID) electron systems. The LL is mostly characterized by the spin-charge separation in the elementary excitation spectrum. [1] However, experimental results concerning inelastic light scattering due to both chargedensity (plasmon) and particle-hole (single-particle) excitations in 1D electron system sbased on sem iconductor quantum wires (SQW s) can be interpreted within the random phase approximation (RPA) in the framework of the Fermi liquid (FL) theory. [2] Am ong other issues, the Fermi edge singularity [3] and the band gap renormalization [4,5] in these systems can also be successfully explained within the RPA. As a matter of fact, the resonant inelastic light-scattering experiments in SQW shave been analyzed using both the FL and LL theory. [6[8] Recently, a new kind of tunneling spectroscopy in coupled parallel quantum wires in G aA s-based sem iconductors was able to check out the Luttinger liquid behavior of the electrons in extrem ely clean system s at very low tem peratures. [9] D i erences between the Luttinger and Ferm i liquid behavior turned out to be noticeable in the one-electron spectrum.

So far, no de nitive evidence for LL versus FL behavior has been obtained. It is still a puzzle in clarifying the conditions under which the 1D electron system embedded in SQW behaves as a LL. There have been theoretical suggestions that mechanisms induced by im – purity scattering, therm al uctuations as well as intersubband scattering can likely suppress the LL behavior. [6,10,11] E ects of the intersubband (or interwire) excitations are believed to disable the LL behavior, provided the system looses its strict one-dimensional character. M oreover, electron intra- and intersubband relaxations through slightly in purity scattering channels could restore the FL behavior. O n the other hand, localized in purity (or defect) induced e ects in a 1D metallic system s in quantum wires have been extensively studied [12] within both the FL and LL theories. These in purity e ects turn out to be related to critical phenomena in the strongly correlated regime and to the X-ray absorption spectrum,

where a optical created valence hole is regarded as an impurity.

In this work we are interested in studying the impurity induced optical properties in sem iconductor quantum wires which can be helpful in understanding the 1D properties of the electron systems. We focus on the spectral function of a localized valence hole (or an spinless in purity) in a two-component coupled double quantum wires at nite temperatures. The considered interaction is of a localized state with a continuum described by a coupled double 1D system with two subbands (or components) led with electrons. Two parallel wires in the x-direction, with zero thickness in the z-direction, compose the system . In the y-direction, the two wires are of 300 A and 200 A widths, respectively, separated by a 30-A A IS aA s barrier of 300 m eV height. We assume zero thickness in the z-direction. The energy gap between the rist and the second subbands is  $!_0$  ' 5.36 m eV. W e consider the impurity localized at the center of the barrier. Such a system is also similar to a type-II quantum w ire heterostructures, where valence holes are localized between two parallel 1D electron gazes.

Our theoretical result indicates that the interwire tunneling induced many-body e ects in coupled asymmetric quantum wire systems lead to a non-monotonic impurity spectral function. A pronounced extra peak appears in the impurity spectral function up to 20 K.

The paper is organized as follows. In Sec. II we present the theory with the working form ulae; in Sec. III we provide our num erical results and discussions; we conclude in Sec. IV with a summary.

## II.THEORY

## A. Interwire Coulom b potential

The anisotropy in the direction perpendicular to the wires leads to a very weak tunneling, but it is sensitive enough to produce important e ects on both the electron-electron (e-e)

 $V^{e}$  and the electron-impurity (e-i)  $V^{e}$  <sup>i</sup> Coulomb interactions. The asymmetry leads to nonzero o -diagonale-e interaction matrix elements of  $V^{e}$  <sup>e</sup>. [13] These elements represent e-e scattering in which only one of the electrons experiences interwire (or intersubband) transition. In the symmetric situation (two identical wires), however, these o -diagonal matrix elements vanish because the wavefunctions of the ground and the rst excited states are symmetrical and anti-symmetrical, respectively, in the con nement direction.

On the other hand, the e-i interaction matrix element related to the interwire transitions is de ned as

where  $"_0$  is the static dielectric constant, e the electron charge,  $K_0(q \dot{y})$  the zeroth-order m odi ed Bessel function of the second order, and  $_j(y)$  the electron wavefunction in the w ire (or subband) j. The derivation of this potential is sim ilar to that in Ref. [14], where its quasi-two-dimensional counterpart was calculated. The Bessel function  $K_0(q \dot{y})$  results from the integral in the x-direction, which involves the external e-i C oulom b potential

and the plane wave describing free electrons in that direction. It depends obviously on the impurity position  $x_i = y_i = 0$ , which has been chosen here as the origin of the coordinates. The component  $V_{12}^{e~i}(q)$  represents interwire (intersubband) transitions su ered by the electron as it interacts with the localized impurity. This interaction induces anisotropy (or tunneling) elects on the full impurity spectral function that we investigate in this work. We mention that, for two identical wires,  $V_{12}^{e~i}(q) = 0$  due to the fact that the  $_1(y)$  and  $_2(y)$  are symmetrical and anti-symmetrical functions of y, respectively.

## B. Interw ire im purity G reens function

We model the system by an Anderson impurity localized below the continuum of the two subbands (j = 1;2) in the coupled quantum wires led with electrons. This approach

has been used before in studying optical holes in doped two-dimensional systems at zero tem perature.  $[15\{17]W$  e point out that the H am iltonian presenting the interaction between the impurity and the two-component 1D electron gas can be transformed into a problem of a localized level with energy "i and a two-component non-interacting bosons (electron-hole pairs). Therefore, we are dealing with an independent boson model which is exactly solvable. The term in the H am iltonian describing the boson coupling to the impurity is written as

where  $b_q^+$  ( $b_q$ ) creates (destroys) a boson in the state (j; j) with wavevector q. Here, V<sup>e i</sup>(q) is the electron-impurity interaction matrix element. Notice that this coupling occurs only when the impurity state is occupied and d<sup>+</sup> d = 1:

A fter a canonical transform ation of the type  $e^{S}H e^{S}$  with

the Hamiltonian (3) can be rewritten as

where  $= \Pr_{q} \frac{v^{e^{-i}(q)}}{!(q)}^{2}$  is the self-energy involving the frequency ! (q) of the boson in the state with wavevector q: One may then proceed to obtain the impurity G reens function from the Hamiltonian (5). A fler som e algebra, an exact and closed form to the impurity G reens function are obtained [18]

with  $n_B$  ( ) being the Bose distribution function. The Feynman stheorem on the disentangling of eld operators is employed to determ ine G (t). The bene t of treating the system within the independent boson model comes when our working form use are obtained without any approximation.

In Eq. (6), is the self-energy shift in relation to the inpurity energy "<sub>i</sub>: This shift is time independent and has no major elect on the total inpurity spectral function other than renormalizing the band-to-band threshold transition energy  $!_T = "_i$ . For the sake of simplicity, we take  $!_T = 0$  throughout this paper. We focus on the time-dependent self-energy term (t) which requires the boson density of states [18]

which determ ines the shape of the impurity spectral function. In Eq. (8),  $V^{s}(q; )$  is the screened e-iC oulom b potential, and (q; ) is the non-interacting irreducible polarizability function. The screened interaction  $V^{s}$  is obtained from the generalized self-consistent equation,

with the dielectric matrix

being written within the RPA.

We point out that the formula for the density of states R () has been conveniently chosen in order to take into account elementary excitations (or screening) occurring in the experiment. The quantity R () is also playing a role of a density of states for the electron-electron interaction provided it is determined by collective excitations (entering in the calculation via the screened e-i potential  $V^{s}(q; )$ ), which remain in the particle-hole excitation continuum where Im [ (q; )]  $\in$  0: It will then depend on the electron density  $n_{e}$  in the sample, since the polarizability does. Therefore, in calculating R (), we are dealing with a boson density of states, which have been m apped onto elementary excitations in the real electron system.

The elementary excitation spectra of a Ferm i system embedded in the biw ire structure present the well-known optical,  $!_+$  (q); and acoustic,  $!_-$  (q), plasm on modes corresponding to the in-phase and out-of-phase charge density uctuations, respectively. [19] The dispersion relations of these modes are obtained through the equation det  $j^{*}$  (q; !) j=0.

We devoted special attention in this work to the element  $R_{12}$  (); which is interpreted as the rate of creating interwire electron-hole pairs (bosons) with electron (hole) being in the wider (narrower) wire. The tunneling between the wires is responsible for  $V_{12}^{e}$  <sup>i</sup>(q) and, as a consequence, for  $R_{12}$  (). It then leads to the interwire in purity spectral function de ned as

is the nite temperature in purity G reens function involving the electronic transitions between the wires. The in purity spectral function in 3D systems at zero temperature diverges as power-law at ! ! !<sub>T</sub>. This divergency is due to the so-called orthogonality catastrophe involving the overlap between the initial (without in purity) and nal (with in purity) m any-body states. [20] Here, the Bose distribution function  $n_B$  (!), governing the particlehole excitations at nite temperatures, plays an important role being responsible for the behavior of  $A_{12}$  (!) as ! ! 0.

## III.NUMERICAL RESULTS

In Fig. 1 we show the  $R_{12}()$  at di erent tem peratures for the total charge density  $n_e = 10^6$  cm<sup>-1</sup>. As discussed above, Eq. (8) indicates that the screened e-i potential  $V_{12}^{s}(q; )$  in the interwire particle-hole continuum, where Im  $[_{12}(q; )] \in 0$ ; determines the interwire density of states  $R_{12}()$ . On the other hand, the weak interwire particle-hole excitations in the present system only result in partially Landau damping on the plasm on

m odes as we discussed in R ef. [13]. Therefore, the survived optical  $!_{+}$  (g) and acoustic ! (g) plasm on m odes in this region are of dom inant contribution to  $V_{12}^{s}$  (g; ) and, consequently, in determ ining the  $R_{12}$  (). In order to understand that, we show in Fig. 2 the intra- and interw ire particle-hole excitation spectra along with the plasm on dispersion relations of the optical and the acoustic m odes in the system with  $n_{e} = 10^{6}$  cm<sup>-1</sup> at zero temperature. The corresponding  $R_{12}$  () is given by the solid curve in Fig. 1. Clearly, there are well de ned borders of the interw ire particle-hole continuum at zero temperature. The wellshaped  $R_{12}$  () follows the optical and acoustic branches entering and leaving each continuum region. The acoustic (optical) m ode enters and leaves the lower interw ire particle-hole continuum region at ! ' 3:0 and 3:8 m eV (!\_+ ' 3:7 and 4:3 m eV), respectively. The optical one enter the higher interw ire particle-hole continuum region at !\_+ ' 6:3 m eV. In comparison with the plasm on dispersions, our calculation indicates that the  $R_{12}$  () is dom inated by the acoustic and the optical plasm on branches which rem ain in the interw ire particle-hole continuum. We address that, in calculating  $R_{12}$  (), we are dealing with an interw ire boson density of states, which have been m apped onto elementary excitations in the Ferm i system .

For the sake of completeness, we show the intrawire element  $R_{11}()$  in the inset of Fig. 1 for the same temperature range. The rate  $R_{11}()$  is dominated by the intrawire particle-hole excitations. But the partially damped acoustic plasm on mode in the intraw ire particle-hole excitation continuum has a small contribution to  $R_{11}()$  in our asymmetric system. We also show that, quantitatively, the  $R_{12}()$  is larger than the  $R_{11}()$  at very low temperatures. Consequently, it dominates the full impurity spectral function at low temperatures. In increasing temperature,  $R_{12}()$  ( $R_{11}()$ ) decreases (increases) and the interwire elects carried by  $R_{12}()$  are suppressed by  $R_{11}()$ . Moreover, the function  $R_{12}()$  is of dimension in comparing with the  $R_{11}()$  which is roughly a slow ly varying function. The abrupt increase in  $R_{12}()$  leads to a speci c structure in the impurity spectral function due to the small probability of creating electron-hole pairs whose electrons are found in the narrower wire.

In Fig. 3, the dotted and dashed lines show  $A_{jj}(!)$  for (j;j) = (1;1) and (j;j) = (1;2), respectively, at T = 2 K. The full spectrum (solid line) should be observed experimentally via photoem ission or photocurrent spectroscopy and are proportional to the in purity density of states involving elementary excitations mostly due to the wider quantum wire. The interwire tunneling induced e ects as discussed above relect on the non-diagonal element  $A_{12}(!)$ . We see structures in the spectral function  $A_{12}(!)$  in which dip and peak correspond to the behavior of  $R_{12}(.)$ . These structures represent the contribution coming from interwire increases.

In Fig. 4(a), we show  $A_{12}()$  at temperature T = 2 K for dimensional densities  $n_e$ . The gure clearly shows the enders due to intervine particle-hole excitations and their dependence on the total charge density in the sample. As  $n_e$  decreases, the narrower wire becomes less populated and the shoulders in the gures get a ected. In Fig. 4(b), we show the temperature evolution of  $A_{12}(!)$  for  $n_e = 10^6 \text{ cm}^{-1}$ . A linearly the temperature suppresses the intervine boson excitations, the end to intervine interaction is observable in our calculation up to T = 30 K. Moreover, the Boson distribution function  $n_B(!)$ ; governing the intervine self-energy propagator  $_{12}(t)$  at nite temperatures, leads to the divergency in  $A_{12}(!)$  for ! ! 0.

## IV.SUMMARY

In sum m ary, we have studied the non-diagonal (interwire) element of the spectral function m atrix of a localized in purity in a coupled double quantum wires. We show that the tunneling between the two asymmetric wires induces interwire particle-hole excitation e ects leading to a pronounced peak in the impurity spectral function up to 20 K which should be observable in the photoem ission or photocurrent spectroscopy. We nally remark that experimental observations of these e ects could serve as a signature of one-dimensional FL in the proposed system.
