## Bogoliubov sound speed in periodically modulated Bose-Einstein condensates

We study the Bogoliubov excitations of a Bose-condensed gas in an optical lattice. Of prim ary interest is the long wavelength phonon dispersion for both current-free and current-carrying condensates. We obtain the dispersion relation by carrying out a system atic expansion of the Bogoliubov equations in powers of the phonon wave vector. Our result for the current-carrying case agrees with the one recently obtained by means of a hydrodynam ic theory.

I. IN TRODUCTION

The possibility of creating optical lattices in trapped Bose-condensed gases has provided an opportunity to study super uids in novel situations. The presence of the lattice leads to a variety of solid state e ects associated with the coherent motion of the atom s in a periodic potential. For example, the oscillation frequency of the centre of m ass m otion of the condensate is reduced [1] as a result of the enhanced e ective mass of the atom s tunnelling between potential wells. Furtherm ore, when subjected to a uniform force, as provided by gravity [2] or alternatively by accelerating the optical lattice itself [3], B loch oscillations of the condensate have been observed. Reducing the amplitude of the lattice potential leads to a breakdown of these oscillations as a result of Landau-Zener tunnelling between bands [3]. All of these observations are essentially a manifestation of the super uidity of the Bose condensate in an optical lattice. A nother aspect of equal interest is the breakdown of super uidity as recently observed [4] in a study of the centre of m ass m otion of a trapped condensate moving through an optical lattice. W hen the amplitude of the oscillation exceeded a critical value, dissipation was seen to set in.

In this paper we study a Bose-condensed gas subjected to a uniform optical lattice in a regime where the dynamics of the condensate wave function is well described by the time-dependent G ross-P itaevskii (GP) equation. In particular, we are concerned with small am plitude collective m odes which at long wavelength are phonon-like excitations. The relevant physical parameters determ ining the properties of the excitation are the optical potential am plitude,  $V_0$ , the lattice constant, d, the m ean density, n, of the gas, and the m agnitude of the supercurrent. The problem has been addressed theoretically in a number of papers using a variety of techniques and approximations.

Berg-S rensen and M Imer [5] were the rst to investigate phonon excitations within an optical lattice. They solved the Bogoliubov equations numerically for a onedimensional model and established that the long wavelength excitations are phonon-like, having an energy dispersion that is linear in the wave vector of the mode. They also obtained an analytic expression for the sound speed, s, which is based on a combined weak potential and slow ly varying approximation. These calculations were extended by W u and N iu [6] to the case in which the condensate carries a current. This work is noteworthy for having pointed out that the modes exhibit both energetic and dynamic instabilities for su ciently large currents. The form er instability is associated with the Landau criterion for the breakdown of super uidity, while the latter is related to the onset of dissipation as observed in [4]. The recent paper by M achholm et al. [7] explores these instabilities further. Sim ilar results were obtained by B ronski et al. [8] by considering a special form of the lattice potential, while K onotop and Salemo [9] used a di erent approach to establish that the dynamic (orm odulational) instability leads to the generation of solitons.

W hen the potential wells are su ciently deep, the condensate is well-localized on each lattice site and a tightbinding description becom es useful. Javanainen [10] used this picture within a many-body form ulation to derive the phonon dispersion throughout the Brillouin zone for a one dimensional lattice. This calculation is in fact equivalent to one based on the Bogoliubov equations [11] or the discrete version of the time-dependent GP equation [12]. The virtue of these m ethods is that they provide analytical expressions for the dispersion relation, although an accurate a priori determ ination of the tight-binding param eters involves further num erical calculation. Sm erzi et al. [12] extended the results of Javanainen [10] by deriving the phonon dispersion for a current-carrying state and found a dynam ic instability that is responsible for a so-called 'super uid-insulator' transition.

The phonon dispersion at long wavelengths was addressed in [13] by deriving an energy functional involving density and phase uctuations which vary slow ly in space. The approach is closely allied to the e ective mass approximation used in solid state physics [14] and recently applied to Bose gases in optical lattices [15], and to multiple-scale analysis [9, 16]. The phonon sound speed is found to be [17]

where m is an e ective mass and is the chemical potential. The precise de nition of the e ective mass as (m )  $^{1} = \sim {}^{2}@^{2} \sim = @k^{2}$ , where ~ is the energy per particle of the N-particle system, seems rst to have appeared later [7, 18]. This is an important point since there are other plausible candidates for the elective mass. In fact, we shall see that a somewhat dierent, but equivalent, de nition can be given. In this regard, we note that the elective mass appearing in both the elective mass [15] and multiple-scale [9] theories is that corresponding to the bare optical potential. In other words, the elect of the interactions on this parameter is not included, and therefore the use of the dynamical equations obtained in these theories will not in general give the correct B ogoliubov sound speed.

O ur purpose in this paper is to obtain the long wavelength phonon dispersion directly from the Bogoliubov equations de ning the collective modes. This is achieved by developing a system atic expansion of these equations in powers of the phonon wave vector q. W e do this rst for the current-free state (Sec. III), con ming the result for the sound speed given above. W e then consider a current-carrying state (Sec. IV) and obtain the analogous phonon dispersion in this case, reproducing the result obtained in [7] by means of a hydrodynam ic analysis. O ur expansion technique can be viewed as a justi cation of the assumptions on which the hydrodynam ic approach is based. Furtherm ore, it provides explicit perturbative expressions for the various physical quantities that appear in the theory (for example, the e ective mass).

In Sec. II we present the theoretical background required for the calculation of sm all am plitude collective excitations in an optical lattice. For the most part we consider a three dimensional optical potential with cubic symmetry, although we also touch on systems with one dimensional modulation as well as radially con ned condensates. The underlying periodicity of the the optical potential in plies that the Bogoliubov equations adm it solutions having a B loch function form . This aspect accounts for the use of a Bloch function basis in solving these equations in both the current-free (Sec. III) and current-carrying (Sec. IV) states. However, di erent calculational methods are used in the two cases and these are therefore presented separately. W e also exam ine various physical lim its (Thom as Ferm i, weak potential, weak coupling and tight-binding) in order to make contact with previous work. As stated previously, our main result for the phonon dispersion a rm s the result which follows from the insightful use of hydrodynam ic equations to describe the dynam ics of long wavelength uctuations [7, 13].

#### II. BASIC THEORY

W e consider an extended 3D BEC subjected to standing wave light elds that give rise to a periodic externalpotential having the property  $V_{opt}$  (r + R ) =  $V_{opt}$  (r), where R is a Bravais lattice vector. For the most part we restrict ourselves to a cubic lattice for which W e base our analysis on the time-dependent G ross-P itaevskii (GP) equation for the condensate wave function, (r;t),

where N is the total number of particles in the volume V . Also of interest is the total energy of the system given by

The energy parameter  $\;$  is the chemical potential and is related to E  $_{tot}$  by  $\;$  = 0E  $_{tot}$  =0N .

O fien the ground state solution of the GP equation is of interest but we shall also consider states which have a super uid ow. These states have a B loch function form

where n is a band index and k is a wave vector restricted to the rst Brillouin zone. The factor n, where n is the m ean density, is introduced in the de nition of  $w_{nk}$  so as to give the norm alization

where is the W igner-Seitz volume. The condensate density is then  $n_c(r) = j_{nk}(r)f = njw_{nk}(r)f$ . The Bloch function  $w_{nk}(r)$  is in general complex and is the self-consistent solution of

We assume that  $w_{nk}$  has the periodicity of the lattice,  $w_{nk}$  (r + R) =  $w_{nk}$  (r), although it should be noted that period-doubled states also exist [19]. The chem ical potential,  $_{nk}$  (n), is implicitly a function of the mean density and depends on the particular B loch state being considered. The super uid current density in this state is

where  $_{nk}$  (r) is the phase of the B loch function  $w_{nk}$ . The spatially-averaged super uid velocity is

In one dimension, the periodicity of  $w_{nk}(x)$  implies  $hd_{nk}=dxi = 2$  l=d, where l is an integer. By continuity of the phase with k, we expect l to have a xed value for a given band, and  $hv_s i = (-m)(k + G)$  where G is some reciprocal lattice vector. For the lowest band, we show in Appendix A that G = 0. Thus, we arrive at the som ew hat surprising conclusion that  $hv_s i = -k=m$ . We suspect that sim ilar results apply in higher dimensions but have not been able to show this explicitly.

The average super uid velocity should be distinguished from the velocity determ ining the average current density

where  $\sim (n;k) = E_{tot} = N$  is the energy per particle in the state characterized by the mean density n and quasim o-mentum k.

In one dimension, the average current density vanishes at the zone boundary k = -d if the mean density is below a critical value  $n_c$  [20]. On the other hand, the average super uid velocity is  $hv_s i = -m d$ . This is not a contradiction since the local super uid velocity in (7) is averaged di erently when calculating the average current density.

D ynam ical states of the condensate are determ ined by the time-dependent GP equation (1). For small am – plitude excitations, the condensate wave function is expressed as  $\frac{1}{2}$

Each distinct solution labelled by the index i corresponds to a collective excitation of the condensate and E<sub>i</sub> represents the excitation energy of the mode. The orthonormality of the quasiparticle amplitudes is specified by

Since the operator  $\hat{L}$  has the translational sym m etry of the lattice, the B ogoliubov equations adm it solutions of the form

O ur notation em phasizes that q and k play distinct roles in the Bogoliubov equations: the former characterizes the B loch-like character of the quasiparticle am plitudes while the latter corresponds to the quasimom entum of the condensate wave function.

In the follow  $\operatorname{ing}$  , we shall also  $\operatorname{m}$  ake use of the H am iltonian

# III. PHONON DISPERSION FOR A STATIONARY CONDENSATE

We begin by considering the simpler situation in which there is no super uid ow (k = 0). In this case, the ground state solution of the time-independent GP equation can be taken to be real, and  $nw_{n=0;k=0}^{2}(r) =$  $nw_{n=0;k=0}^{2}(r) = n_{c}(r)$ . It is then convenient to introduce the functions  $_{i} = u_{i}$  y and to combine the Bogoliubov equations into a single equation for  $_{i}^{+}$  [21],

To solve (19), we introduce a complete set of B loch states which are solutions of the equation

This is a linear Schrödinger equation but the solution for q = 0 and n = 0 coincides with the self-consistent GP solution  $w_{0;0}$ . By de nition, the band energies, "<sub>n</sub> (q), are referred to  $_{0;0}$ , so that "<sub>0</sub>(0) = 0. The functions  $w_{nq}$  satisfy the periodicity property  $w_{nq}$  (r+ R) =  $w_{nq}$  (r) and the orthonorm ality relation

The label i represents a band index m and the B loch wave vector q. However in the following, we will only be interested in the lowest excitation band and will therefore drop the label for convenience. Substituting this expansion into (19) we obtain

W e have displayed explicitly the q-dependence of all the variables.

For a cubic lattice, we anticipate a particular eigenvalue E (q) which has a linear dispersion of the form

O ur objective is to derive an explicit expression for the Bogoliubov sound speed s. From Eq. (19) it is clear that in the  $q ! 0 \lim it$ , the eigenvector corresponding to this particular eigenvalue will be

where n = 0 labels the low est B loch band, since only this band has a vanishing energy (" $_0(0) = 0$ ). As a function of q, the low est band energy behaves as

The phonon eigenvector is a continuous function of q and, as we shall see, behaves as  $c_n (q) = {}_{n0} + O (q^2)$  for sm all q.

To obtain an expression for s we separate the n = 0 equation in (24)

Since  $"_0(q)$  and  $E^2$  are both proportional to  $q^2$ , the latter equation shows that  $c_n(q) / q^2$  for  $n \notin 0$ , as claimed. Thus, to order  $q^2$ , these equations can be replaced by

where all quantities within the square brackets are understood to be the q = 0 values. The prime on the sum mation indicates that the terms n = 0 and n<sup>0</sup> = 0 are excluded from the sum. The matrix  $M_{nn^0}$  is the matrix obtained by deleting the rst row and rst column of M  $_{nn^0}$ . We note that this combination of matrix elements can in fact be written as

This result for an optical lattice was rst given by M enottiet al. [17] on the basis of general dynam ical considerations. We see here that it follows directly from the B ogoliubov equations and also applies in the case of a 3D lattice with cubic symmetry. The small-q expansion can be viewed as a system atic way of im plementing the slow ly varying ansatz used by K rameret al. [13]. The expression for s has the same form as for a hom ogeneous gas, with m<sub>0</sub> replacing the bare massm and the the density derivative of the chemical potential,  $_{0;n}$ , replacing the interaction parameter g. In other words, at long wavelengths the condensate behaves as a gas of particles of m ass m<sub>0</sub> with a compressibility, given by  $^{1} = n$  (@  $_{0;0} = @n$ ).

### A. Thom as-Ferm iLim it

The Thom as Ferm i (TF) approximation is valid when the density varies in space on a length  $\frac{\text{scale much}}{\sqrt{2}=2m \text{ gn}}$ . In this situation, the density is well-approximated by

except in regions where  $V_{opt}$  ' 0. This does not occur if  $_0 > [V_{opt}]_{max}$ , and we then have

where  $\overline{V}_{opt}$  is the mean value of the optical potential in the unit cell. Thus,  $_{0;n} = g$  as for a hom ogeneous gas. Since the e ective potential,  $V_{opt} + gn_0$ , in the GP equation is a constant in the TF limit, we would expect the band mass, m<sub>0</sub>, to be close to the free particle mass, m. One can in fact show that the deviation of m<sub>0</sub> from m is proportional to  $V_0^2$  (=d)<sup>4</sup>, where  $V_0$  is the am plitude of the potential modulation. Since we are assuming that =d 1, m<sub>0</sub> ' m and the TF sound velocity is

as for a uniform gas. It should be noted that this result is valid even when the amplitude of the density modulation is of order the mean density n, provided only that the inequality = d 1 is everywhere satis ed.

If  $_0 < [V_{\rm opt} \, l_{\rm max}$ , the Thom as Ferm idensity develops holes' in regions where  $V_{\rm opt} > _0$ . For a one-dimensional modulation the density is disjoint, as is the case in two or three dimensions for su ciently smalldensity. In this situation long wavelength propagating phonon excitations cannot exist within the TF approximation since the necessary uctuations in the number of atoms from one lattice cell to the next cannot occur. In reality, the GP density in regions where  $V_{\rm opt} > _0$  is smallbut nite and phonon-like excitations continue to exist. However, increasing the localization of the density in the potential minimal leads to larger elective masses and eventually the sound speed s tends to zero. This behaviour cannot be described within the TF approximation.

# B. Weak-Coupling Limit

The g-dependence of  $_{0,n}$  appears explicitly in (35) and in plicitly through the wave function  $w_0$  which satis es (33). To extract the dependence in the limit g ! 0, we expand the wave function as  $w_0 = w_0^{(0)} + g(@w_0 = @g)_{g=0} +$ 

. Since depends on g through the combination gn, we see that  $g(@w_0=@g) = n(@w_0=@n)$ . Thus, the combination  $nw_{0,n}$  appearing in (35) is proportional to g in the small-g lim it and the second term on the right

hand side of (35) is of order  $g^2$  . We then have

As discussed in Ref. [18], the rst term accounts for the e ect of the lattice on the compressibility, , which decreases with increasing localization of the wave function  $w_0^{(0)}$ . The second term shows that  $_{0,n}$  deviates from a linear dependence on g as the strength of the interaction is increased. An explicit expression for this quadratic correction can be obtained from the equivalent expression for  $_{0,n}$  in (39) in which the two terms respectively correspond to the two integrals in (35). From the de nition of the M<sub>nn</sub><sup>o</sup> matrix in (25), we see that

Since the excitation energies are positive, we see that  $_{0,n}$  has a negative curvature, which agrees with the num erical results in Ref. [18]. The interatom ic interaction has the e ect of increasing the width of the wave function which counteracts the localizing e ect of the lattice potential.

#### C. W eak Potential Lim it

It is also of interest to obtain an expression for the sound speed in the case of a weak optical potential where perturbation theory applies. For simplicity we consider a weak one-dimensional periodic potential  $V_{opt} = V_0 \cos(G z)$ , where G = 2 =d, applied to an otherwise three-dimensional system. The relevant GP equation is now one-dimensional,

To complete the calculation of the sound speed, we require an equivalent expression for the e ective mass. This can be obtained by solving

in agreem ent with the approximation to the sound speed obtained by Berg-S rensen and M lm er [5].

To make contact with Ref. [18], we introduce the recoil energy  $E_R = \sim^2 {}^2=2m d^2 = "_G^{(0)}=4$  and de ne  $2V_0 = E_R$  (the parameter is called 's' in Ref. [18]). Eq. (52) can then be rewritten as

This shows that s decreases quadratically with the strength of the optical potential, which is consistent with the numerical results in Ref. [18]. This expression is valid if  $2V_0 = \frac{m_G^{(0)}}{G}$ , or 4, how ever, this constitutes a rather limited range of the values of of physical interest.

# D. Radially Con ned Condensates

As a nalapplication of the results derived in this section we consider a condensate that is con ned in the radial direction. To be specific, we assume a potential of the form

where  $V_{?}$  () = m !<sub>?</sub> <sup>2</sup>=2, that is, harm onic con nem ent in the radial () direction. The optical potential is periodic in the axial direction with periodicity d. This potential approximates the situation of a long cigar-shaped trap with an axial standing light wave.

A lthough the geom etry is quite di erent from that considered earlier, the previous analysis can be carried over with m inor m odi cation. The ground state GP solution has the property  $_0(;z+d) = _0(;z)$ , and has the norm alization

which de nes the mean linear density along the length of the condensate. As before, it is convenient to de ne 0 (r) w 0 (r).

The Bogoliubov excitations in the present situation have a B loch wave character along the axis and are obtained from (19) with the H am iltonian

The eigenstates of  $\hat{h}_0(q)$  are now labelled by the set of quantum numbers fq;n;m; g, where n is a onedimensional band index, m is the azim uthal quantum number associated with the z-component of angularm omentum, and labels the dierent radial excitations. Of interest here are axially symmetric solutions (m = 0) since these have the character of the phonon mode of interest.

The analysis after (19) is followed step by step, the only change being the integration volume used in the norm alization of the states. We thus nd that the sound speed is given by

Eq. (58) is of course valid in the absence of the optical potential. Treating the condensate in the TF approxim ation, we nd =  ${}^2_0$ =gm ! ${}^2_2$  and @  ${}_0$ =@ = gm ! ${}^2_2$ =2 0. This gives a sound speed

where  $n_0(0) = {}_0=g$  is the density at the centre of the trap. This result was rst obtained in Ref. [22] using a di erent m ethod. In the weak coupling limit, (45) applies. In this case, the condensate wave function is a gaussian,

W hen the optical potential is strong the condensate becomes localized on each site. In this situation, the tight-binding approximation is a usefulm ethod for dealing with the system [10, 11, 24]. Approximating the condensate wave function as  $(r) = \frac{1}{i} c_i f_i(r)$  where  $f_i(r)$  is a function localized on the i-th site and normalized to unity, the energy of the system is given approximately by

Assuming that the parameters  $"_0$ , t and g are density independent in the extreme tight-binding limit, we have  $_0 = @E_{tot}=@N = ("_0 2t) + g$  and  $@_0=@ = gd$ . W ithin the same approximation the band energy is "(q) = "\_0 + g 2tcos(qd), which gives an elective mass m\_0 =  $\sim^2 = 2td^2 p$  Thus the B ogoliubov sound speed from (58) is s<sub>tb</sub> ' 2g td<sup>2</sup>= $\sim^2$ , which is the result obtained by Javanainen [10].

# IV. PHONON DISPERSION FOR A MOVING CONDENSATE

W e turn next to the derivation of the phonon dispersion relation for the case where the condensate is  $\setminus$  ow ing" through the optical lattice. We address this problem by directly solving the Bogoliubov equations in (16) for a specic condensate wave function w<sub>nk</sub> in the limit of small wave vectors q. The structure of these equations is quite di erent when  $k \in 0$  and the method used in the previous section to determ ine the dispersion relation can no longer be applied. In fact, the analysis is much m ore intricate as will soon becom e apparent. The results we obtain con m the more intuitive hydrodynam ic approach presented recently [7], which describes the dynam ics of the system in terms of slow ly varying hydrodynam ic variables (density and m om entum). By including small length scale variations, our approach in a sense provides a \m icroscopic" derivation of the hydrodynam ic equations that one would expect to be valid in the long wavelength lim it.

Since the solution in the small-q limit is required, we rewrite (16) so as to display the q-dependent term s explicitly:

In these equations, we have adopted the index n = 0 for the condensate wave function. We will usually think of this state as the lowest B loch state solution of the GP equation, although it in principle could correspond to an arbitrary excited band. For simplicity we have dropped the index on the quasiparticle amplitudes u and v and the excitation energy E as we will only be considering the phonon-like excitation.

It is clear that for q = 0 (60) adm its a solution with  $u / w_{0k}, v / w_{0k}$  and E = 0. For nite q we seek solutions in the form of an expansion in eigenfunctions of  $\hat{h}_{k}$ , namely,

D ue to the inversion sym m etry of the lattice, the B loch states at the zone centre (k = 0) can be chosen to be simultaneous eigenstates of parity. A lthough parity is not a good quantum number for states with nonzero k, each band can nevertheless be assigned a parity index  $_n = 1$  such that

Note that A and P are herm itian while B is not. In addition, we see that  $A_{nn^{\circ}}(0)$  and  $B_{nn^{\circ}}(0)$  are real and nonzero only for pairs of states having the same parity index, while  $P_{nn^{\circ}}(0)$  is purely in aginary and only couples states with opposite parity.

In solving (63) and (64), it is convenient to de ne the following linear combinations:  $c_n = \frac{1}{2}(a_n + {}_nb_n)$  and  $d_n = \frac{1}{2}(a_n {}_nb_n)$ . Introducing these variables into (63) and (64), and making use of the relations in (70), we obtain the equations

As in our earlier analysis, we anticipate that E (q) will depend linearly on q for q ! 0, but due to the quasimom entum k of the condensate, it no longer depends simply on the magnitude q. To extract this dependence we system atically expand the coe cients c<sub>n</sub>(q) and d<sub>n</sub>(q) as a series in powers of q. Speci cally, we write

For a hom ogeneous system, h (q) / q  $^{1=2}$ , and we expect a sim ilar dependence in the case of a lattice. In the following, it is su cient to note that this factor is the same for both coe cients and can therefore be ignored in developing a system atic q-expansion.

W enoted earlier that u /  $w_{0k}$  and v /  $w_{0}$ ; k forq ! 0 which, according to (61), in plies that  $a_n (q) / {}_{n0}$  and  $b_n (q) / {}_{n0}$  in this limit. If the state  $w_{0k}$  is an even parity state ( $_0 = +1$ ), as we assume in the following, we must then have  $c_n^{(0)} = {}_{n0}$  and  $d_n^{(0)} = 0$ . W ith this information, (71) gives to 0 ( $q^0$ ) the equation

Since  $d_n^{(1)}$  is itself linear in E according to (76), we see that (79) is implicitly a quadratic equation for E which can be solved to determ ine the excitation energy to lowest order in q. However, to do so directly would not reveal the interesting dependences on various physical parameters that in fact emerge. As seen in the k = 0 analysis, the excitation energy could be related to the variation of the chem ical potential with m ean density n. This remains a quantity of interest in the present case, but we must also consider variations of the chem ical potential with a consider variation of  $0_{k,n}$  ( $0_{0k}=0$  n and  $0_{k,i}$ ) ( $0_{0k}=0$ k.

#### A. Determ ination of $_{0k;n}$

The chem ical potential  $_{0k}$  is determ ined by the selfconsistent solution of the GP equation,  $\hat{h}_k w_{0k} = 0$ , with  $\hat{h}_k$  given by (18) with q = 0. The variation of this equation with respect to n gives

This is precisely the elective mass tensor obtained by means of k p perturbation theory [27] as applied to the Ham iltonian  $\hat{h}_0$  (q) in (20). The tensor de ned in (102) is a generalized elective mass tensor in that it depends on the presence of a super uid ow (k  $\in$  0). A loo because of this, it is no longer diagonal despite the cubic symmetry of the optical lattice.

We note in passing that direct di erentiation of (115) establishes the relation  $hj_s i = r_k (n \sim) = \sim [20]$ .

W ith these results, the phonon energy (101) can be written in a compact form. De ning the mean energy density as e n~, the Bogoliubov excitation energy at long wavelengths is given by

where we use a repeated summation convention on the Cartesian indices i and j. This is precisely the expression given by M achholm et al. [7] who argued that the dynam ics of the system at long wavelengths could be based on a hydrodynam ic analysis. Since their approach arrives at (117) in a more econom ical fashion, it is useful to sum marize the essential assumptions on which it is based.

The central assumption is the existence of an average phase uctuation, h (r;t)i, that varies slow ly in space and time. Expanding this average phase as

The dispersion relation found is identical to (117).

It is clear that the assumptions made in the hydrodynam ic approach are com pletely justi ed. The average energy density e is the fundam ental quantity determ ining the excitation energy at long wavelengths, as con med \_by our system atic q-expansion. The additional inform a-. However, as proved by (105), the ion provided by the expansion technique are the perturbative expressions for  $0_{0k}=0n$ ,  $r_{k}_{0k}$  and  $(1=m)_{ij}$  as given by (86), (92) and (102), respectively.

#### F. D iscussion

For smallk,  $e(n;k)' = (n;0) + n^{2}k^{2} = 2m_{0} +$ , and the Bogoliubov excitation energy is

where s is the sound speed for the condensate at rest. This result was given previously by Kramer et al. [18]. The energy rst becomes negative when the super uid ow satis es k > m s=~, where 1=m =  $(n=m_0)=(n, m_0)=(n, m_0)$ which de nes the Landau criterion for energetic instability at long wavelengths in an optical lattice. The region of energetic instability was mapped out for arbitrary q by W u and N iu [6, 28] and M achholm et al. [7]. In this region the energy of the super uid state is no longer a local maximum. As a result, transitions to low erenergy states can occur spontaneously provided a m eans of conserving energy and quasim om entum is available.

The excitation energy given by (117) becomes in agi-118)nary when the argum ent of the square root is negative. This signals a dynam ic instability whereby the amplitude of the condensate uctuation grows (or decays) in time. Of the two factors in the square root, e; ij, or equivalently the e ective m ass tensor, (1=m ) ij, is the m ost physically relevant.

It is instructive to examine the latter in the weak potential limit. We consider for simplicity the onedimensional situation discussed in Sec. IIIC. Repeating the perturbative analysis in Sec. IIIC for the case k  $\neq$  0, we nd

We note that at  $k = k_c$  k, the perturbative correction to the energy in (123) is still sm all so that the perturbation theory estimate of where m<sub>0</sub><sup>-1</sup> goes to zero is reasonable. We thus expect a dynamic instability to set in when k '  $k_c$  in the weak potential limit.

This condition for the dynamical instability is the  $q = 0 \lim it of the result given in Refs. [6] and [7]. The Bo$  $goliubov excitations of wave vector q in an hom ogeneous gas with current hj_si = n~k=m have the energies$

W e follow W u and N iu [6] in referring to the modes with the plus (m inus) sign as phonons (anti-phonons). The form er correspond to physical excitations in that their norm alization is given by (15). The e ect of an optical potential is to couple an anti-phonon mode with wave vector q to a phonon mode with wave vector q G. The condition that E (q) =  $E_+$  (q G) in plies that the two m odes are resonantly coupled and gives the critical wave vector

Forq = 0, this gives the critical wave vector in (124). The expression in (128) was shown in [6] to account for the boundary of the dynam ically unstable region in the weak potential lim it. In fact, it can be shown by means of degenerate perturbation theory (Appendix B) that im posing a weak optical potential indeed gives rise to complex B ogoliubov eigenvalues.

A lternatively, the condition  $E(q) = E_+(q G)$  can be written as  $E_+(q) + E_+(q G) = 0$ . This was interpreted by M achholm et al. as a Landau criterion for the em ission of two phonon excitations with zero total energy.

A lthough this physical interpretation is appealing, it is not clear how it can be used to actually determ ine the rate at which the excitations are being produced, short of performing the perturbation analysis carried out in Appendix B in term s of phonon and anti-phonon m odes.

We thus see that the phonon-anti-phonon resonance condition, or alternatively the two-phonon Landau criterion, is consistent with the elective mass condition for a dynam ical instability in the q! 0 lim it. A similar statement can be made in the weak coupling lim it (g! 0). W u and N iu [6] noted from their num erical analysis that one boundary of the dynam ically unstable region is given by the condition  $"_0 (q + k) = "_0 (k) = "_0 (k) = (k) = (k) = (k)$  where  $"_0 (k)$  is the band energy for the optical potential by itself. In the small-q lim it, this condition becomes

Thus the onset of dynam ical instability at q = 0 in the weak coupling lim it is again given by the point at which the inverse e ective m ass goes to zero.

#### V. CONCLUSIONS

We have studied the long wavelength phonon excitations in a three dimensional optical lattice. By making use of a system atic expansion of the Bogoliubov equations in terms of the phonon wave vector q, we obtain the phonon dispersion in the long wavelength limit. Our result (40) for the current-free state de ness the sound speed in terms of the elective mass m<sub>0</sub> and variations of the chemical potential with n and agrees with the result given by M enotti et al. [17]. The elective mass is dened quite generally in terms of the energy per particle, ~ (n;k), but can also be calculated using the current-free GP H am iltonian in the k ! 0 limit. We present analytic expressions for the sound speed in the Thom as-Ferm i, weak potential, weak coupling and tight-binding limits.

For the current-carrying case, we rederive the dispersion relation obtained by m eans of a hydrodynam ic analysis [7] (see also [13]). Our approach con m s that the dynam ics at long wavelengths is de ned by the local energy density e (mi;hki) viewed as a function of the slow ly varying local density, hm (r)i, and local condensate w ave vector, hk (r)i. At long wavelengths, dynam ical instabilities arise at the point where the generalized e ective m ass tensor has a vanishing eigenvalue.

# APPENDIX A:REFLECTION SYMMETRY OF BLOCH FUNCTIONS

In this Appendix we give a proof of the sym m etry property (68) used throughout our analysis. We do this for the one-dimensional case for which the wave function is a solution of

The method described above cannot be used in three dimensions, but perturbation theory allows one to infer the same symmetry property. We write the Schrödinger equation for the B loch function  $w_k$  (r) as

 $w_k$  (r), depending on the parity of the state n. Thus, the B both state exhibits the sym m etry property to bw – est order in k. It is evident that this argum ent can be extended to higher orders in perturbation theory.

## APPENDIX B:DYNAM IC INSTABILITY IN THE W EAK POTENTIAL LIM IT

Thus, the line in the k-qplane de ned by (128) lies within the region of dynam ical instability when  $V_0$  is nite. As emphasized by W u and N iu [6], the dynam ical instability in the weak potential lim it arises from a resonant coupling between phonon and anti-phonon m odes.
