# Translocation of a Single Stranded D NA Through <br> a Conform ationally Changing N anopore

W e investigate the translocation of a single stranded D NA through a pore which uctuates betw een two conform ations, using coupled $m$ aster equations. The probability density function of the rst passage tim es (FPT) of the translocation process is calculated, displaying a triple, double orm ono peaked behavior, depending on the interconversion rates betw een the conform ations, the applied electric eld, and the initial conditions. The cum ulative probability function of the FPT, in a eld-free environm ent, is show $n$ to have tw o regim es, characterized by fast and slow tim escales. A $n$ analyticalexpression for the $m$ ean rst passage tim e of the translocation process is derived, and provides, in addition to the interconversion rates, an extensive characterization of the translocation process. Relationships to experim ental observations are discussed.

## INTRODUCTION

Translocation of biopolym ers through a membrane pore occurs in a variety of biologic .........e expression in eucaryotic cells
 translocation in olological system $s$ and its applications, have been the $m$ otivation for recent theoretical and experim ental work on this topic. In experim ents one usually $m$ easures the tim e it takes a single voltage-driven single stranded D NA (ssD NA) to transloca
lysin channel of a known structure
. Since ssD NA is negatively charged (eacn m onom er OI ength $b$ has an e ective charge of $z q, w$ here $q$ is the electron charge, and $z(0<z<1)$ is controlled by the solution pH and strength), when applying a voltage the polym er is sub ject to a driving force while passing through the transm embrane pore part (TPP) from the negative (cis) side to the positive (trans) side (for an illustration of the process see M eller 2003, gure 4). Because the presence of the $\operatorname{ssD} N A$ in the TPP blocks the cross-TPP current, one can deduce the FP T probability density functio -1.....ion tim es

E xperim ents by $K$ asianow icz et al. (1996), show $F$ ( $t$ ) w ith three peaks. It was suggested that the shorttim e peak represents the non-translocated events, while the other two, longer-tim e peaks, represent translocation events of di erent ssD N A orientations. In addition, the tim es that $m$ axim ize the translocation peaks were shown to be proportional to the polym er length and inversely proportional to the applied eld. In experim ents by $M$ eller et al. (2001), $F$ ( $t$ ) $w$ as show $n$ to be monopeaked, w ith a corresponding $m$ axim izing tim e that has an inverse quadratic eld dependence. $M$ ore recently,
$B$ ates et al. (2003) m easured the FP T cum ulative probability function ( Cpf ), which $\mathrm{R}_{\mathrm{t}}$ the probability to exit the channeluntiltimet, $G(t)={ }_{0} F(s) d s$, in a eld-free environm ent. G (t) was approxim ated by tw o w ell separated tim escales w ith the ratio of $1=20$.

In previous theoretical works, the translocation of a $\operatorname{ssD}$ NA through a nanopore was described by statisticalm odels that focused on calculating the free energy of the process as a function of the translocation state. T he free energy contained term $s$ that represent the entropy and the chem icalpotential of the polym er parts on both sides ofa zero thicknessm em brane (Sung and park, 1996; M uthukum ar, 1999). T he role of them em brane thickness w as studied by Ambjomsson et al. (2002), Solonika and K olom eisky (2003), and F lom enbom and K lafter (2003a). $T$ he obtained free energy w as used to calculate the $m$ ean
rst passage time (MFPT), which asym ptotically was found to scale linearly $w$ th the polym er length for a eldbiased process. This is the expected M FP T dependence biased random walk in a nite interval

A di erent approach was suggested by Lubensky and N elson (1999) and w as further developed by B rezhkovskii and G opich (2003), where a di usion-convection equation w as used to describe the translocation process, under the assum ption that the polym er parts outside the $m$ em brane hardly a ect the translocation. B rezhkovskii and G opich (2003) show ed that by changing the cis absorbing end to be partially absorbing, the m ono-peaked F (t) obtained by Lubensky and N elson (1999) changes to a superposition of a decaying non-translocation pdf and a peaked translocation pdf. U sing the fractionalFokker$P$ lanck equation, $M$ etzler and $K$ lafter (2003) suggested an explanation for the slow relaxation tim e of the experim entally obtained $G(t)$. W e have shown by using the $m$ aster equation ( $M E$ ) that $F(t)$ can be double or $m$ ono
peaked, c
condition
In the approacnes sum $m$ arized above the structure of the pore is taken to be rigid, nam ely, govemed by a single conform ation. A though it is known that the hem olysin ch ucture that allow s its crystallization , during the translocation of a long polym er (larger unan the pore length) w ith the sam e width that of the channel at som e cross sections along the channel, sm all uctuation in the channel structure $m$ ay occur, which give rise to a $m$ ore com plex process than what was assum ed so far. In this work we relax the assum ption of a single pore conform ation and introduce a second conform ation coupled to the rst one. In a continuum form alism, the process takes place in an e ective two dim ensional system, where one dim ension represents the translocation itself, and the second dim ension represents the structural uctuations. This picture is richer and is $m$ ore realistic, since sm all structural changes in physiological conditions are known to occur in large biom olecules, certainly during interaction w ith other large biom olecules.

The function that represents best the translocation process is $F$ ( $t$ ) (or its integralG ( $t$ )). Through the dependence of $F$ ( $t$ ) on the system param eters, we leam about the im portant degrees of freedom which participates in the translocation process. The characteristics off ( $t$ ) are the dependence of its shape, $m$ om ents, and tim es that $m$ axim ize its peaks on the system param eters. U sing the generalized $m$ odel that takes into account uctuations in the pore structure, w e calculate $F(t)$ and show that it can display one tw o or three peaks, depending on the applied voltage, the tem perature and the interconversion rates between the two conform ations. A nalytical expressions for the M FPT are derived and related to the experim ental
ndings. In addition, we calculate the cum ulative probability $G(t)$ in the eld-free lim it, and show that it also provides valuable inform ation about the system param eters. Thus, these tools help in gaining insight into the translocation of a polym er through a narrow pore, and in


THEORETICALMODELLING
B asic M odel
The basic $m$ odelwe use to describe the translocation relies on a one-dim ensional process. To use this sim pli cation, we map the three-dim ensional translocation process onto a discrete one-dim ensionalspace containing $\mathrm{n}(=\mathrm{N}+\mathrm{d} 1$ ) states separated from each other by a unit length b . The translocation takes place w ithin a TPP of a length that corresponds to $d m$ onom ers. An n-state ME is introduced to describe the translocation of an N $m$ onom er long ssD NA sub ject to an extemal voltage V and tem perature $T$. The occupation pdf of the $j$ state is $[\dot{P} \quad(t)]_{j}=P_{j}(t)$, where the state index $j$ determ ines the num ber of $m$ onom ens on each side of the $m$ em brane and
within the TPP $\left(m_{j}\right) . P_{j}(t)$ satis es the equation ofm otion:

under absorbing boundary conditions on both sides of the $m$ em brane (the polym er can exit the TPP on both sides). E q. 1 can be written in a m atrix representation:

where the propagation $m$ atrix $A$ is a tridiagonalm atrix that contains in form ation about the transitions betw een states in term $s$ of rate constants, $a_{j ; j} 1$, which are given by:

$H$ ere $k_{j}$ is the rate to perform a step, $p_{j ; j} 1\left(p_{j ; j+1}\right)$ is the probability to $m$ ove one state from state $j$ to the trans (cis) side, and $p_{j ; j+1}+p_{j ; j} 1=1$.

with two exceptions: the param eter $p$ represents the ssDNA-TPP interaction and cannot be calculated from the Stokes relation, and serves as a measure of the polymer sti ness inside the con ned volume of mond by the conventional values A ssum ing a quastequltibrium process, which enables using the detailed balance condition, and using the approxim ation $a_{j ; j} 1=a_{j} \quad 1 ; j \quad p_{i j} \quad 1=\left(\begin{array}{ll}1 & p_{j j}\end{array}\right)$, the probability $p_{j ; j} 1$ is found to be:

The free energy di erence betw een states, $E_{j}=E_{j} 1$ $\mathrm{E}_{j}$, is com puted considering three contributions: electrostatic, entropic, and an average attractive interaction energy betw een the SSD N A and the pore. M ore explicitly,
$E_{j}$ is given by $E_{j}=E_{j}^{p}+{ }_{j}$, where $E{ }_{j}^{p} 0$ represents the ect of the eld which directs tow ards the trans-side and $j>0$ (for $j>d$ ) represents an e ective directionality to the cis-side, which originates from the entropic factors and the average attractive interaction energy between the sSD NA and the pore. For a m ore detailed discussion see F lom enbom and K lafter (2003a).

Several features em erge from the simple onedim ensionalm odel. For hom opolym ers, poly-dnu, where nu stands for the nucleotide type, we estim ate $\mathrm{p}\left(\mathrm{A}_{\mathrm{nu}}\right)$ $10{ }^{4} \mathrm{meVs}=n \mathrm{~m}^{2}$, $\mathrm{p}\left(\mathrm{C}_{\mathrm{nu}}\right)={ }_{\mathrm{p}}\left(\mathrm{T}_{\mathrm{nu}}\right)={ }_{\mathrm{p}}\left(\mathrm{A}_{\mathrm{nu}}\right)=3$ and $\left(C_{n u}\right)=1, \quad\left(A_{n u}\right)=1: 14, \quad\left(T_{n u}\right)=1: 28$. Here $A_{n u}$, $\mathrm{C}_{\mathrm{nu}}$ and $\mathrm{T}_{\mathrm{nu}}$ stand for adenine, cytosine and thym ine nucleotides, respectively. Interestingly, $p$ is three order of $m$ agnitude larger than the bulk friction constant,
which is consistent w ith the role assign to $p$ to represent the interaction betw een the polym er and the channel.

In addition, from the expressions for $E_{j}$ and $p_{j ; j} 1$, the im portant param eter $V=V_{C} \quad z \dot{j} j V(1+1=d)$ com es out naturally. This ratio determ ines the directionality of the translocation, and, in particular, for $\mathrm{V}=\mathrm{V}_{\mathrm{C}}>1$ there is a bias tow ards the trans-side of the $m$ em brane.

## Translocation $T$ hrough a C onform ationally

 Changing PoreA $m$ ore realistic description of the translocation can be obtained by taking into consideration uctuations in the TPP, either spontaneous or interaction induced. A ccordingly, we introduce an additional pore conform ation $w$ hich is represented by the propagation $m$ atrix $B$. The changes in the pore conform ation between $A$ and $B$ are controlled by the interconversion rates, $!_{A}$ and $!_{B} .!_{A}$ $\left(!_{B}\right)$ is the rate of the change from the $A(B)$ to the $B$ (A) pore conform ation.

The physical picture of the process is that when the pore conform ation changes, a di erent environm ent is created for the ssD N A occupying the TPP.This im plies a change in p and. For a large polym er, $\mathrm{N}>\mathrm{d}$, we take B A, where is a (dim ensionless) param eter that represents the ect of the conform ational change on $p$ and. The param eter $m$ ay be intenpreted as a $m$ easure of an e ective available volume in the TPP, when the am ino acids residues protruding the TPP change their positions.
$T$ he equations of $m$ otion of the ssD NA translocation through the uctuating pore, w ritten in $m$ atrix representation, are:

## Param eters Tuning

To study the translocation of SsD NA through a uctuating pore, we start by com puting $F(t)$. Form ally, $F(t)$ is de ned by

Here, $S(t)$ is the survival probability, nam ely, the probability to still have at least one $m$ onom er in the pore, and is given by sum $m$ ing the elem ents of the vector that solves Eq. 6; see A ppendix A for details. U sing the known values of $p$ and from the single conform ation $m$ odel, we exam ine in this subsection the e ect of the param eters ,$!{ }_{A}$ and $!_{B}$ on $F(t)$.
$F$ irst, we check the e ect of on $F(t)$ for several lim iting cases. For $=0 \mathrm{~m}$ ovem ent in any direction occurs only under the A conform ation environm ent. The B conform ation traps the polym er for a period oftim e govemed by the interconversion rates. For $=1$, nam ely, $\mathrm{B}=\mathrm{A}$, the environm ental changes do not a ect the translocation, and the process reduces to a translocation through a single conform ation. For $>1$ the environm ental changes enhance the process. In this paper we restrict ourselves to the range $0 \quad 1$.

T he picture is less intuitive for interm ediate values of
. Fig. 1 show sthat by choosing properly, three peaks in $F$ ( $t$ ) can be obtained. In particular, as show $n$ in the inset of $F$ ig. 1, the range of values for which $F(t)$ exhibits three distinct peaks is $0: 1$ $0: 30$. For the single conform ation case we found that $F$ ( $t$ ) can be either $m$ ono or double peaked depending on $V=V_{C}$, and on the initial state of the translocation $x$. The short tim e peak represents the non translocated events, while the long tim e peak represents the translocation events. $T$ he generalization for tw o pore conform ations $m$ ay yield tw o translocation peaks in addition to a short tim e non translocation peak. Indeed, Fig. 1 supports the expected behavior for the lim iting values, and shows that as
! 1,F ( t ) possess only one translocation peak, as well as for ! 0, where the $B$ conform ation peak spreads out tow ards larger tim es, which results in its disappearance.

A though $F$ ig. 1 is obtained for a given value of the interconversion rates, our explanations regarding the $F$ ( $(\mathrm{t})$

behavior for the lim iting cases $=1 ; 0$, are valid for any system conditions. This is dem onstrated by calculating the MFPT (Appendiges B and D). In Appendix B we show that when $=1$, the MFPT of the two con gurations $m$ odel reduces to that of the single conform ation m odel. In A ppendix $D$ we show that for $=0$, the $B$ conform ation contribution for the M FPT is a term which is inversely proportional to the interconversion rate, ! ${ }_{B}{ }^{1}$.
$T$ herefore, serves as a tuning param eter that leads to either one or two actual translocation peaks in $F(t)$. The question of interest is how depends on the system param eters. W e assum e a sm all eld perturbation in the regim $\epsilon$ it using $V_{C}$ $50 \mathrm{~m} V$
follows $\quad 0+V=V$, ana keeping ( $V$ ) so that $(V)$

1. Here 0 and $V \quad m$ ight be expansion coe $\quad 1$ is im plied from recent experim ents as we discuss later. The process can be viewed sucn that as the voltage increases, am ino acids residues protruding the TPP that constitute obstacles for the translocating ssD NA clear the way. W hile the dependence on the voltage is assum ed here, its dependence on other system param eters (e. g., tem perature and pH ) is unknown and is folded into $V$.

To check how interconversion rates a ect $F$ ( $t$ ), it is convenient to de ne two dim ensionless param eters, ! $!_{\mathrm{A}}=!_{\mathrm{B}}$ and $!_{\mathrm{B}}=\mathrm{k}$ (or $!_{\mathrm{A}}=\mathrm{k}$ ), where k is the dom inate rate of the $A$ conform ation for a su ciently large $N$, $k=R=d . T$ he rst ratio set the dom inance of a given conform ation over its counterpart; nam ely, for ! 1 $m$ ost of the translocation events take place in the A conform ation. The second ratio gives an estim ate of the num ber of $m$ oves done in a given conform ation before a change in the pore structure occurs, and thus relates the ssD NA dynam ics to the structural changes dynam ics.

As shown in $F$ ig. 2 and in the inset of $F$ ig. 2, $F$ ( t ) exhibits tw o peaks corresponding to actual translocation only when! 1. For! 1 and! 1 only one peak corresponding to an actual translocation survives. For all cases there is a peak representing non-translocation events. In addition, we nd that for two translocation peaks to be obtained, the ratio ! $\mathrm{B}=\mathrm{k}$ (or $!_{\mathrm{A}}=\mathrm{k}$ due to !

1) $m$ ust ful $l!_{B}=k \quad 10^{3}$ (data not shown). T he low er lim it of the interconversion rates is inversely proportional to the order of the $m$ easurem ent tim e otherw ise only one conform ation $w$ ill be detected.
$F$ inally, we assum e that the rate of the conform ational changes is controlled $m$ ainly by tem perature; nam ely, we take $!_{A}$ and $!_{B}$ as voltage independent in the regim e of biological interest: $0 \quad \mathrm{~V}=\mathrm{V}_{\mathrm{C}} \quad 3$.

Translocation V elocity
To study further the translocation process, we check the voltage dependence of the tim es that $m$ axim ize the peaks of $F(t)$, denoted as $t_{m} ; i$ where $i=1 ; 2 ; 3$ (e.g. $t_{m} ; 1$

probable average velocity of the translocation (up to a multiplicative constant). W e show below that our assum ptions regarding the voltage dependence of the system param eters, yield either linear or quadratic dependence of the translocation velocity on the voltage, and can be used to explain the di erent experim ental observations.

Fig. 3 shows $t_{m ; i}\left(V_{C}=V\right)$ and $t_{n}{ }^{1}\left(\mathrm{~V}=\mathrm{V}_{\mathrm{C}}\right)$, for $\mathrm{V}=350 \mathrm{~m} \mathrm{~V}$, in a voltage w indow that leads to $0: 215$
(V) 0:30, and accordingly to a triple-peaked F (t). $t_{m} ; 1$ is alm ost independent of $V_{C}=V$ (see Fig . 3a). A 1though the non translocation peak am plitude decreases upon increasing $V=V_{C}$, the location of its $m$ axim um hardly changes. This happens since exiting against the eld must happen within a short time window at the beginning of the process, otherw ise the polym er is $m$ ore likely to cross the $m$ em brane due to the elecwas observed experim entally

For the single conform ation case, we showed that $\mathrm{t}_{\mathrm{n}}{ }^{1} ; 2$ scales linearly w ith $\mathrm{V}=\mathrm{V}_{\mathrm{C}}$ when the in itial state of the brane Fig. 3b show s that the linear scaling of $\tau_{m ; 2}\left(V=V_{C}\right)$ persists. How ever, $\mathrm{t}_{\mathrm{m}}{ }^{1}\left(\mathrm{~V}=\mathrm{V}_{\mathrm{C}}\right)$ ( F ig. 3c) displays a quadratic behavior, which is a consequence of the form of $(V)$, as discuss in the next section when com puting the M FPT.On the other hand, setting $V=120 \mathrm{~m} V$ leads to one translocation peak, and to sm alldeviations from linearity tow ards a weak quadratic behavior of $\mathrm{t}_{\mathrm{m}}{ }^{1} ; 2\left(\mathrm{~V}=\mathrm{V}_{\mathrm{C}}\right)$; see F ig. 4.

Them odelof tw o conform ations not only yields one or two actual translocation peaks as a function of $V$, but can account for either a linear or quadratic dependence of the translocation velocity $w$ th the voltage, again, as

a function of $V$. Thus, varying $V$ we obtain di erent behaviors of the translocation, which can be related to the di erent experim ental observations.

## THEMEPT

## Sm all F ield B iased T ranslocation

W e now tum to calculate the M FP T, which allow sfor an analyticalestim ation of the characteristic tim es of the

FP T pdf and cdf. In general, the $m \mathrm{~m}$ om ent of $F(t)$ is calculated by raising to the $m$ pow er the inverse of the propagation $m$ atrix. For the two conform ations translocation this $m$ atrix is given on the right hand side of Eq . 6.

A fter som ew hat lengthly calculations, which are given is A ppendices B and C, the expression for the MFPT, $<\quad>$, reads:

where - is the MFPT for the single con guration model, and is given by Eq. C 5, and $P_{A} ; 0\left(P_{B} ; 0\right)$ is the probability that the process starts in conform ation $A(B)$. For $P_{A} ; 0$ and $\mathrm{P}_{\mathrm{B} ; 0}$ the equilibrium condition is assum ed, $\mathrm{P}_{\mathrm{A}} ; 0=$ $!_{B}=\left(!_{A}+!_{B}\right)$ and $P_{B ; 0}=1 \quad P_{A} ; 0$.

Eq. 8 is valid for not too high elds, $V=V_{C}$ \& 1 , and the relations betw een the interconversion $w$ ith $k$ found in the previous section, $!_{A}=k ;!_{b}=k \quad$ 1. Eq. 9 provides a solid basis for the num erically obtained dependence of the translocation velocity on the voltage. $<>$ consists of two term s that can be attributed to the A ( rst term in the brackets) and B (second term in the brackets) pore conform ations. For V $\quad 120 \mathrm{mV}$ we can replace the expression in brackets by one in the relevant voltages window. Thus, we nd that $<>/\left(V \quad V_{C}\right)^{1}$, which im plies that $F(t)$ has one translocation peak for this choice ofV . Forhigher values ofV and voltages ofbiological interest, the tw o term s in the brackets are separated. This leads to a term that represent the A conform ation and scales as $\left(V \quad V_{C}\right)^{1}$, and a term that represents the B conform ation that scales as $\left[\begin{array}{ll}V(V \quad & \left.V_{C}\right)\end{array}{ }^{1}\right.$.

A ccordingly, Eq. 9 captures the physical essence of the translocation of the ssD NA through the conform ationally changing pore, under a relatively sm all eld.

The tw o conform ationsm odelproduces a tem poralbehavior that agrees $w$ ith experim ental observation, and provides a good explanation for it. In the lim 止, V ! 0 , the $B$ conform ation acts as a trapping conform ation; nam ely, the polym er is stuck in its position when sub ject to the environm ent due to the $B$ conform ation. M ove$m$ ent occurs only through the A conform ation. A s a result two regim es are obtained for $G(t)$. T he fast increase in $G(t)$ at short tim es, is a consequence of exiting due to the A conform ation (at either side of the $m$ em brane),

while the slow saturation at longer tim es is a result of the release from the trapping in the $B$ conform ation.

In the inset of $F$ ig. 5 we show both $F(t)$, the approxim ate $F(t)$, and the $m$ odi ed version of the approxim ation, which is obtained when using $1!t_{m}$. Because the process starts in the $m$ iddle state, $x=n=2, F$ ( $t$ ) Sw ith previous results
A though the approxIm ate $F^{\prime}$ ( $\tau$ ), or any orner approxm ation of tw o exponentials $w$ ith positive coe cients, does not exhibit a peaked shape, inform ation about the $m$ axim alpeak value ofF ( $t$ ) and the interconversion rates can still be extracted from $G_{a p}(t)$ tim escales by using Eq. 11. For exam ple, the tim escales suggested by B ates et al. (2003), im ply that $t_{m} \quad 165 \mathrm{~s}$, and ! ${ }_{B} \quad 300 \mathrm{~Hz}$.

## CONCLUSIONS

Them odel introduced here describes the translocation of ssDNA through a uctuating pore structure. As a consequence the ssD NA w th in the transm em brane pore part is exposed to a changing environm ent, which can be re ected in the rst passage tim es pdf, $F$ ( $(\mathrm{t})$. By com puting $F(t)$, com paring our results to experim ental results, and using physical argum ents, we obtained theoretically a behaviorw hich w as previously observed experim entally $-F(t)$ having three peaks. $T$ his behavior is obtained by tuning the dim ensionless param eter, which controls the $e$ ect of the change in the pore structure on the translocating SSD NA, and the interconversion rates betw een the pore conform ations, $!_{A}$ and $!_{B}$. In particular, has to ful $110: 1 \quad 0: 30$, and the interconversions rates have to be of the sam e order of $m$ agnitude, and $m$ uch sm aller than the typical rate of the A pore conform ation, $k,!_{B}=k \quad 10^{3}$. This im plies that the relaxation tim escale of the SsD NA in the pore is much shorter than of the pore conform ationalchangestim escale. From these relations the $m$ axim al values of the interconversion rates can be deduced from the value of $k$, given by Eq. 3, to be: ! $A_{A} \quad!_{B}=10^{2} \mathrm{~Hz}$.

W e have been able to show, both num erically and analytically, that the tim es that $m$ axim ize the $F$ ( t ) actual translocation peaks, $t_{n} ; i ; i=2 ; 3$, and the M FPT, are inversely proportional to the rst or the second pow er of the eld, depending on $V$. This em phasizes the crucial role of $V$ on the translocation extracted functions, and $m$ ay explain the di erent experim ental results for $F(t)$ discussed in the introduction, $m$ eaning that $V$ is sensitive for the speci cexperim ental set up, and biological conditions.

The probability to exit the channel until tim e $t, G(t)$, in a eld-free environm ent, has been show $n$ to have two regim es that can be approxim ated by tw o tim escales, 1 and 2 , which are about one order of $m$ agnitude apart, and are closely related to the,$- t_{m}$, and the interconversion rates: $1=-(1+3=2$ ! $)$, or $1!t_{m}$, and $2=-(1=2+!)+1=!_{\mathrm{B}}$. From these relations the interconversion rates can be deduced when analyzing experim ental data.
